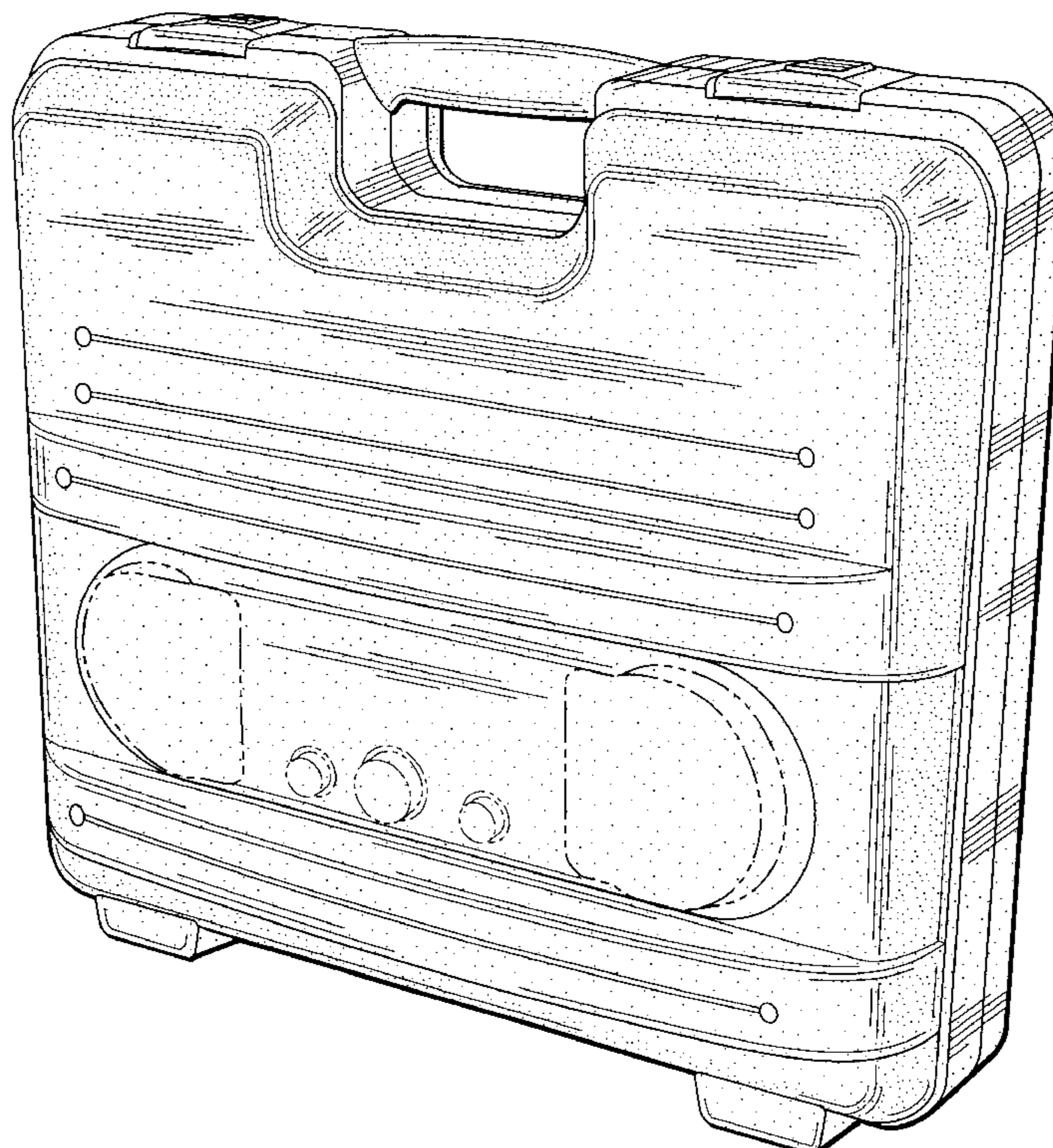
The ornamental design for molded tool case with radio, as shown and described.

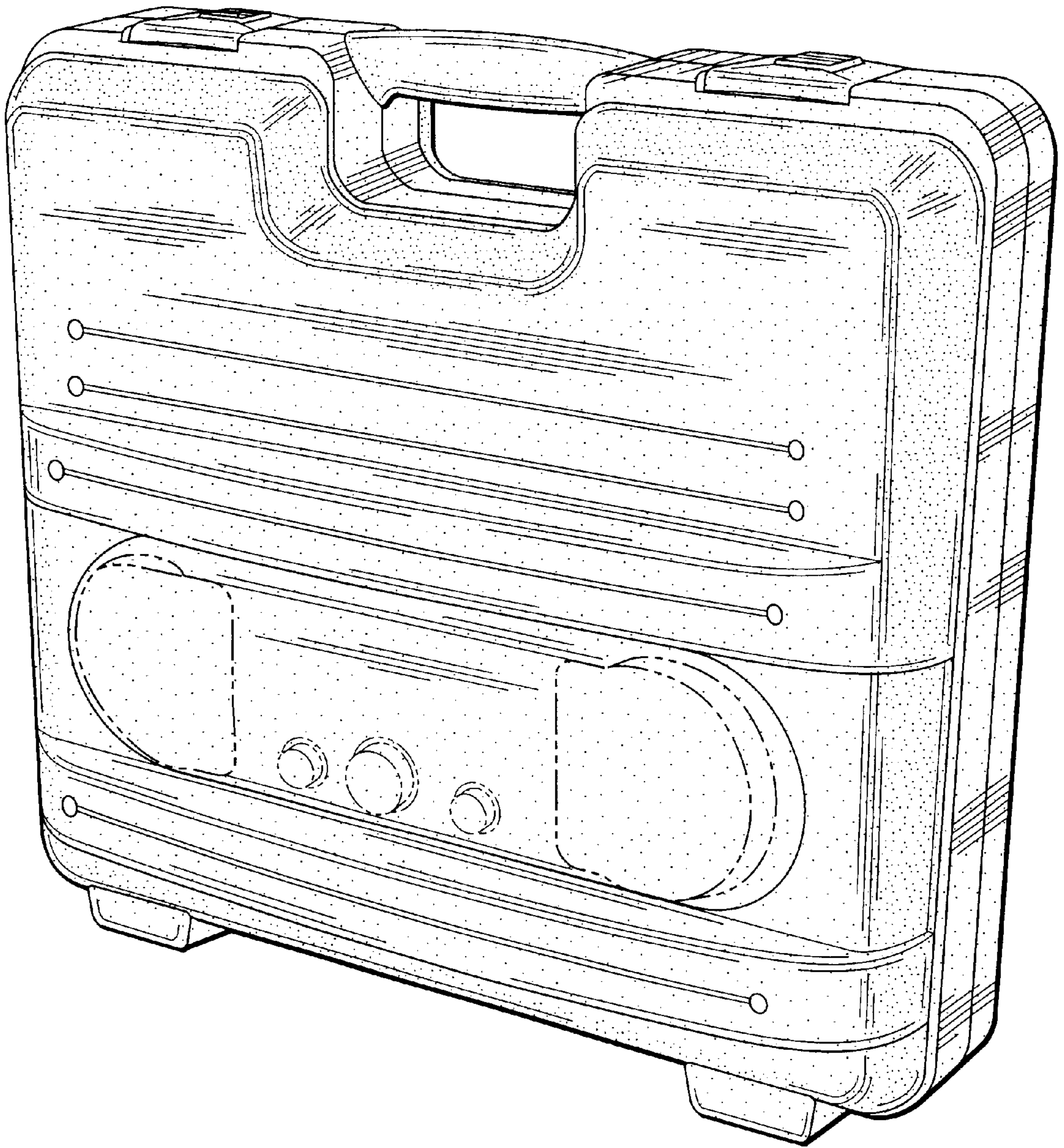
**DESCRIPTION**

FIG. 7 is a bottom view thereof.

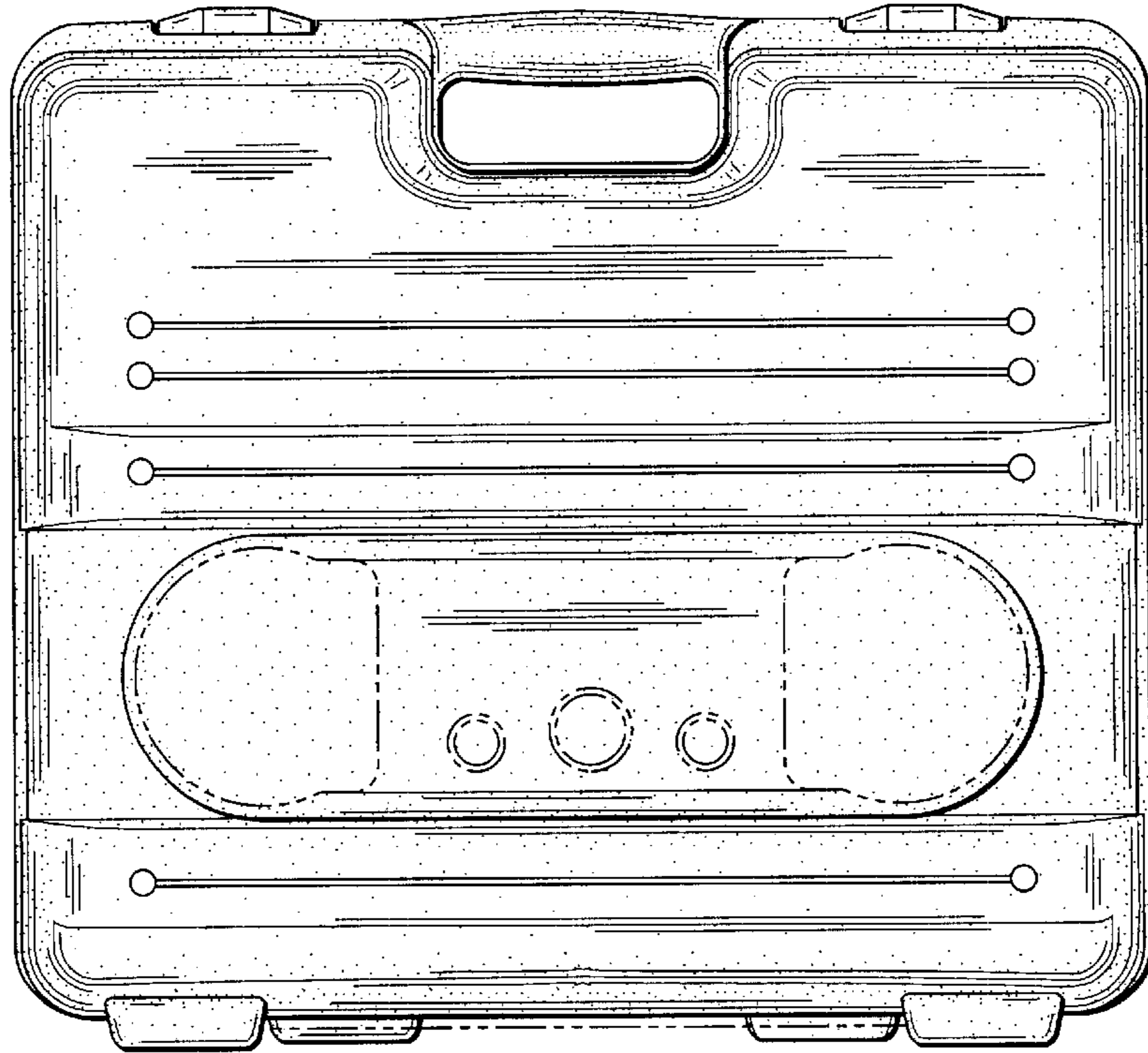
The broken line showing on FIGS. 1-5 and 7 is for illustrative purposes only and forms no part of the claimed design.

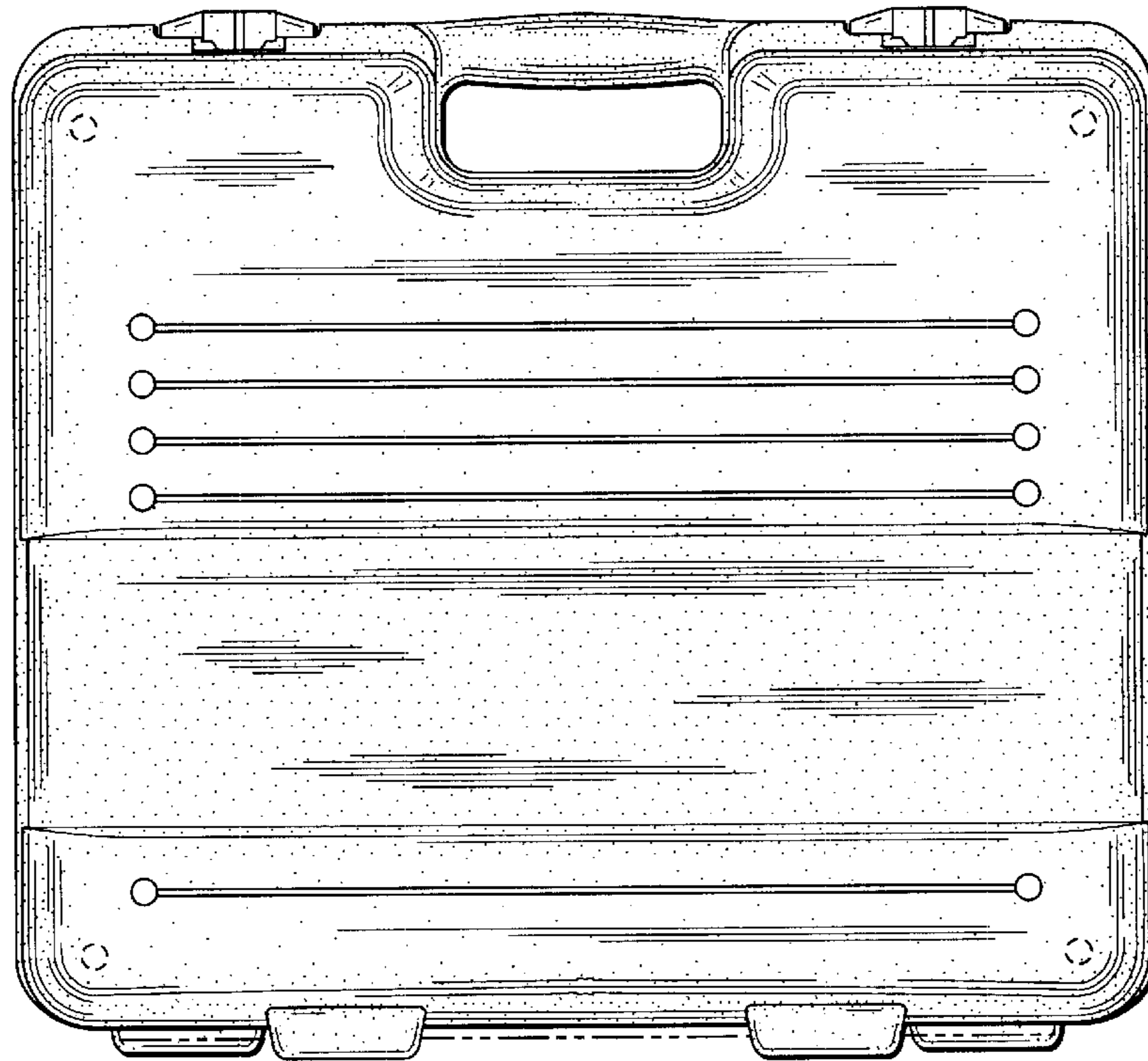




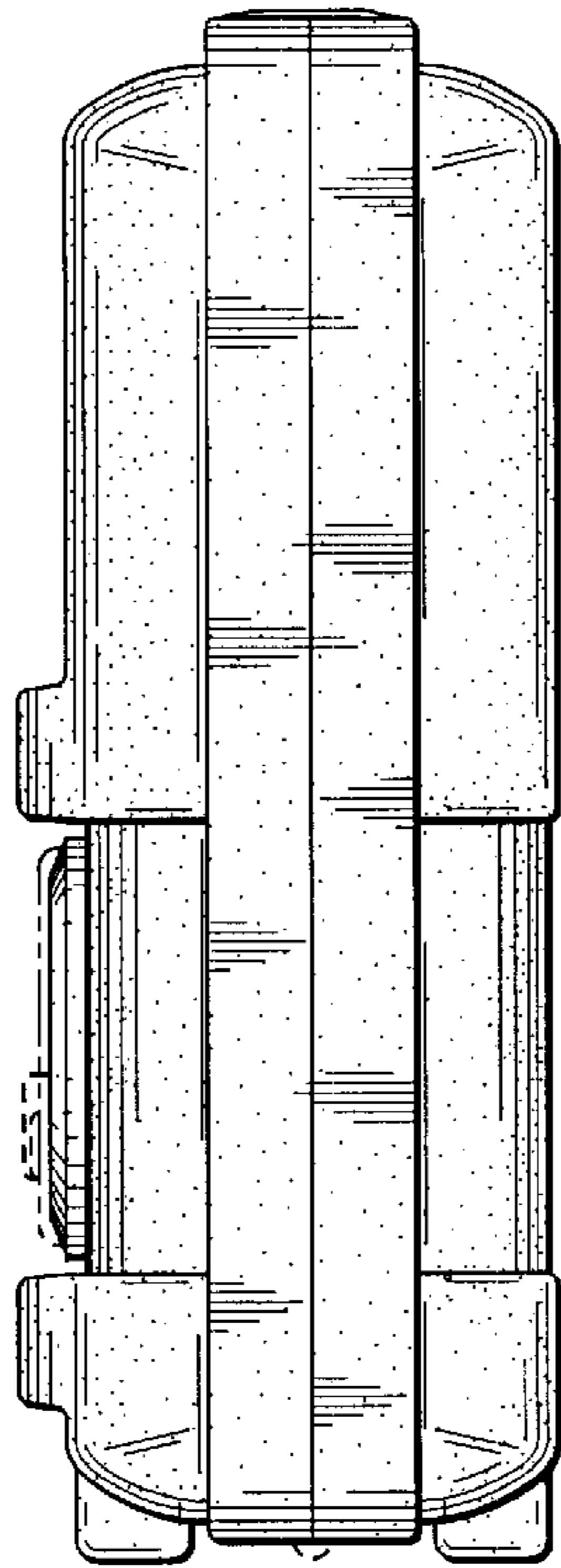

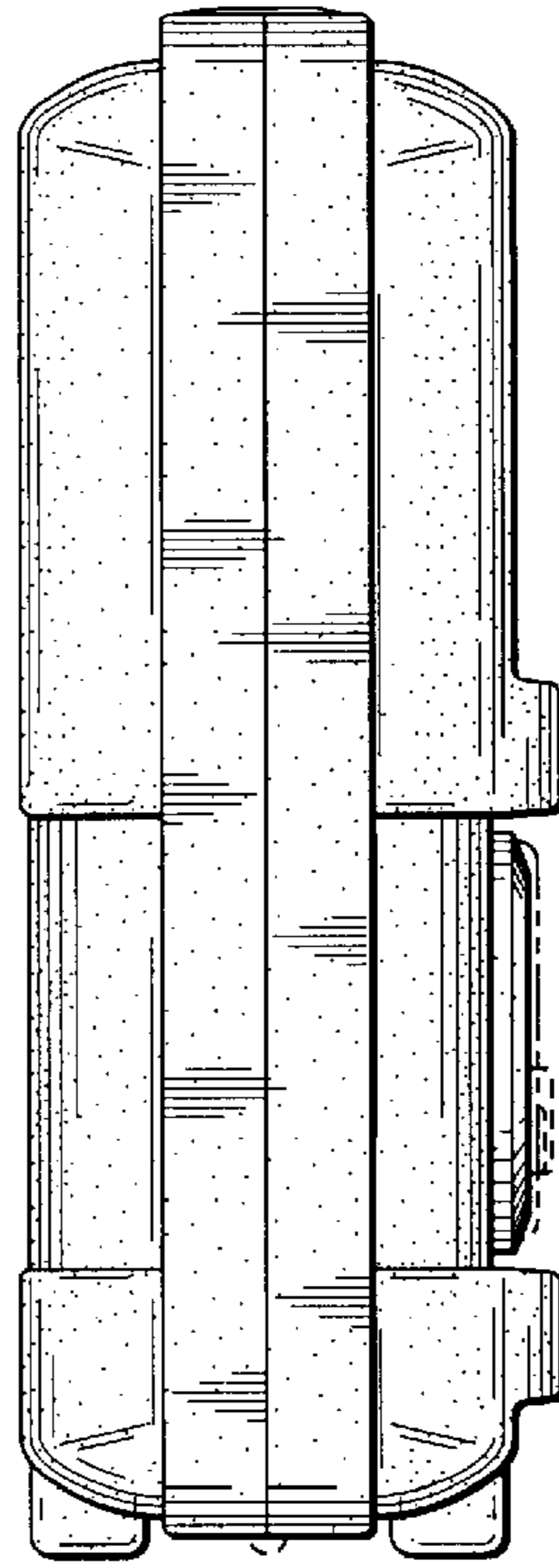

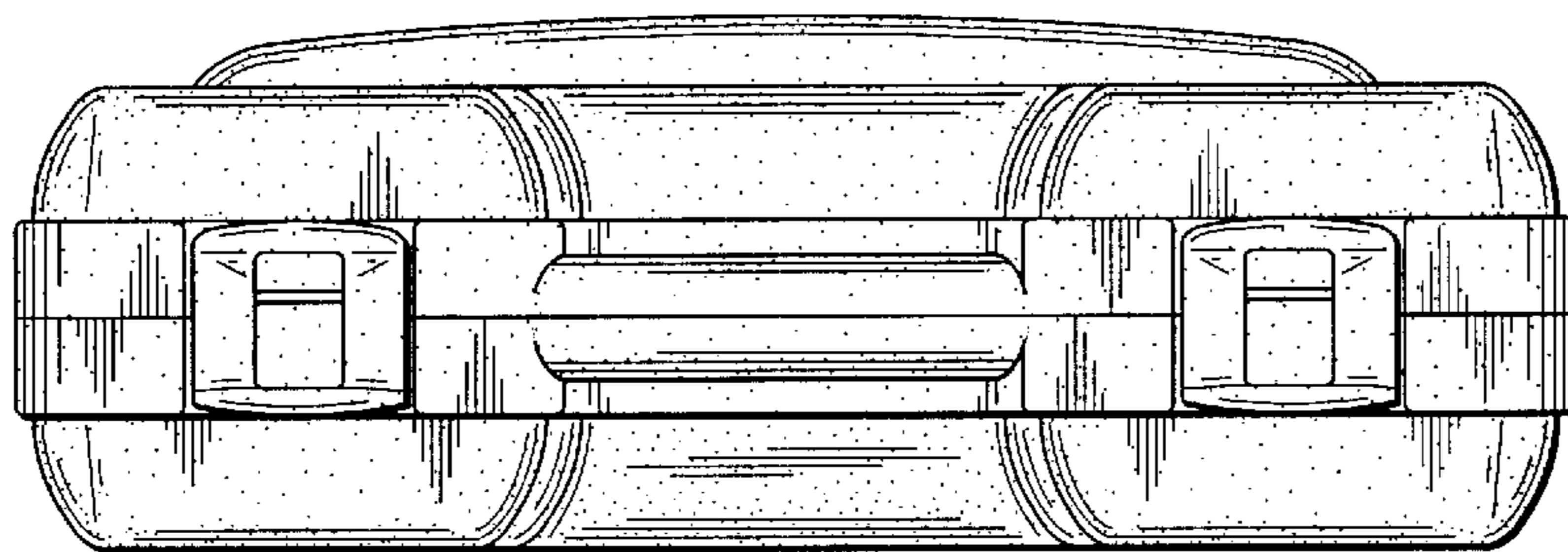

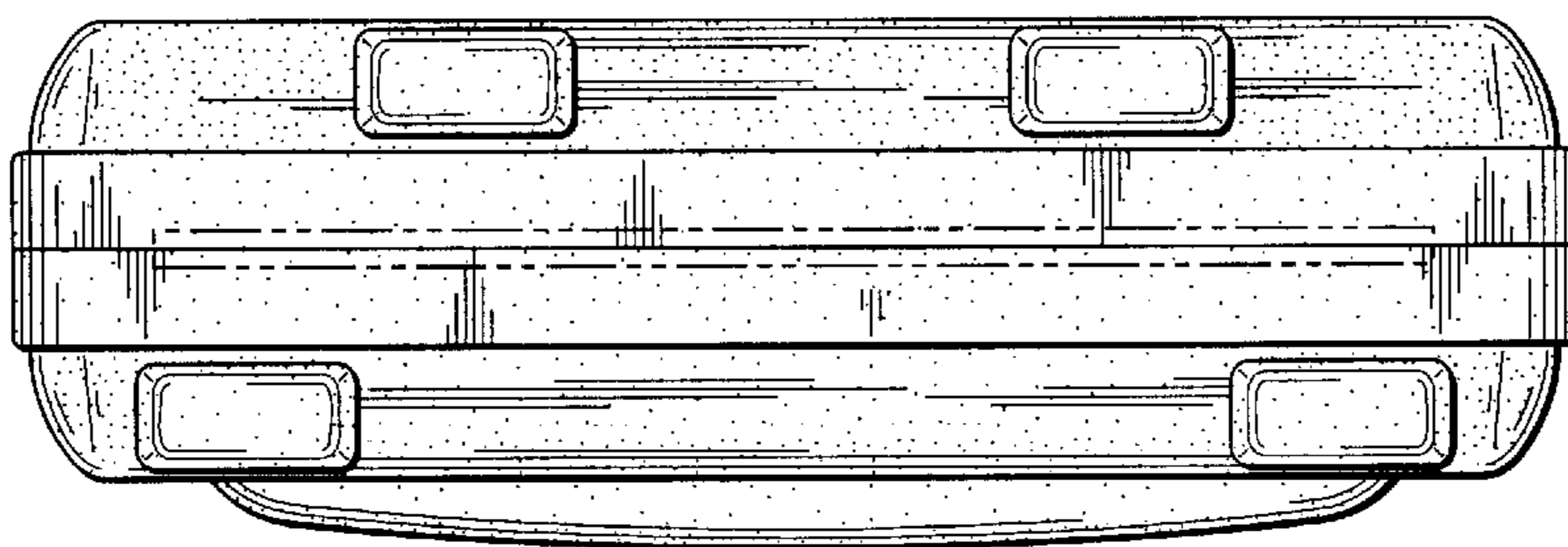
