(57) **CLAIM**

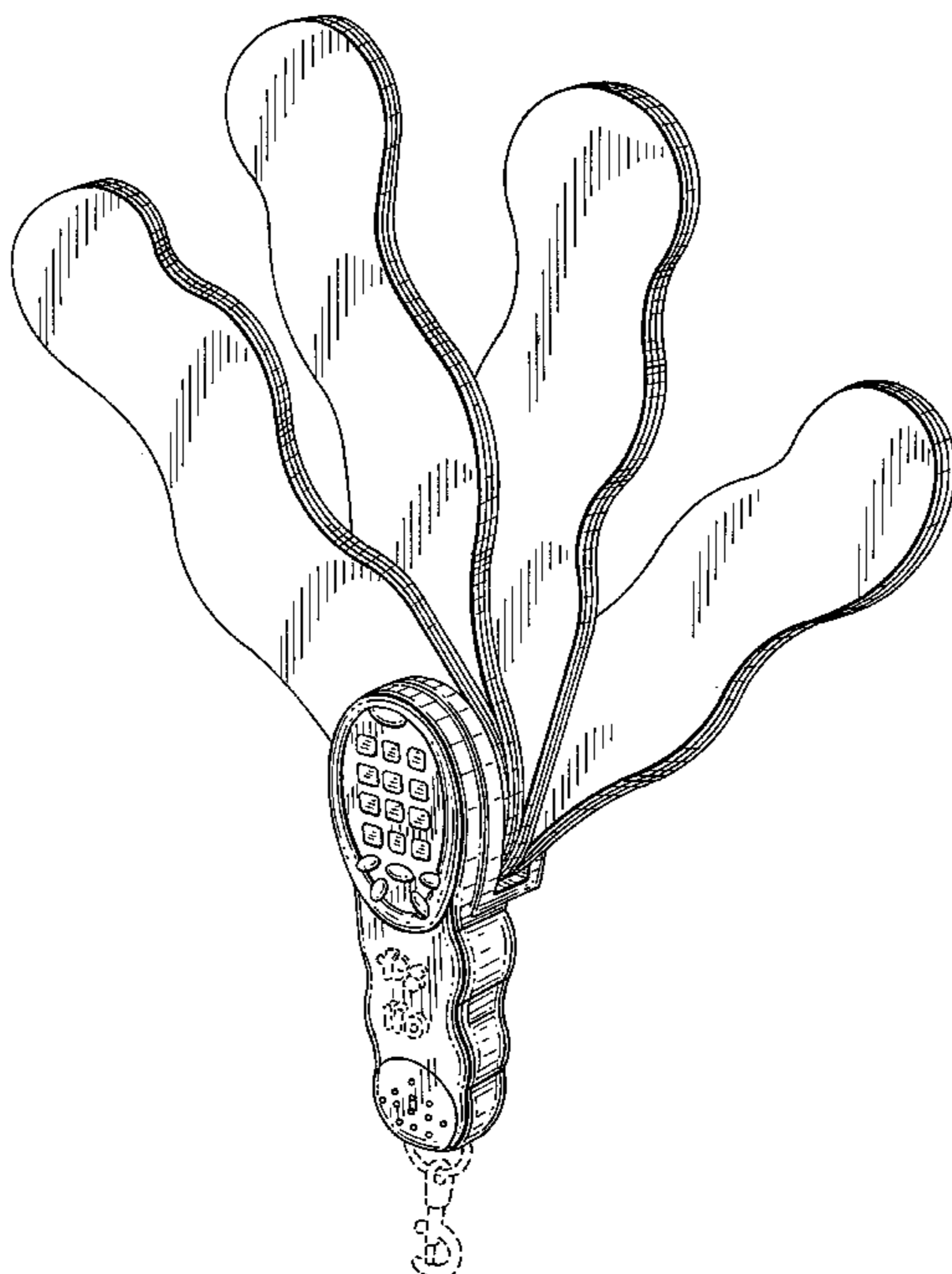
The ornamental design for an interactive quiz machine with cartridge in an open position, as shown and described.

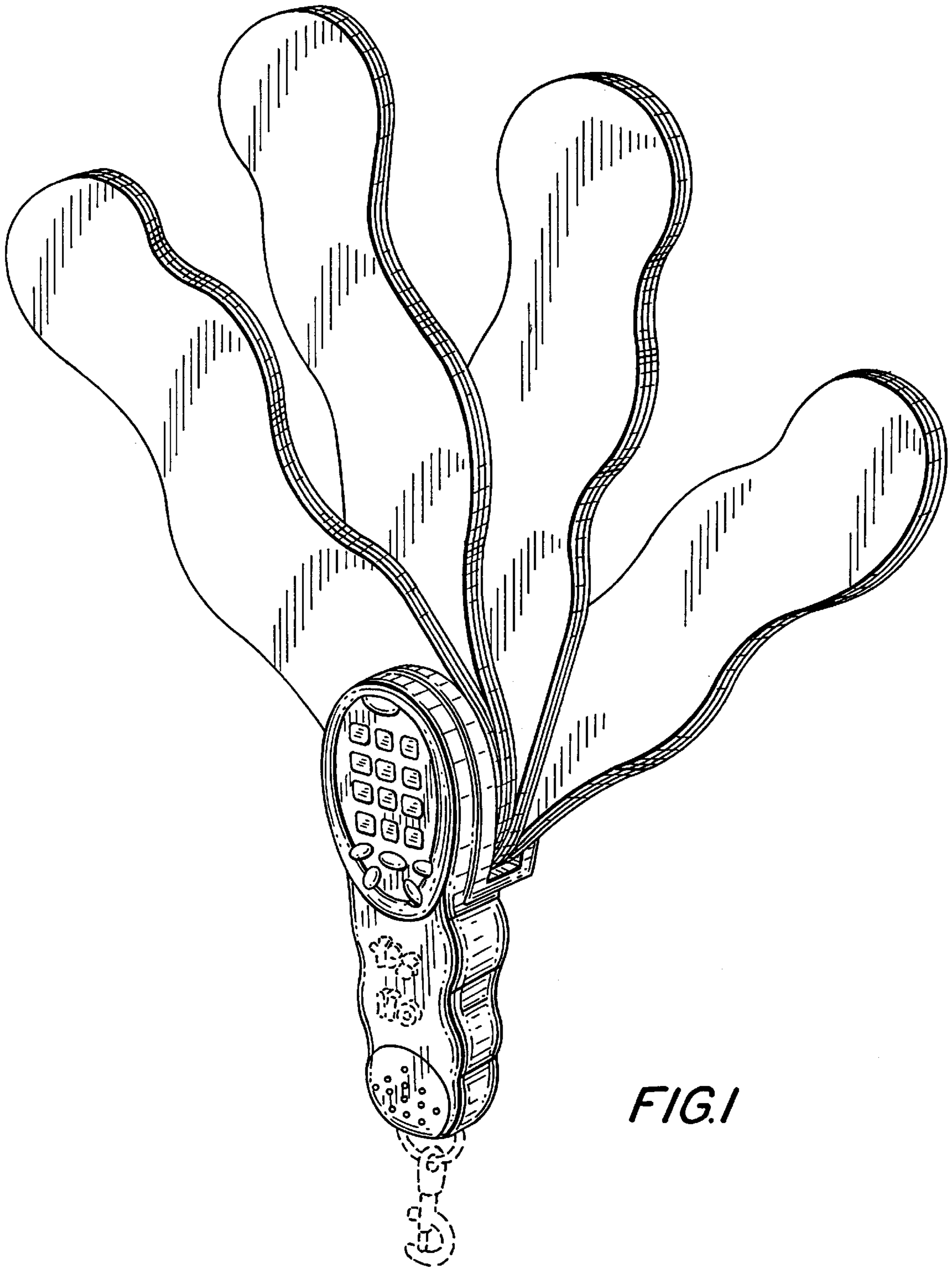

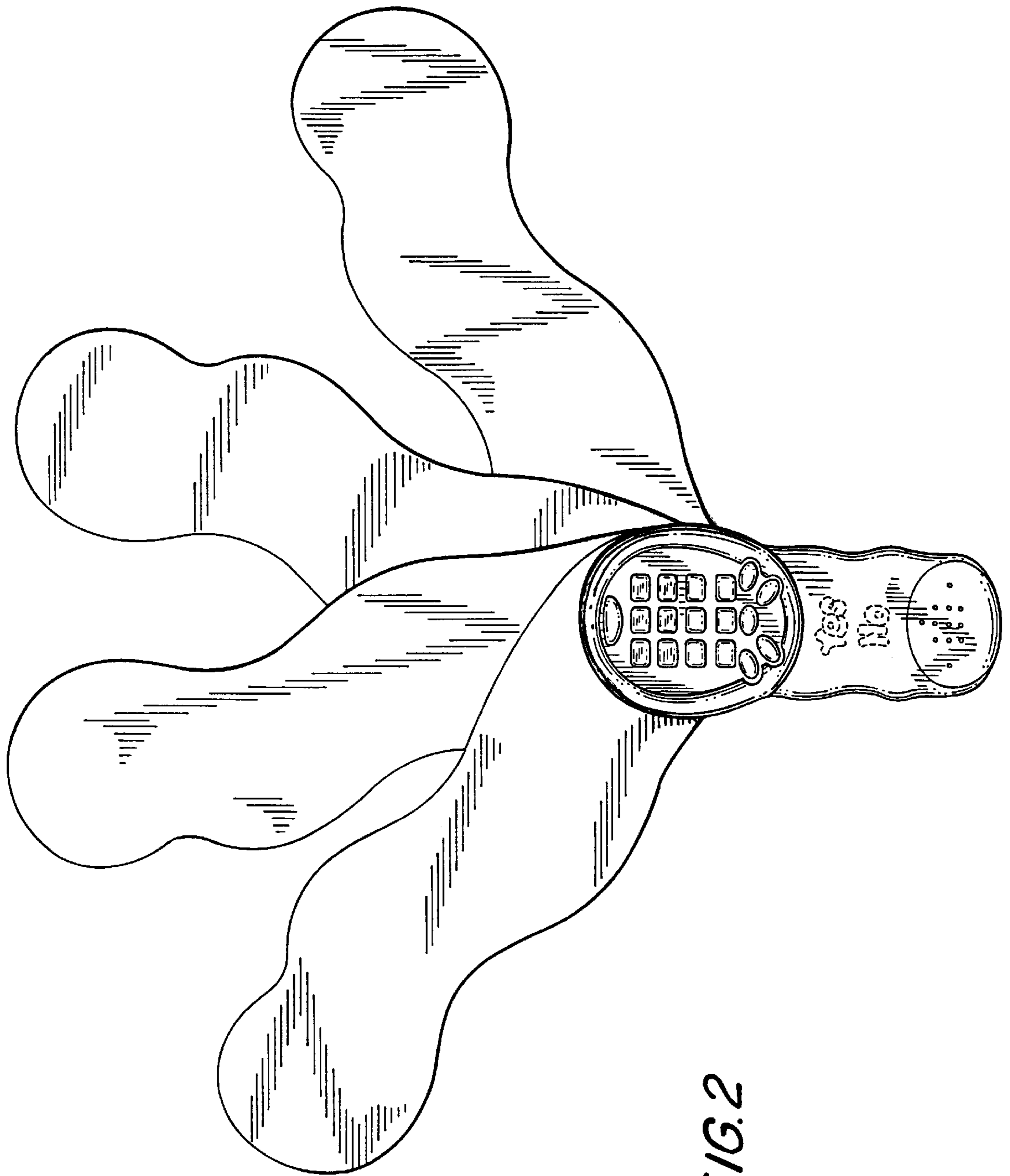

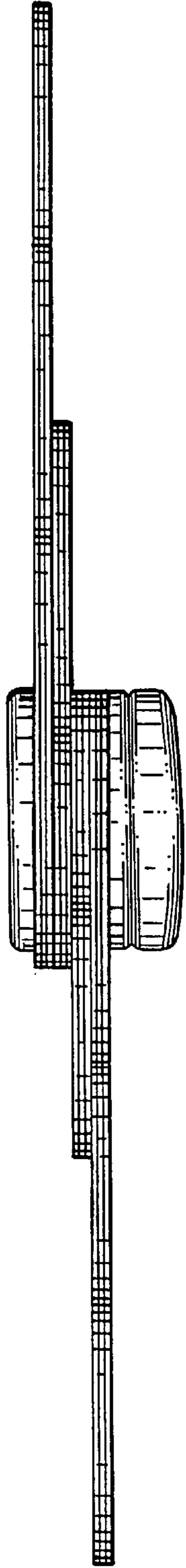

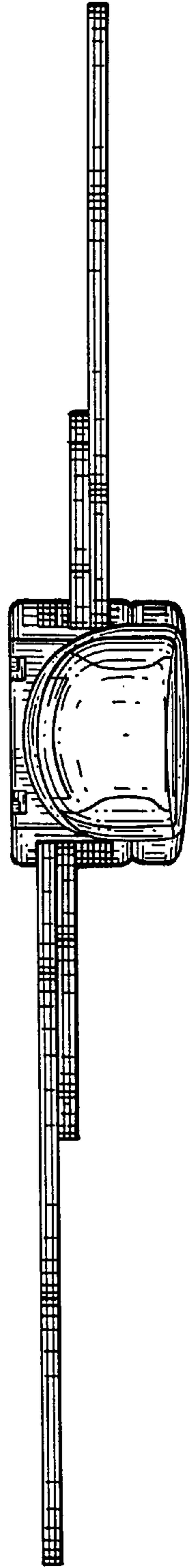

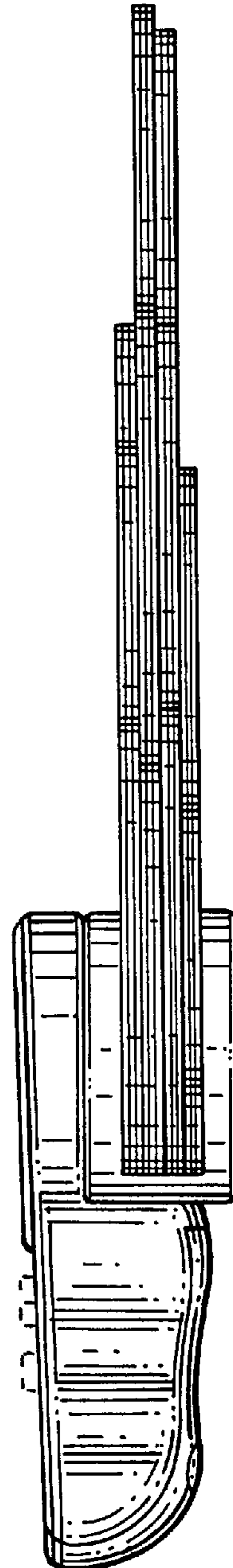
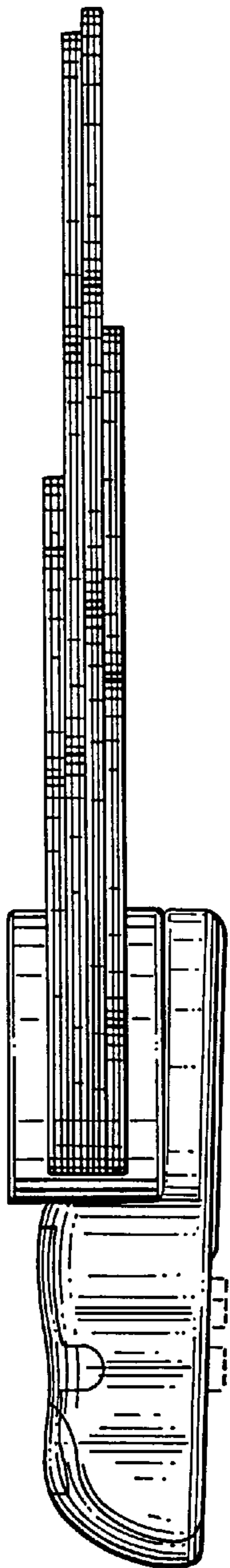
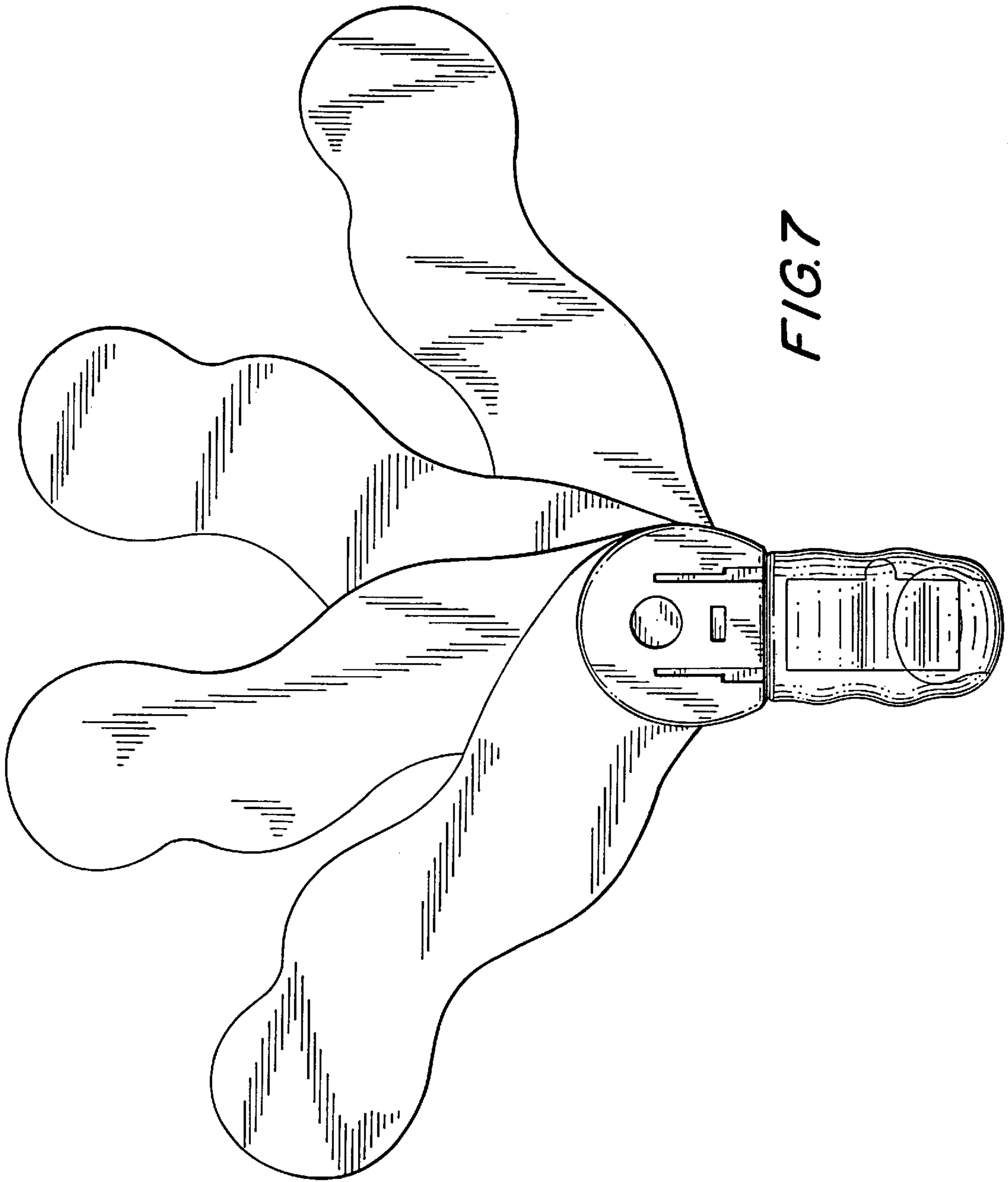
