(57) **CLAIM**

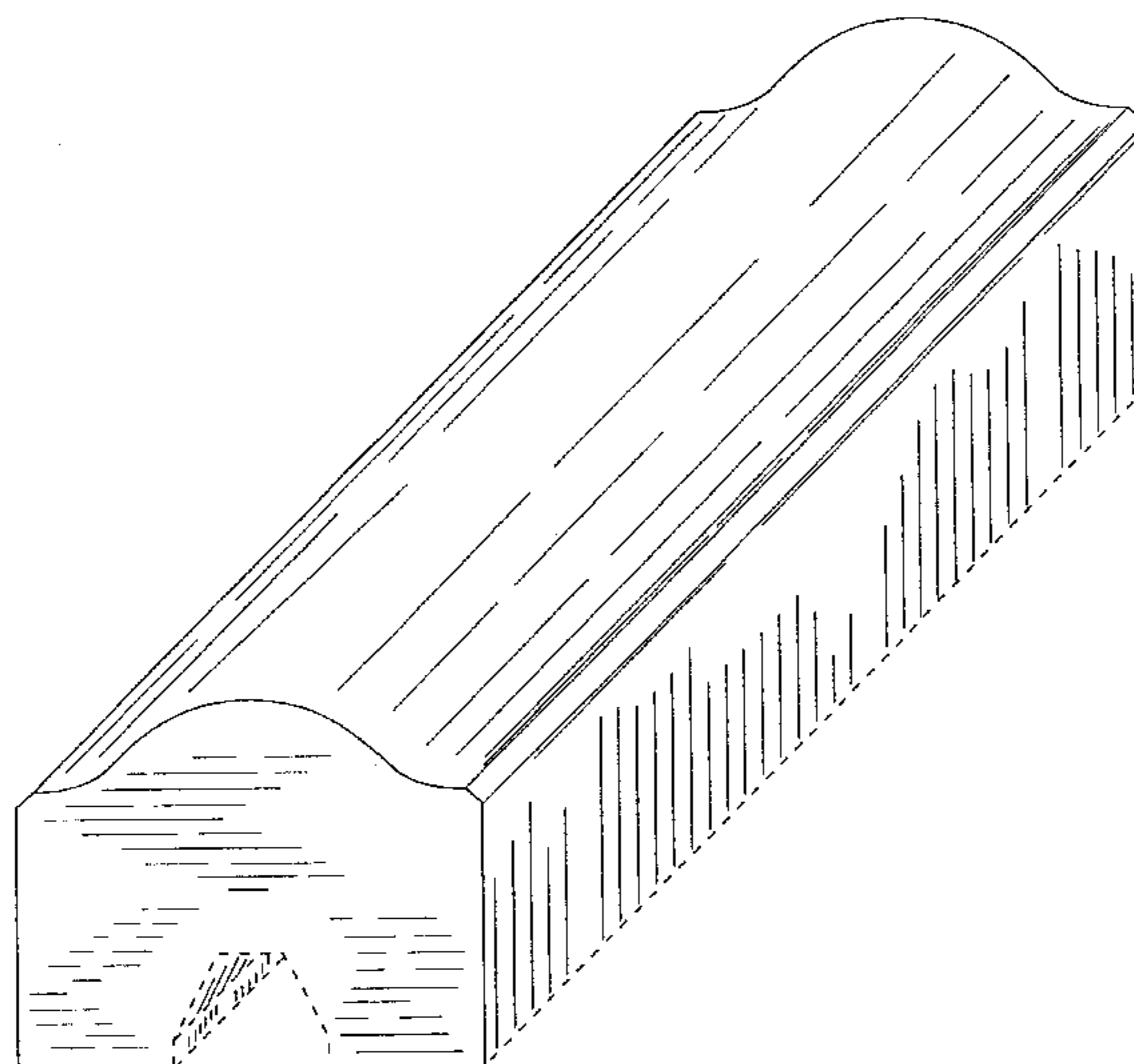
The ornamental design for a straight wall block, as shown  
and described.

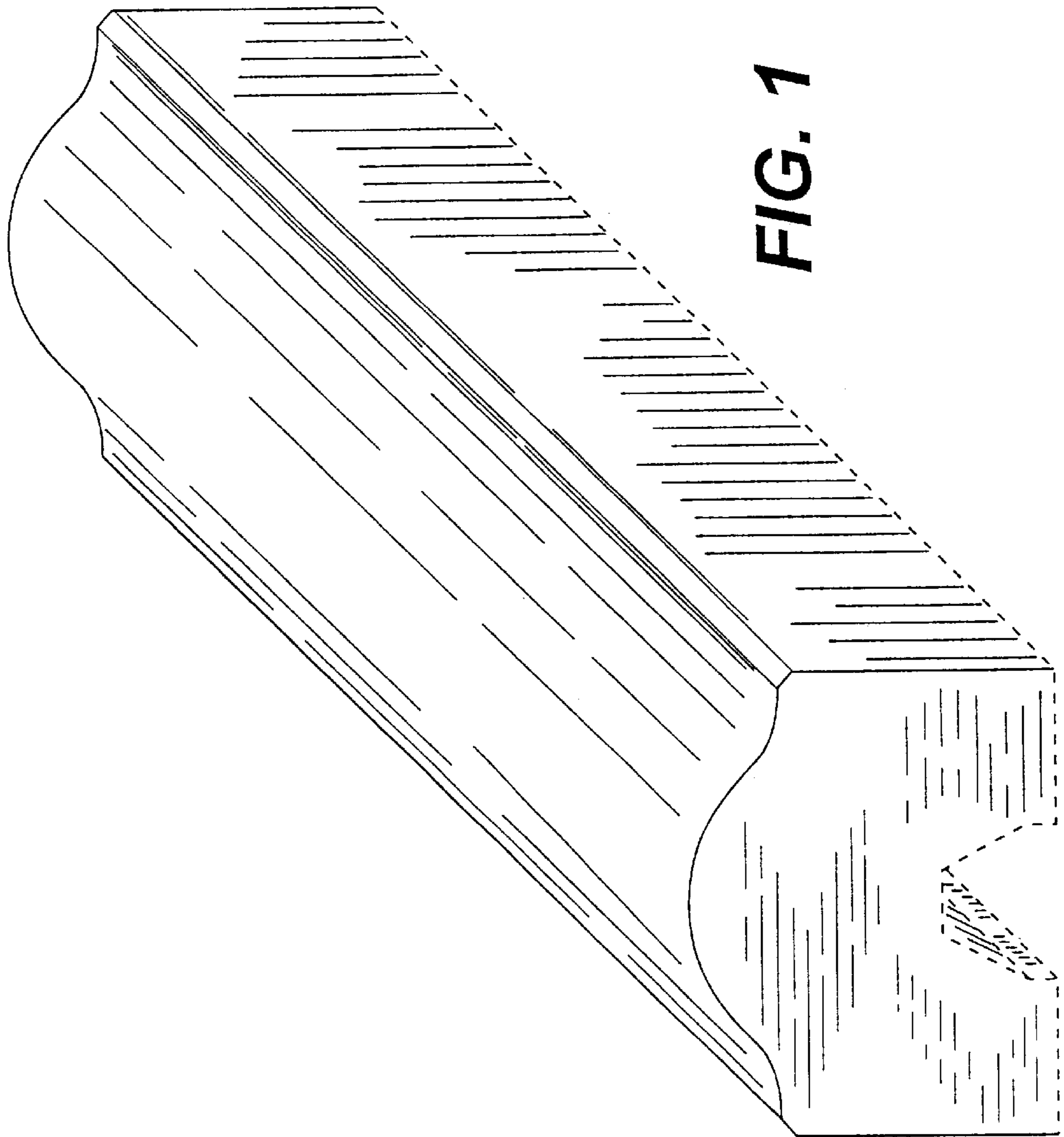
**DESCRIPTION**

FIG. 1 is a perspective view of a straight wall block  
according to our new design;  
FIG. 2 is a right side elevational view of the straight wall  
block shown in FIG. 1;  
FIG. 3 is left side elevational view of the straight wall block  
shown in FIG. 1;  
FIG. 4 is a front elevational view of the straight wall block  
shown in FIG. 1;  
FIG. 5 is a rear elevational view of the straight wall block  
shown in FIG. 1;  
FIG. 6 is a top plan view of the straight wall block shown  
in FIG. 1; and,  
FIG. 7 is a bottom plan view of the straight wall block shown  
in FIG. 1.

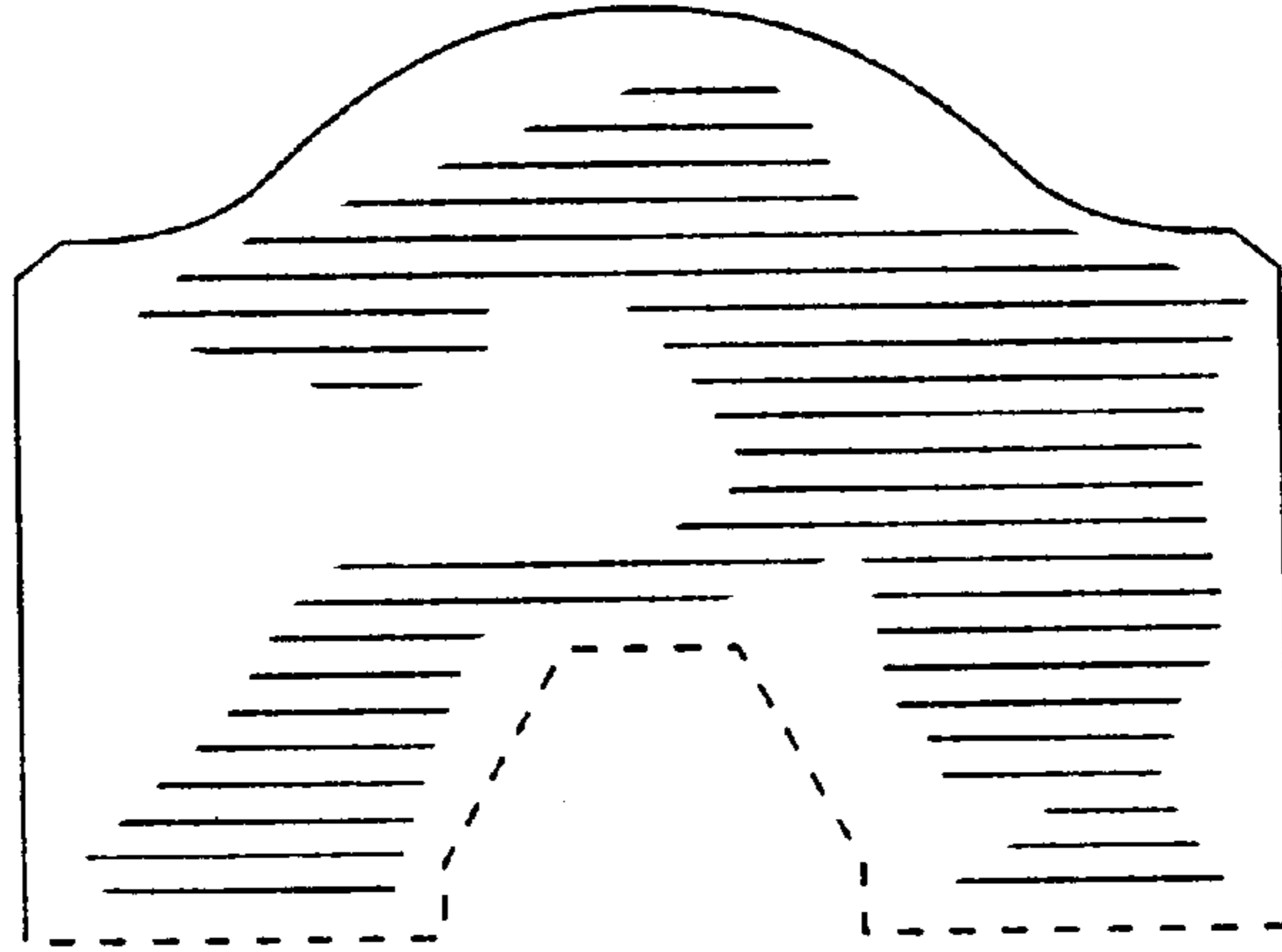
The ornamental design which is claimed is shown in solid

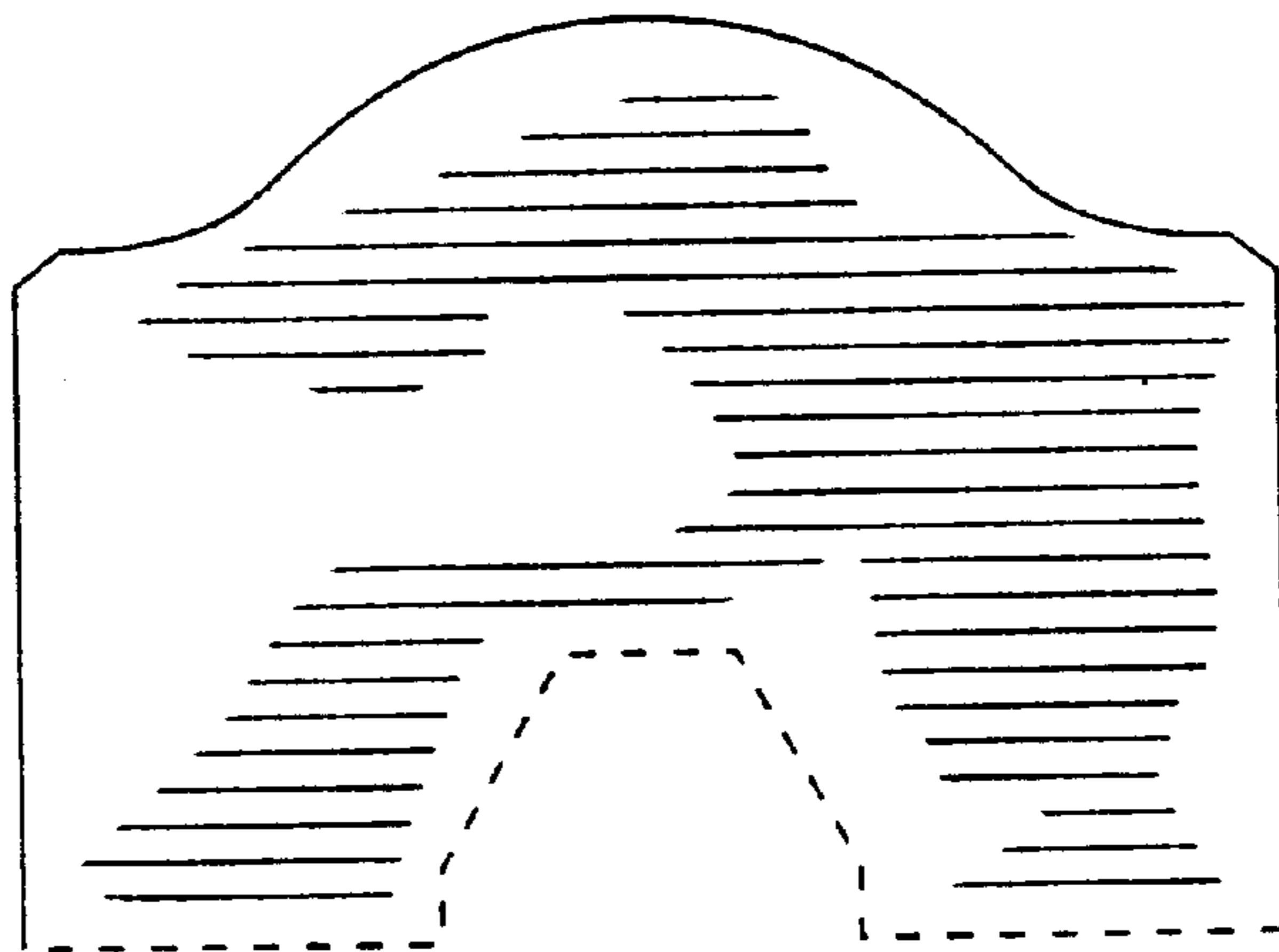




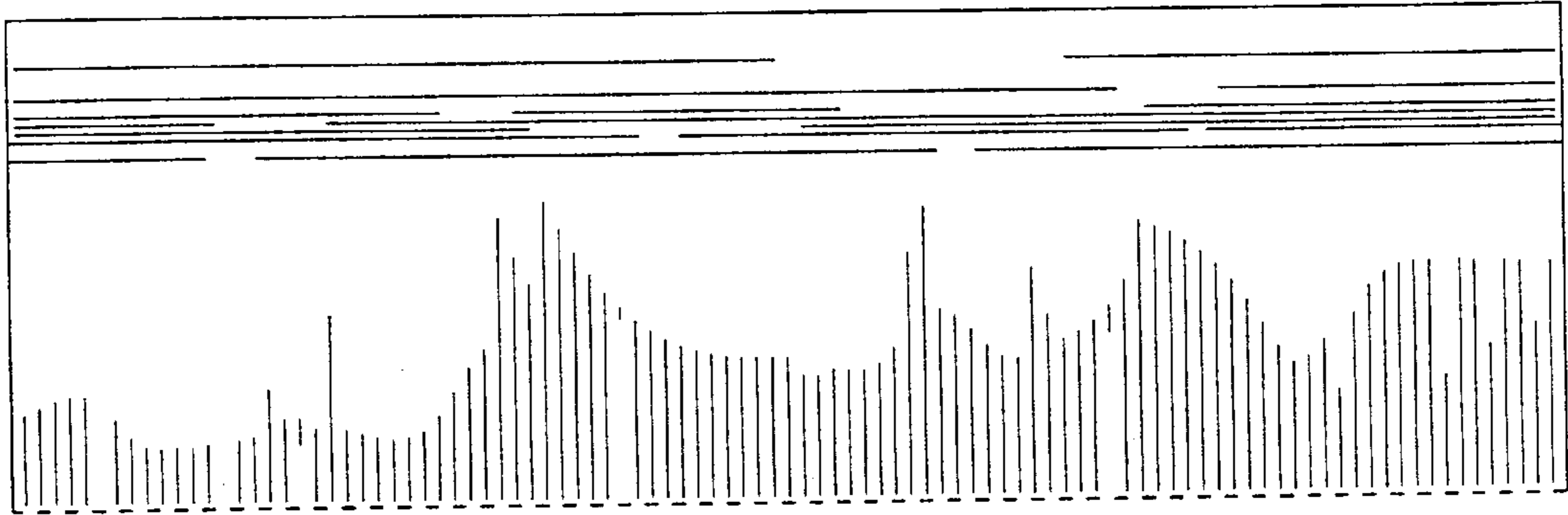

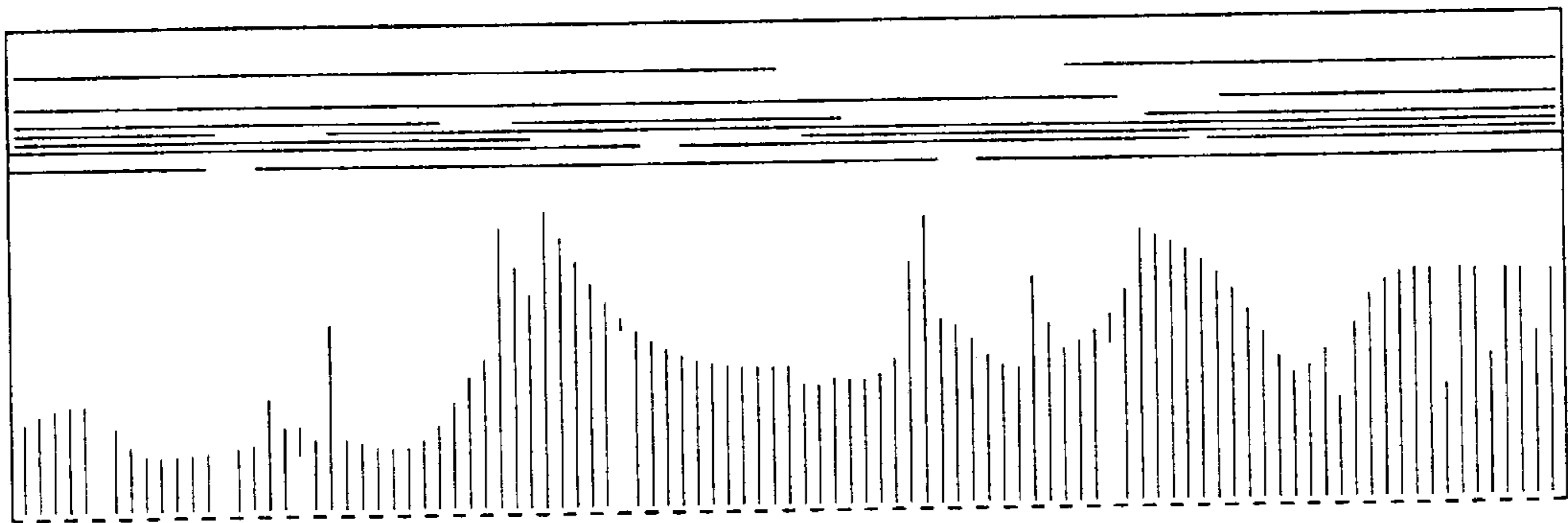

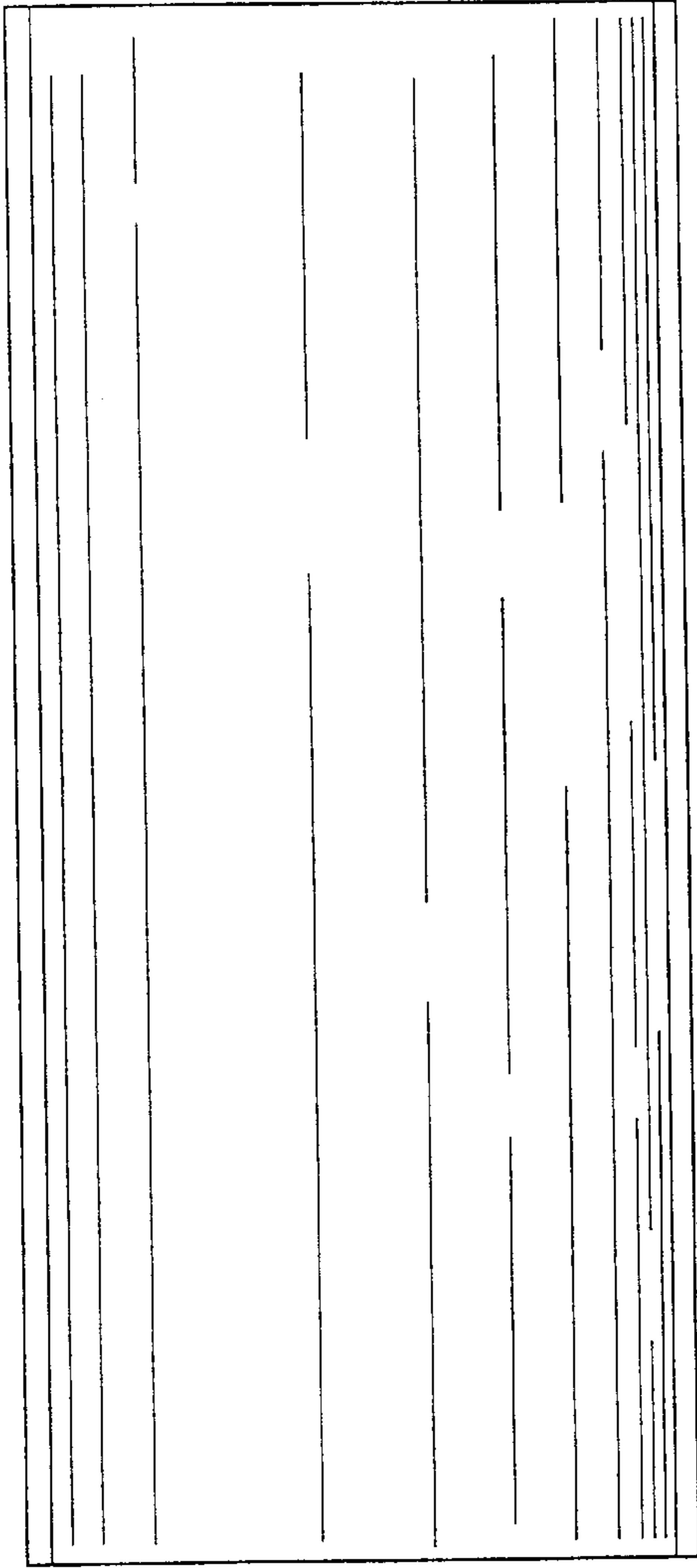

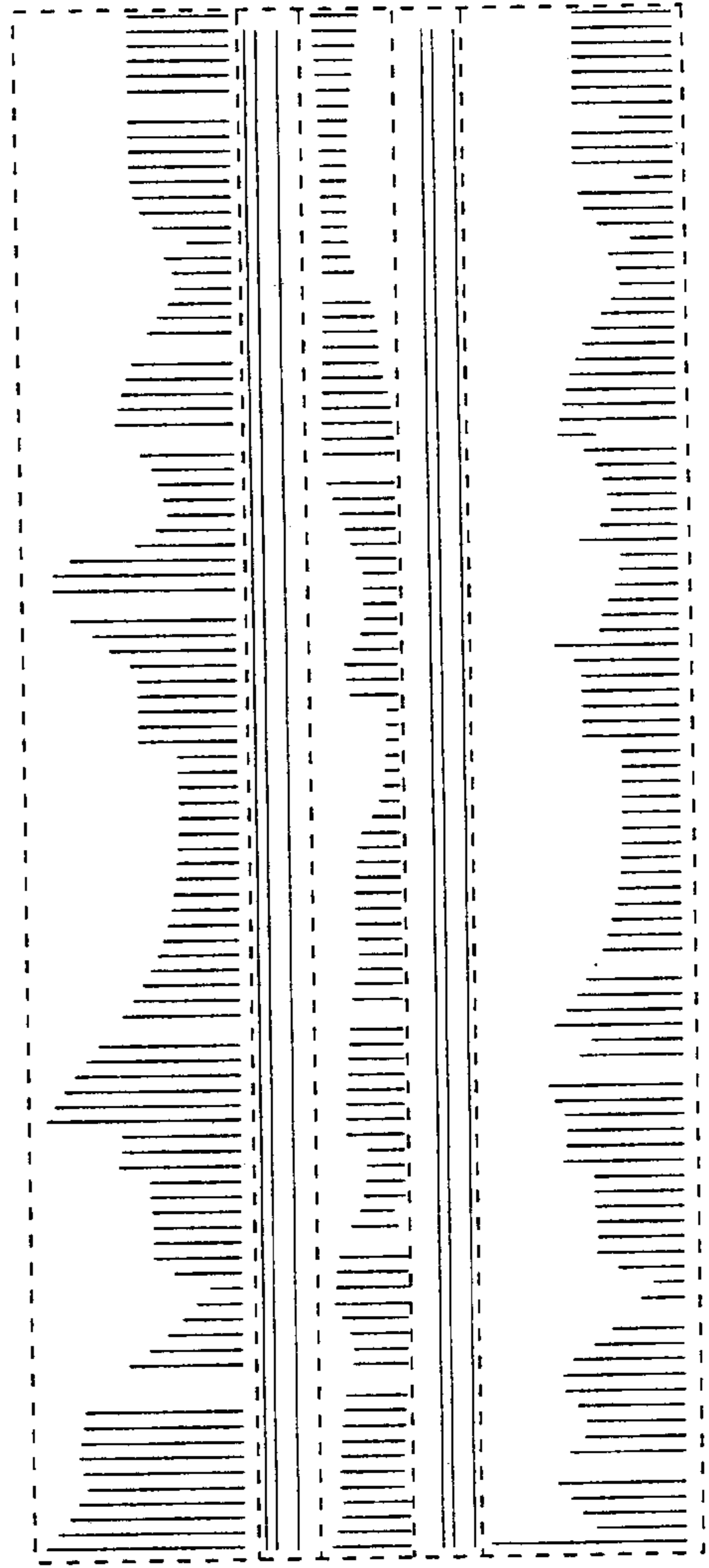
