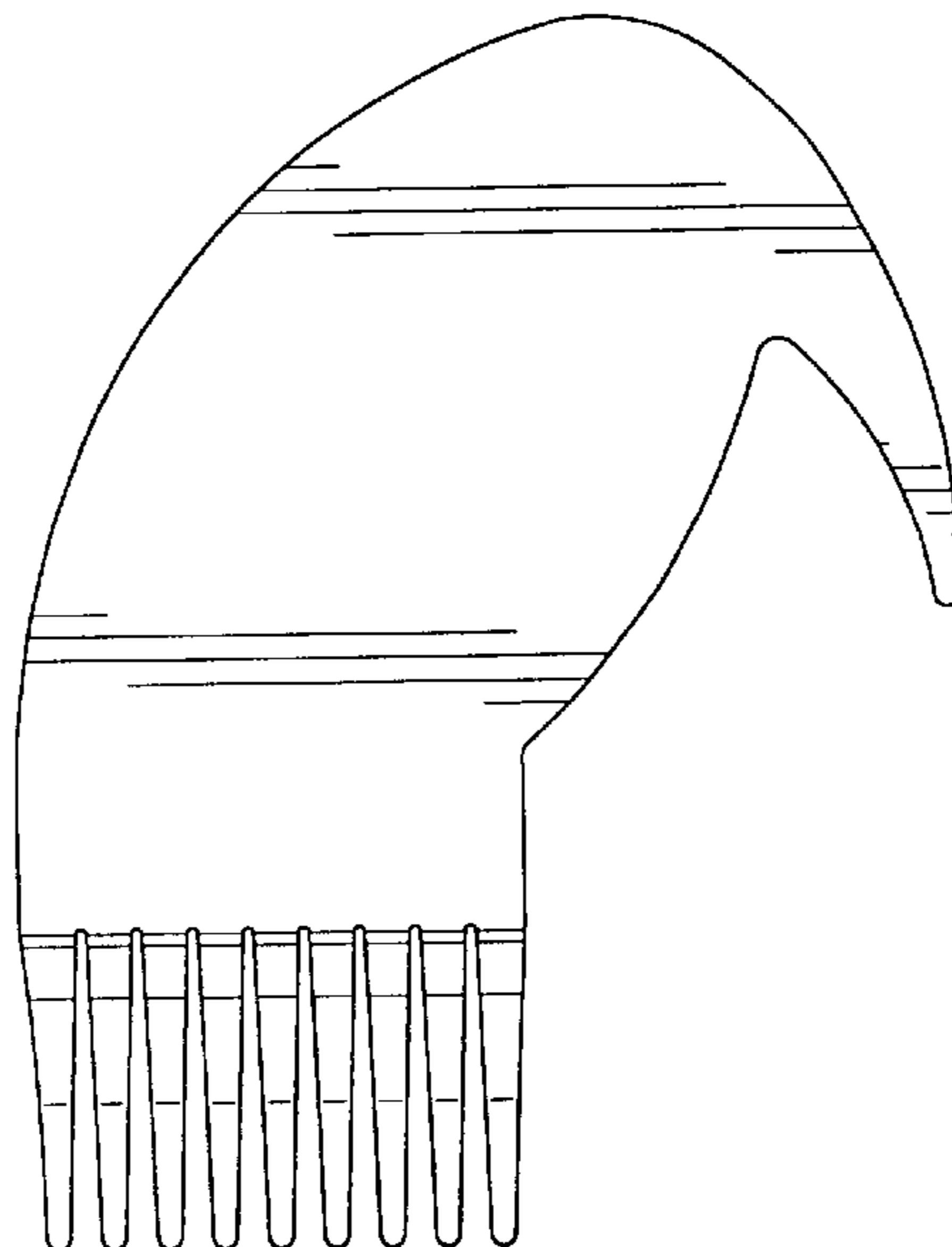
(57) **CLAIM**

The ornamental design for a combination hair comb and pick, as shown and described.

DESCRIPTION

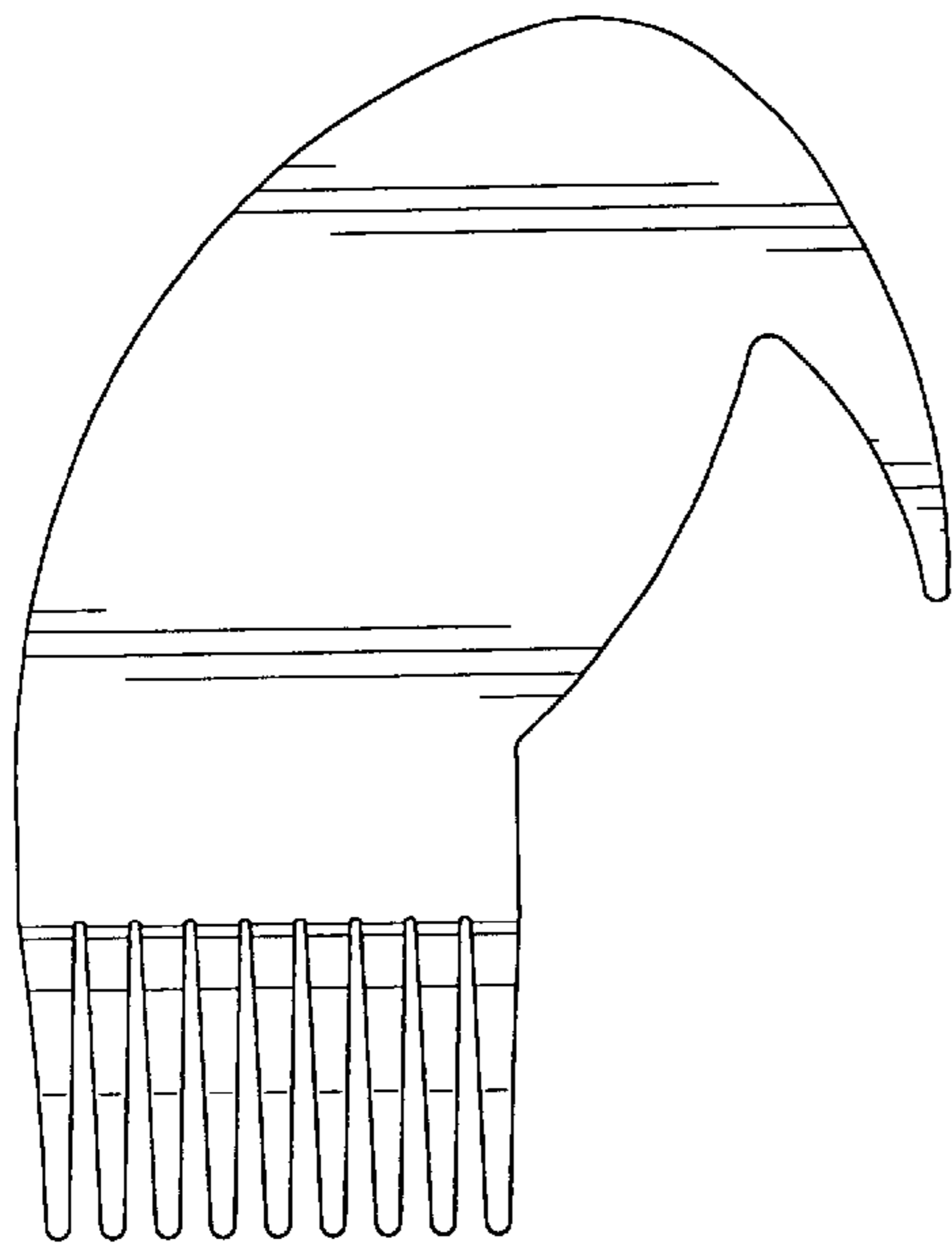

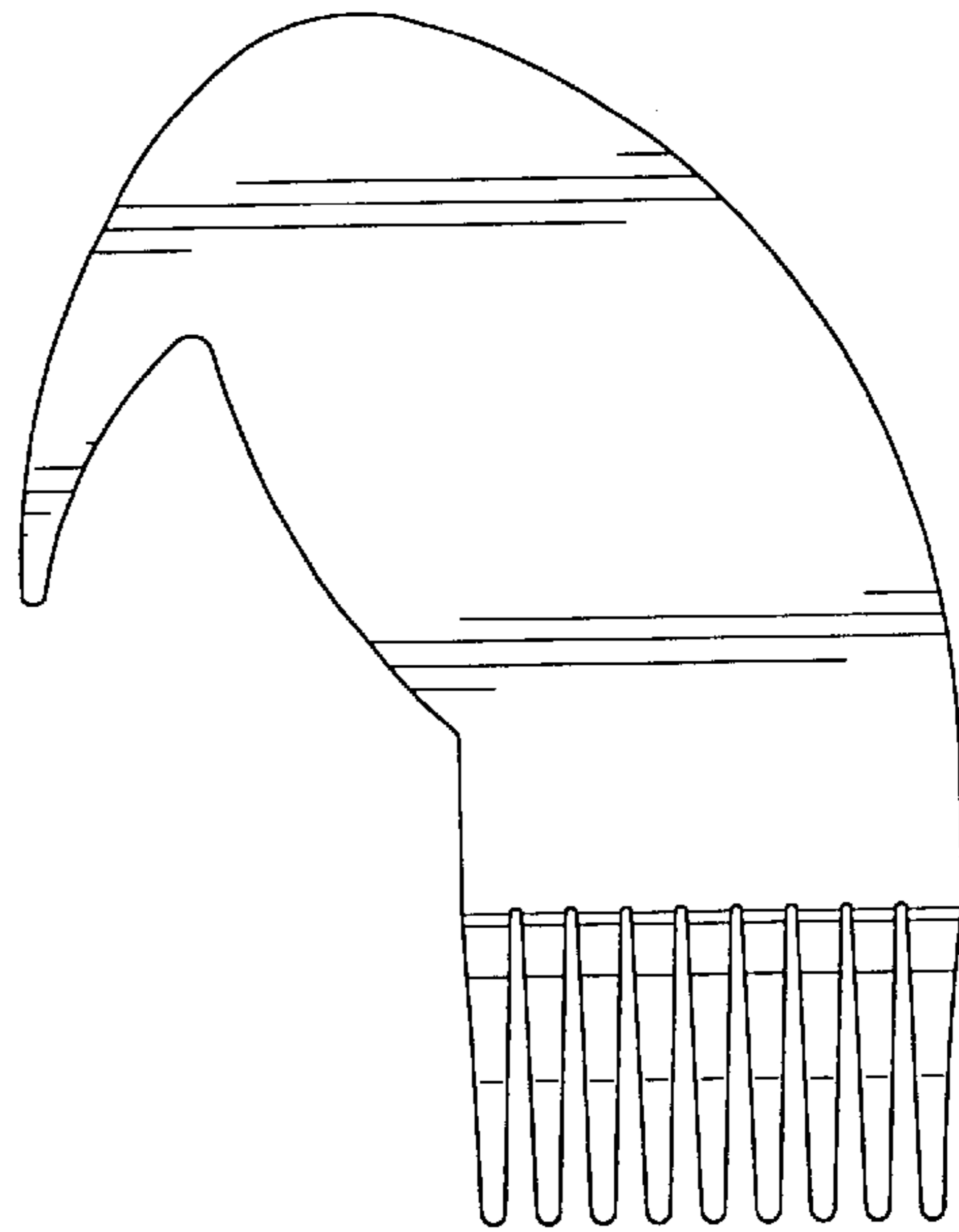

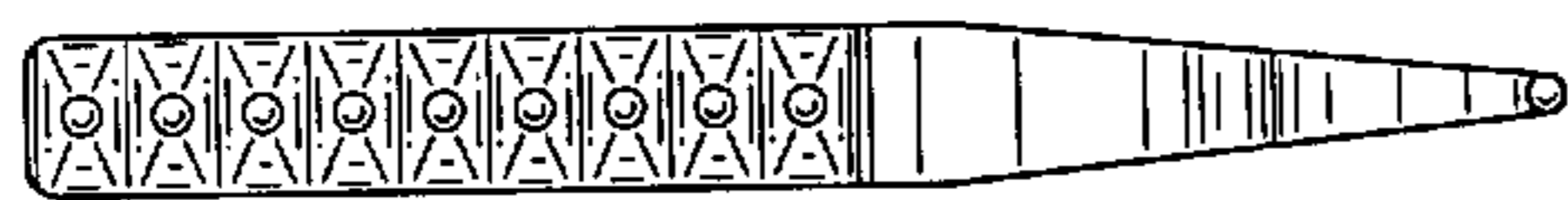

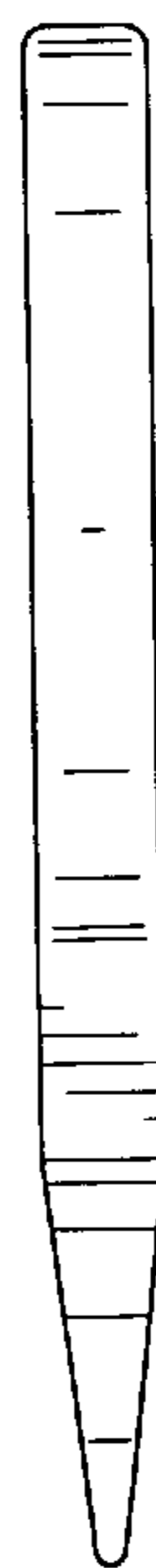

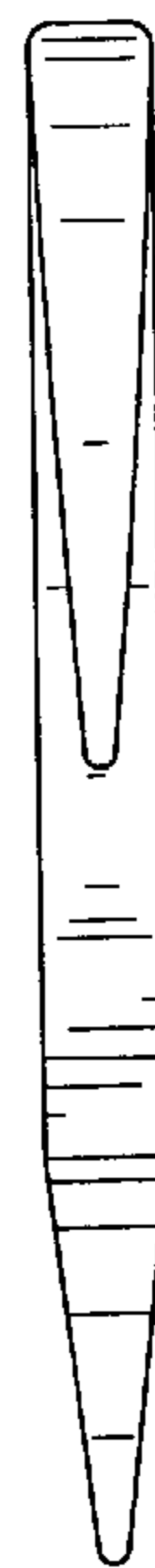

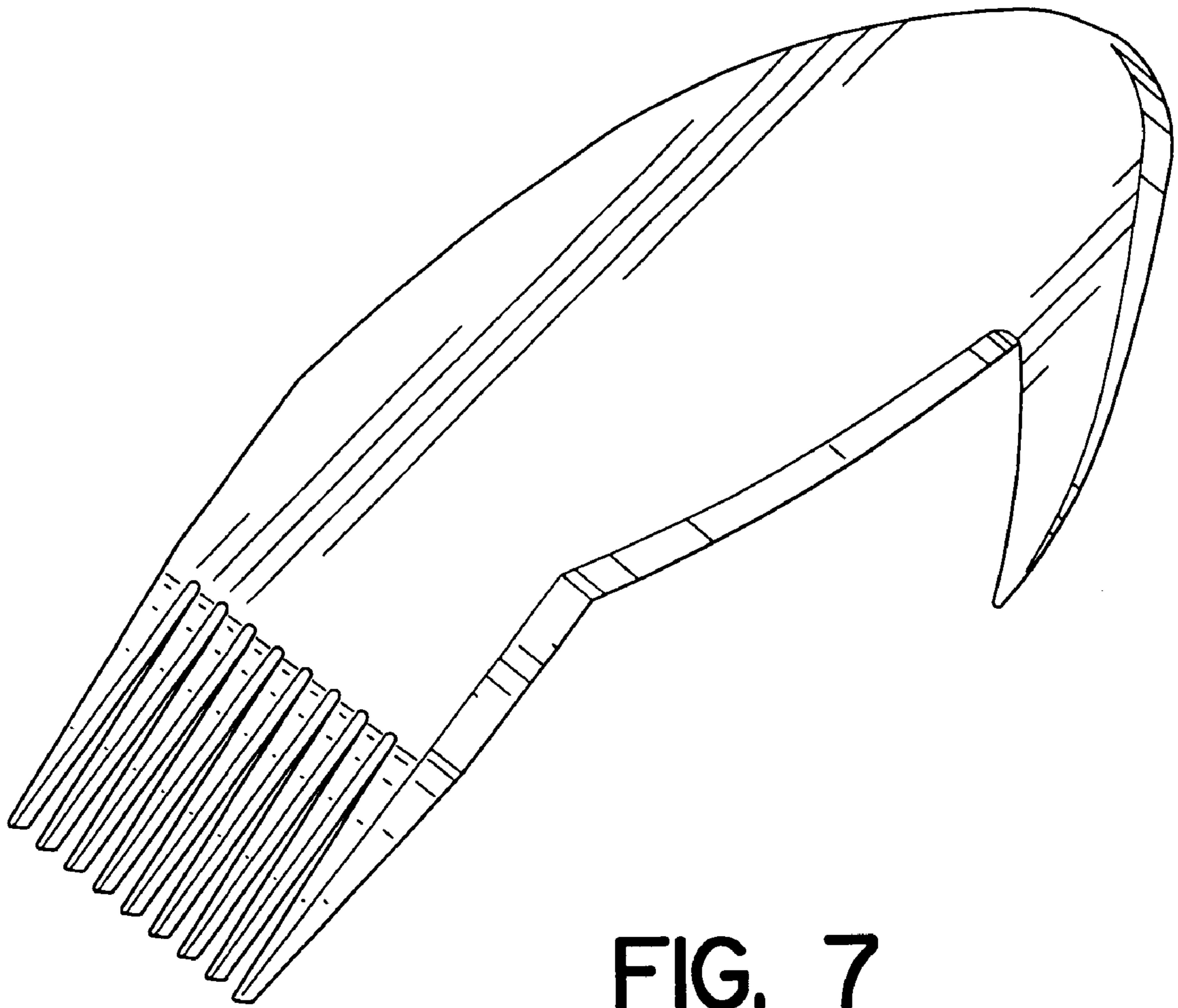

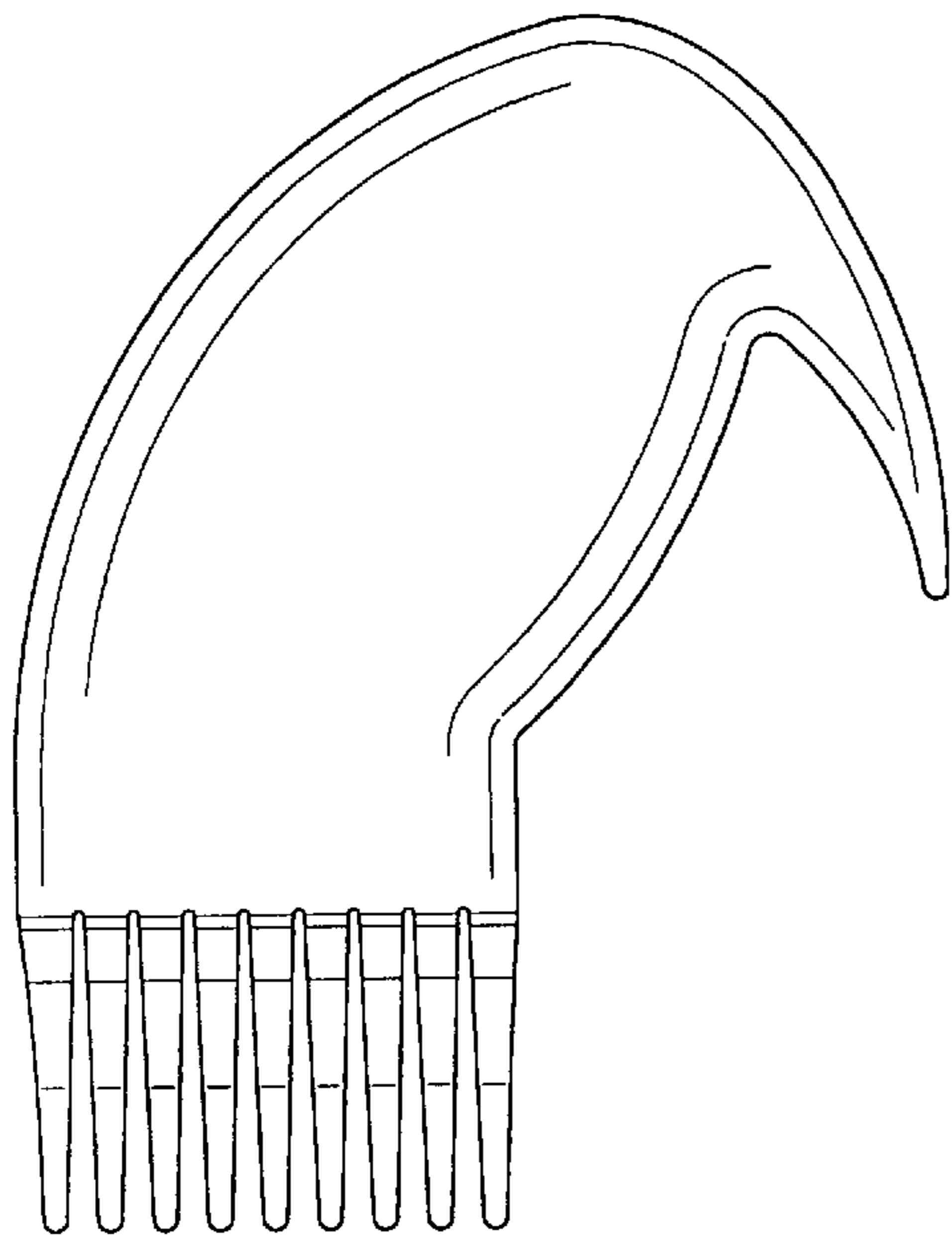

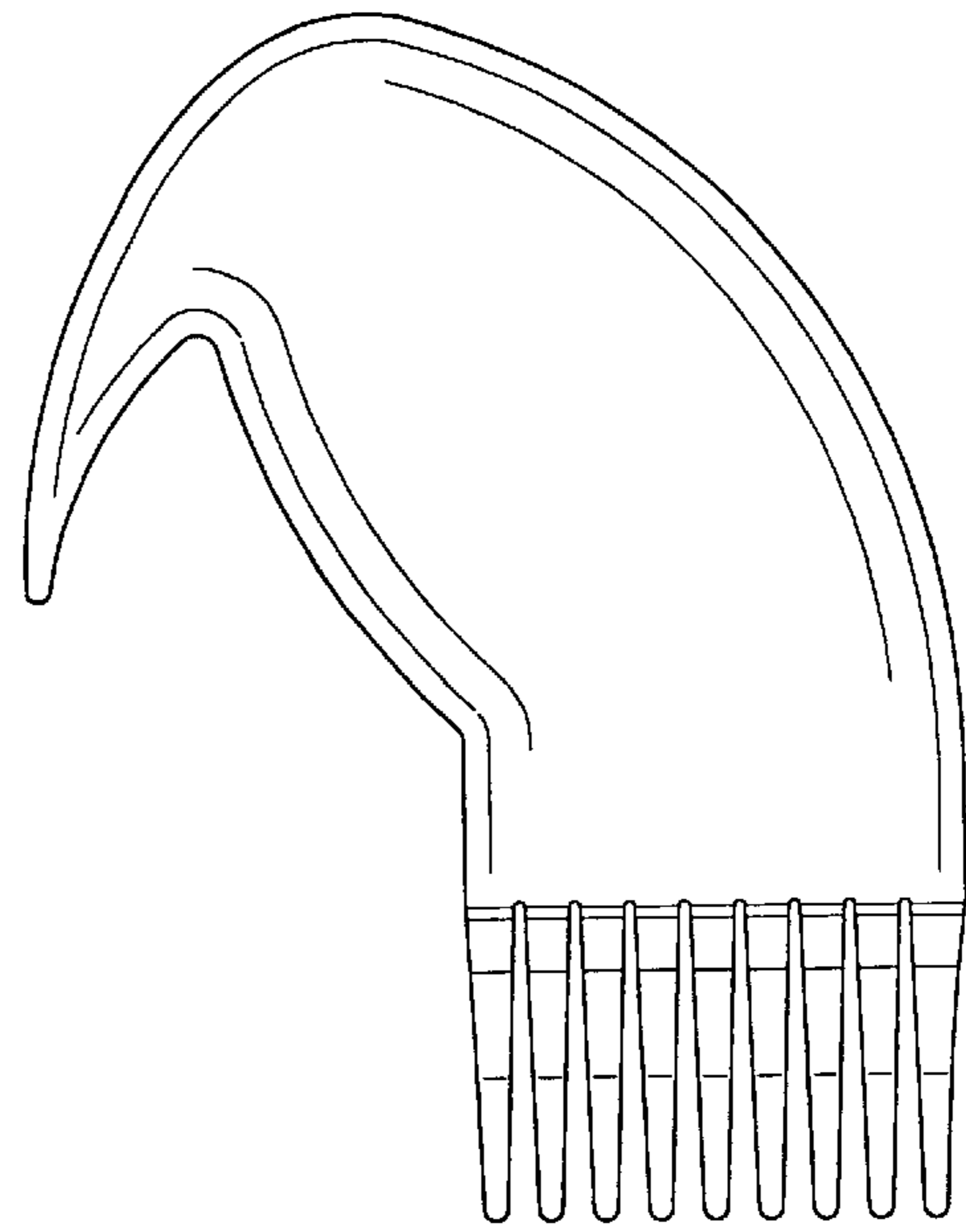

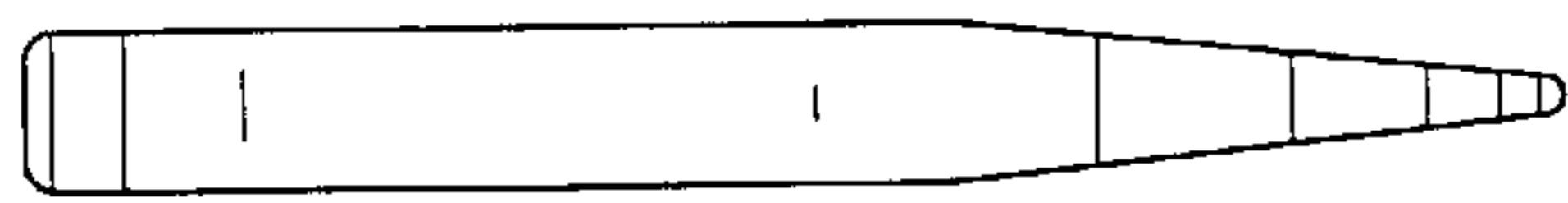

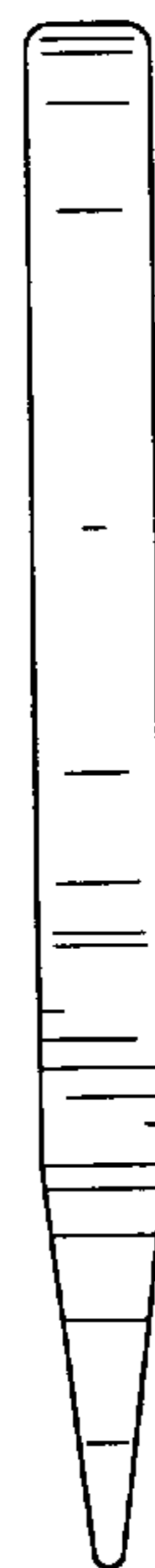

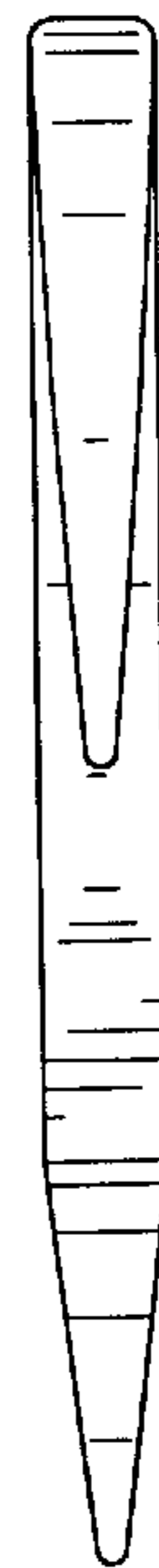

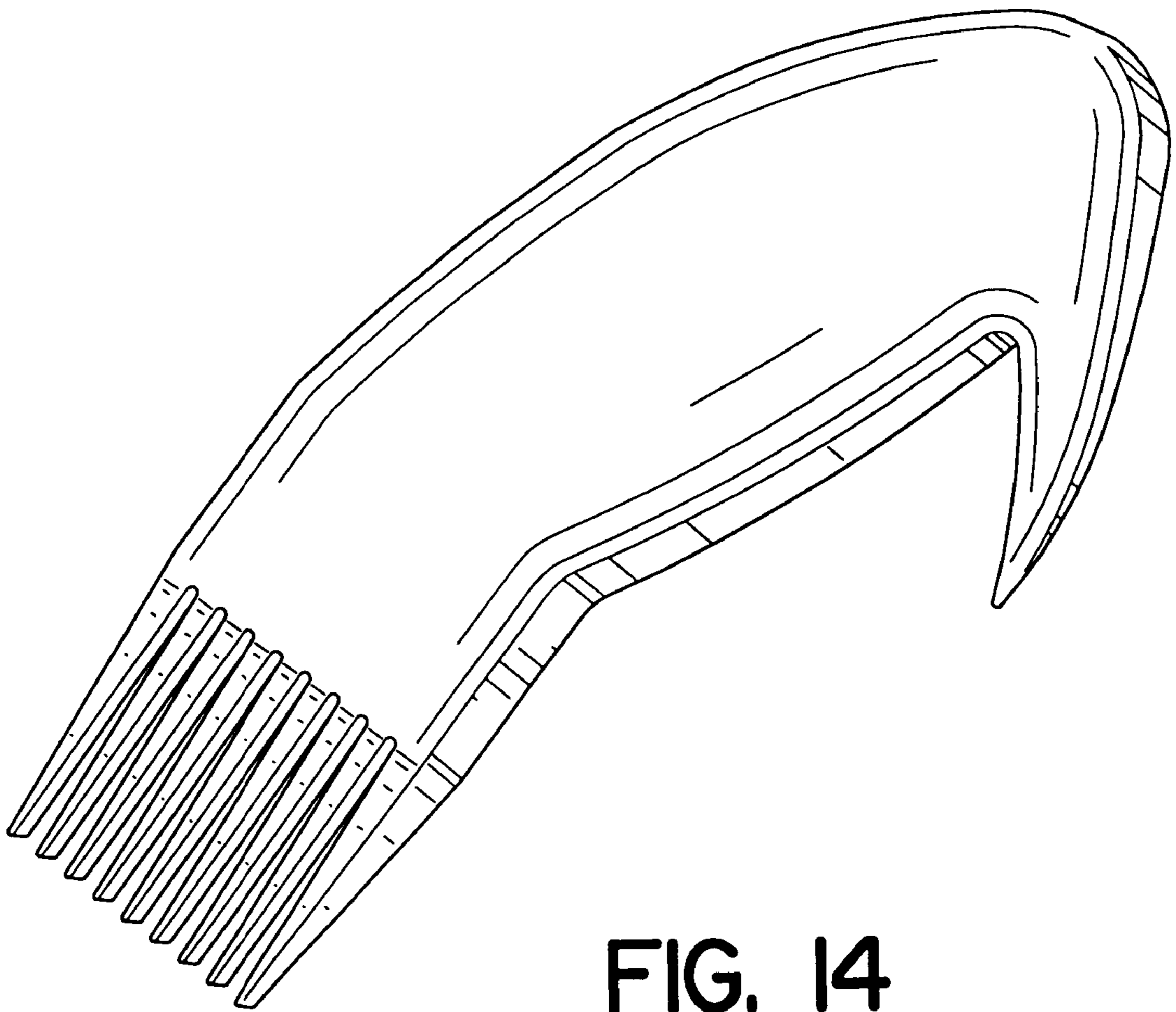
