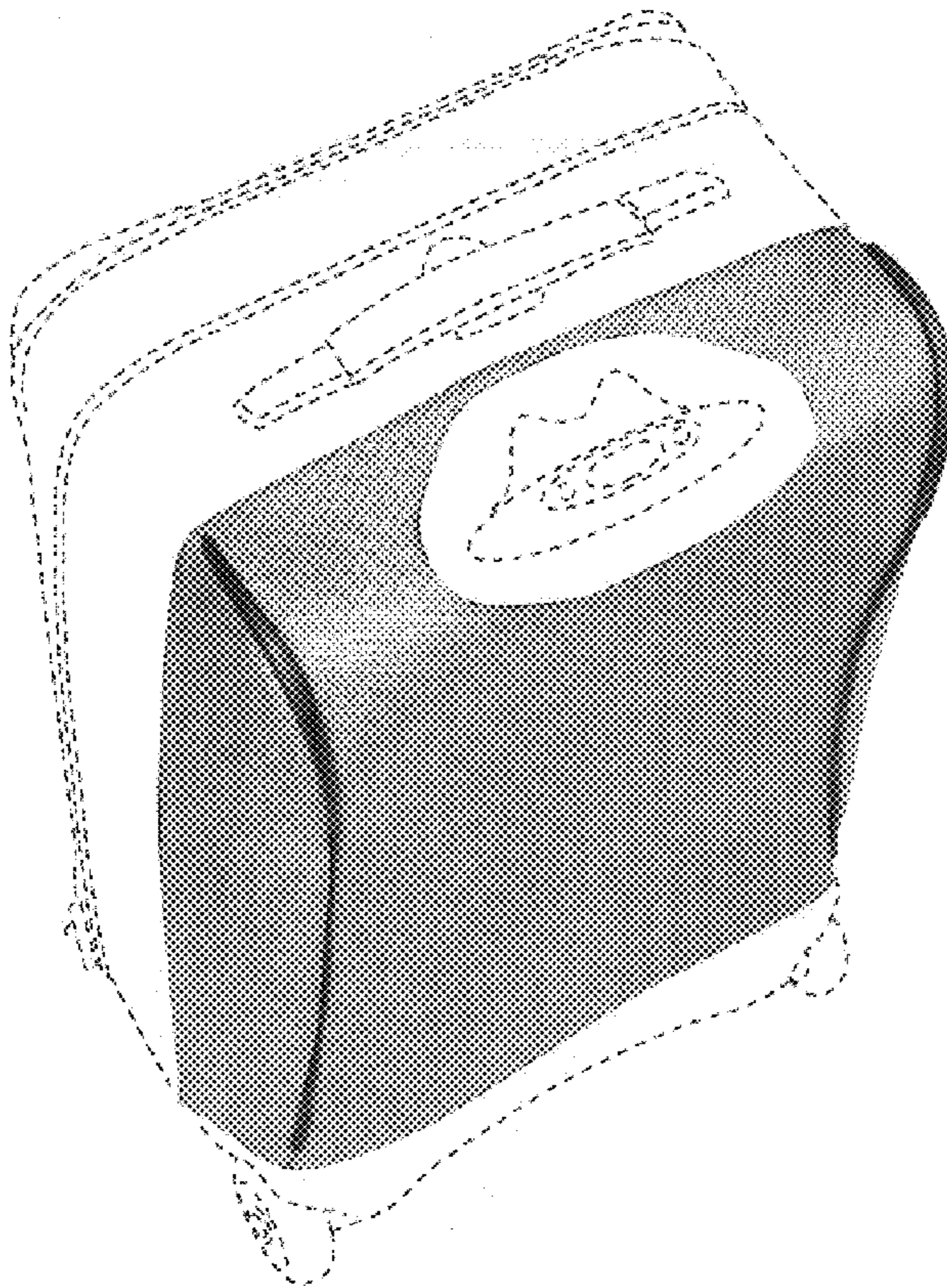
(57) **CLAIM**

The ornamental design of a back facing of a piece of baggage, as shown and described.

DESCRIPTION

FIG. 1 provides a front elevational view of the facing.
 FIG. 2 provides a left side elevational view of the facing.
 FIG. 3 provides a right side elevational view of the facing.
 FIG. 4 provides a top view of the facing.
 FIG. 5 provides a bottom view of the facing; and,
 FIG. 6 provides a perspective view of the facing.
 The broken line showing the remaining structure of a piece of baggage is for illustrative purposes only and forms no part of the claimed design.

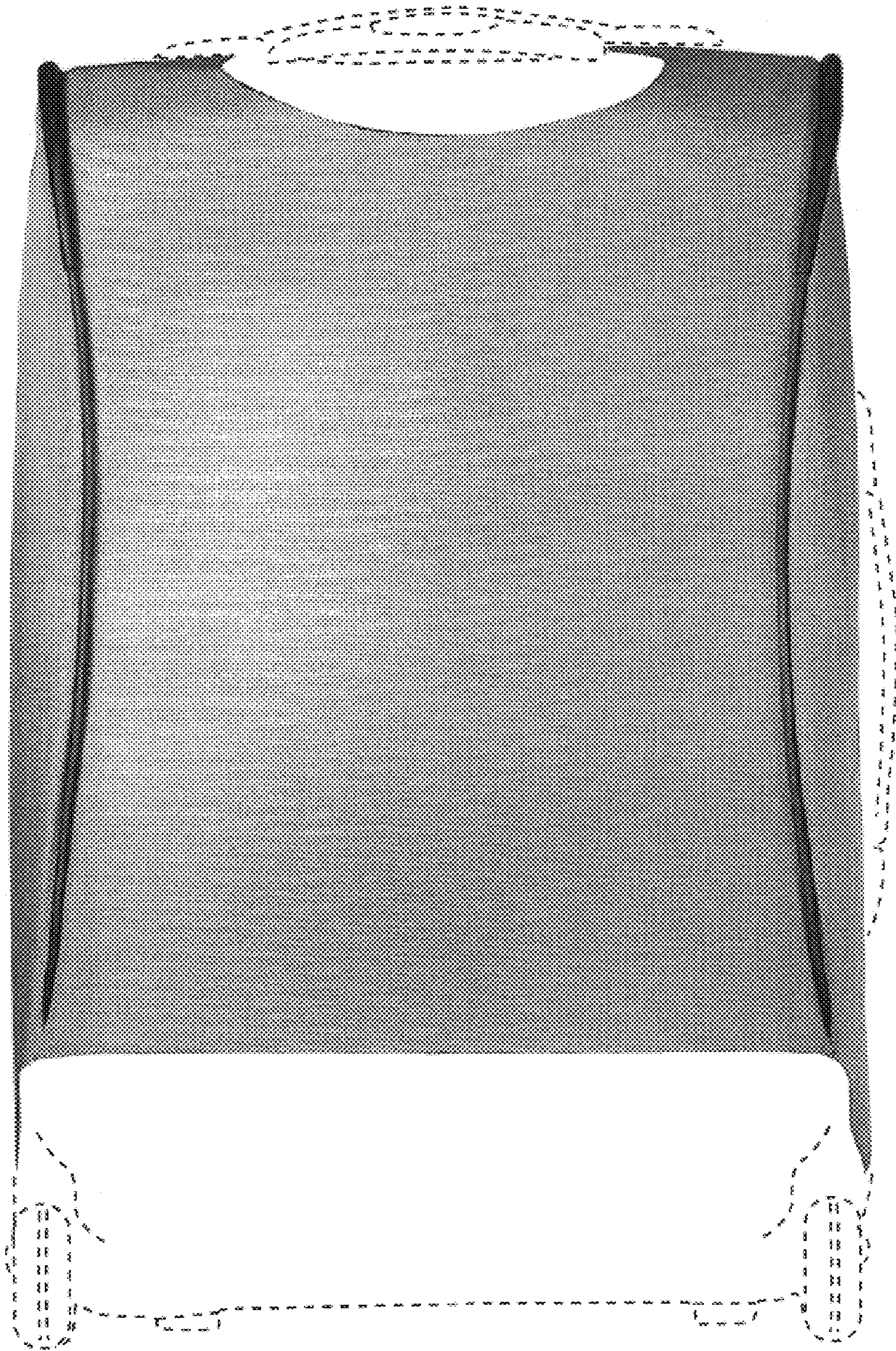

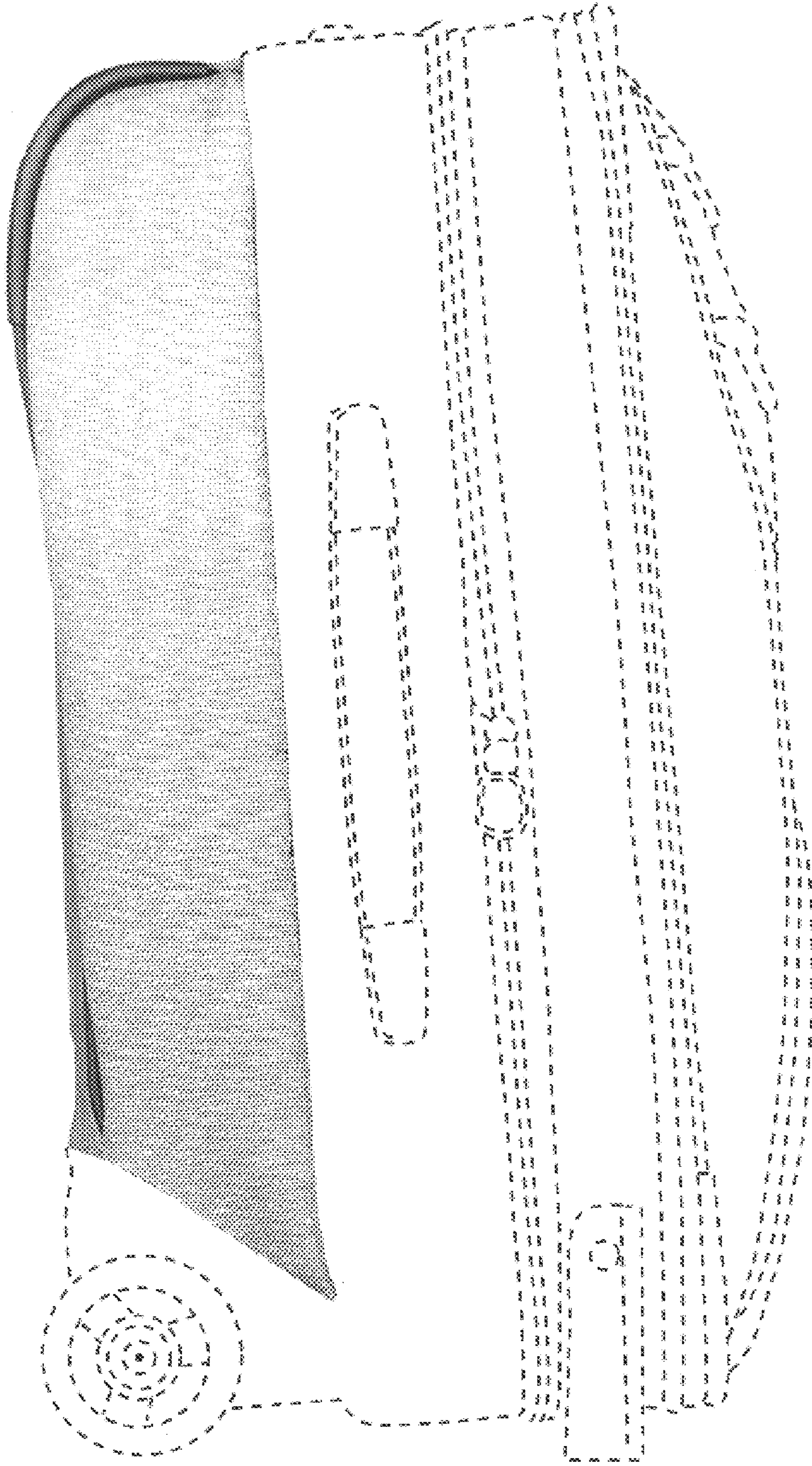

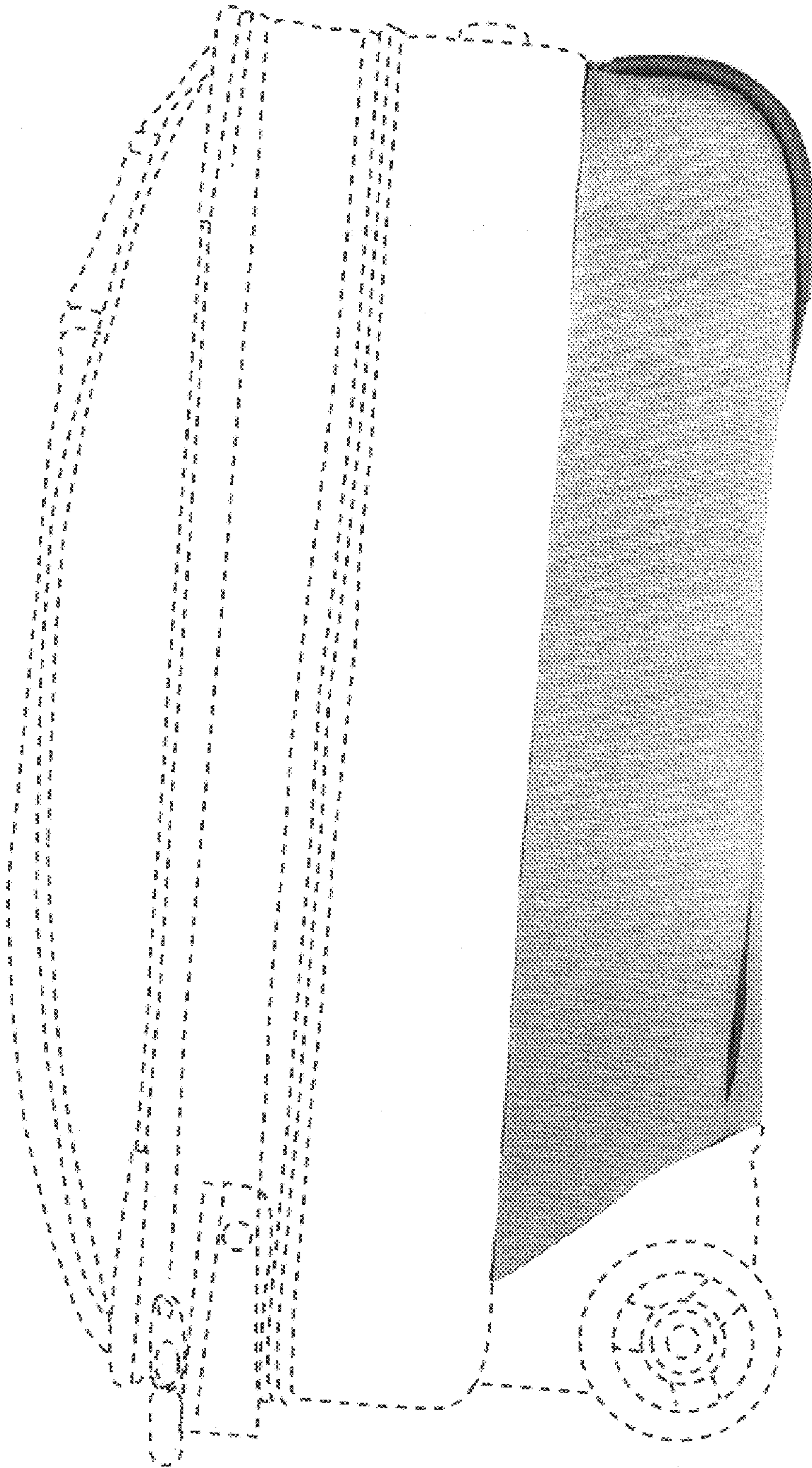

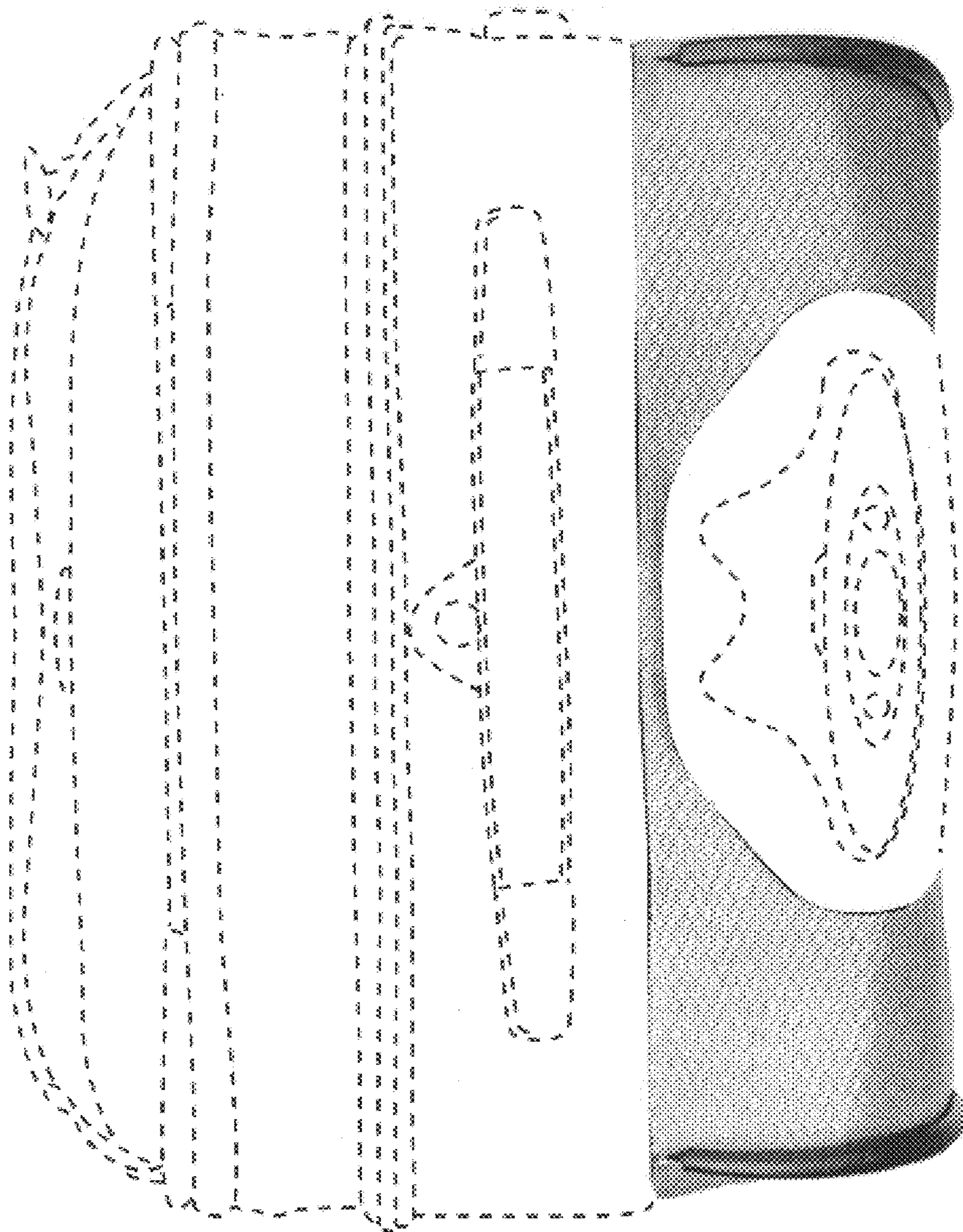

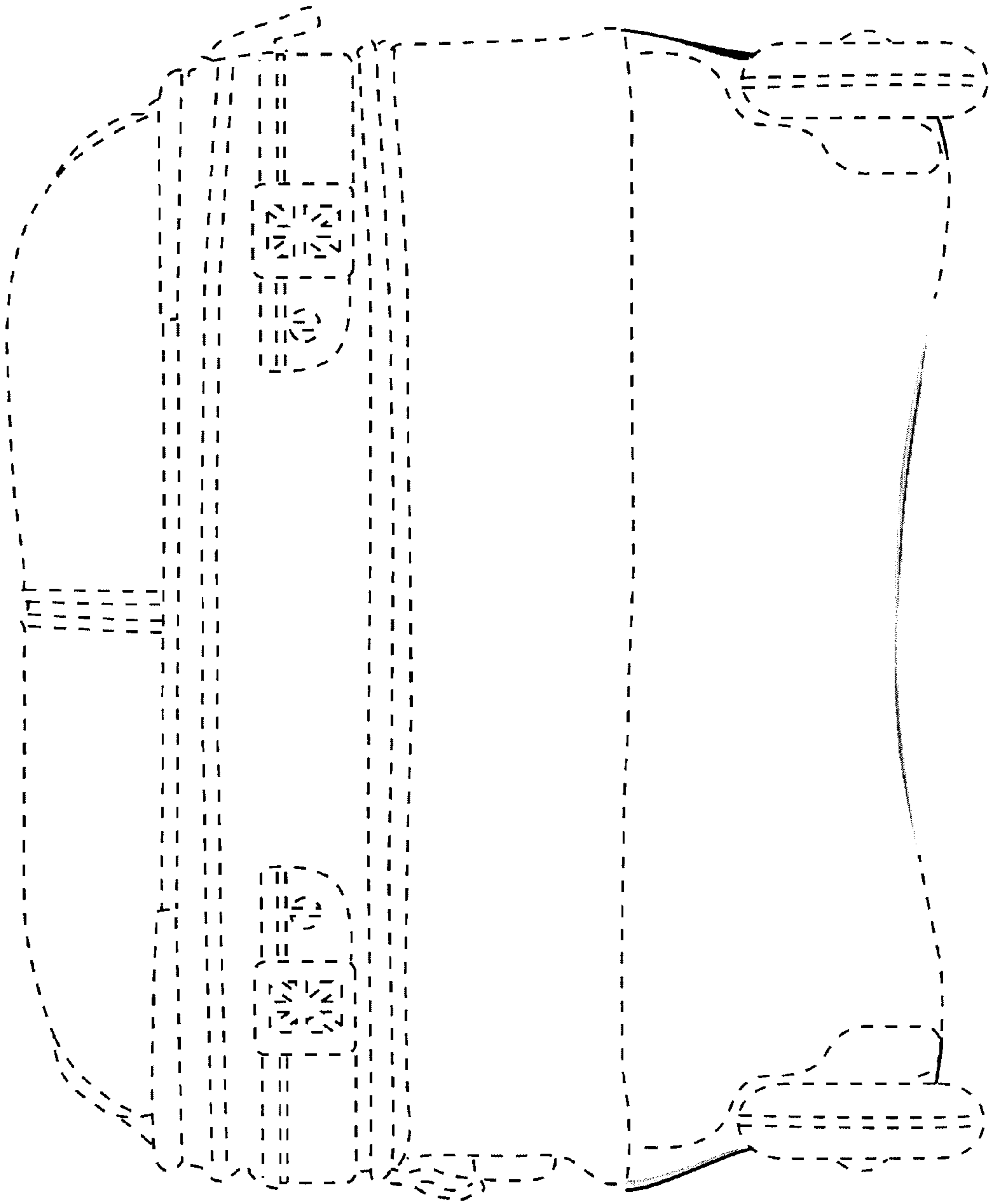

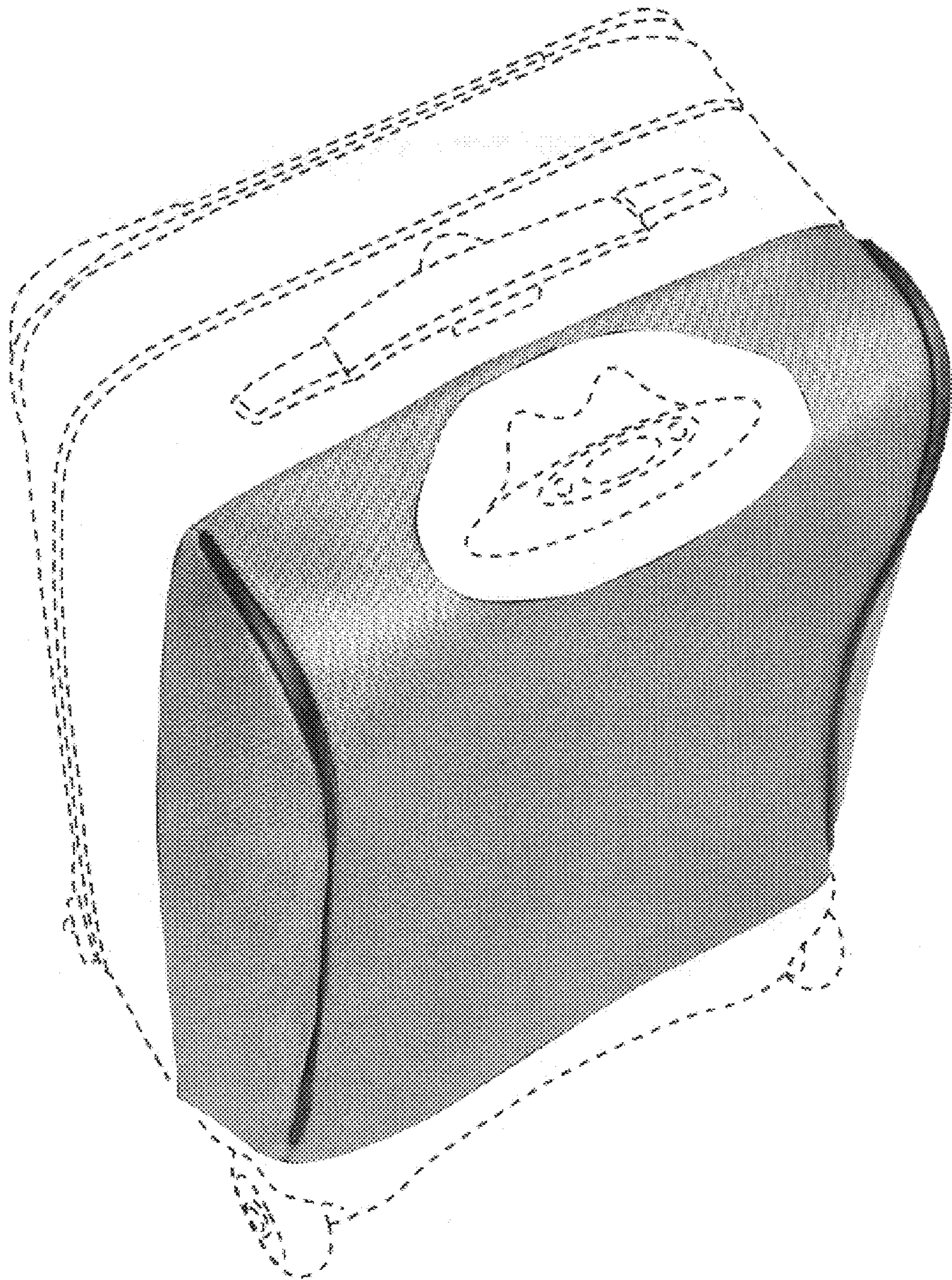
