(57) **CLAIM**

The ornamental design for a safety razor holder, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a safety razor holder showing my new design;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a right side elevational view thereof, the left side elevational view being a mirror image thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a cross-sectional view taken along line 6—6 in FIG. 1;

FIG. 7 is a cross-sectional view taken along line 7—7 in FIG. 1;

FIG. 8 is a perspective view thereof;

FIG. 9 is a referential top plan view showing the safety razor holder in an opened state and a blade cartridge holder, which is connected to the safety razor holder, in an opened state; and

FIG. 10 is a referential top plan view showing the safety razor holder in a state holding a safety razor; and,

FIG. 11 is a referential top plan view showing the safety razor holder in a closed state and the blade cartridge holder accommodating blade cartridges in an opened state.

The broken lines in FIGS. 1 to 11 are shown for illustrative purposes only and form no part of the claimed design.

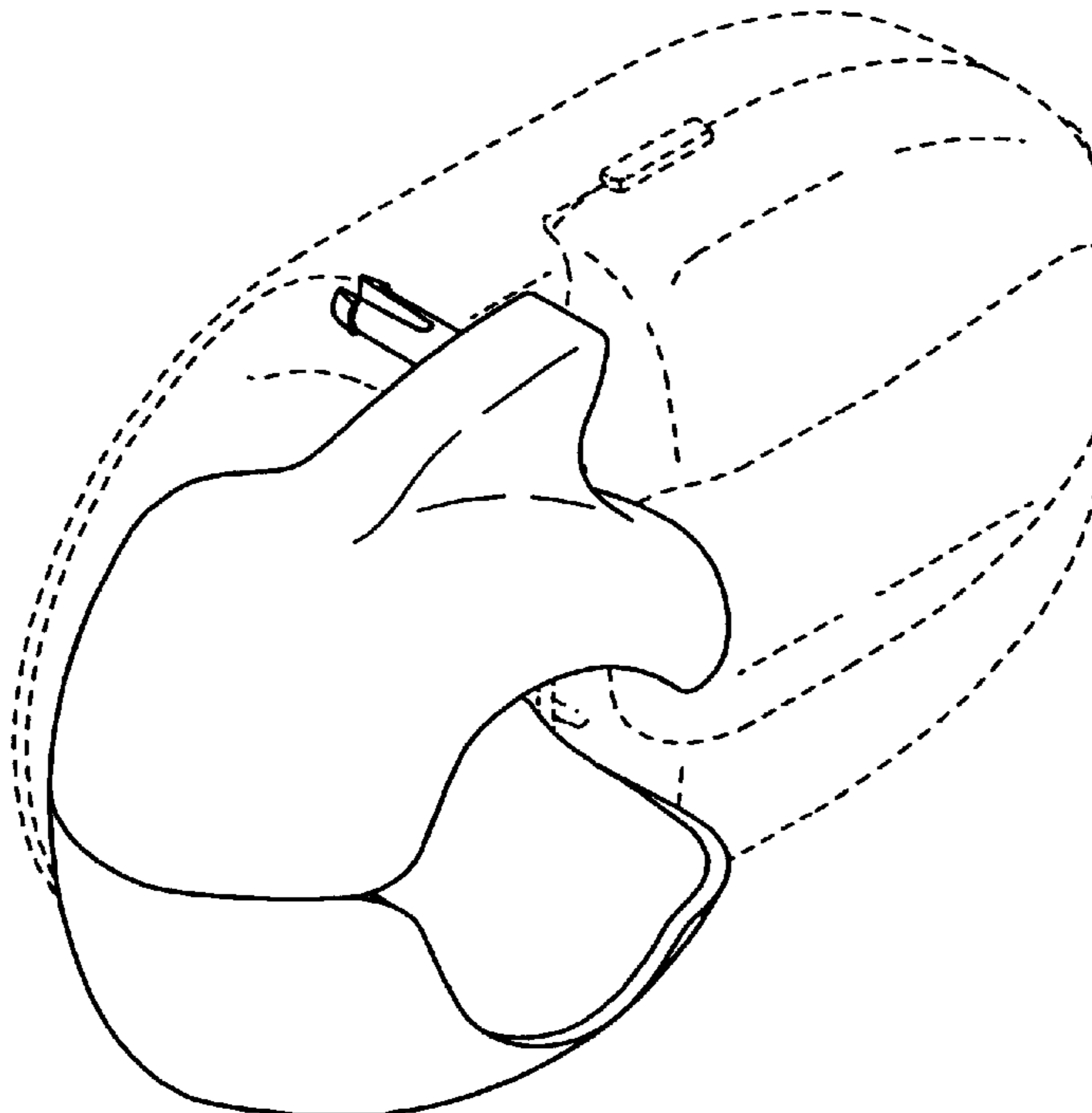

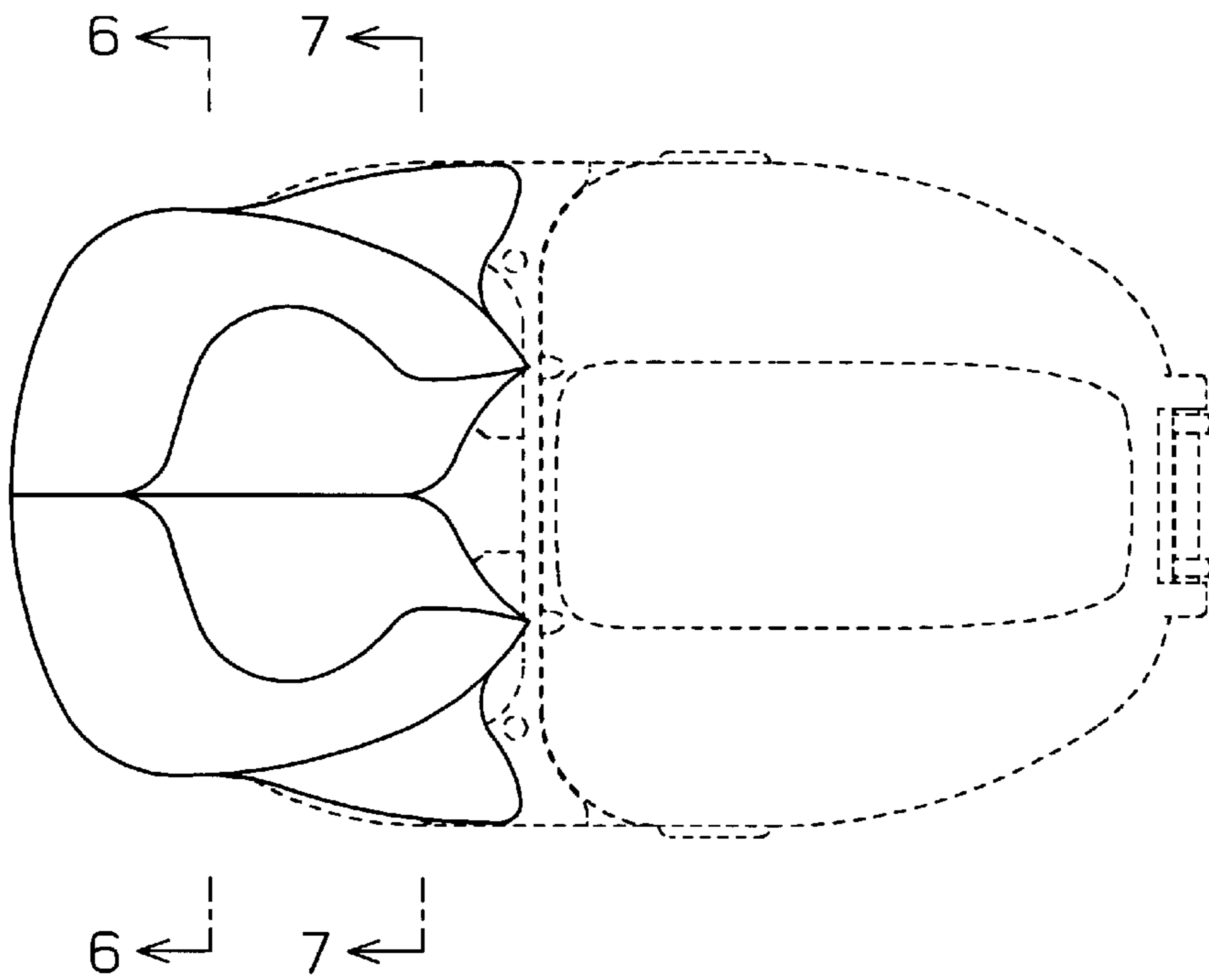

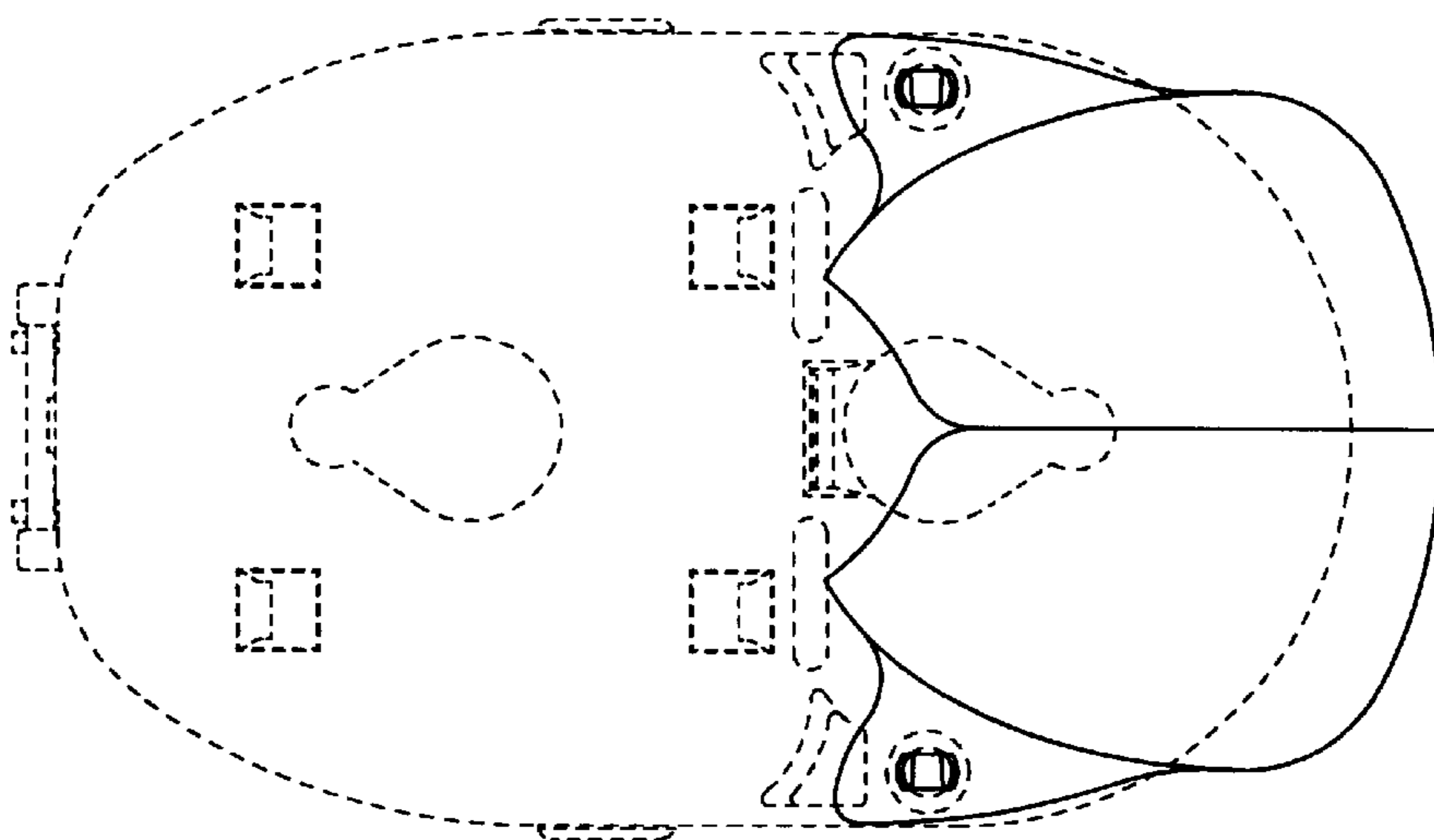

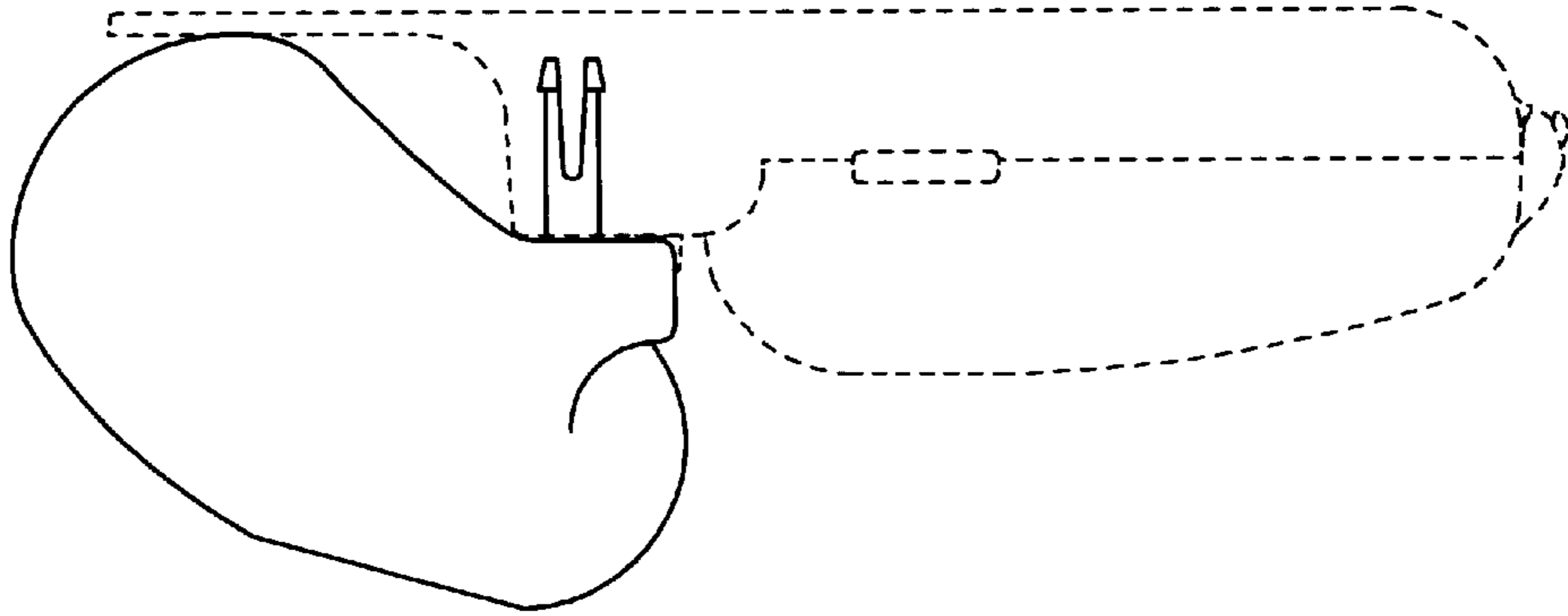

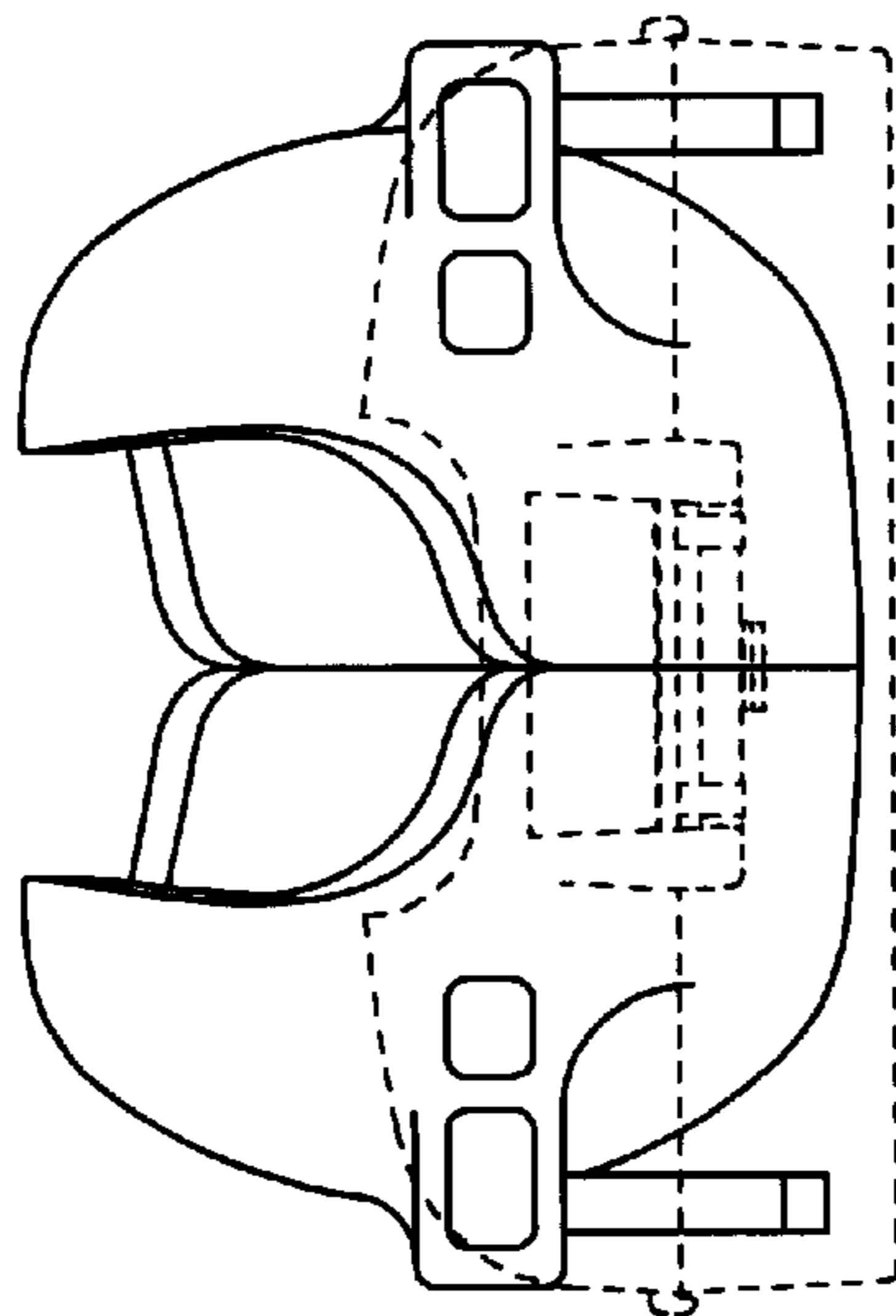

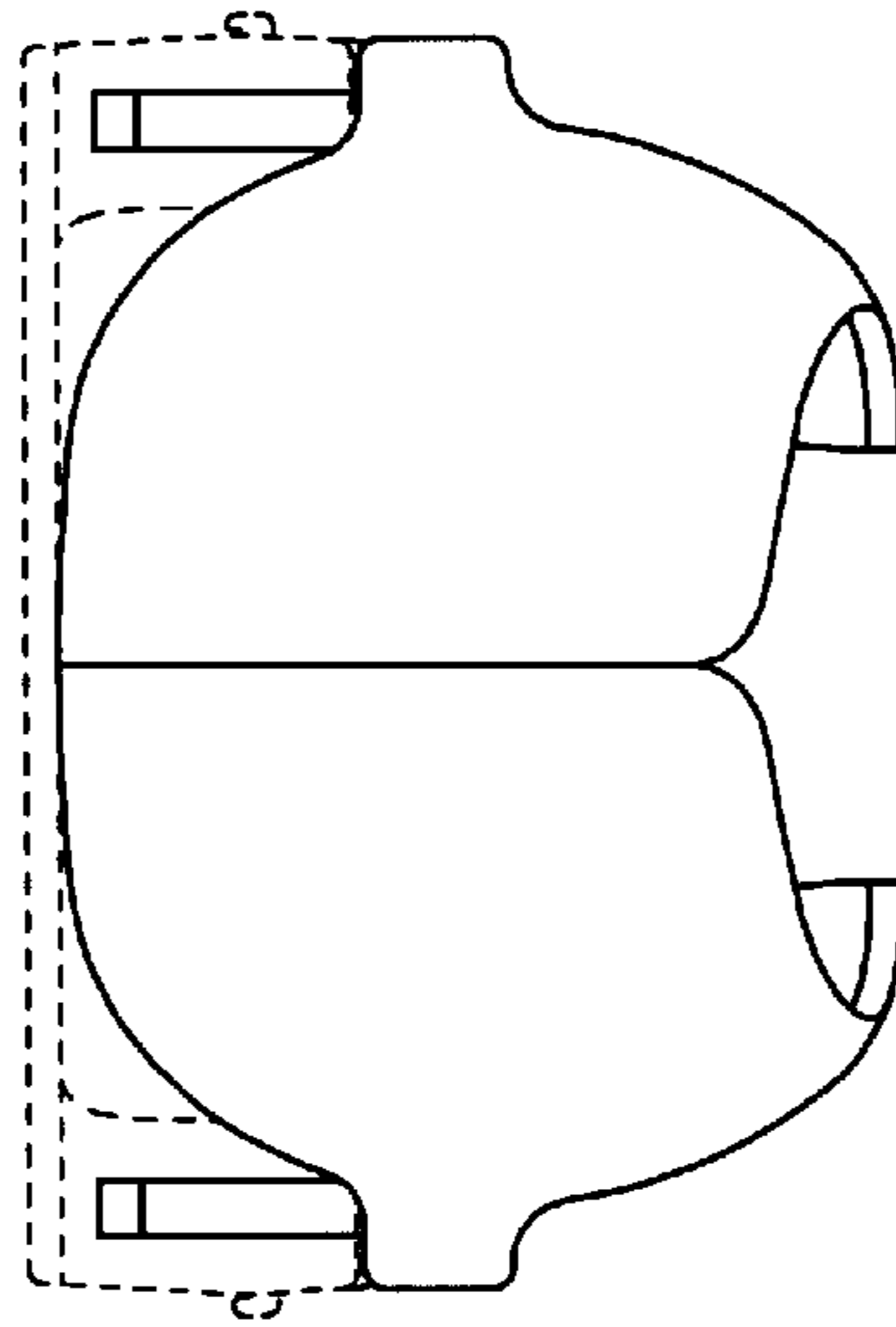

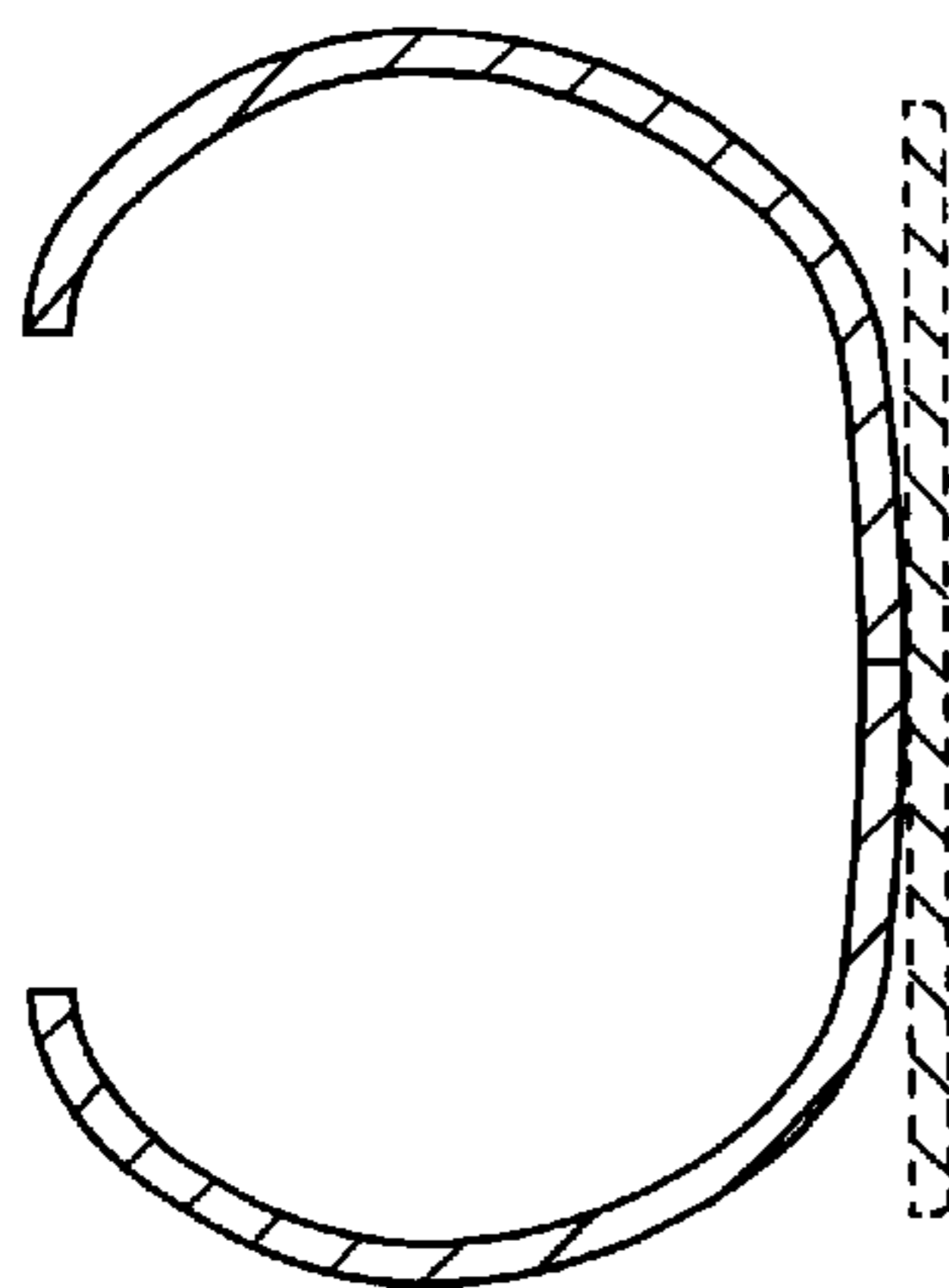

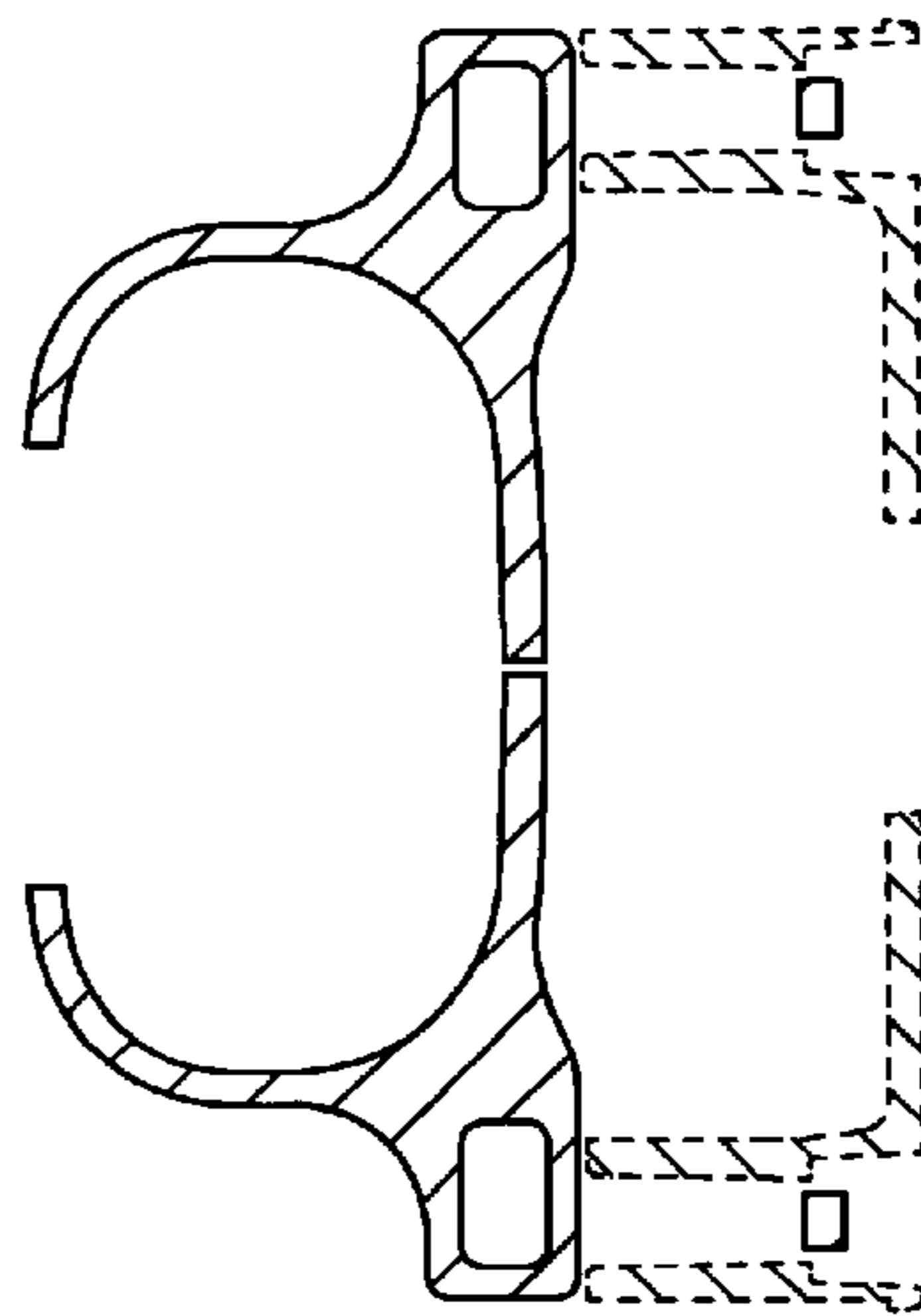

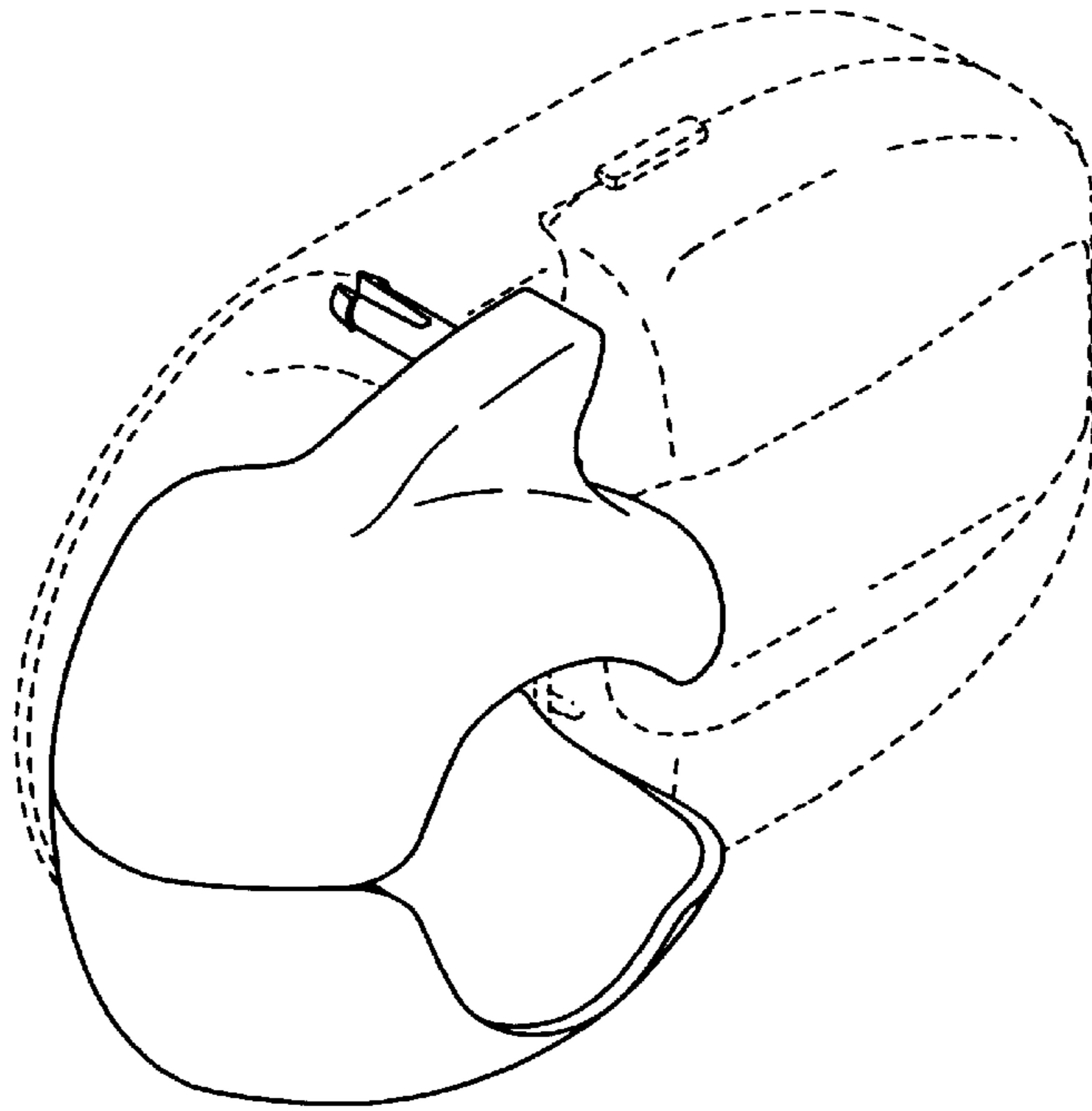

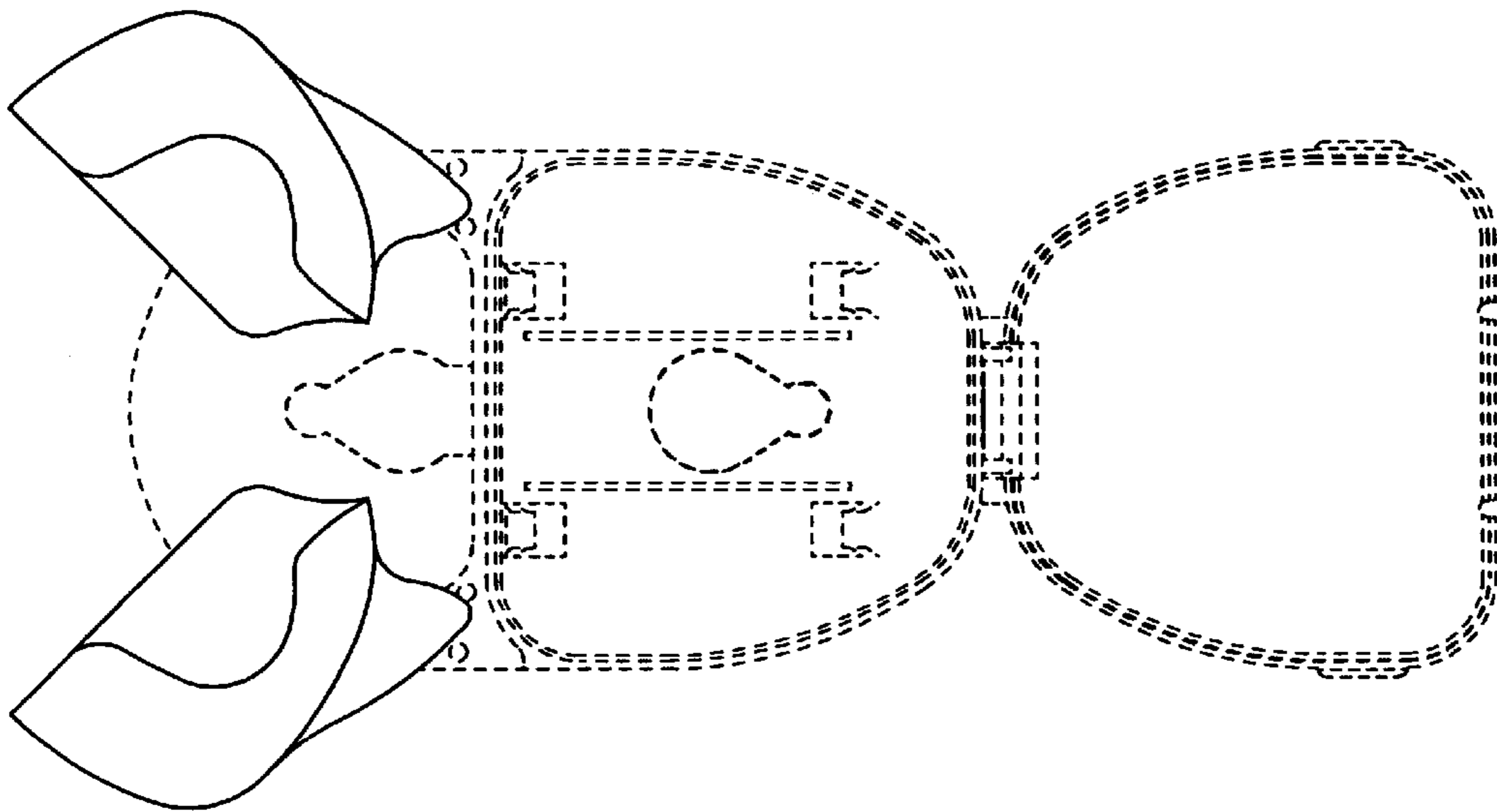

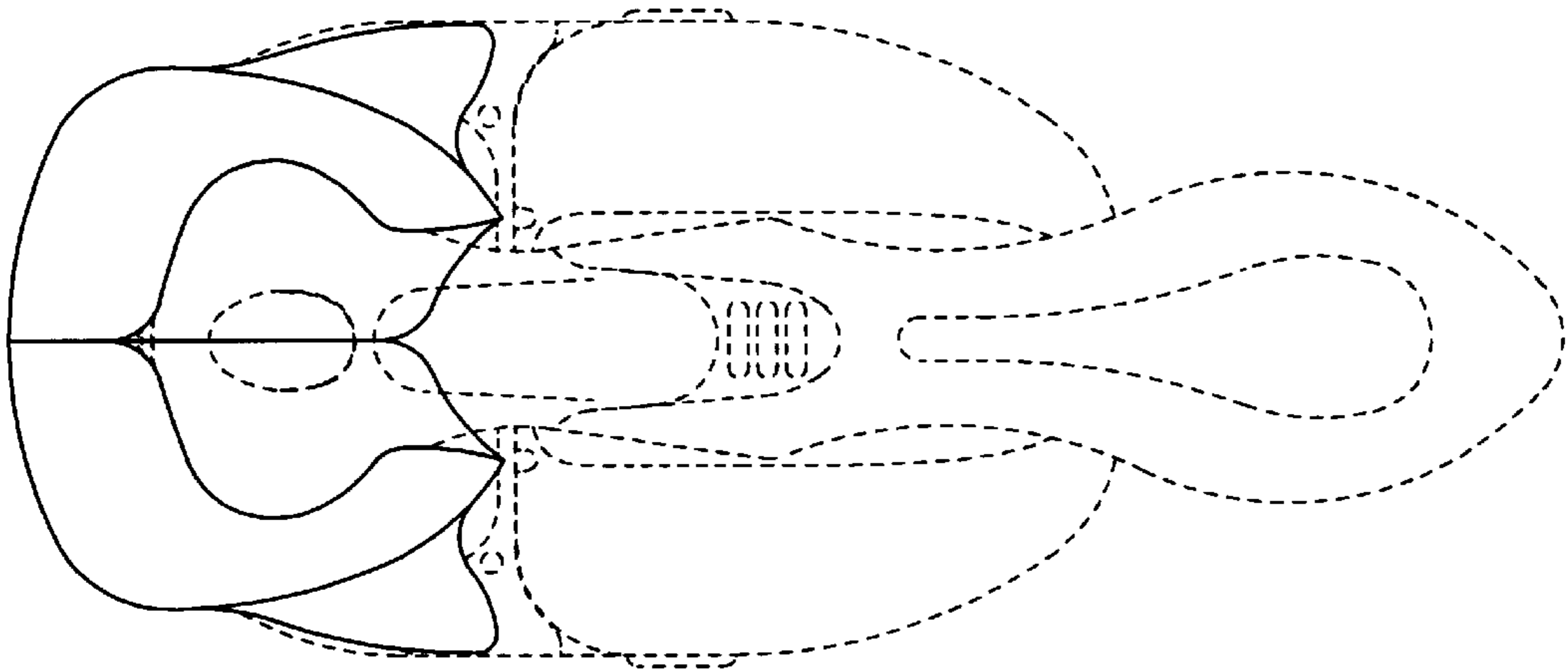
