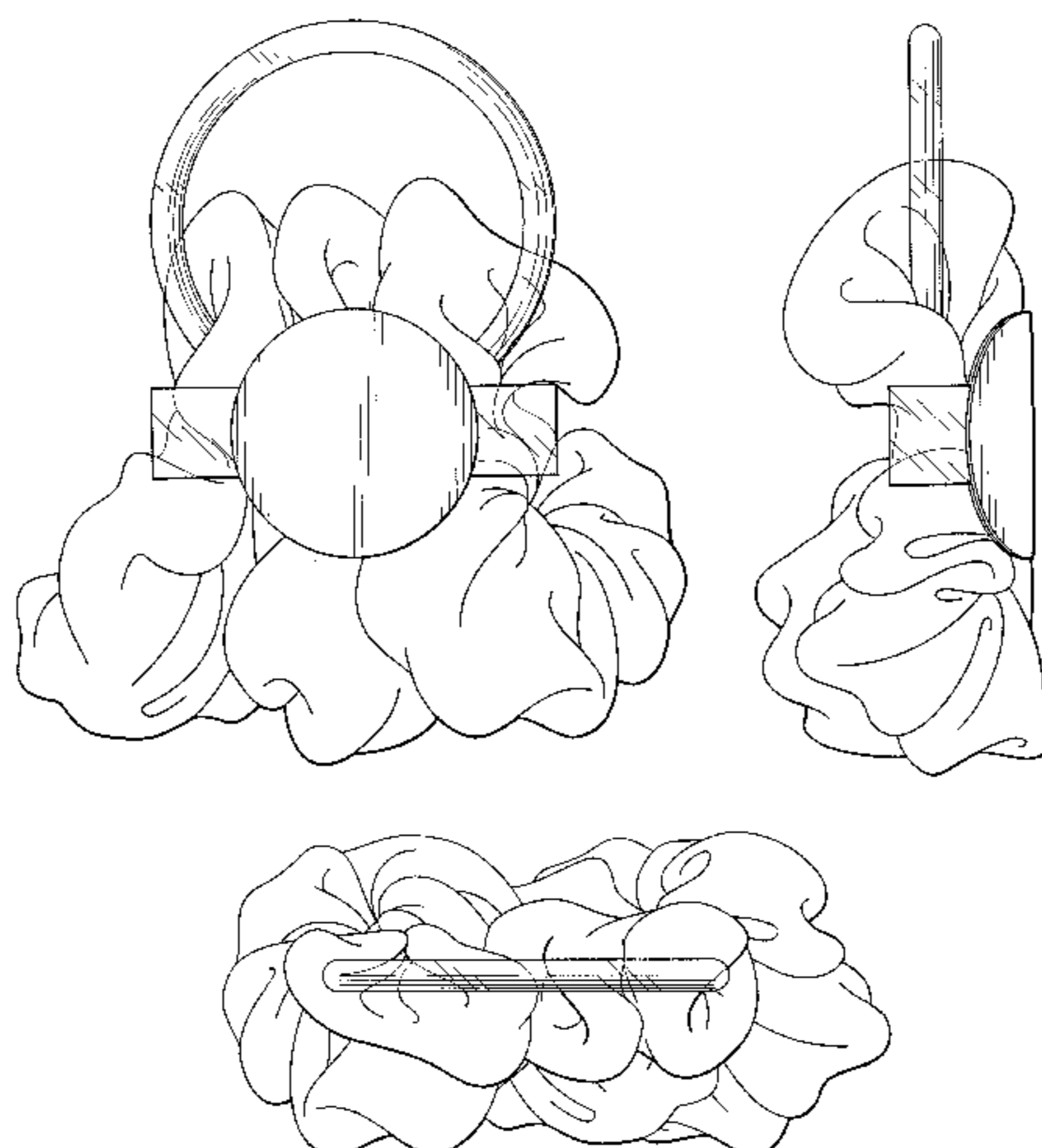
(57) **CLAIM**

The ornamental design for a hair band display, as shown and described.

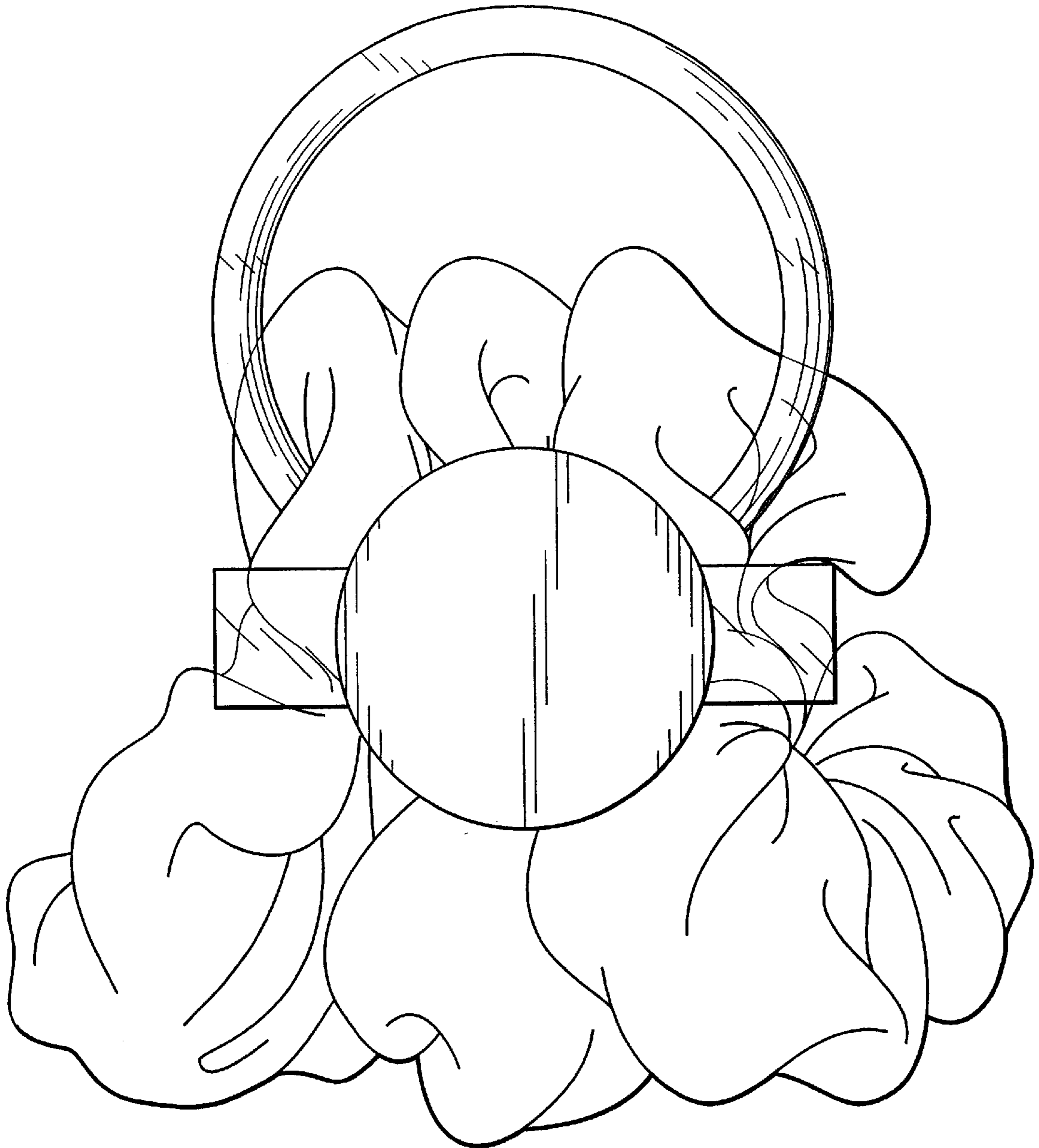
**DESCRIPTION**

FIG. 1 is a front elevational view of a hair band display showing our new design; FIG. 2 is a rear elevational view; FIG. 3 is a left side elevational view; FIG. 4 is a right side elevational view; FIG. 5 is a top plan view; FIG. 6 is a bottom plan view; FIG. 7 is a front elevational view of a second embodiment of the design shown in FIGS. 1-6; FIG. 8 is a rear elevational view; FIG. 9 is a left side elevational view; FIG. 10 is a right side elevational view; FIG. 11 is a top plan view; and, FIG. 12 a bottom plan view.

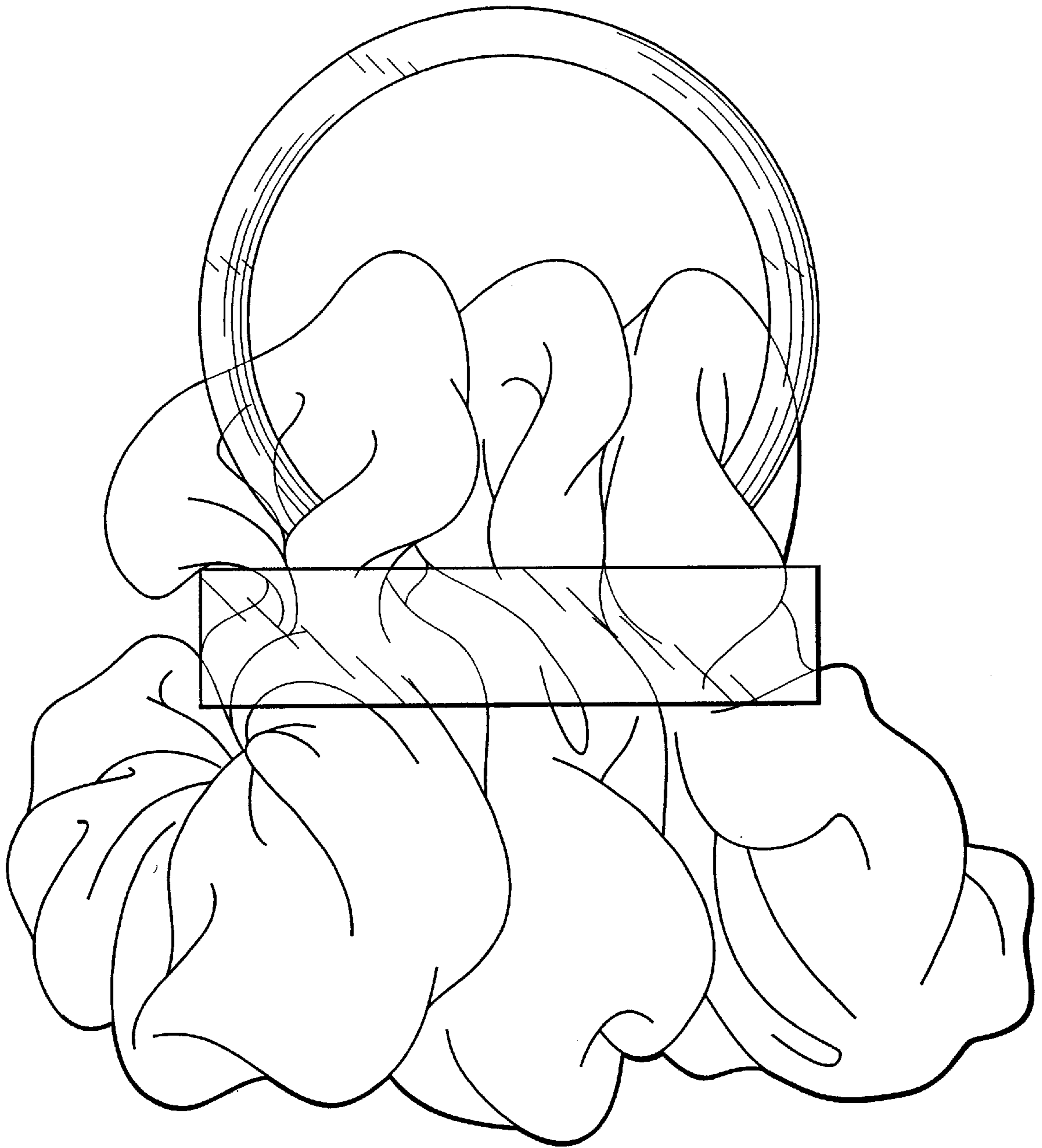

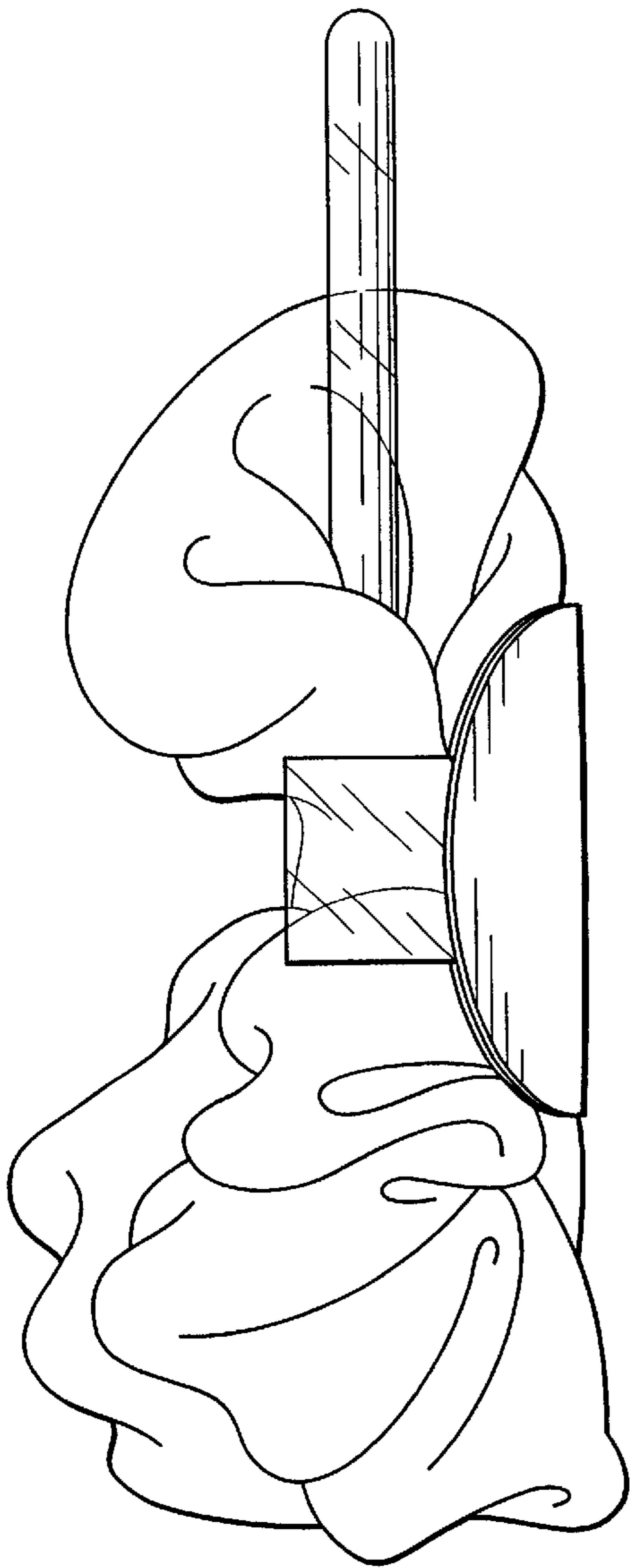

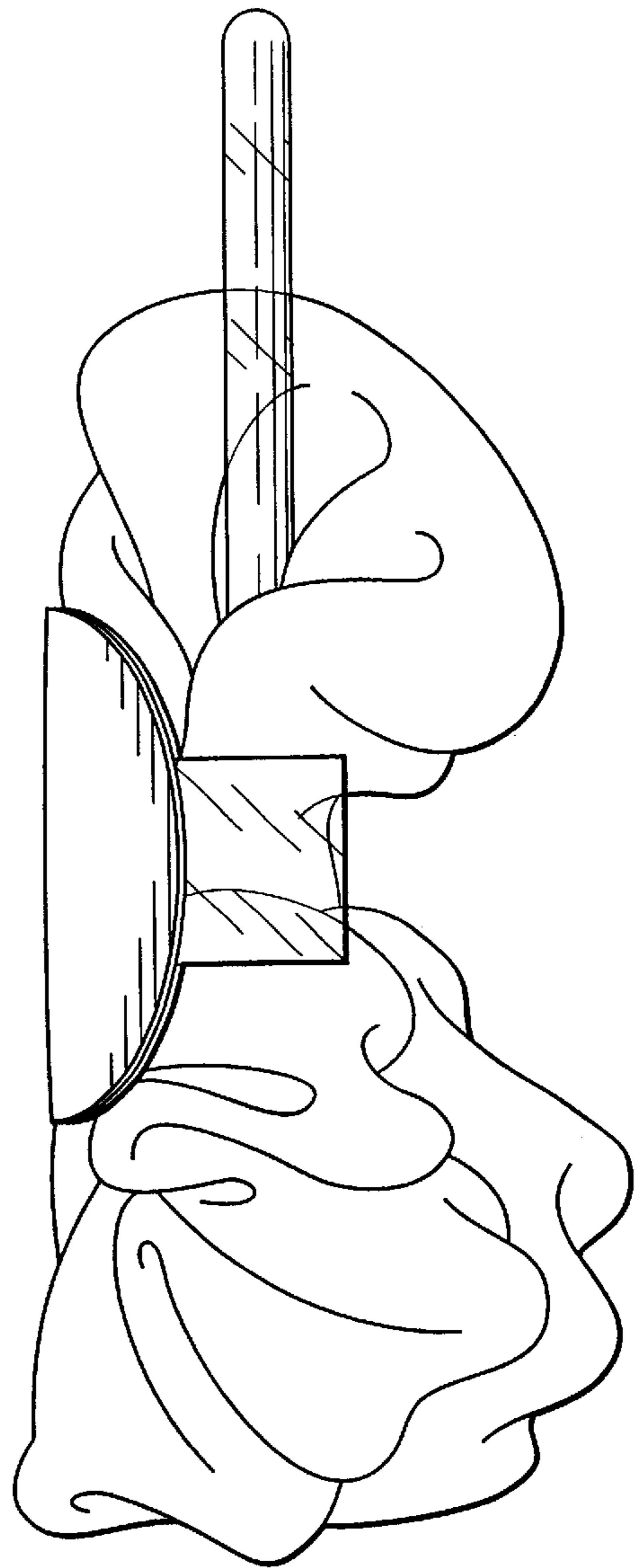

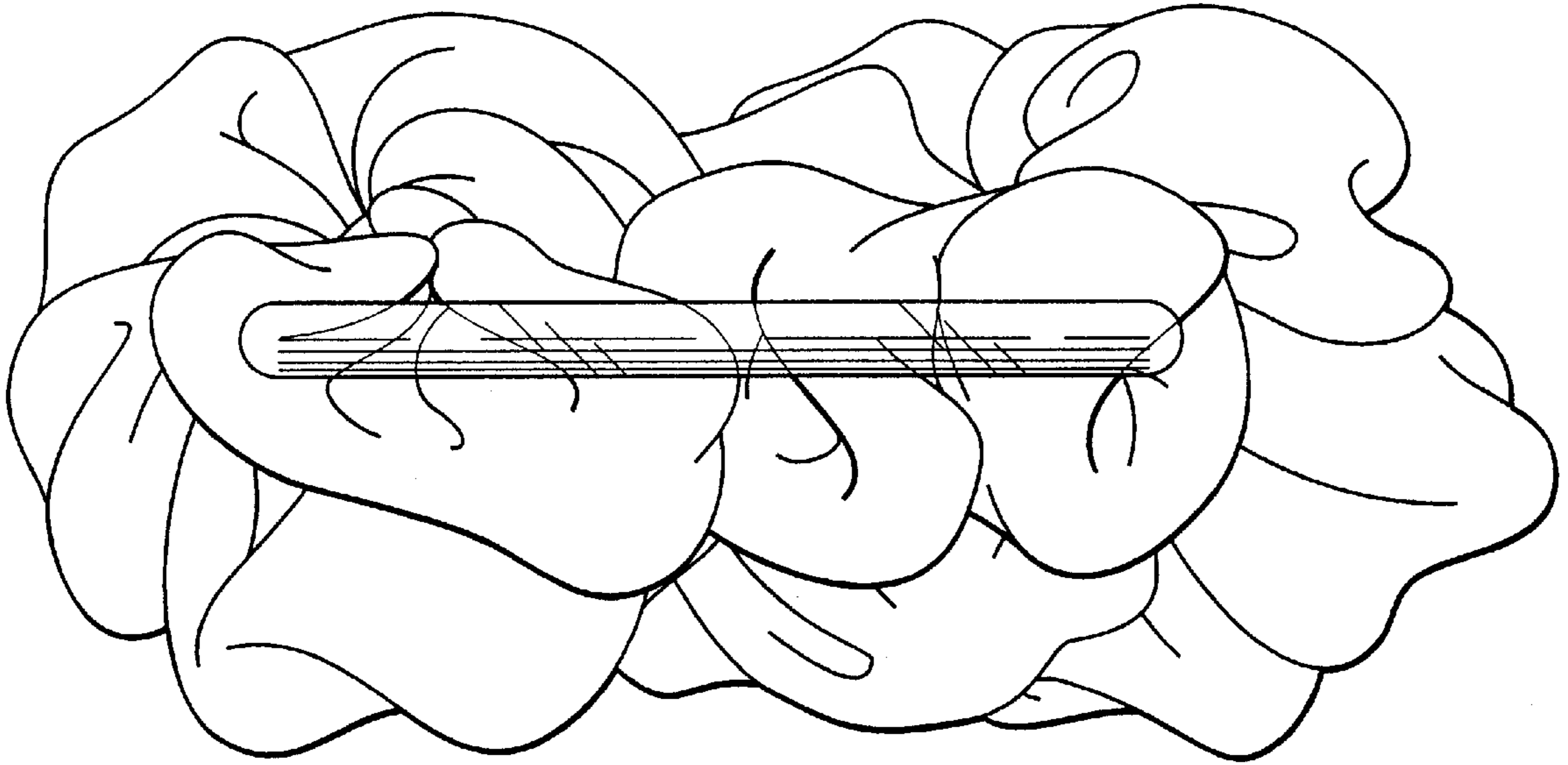

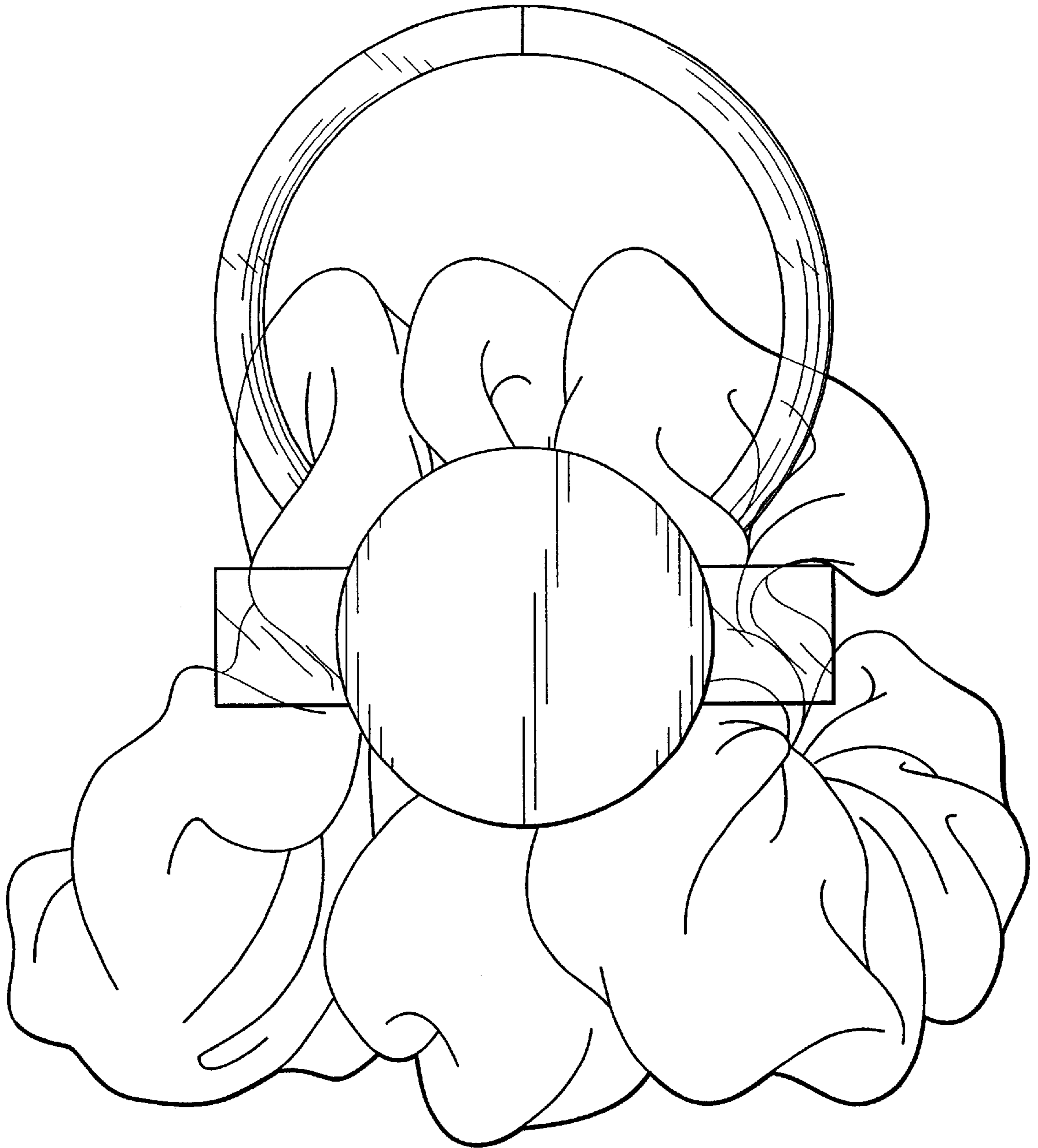

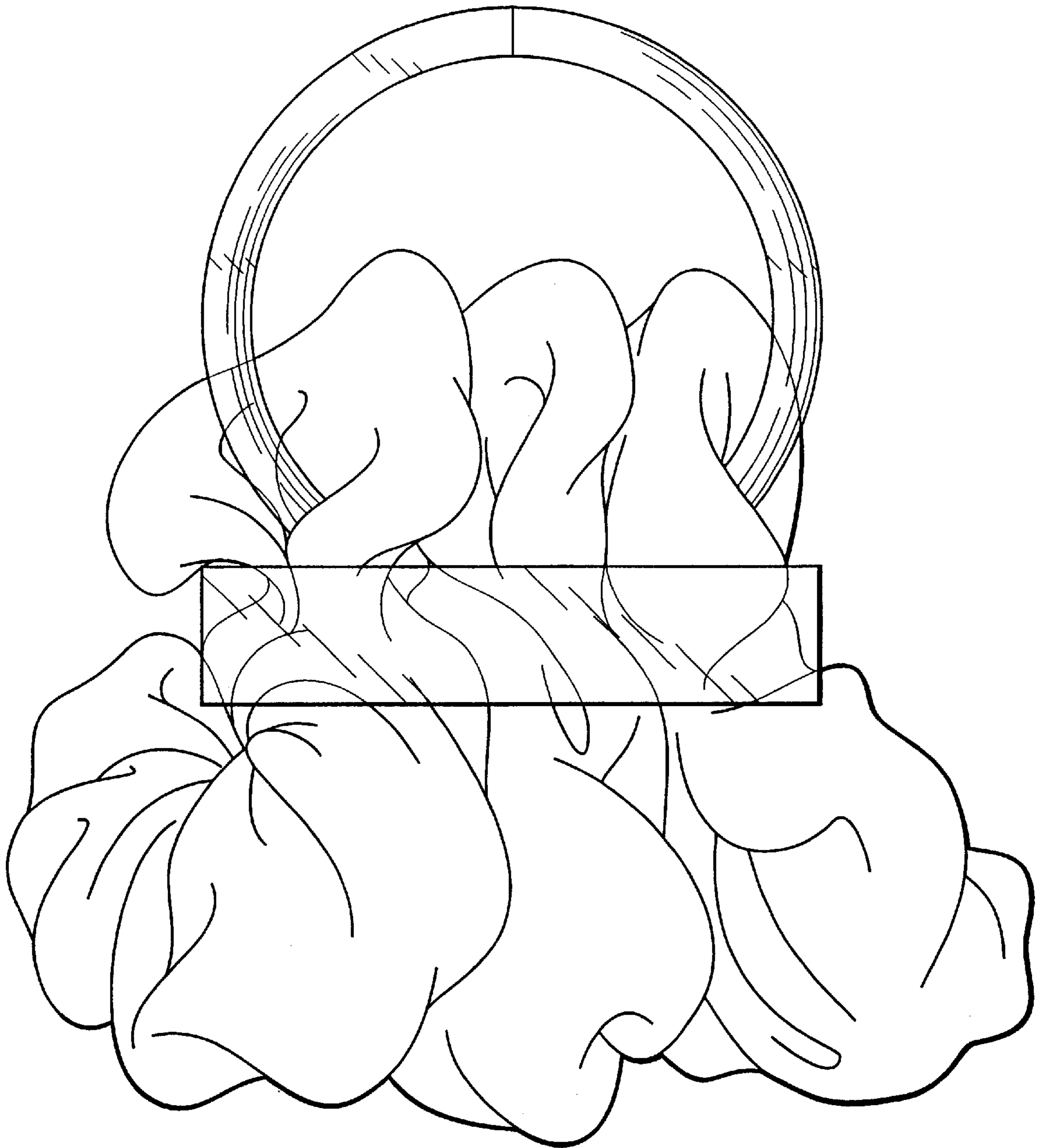

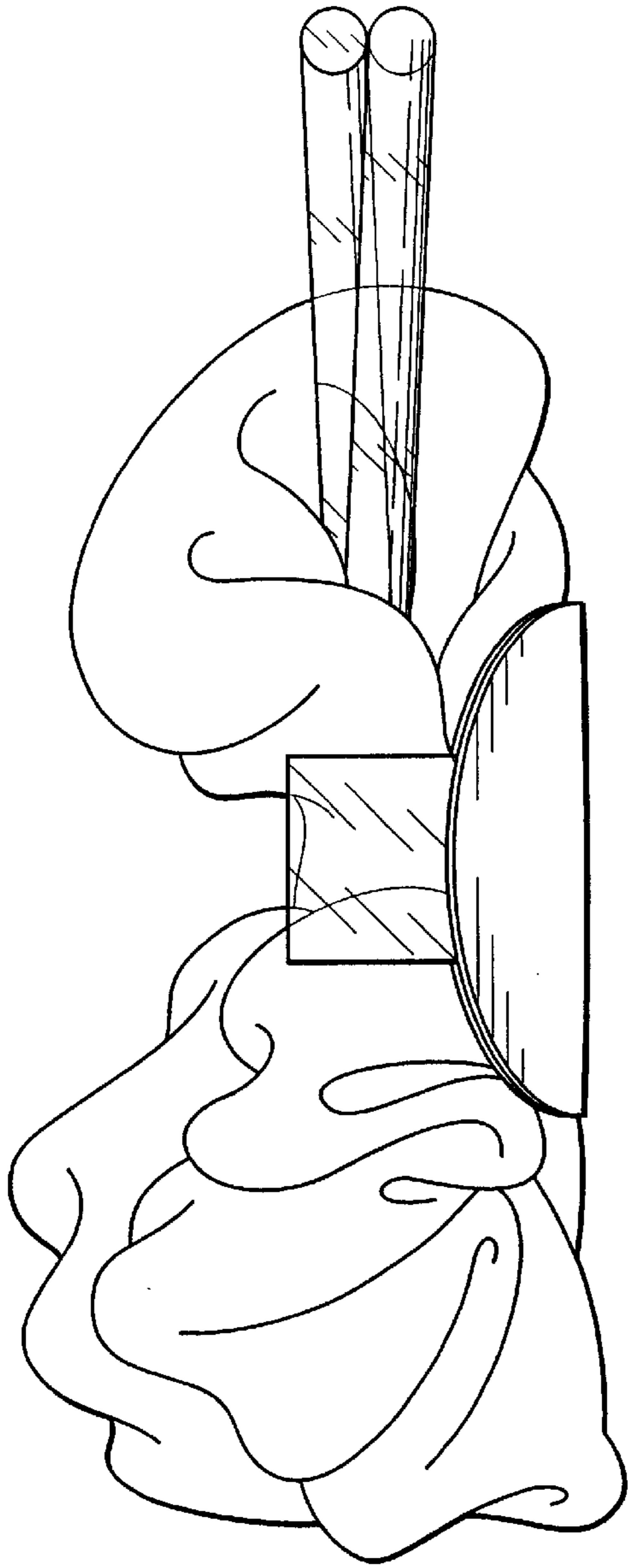

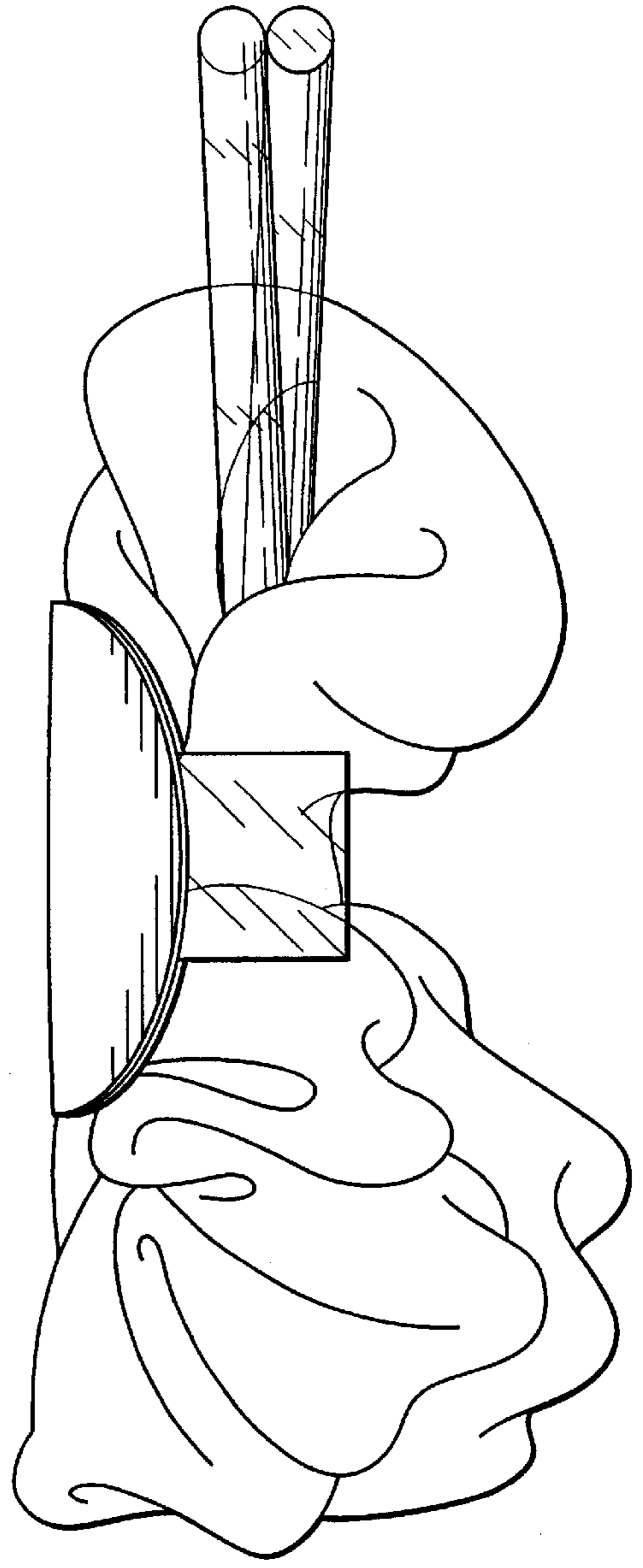

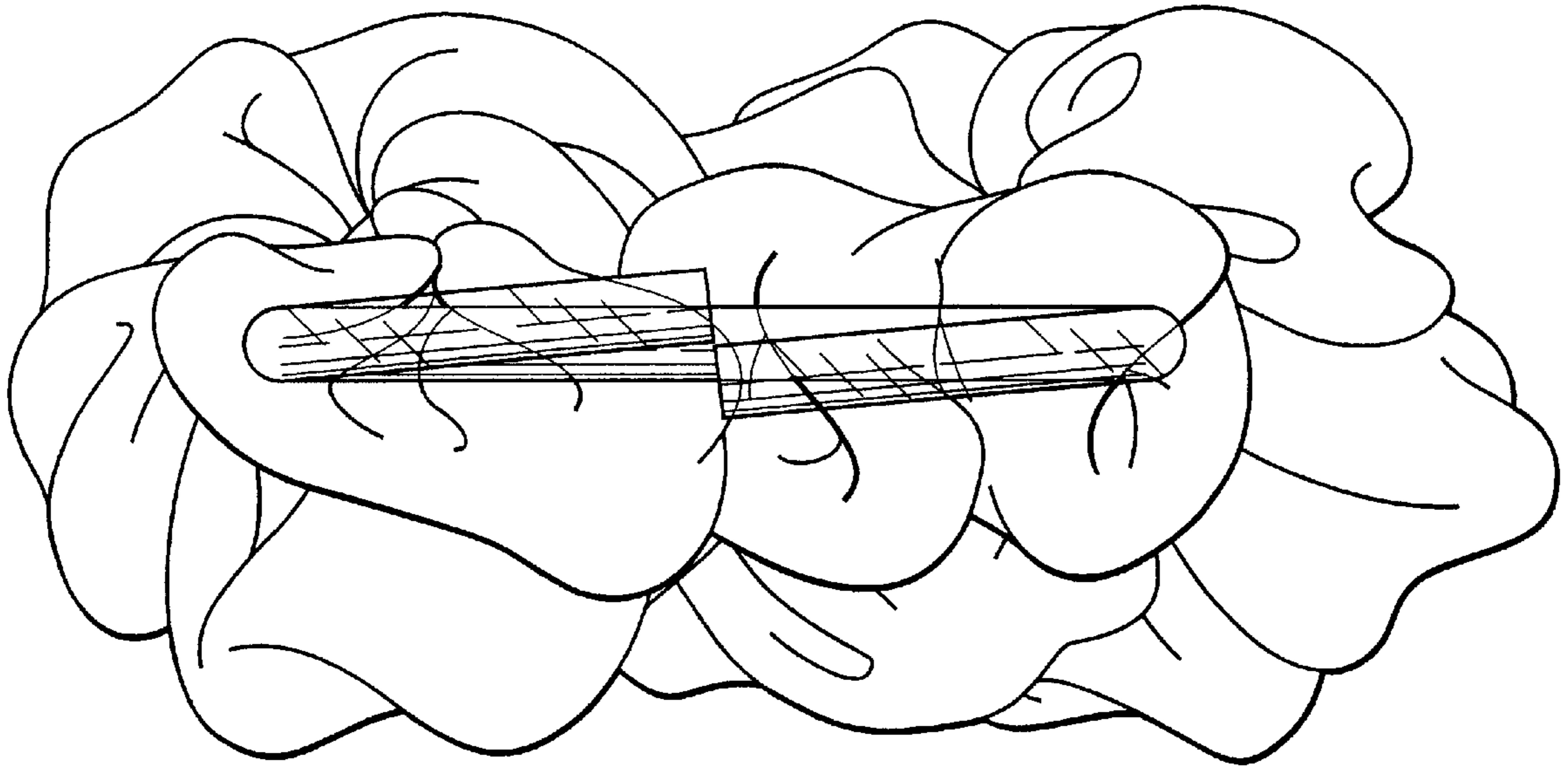
