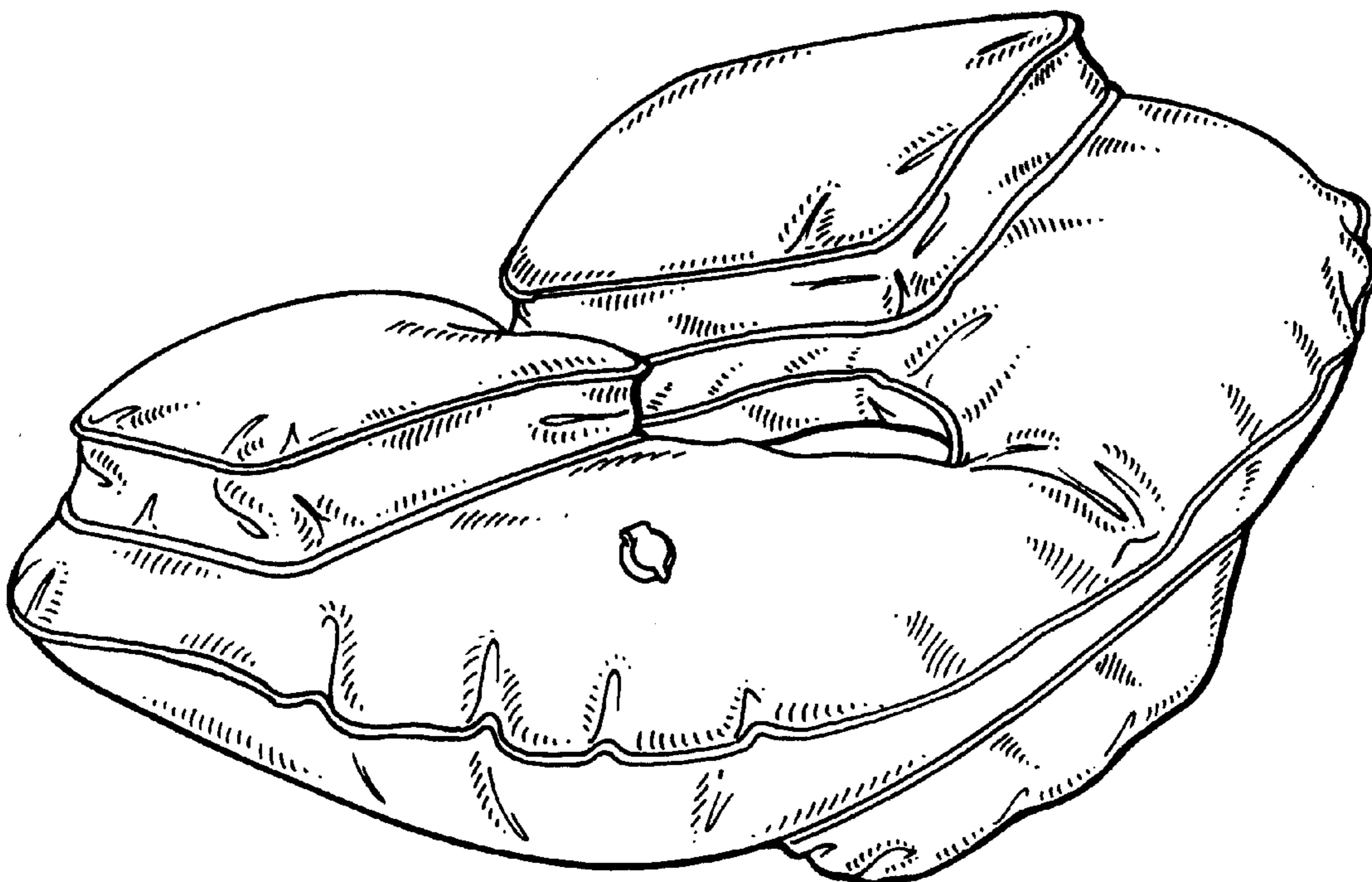
(57) **CLAIM**

The ornamental design for a travel pillow, as shown.

DESCRIPTION

FIG. 1 is a perspective view from in front and to one side of a travel pillow in accordance with the design;
FIG. 2 is a front view of the travel pillow of FIG. 1;
FIG. 3 is a bottom view of the travel pillow of FIG. 1;
FIG. 4 is a back view of the travel pillow of FIG. 1;
FIG. 5 is a top view of the travel pillow of FIG. 1;
FIG. 6 is a view of the left side of the travel pillow of FIG. 1;
FIG. 7 is a view of the right side of the travel pillow of FIG. 1; and,
FIG. 8 is a perspective view of the travel pillow of FIG. 1 in deflated condition from in front and to one side.

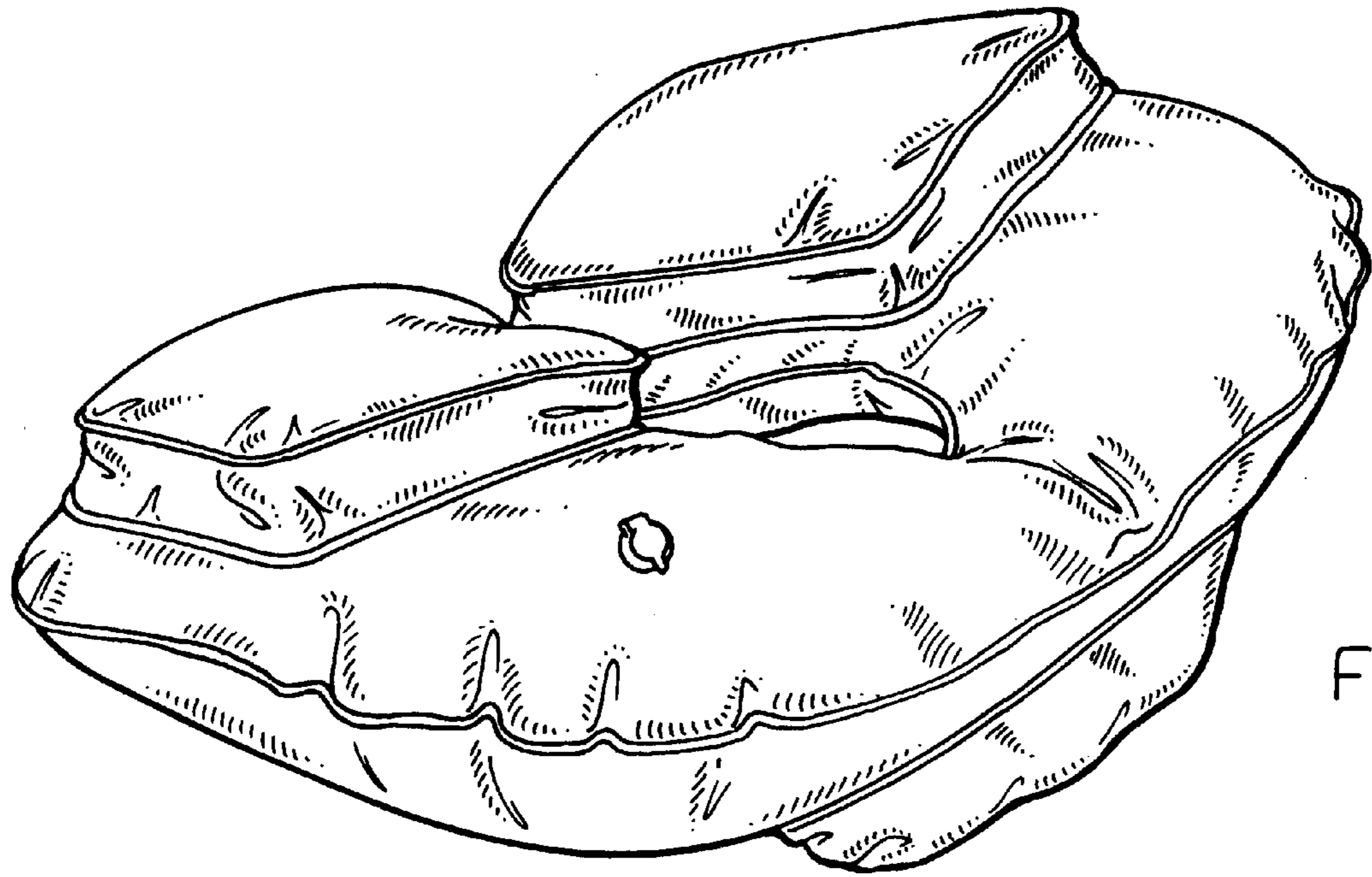
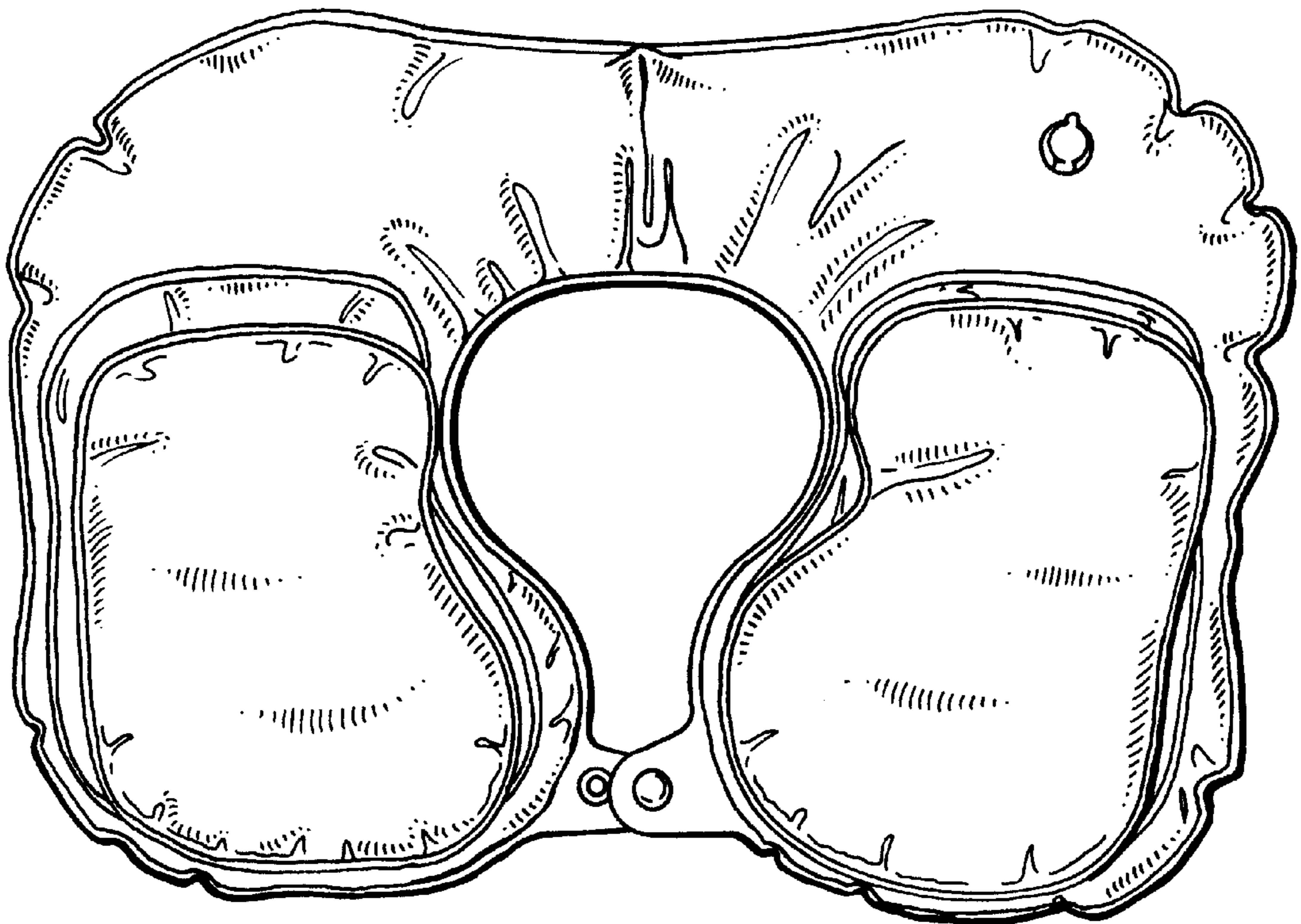

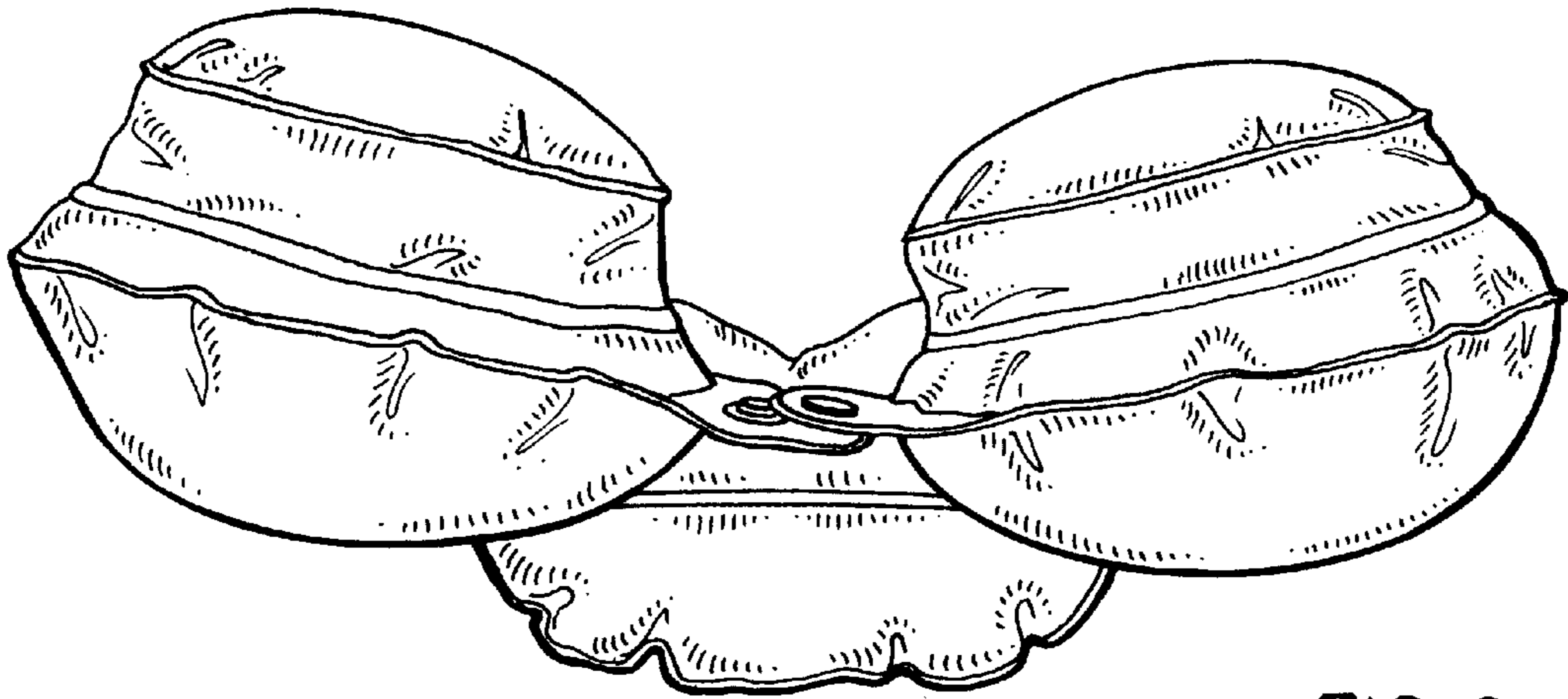
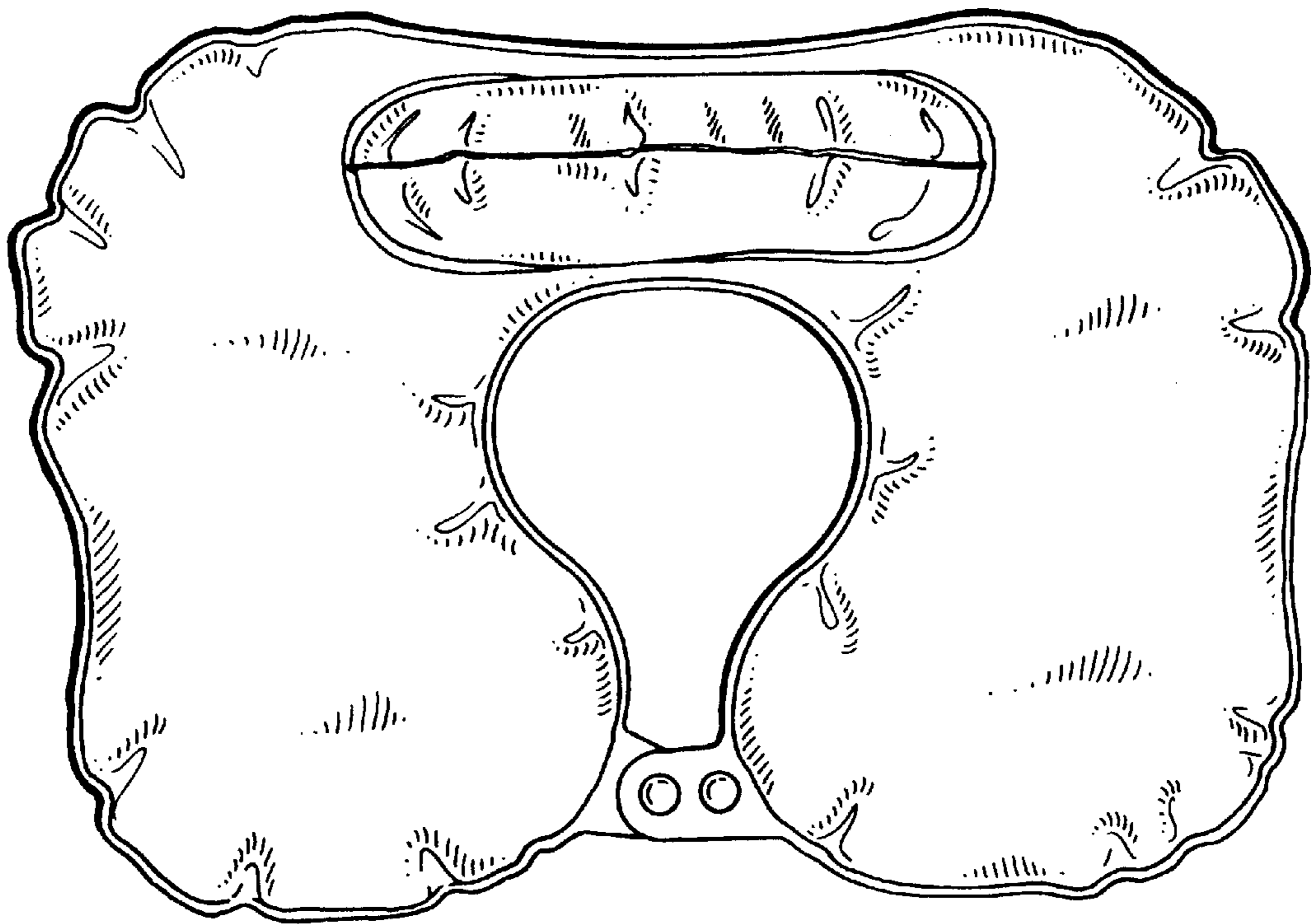

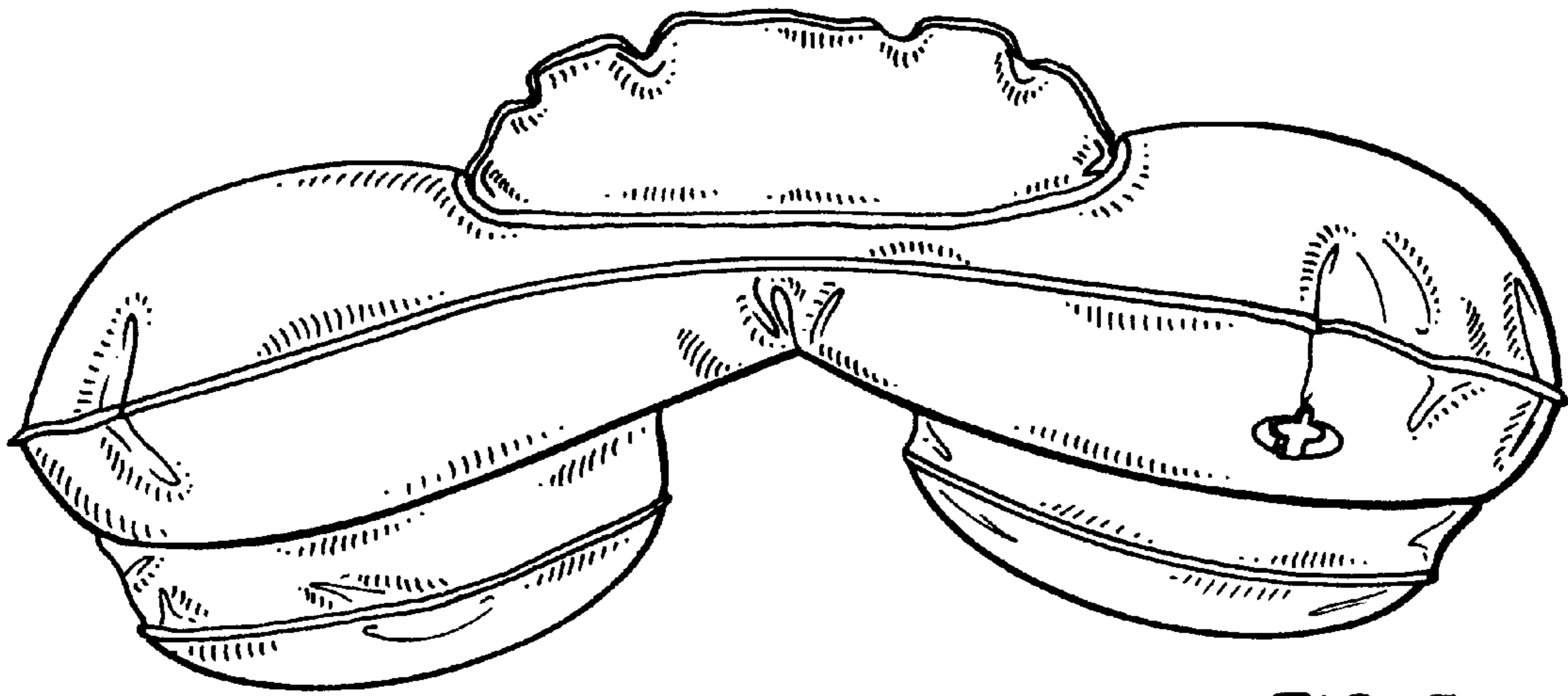

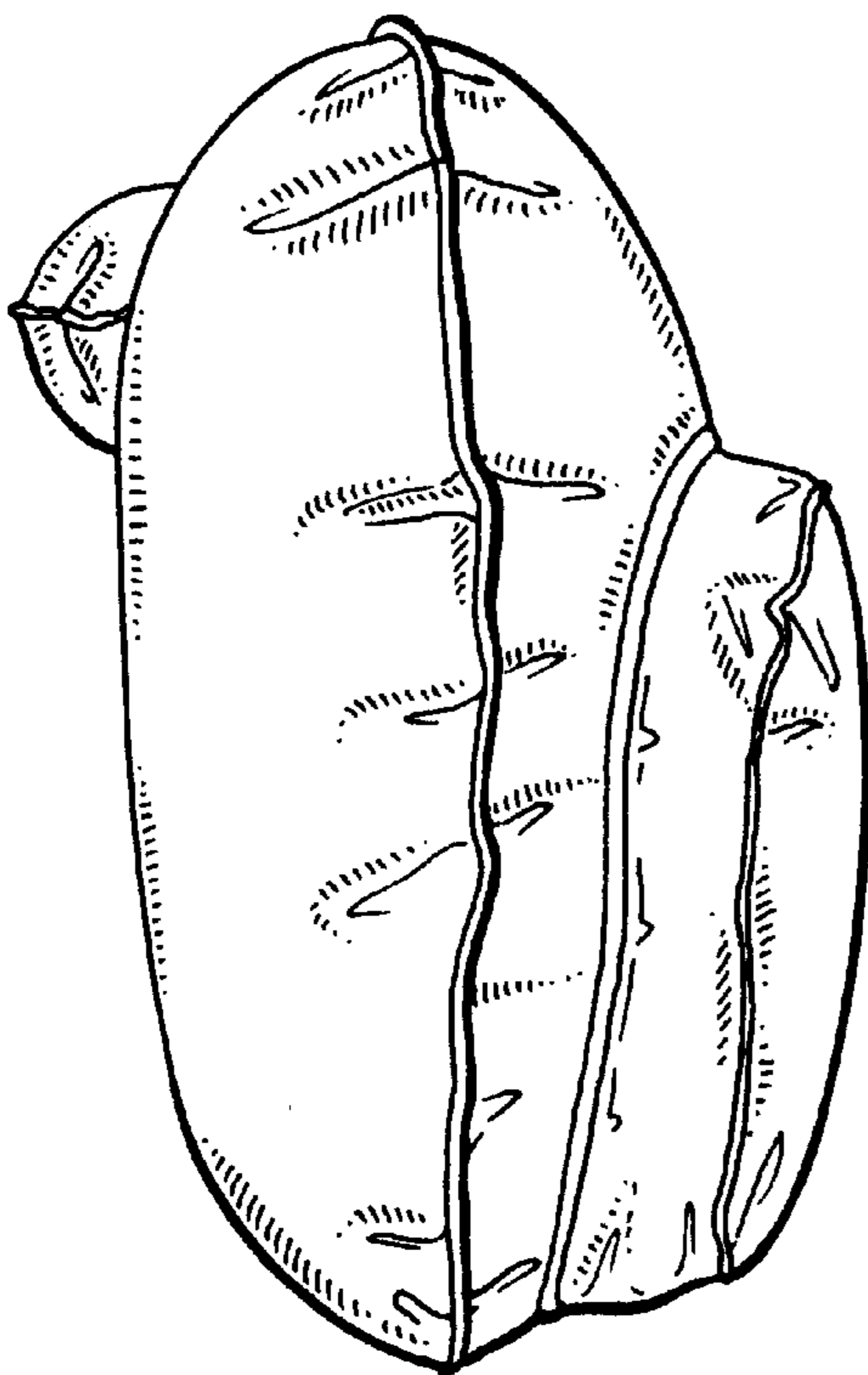

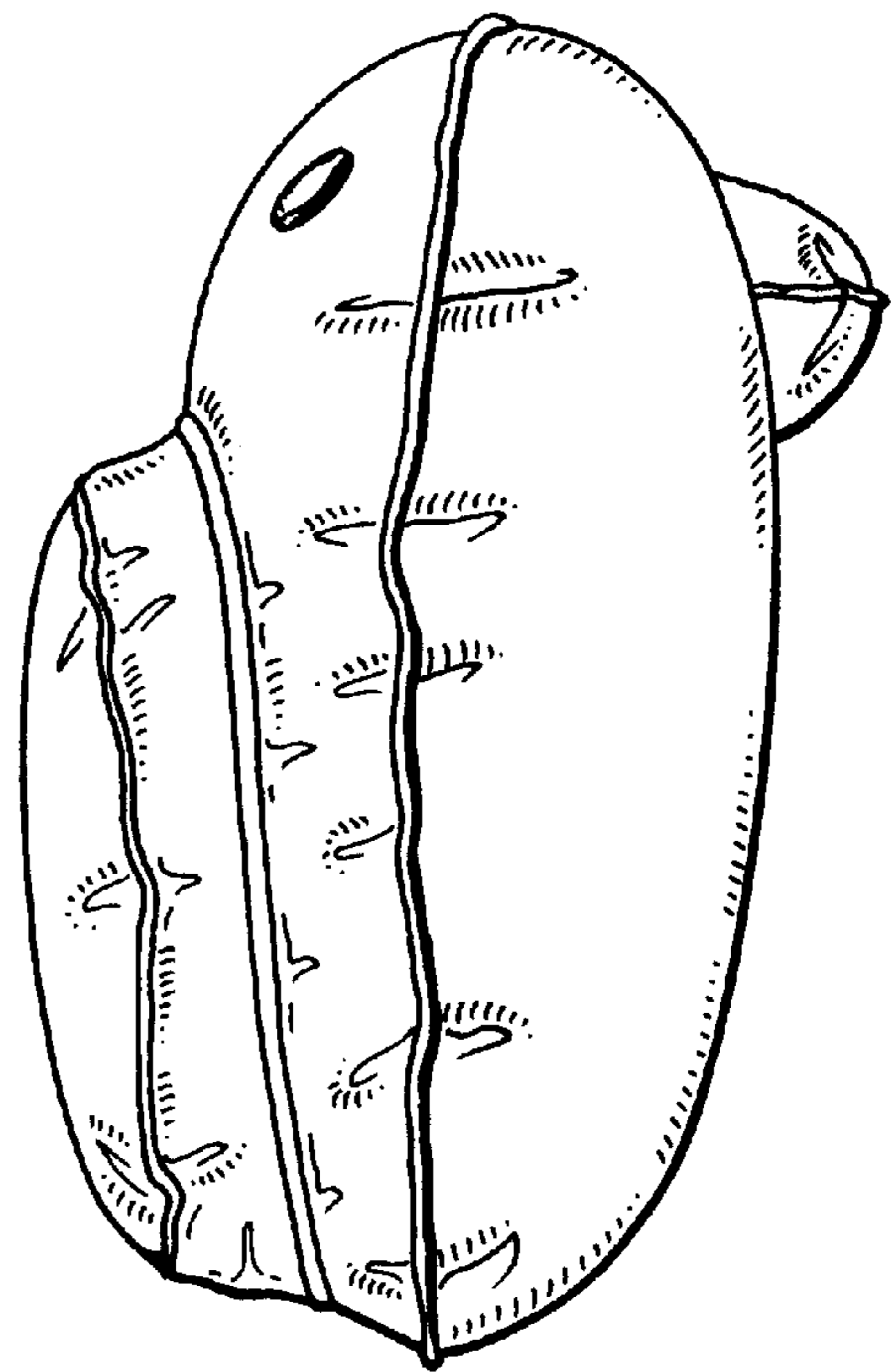

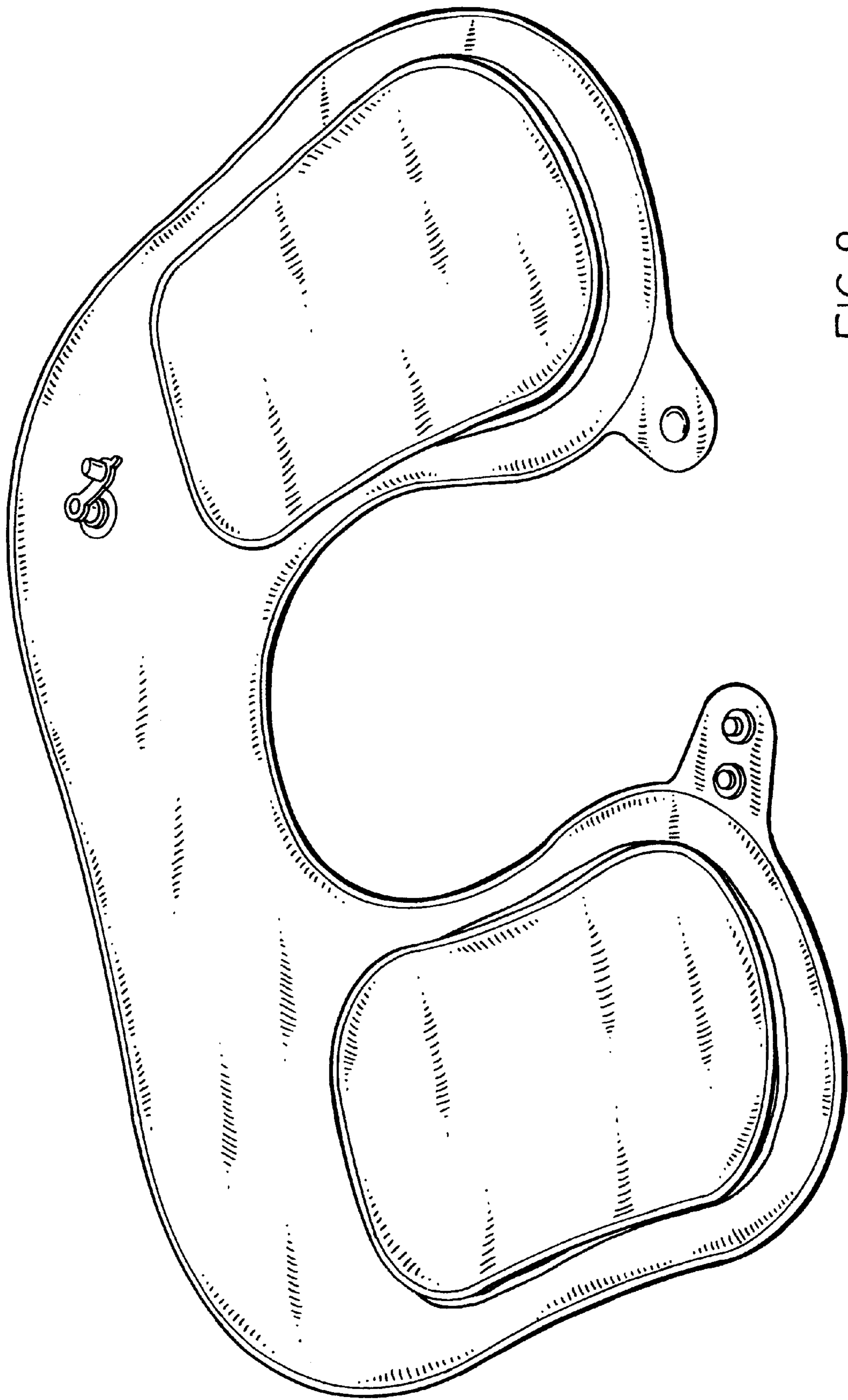
