(57) **CLAIM**

I claim the ornamental design for a multi-function tool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a multi-function tool; FIG. 2 is a front elevation view of the tool shown in FIG. 1, the rear view being a mirror image; FIG. 3 is a right side view of the tool shown in FIG. 1; FIG. 4 is a top view of the tool shown in FIG. 1; FIG. 5 is a bottom view of the tool shown in FIG. 1; and, FIG. 6 is a front elevation view of the tool shown in FIG. 1 in an open configuration.

The ornamental design which is claimed is shown in solid lines in the drawings. The broken lines in the drawings are for illustrative purposes only and form no part of the claimed design.

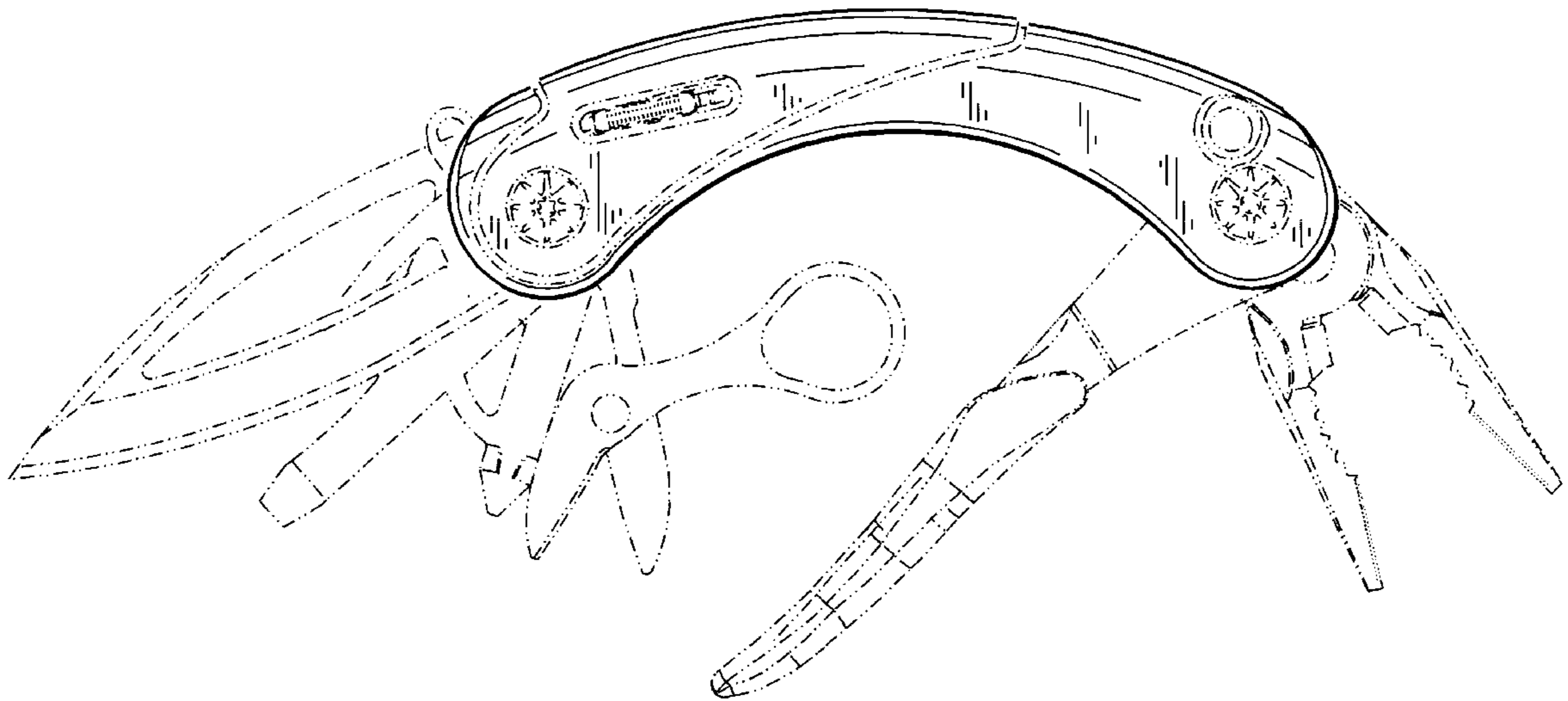

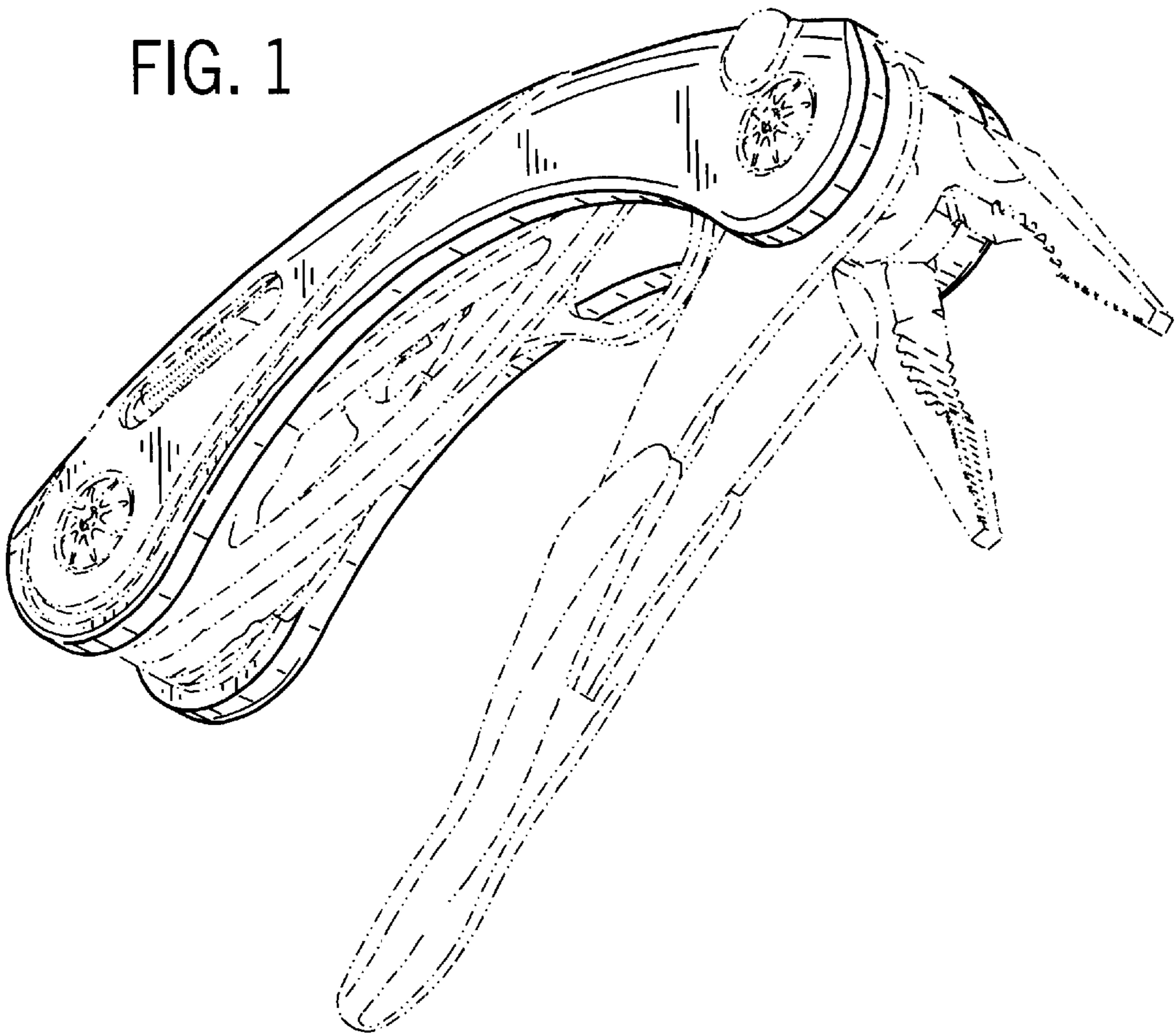

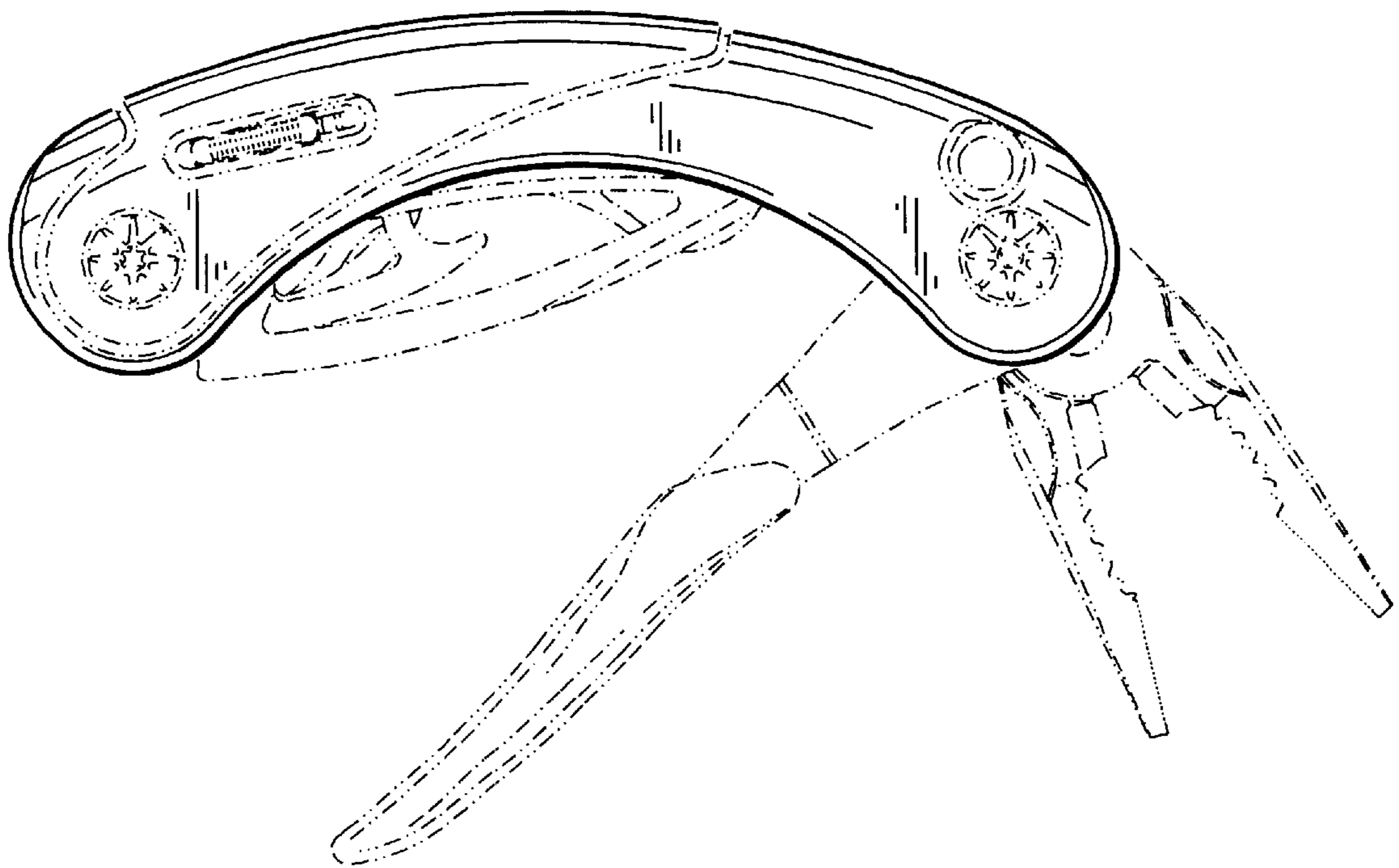

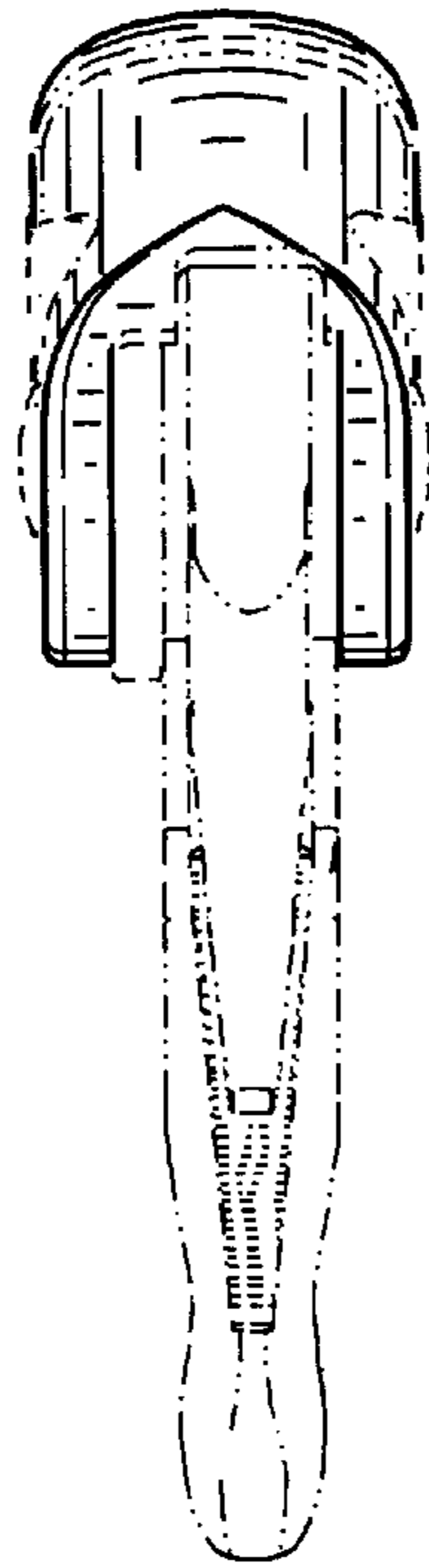

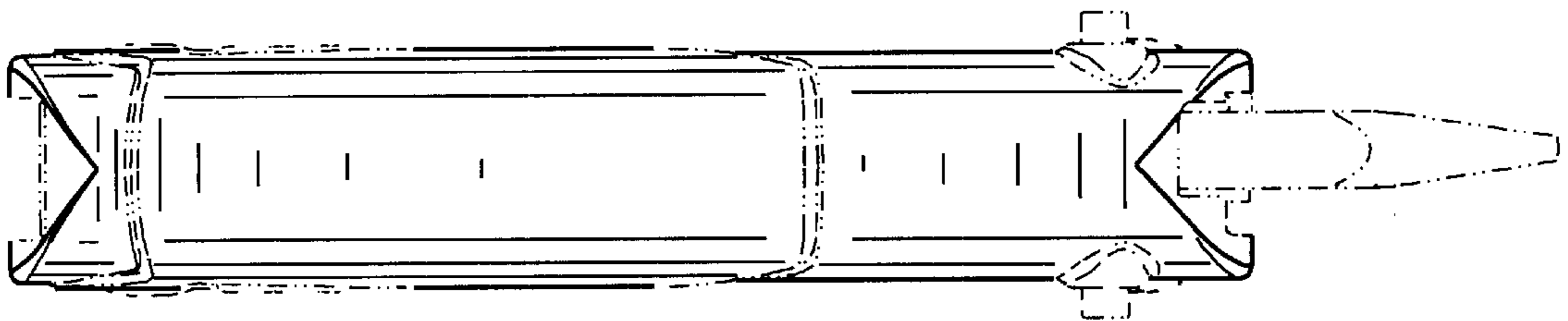

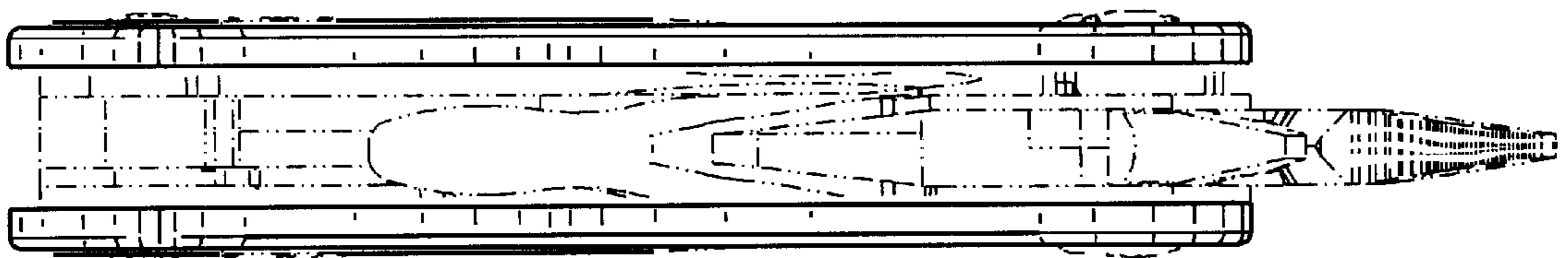
