DESCRIPTION

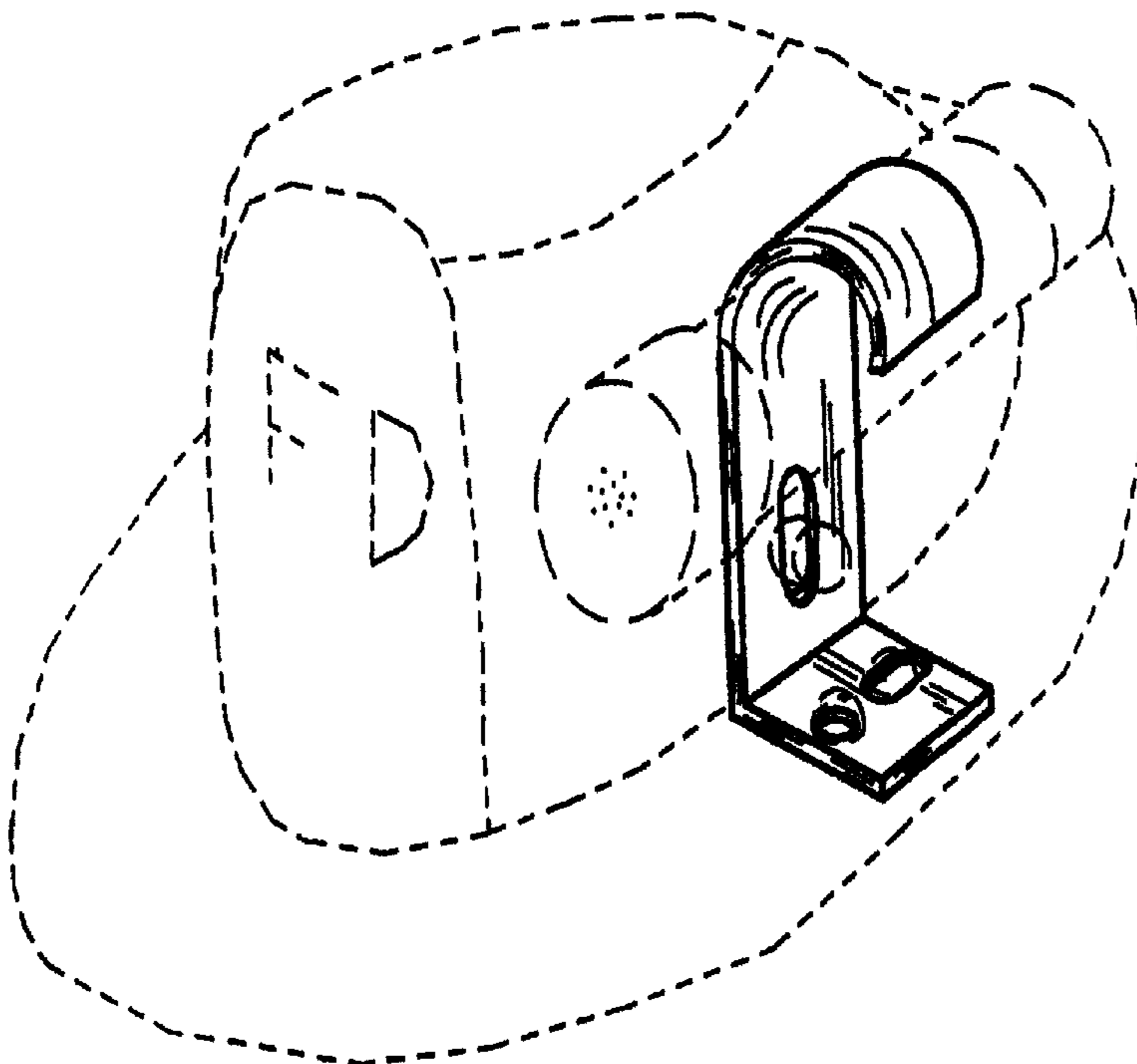
FIG. 1 is a top elevation view of a helmet mount/clamp;
FIG. 2 is a rear elevation view thereof;
FIG. 3 is a right elevation view thereof; the left side being a mirror image and
FIG. 4 is a front elevation view thereof;
FIG. 5 is a top, rear, right side perspective view of embodiment of the invention thereof;
FIG. 6 is a front, top right perspective view of the invention that is attached to a helmet and has a flashlight installed for illustrative purposes only and forms no part of the invention; thereof; and,
FIG. 7 is a front view of the invention that is redundantly attached to a helmet and has flashlights installed for illustrative purposes only and form no part of the invention.

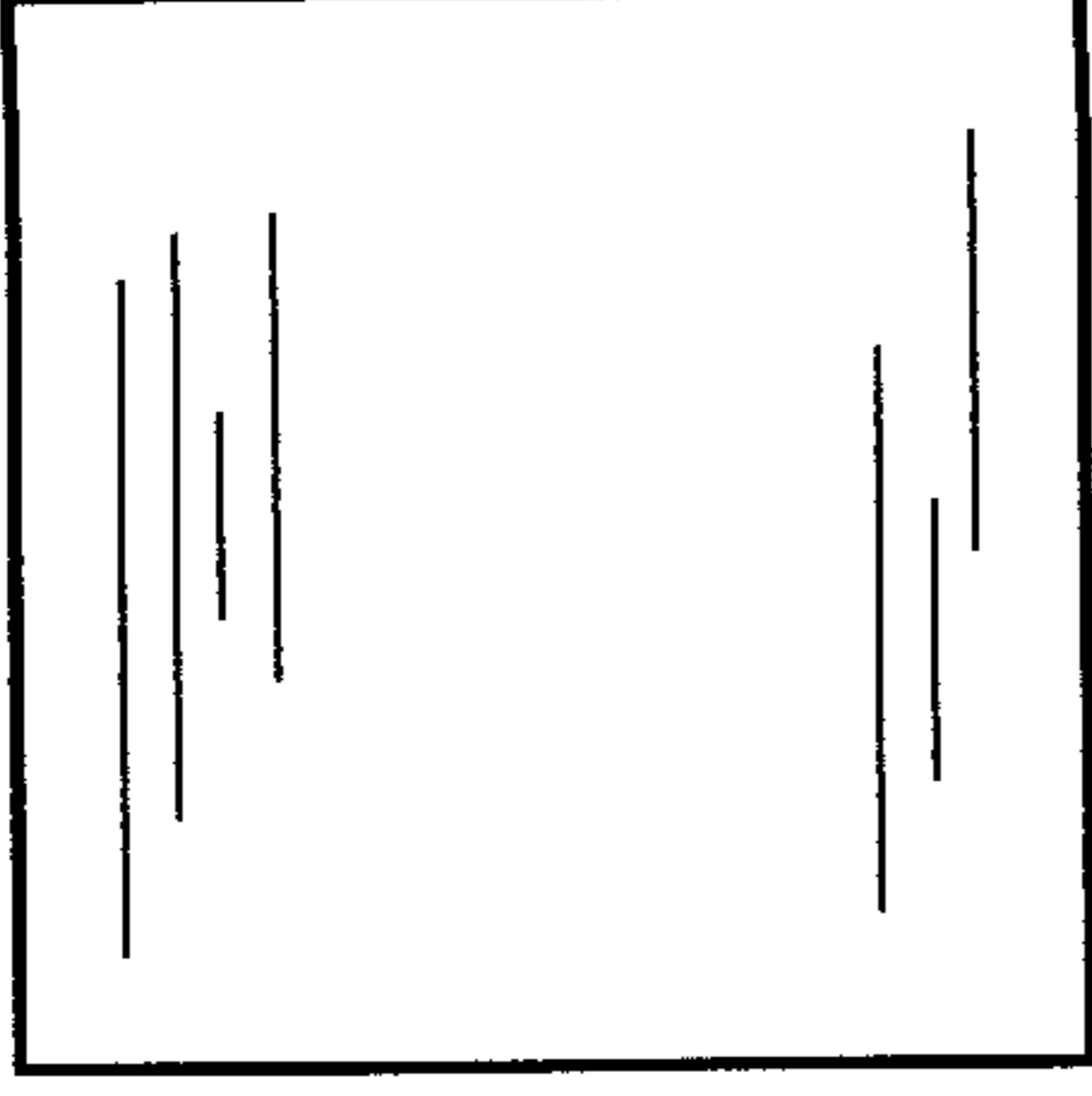

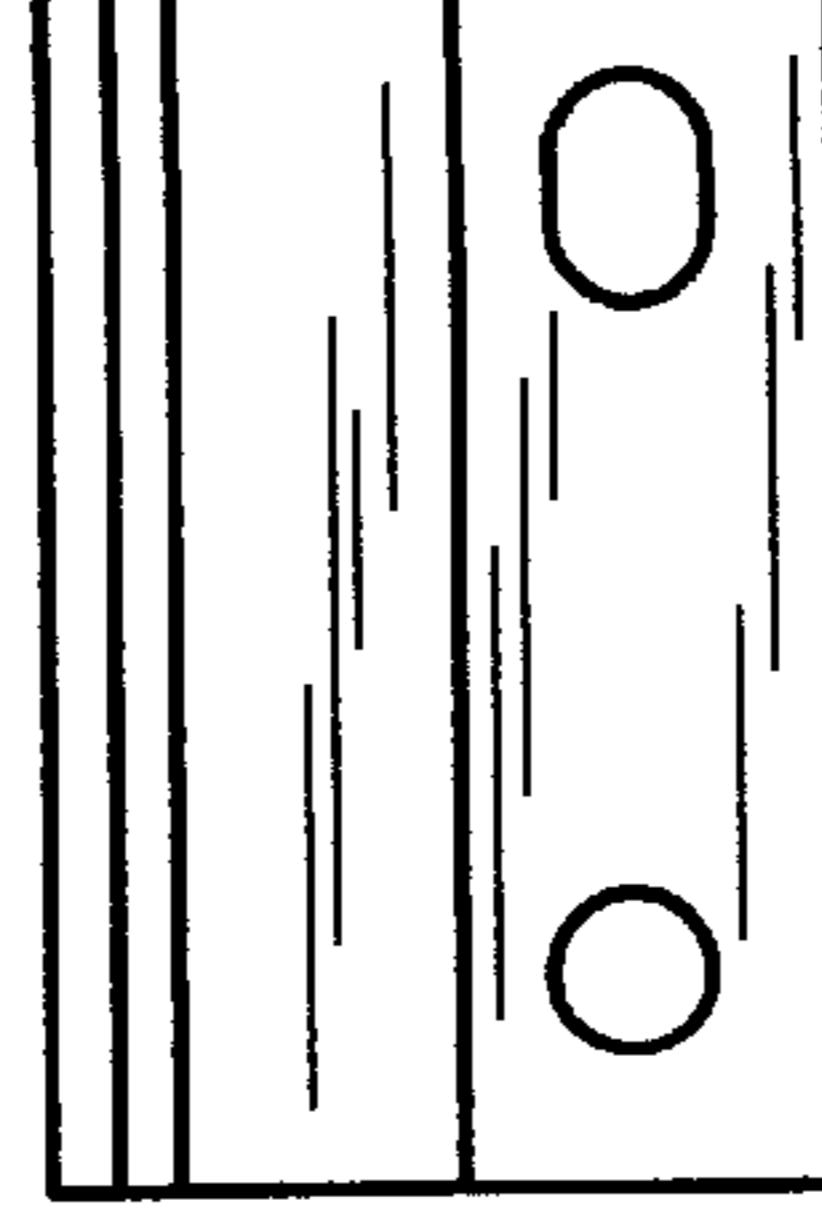

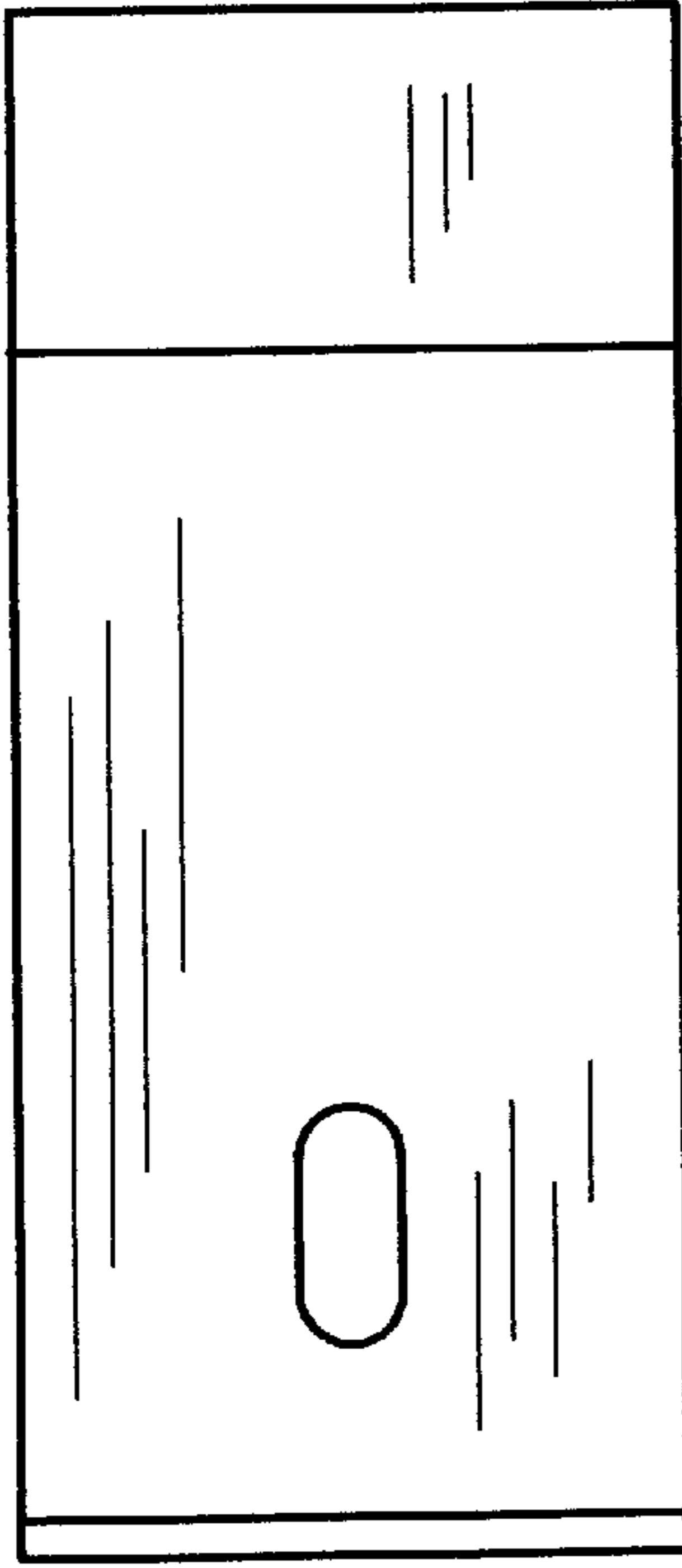

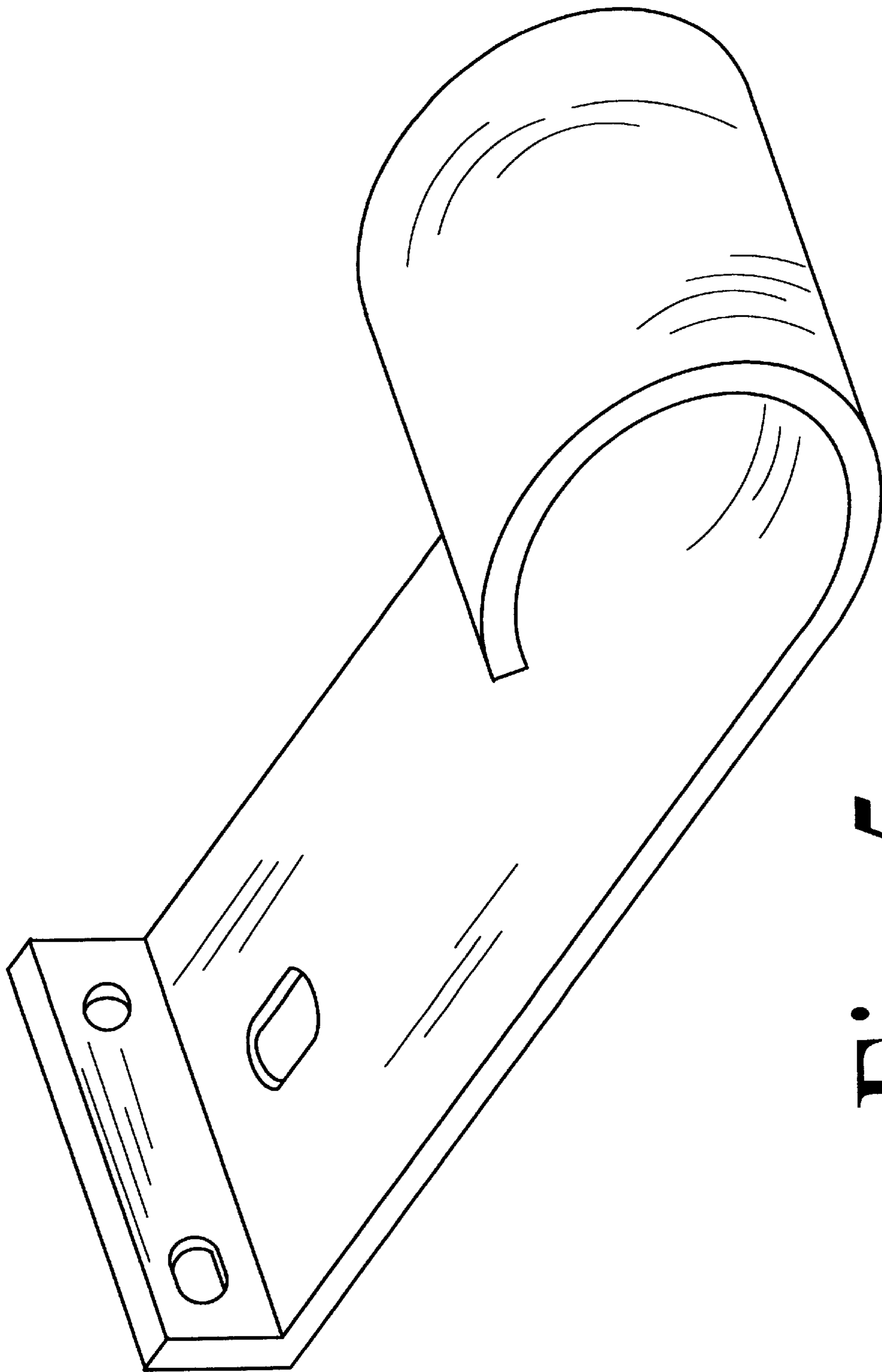

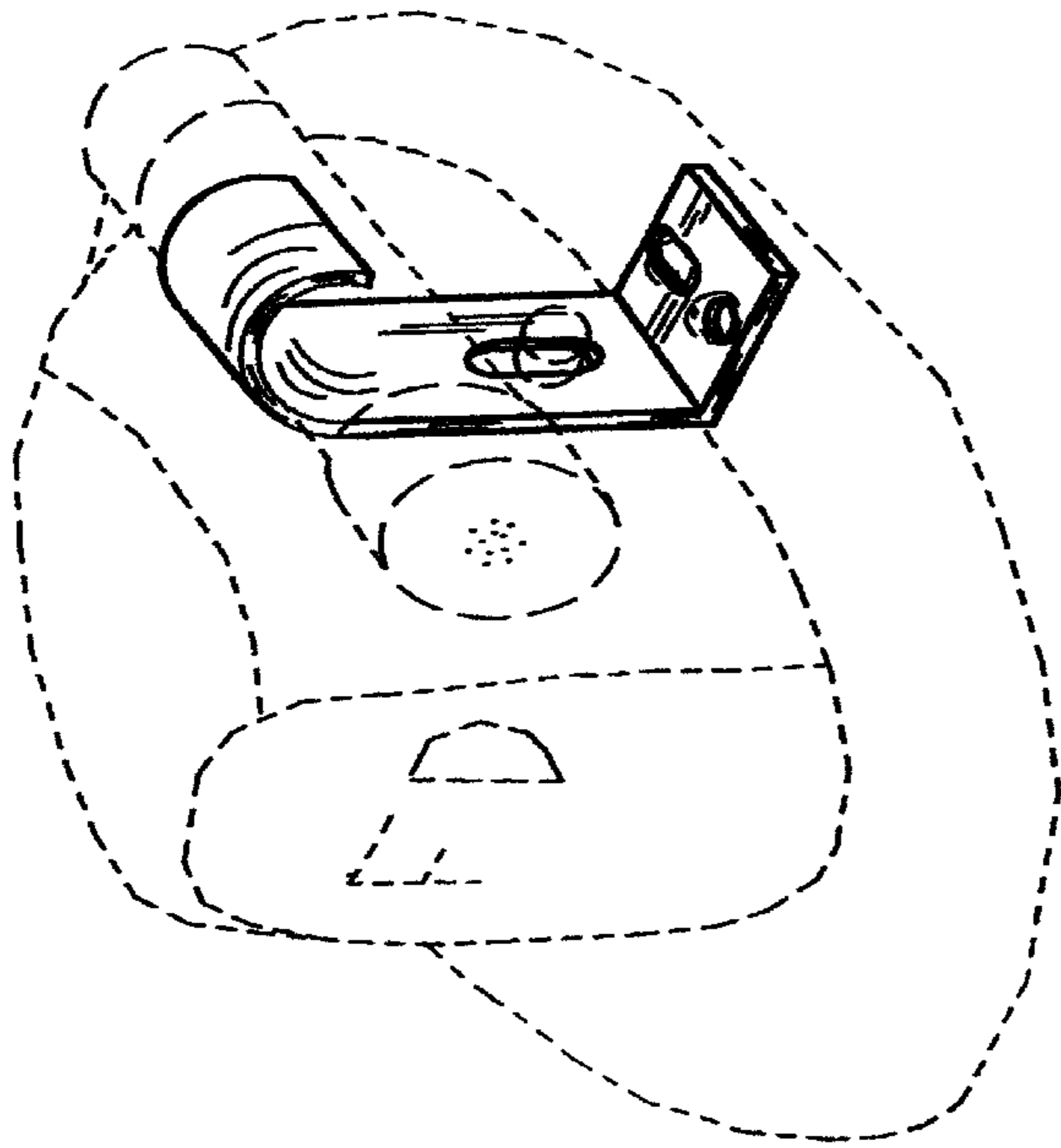

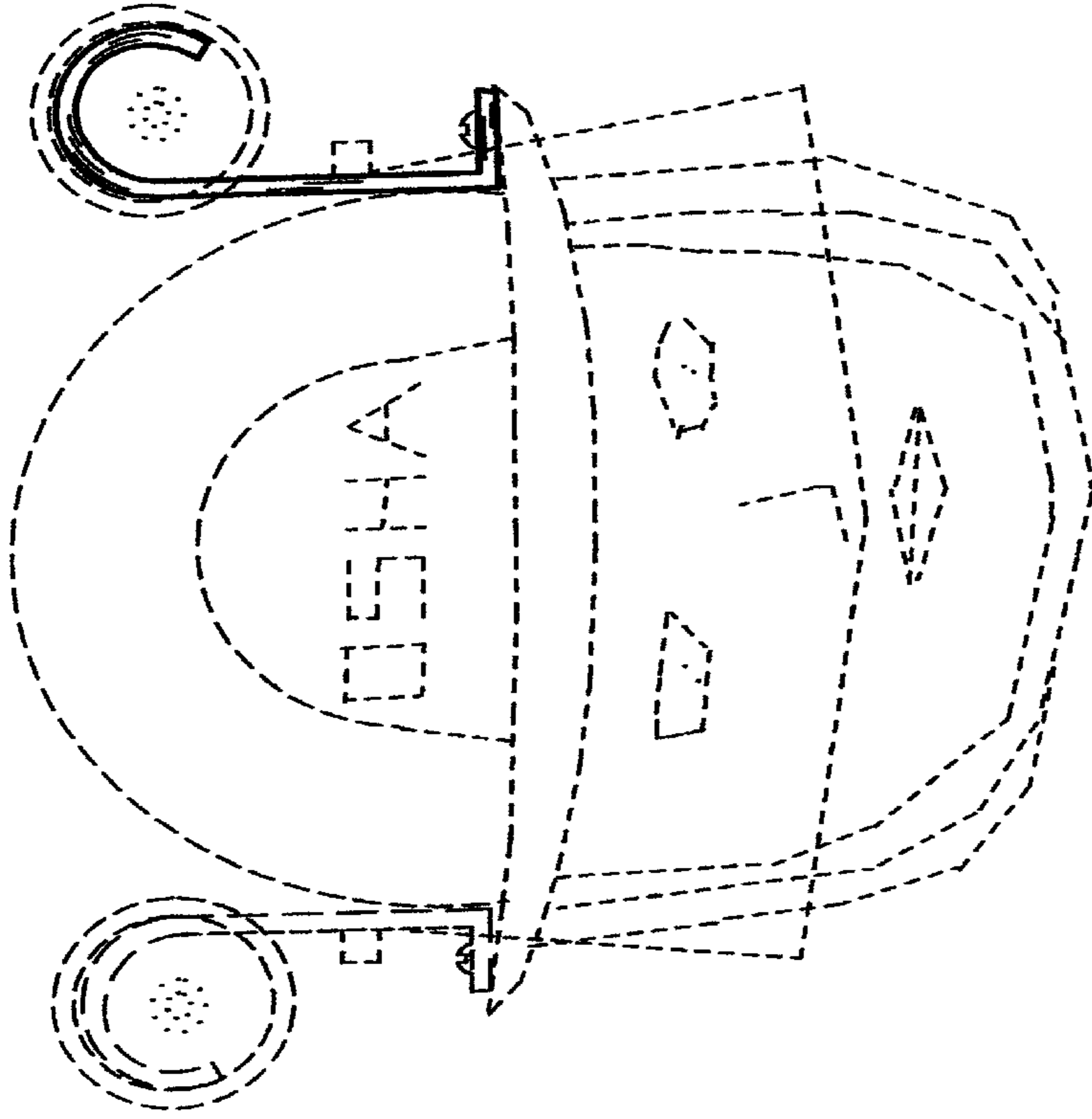
