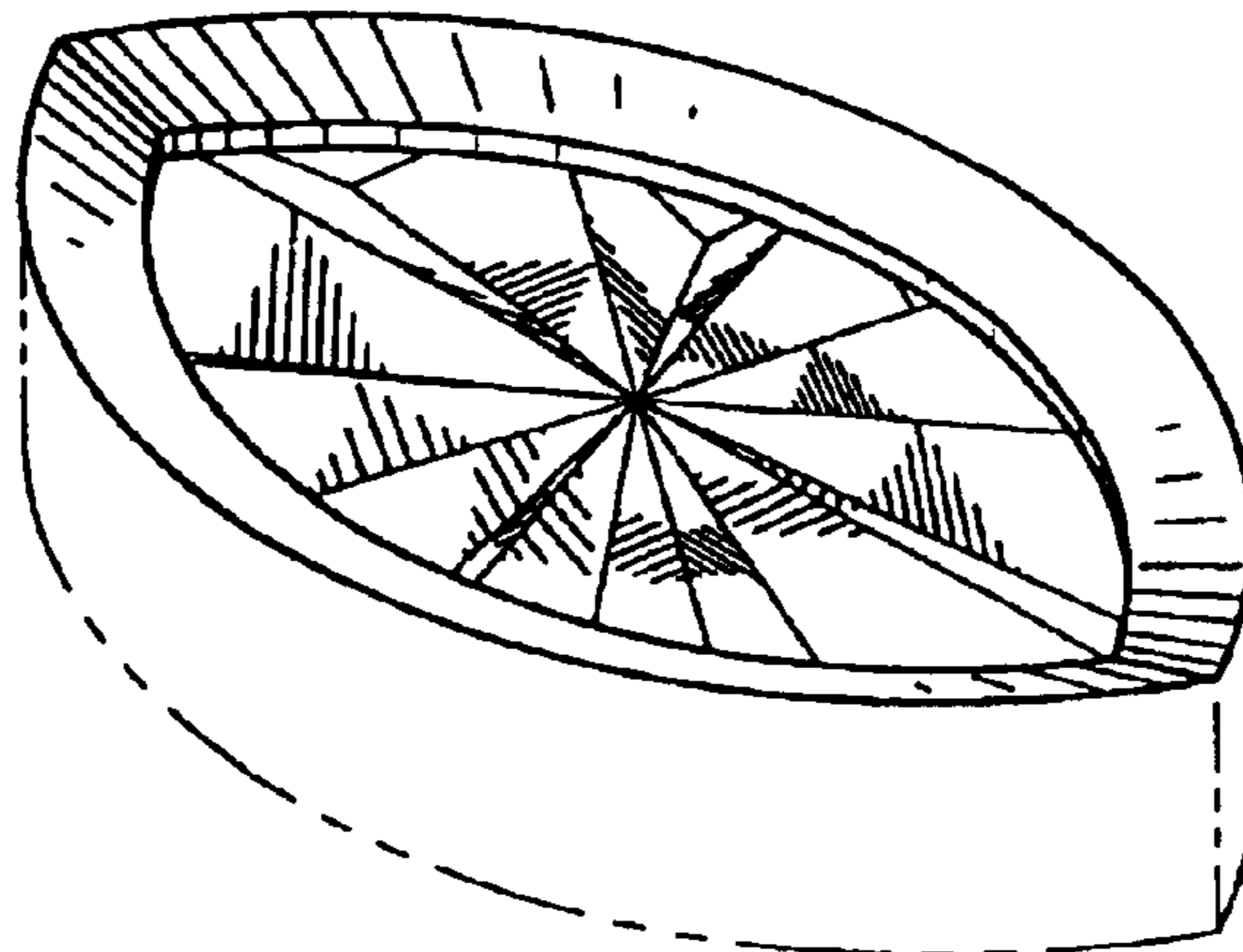

## CLAIM

The ornamental design for a jewelry component, as shown and described.

## DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a

jewelry component showing our new design;

FIG. 2 is a top plan view of the first embodiment;

FIG. 3 is an enlarged partial cross sectional view taken along the line 3—3 in FIG. 2 to show only the feature of the sloping top;

FIG. 4 is a left side elevational view of the first, second, third, fourth, and fifth embodiments, the right elevational view being a mirror image;

FIG. 5 is a front elevational view of the first, second, third, fourth, and fifth embodiments, the rear elevational view being a mirror image;

FIG. 6 is a perspective view of a second embodiment of a jewelry component showing our new design;

FIG. 7 is a top plan view of the second embodiment;

FIG. 8 is an enlarged partial cross sectional view taken along the line 8—8 in FIGS. 7, 10, 12, and 14 to show only the feature of the sloping top;

FIG. 9 is a perspective view of a third embodiment of a jewelry component showing our new design;

FIG. 10 is a top plan view of the third embodiment;

FIG. 11 is a perspective view of a fourth embodiment of a jewelry component showing our new design;

FIG. 12 is a top plan view of the fourth embodiment;

FIG. 13 is a perspective view of a fifth embodiment of a jewelry component showing our new design;

FIG. 14 is a top plan view of the fifth embodiment;

FIG. 15 is a perspective view of a sixth embodiment of a jewelry component showing our new design;

FIG. 16 is a top plan view of the sixth embodiment;

FIG. 17 is a left side elevational view of the sixth, seventh, eighth, ninth, and tenth embodiments, the right elevational view being a mirror image;

FIG. 18 is a front elevational view of the sixth, seventh, eighth, ninth, and tenth embodiments, the rear elevational view being a mirror image;

FIG. 19 is a perspective view of a seventh embodiment of a jewelry component showing our new design;

FIG. 20 is a top plan view of the seventh embodiment;

FIG. 21 is a perspective view of an eighth embodiment of a jewelry component showing our new design;

FIG. 22 is a top plan view of the eighth embodiment;

FIG. 23 is a perspective view of a ninth embodiment of a jewelry component showing our new design;

FIG. 24 is a top plan view of the ninth embodiment;

FIG. 25 is a perspective view of a tenth embodiment of a jewelry component showing our new design; and,

FIG. 26 is a top plan view of the tenth embodiment.

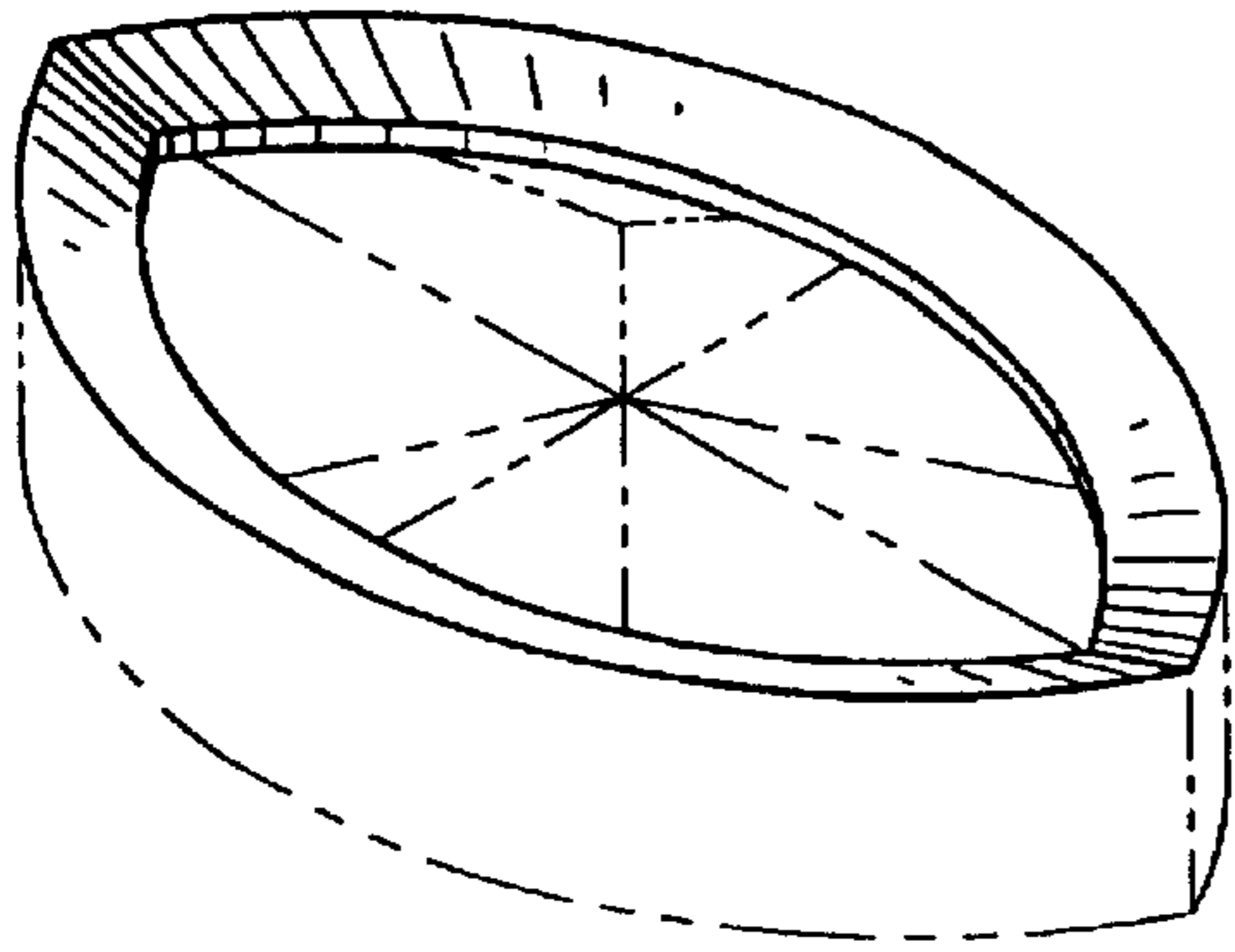

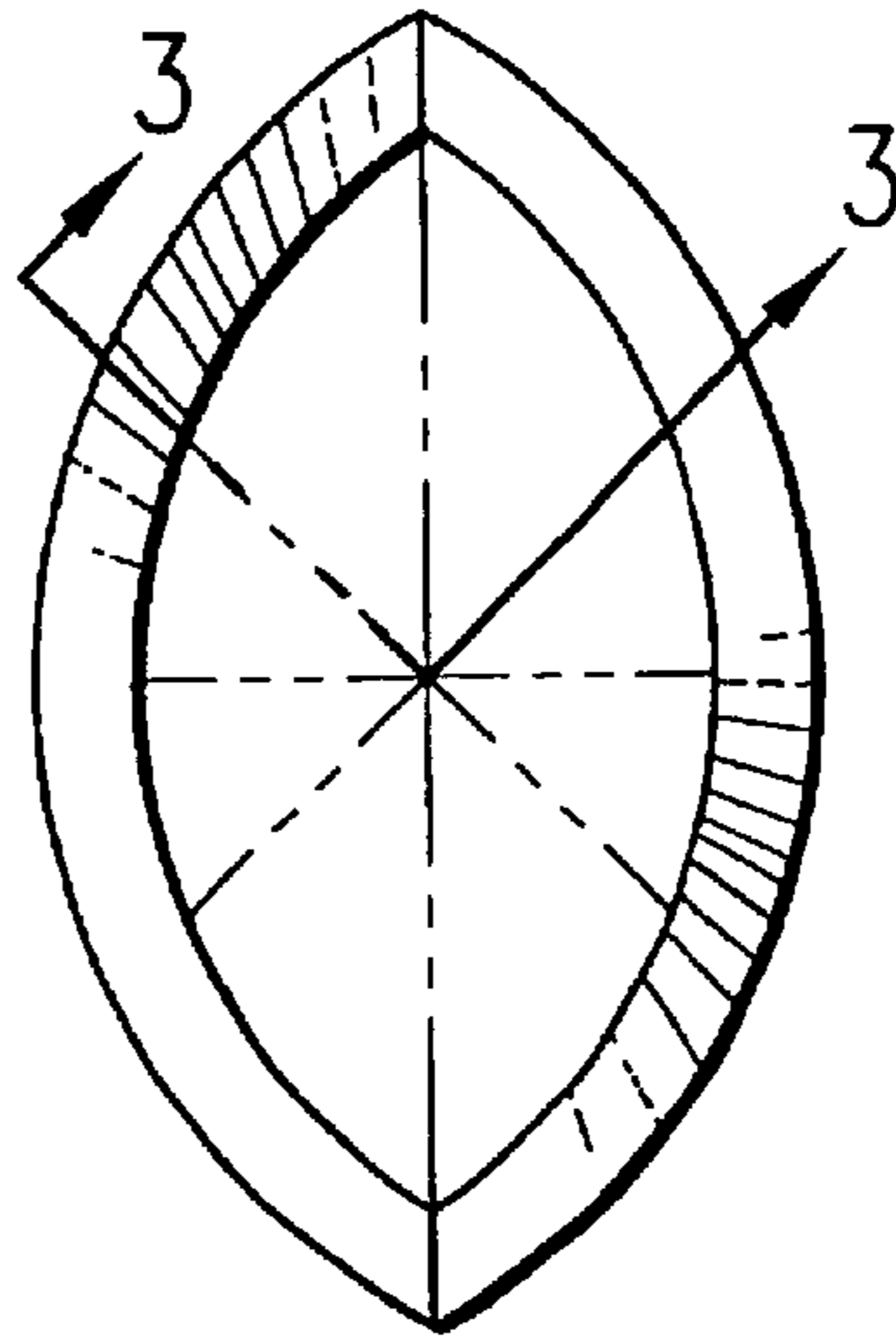

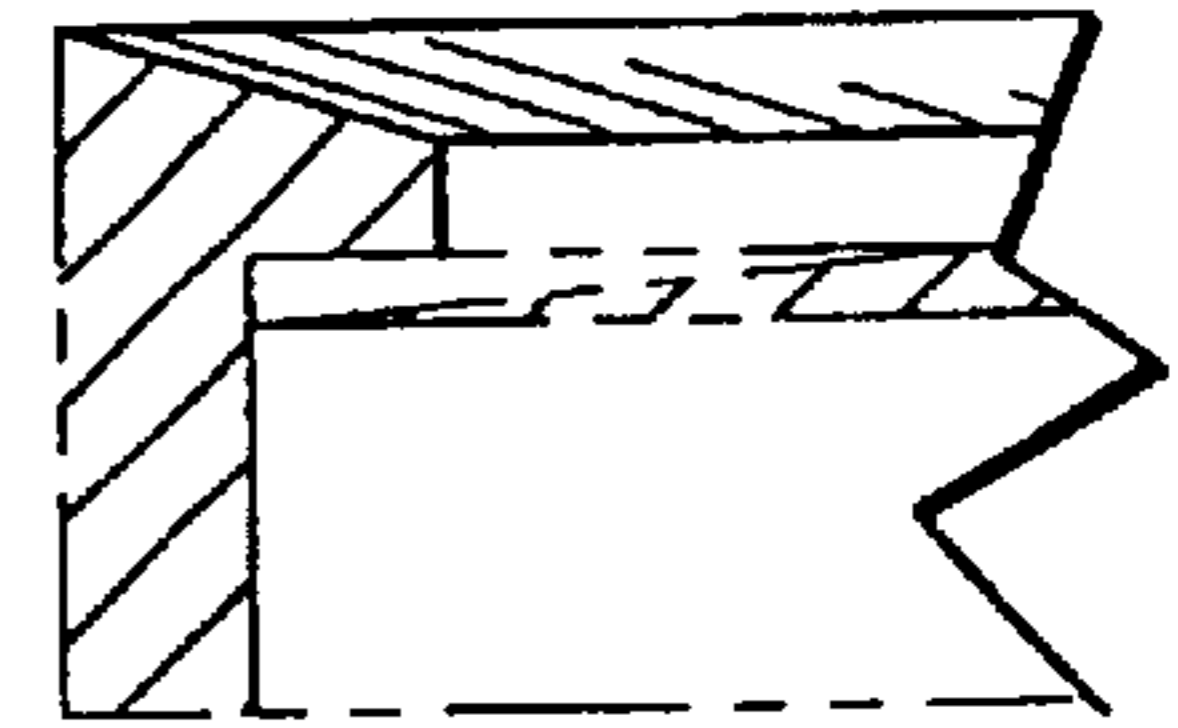

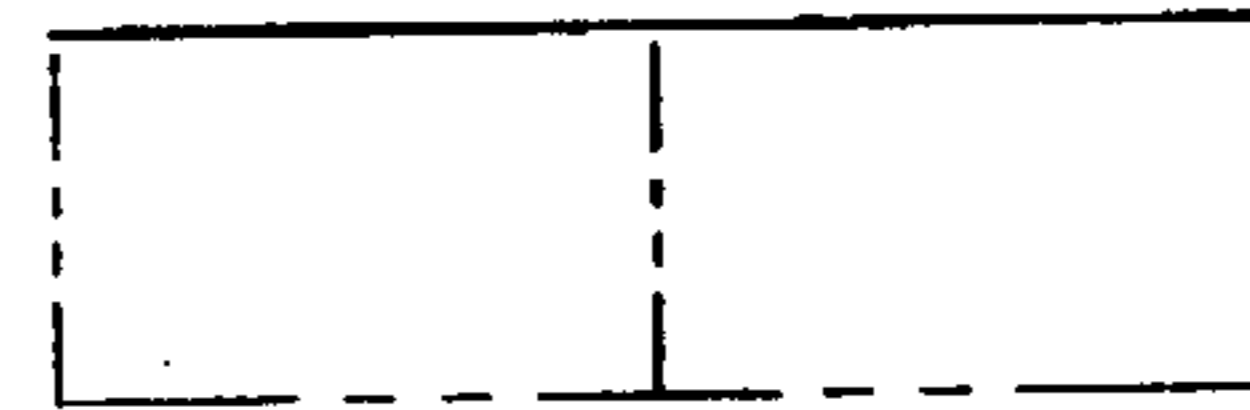

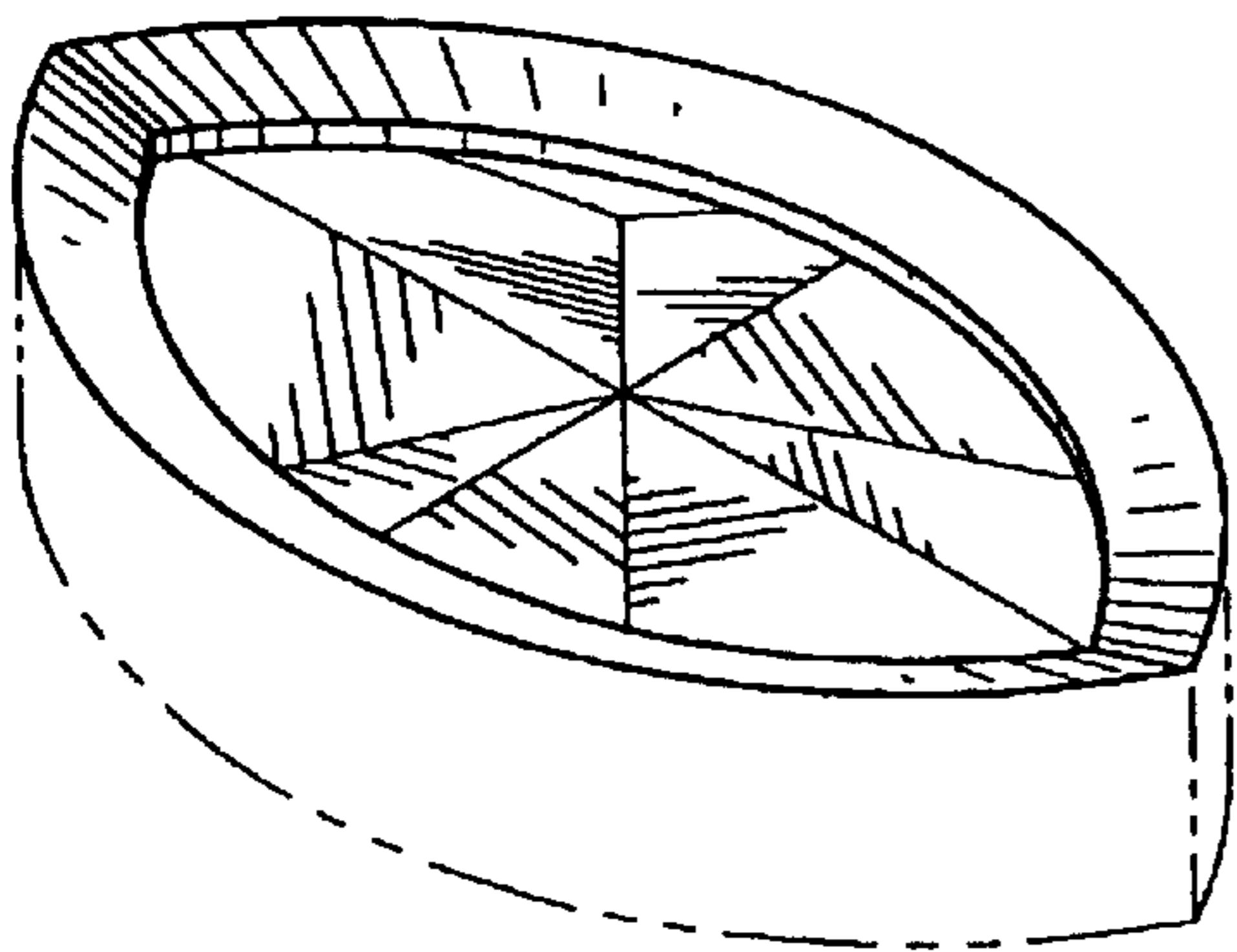

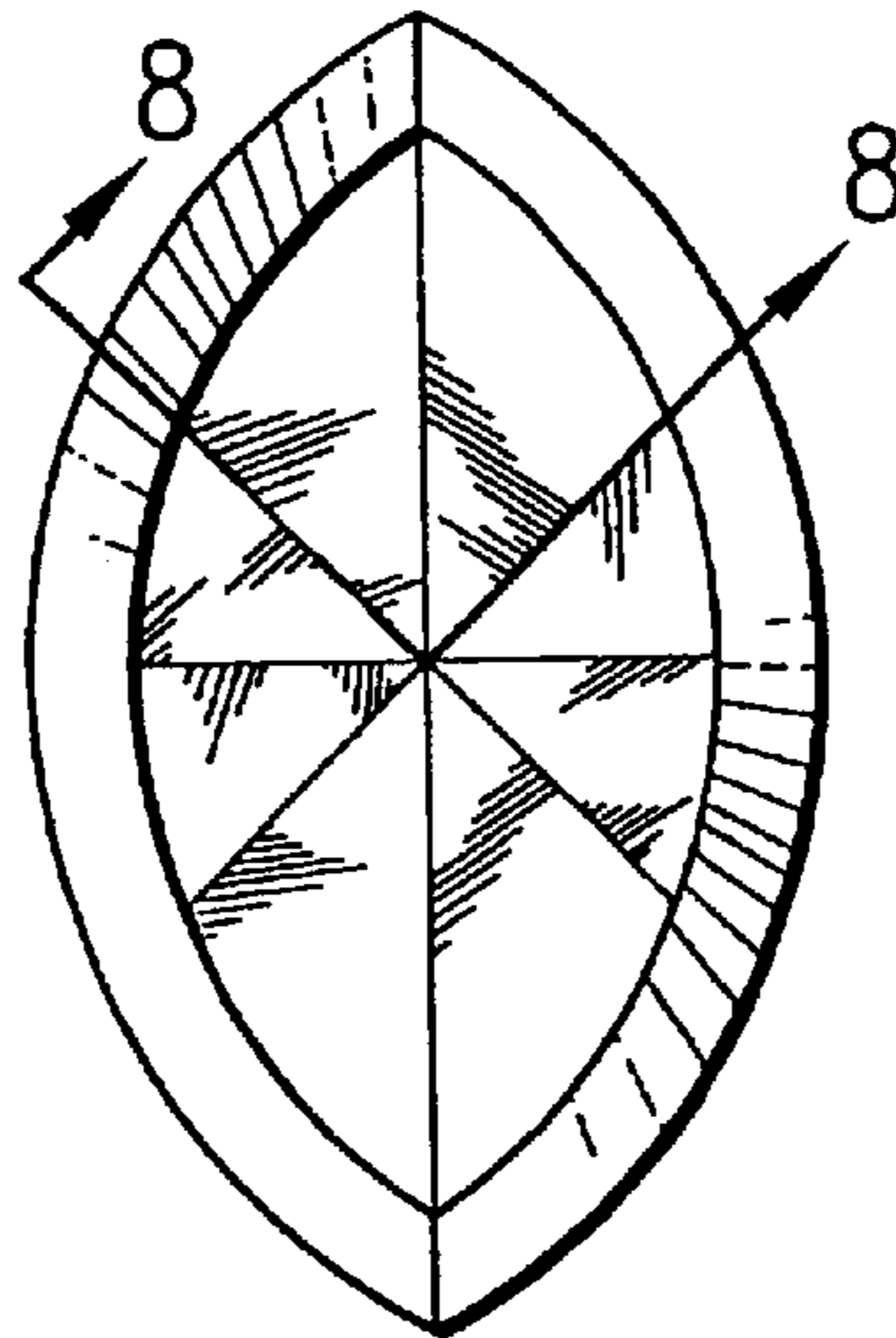

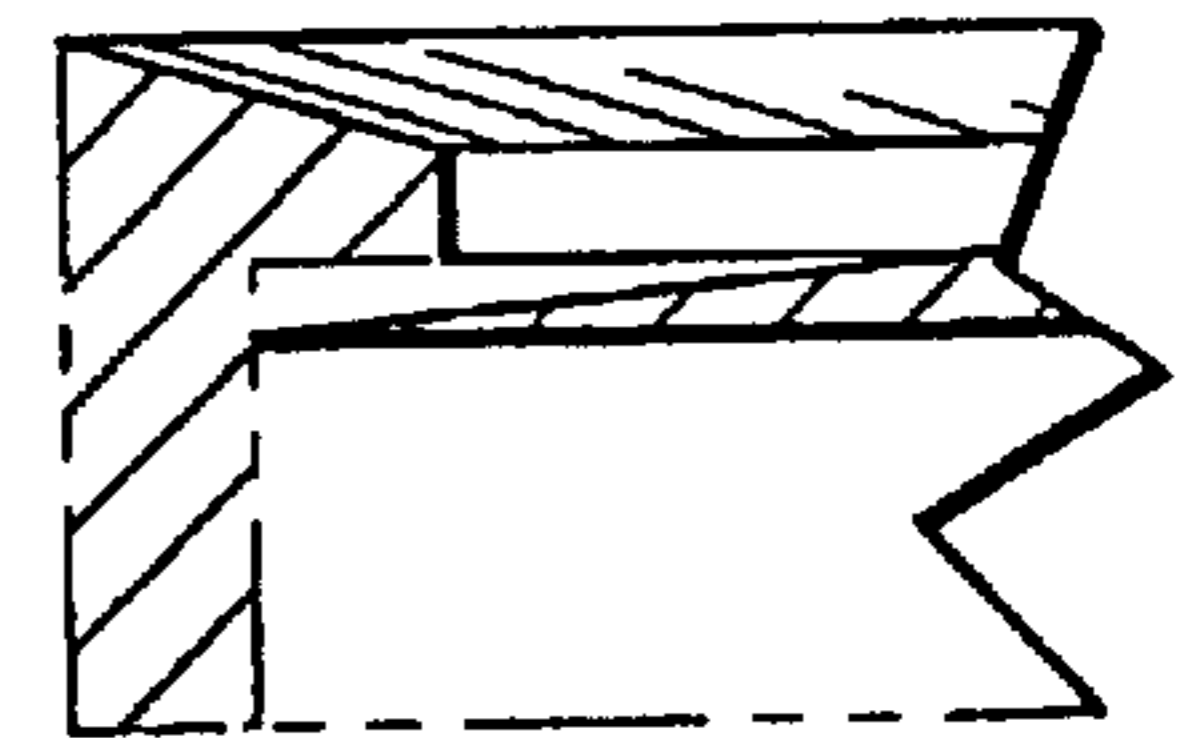

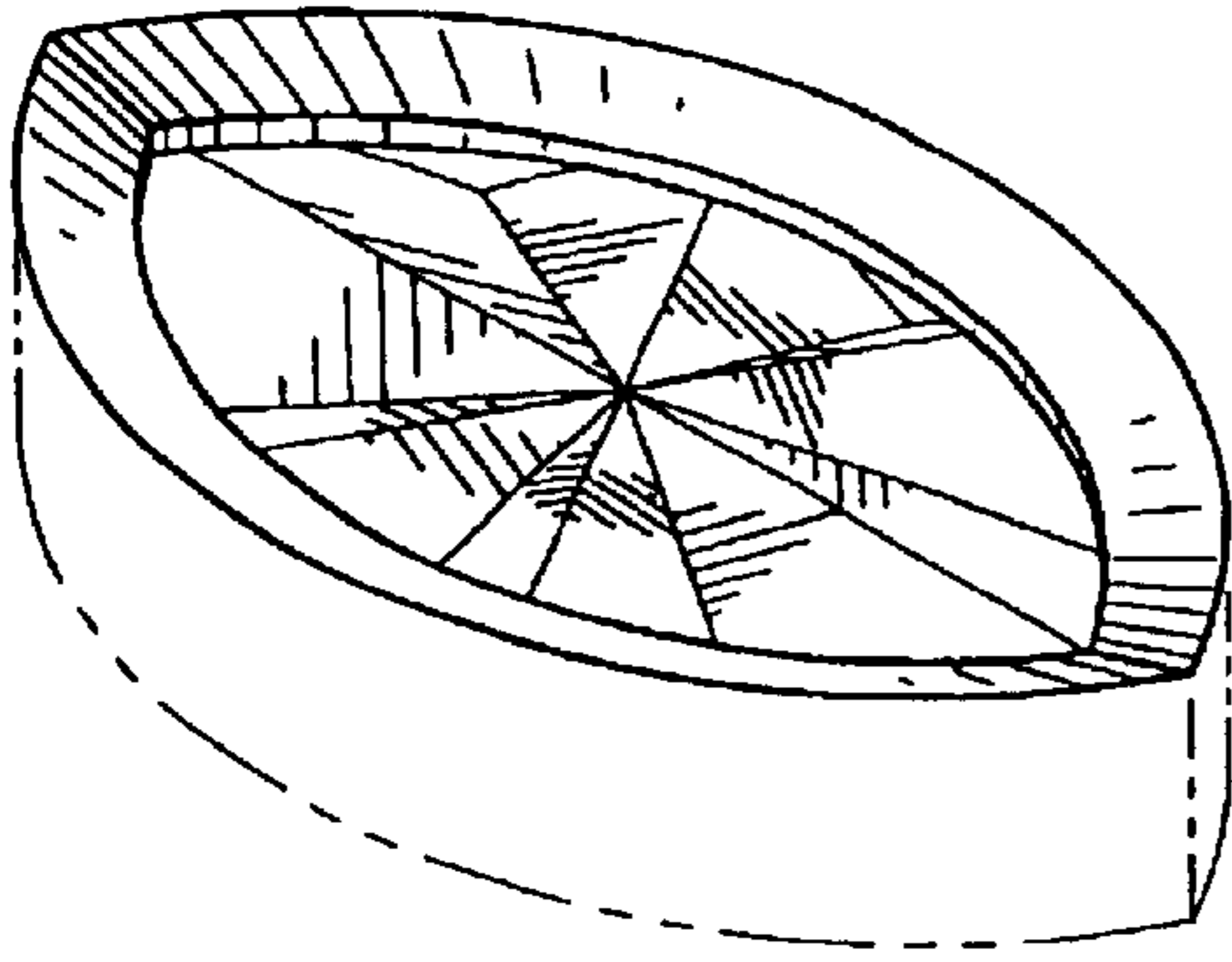

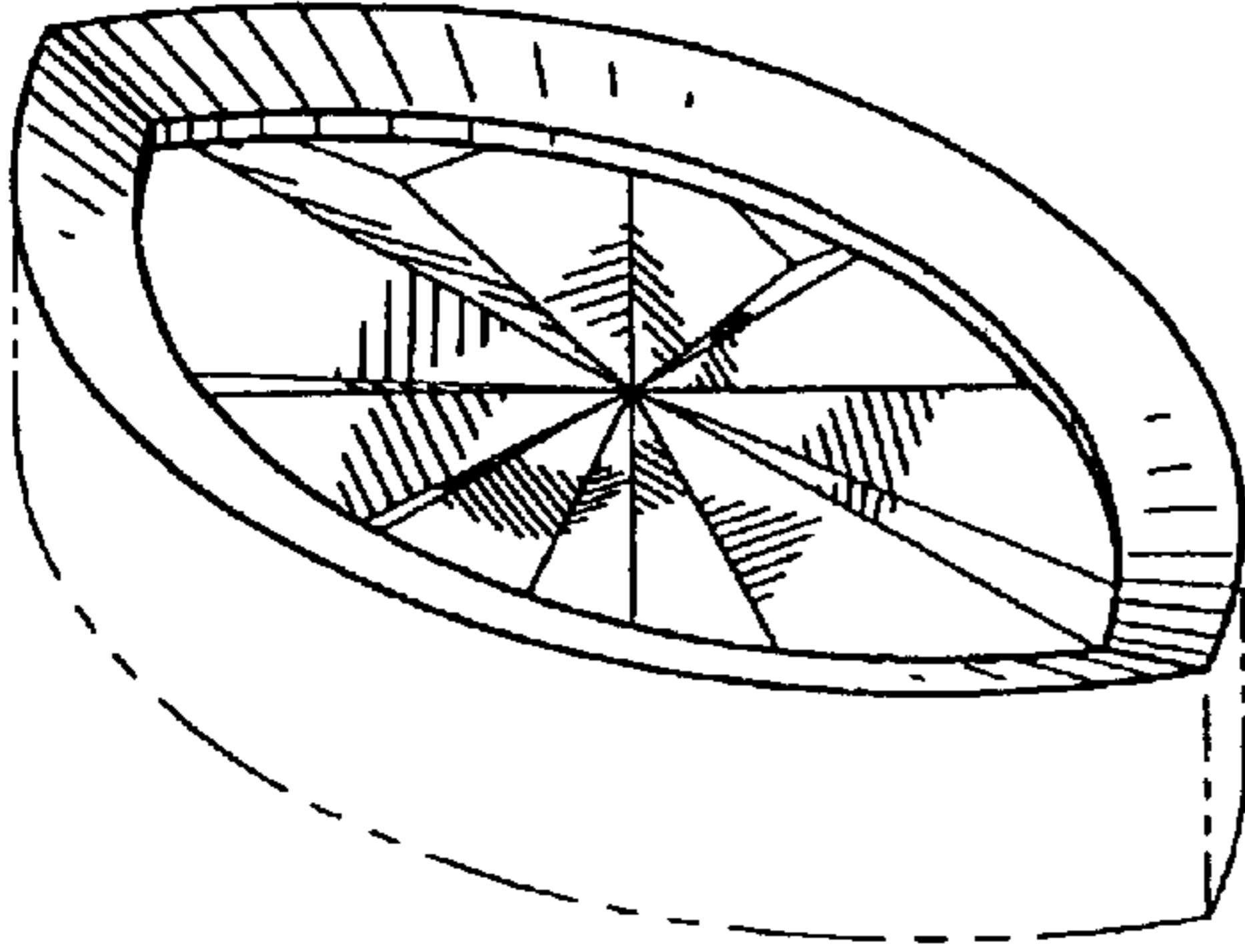

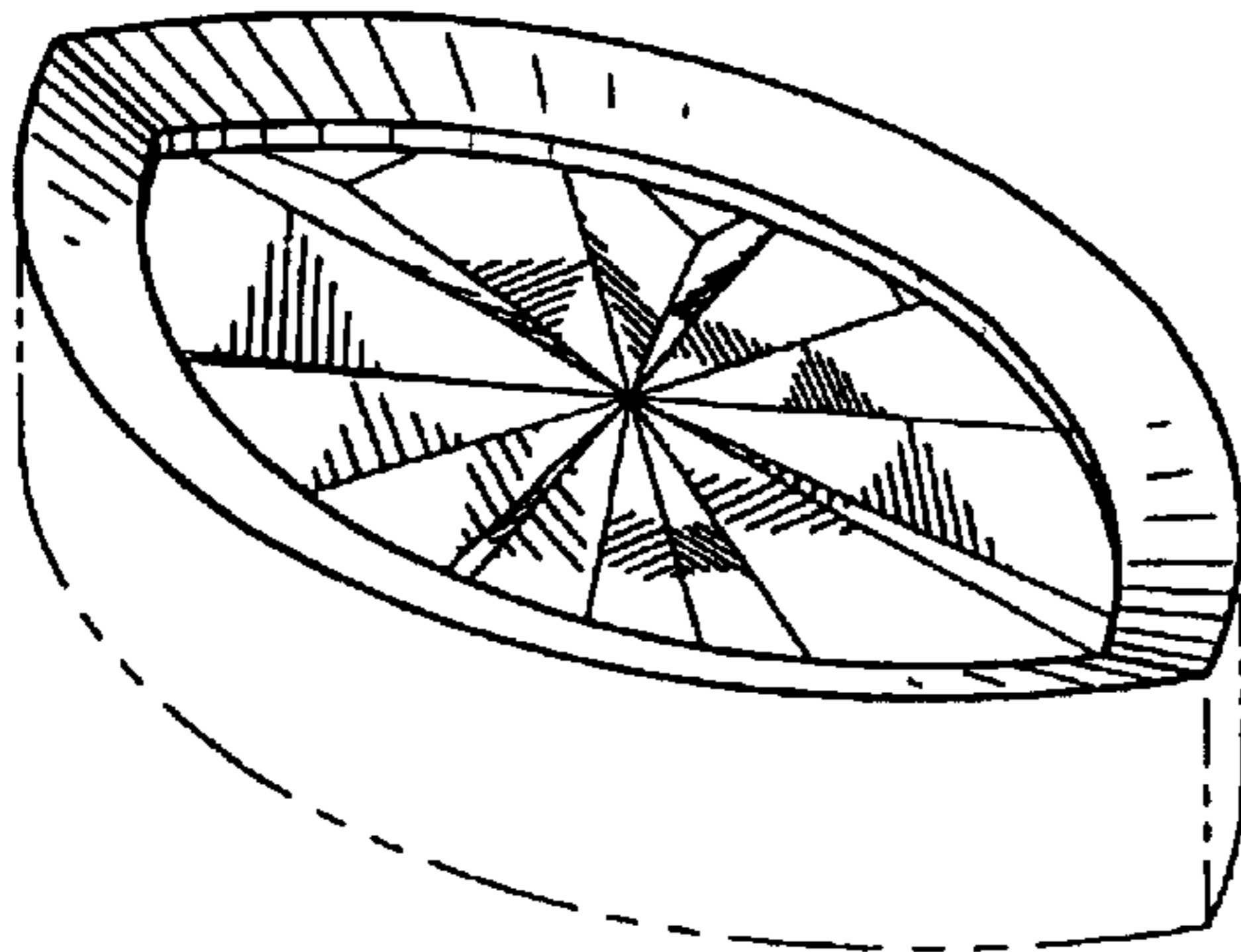

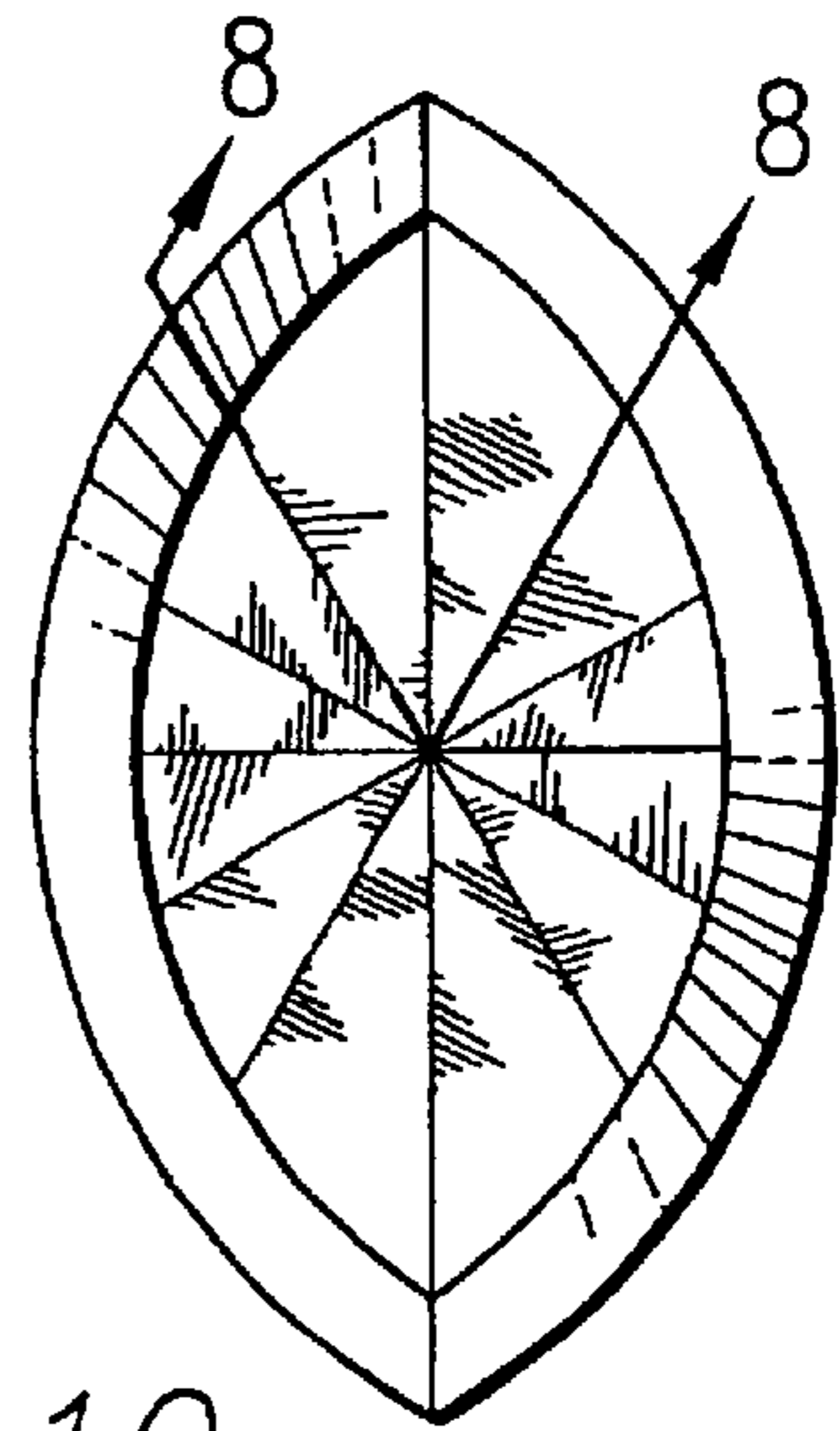

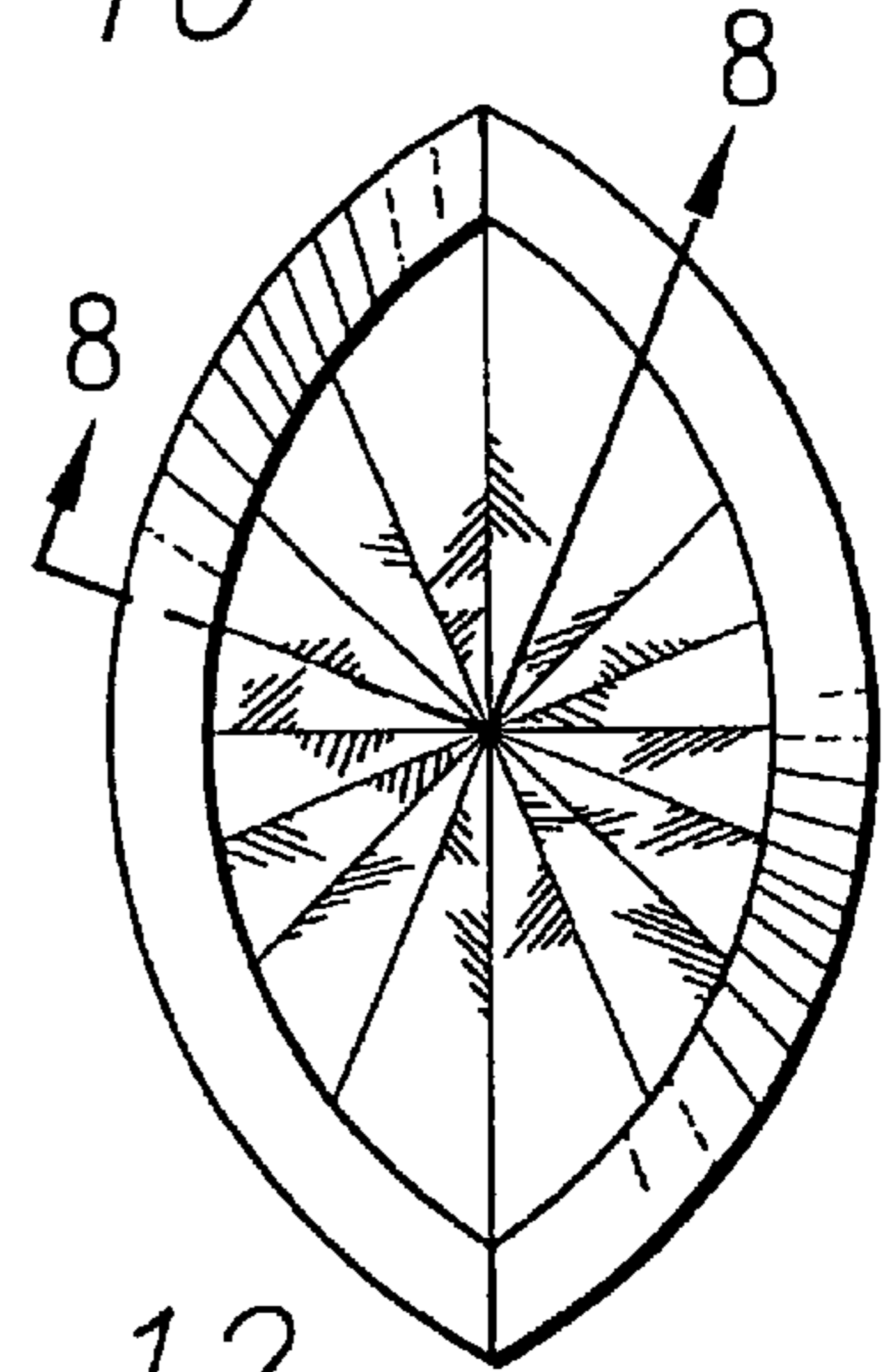

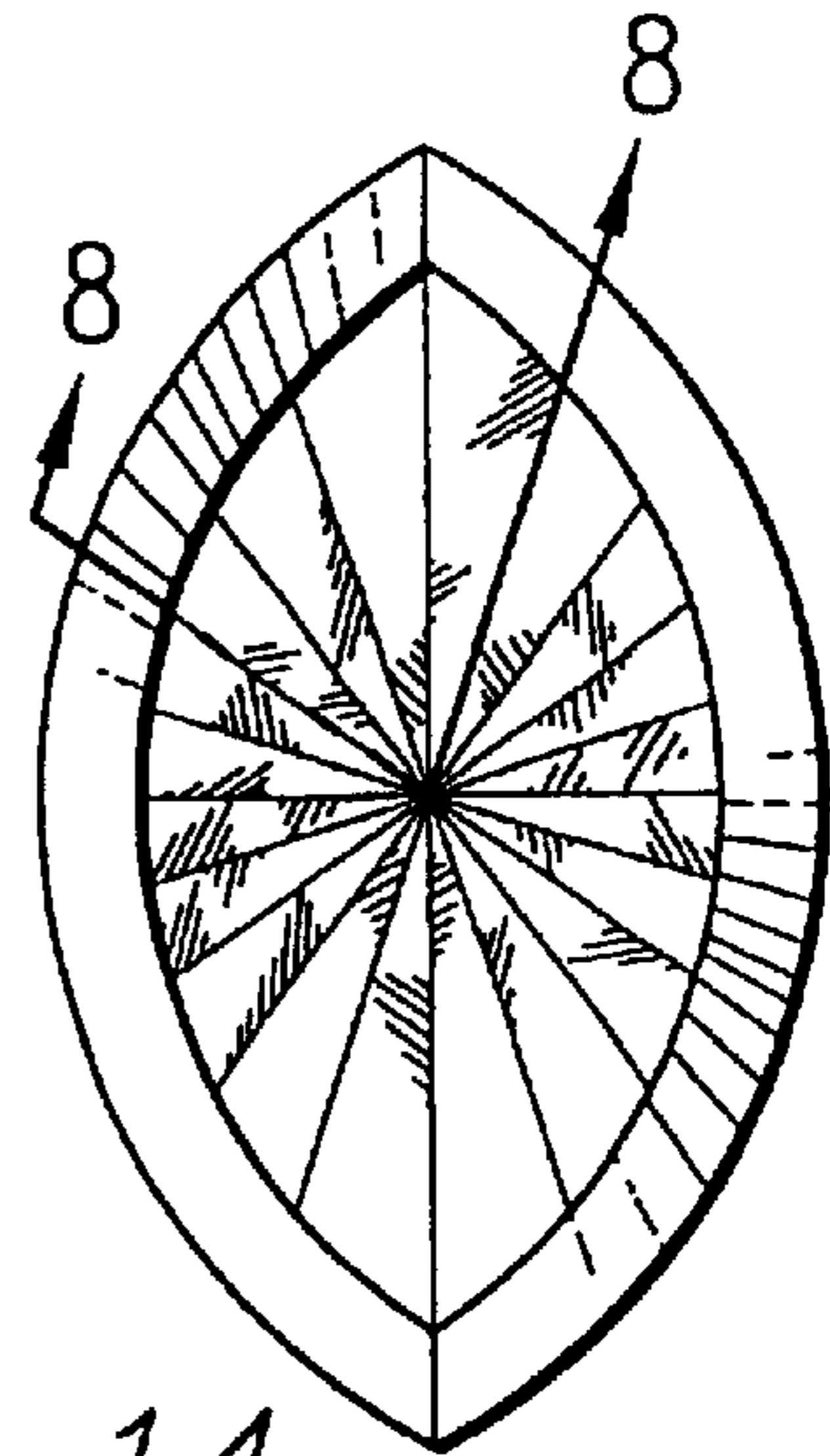

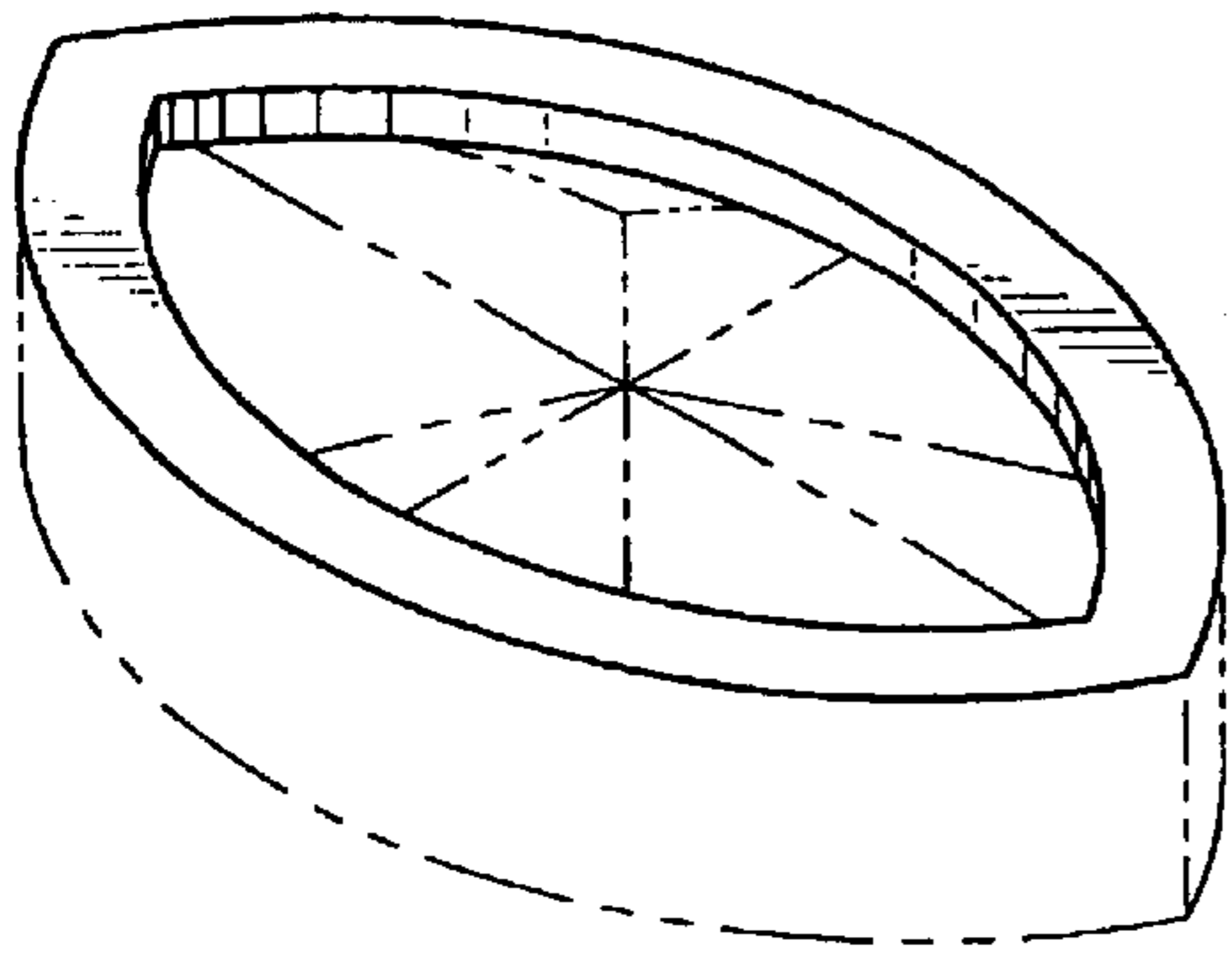

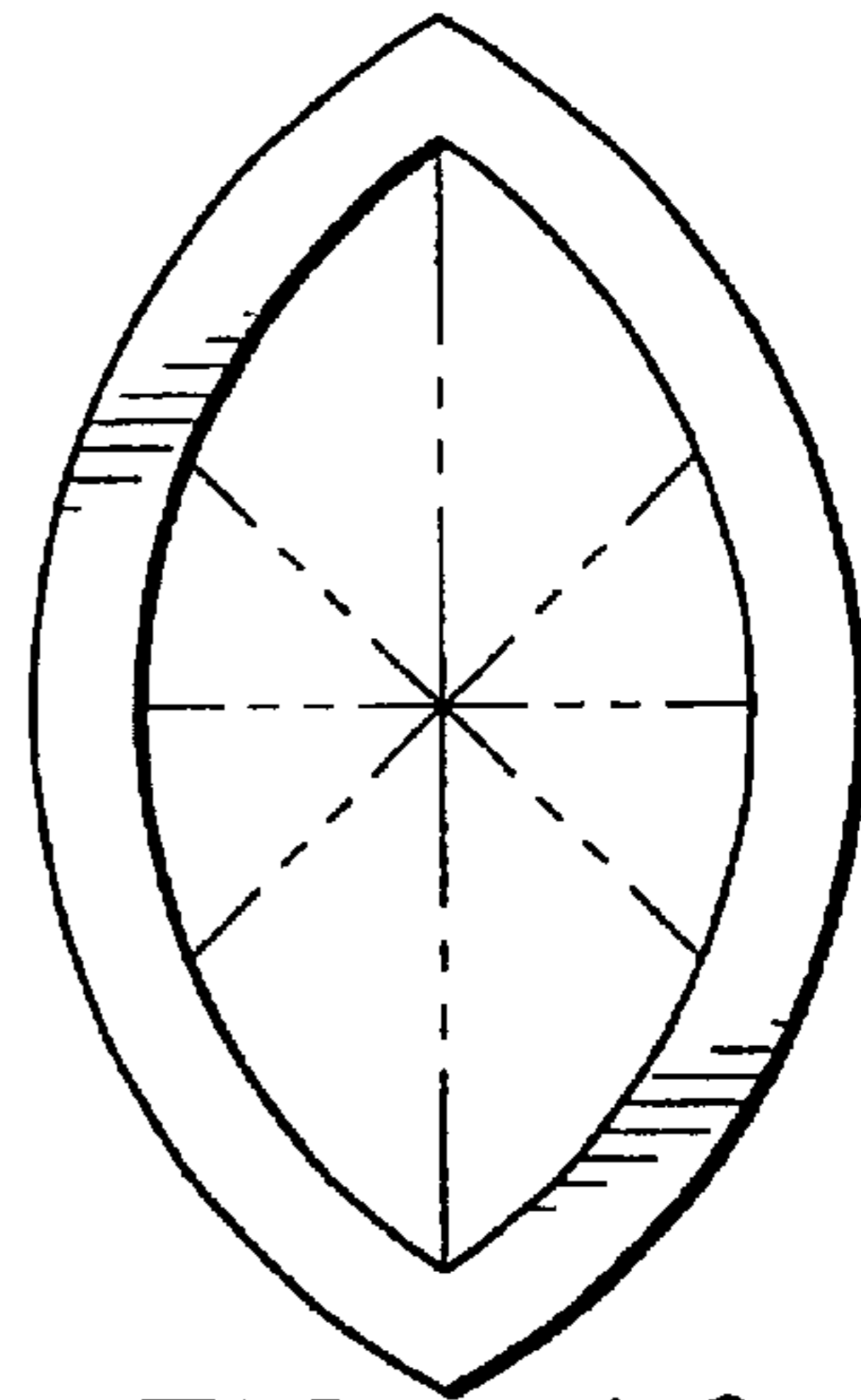

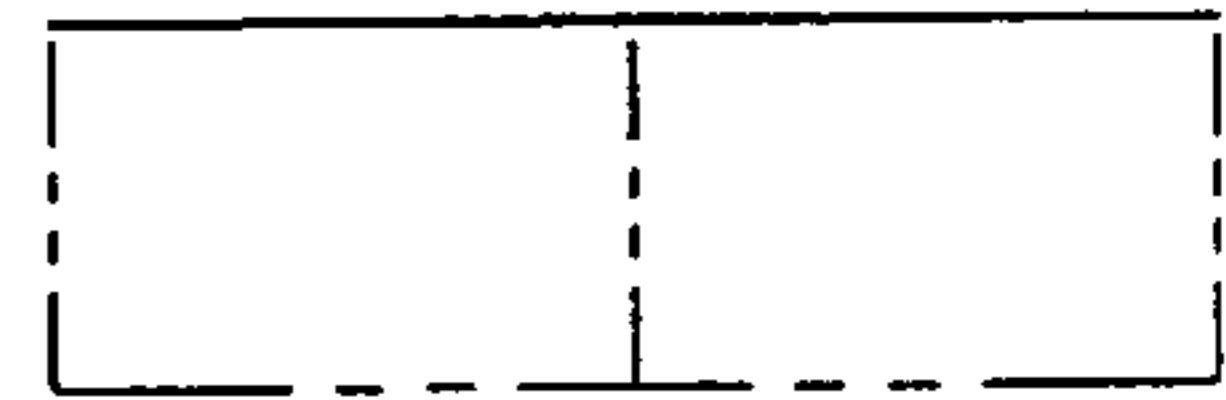

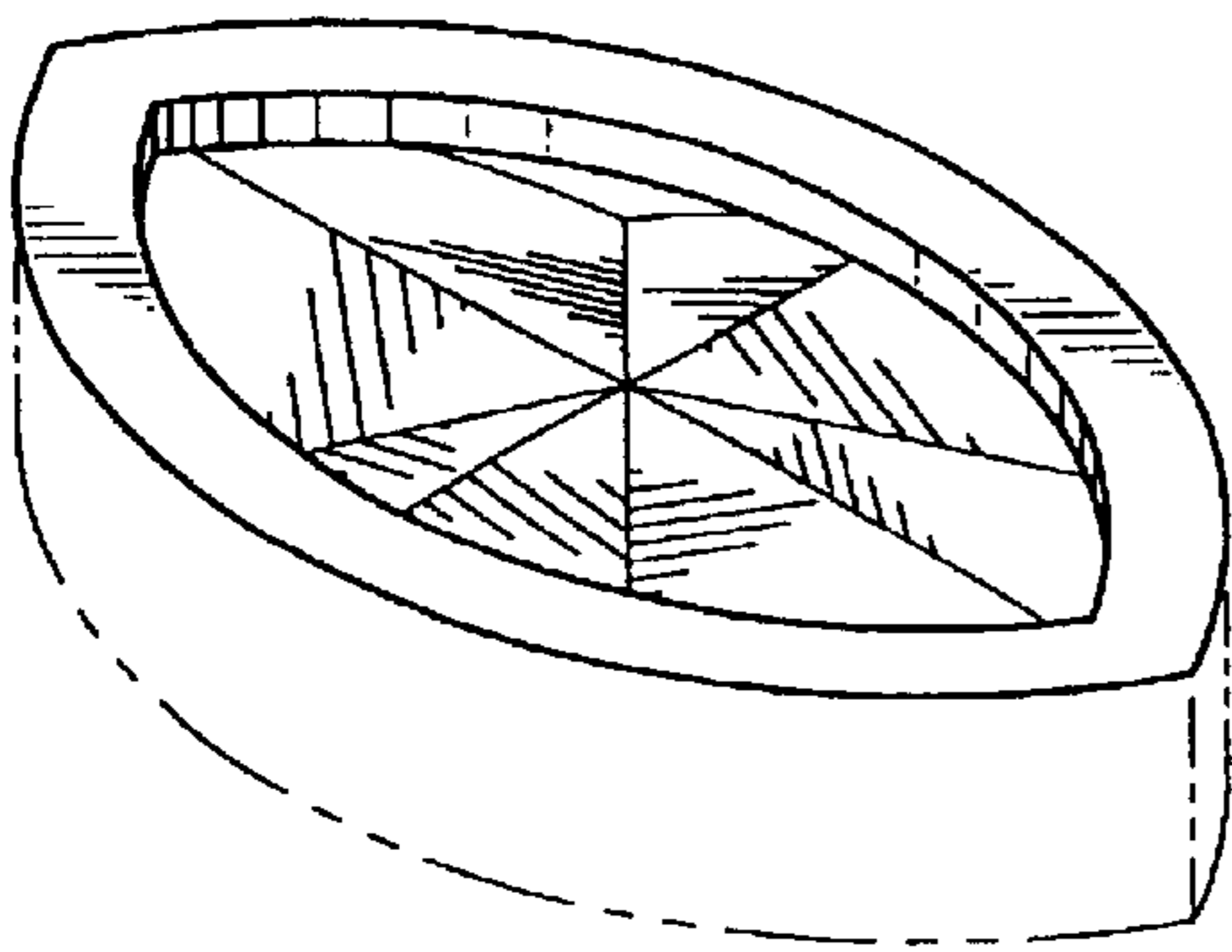

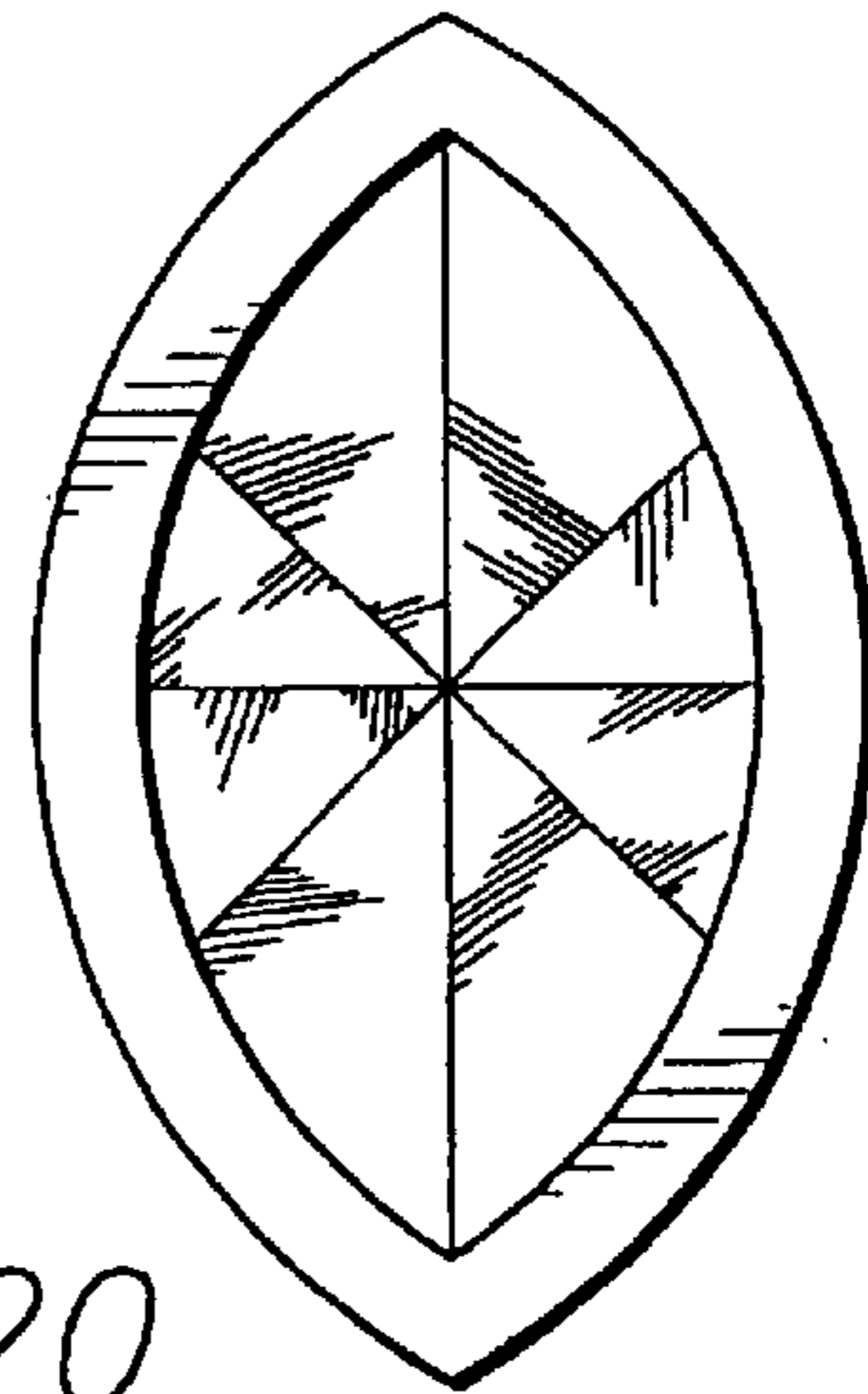

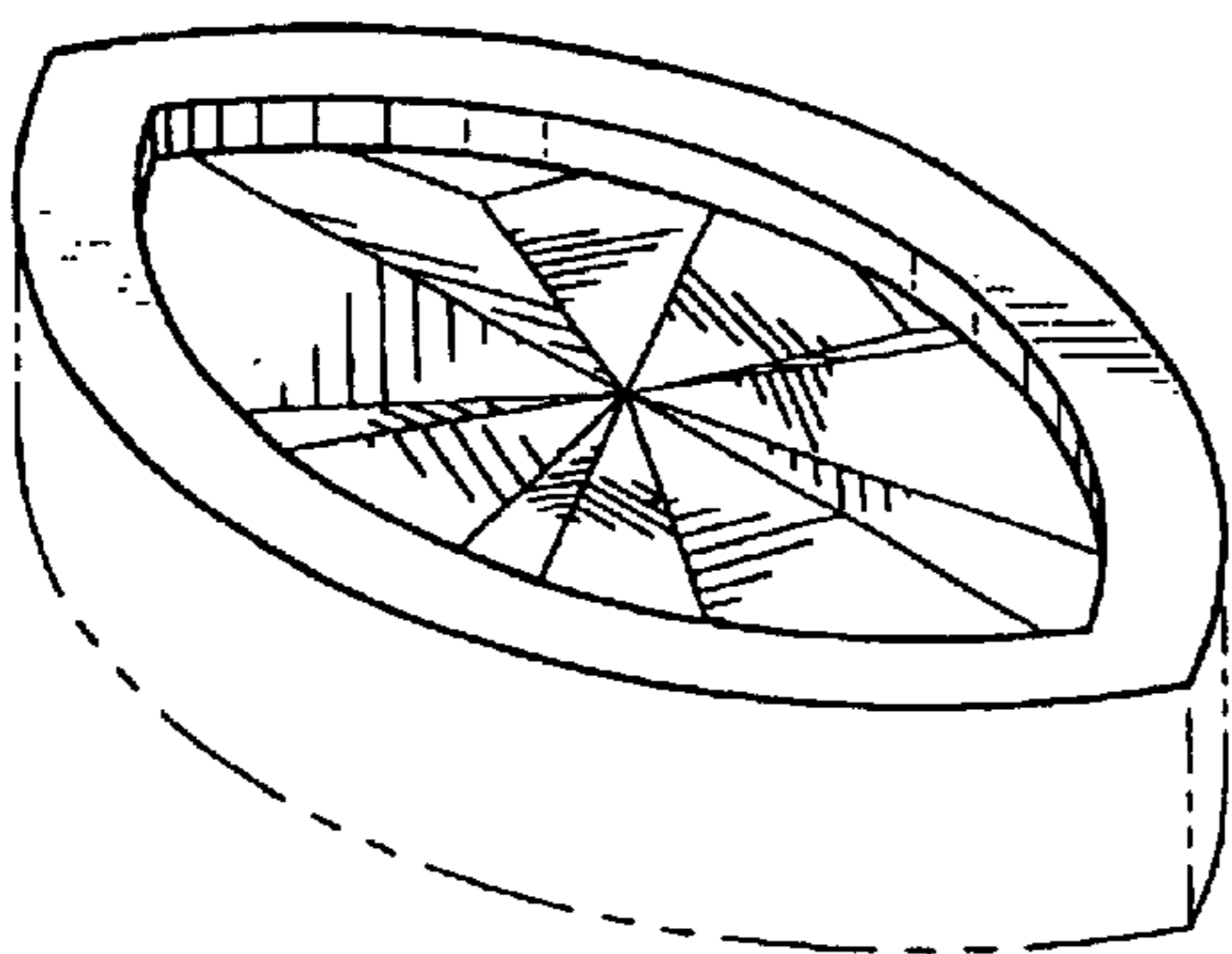

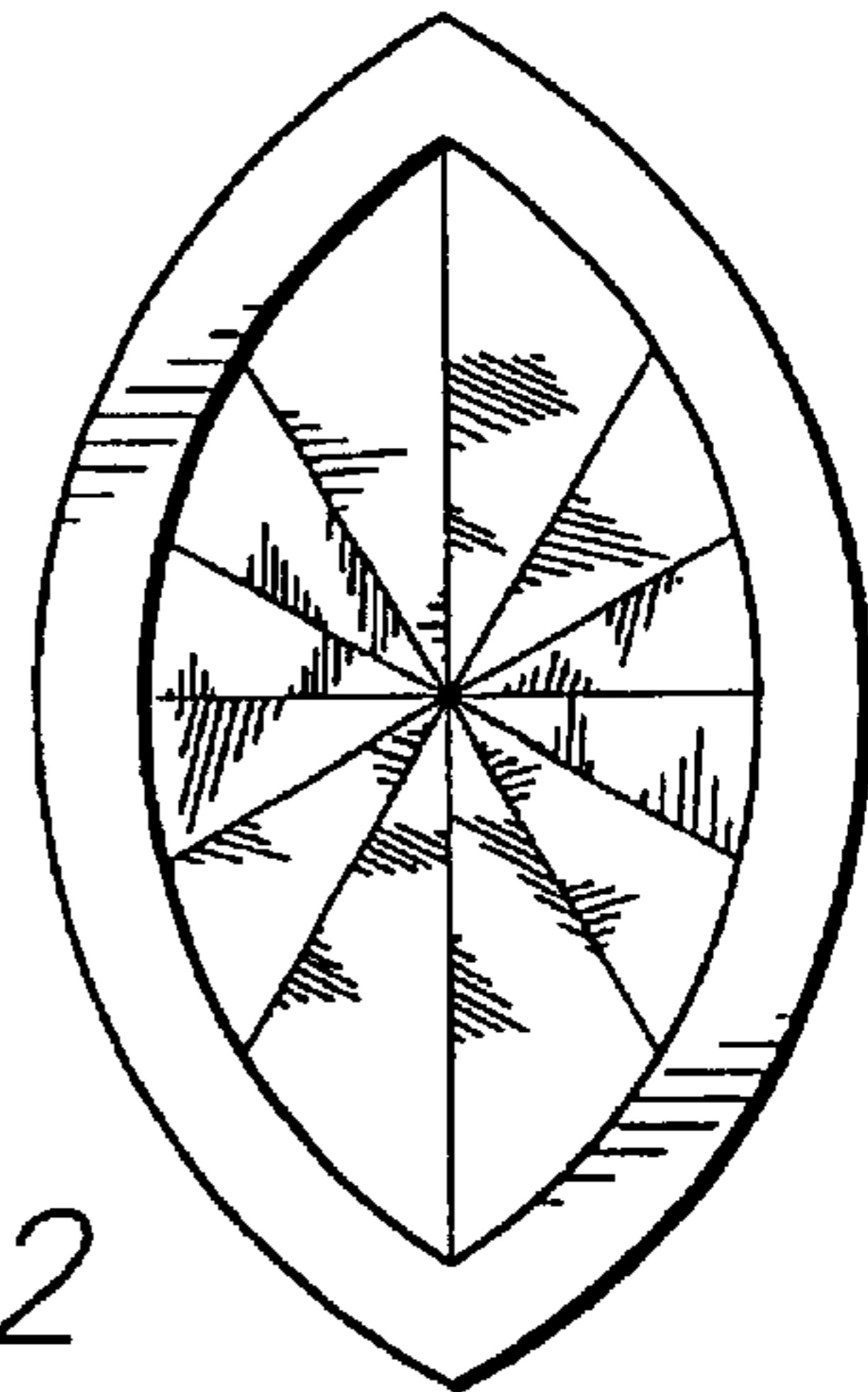

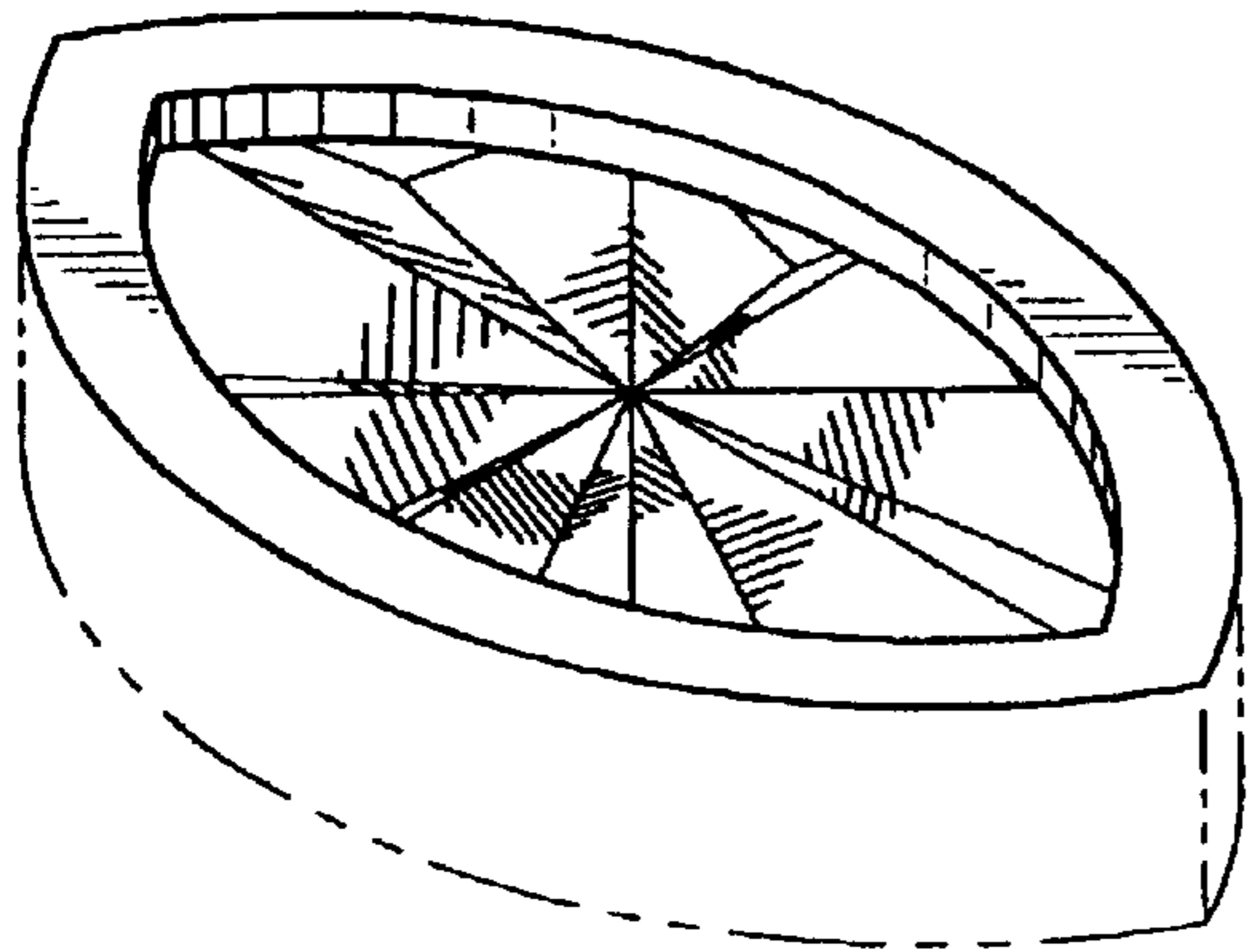

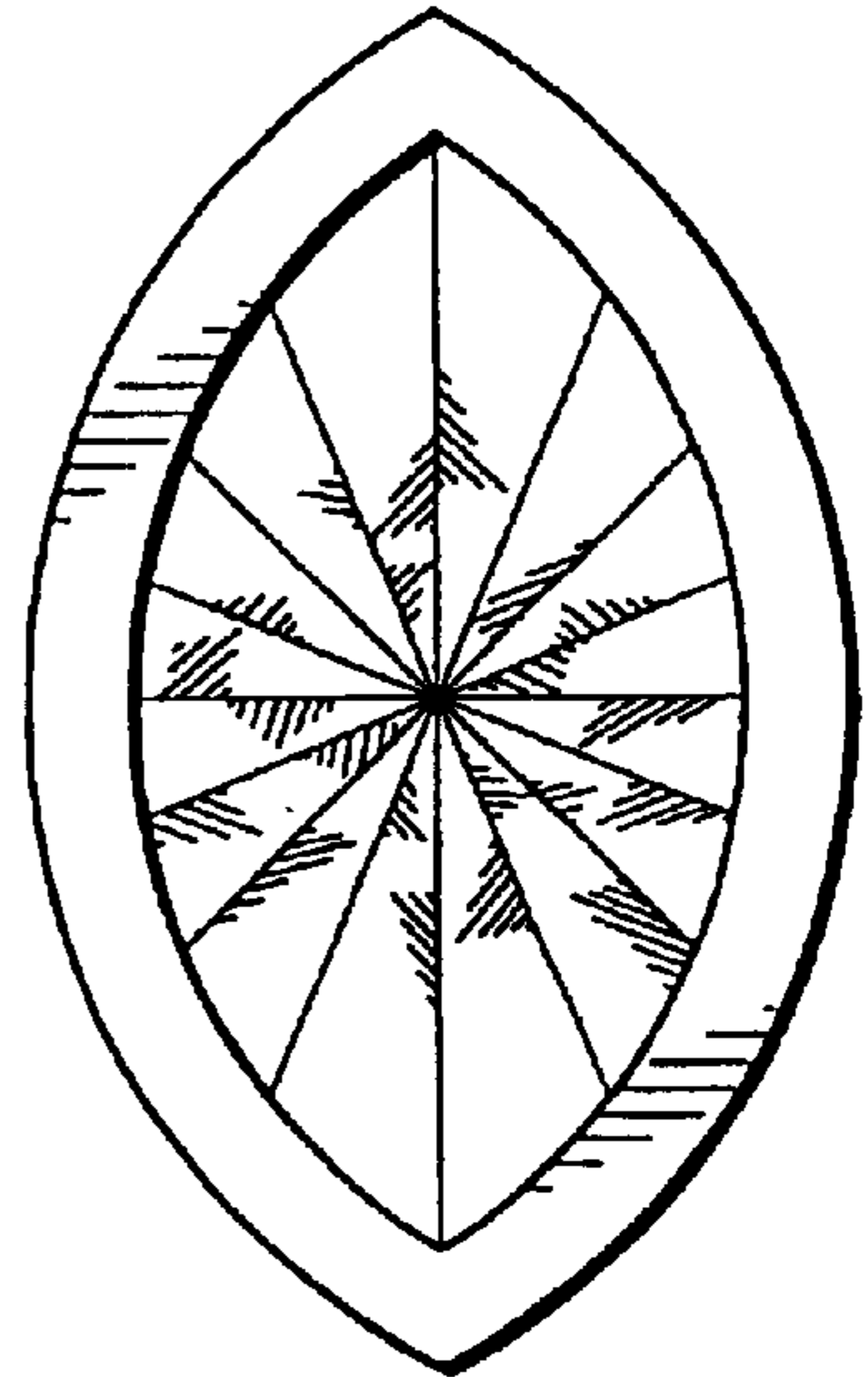

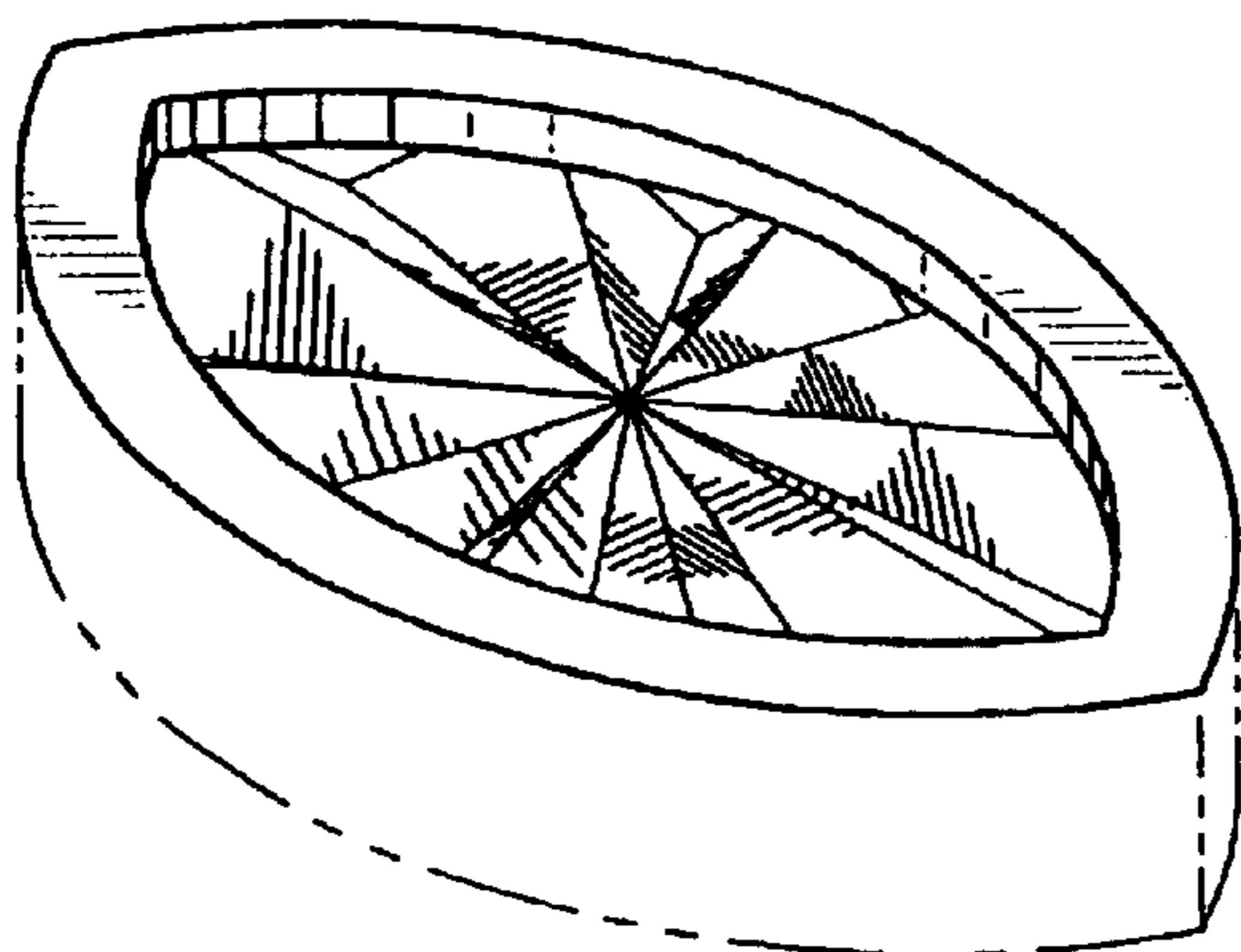

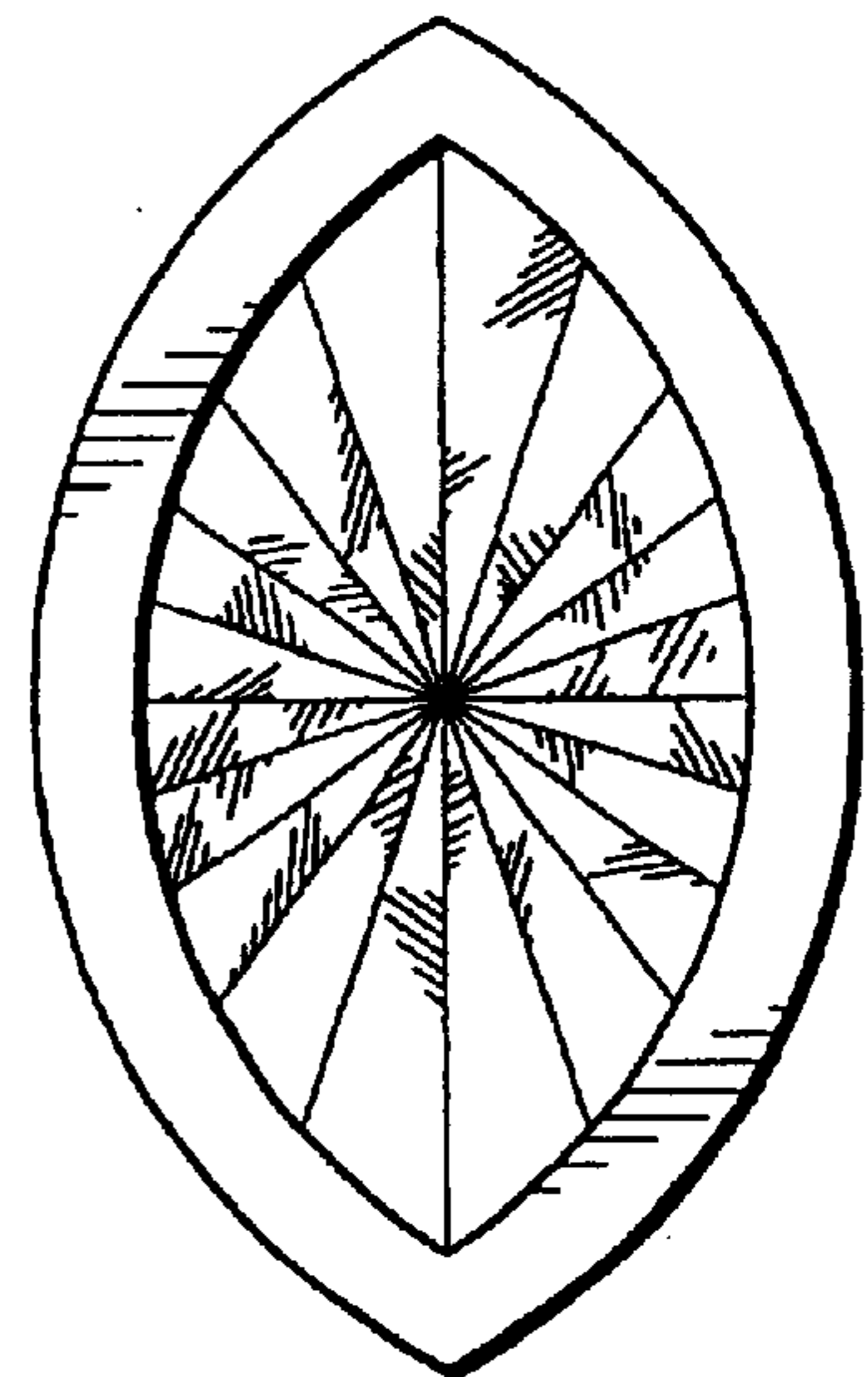
