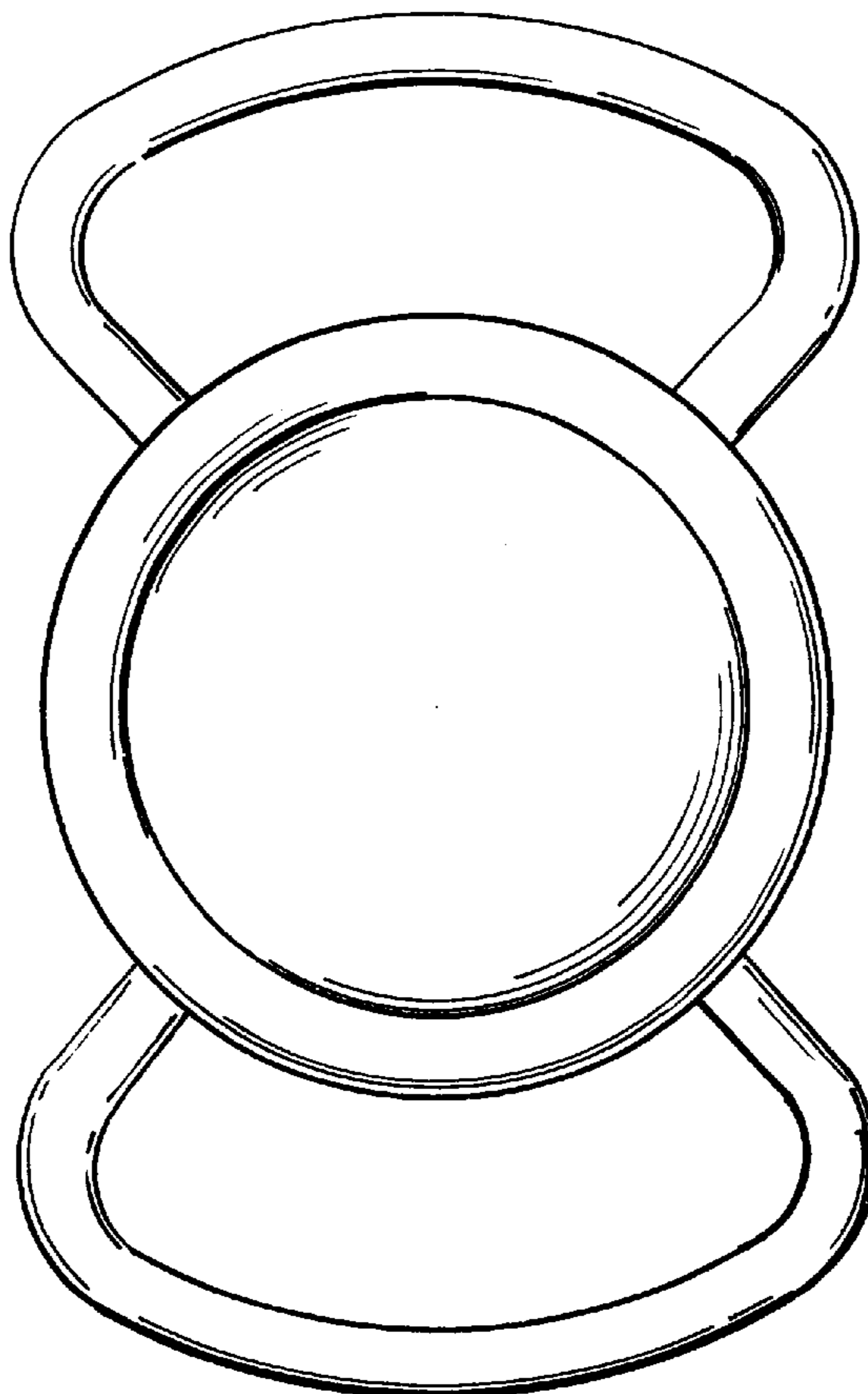
(57) **CLAIM**

The ornamental design for a button-type strap connector, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a button-type strap connector showing my new design;  
FIG. 2 is a rear elevational view thereof;

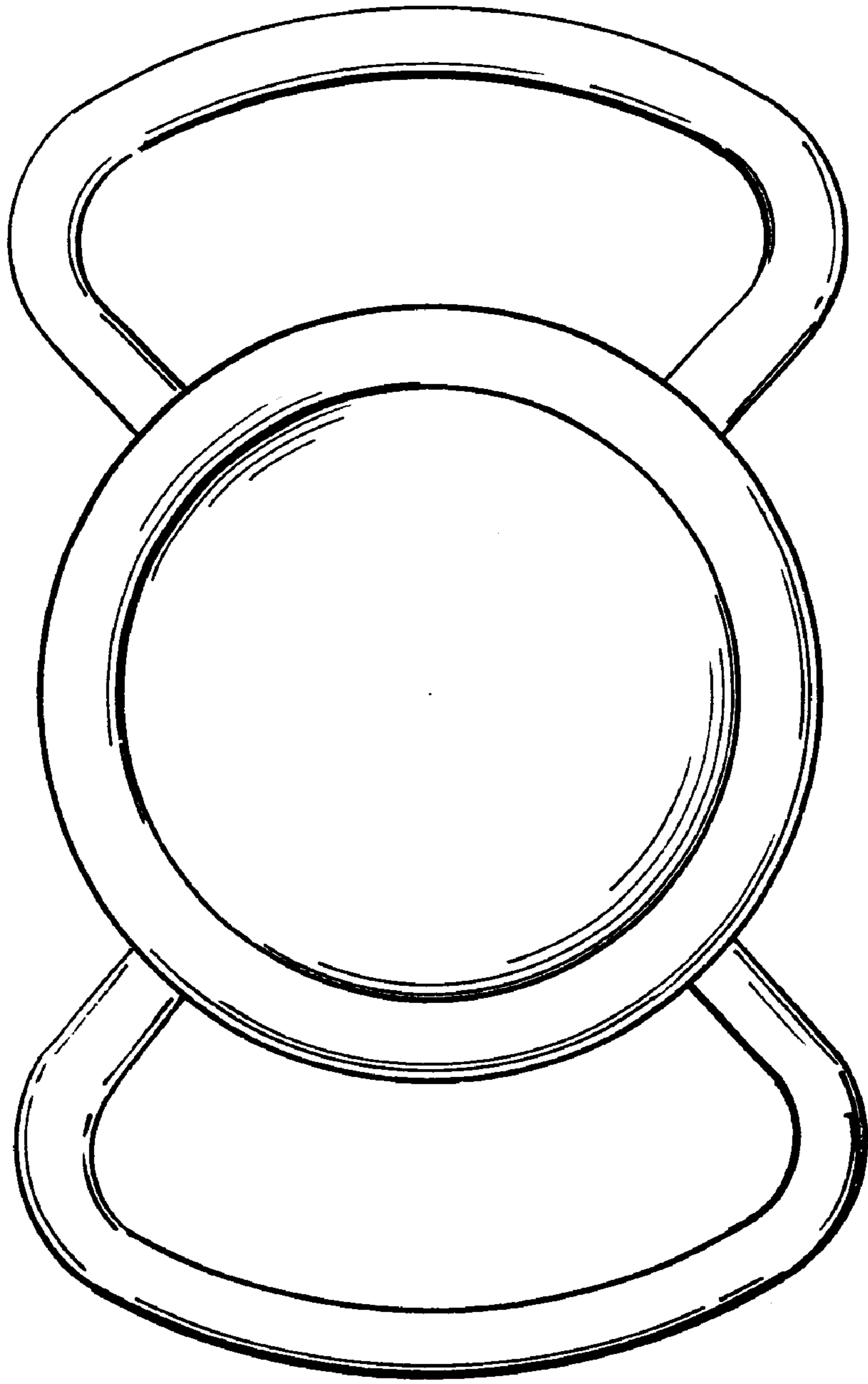

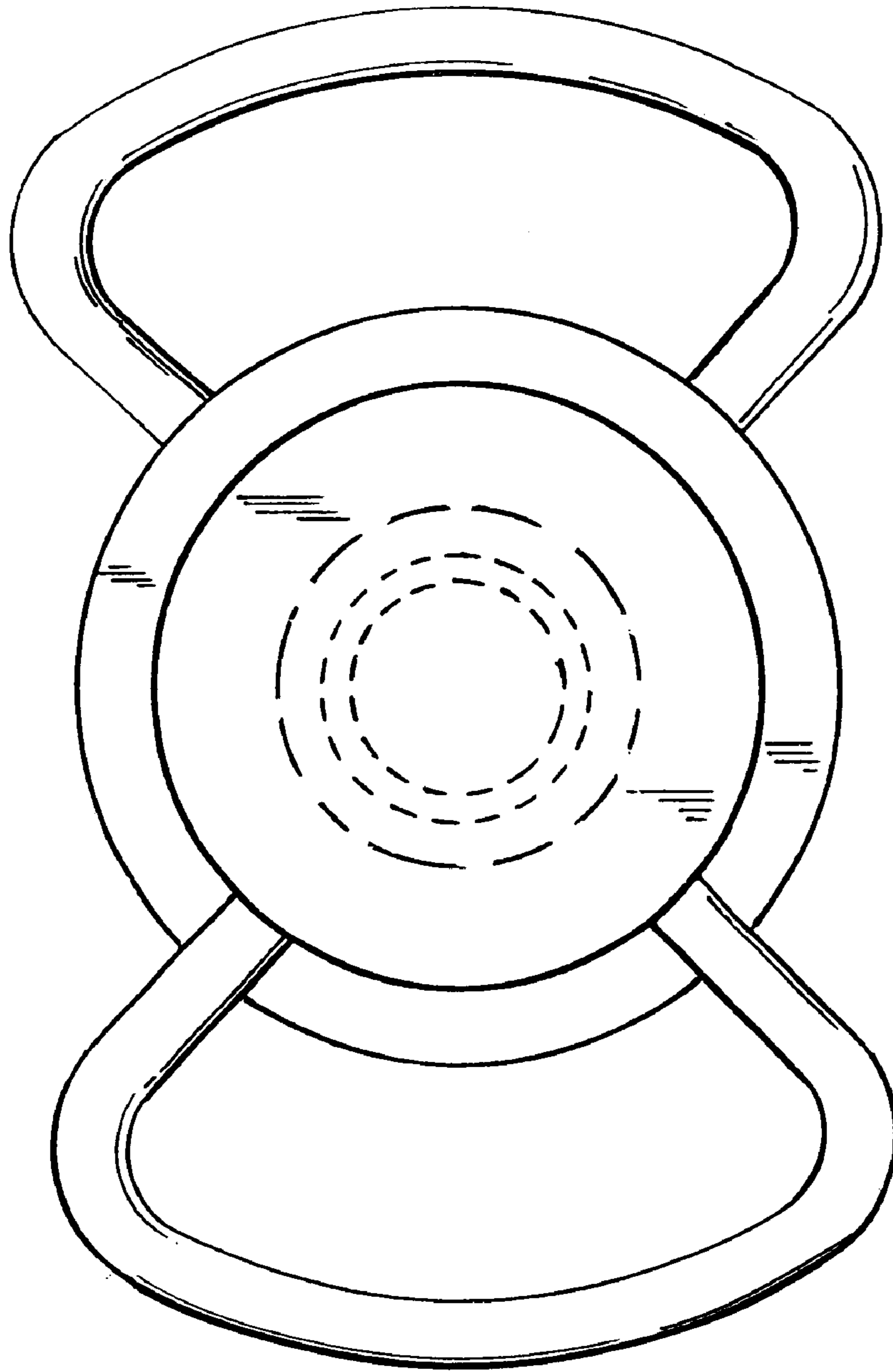

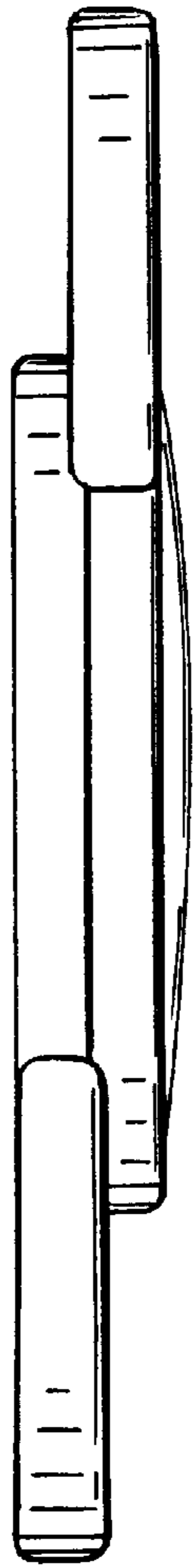

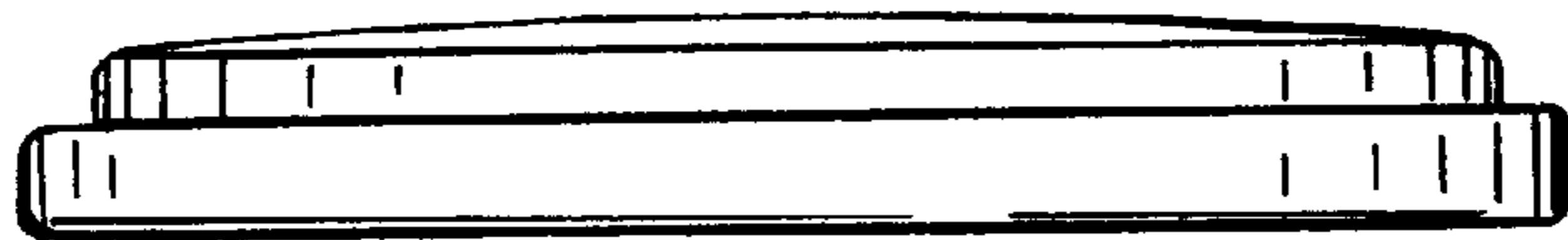

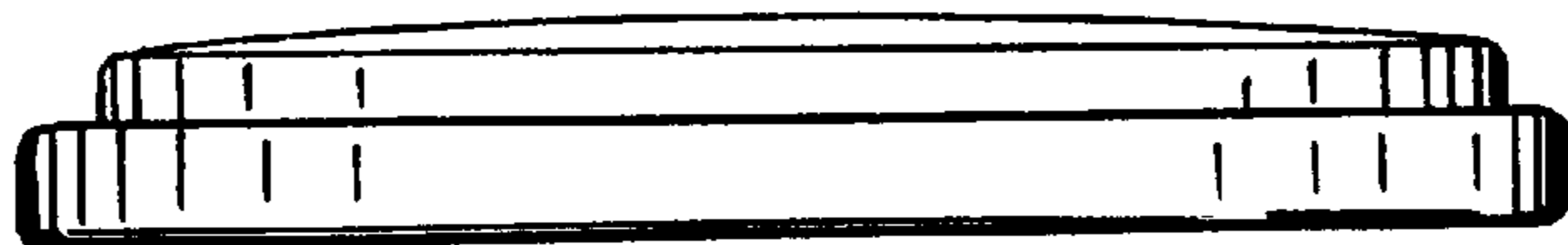
