(57) **CLAIM**

The ornamental design for a male member of snap button for wear, as shown and described.

**DESCRIPTION**

FIG. 1 is a right perspective view of a male member of snap button for wear of the claimed design.

FIG. 2 is a left perspective view of the male member of snap button for wear of FIG. 1.

FIG. 3 is a right-side elevational view of the male member of snap button for wear of FIG. 1.

FIG. 4 is a left-side elevational view of the male member of snap button for wear of FIG. 1.

FIG. 5 is a front elevational view of the male member of snap button for wear of FIG. 1, and the rear elevational view is symmetrical thereto.

FIG. 6 is a top plan view of the male member of snap button for wear of FIG. 1, and the bottom plan view is identical thereto.

FIG. 7 is a cross sectional view of the male member of snap button for wear of FIG. 1 taken along the line 7—7 of FIG. 3; and,

FIG. 8 is a reference view of the male member of snap button for wear of FIG. 1 in the state of being used with a female member of snap button for wear, the female member of snap button for wear forming no part of the claimed design.

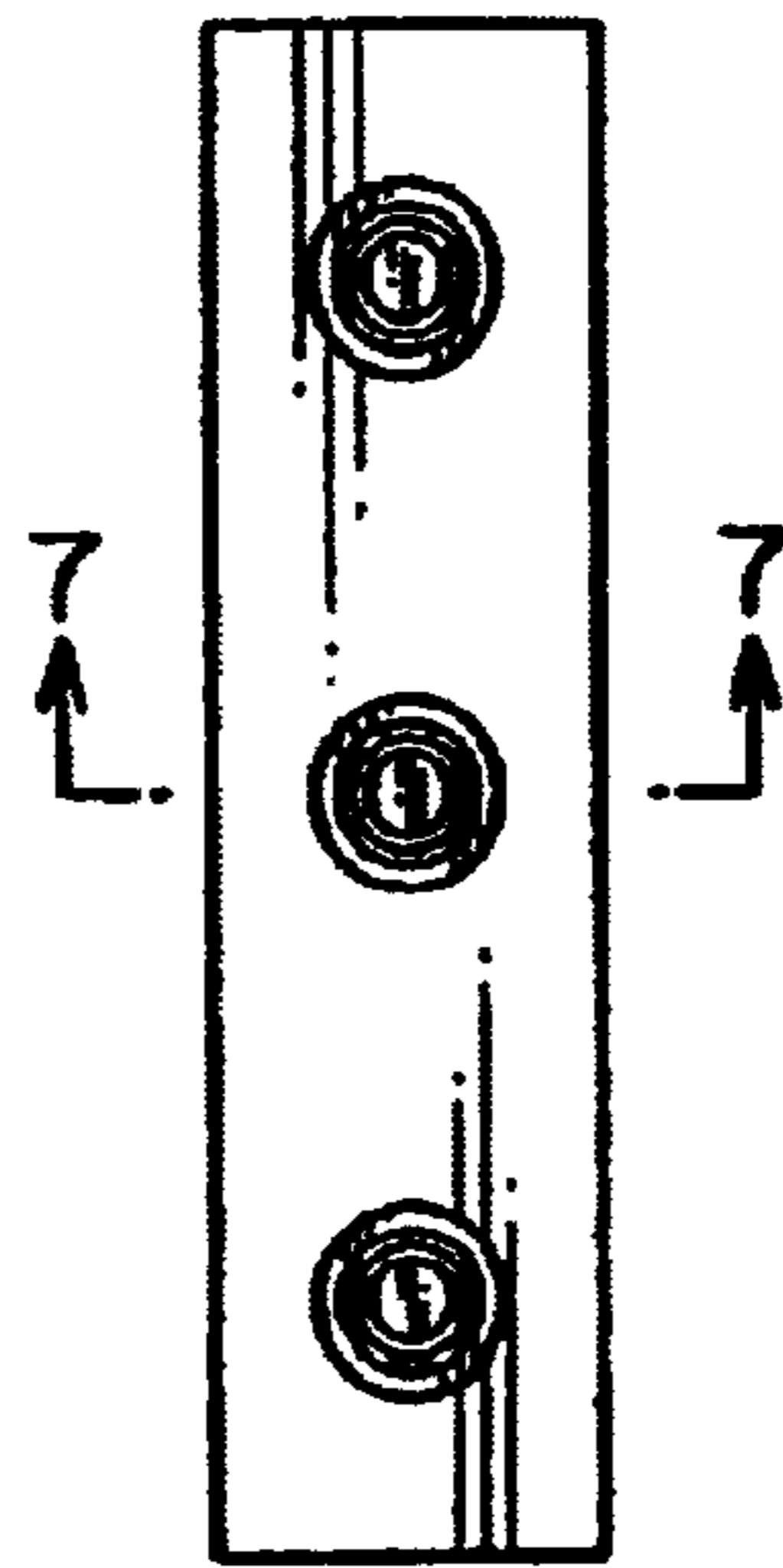

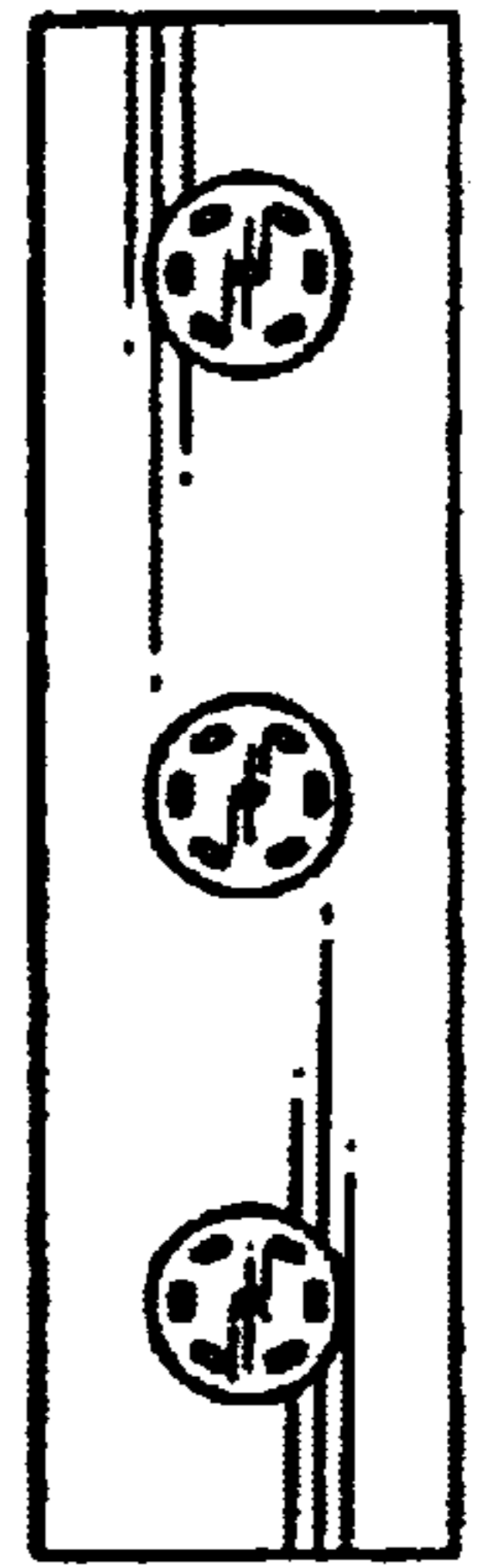
