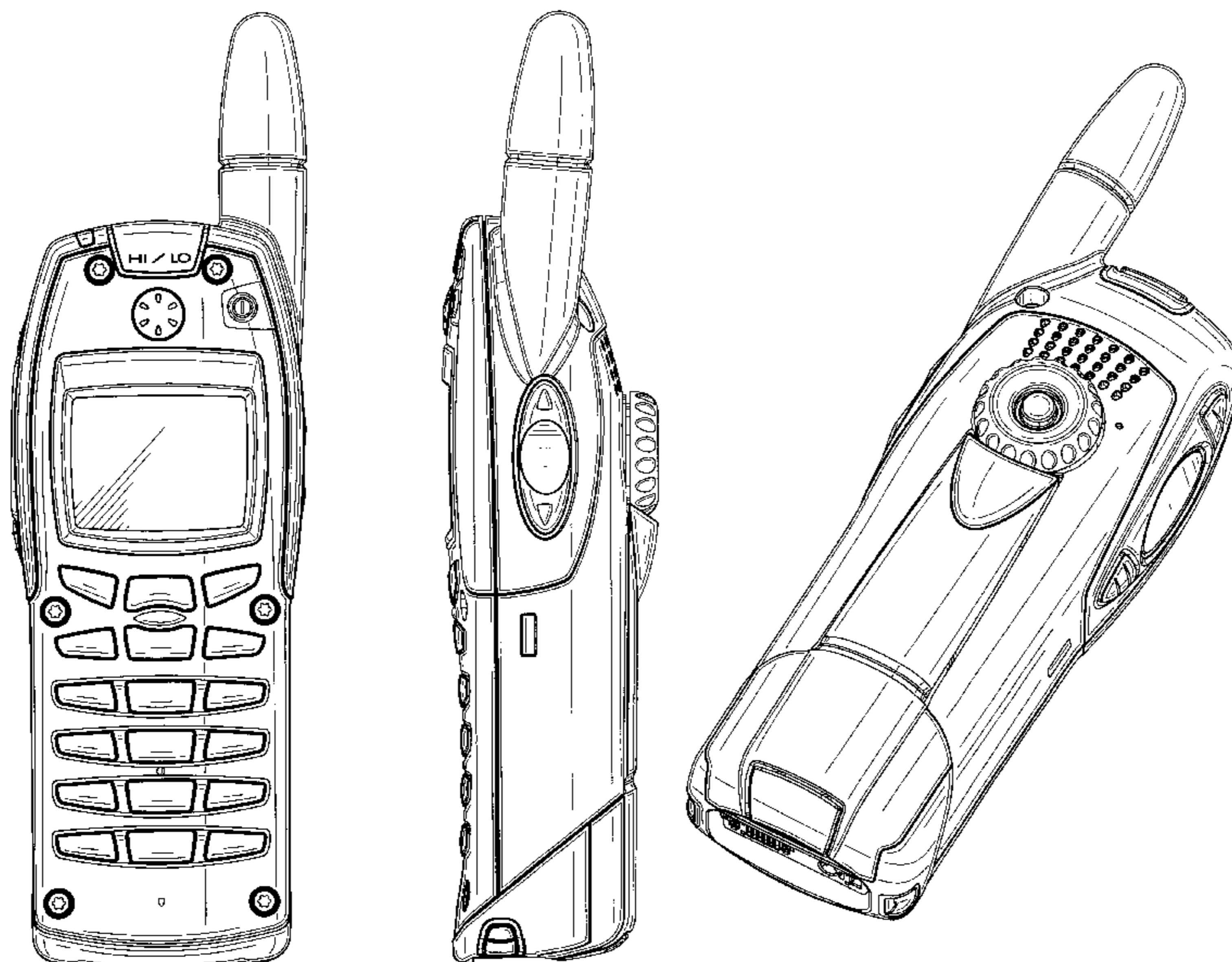
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a handset showing our new design; FIG. 2 is a perspective front view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a rear view thereof; and, FIG. 8 is a perspective rear view thereof.

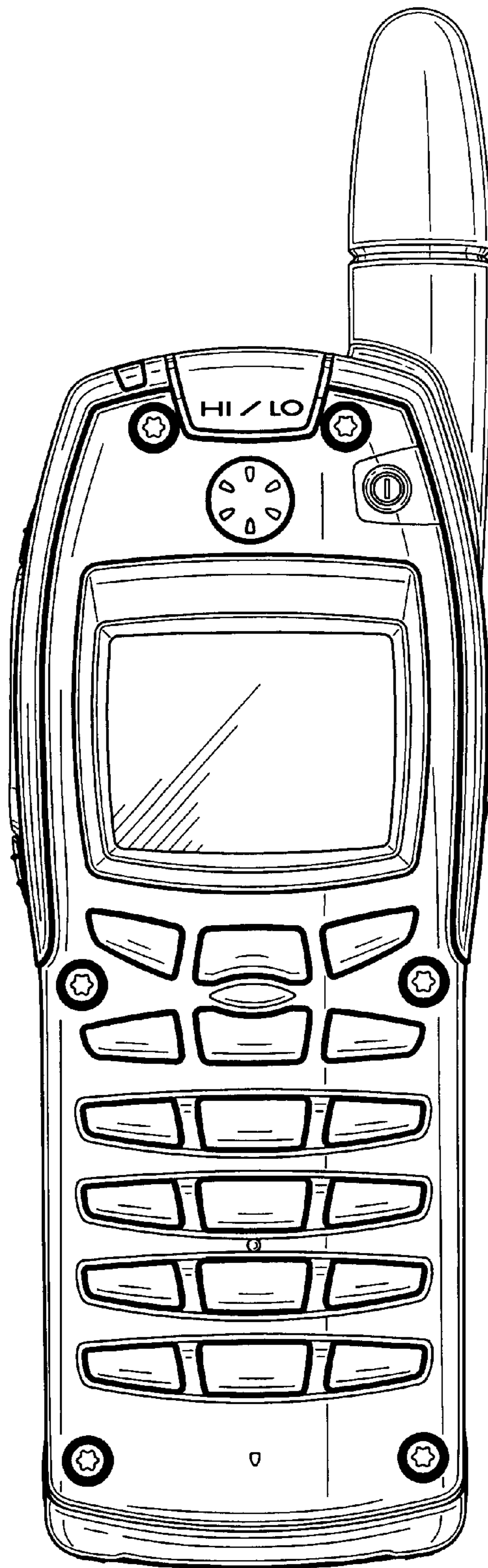

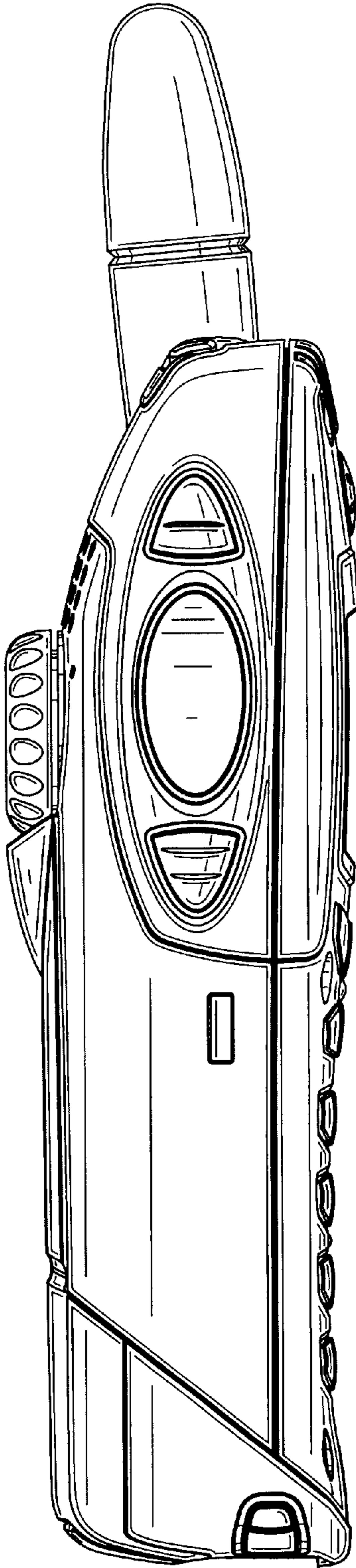

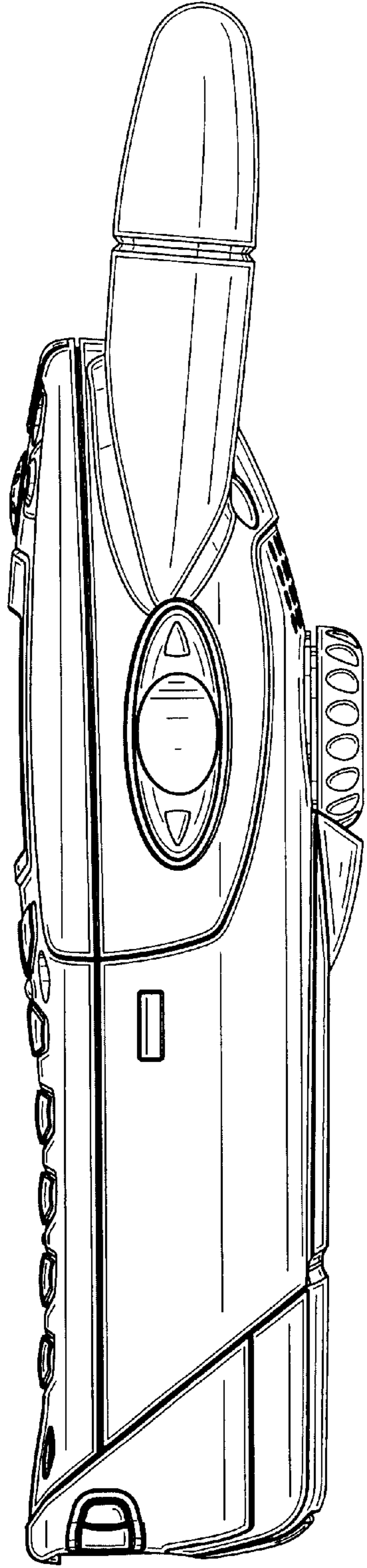

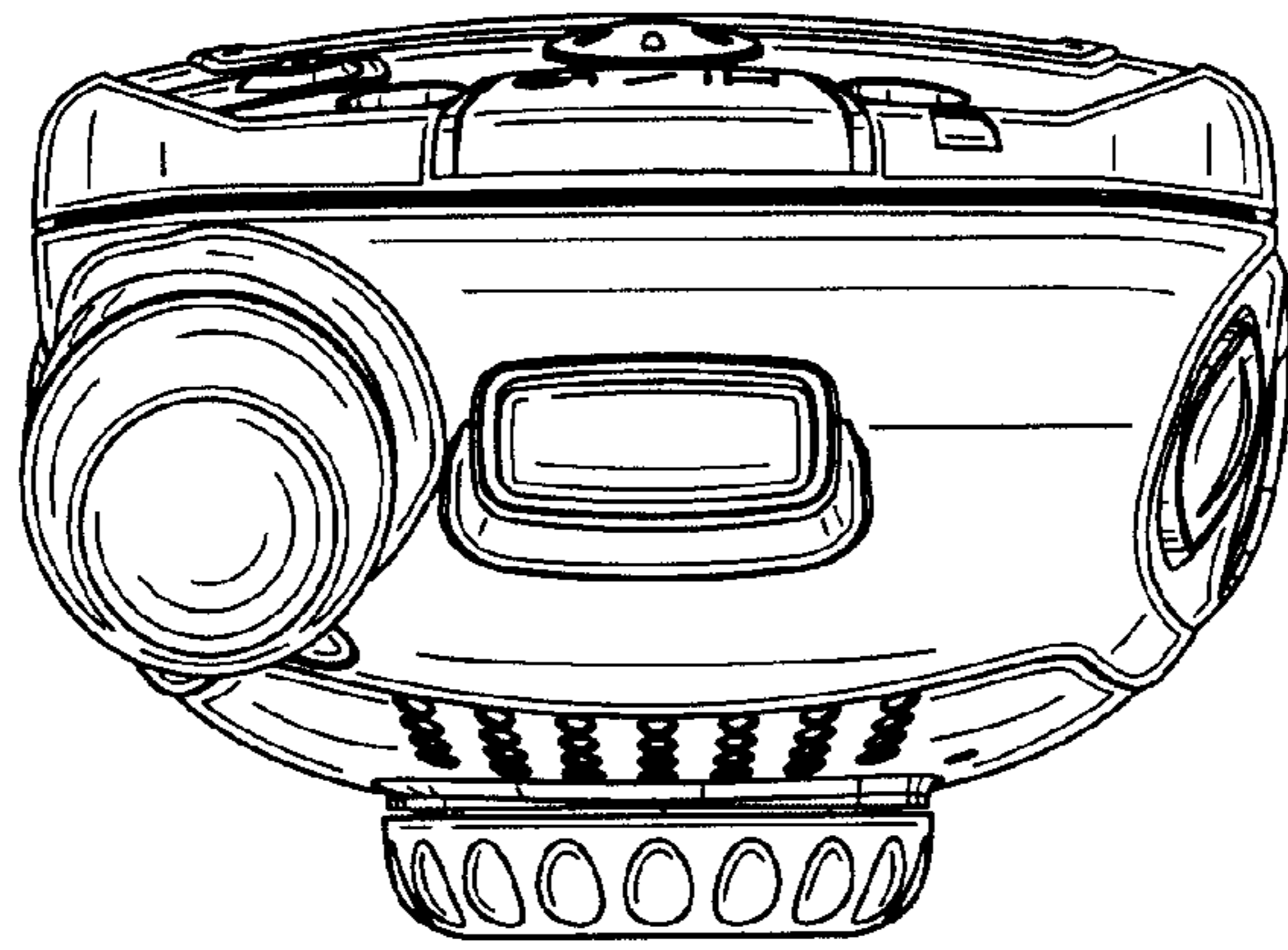

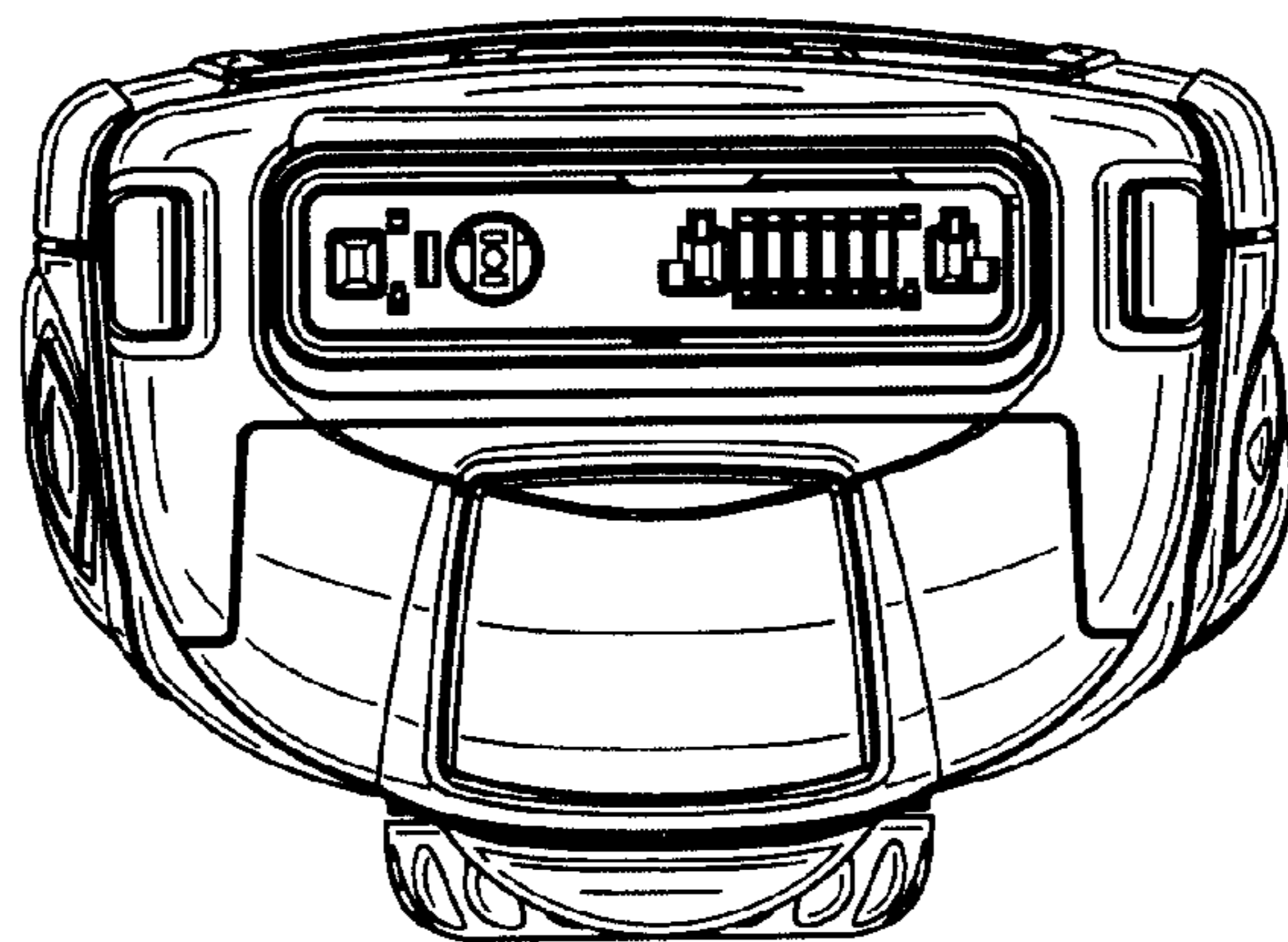

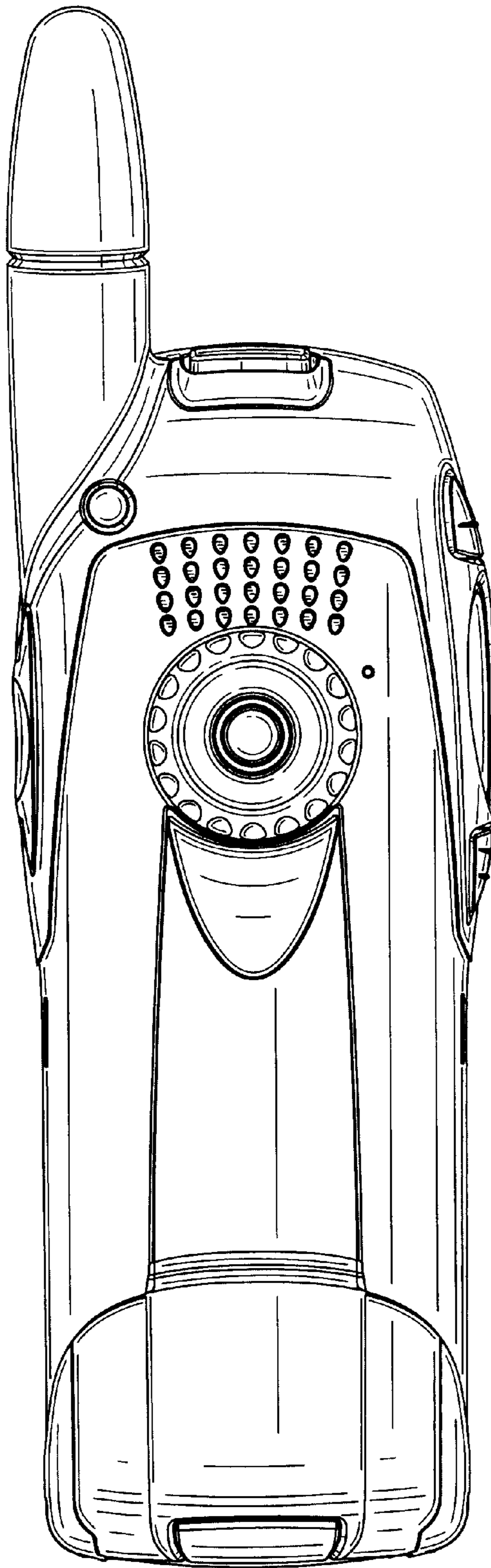

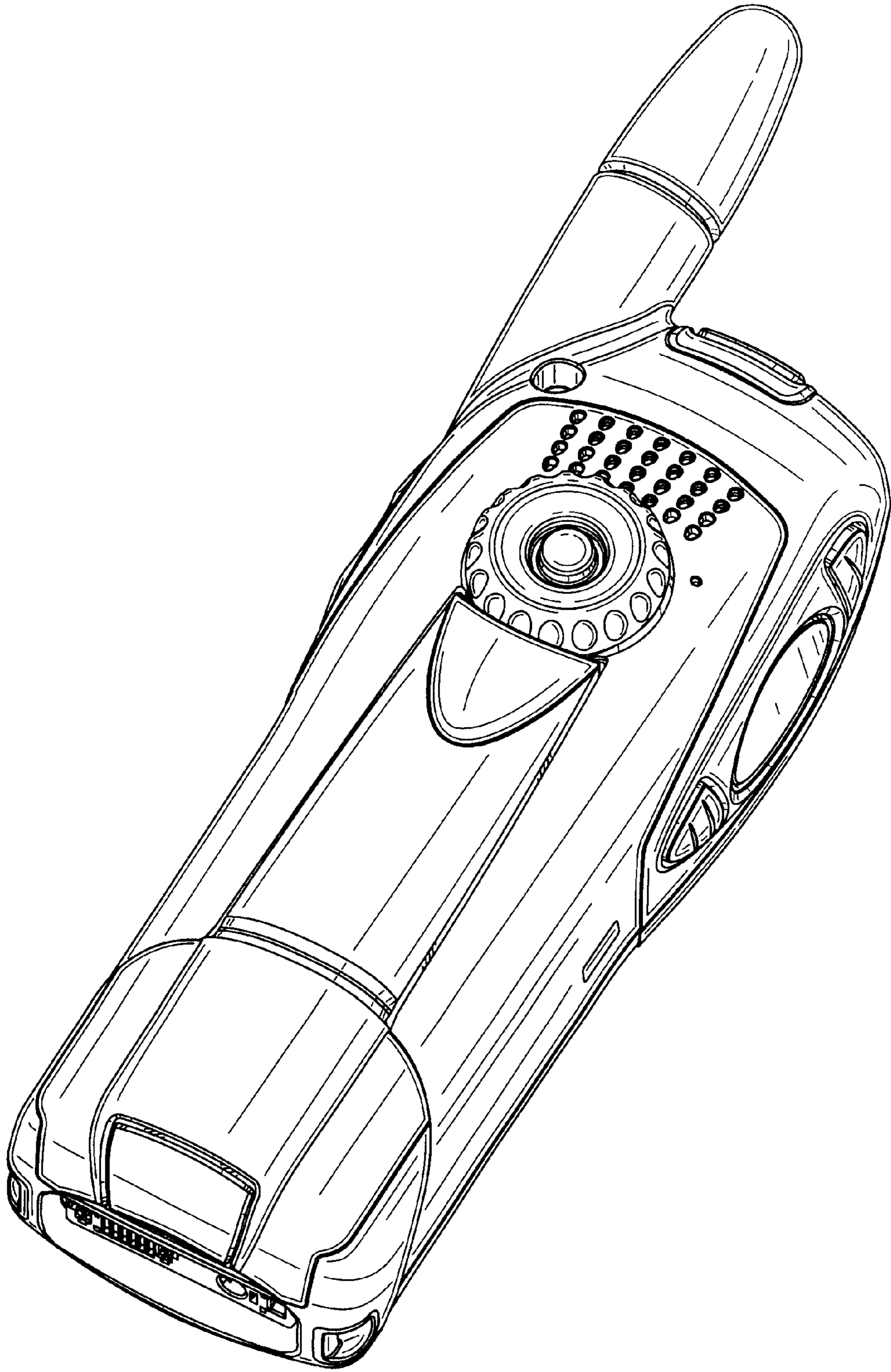
