(57) **CLAIM**

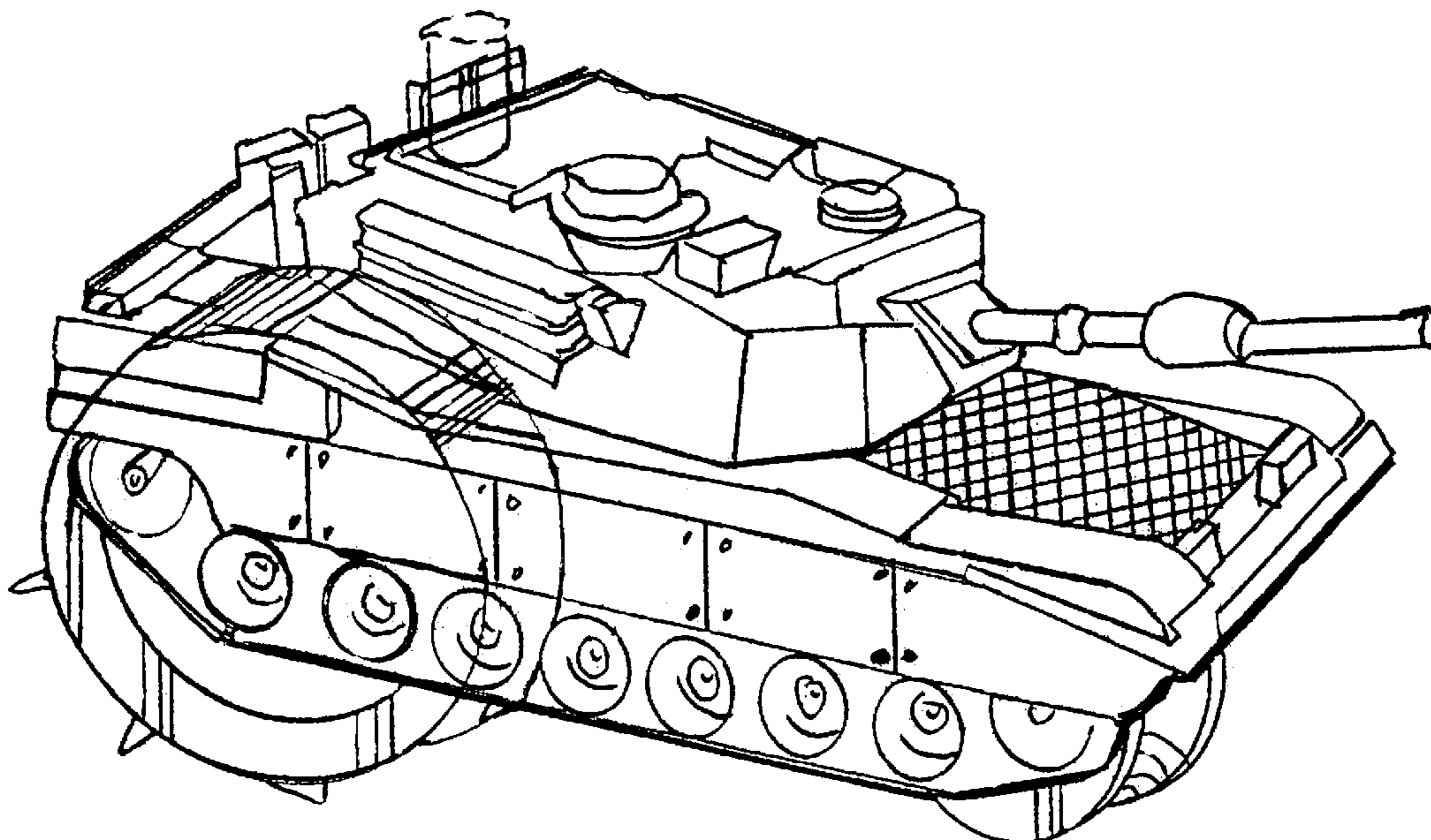
I claim the ornamental design for tank sprinkler, as shown.

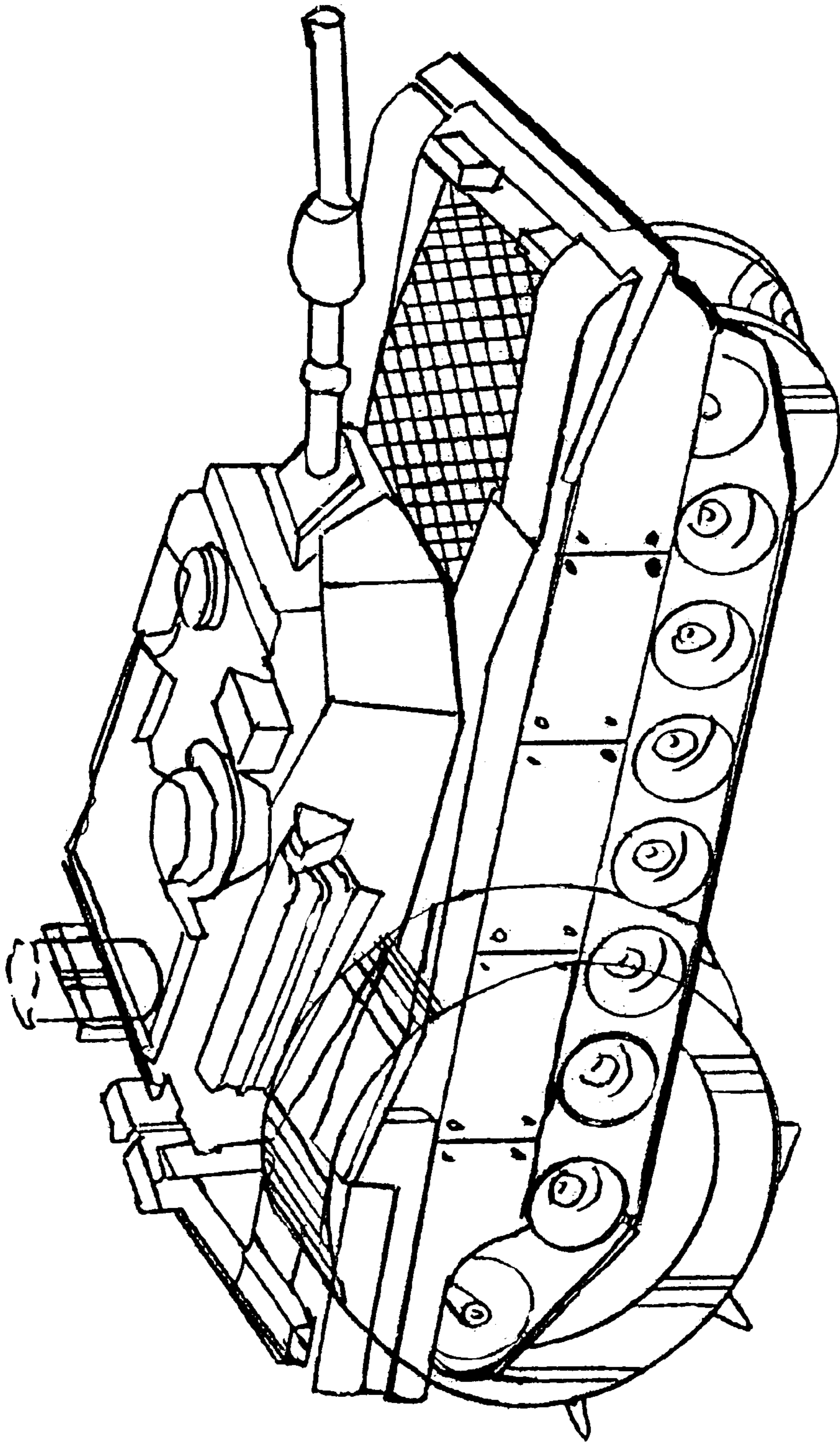
