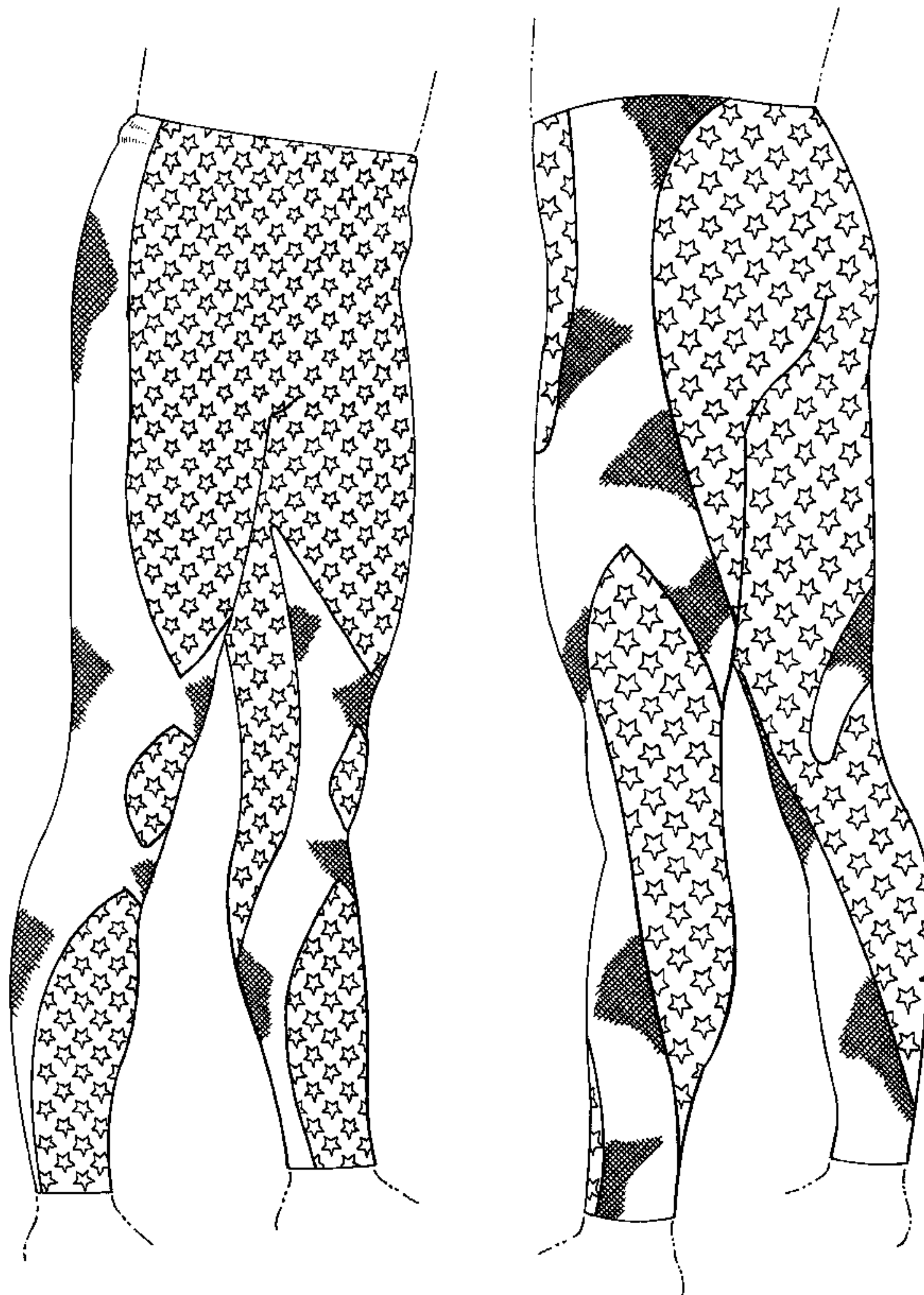

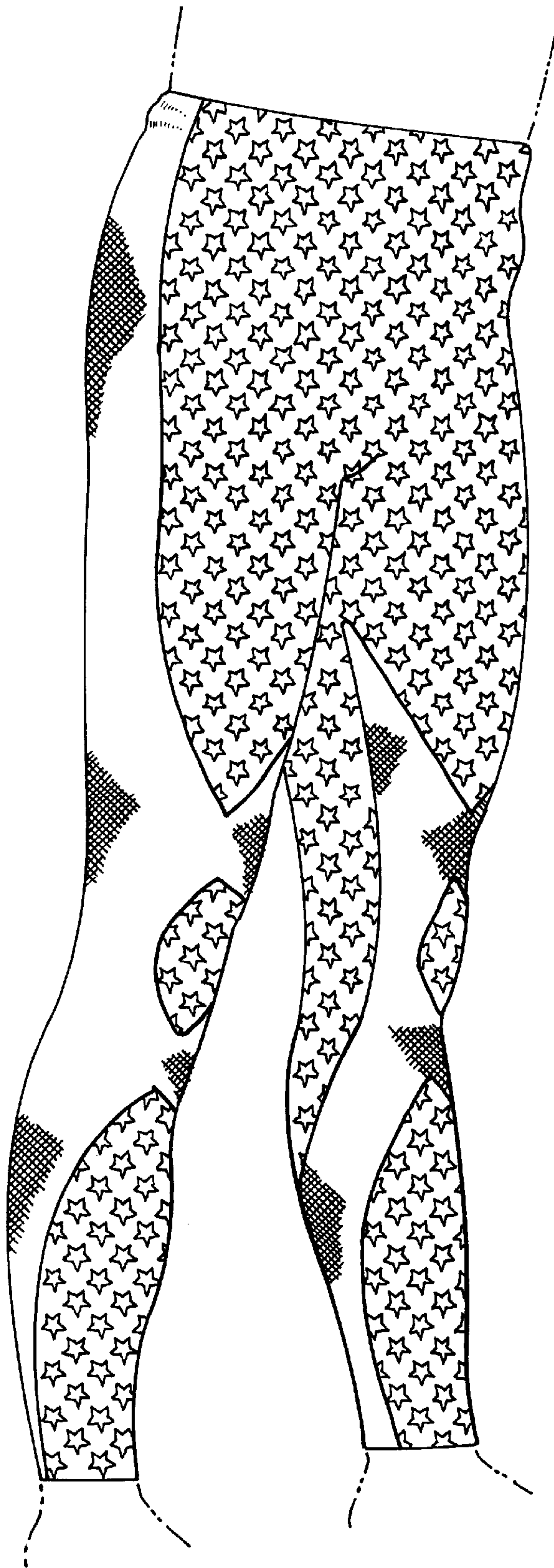

The broken line showing of the human figure is for illustrative purposes only and forms no part of the claimed design.

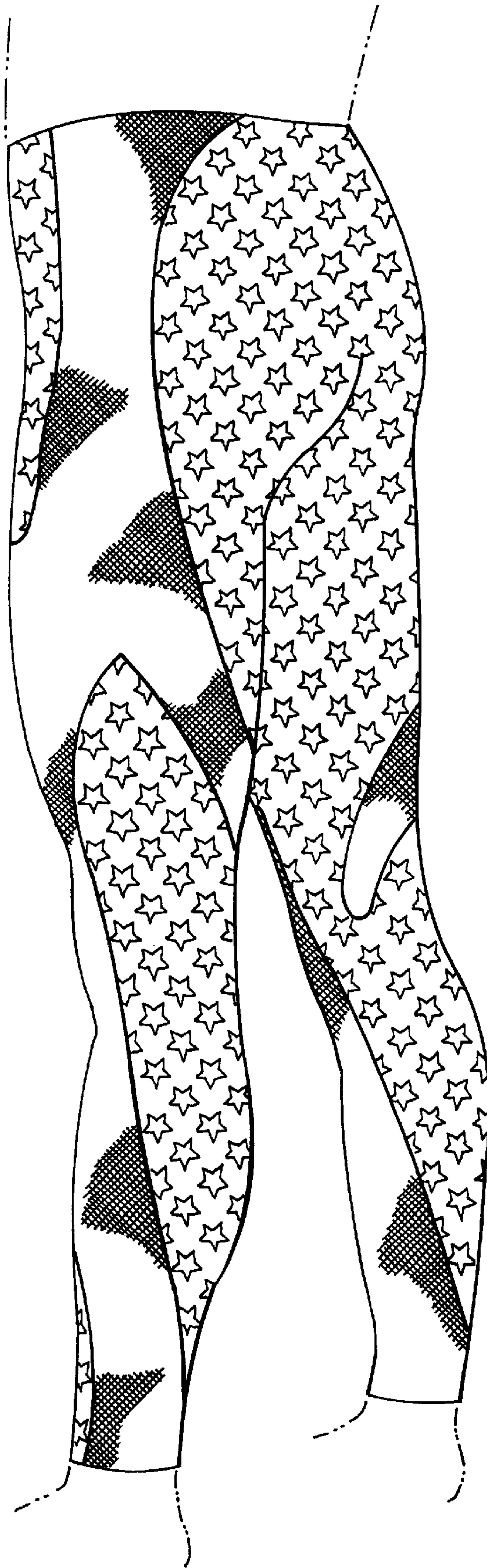
