FIG. 6 shows a bottom view thereof;

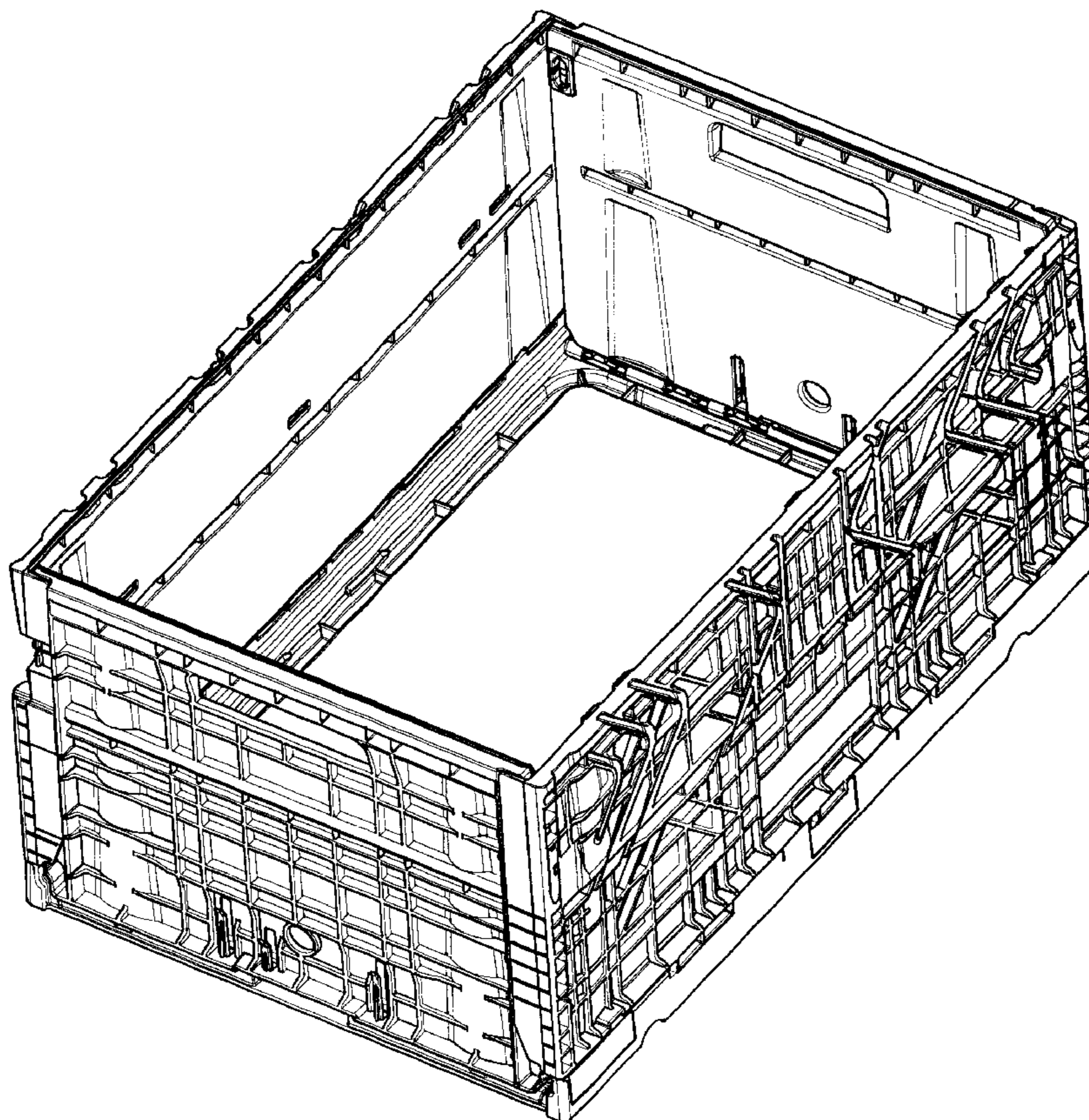
FIG. 7 shows a top perspective view of my design for a carrying container in a folded position according to the invention;

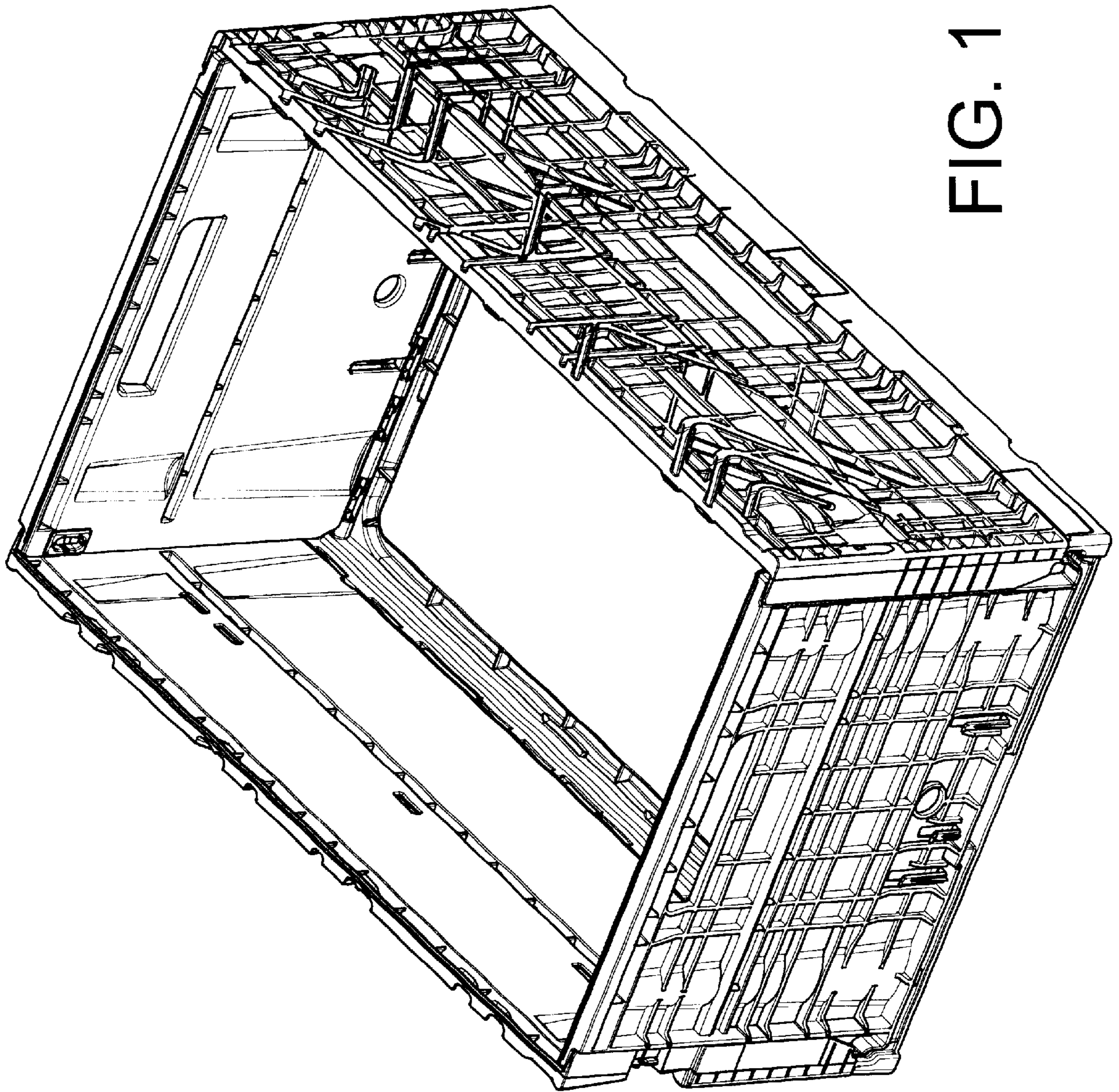

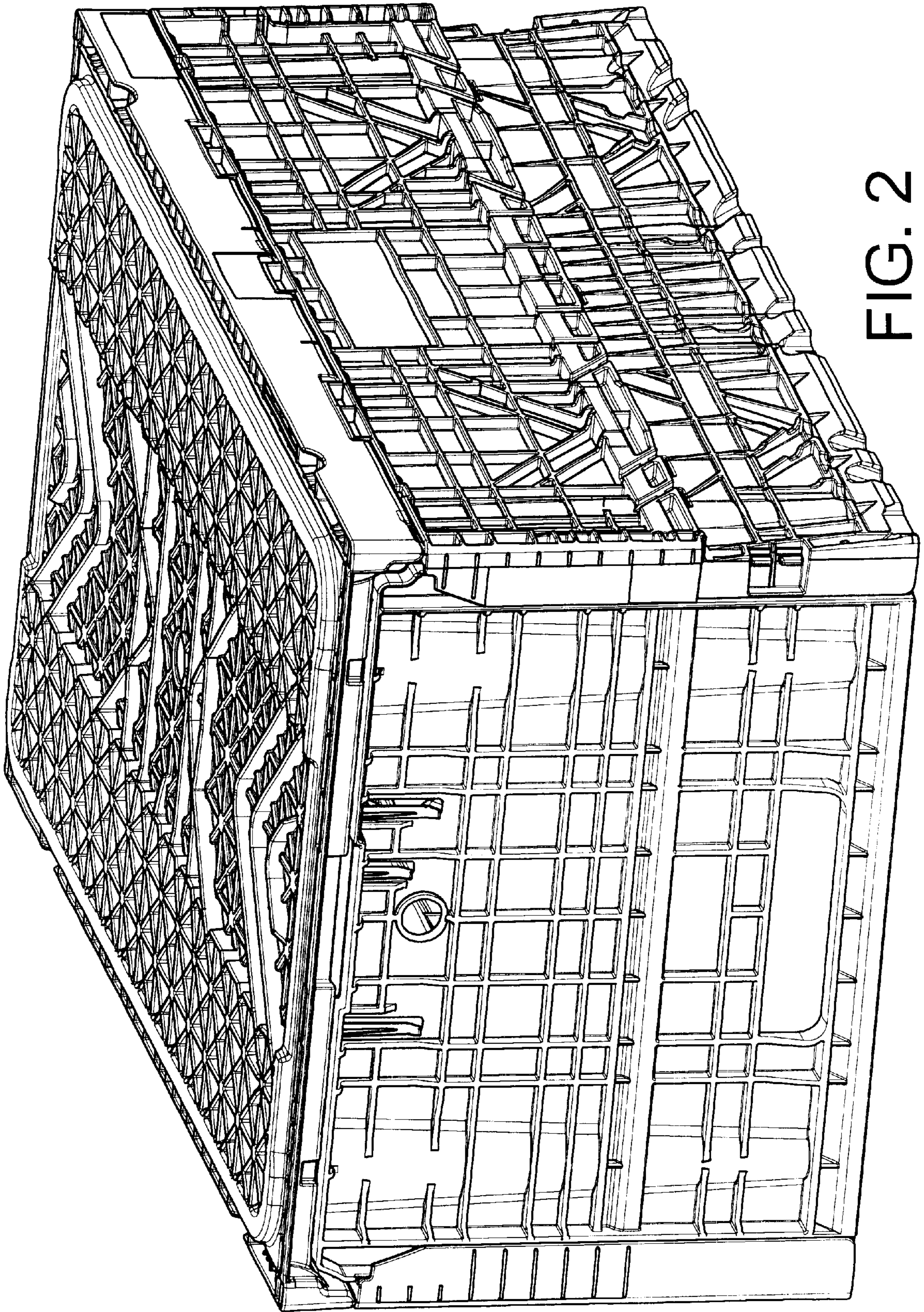

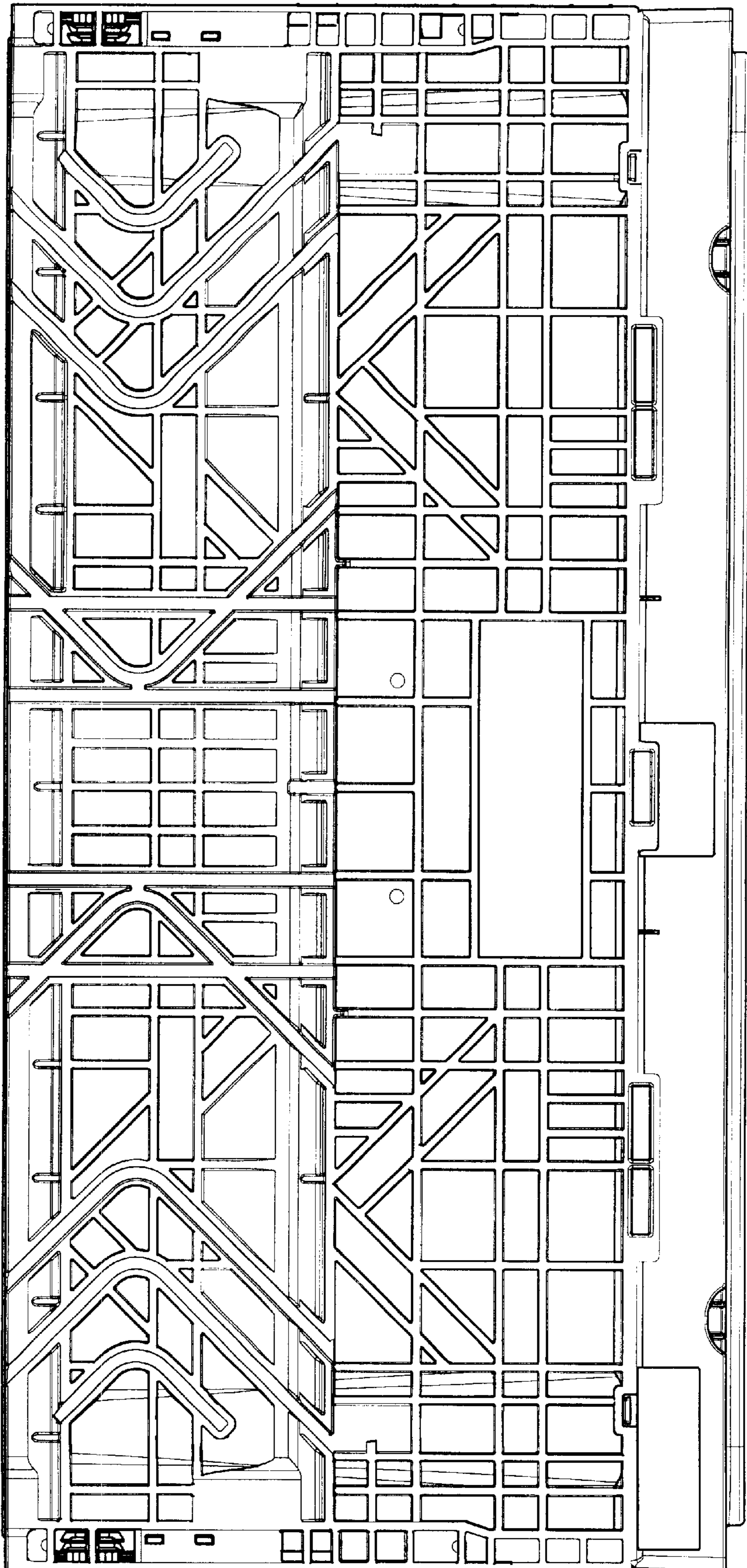

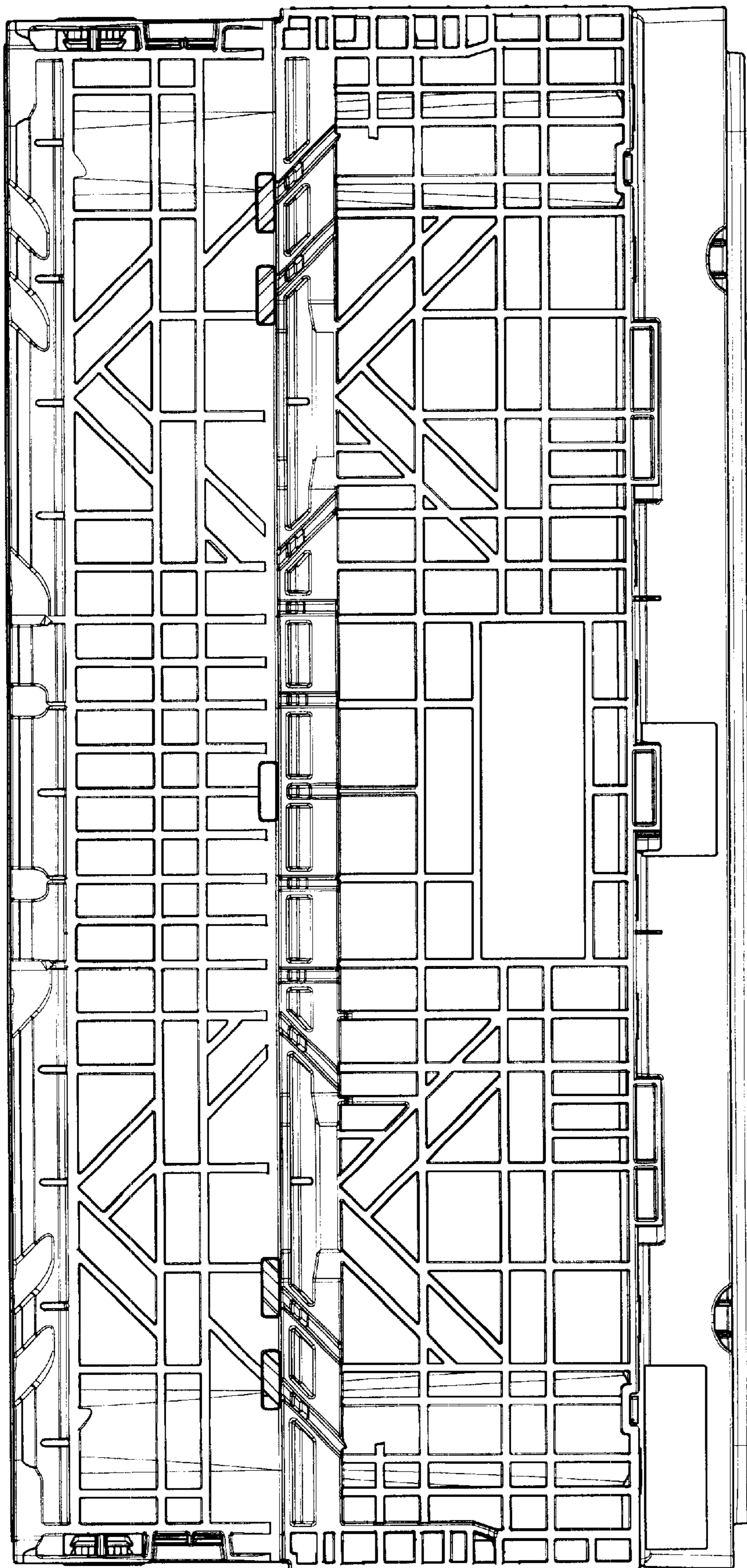

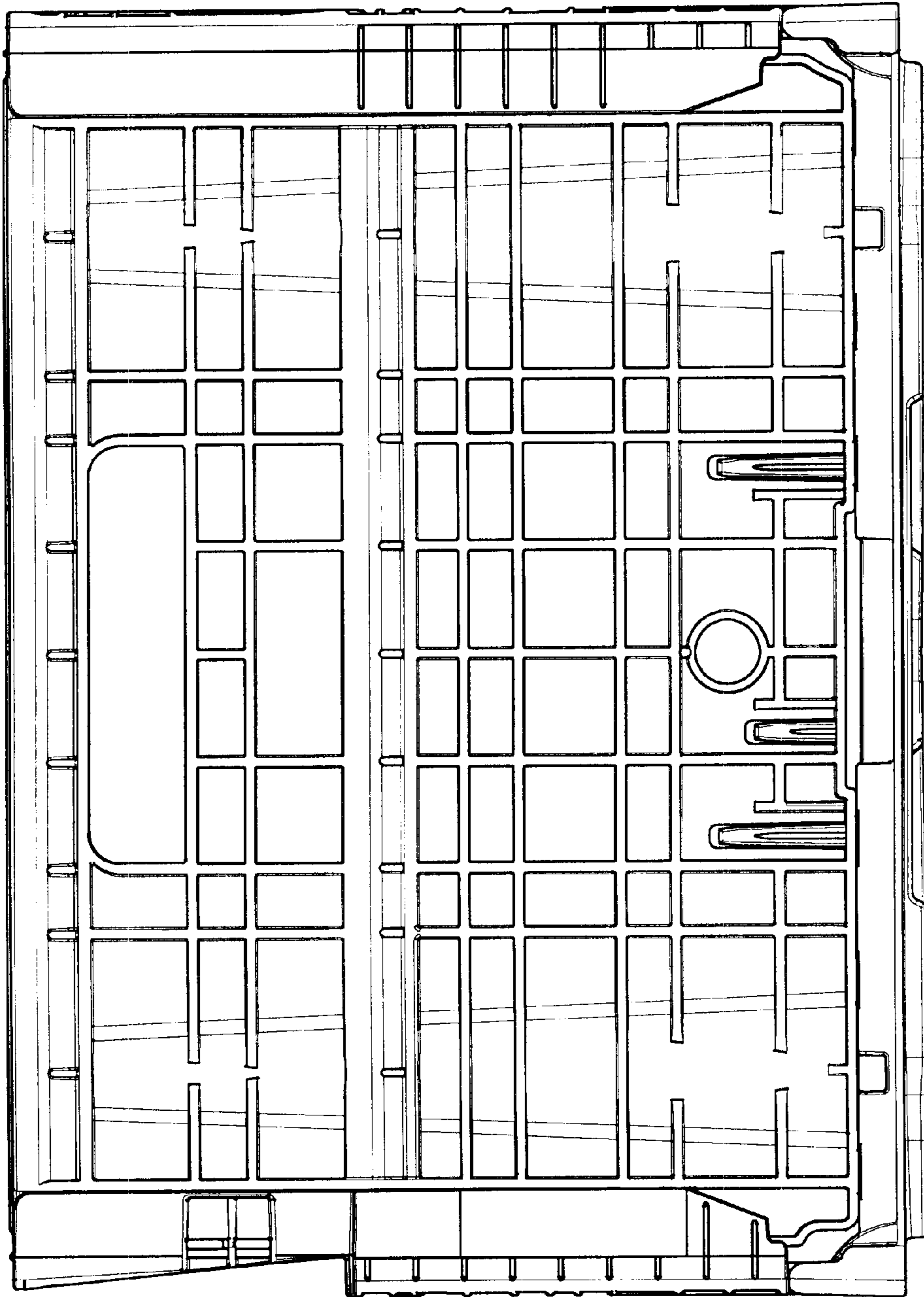

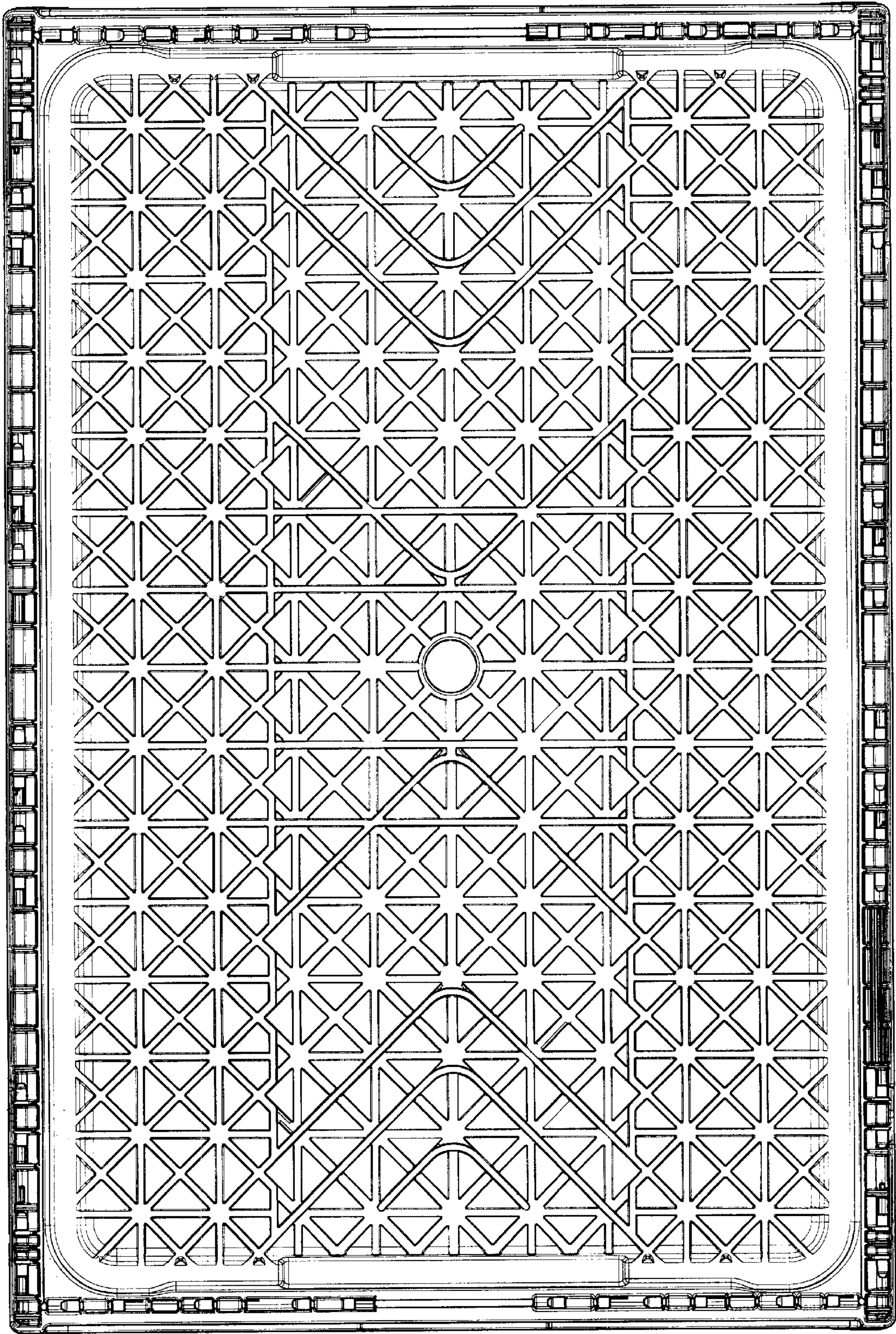

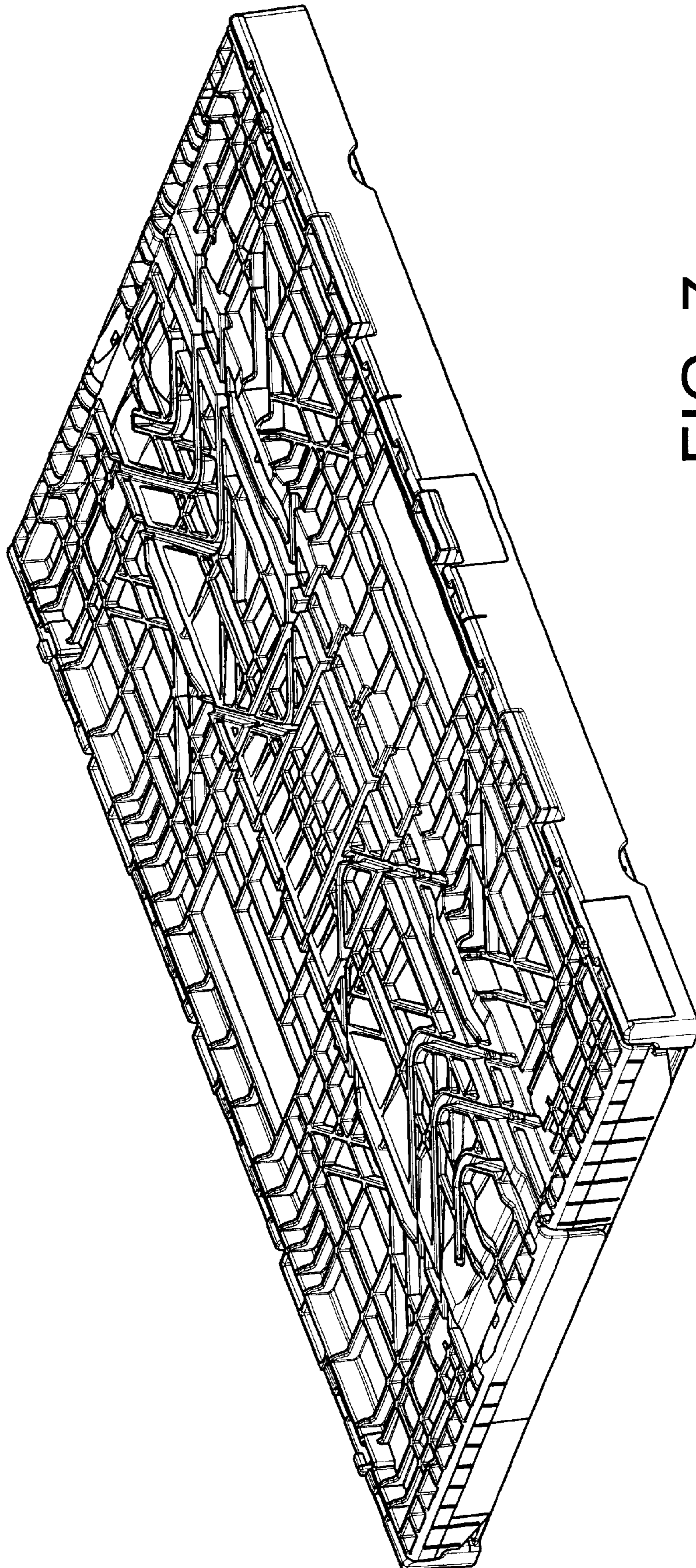

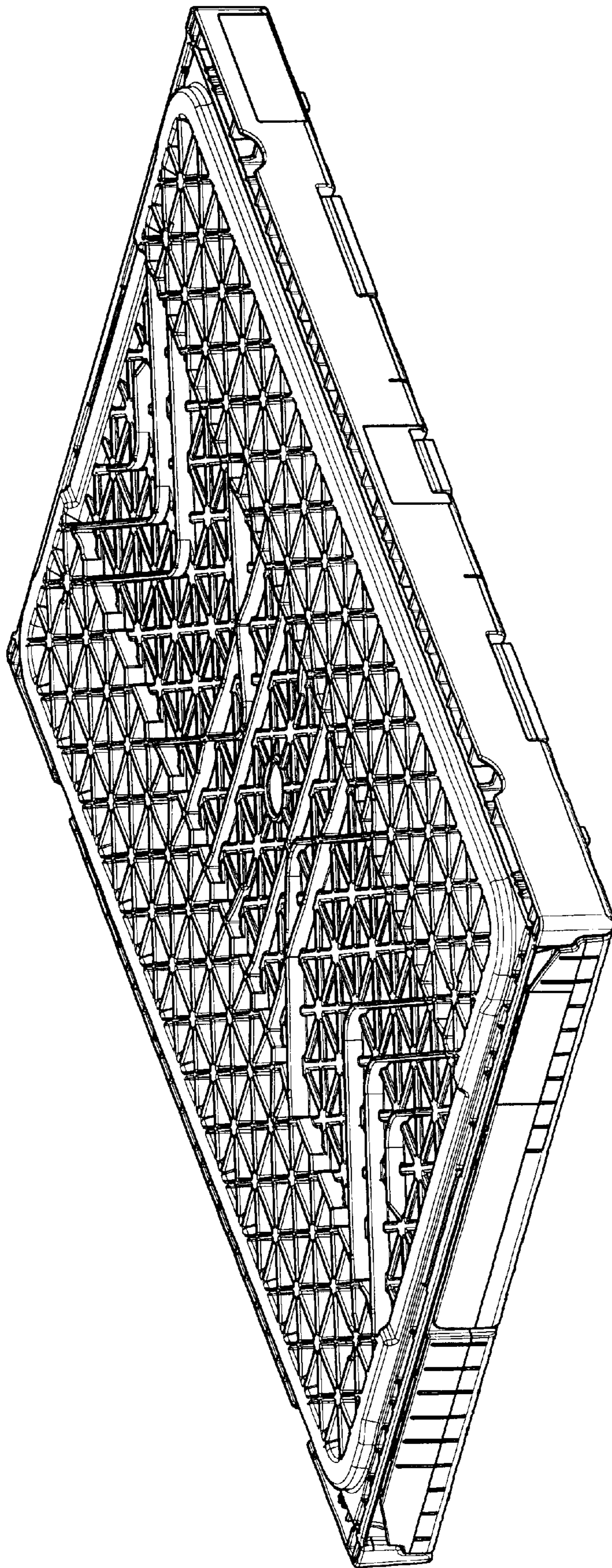

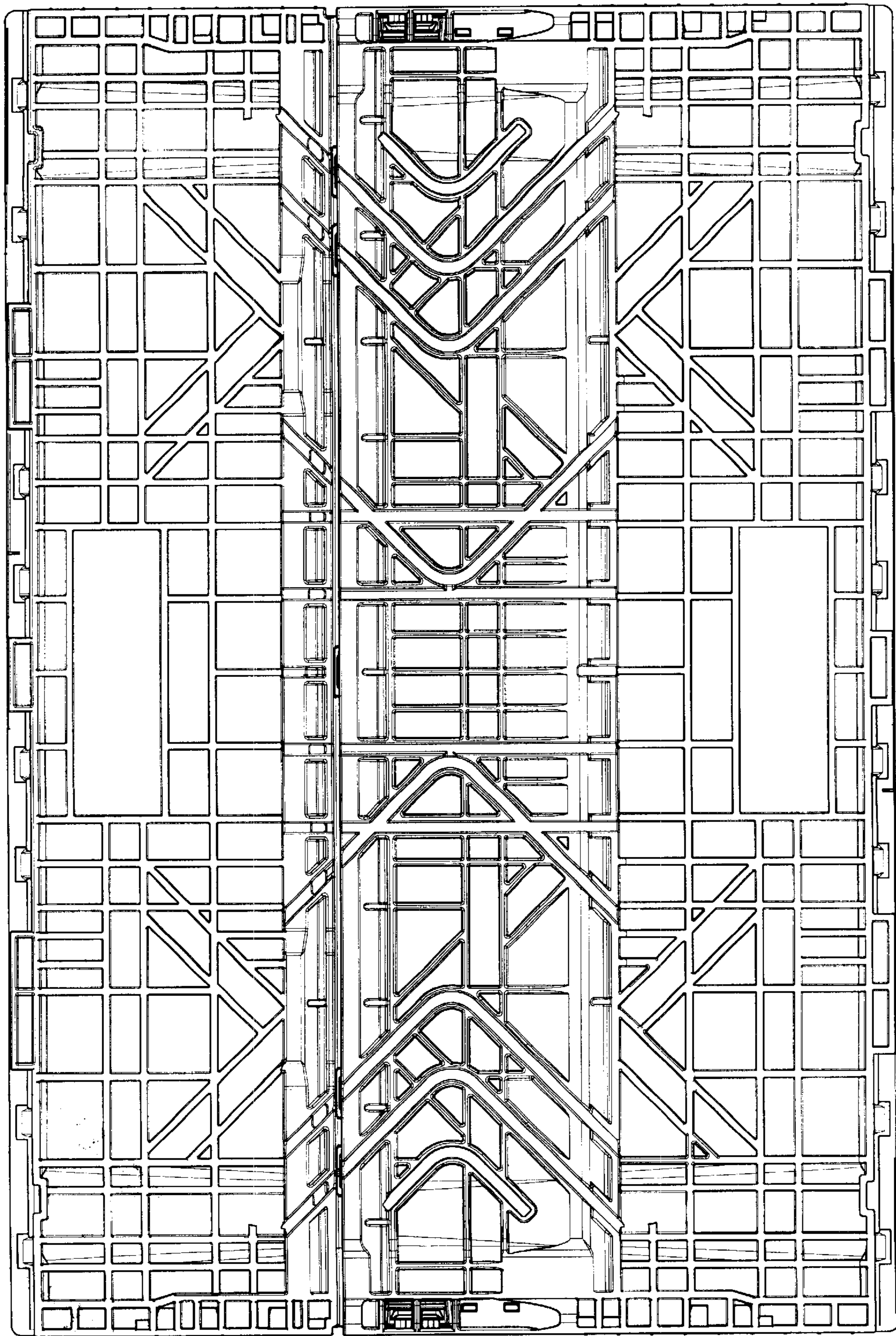

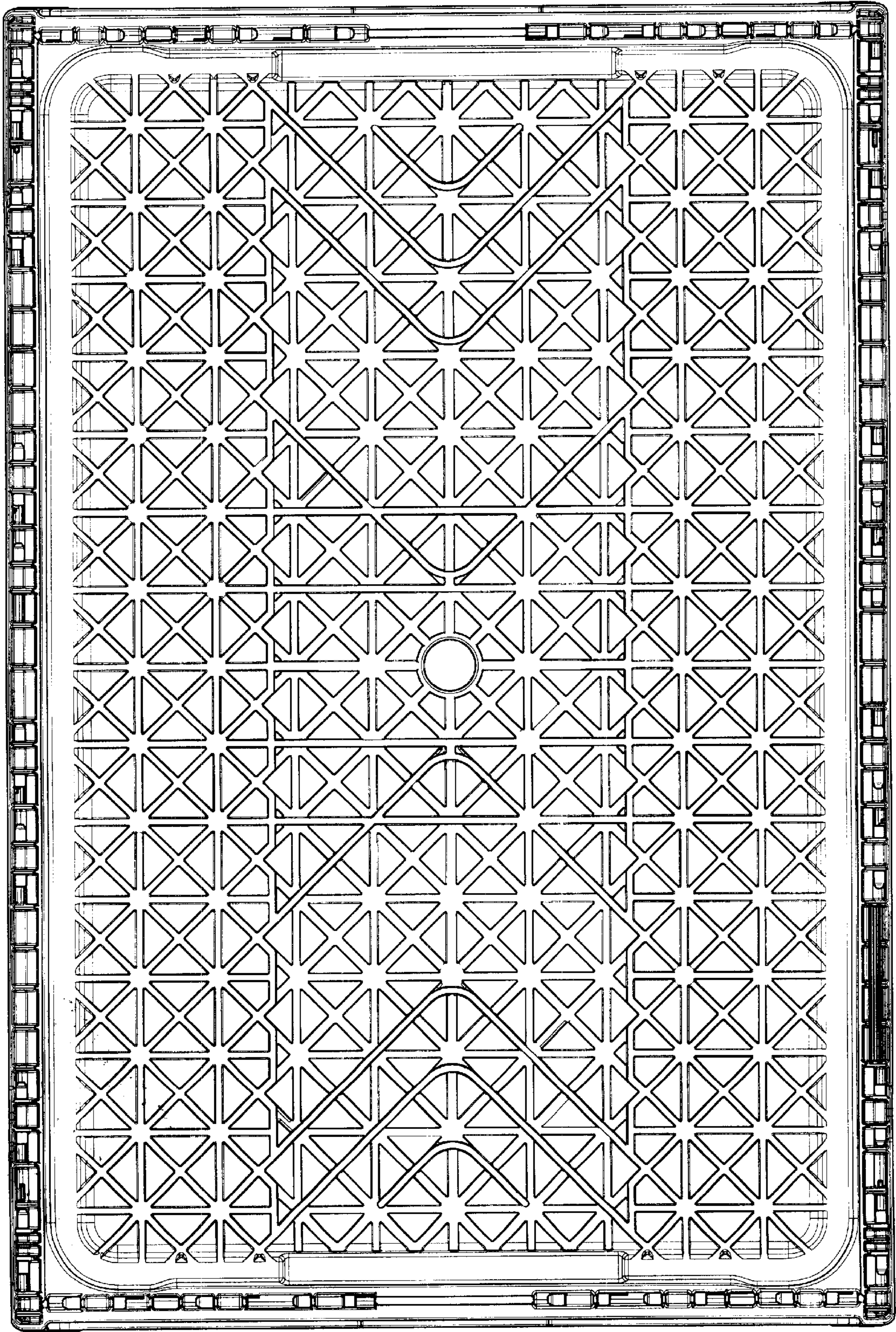
