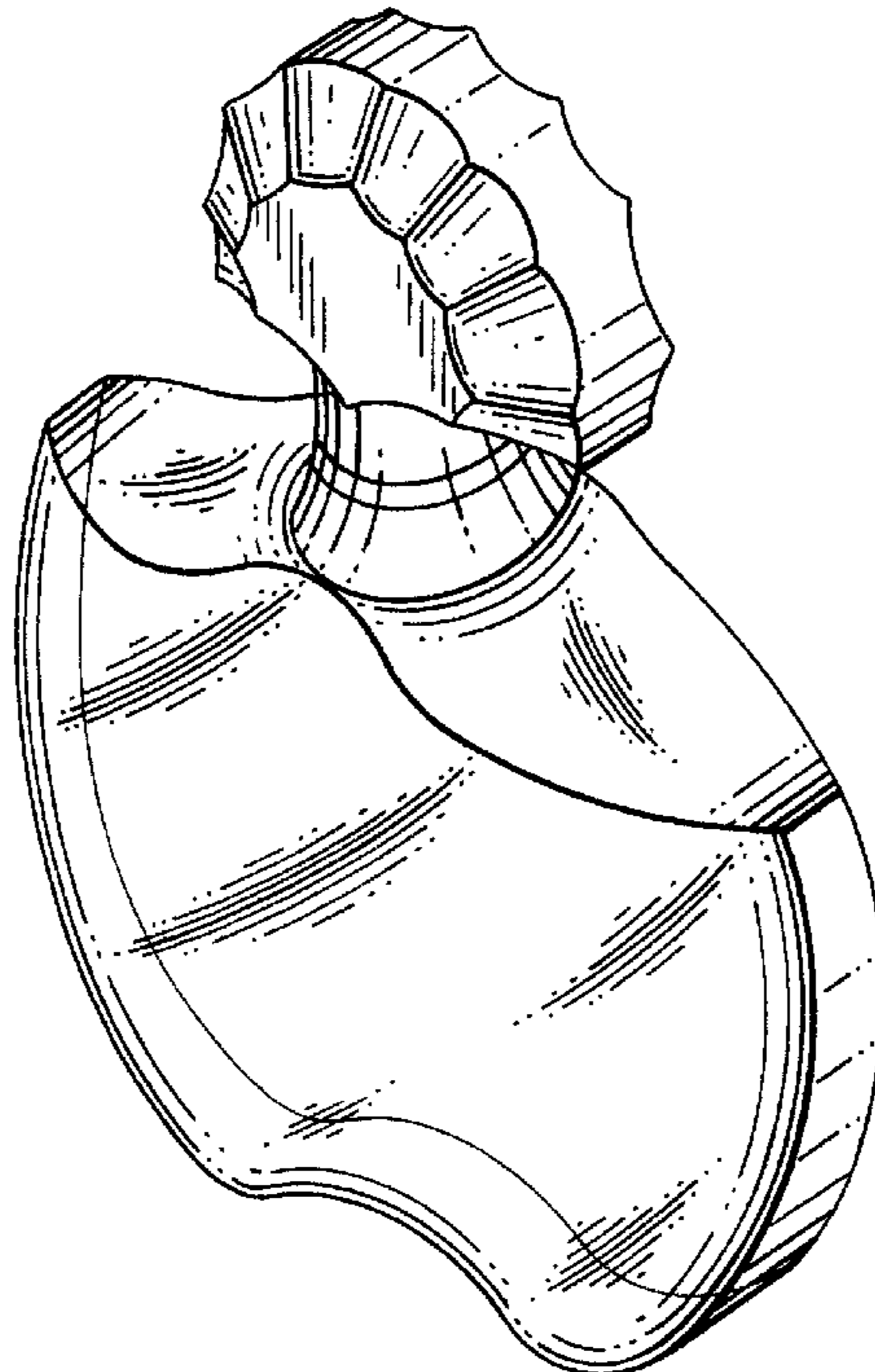
FIG. 1 is a front perspective view of the design;

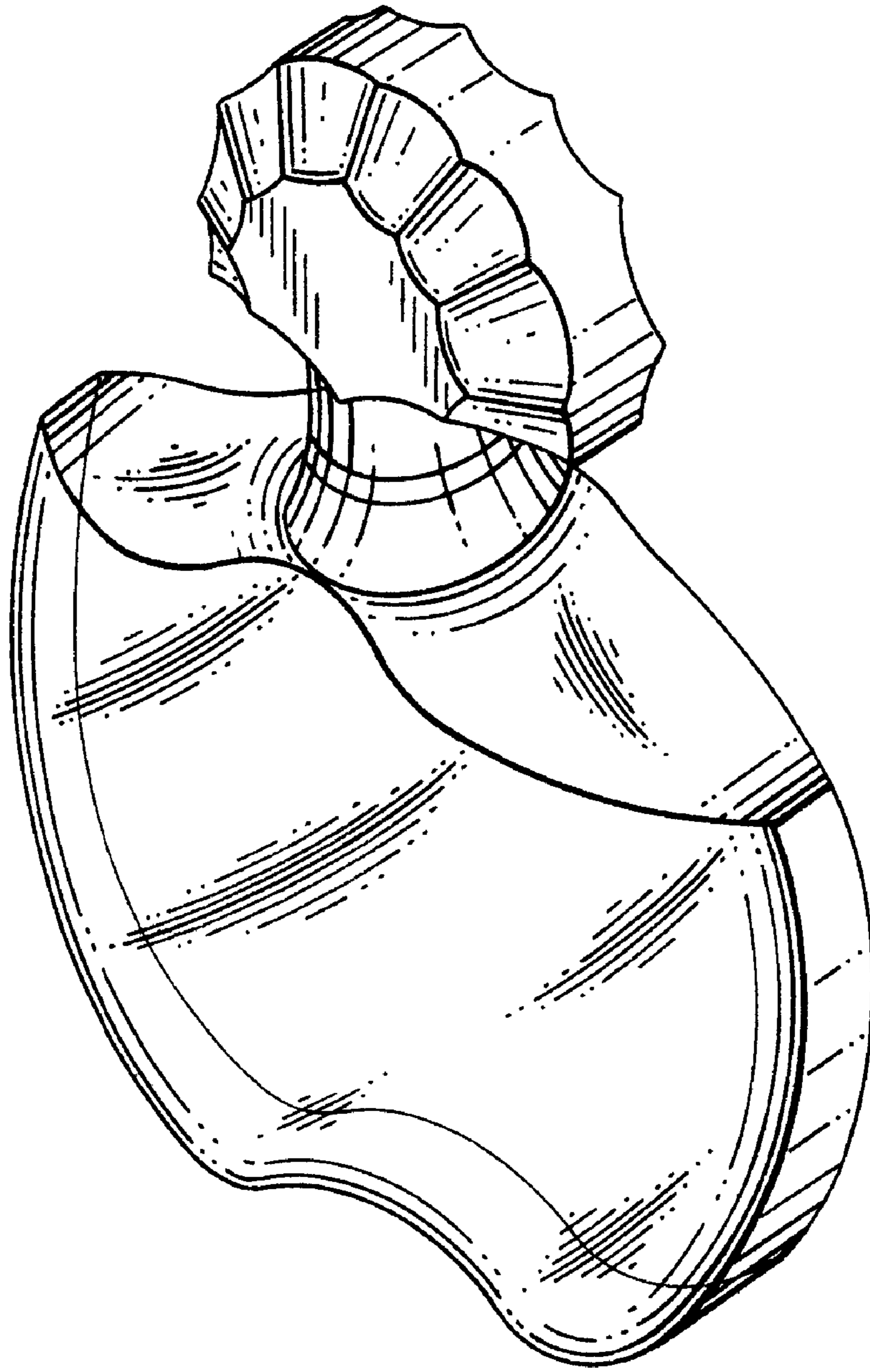
FIG. 2 is a top view;

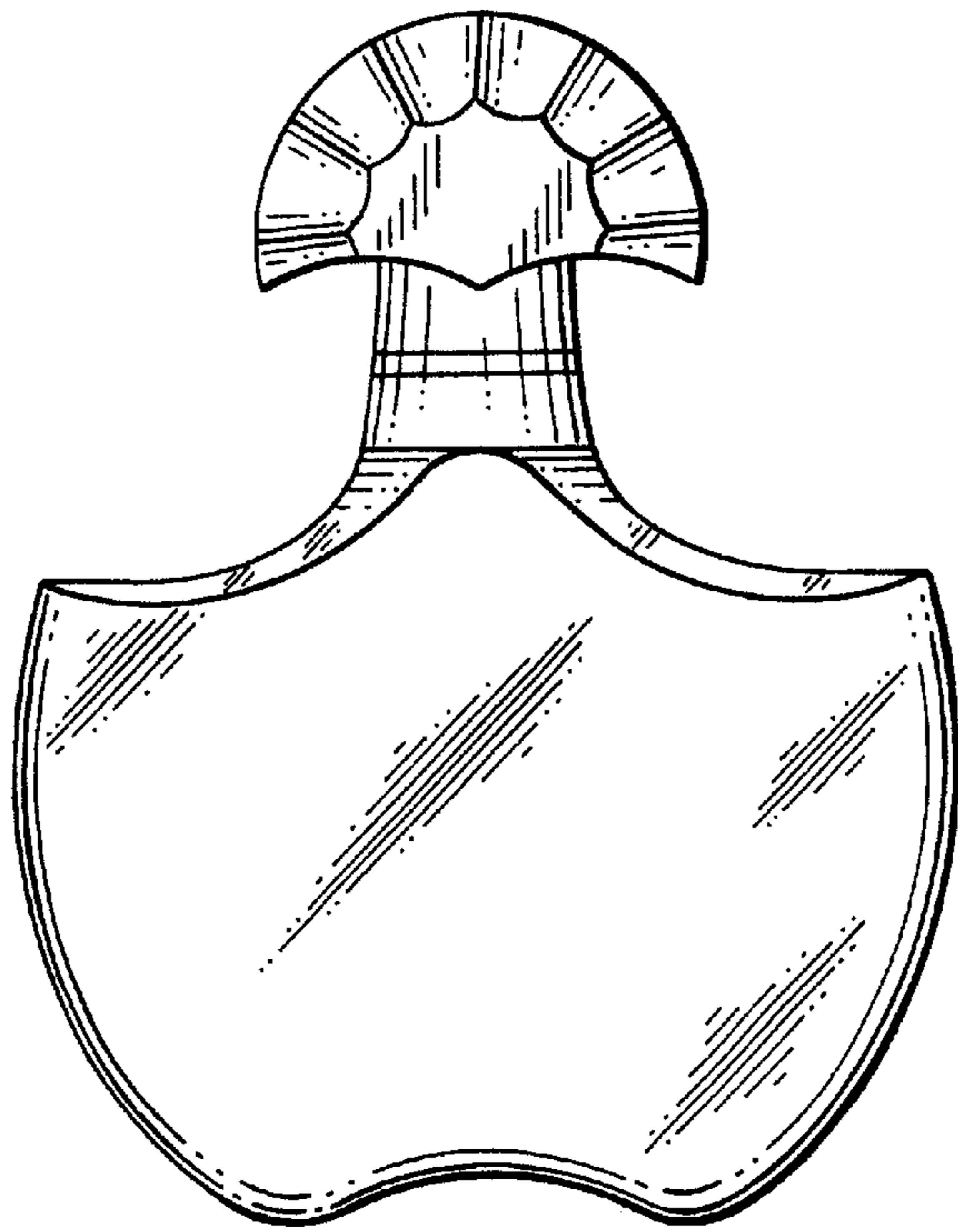
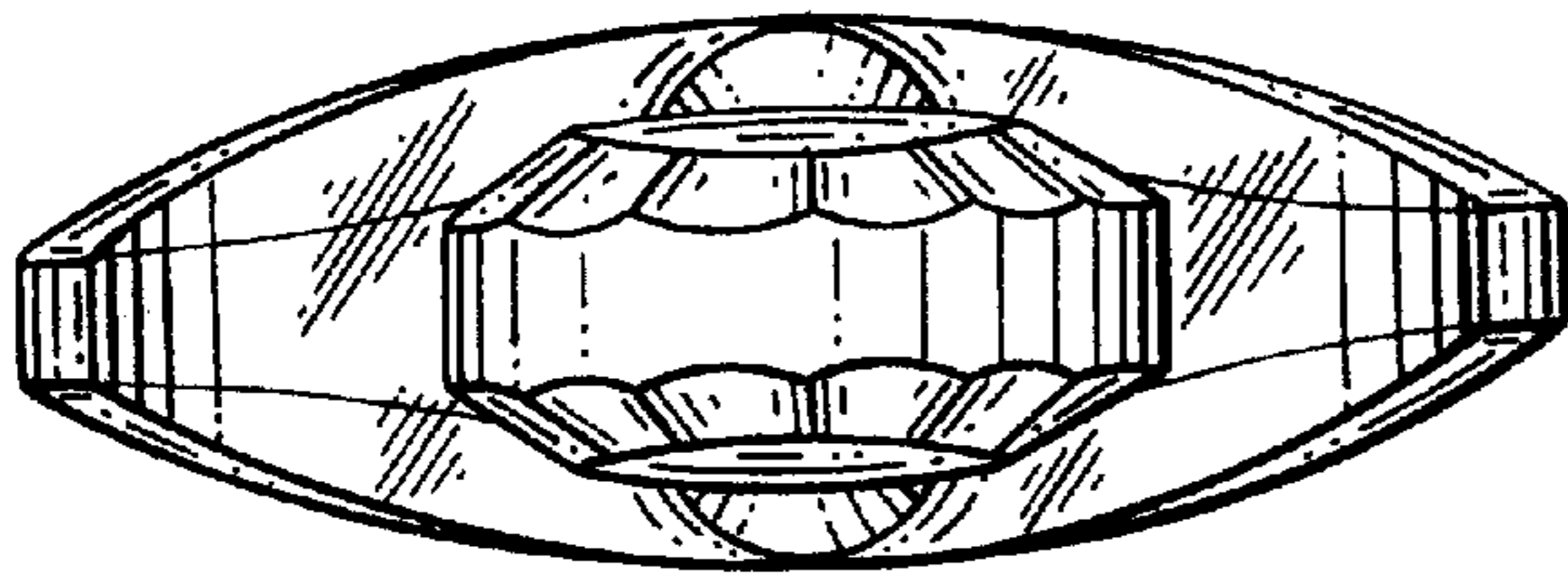

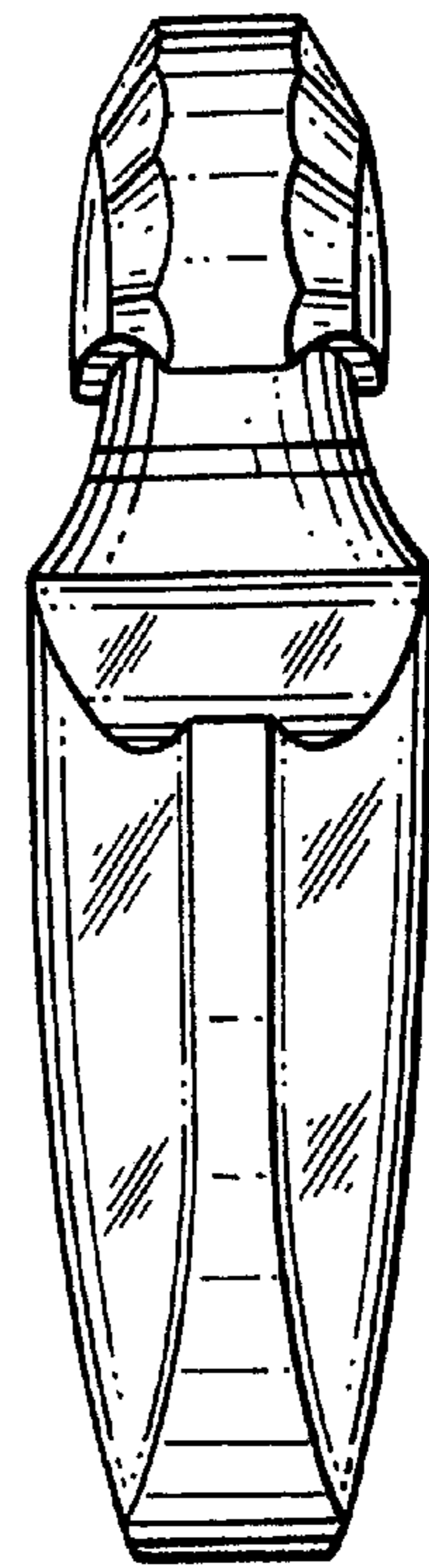
