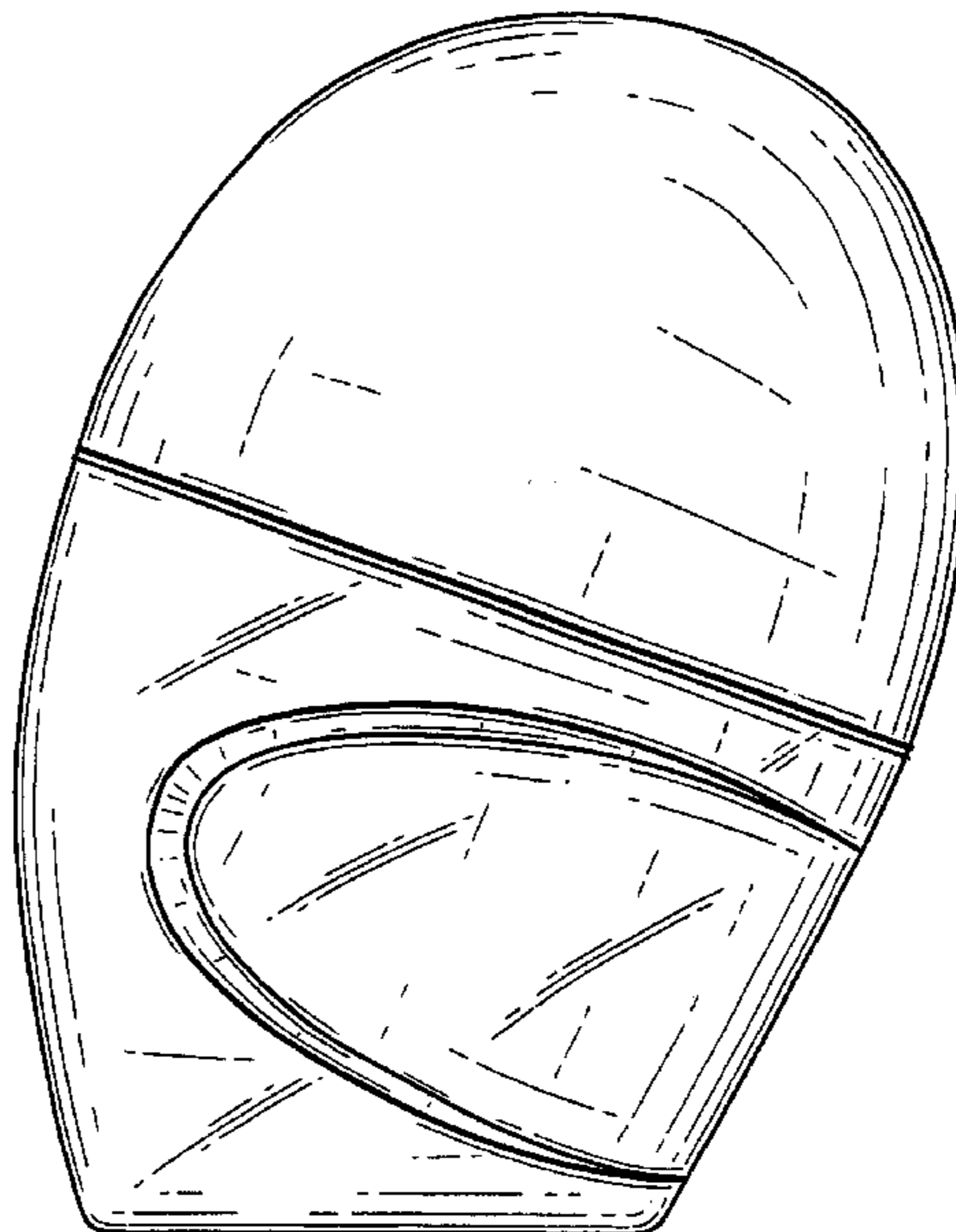
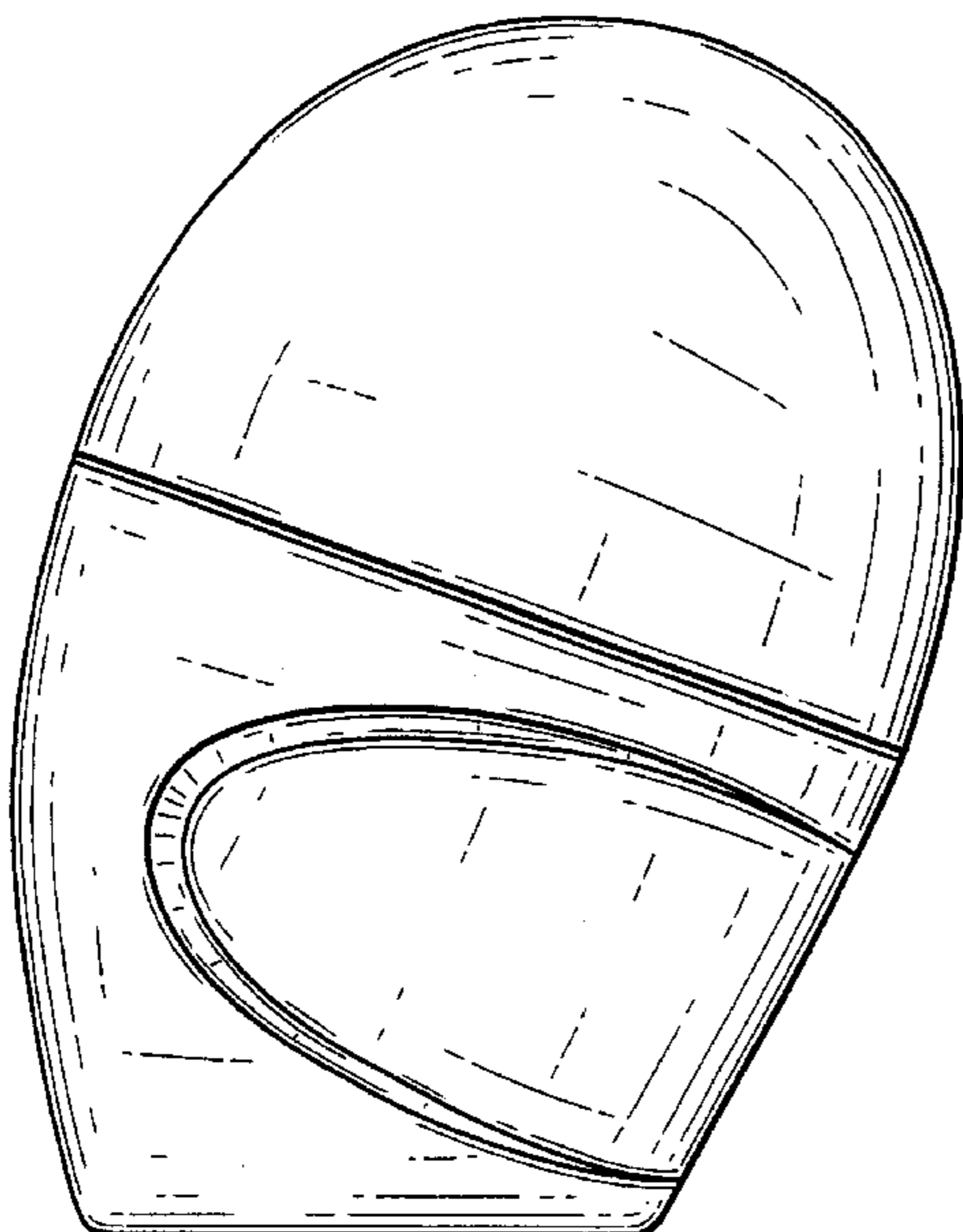
(57) **CLAIM**

The ornamental design for a dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the dispenser of my design; FIG. 2 is a right side elevation view thereof. FIG. 3 is a left side elevation view thereof. FIG. 4 is a front elevation view thereof. FIG. 5 is a rear elevation view thereof. FIG. 6 is a top plan view thereof. FIG. 7 is a bottom plan view thereof. FIG. 8 is an alternate embodiment thereof where the lower part of the dispenser is transparent. FIG. 9 is a right side elevation view thereof. FIG. 10 is a left side elevation view thereof. FIG. 11 is a front elevation view thereof. FIG. 12 is a rear elevation view thereof. FIG. 13 is a top plan view thereof; and, FIG. 14 is a bottom plan view thereof.

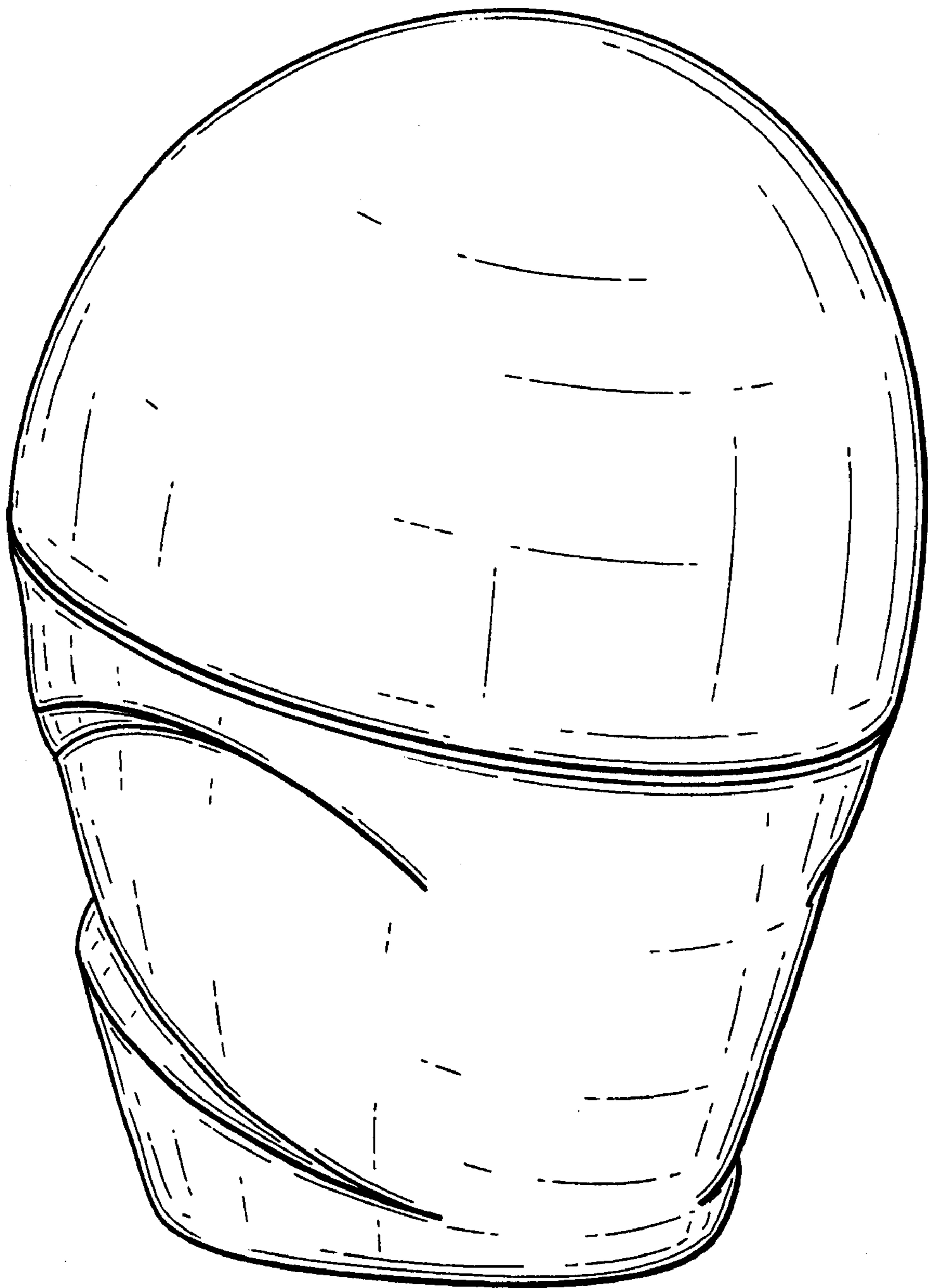

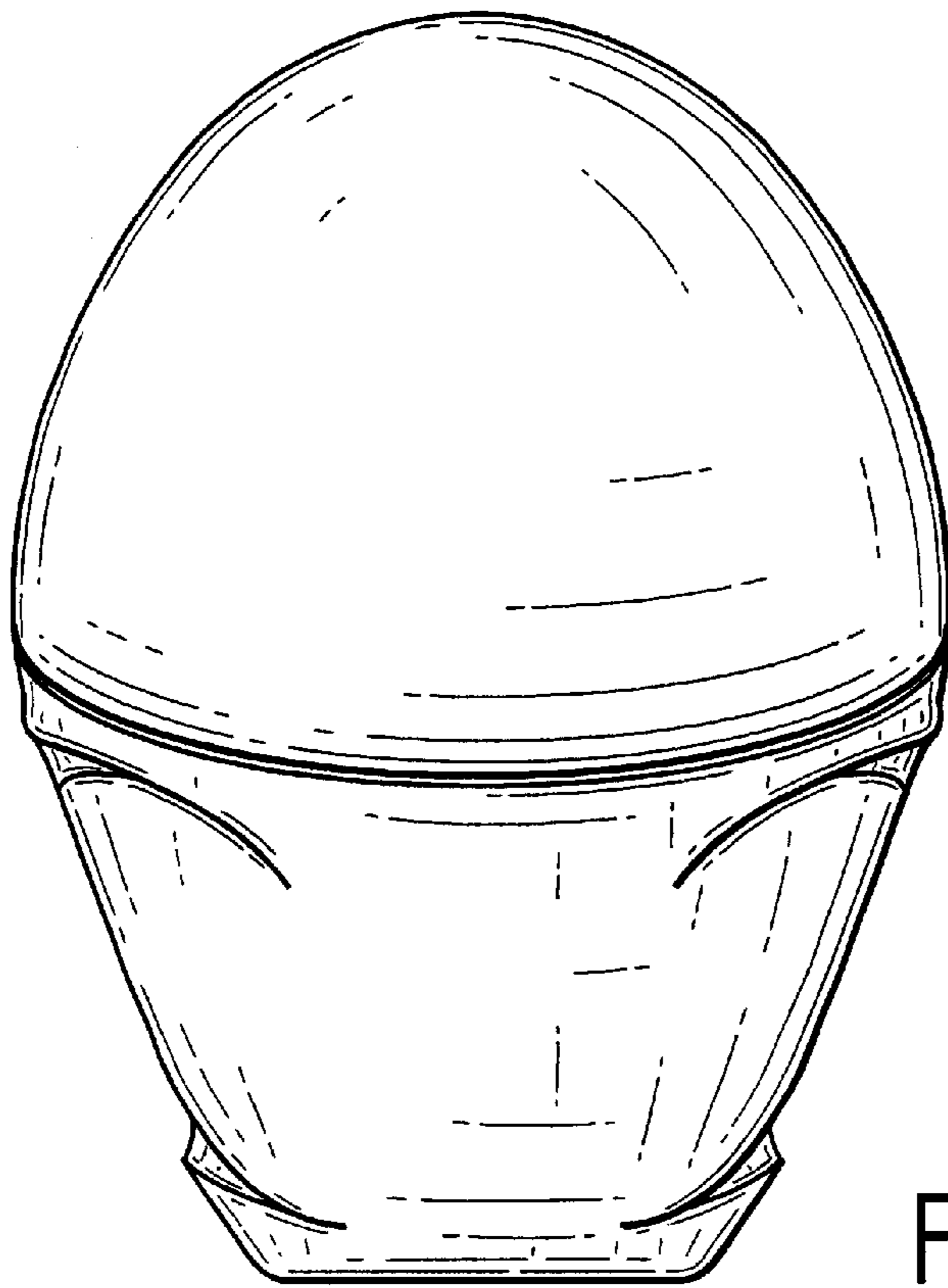

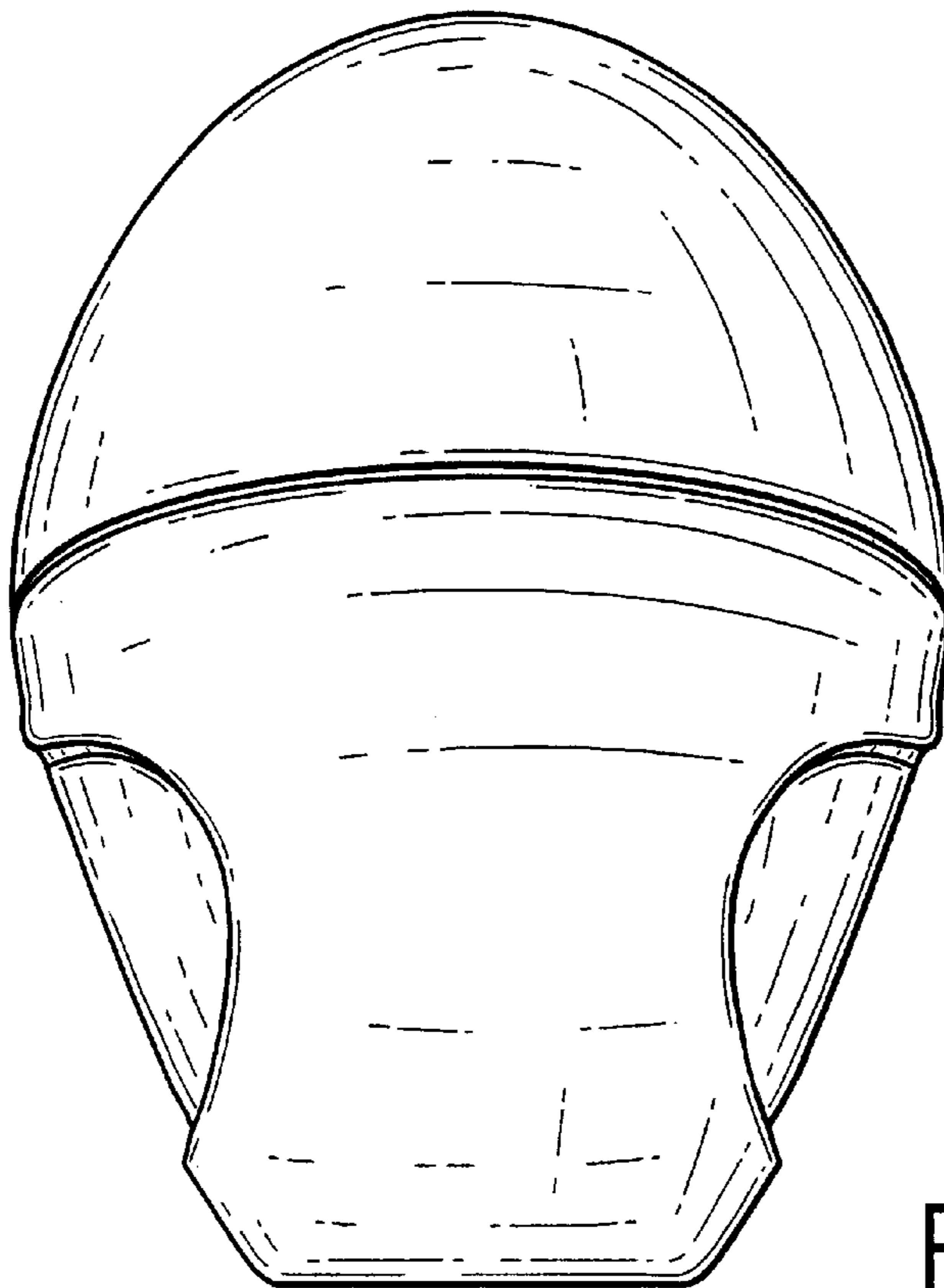

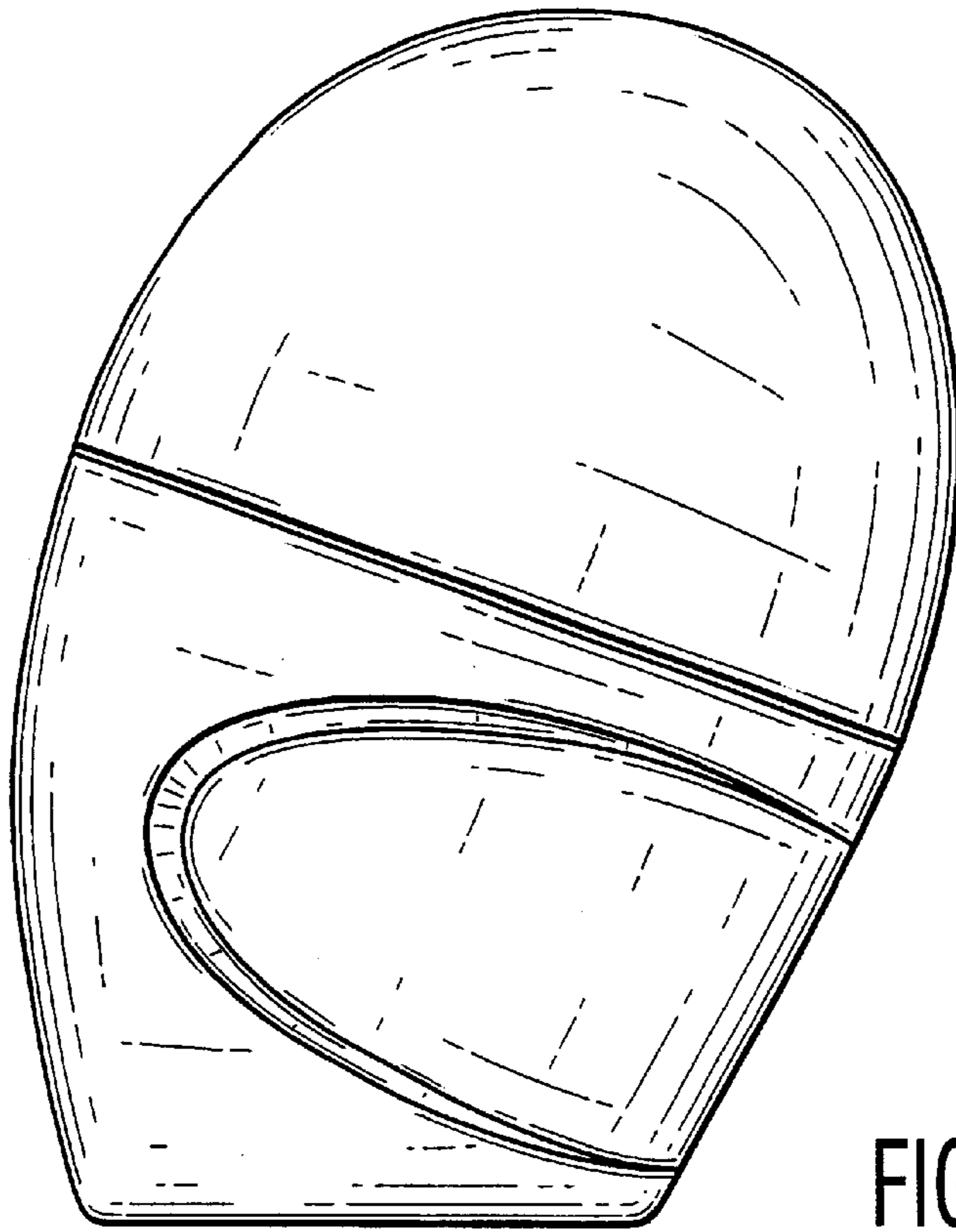

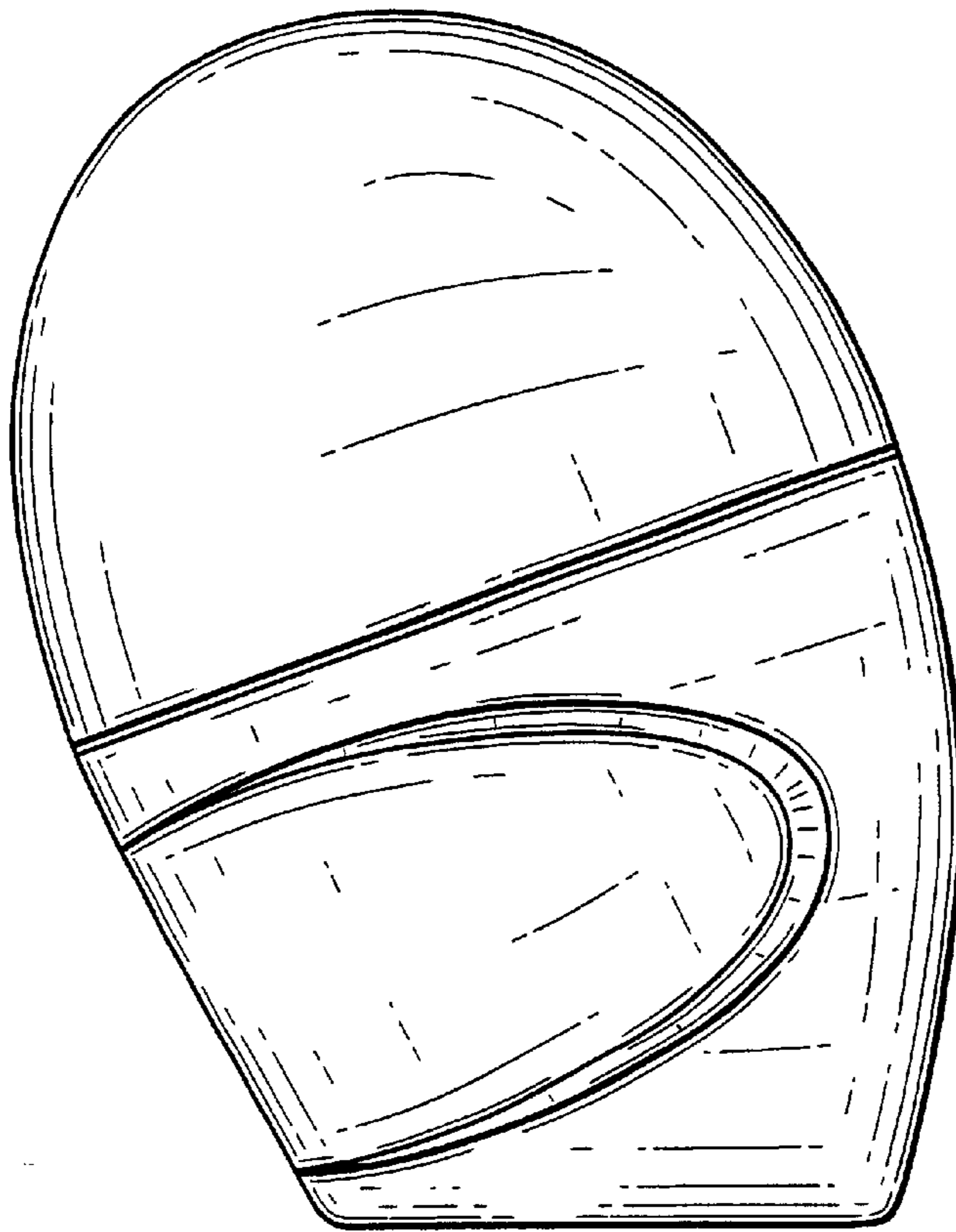

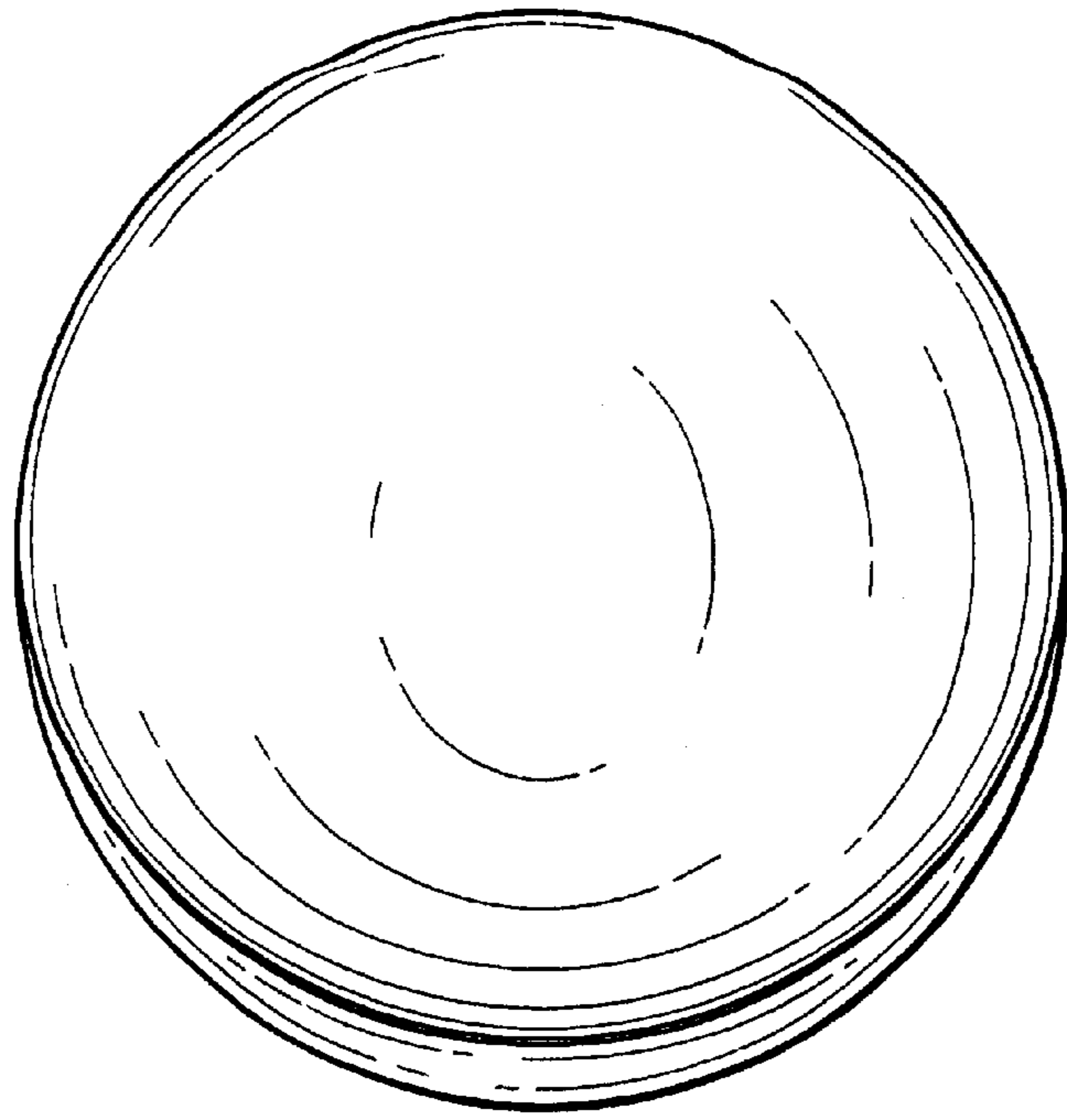

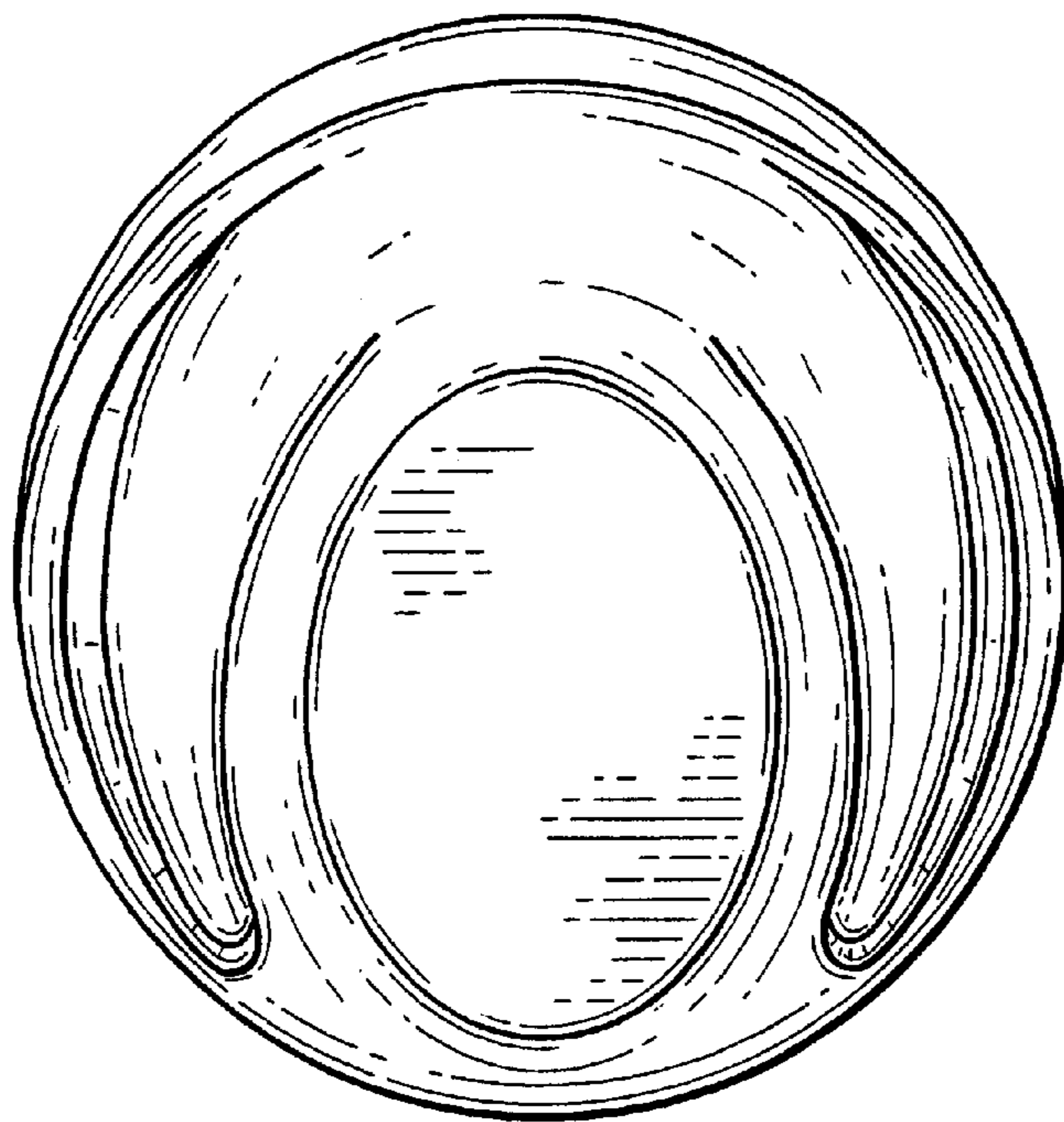

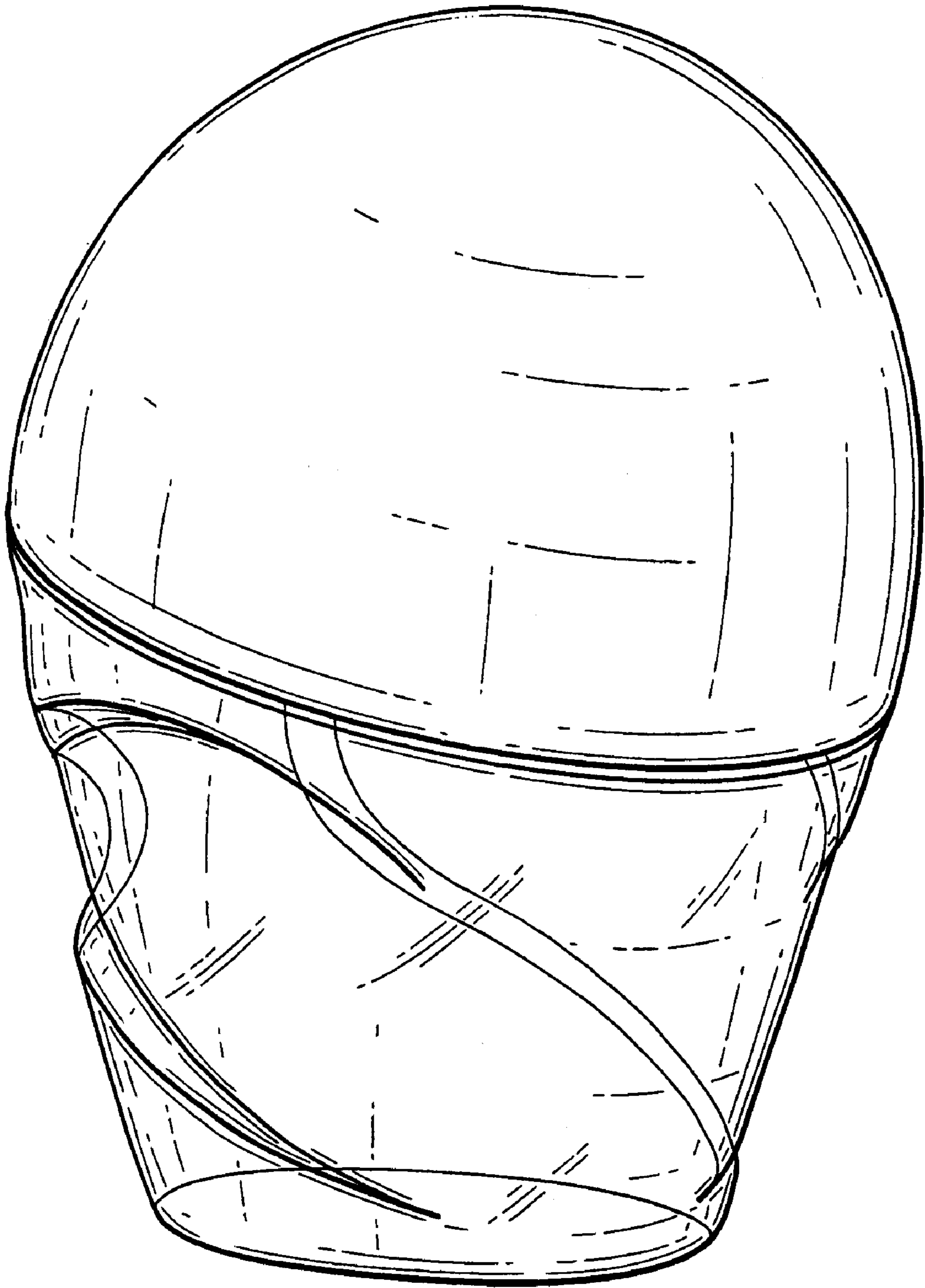

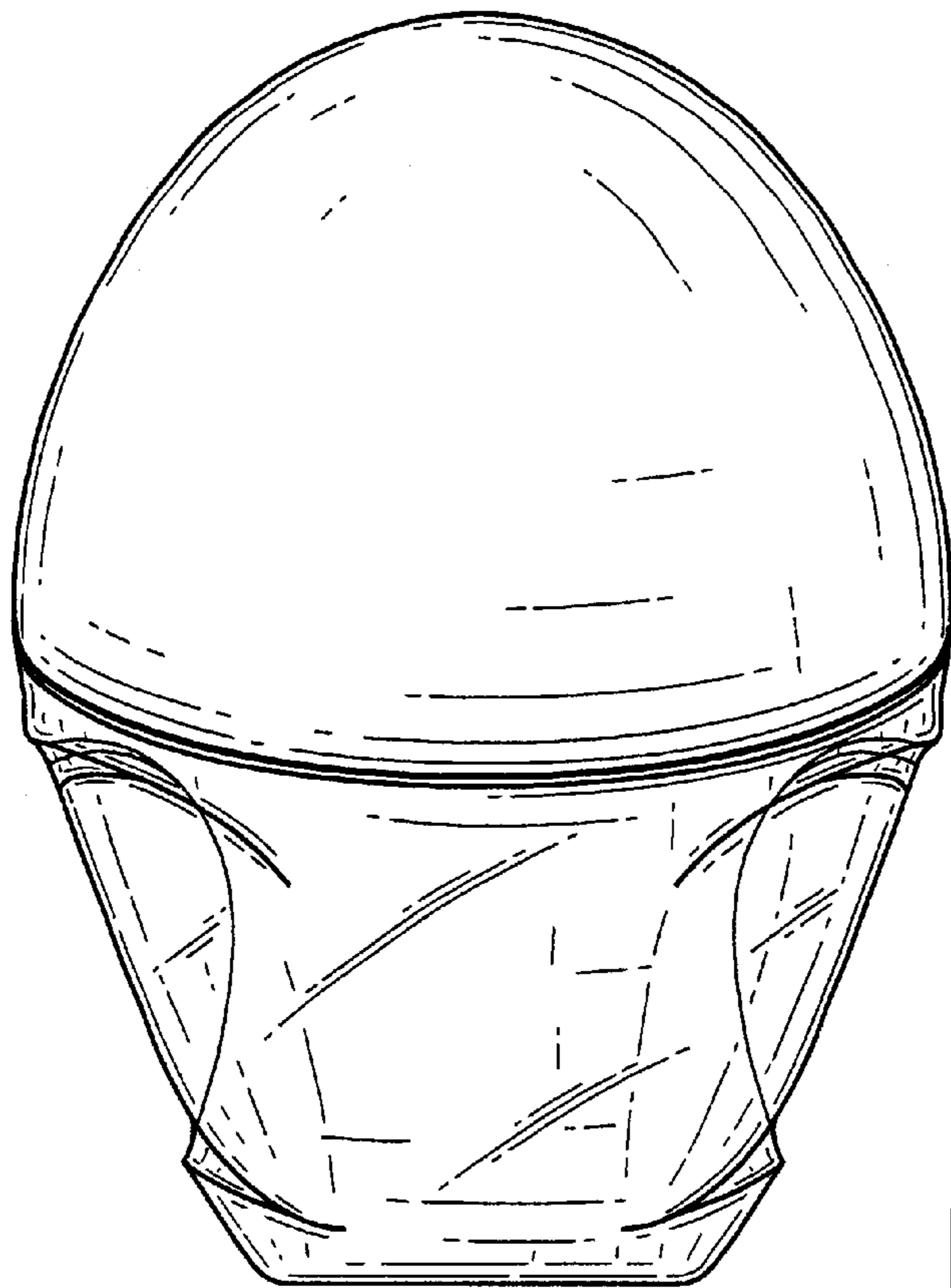

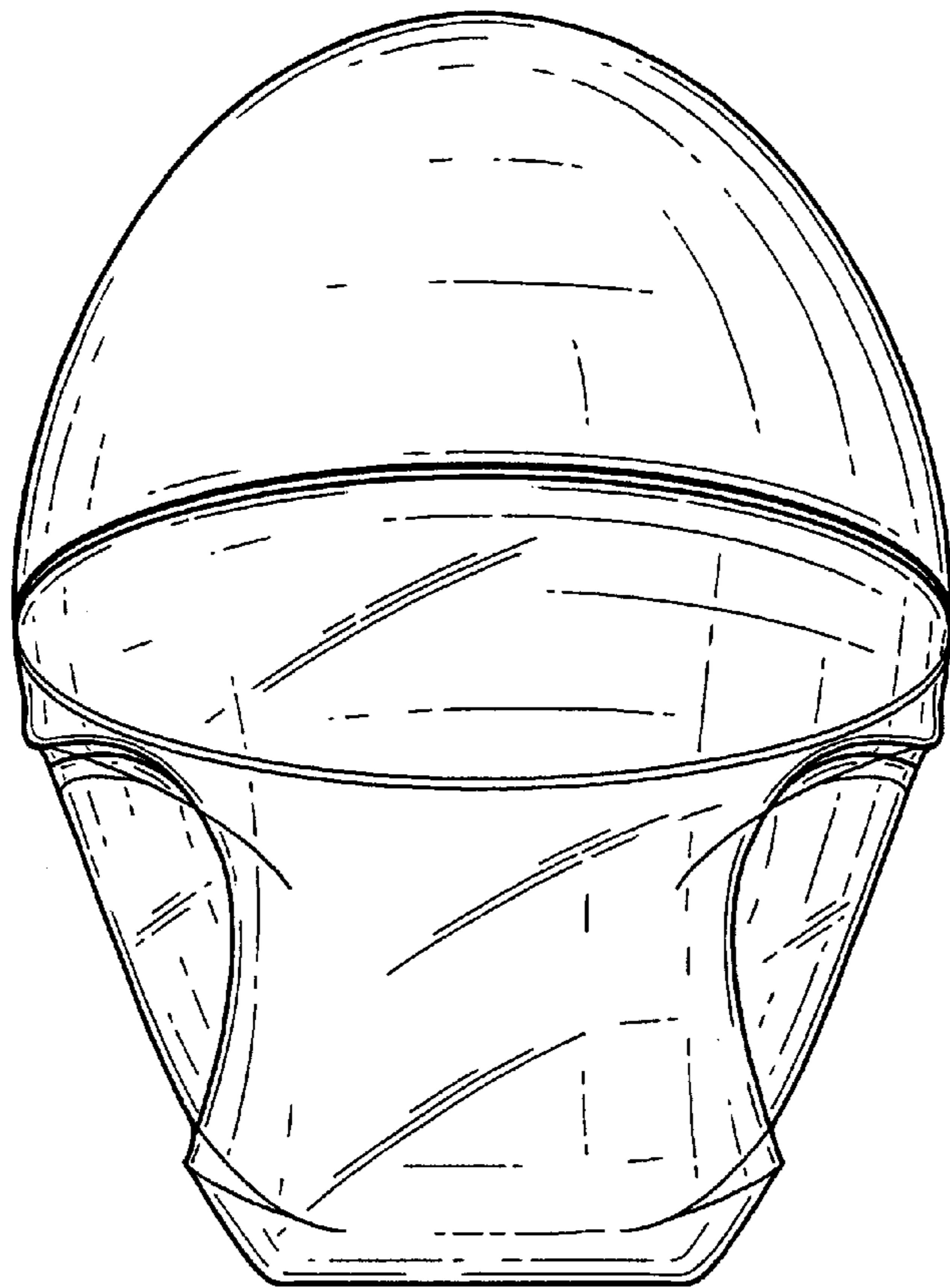

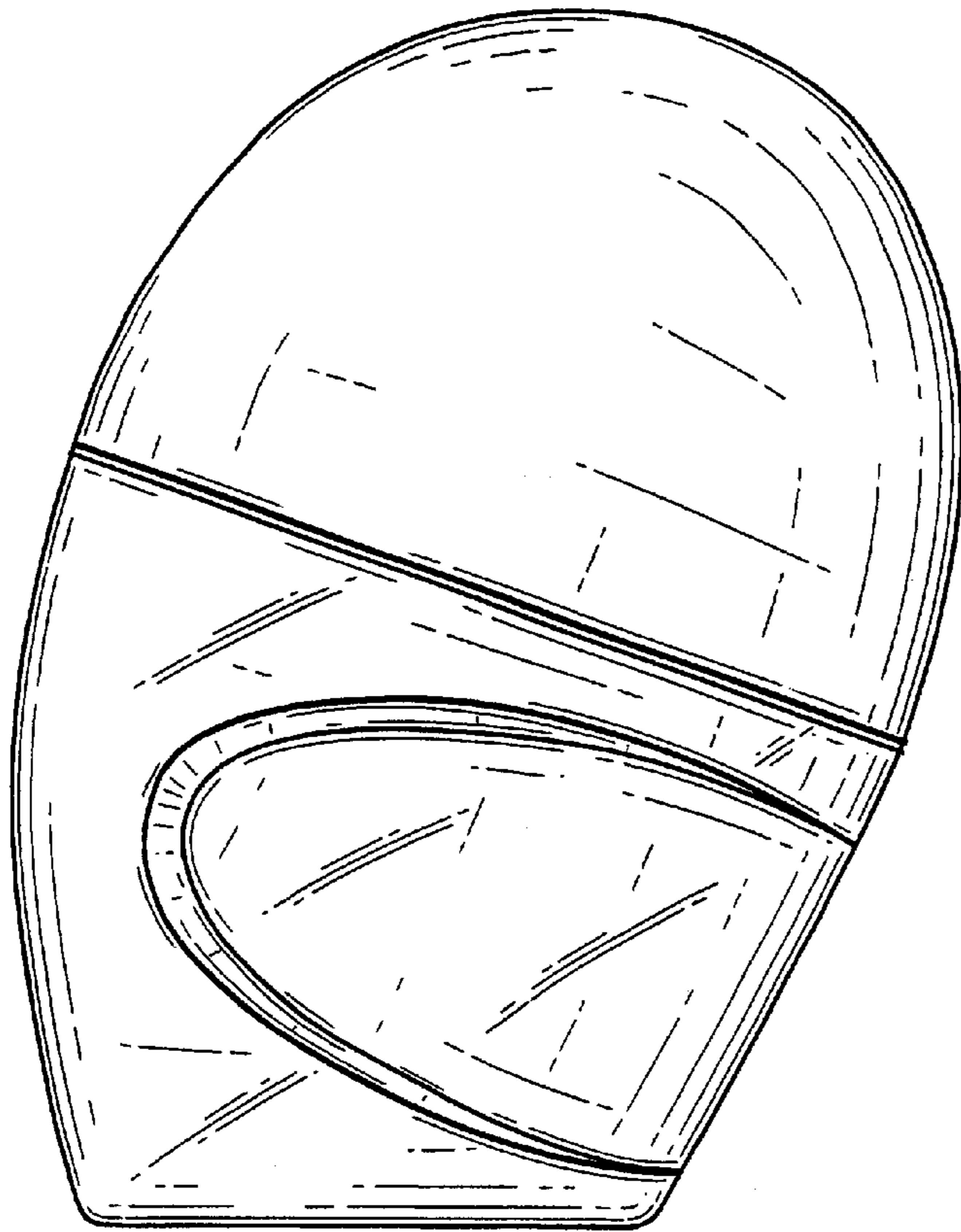

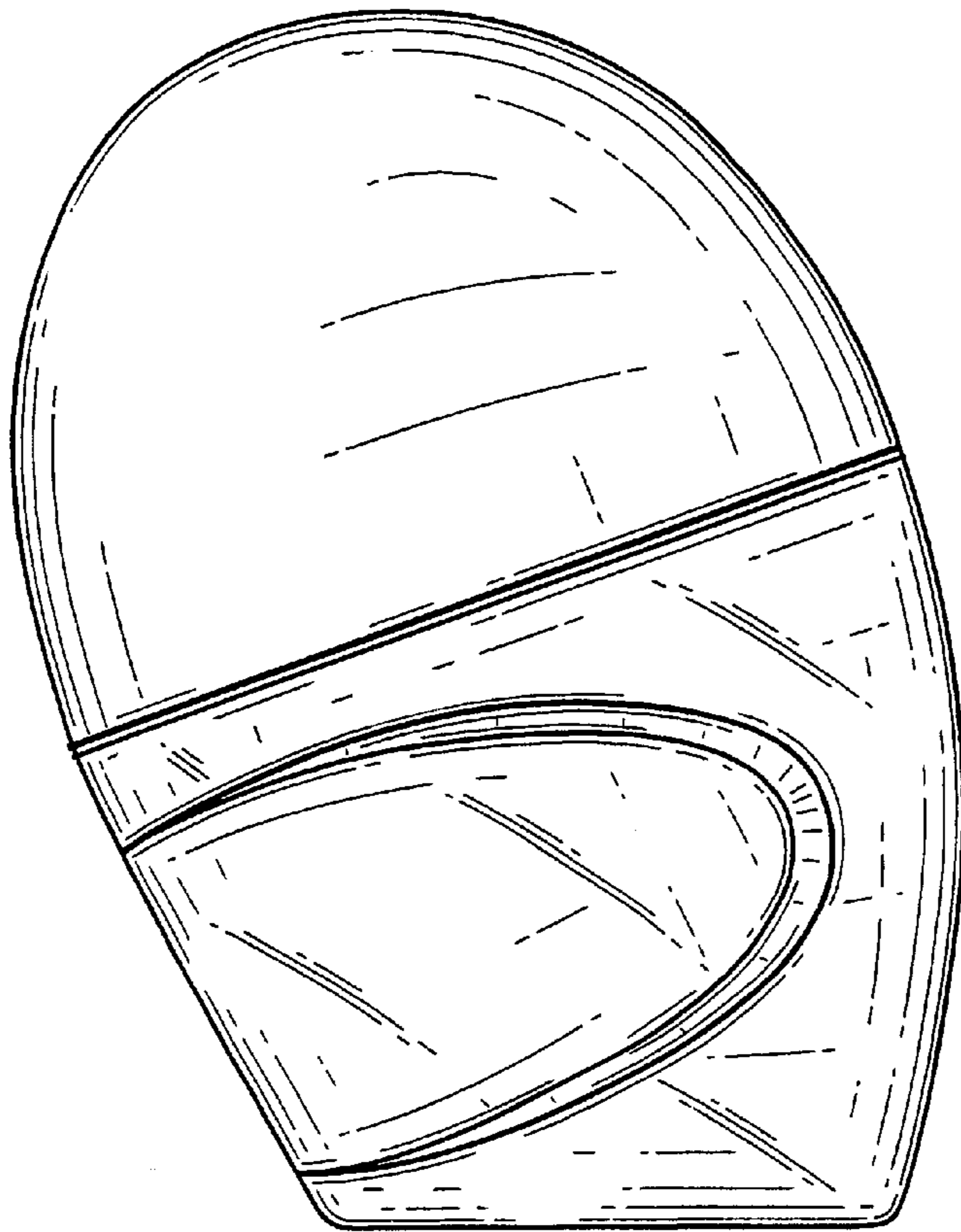

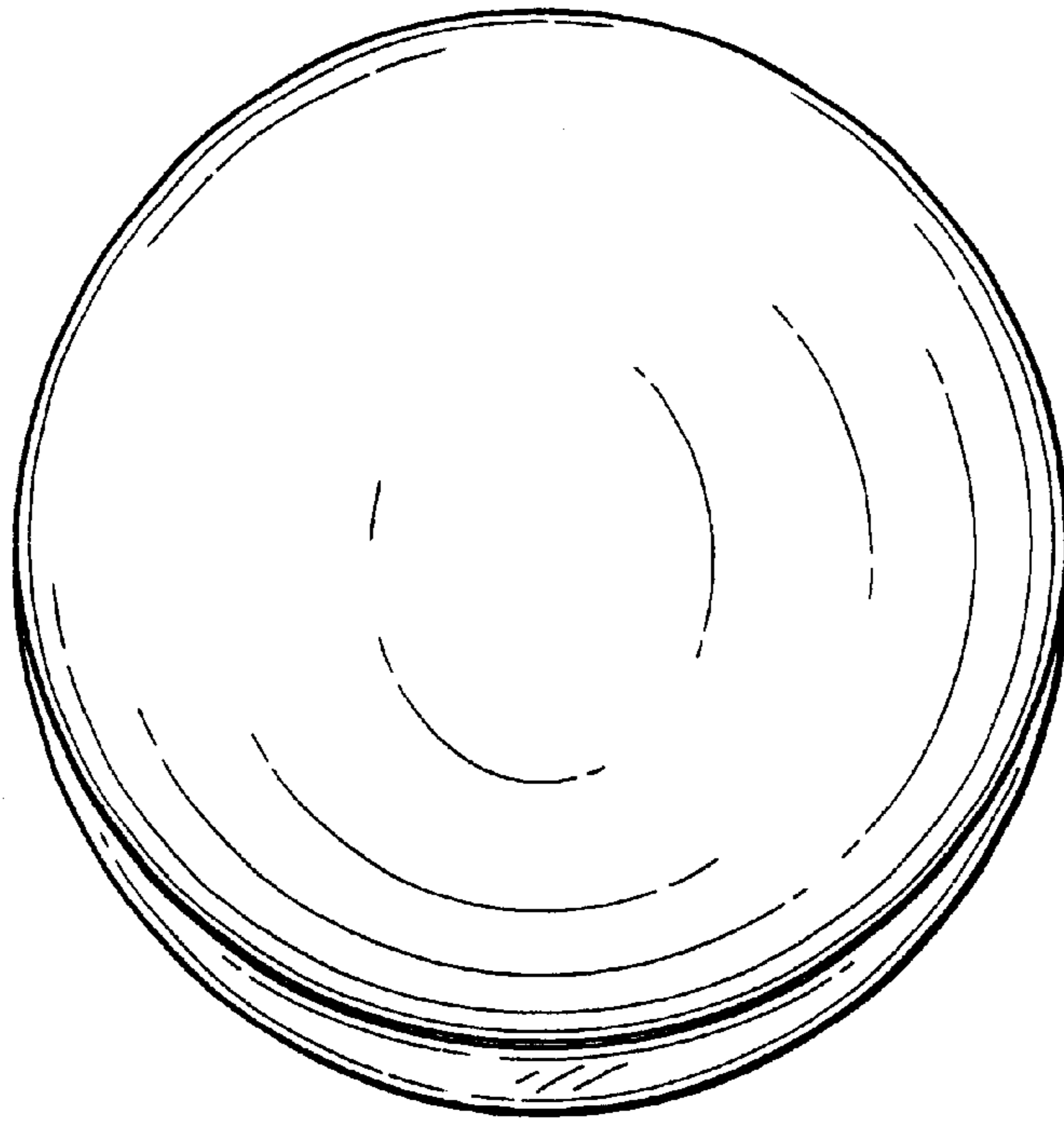

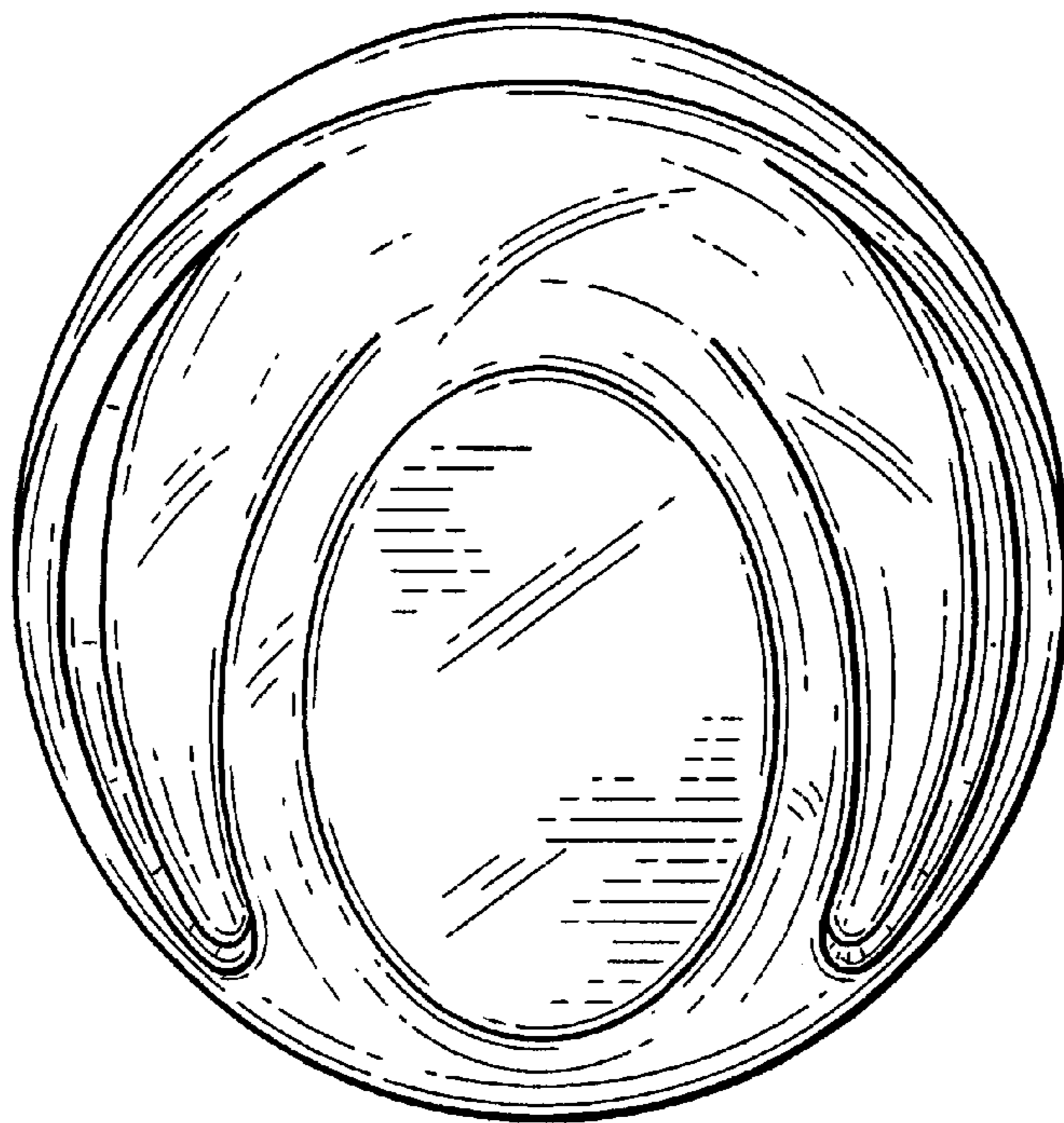
