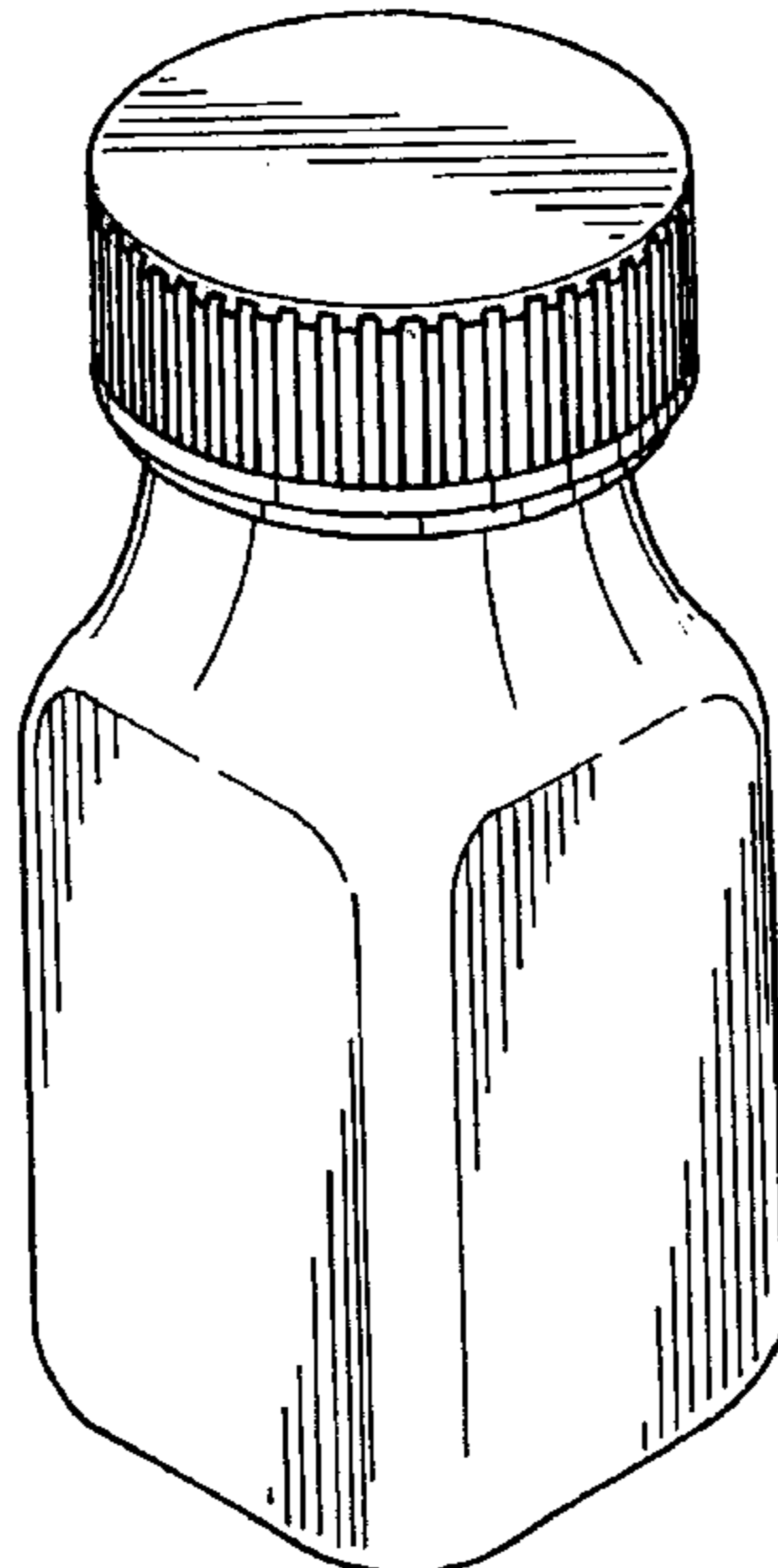
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view in accordance with my new design;
FIG. 2 is a front elevational view thereof, with left side, right side and rear elevational views thereof being identical;
FIG. 3 is a top plan view thereof; and,
FIG. 4 is a bottom plan view thereof.

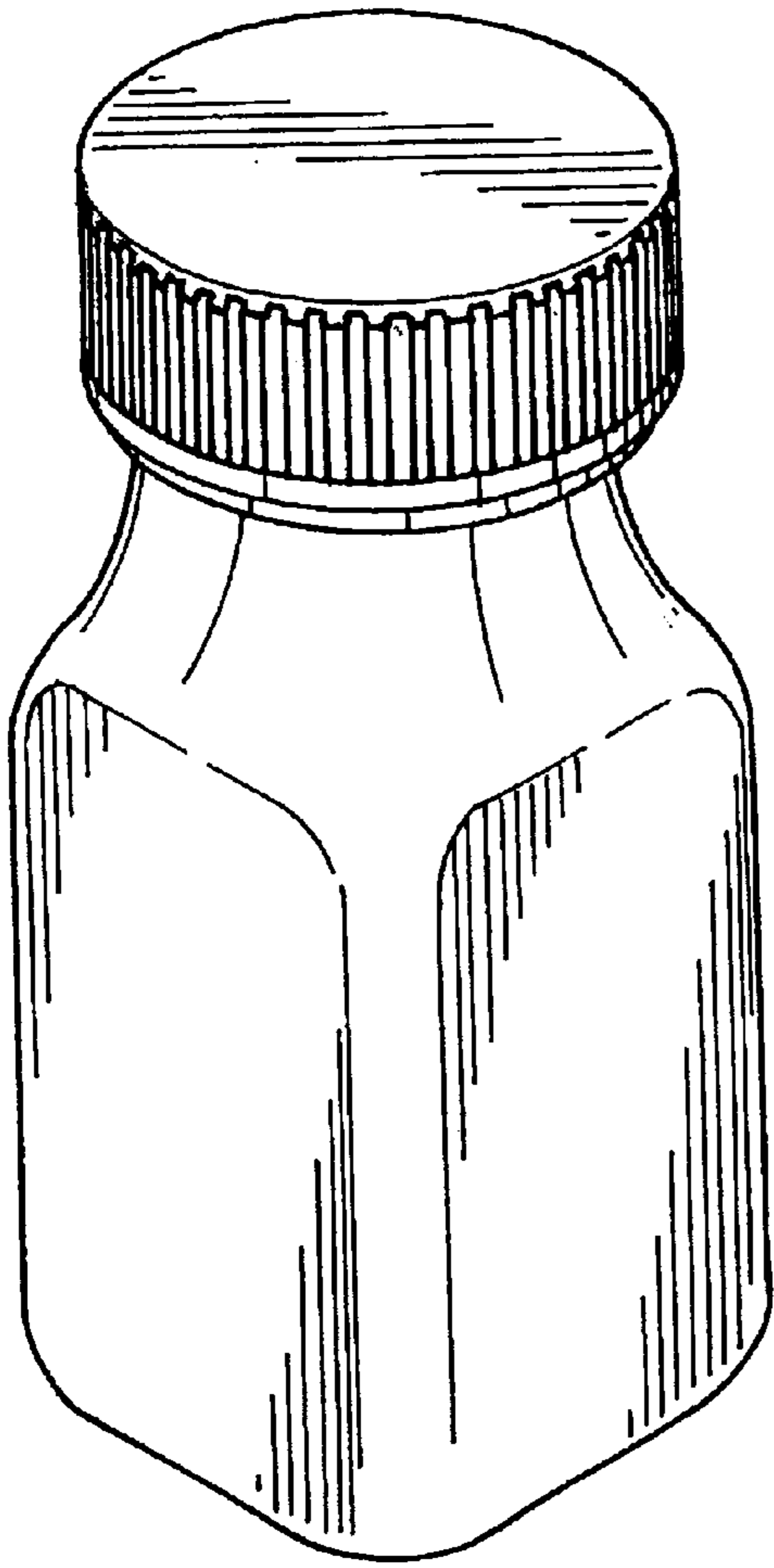

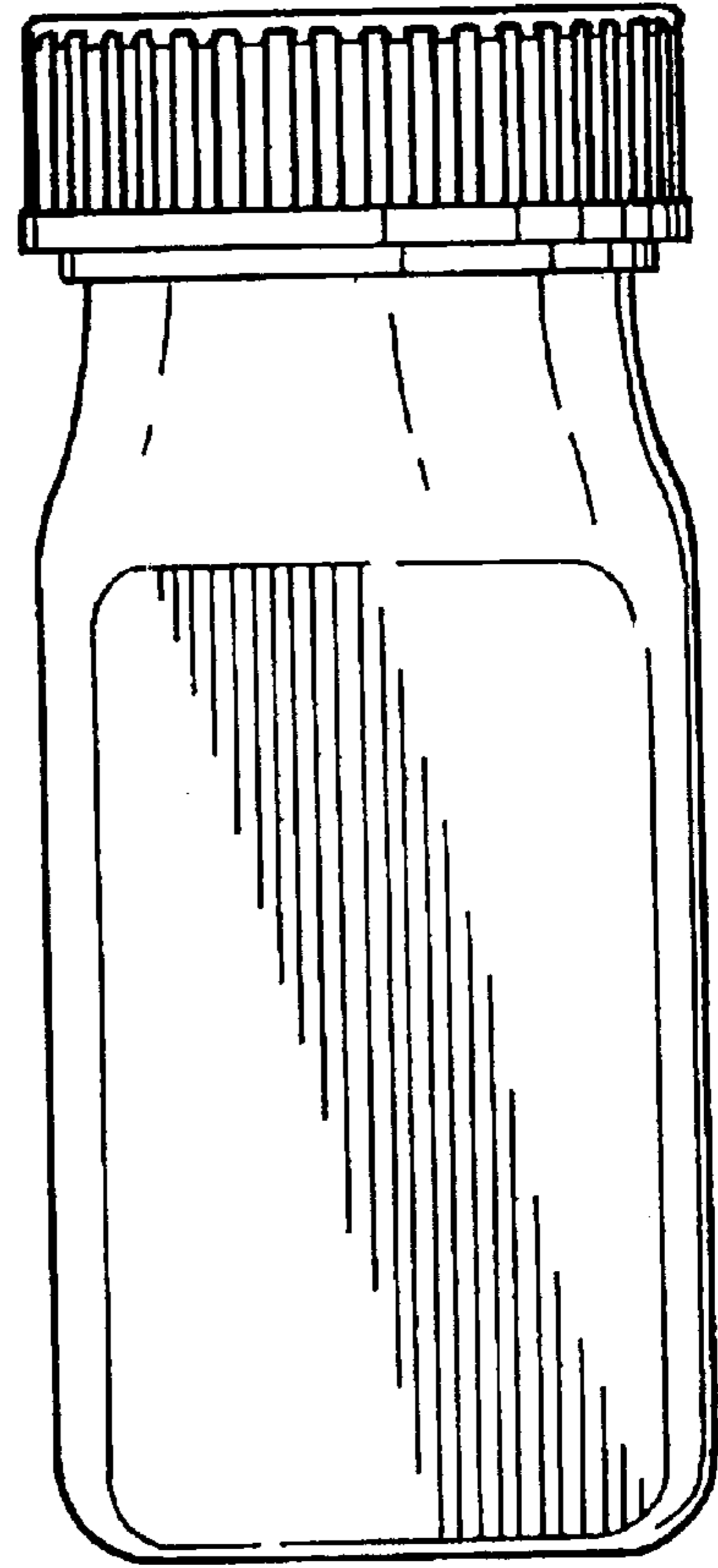

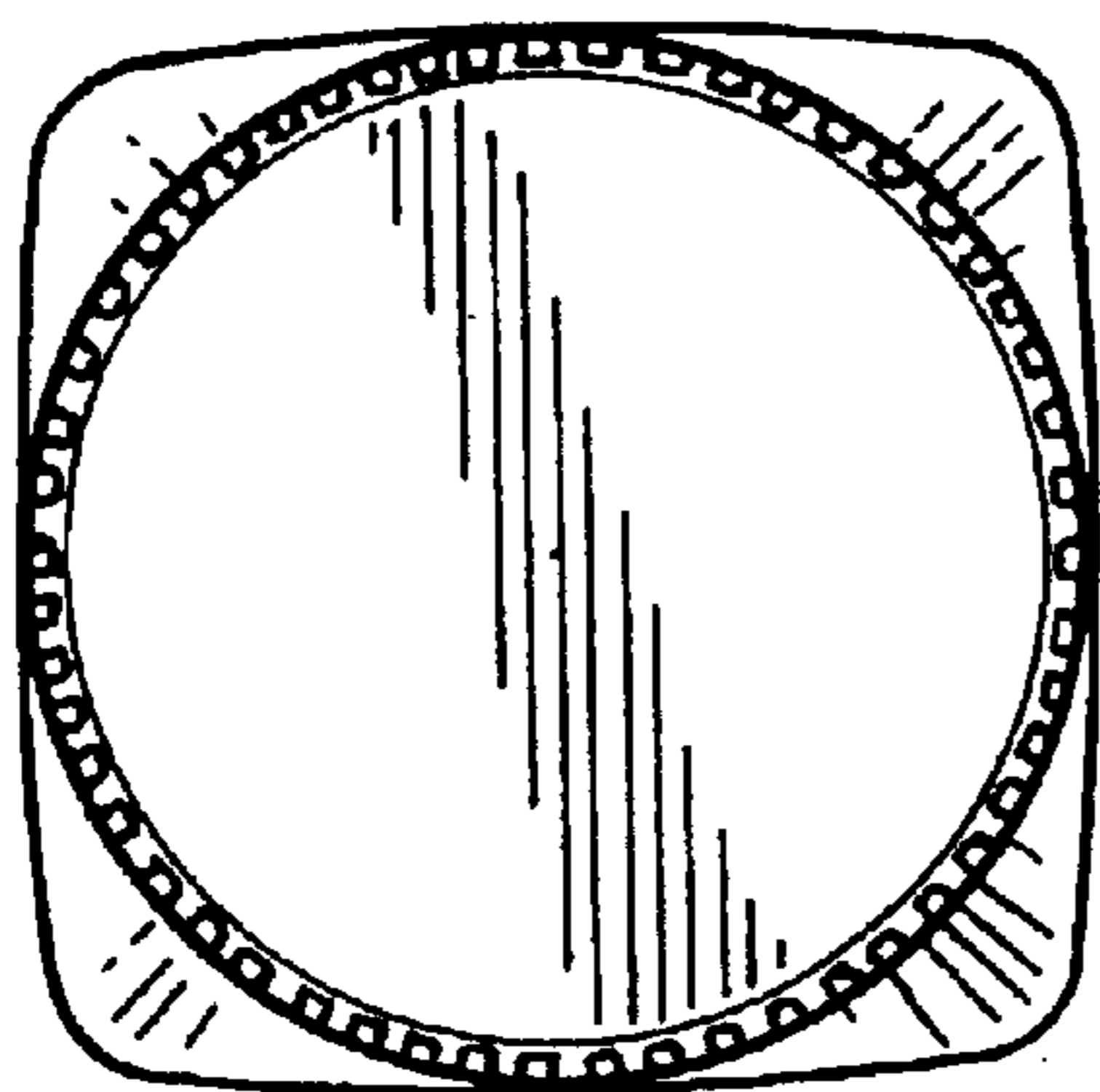

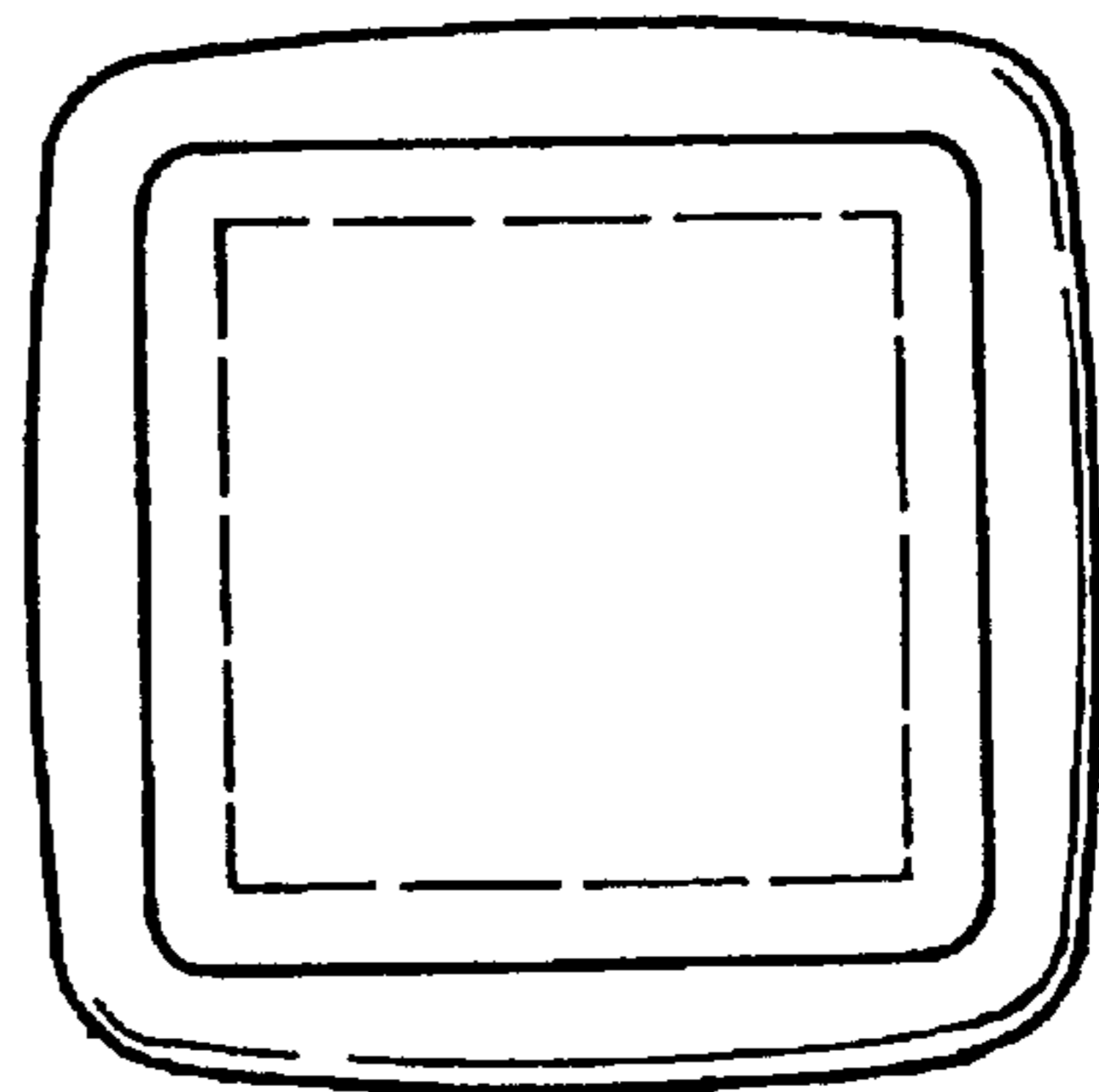
