DESCRIPTION

FIG. 10 is a side elevation view of the rectangular embodiment of the bonding tab design.

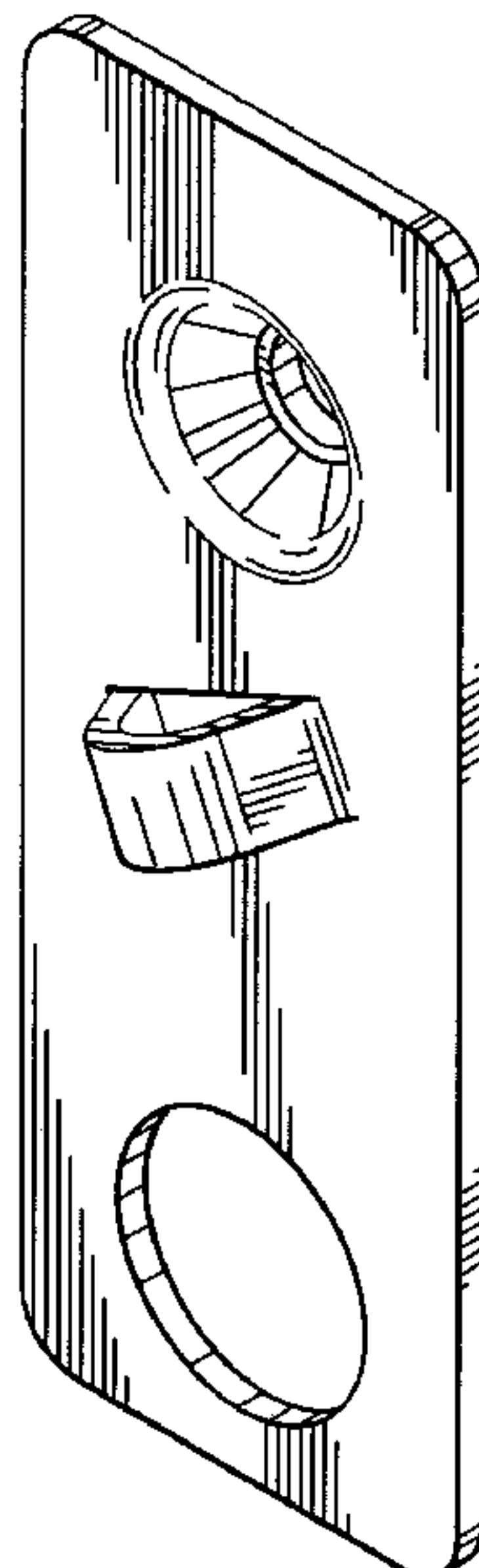
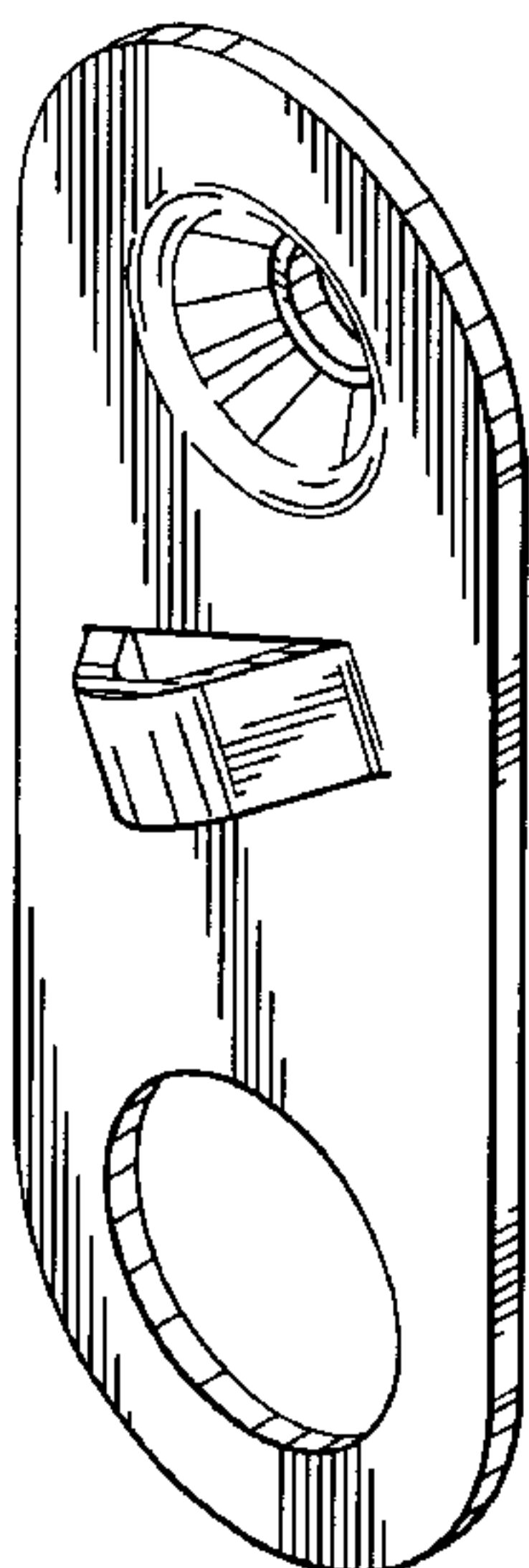
FIG. 11 is a bottom plan view of the rectangular embodiment of the bonding tab design.

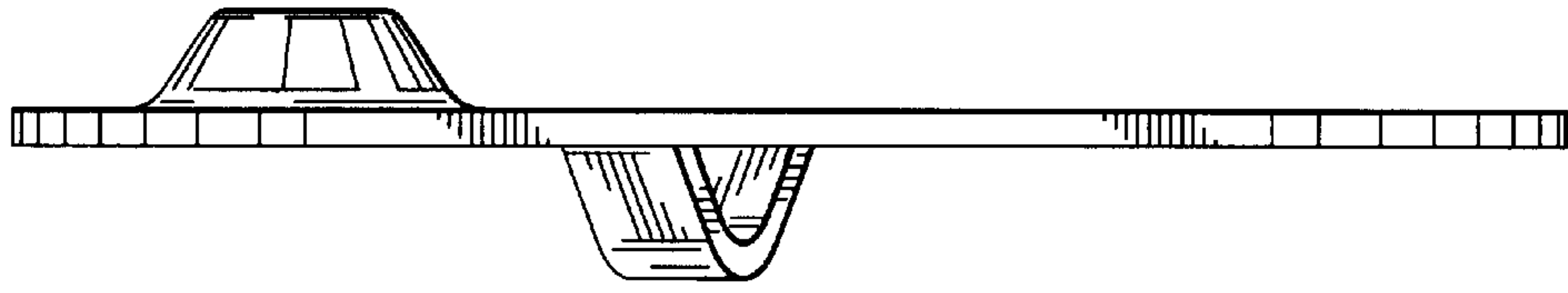

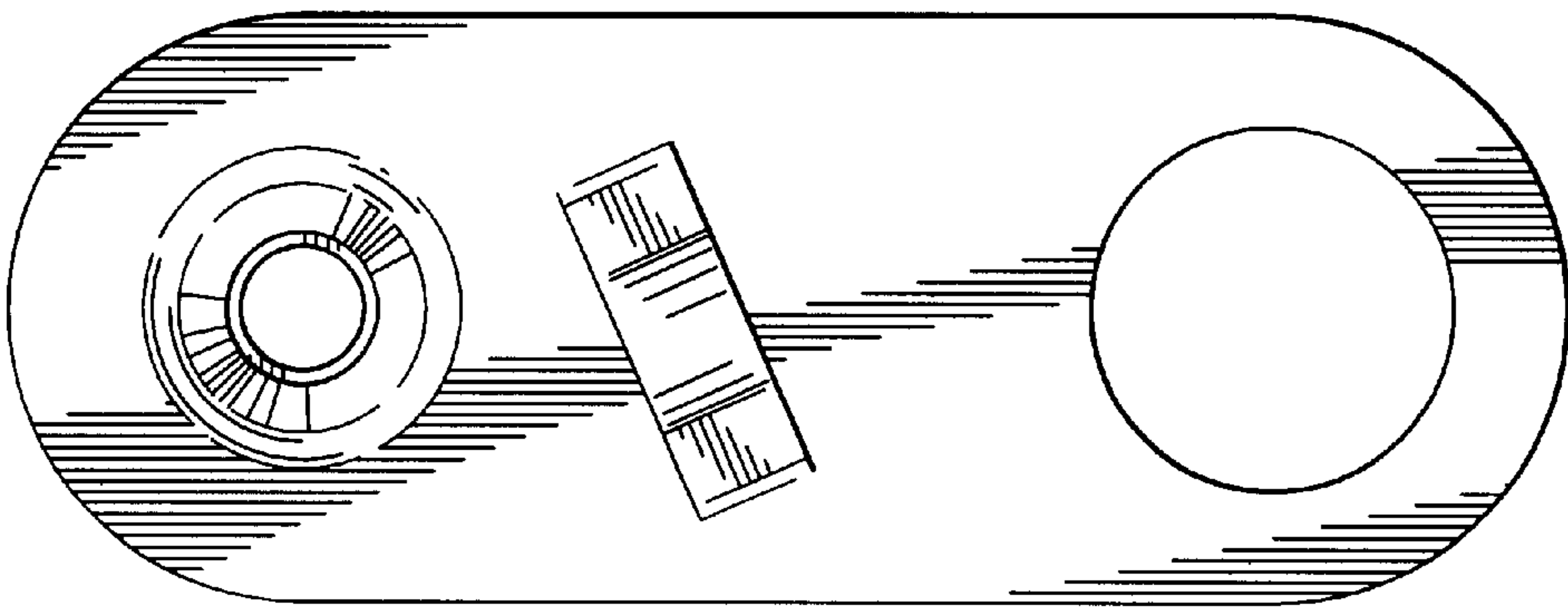

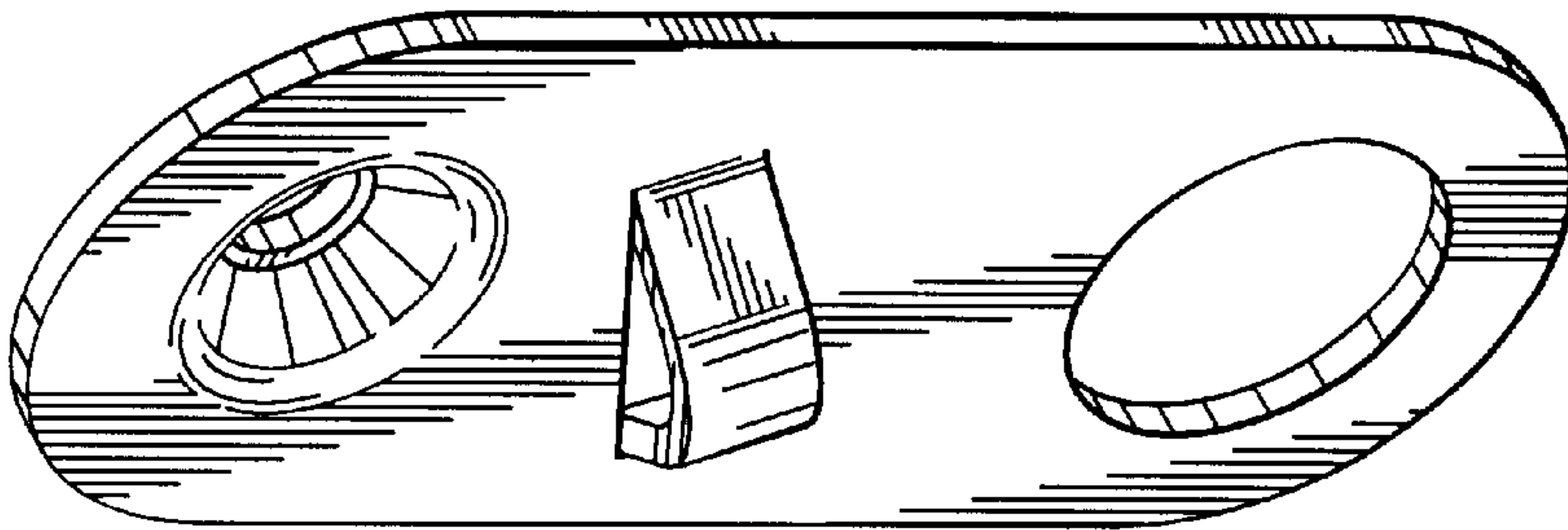

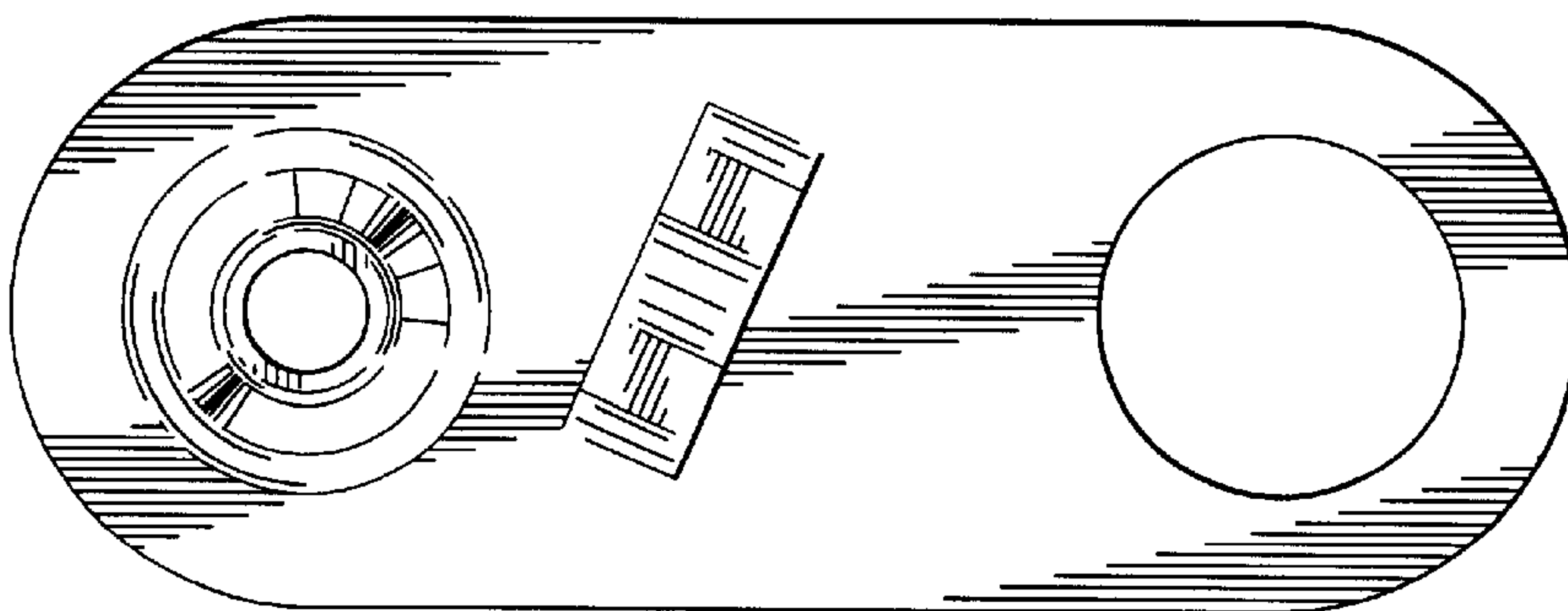

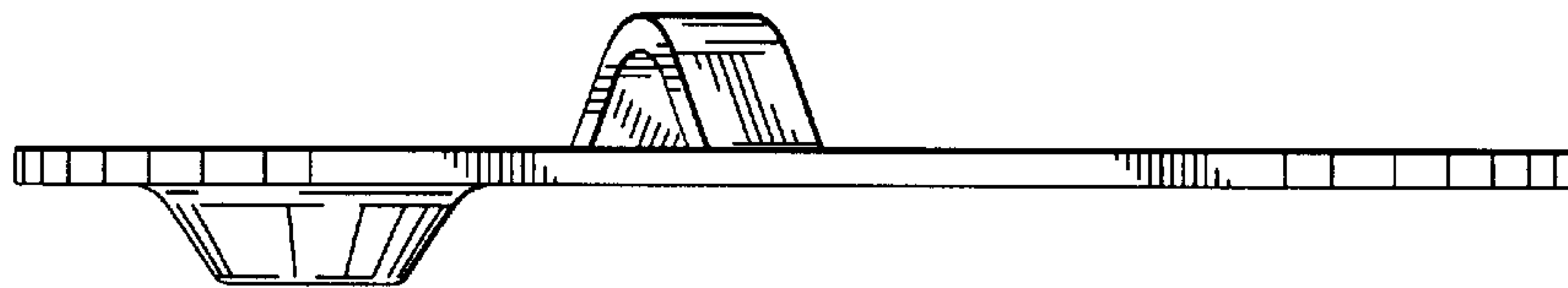

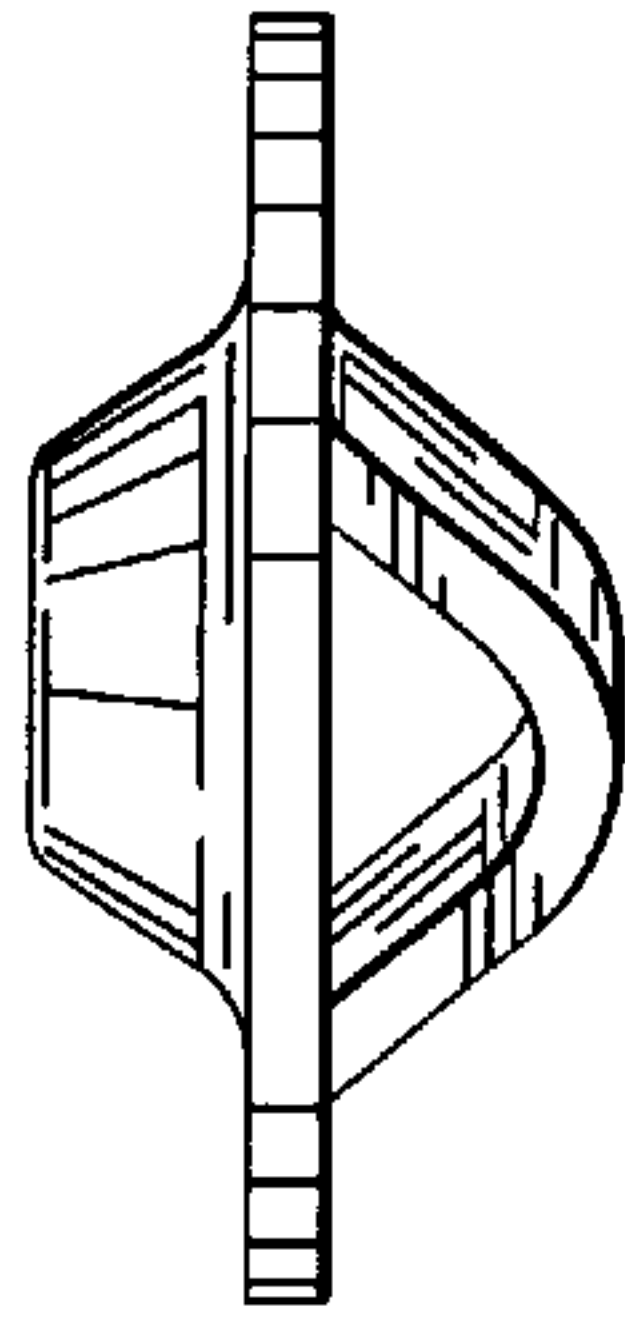

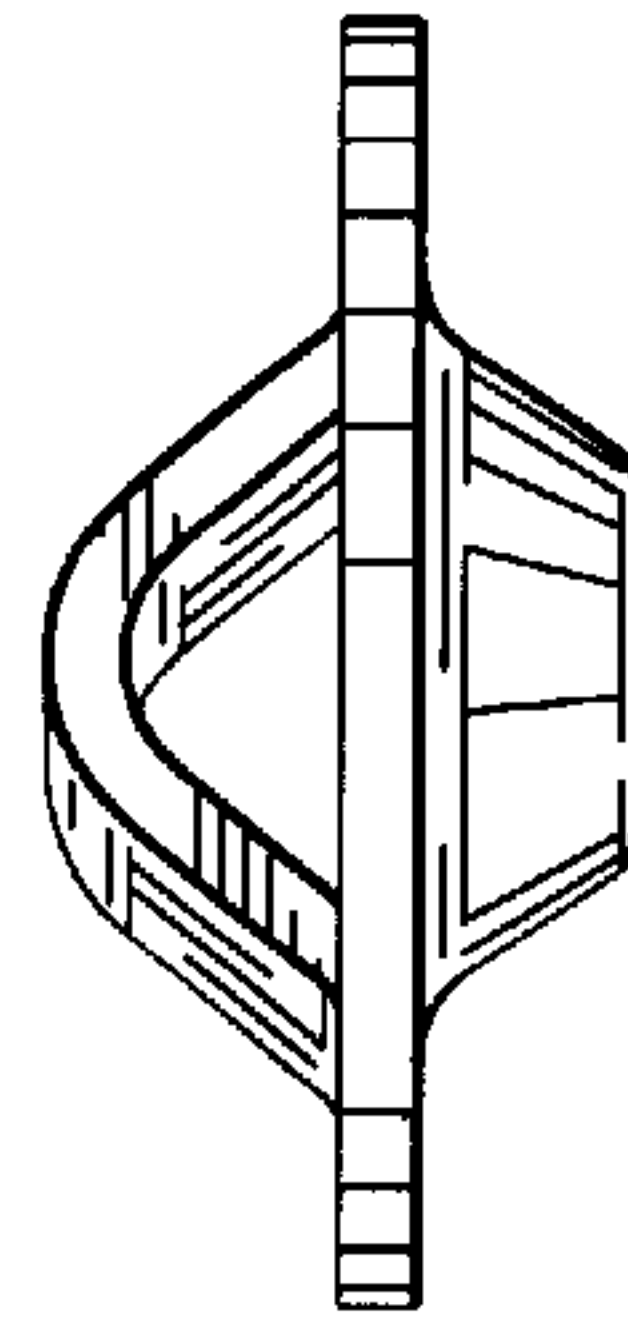

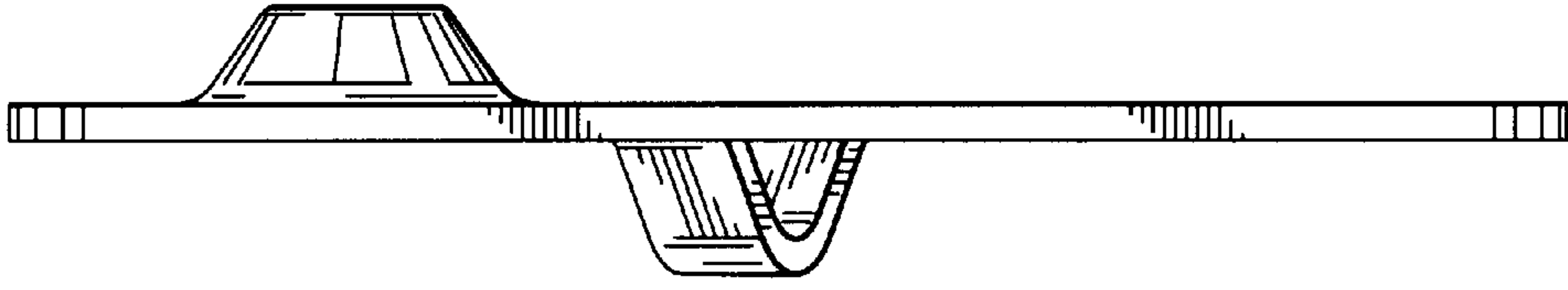

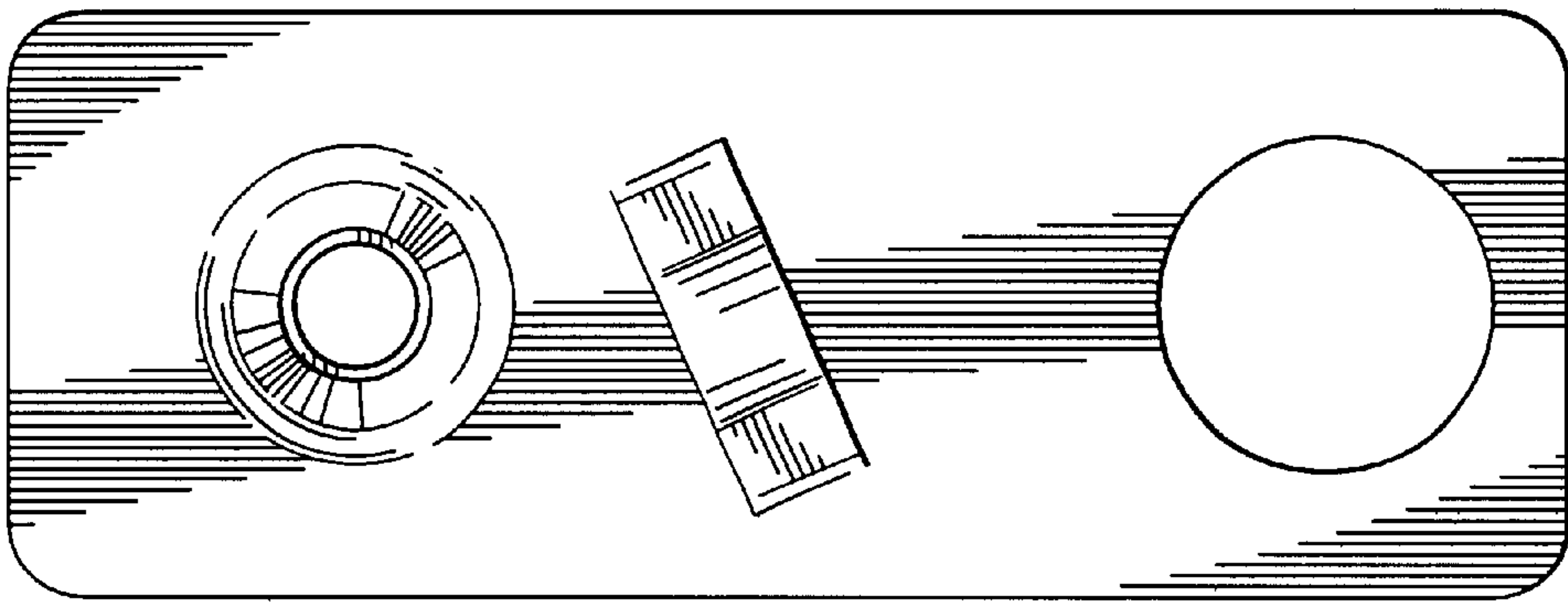

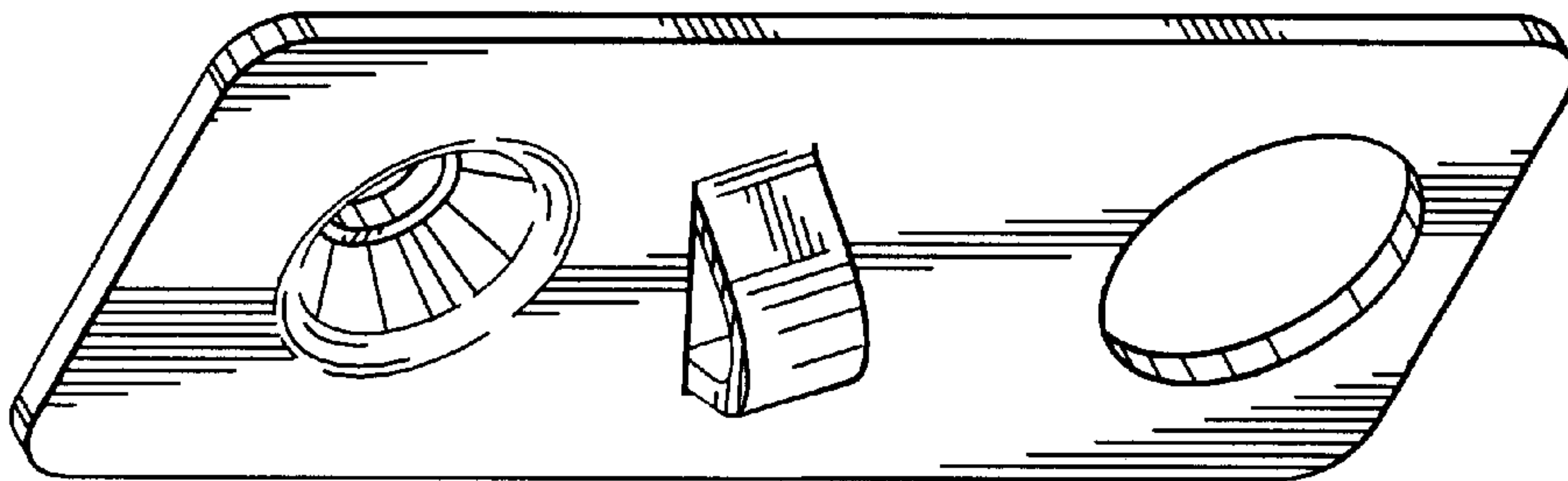

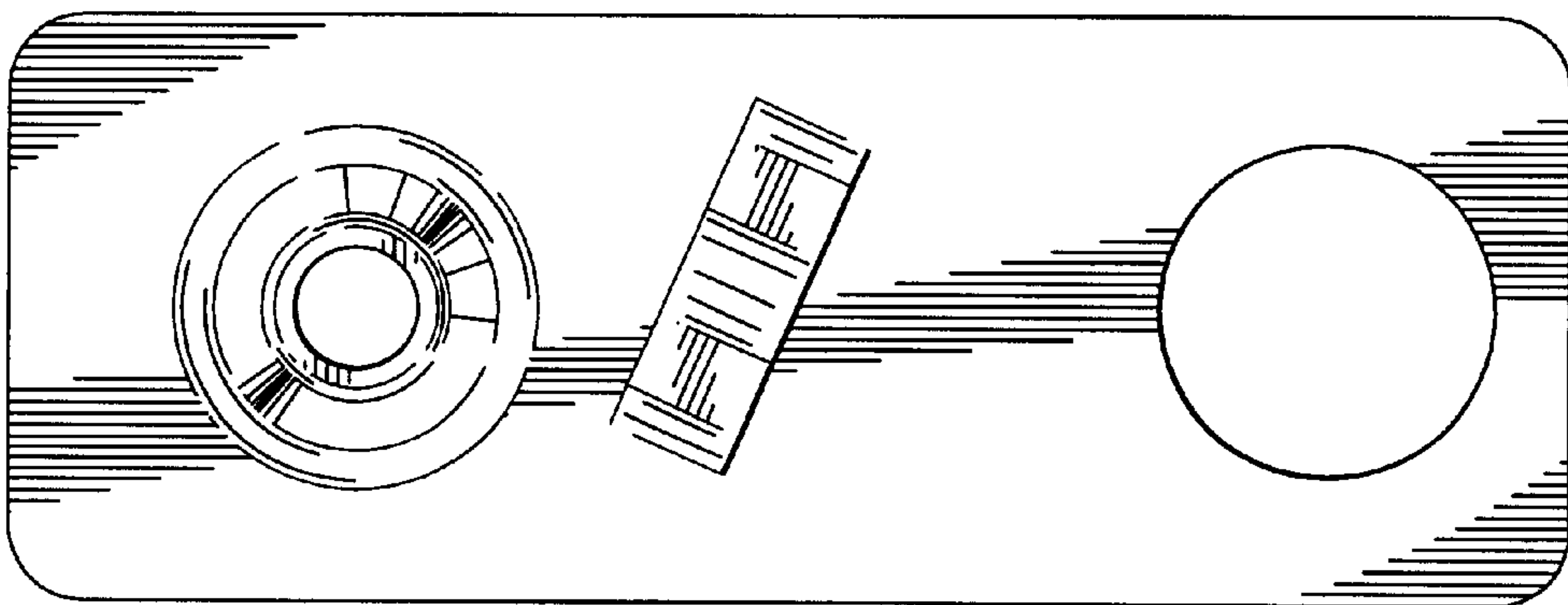

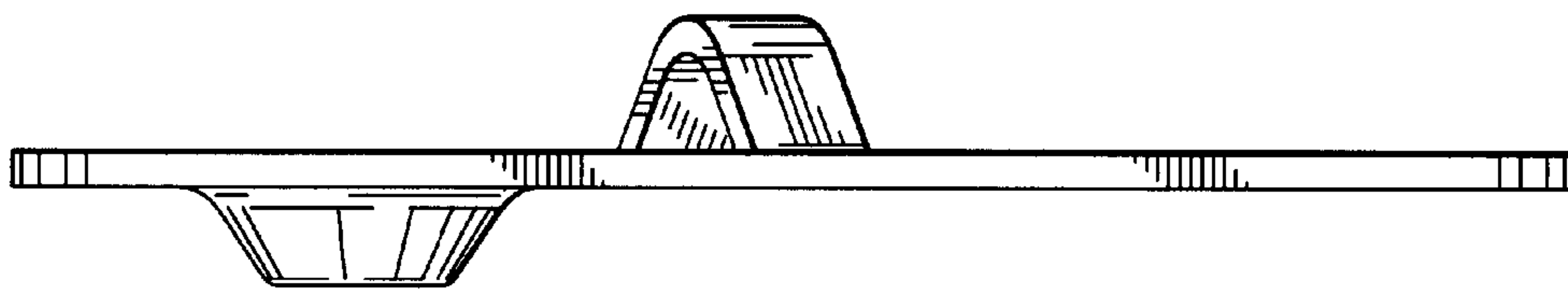

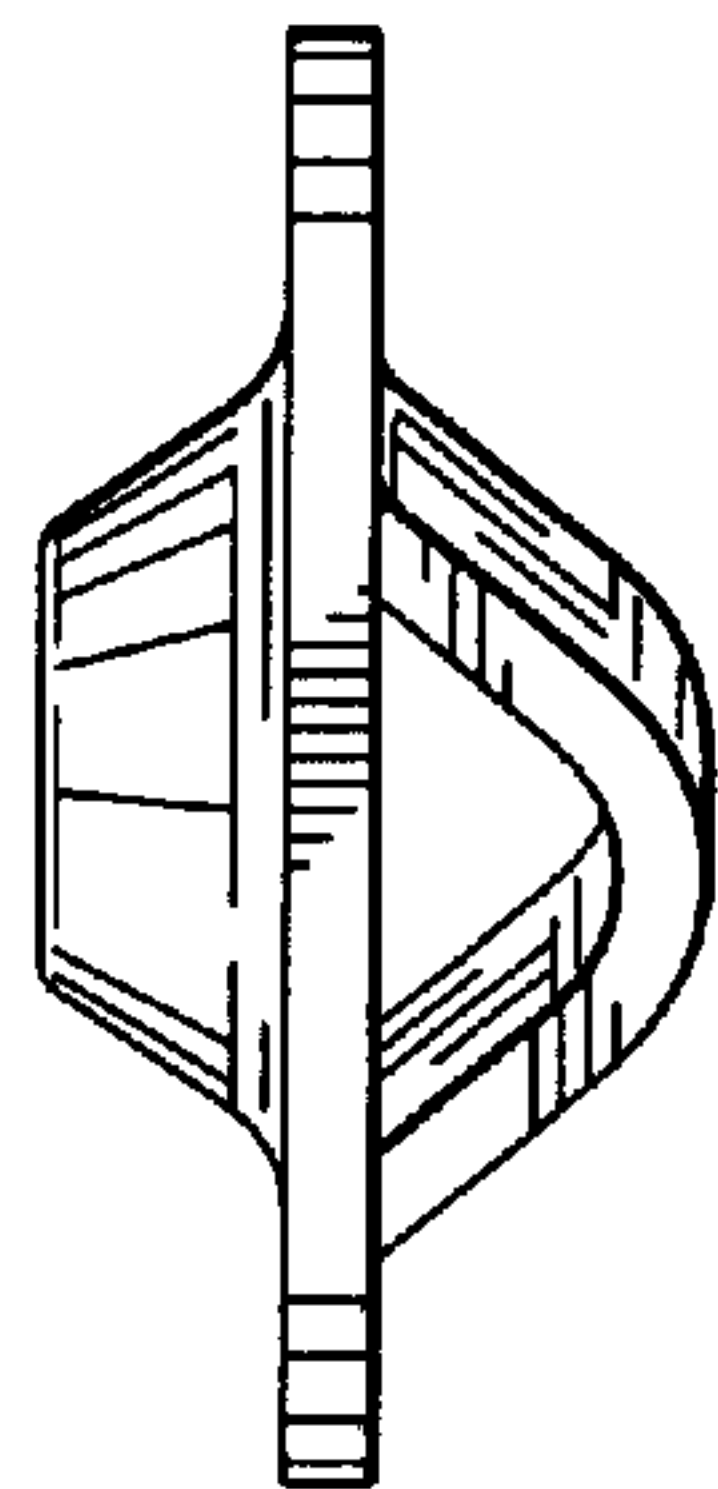

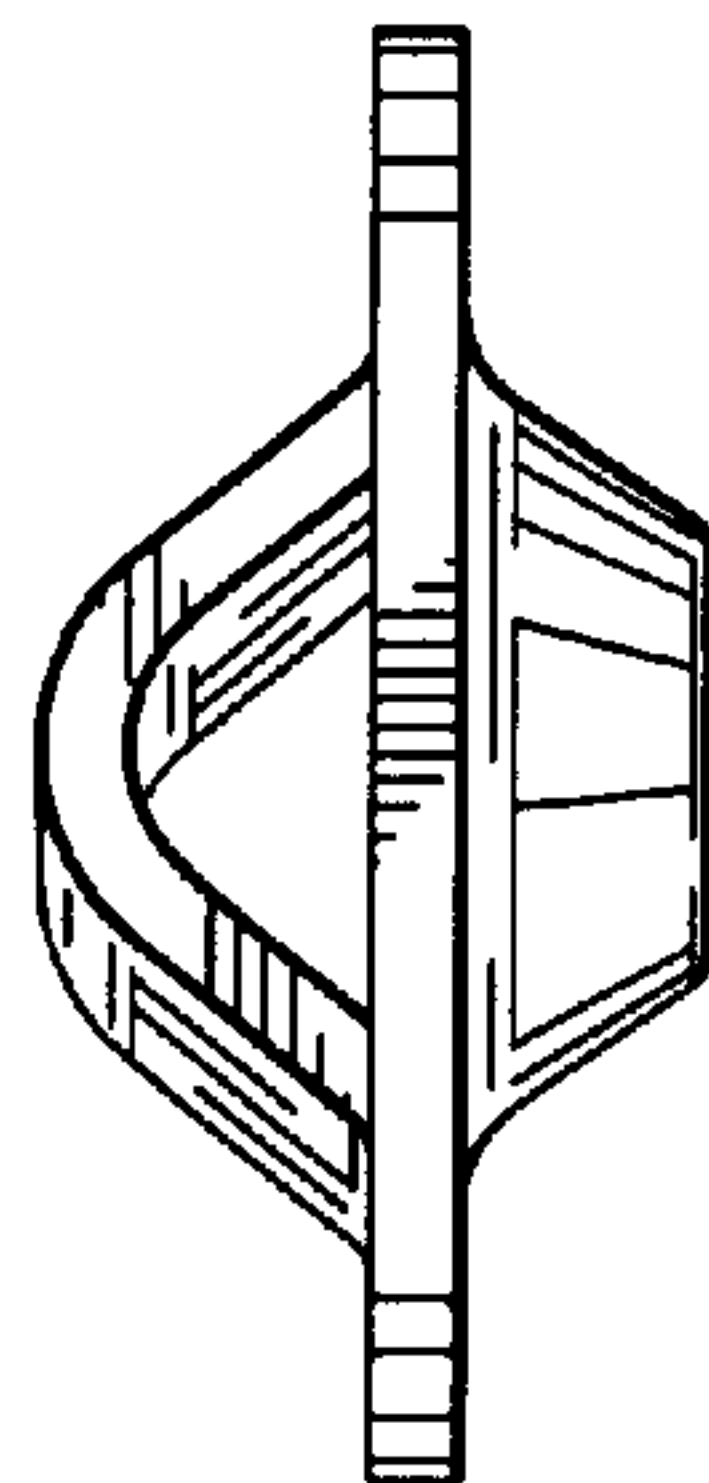
