The ornamental design for a telephone with display, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a telephone with the handset in the base;

FIG. 2 is a perspective view of the telephone with the handset removed from the base;

FIG. 3 is a top elevation view of the base;

FIG. 4 is a bottom elevation view of the base;

FIG. 5 is a right side elevation view of the base;

FIG. 6 is a left side elevation view of the base;

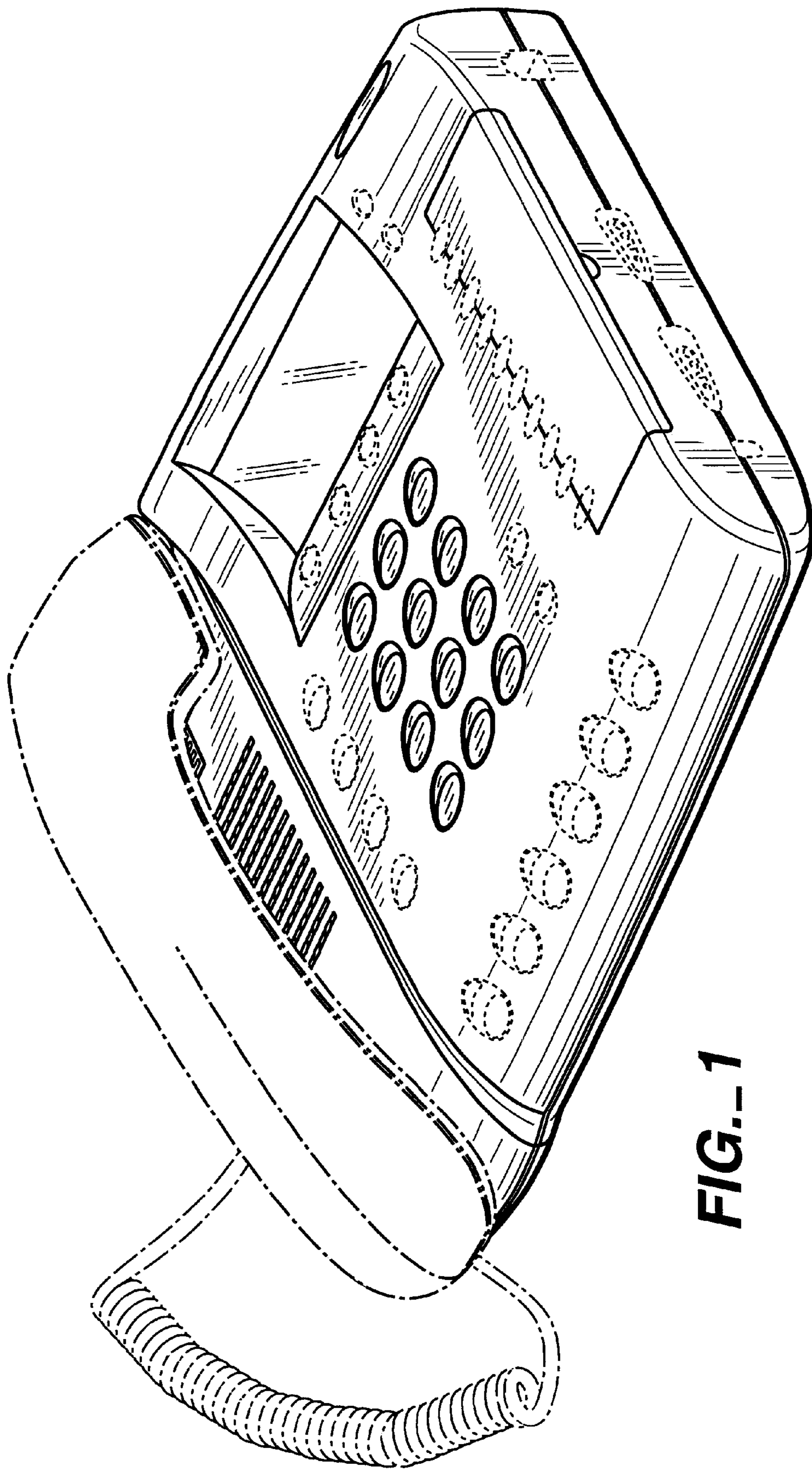
FIG. 7 is a back elevation view of the base; and,

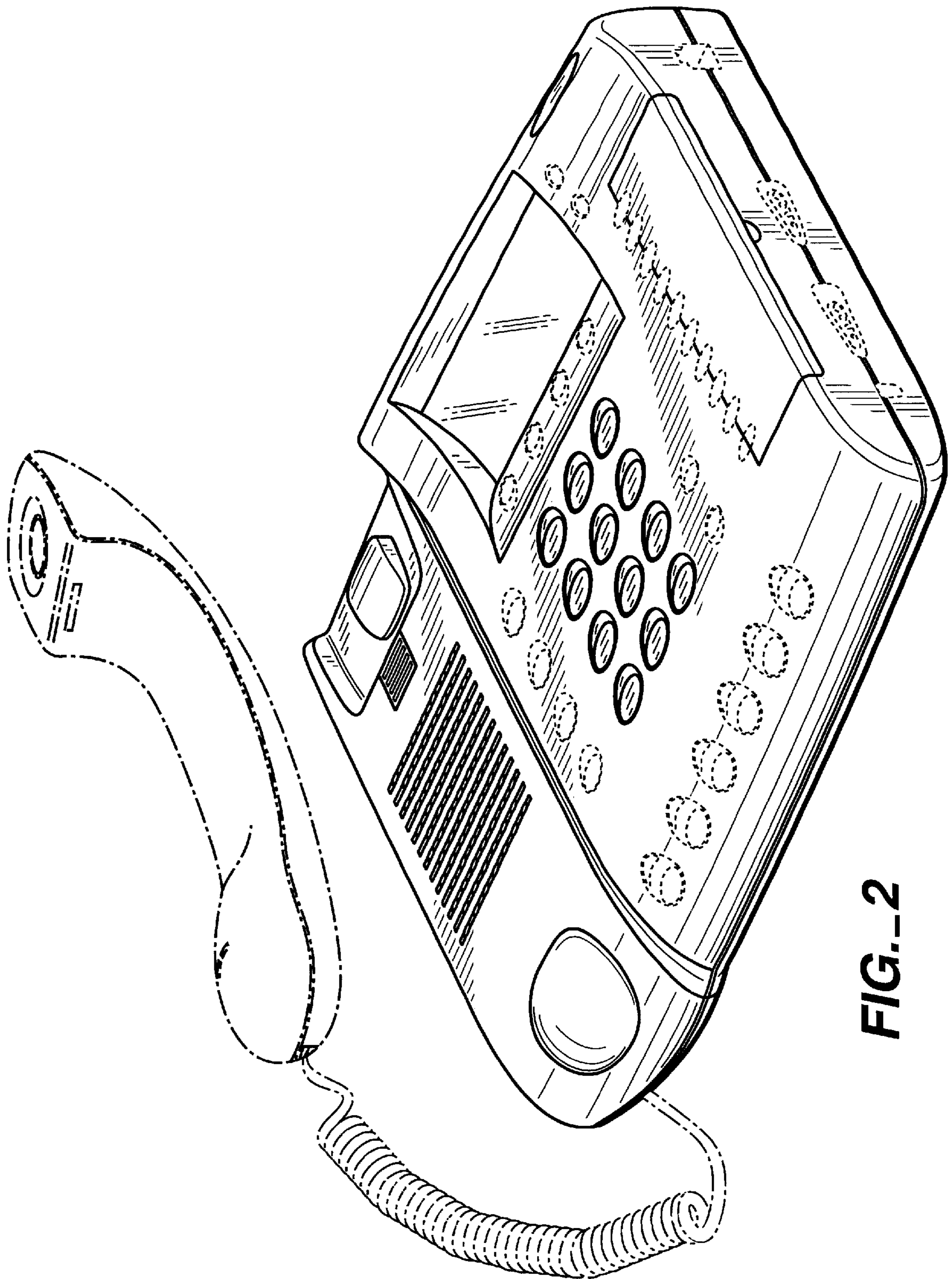

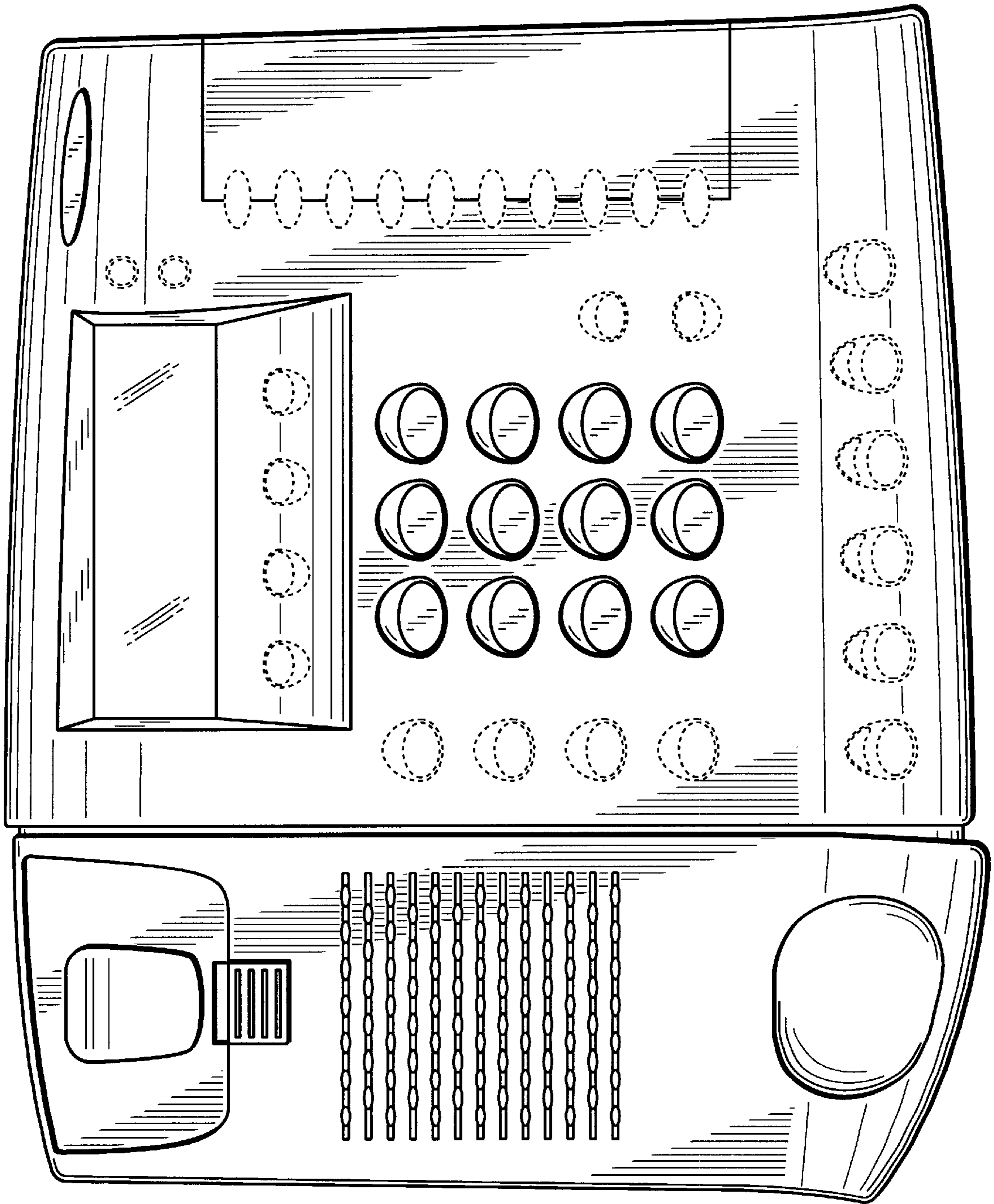
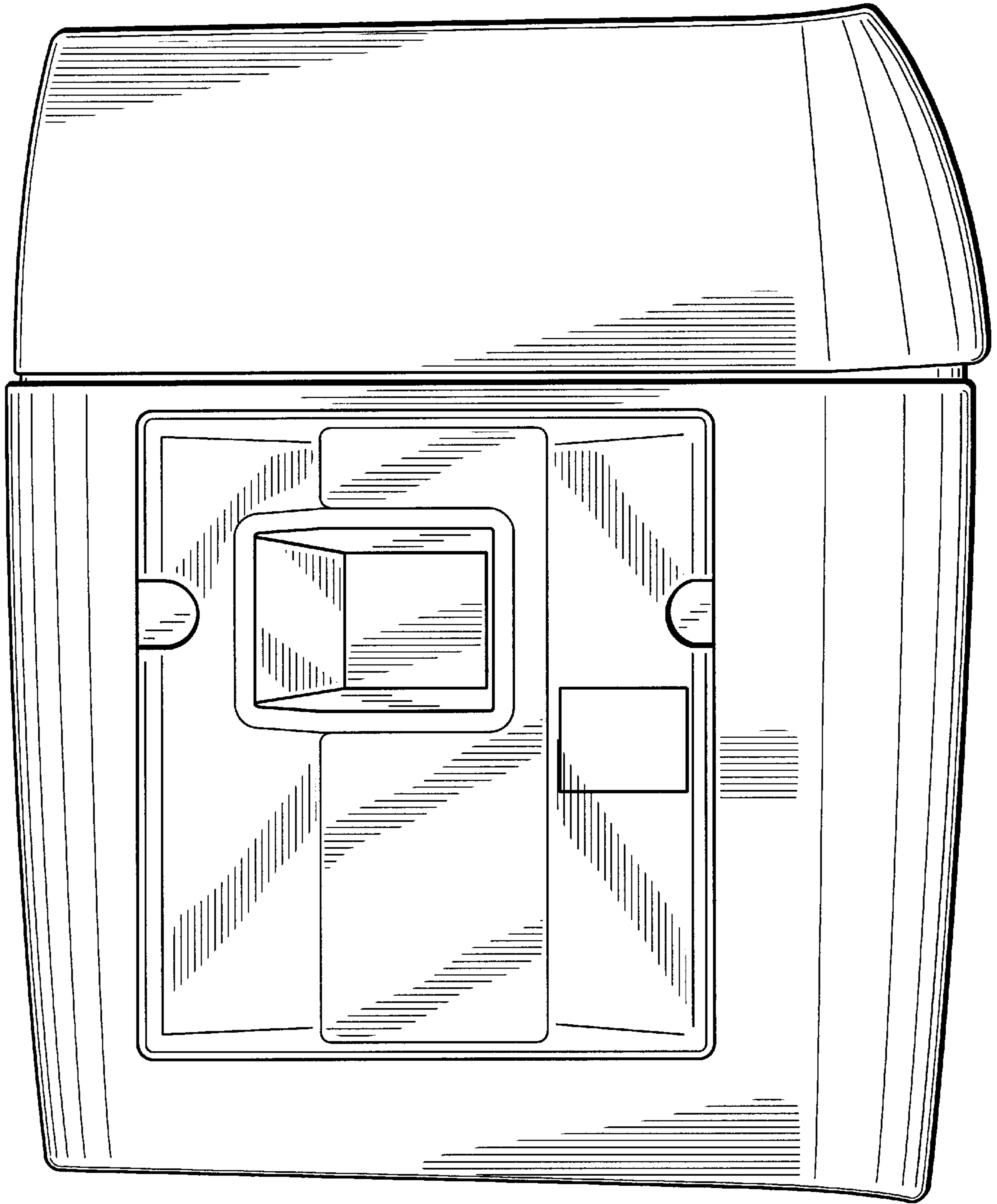
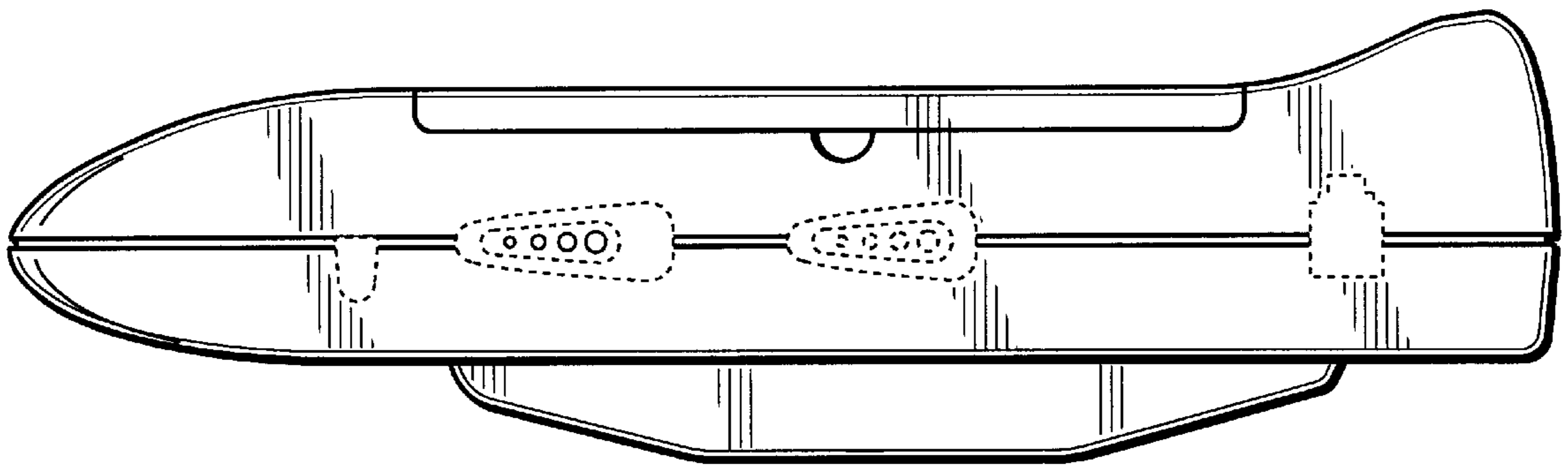


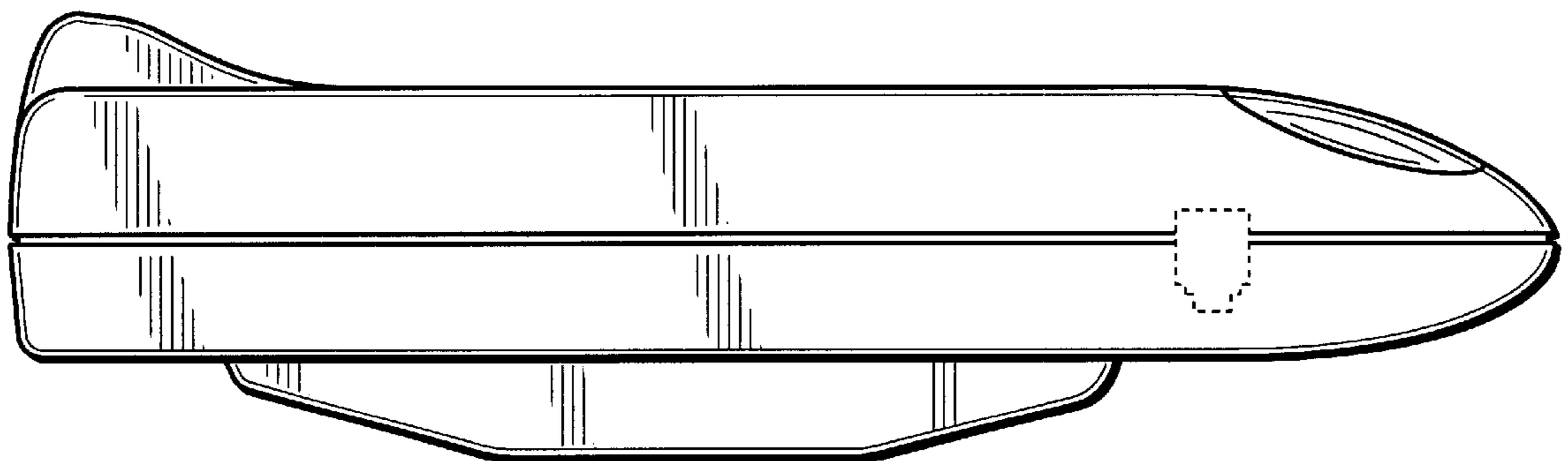

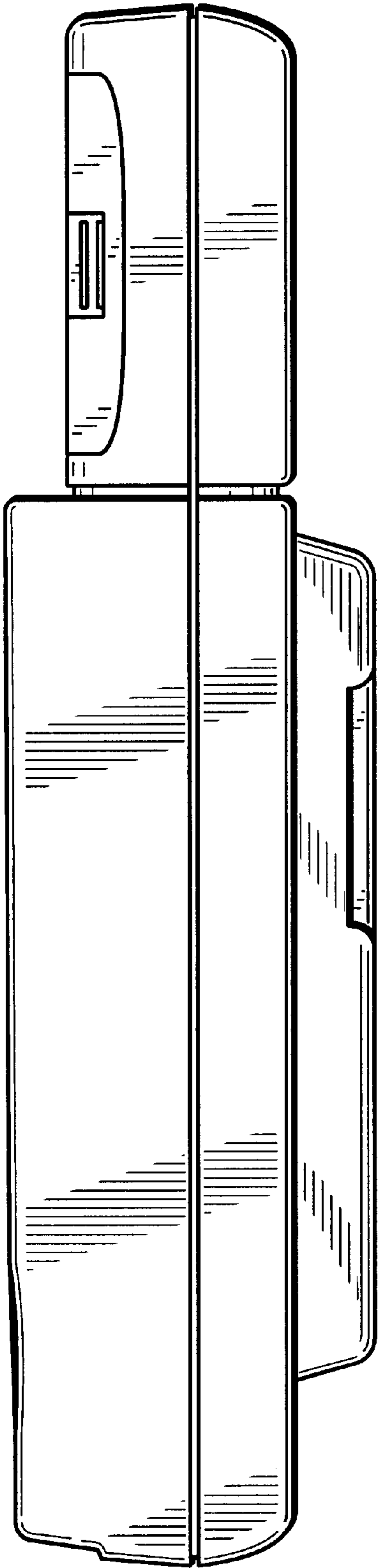

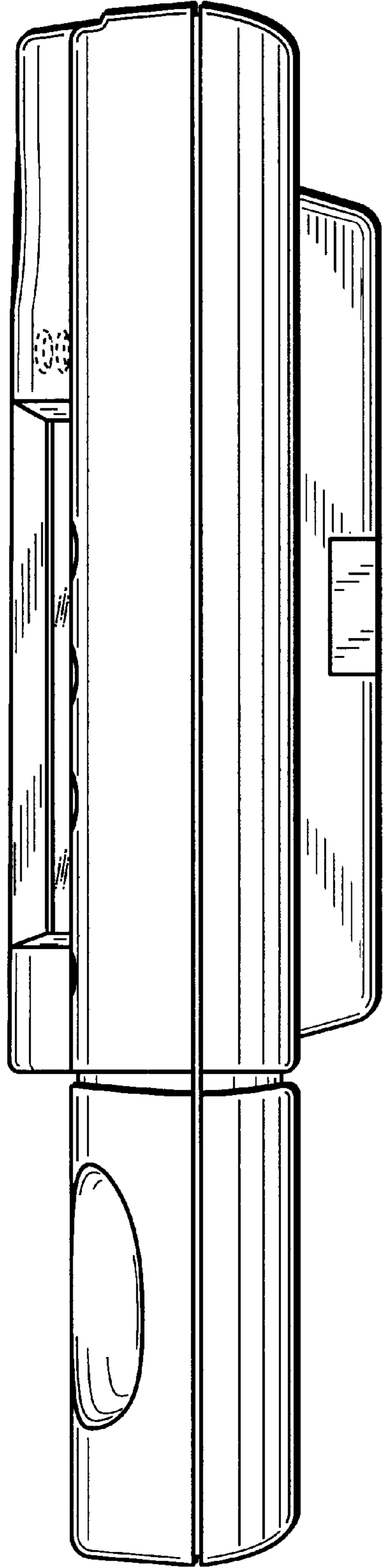
