The ornamental design for an arm toy, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the arm toy of the instant invention;

FIG. 2 is a top plan view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a front view thereof;

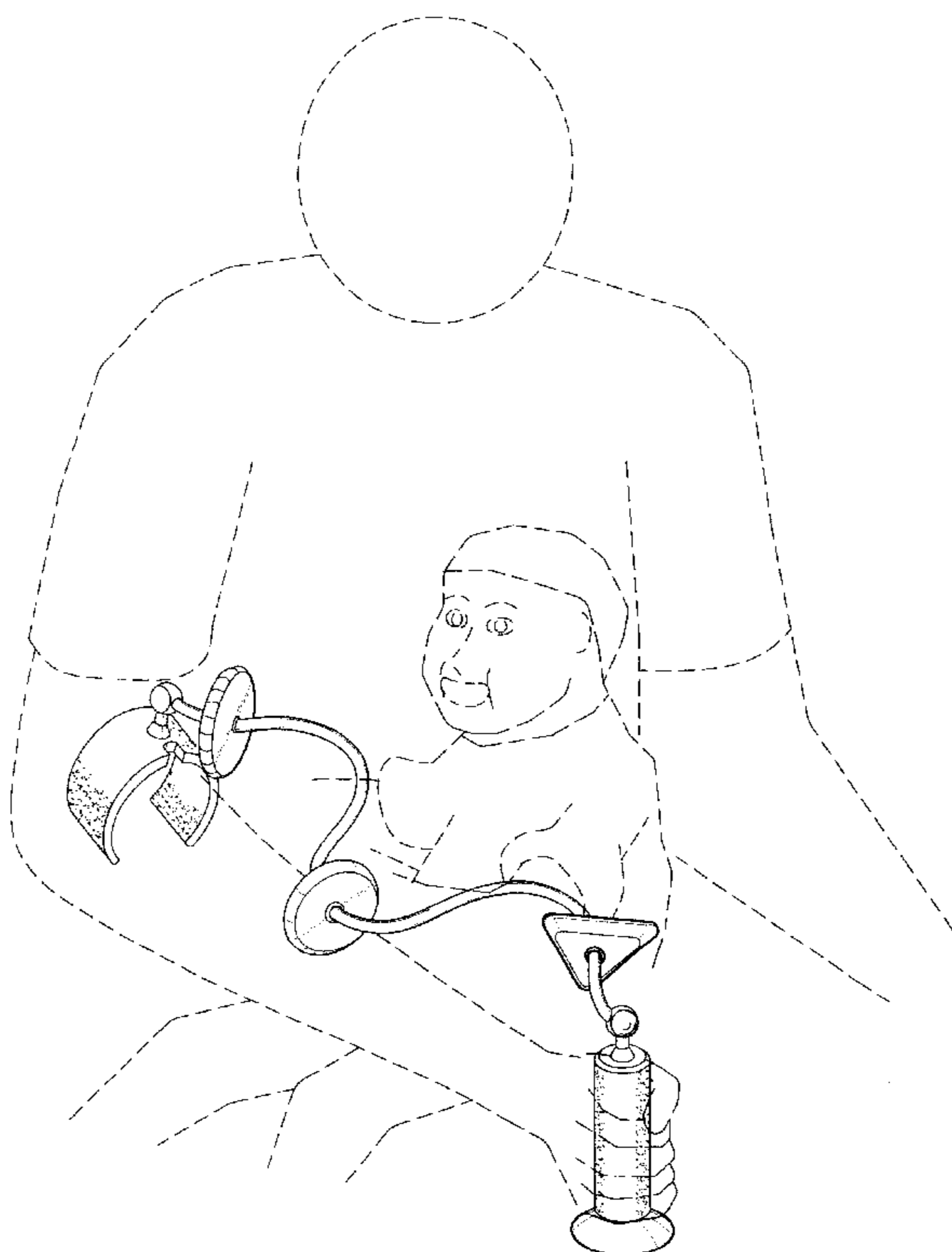
FIG. 7 is a rear view thereof;

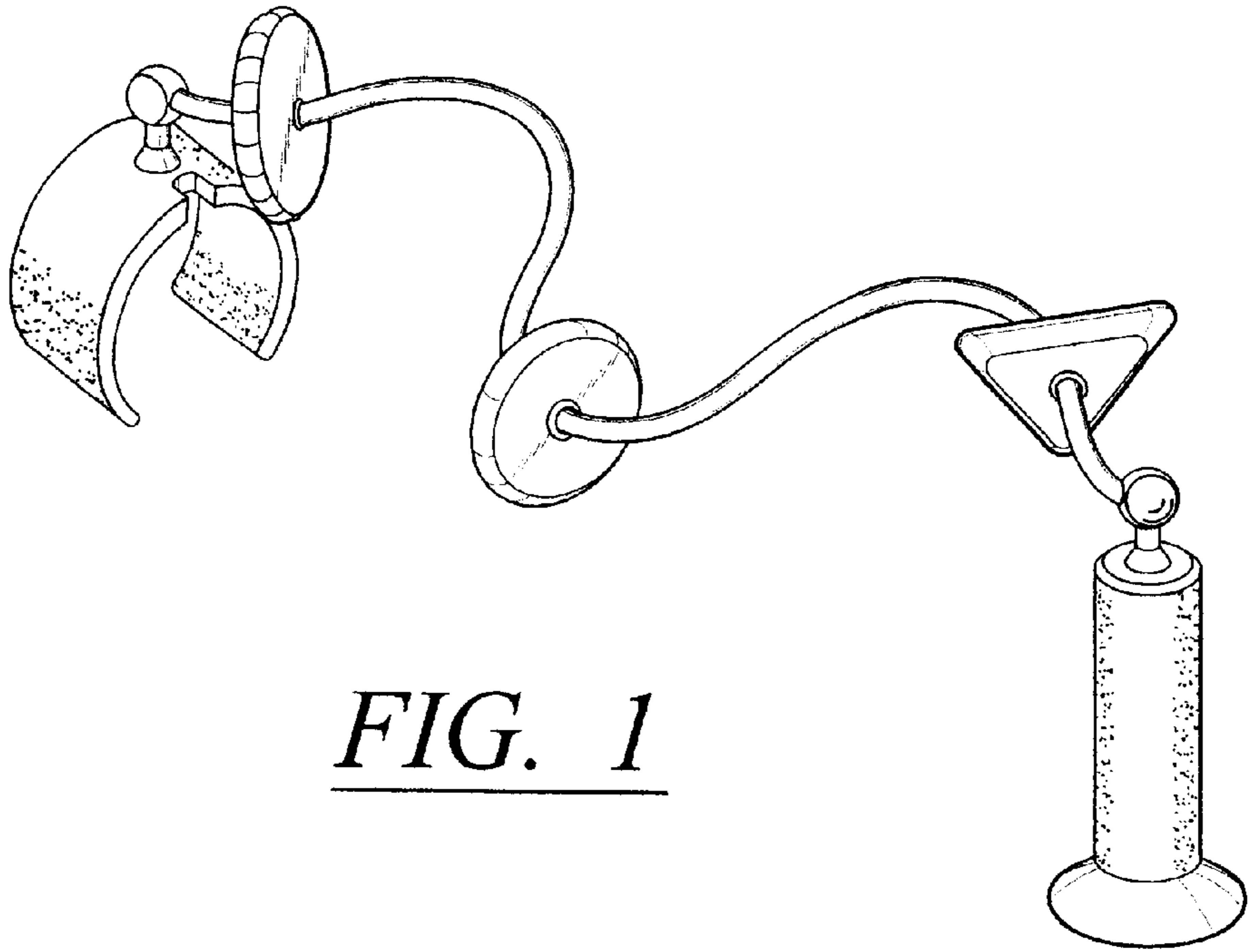

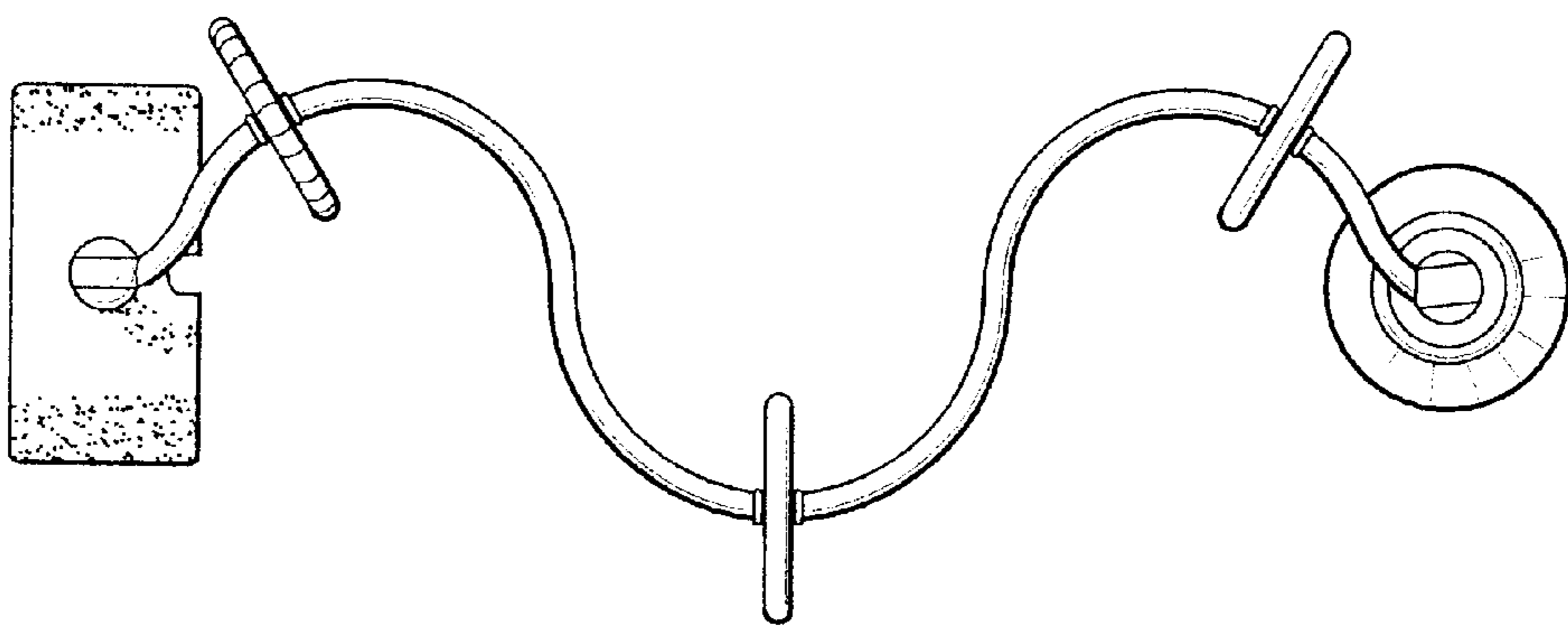

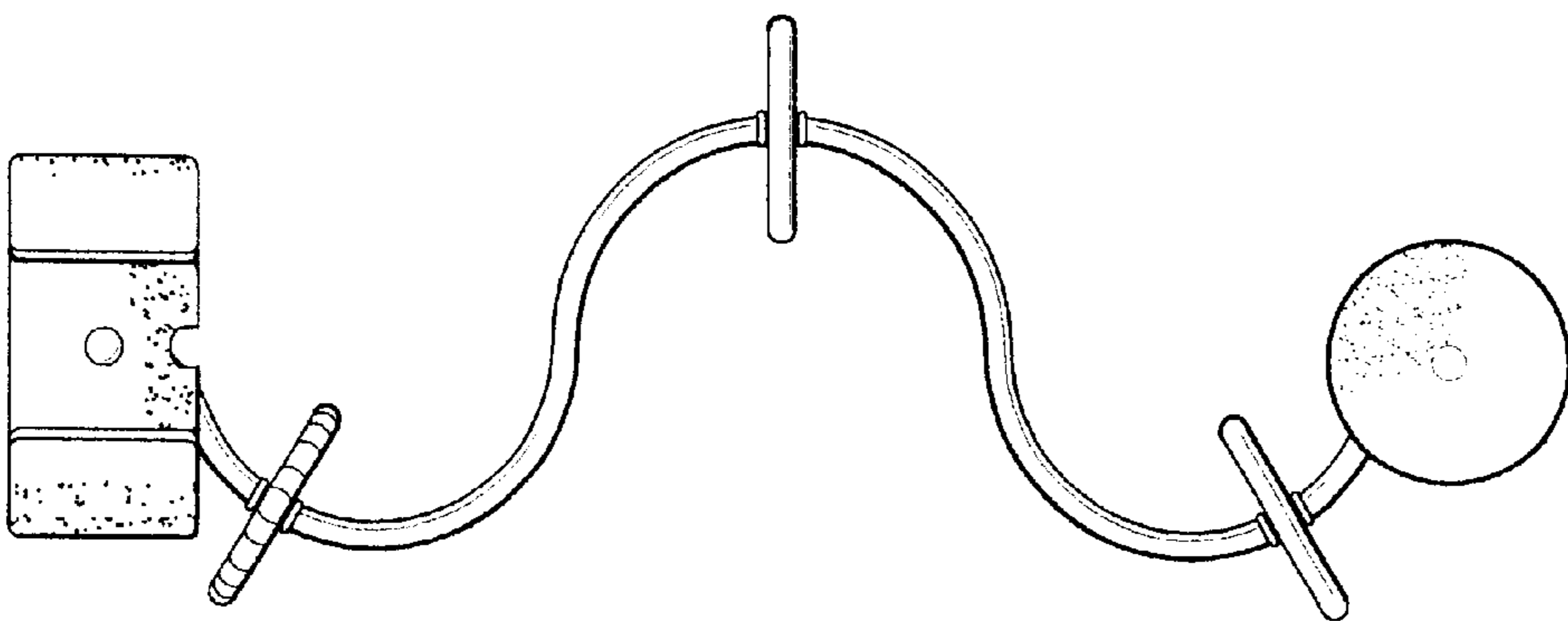

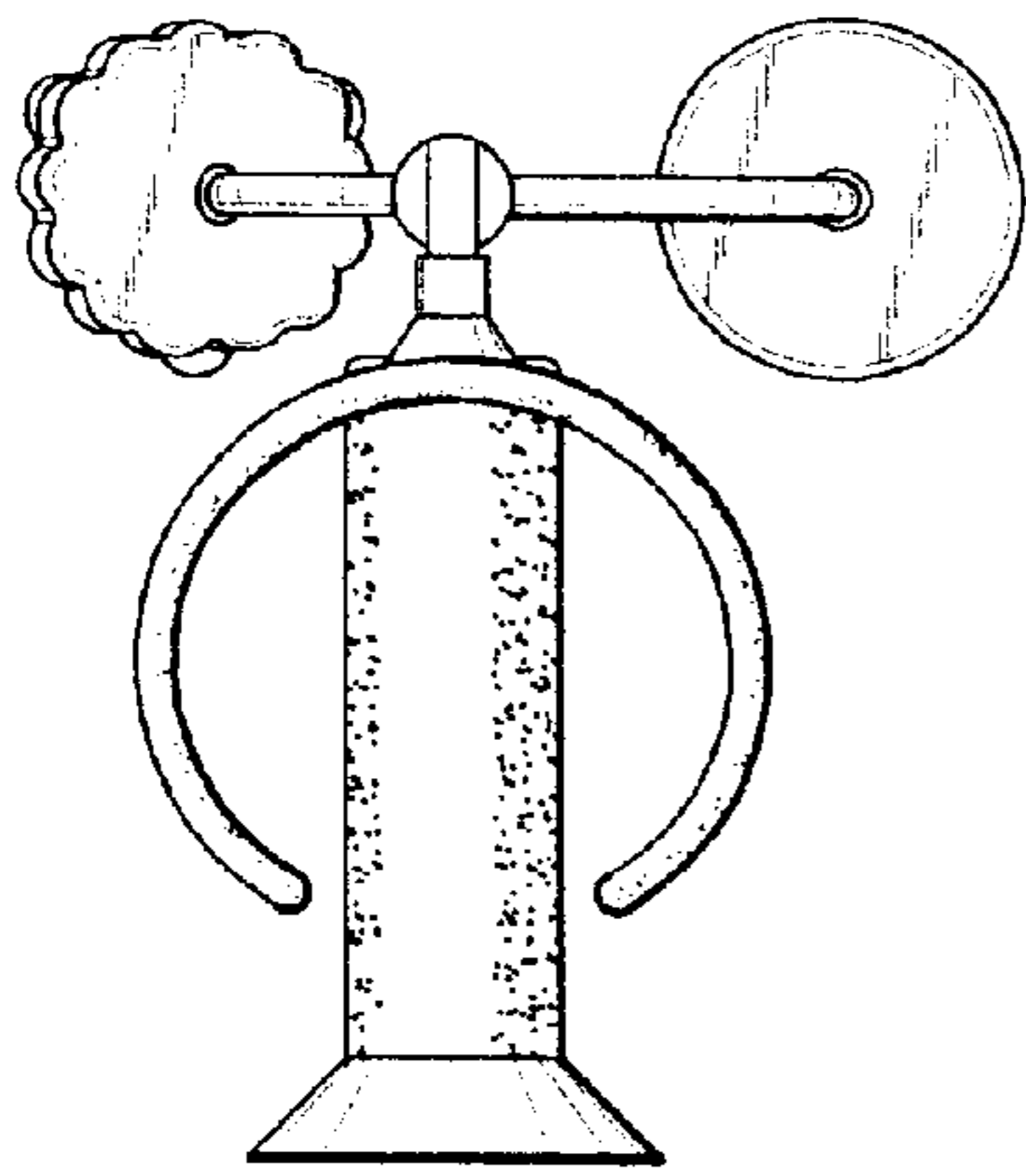

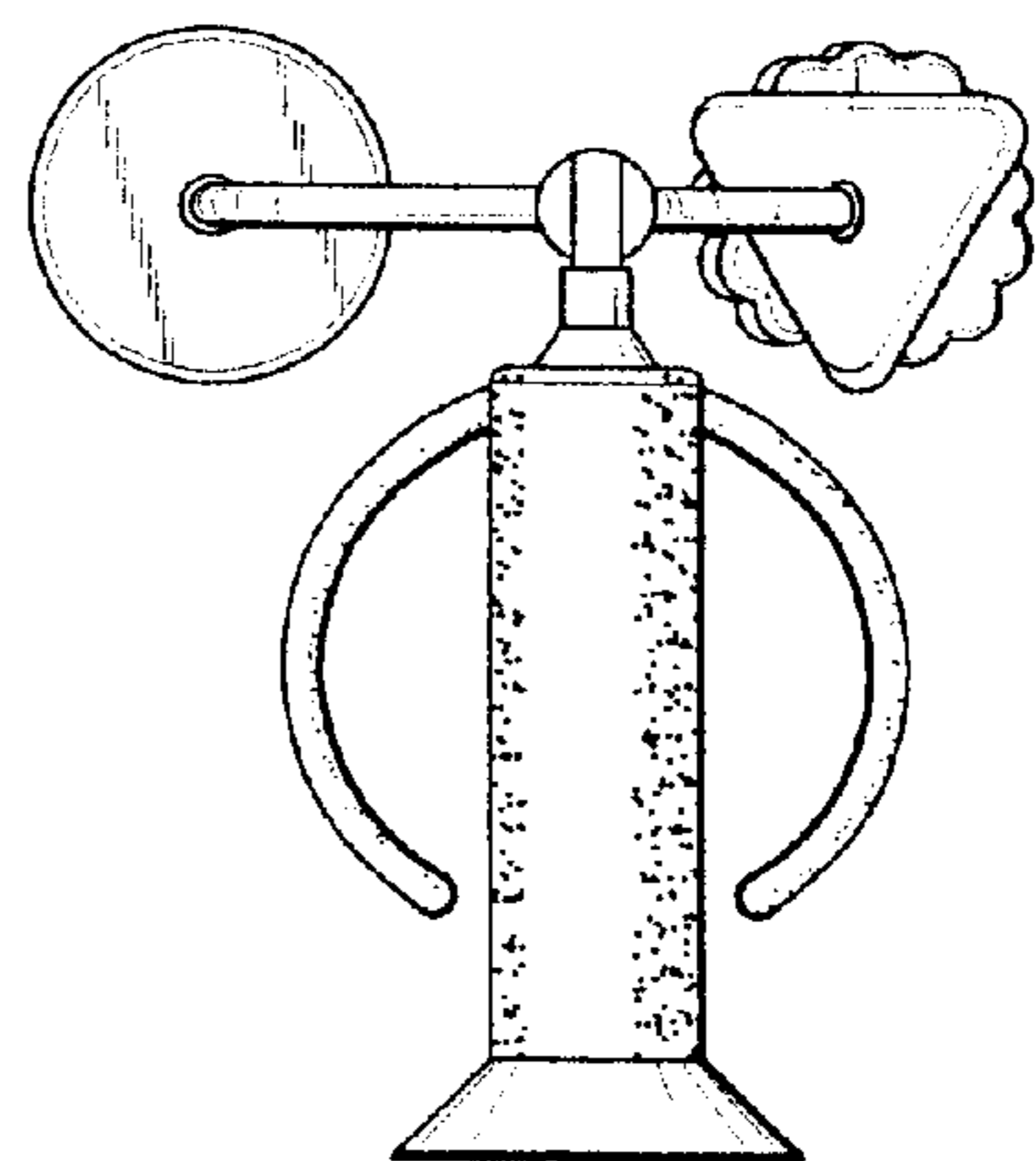

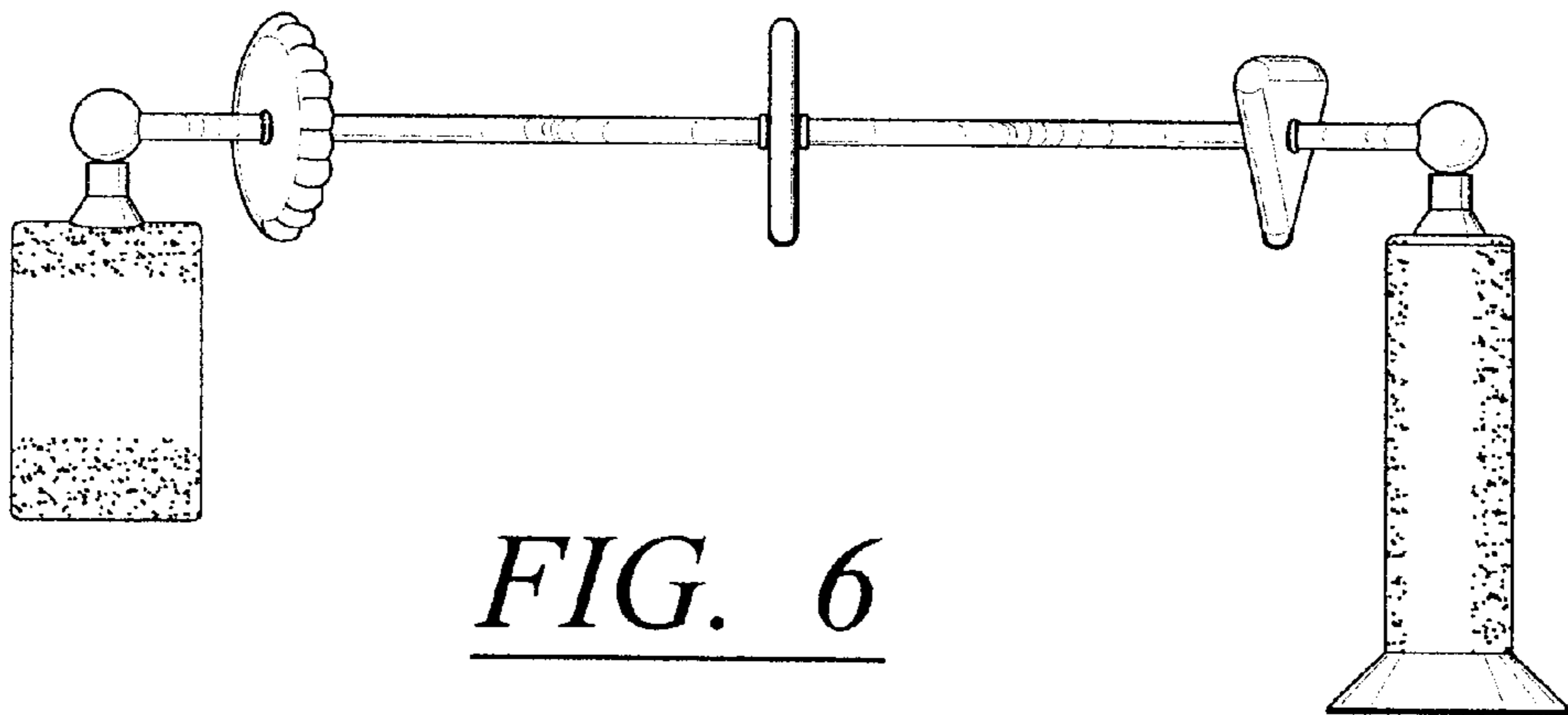

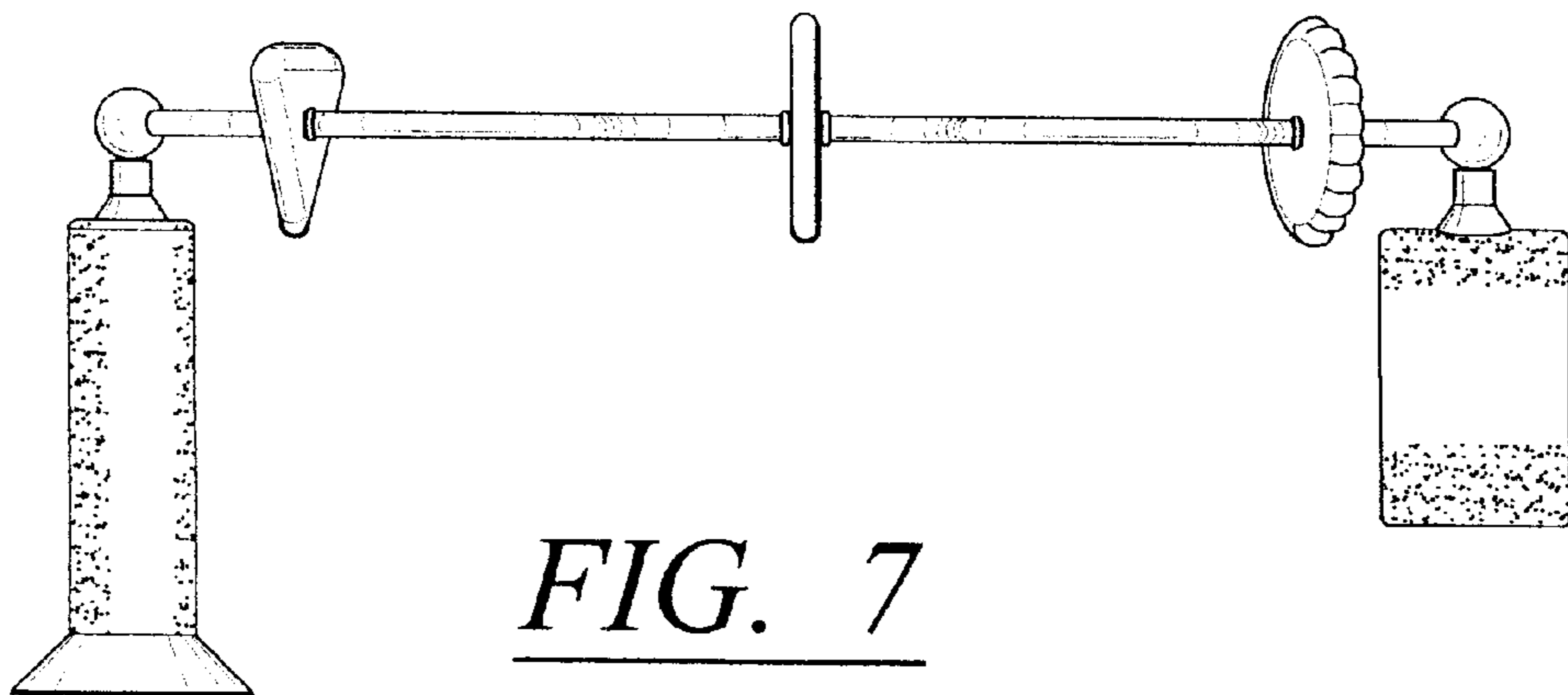

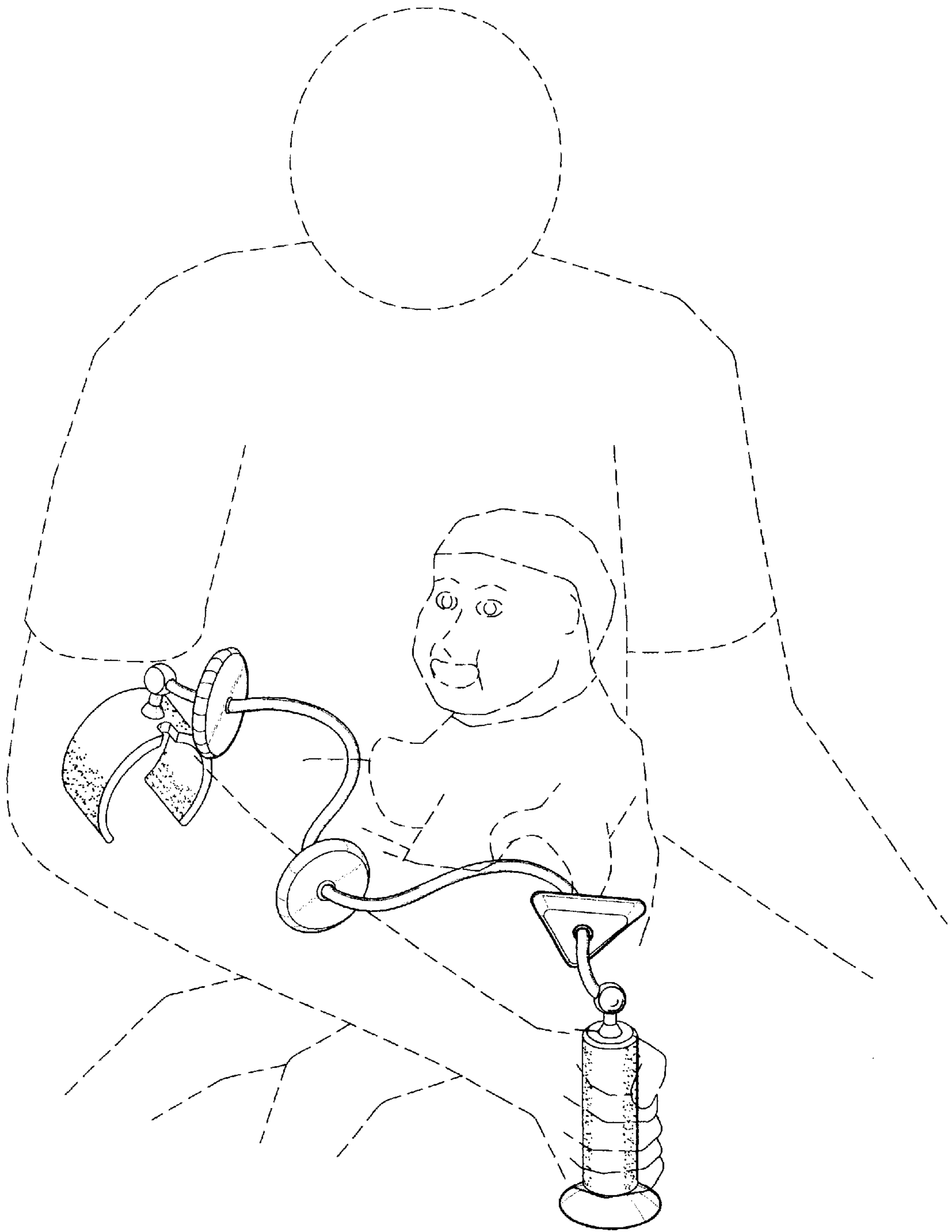

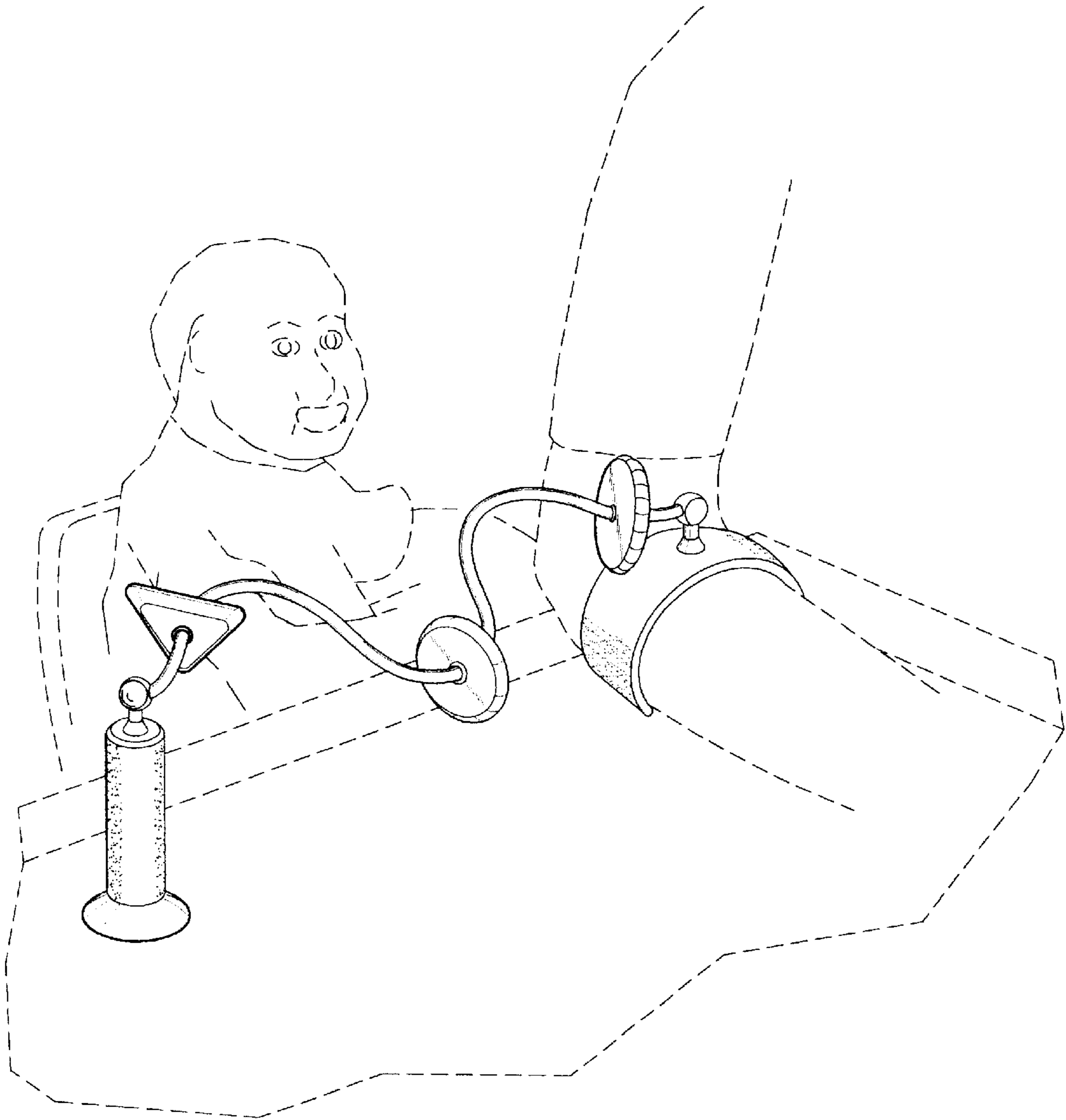
