The ornamental design for a luminaire, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom perspective view of the luminaire in accordance with an embodiment of the design;

FIG. 2 is a front elevational view of the luminaire illustrated in FIG. 1;

FIG. 3 is a rear elevational view of the luminaire illustrated in FIGS. 1-2;

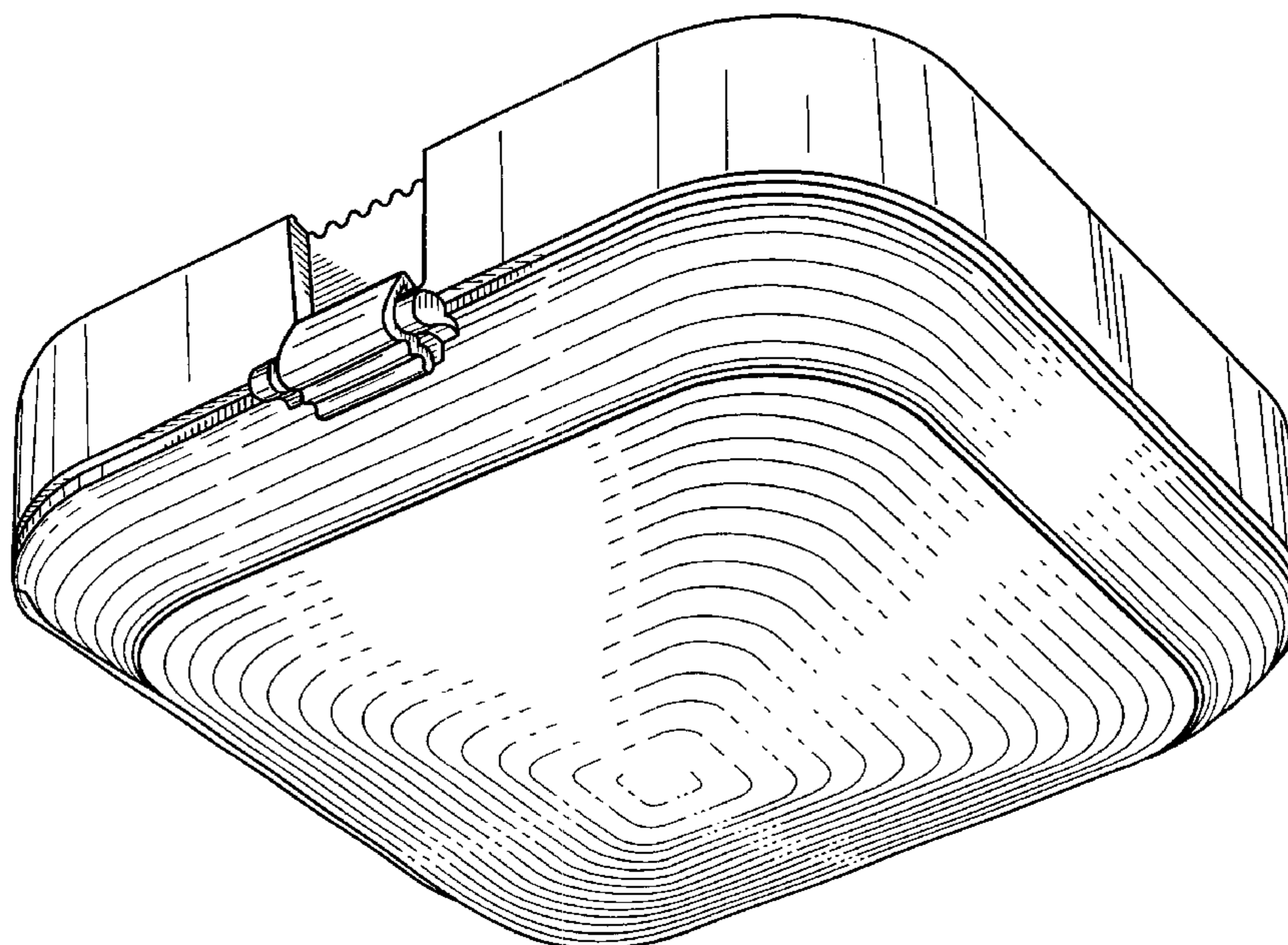
FIG. 4 is a left side elevational view of the luminaire illustrated in FIGS. 1-3;

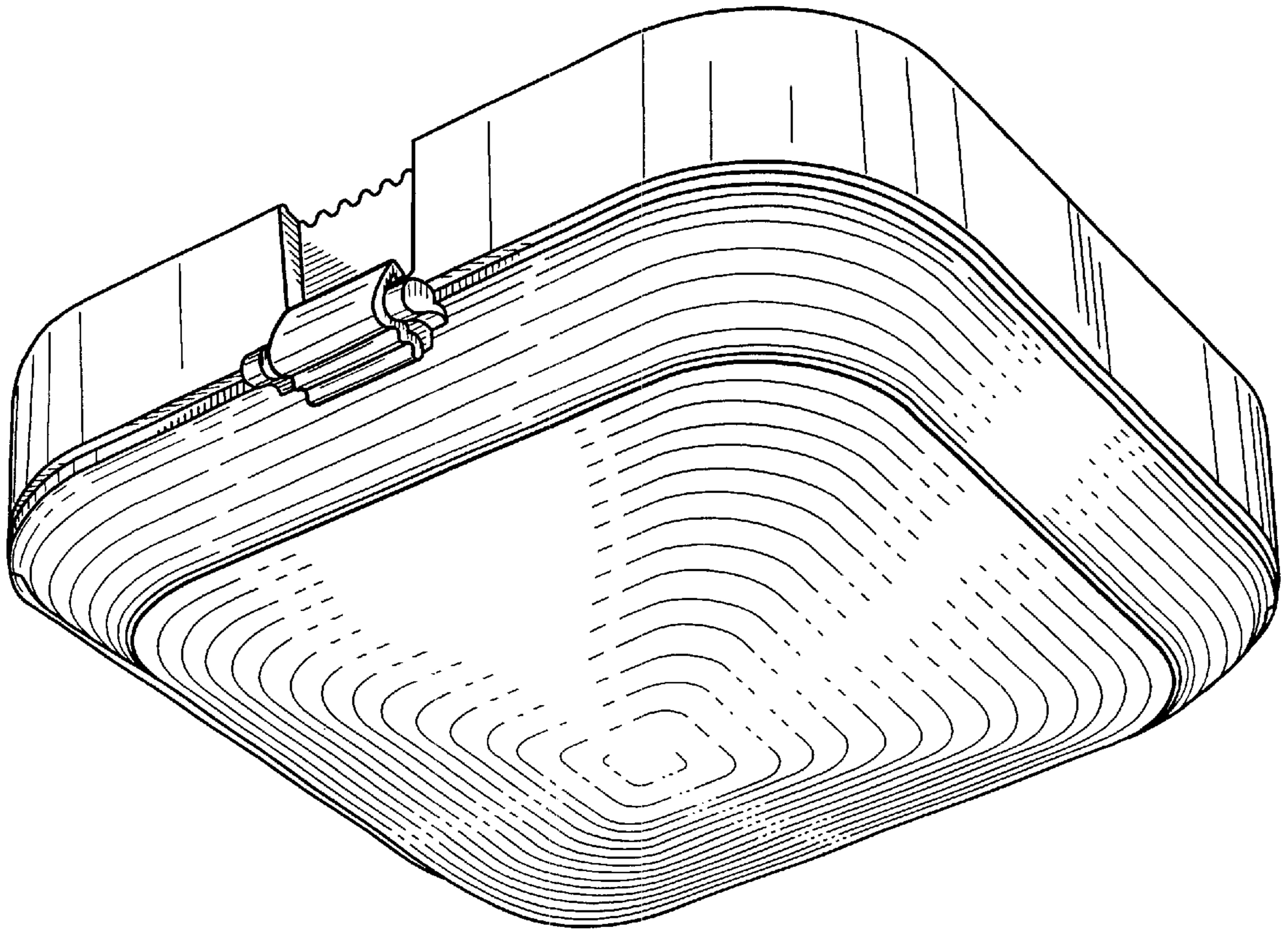

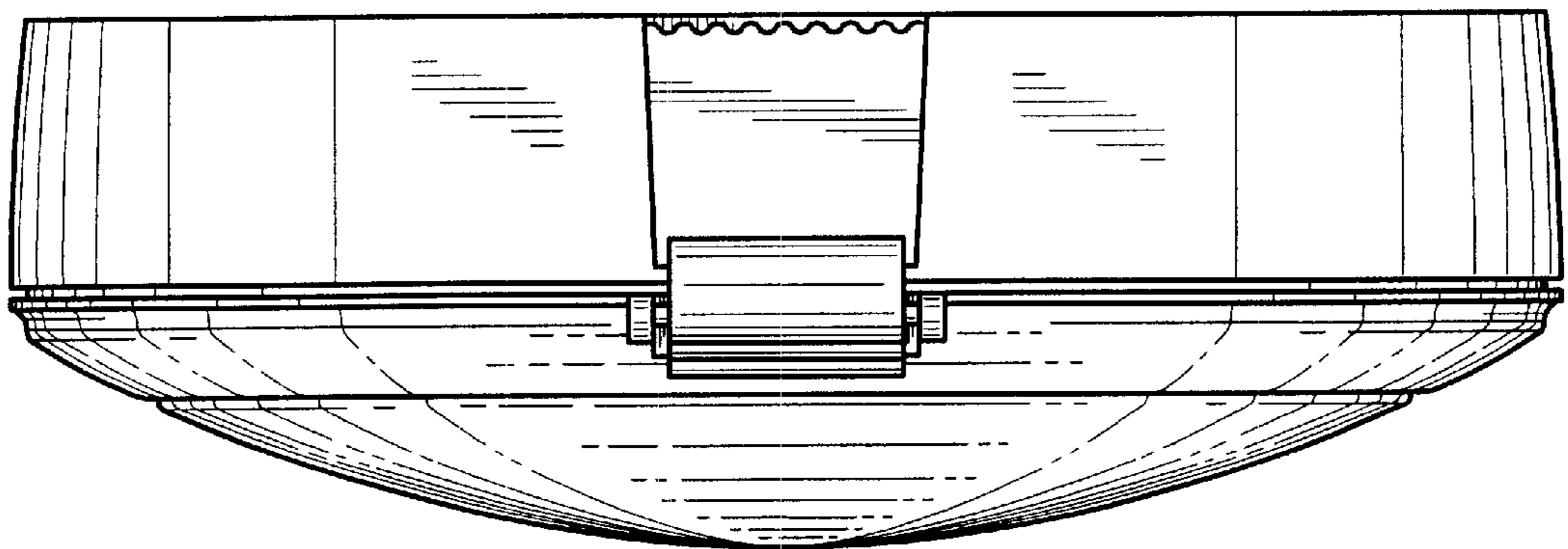

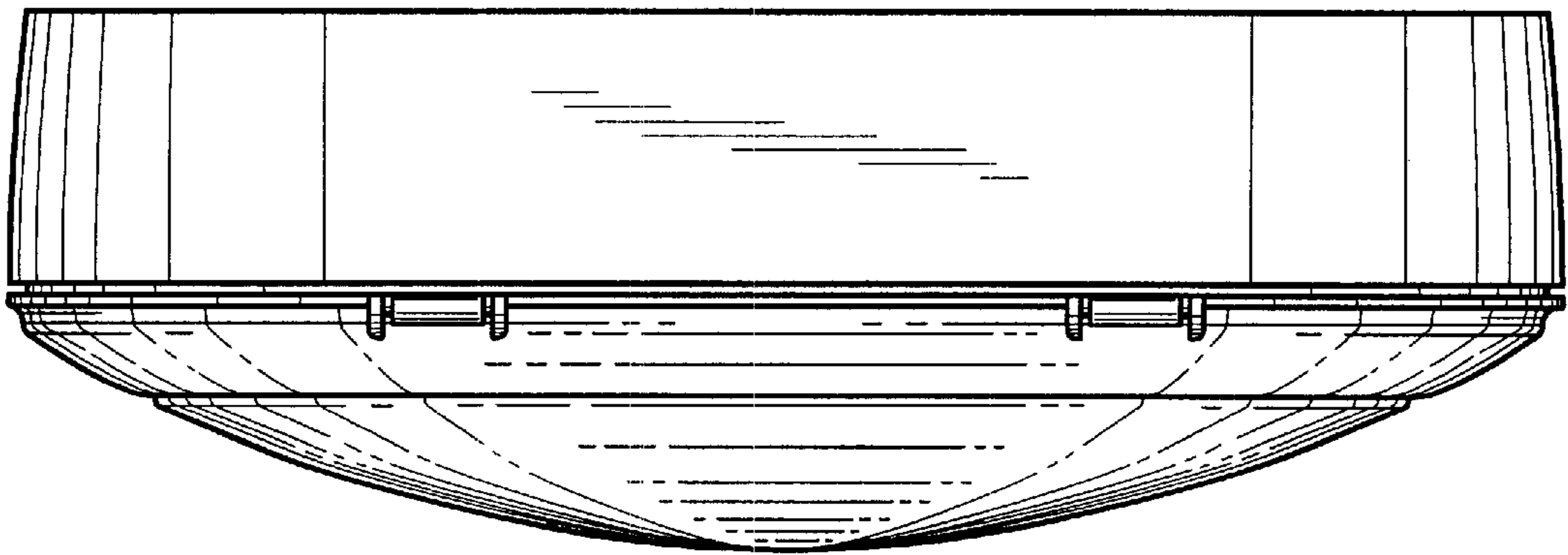

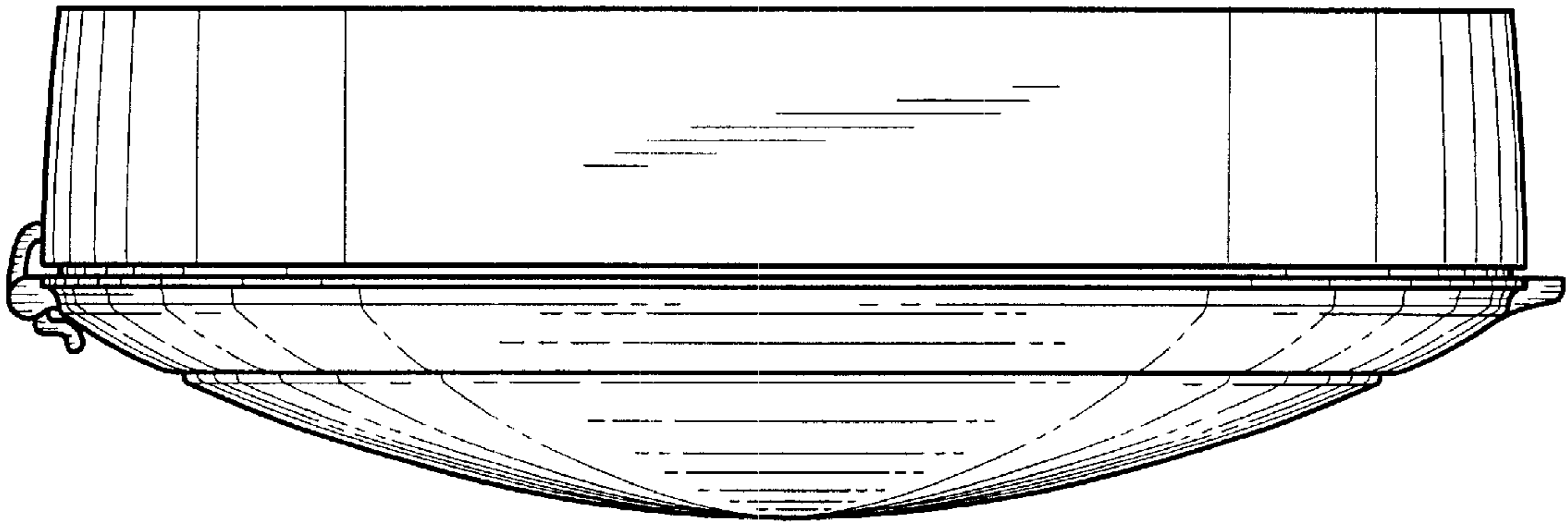

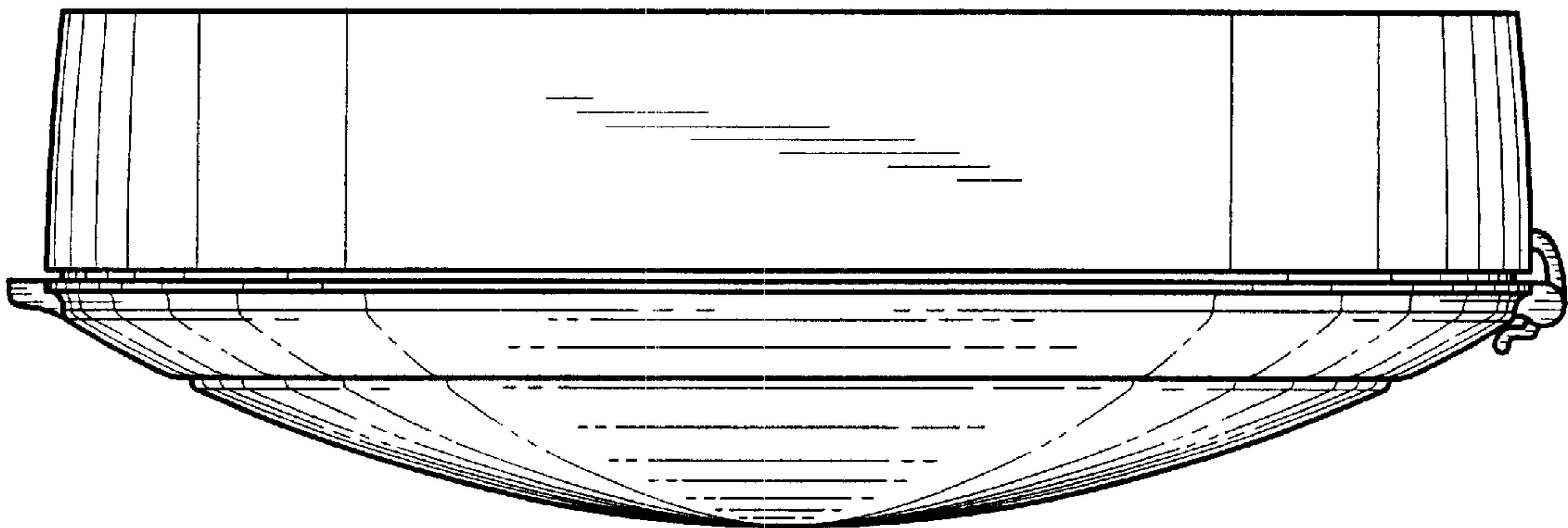

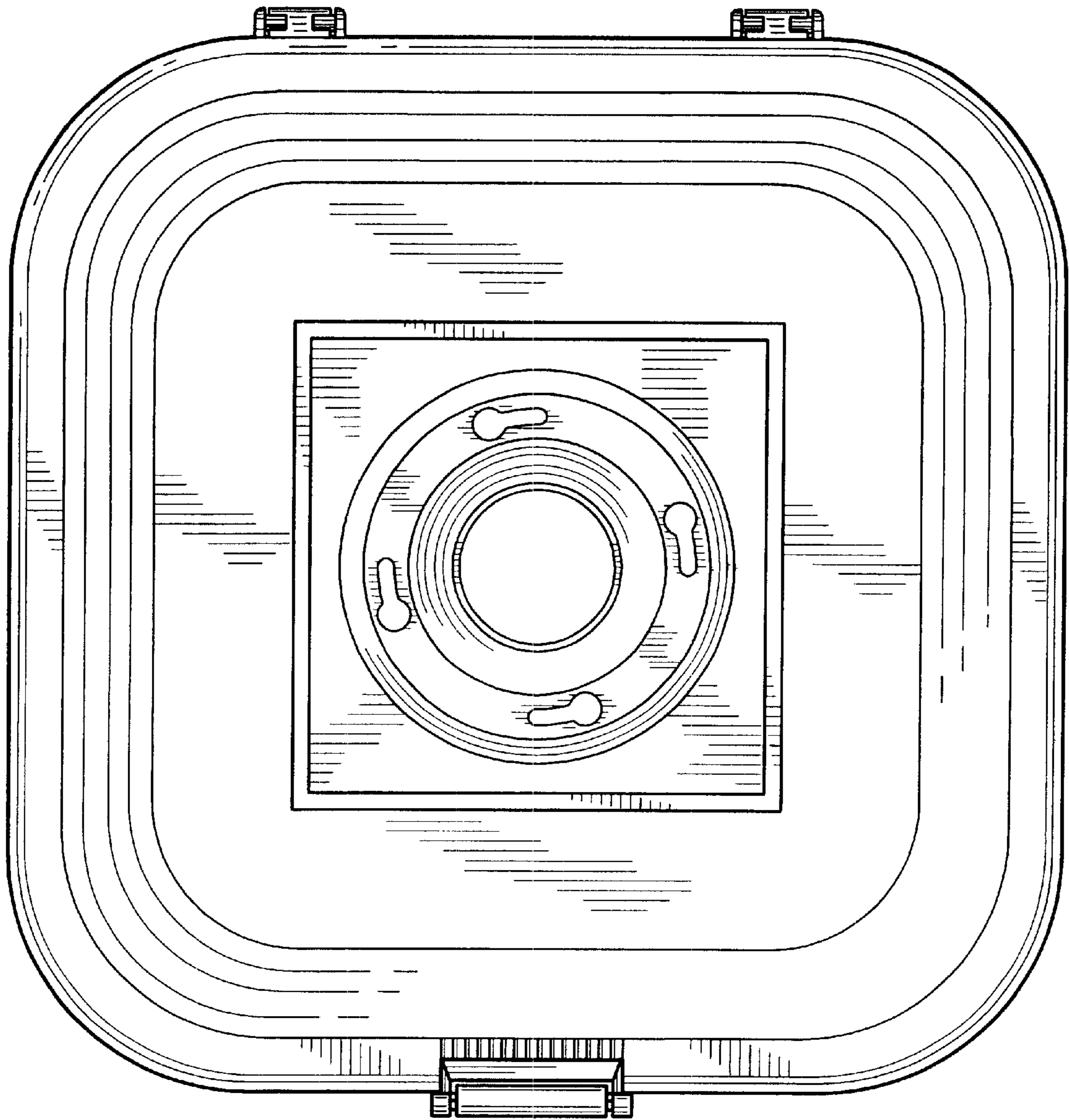

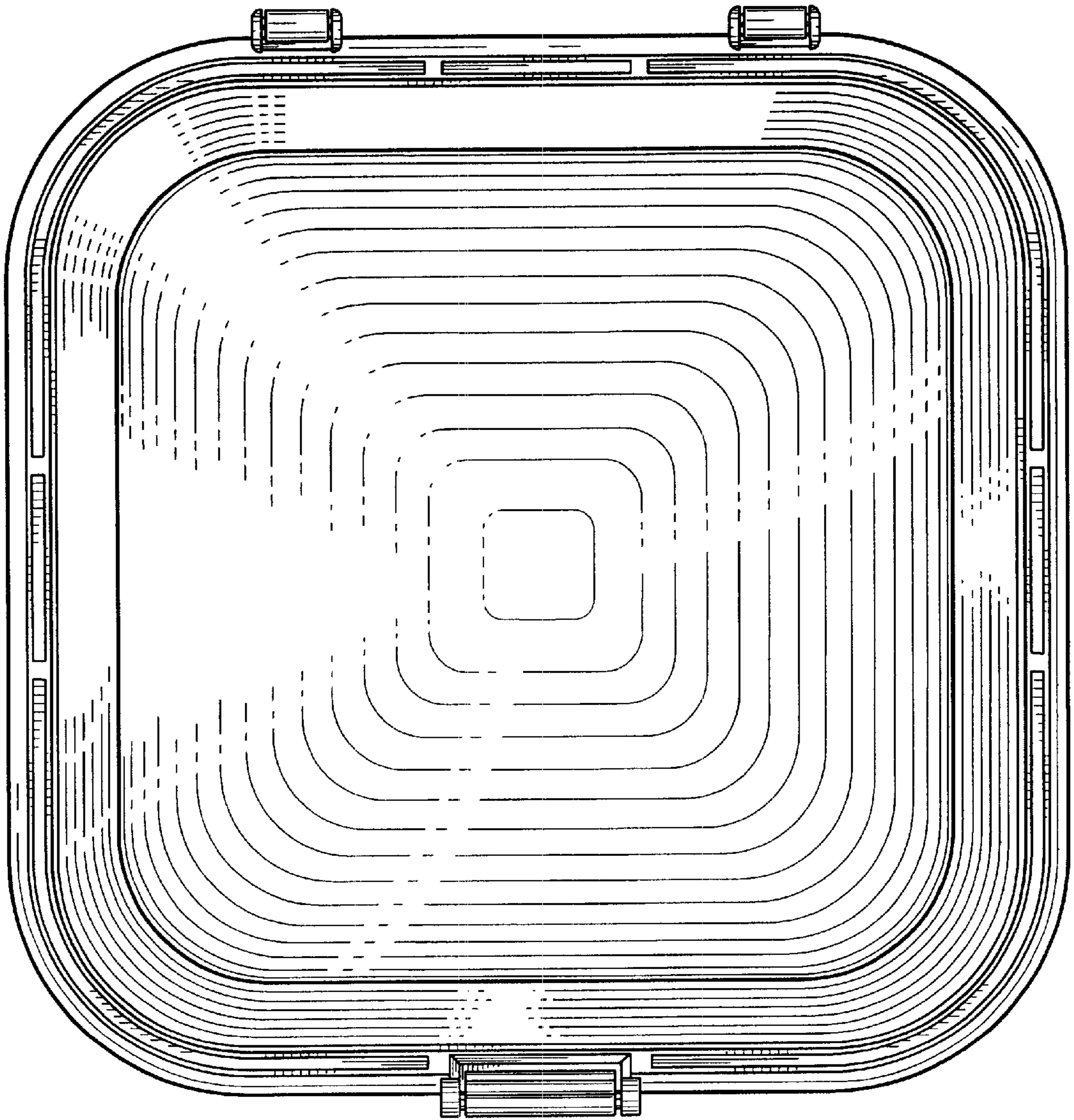
