which include hook and loop closure at their tops.

FIG. 6 is a bottom view.

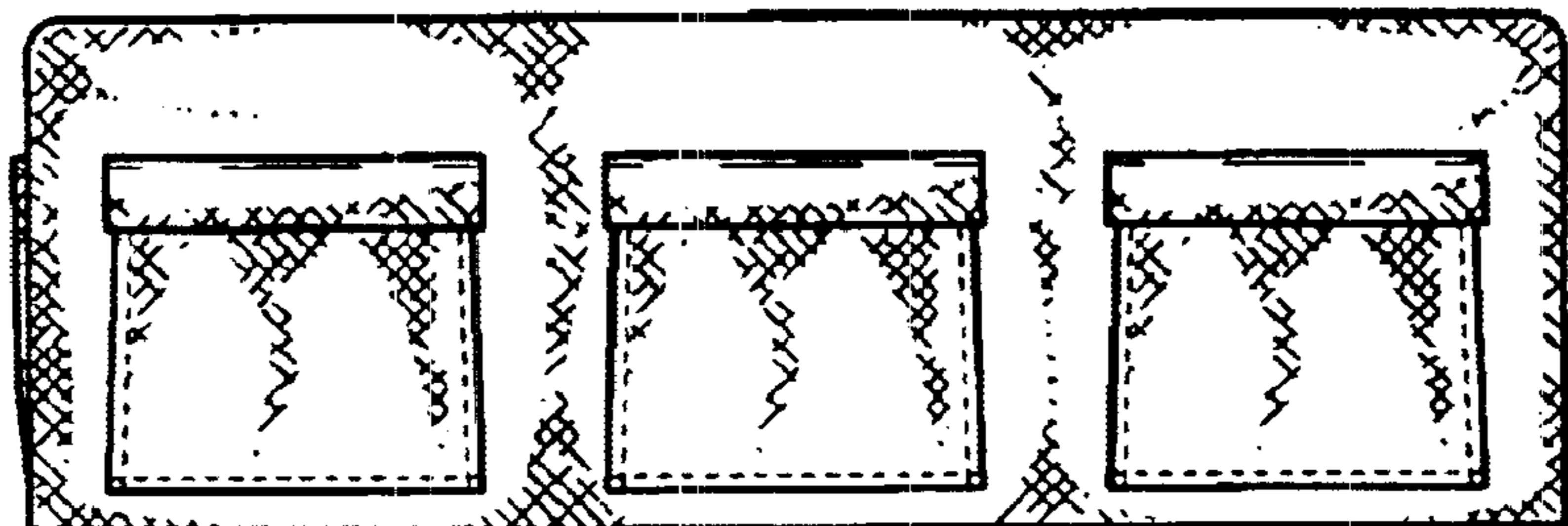
The broken lines on the pockets of the dust ruffle with

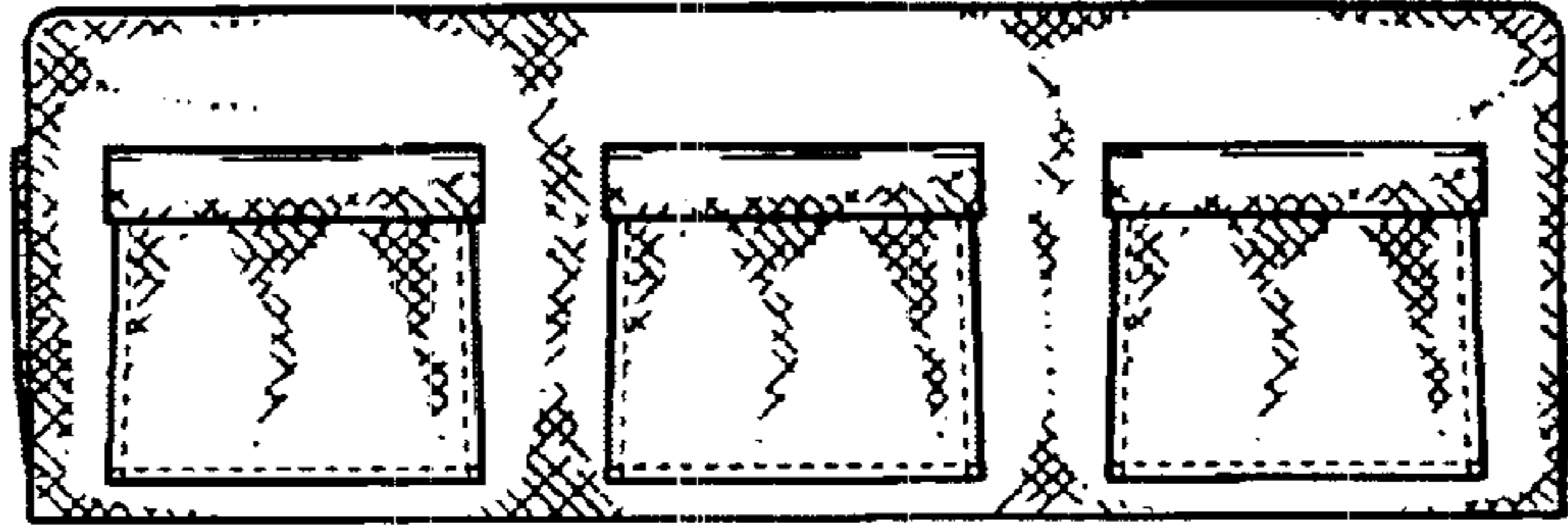

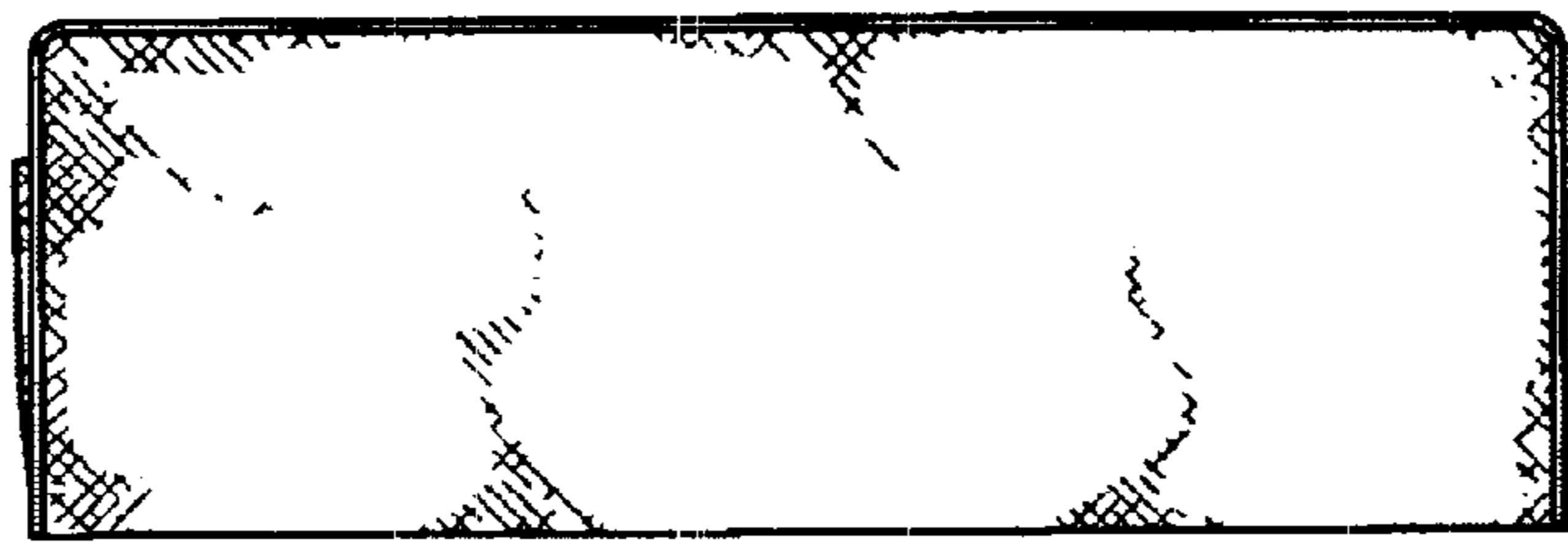

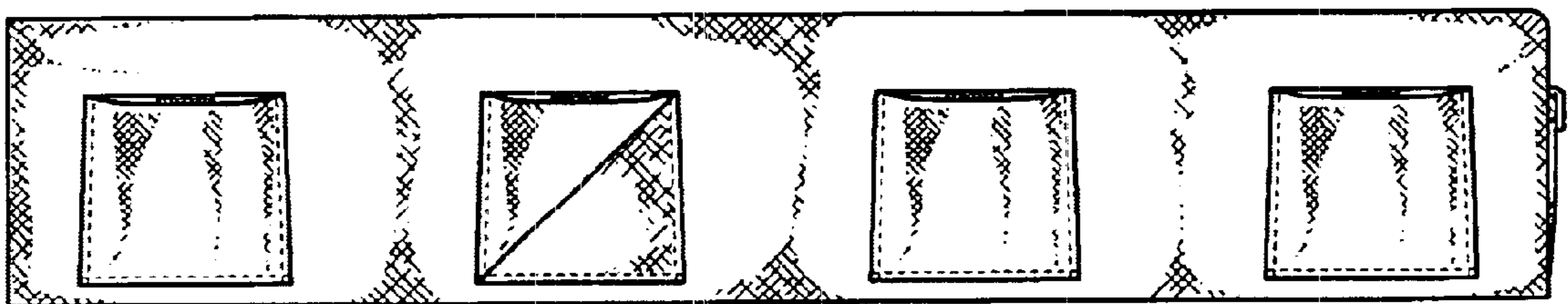

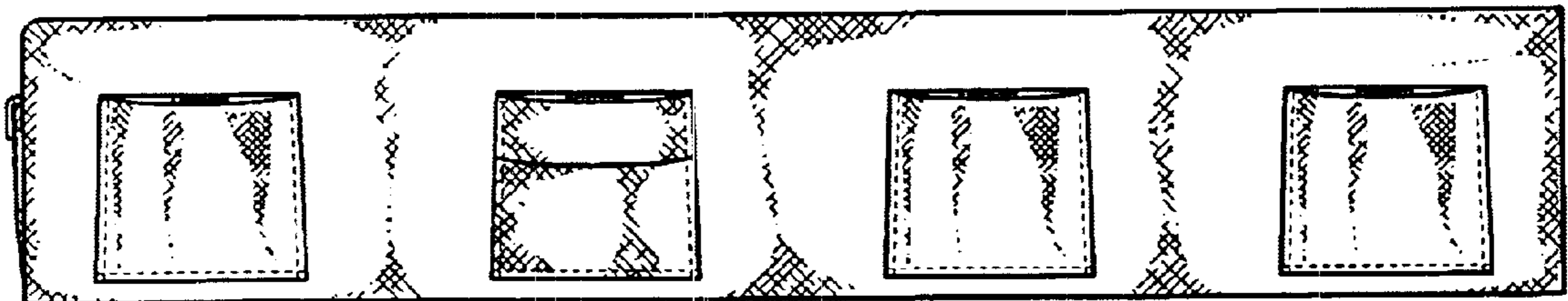
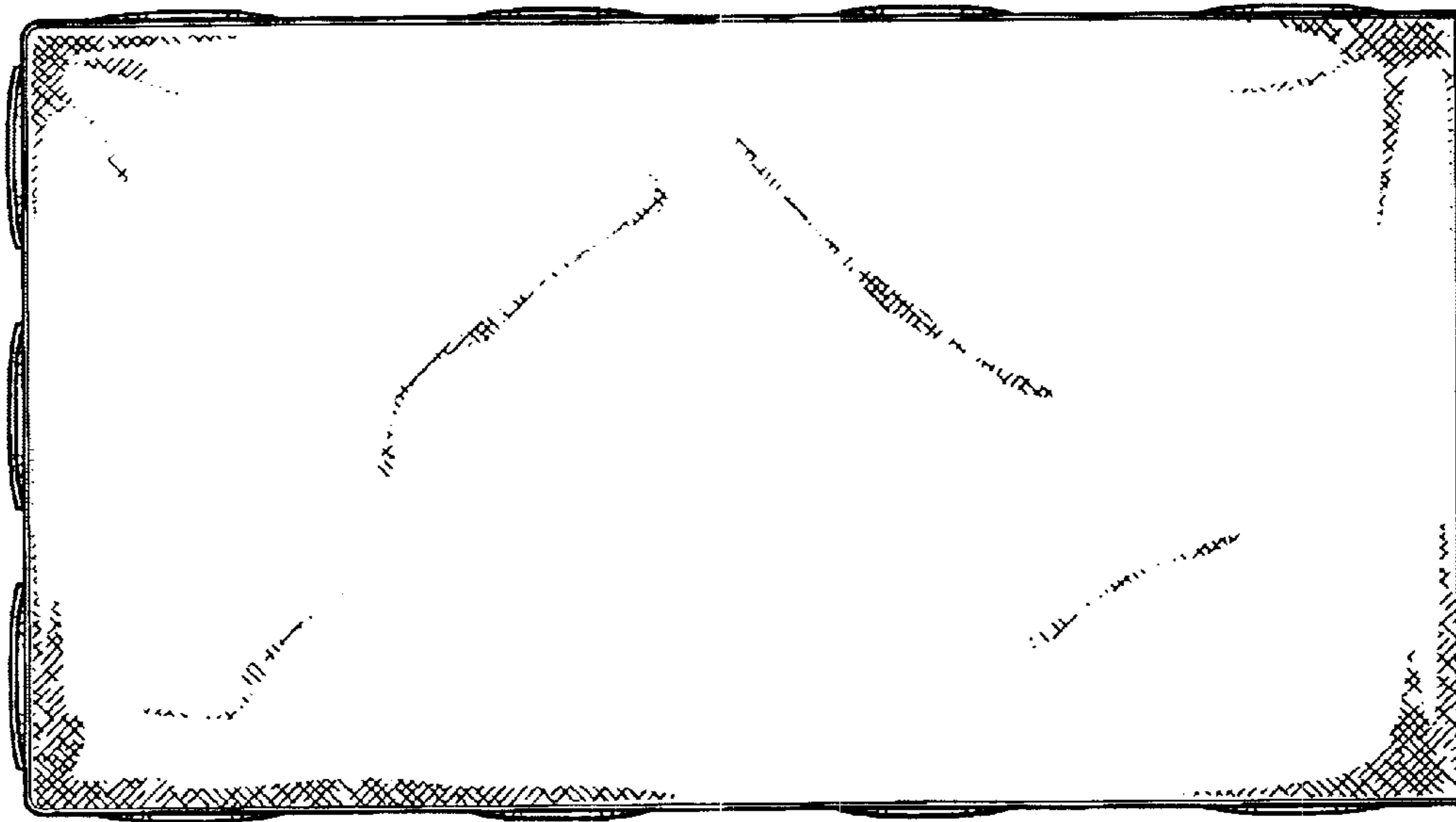
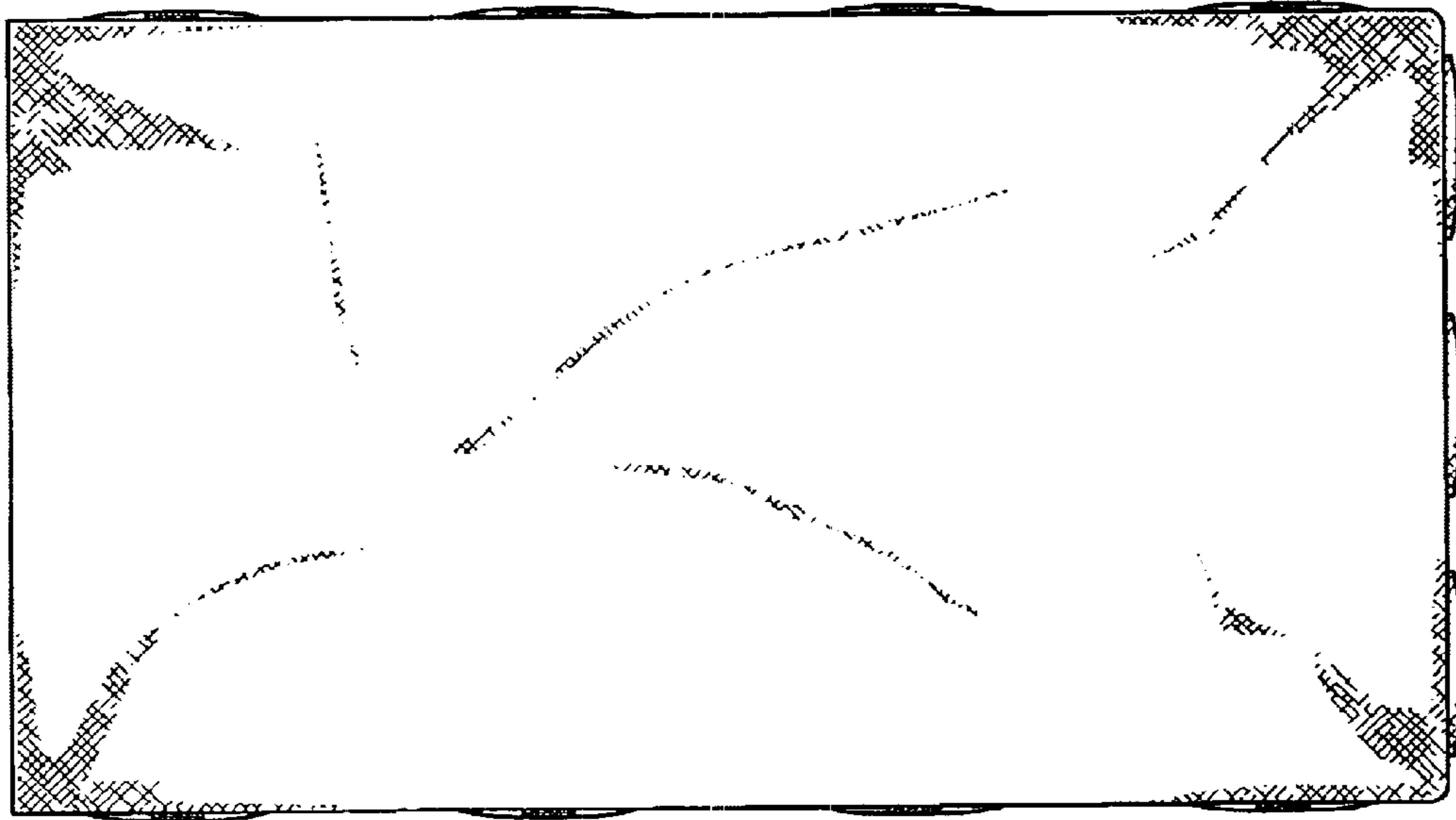
