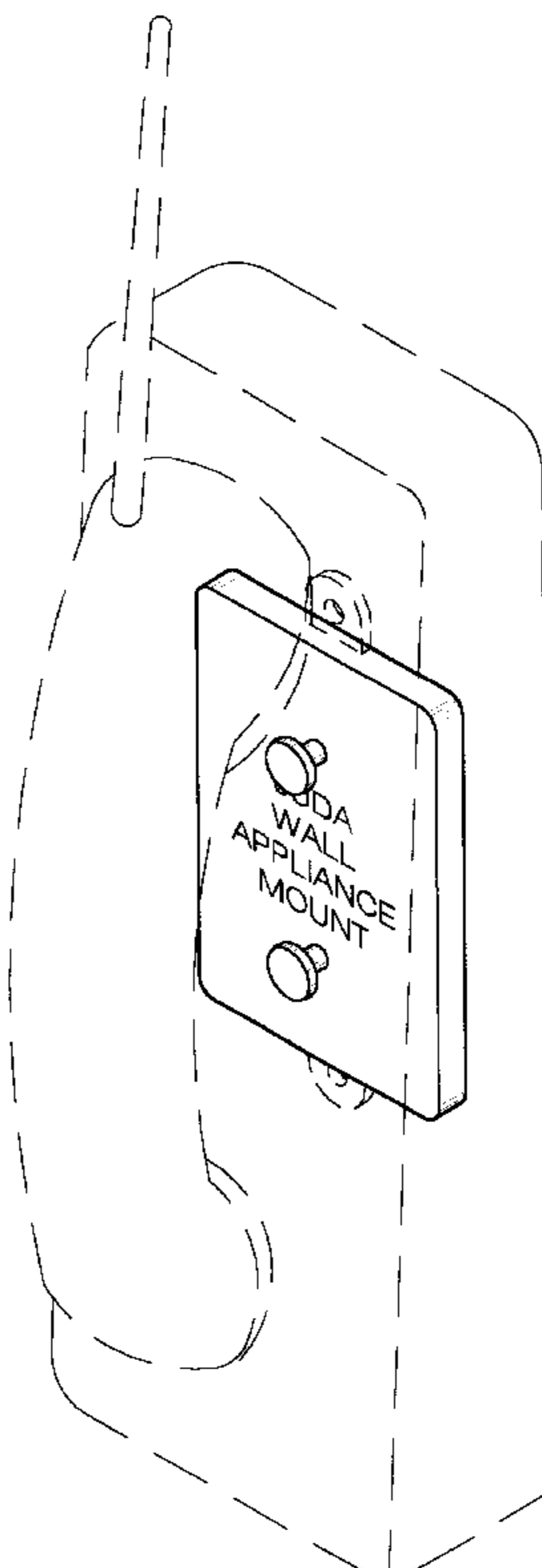
(57) **CLAIM**

The ornamental design for a plate with adjustable mounts for telephones, tools, appliances and the like, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a plate with adjustable mounts for telephones, tools, appliances and the like showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a side view, taken from the left side of FIG. 1, the right side view being a mirror image thereof; and,
FIG. 5 is a top plan view thereof, the bottom plan view being a mirror image thereof.
The broken lines showing a telephone in FIG. 1, showing a mounting plate and squares of adhesive in FIGS. 1-5 are for illustrative purposes only and form no part of the claimed design.

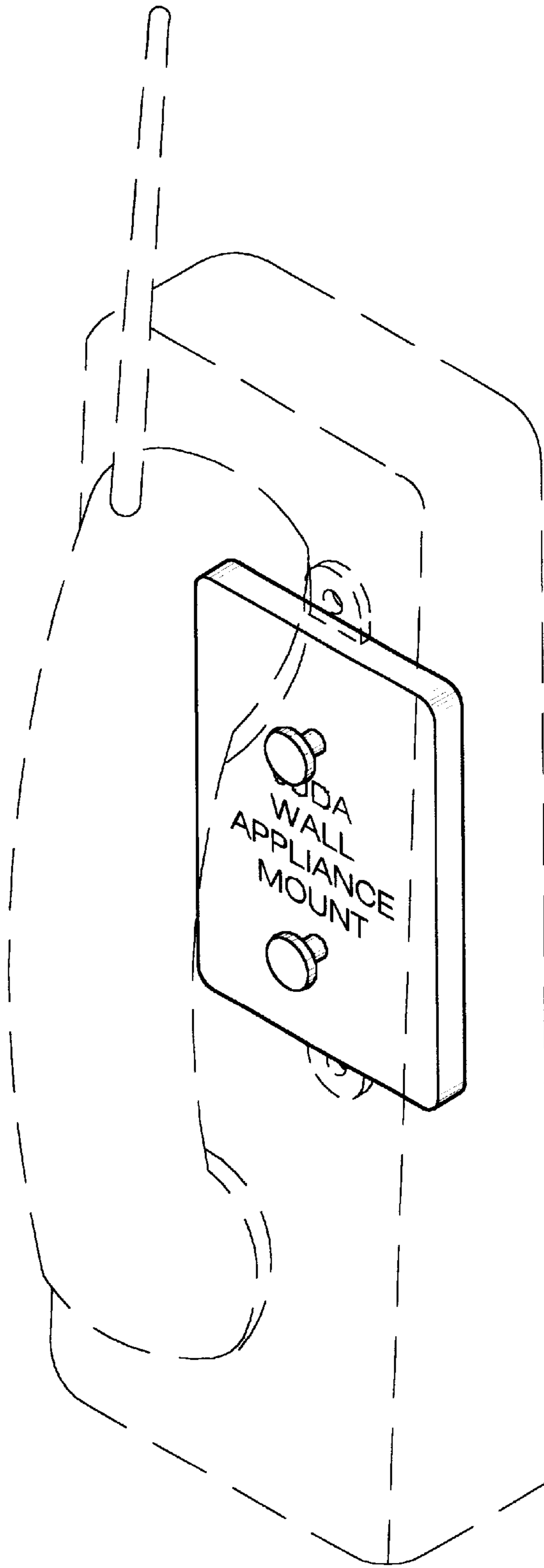

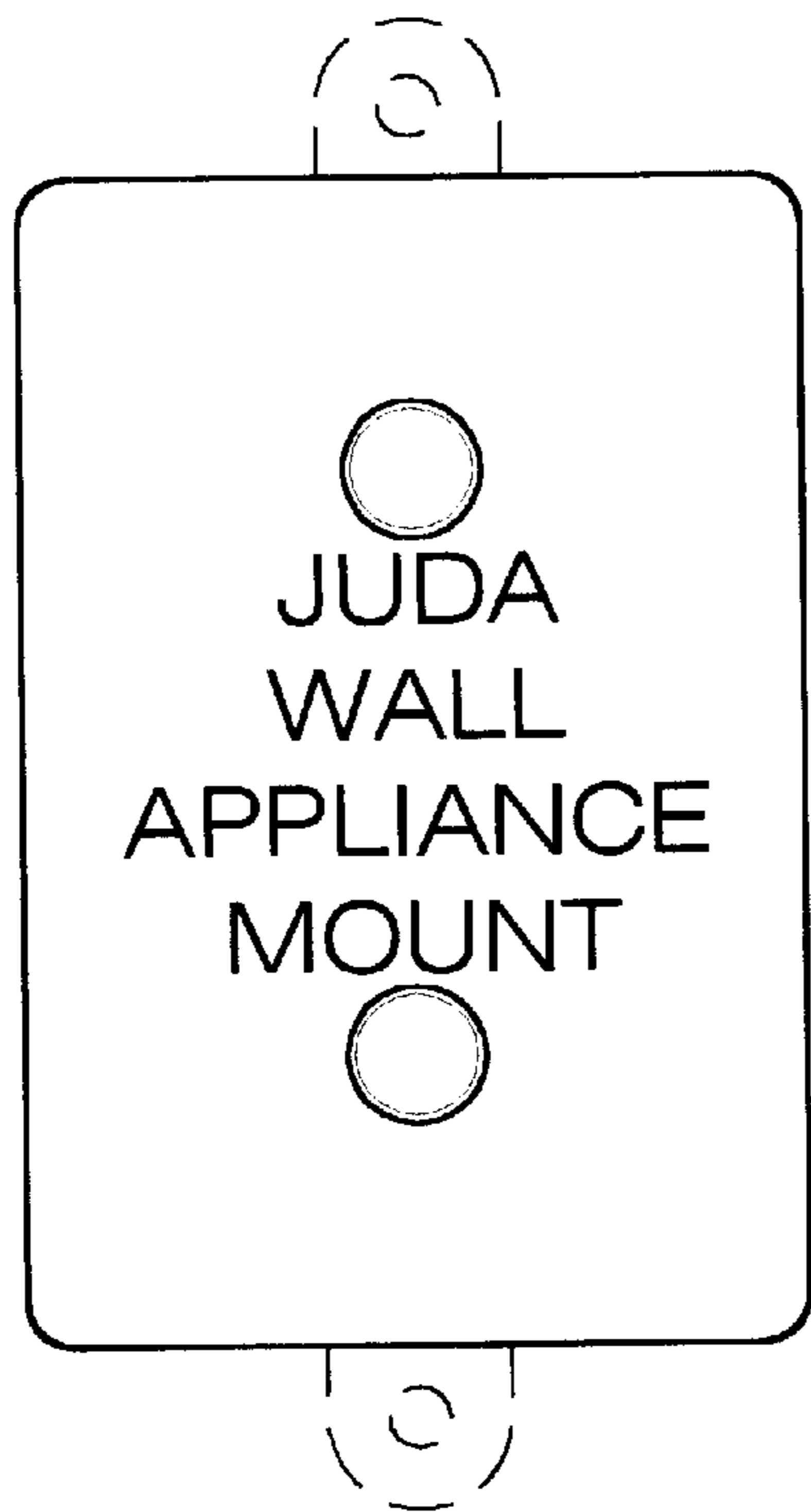

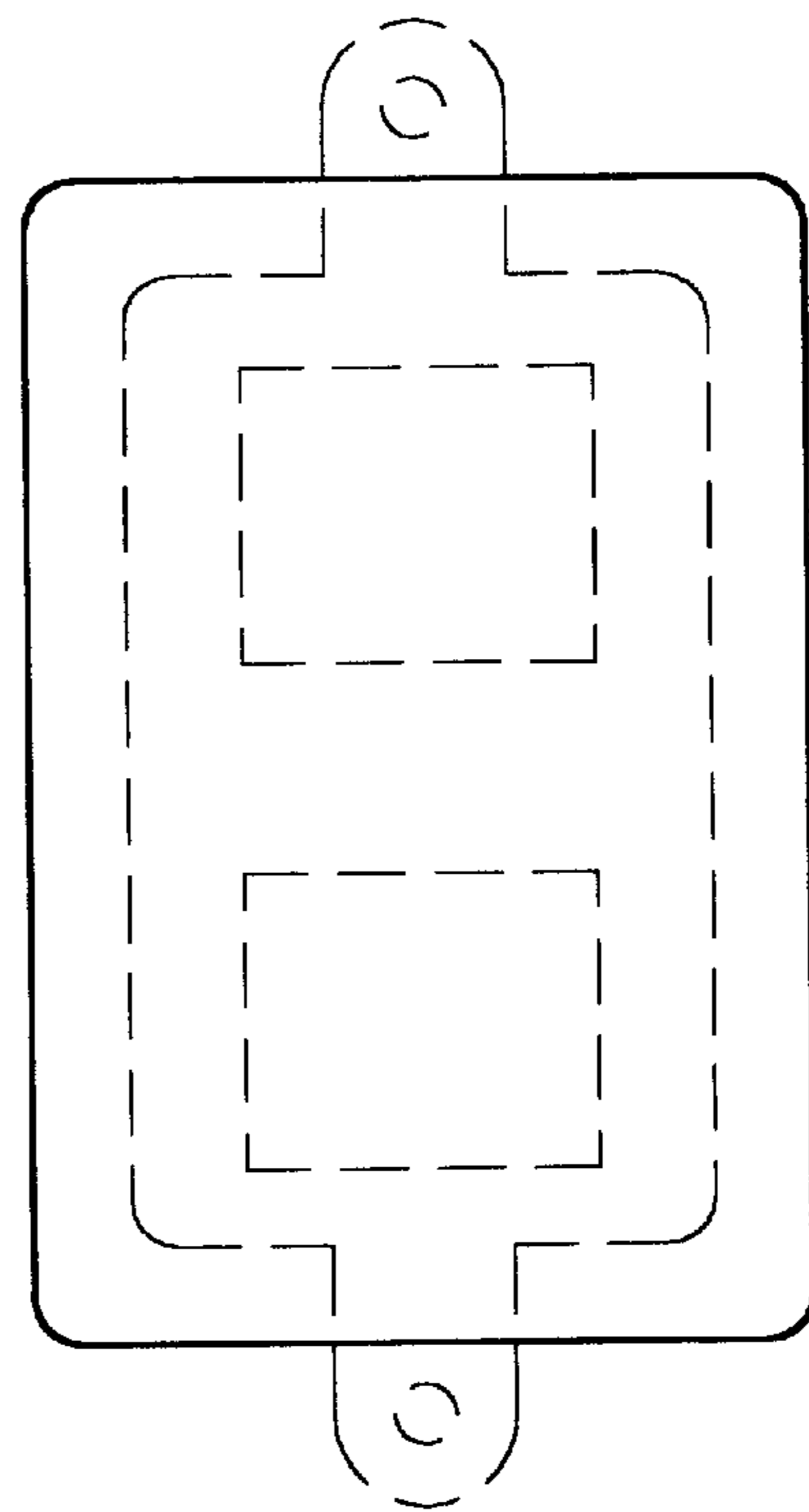

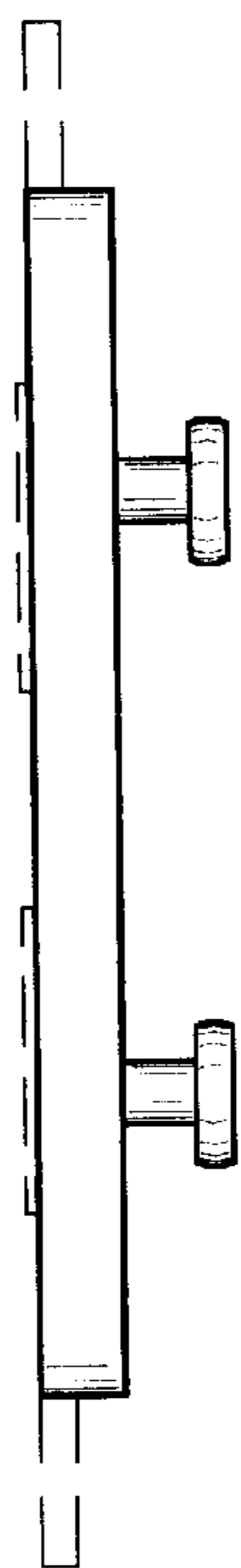

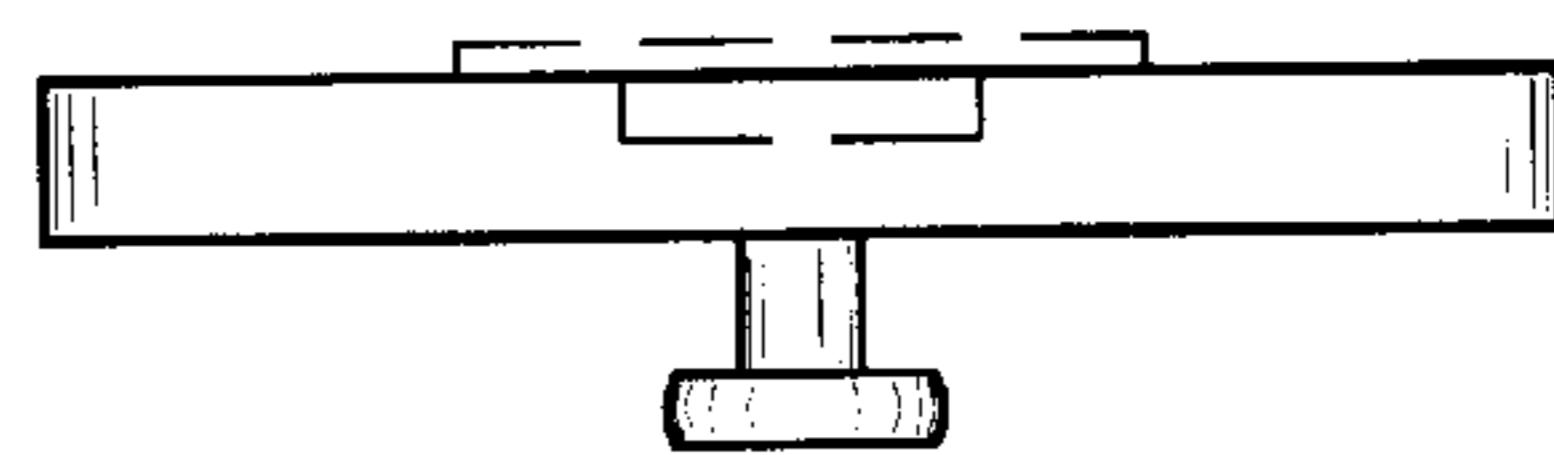
