(57) **CLAIM**

The ornamental design for a vehicle wheel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a vehicle wheel showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a left side elevational view thereof; the right side elevational view being a mirror image thereof; and,
FIG. 7 is a sectional view taken along line 7—7 shown in FIG. 2.

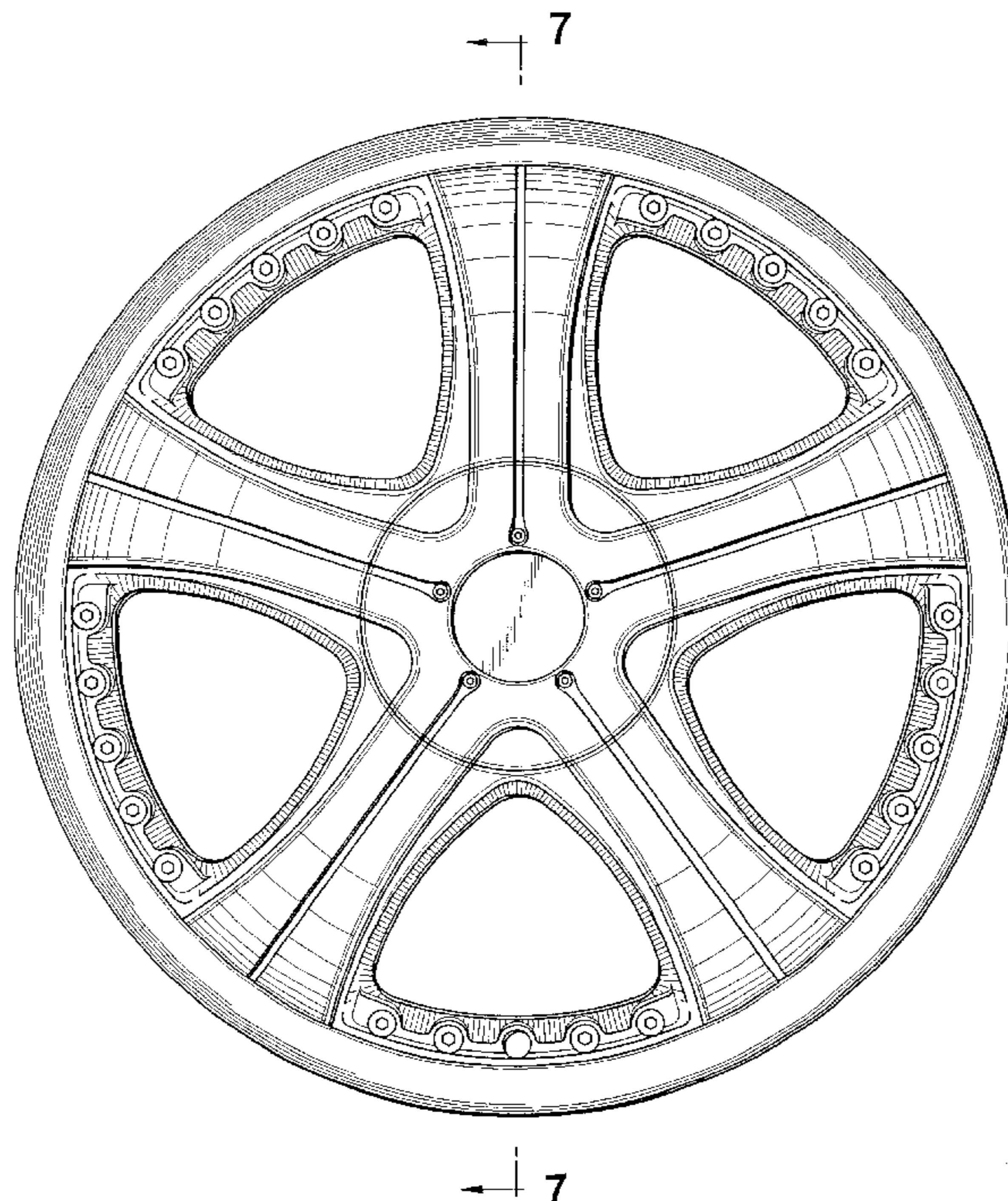

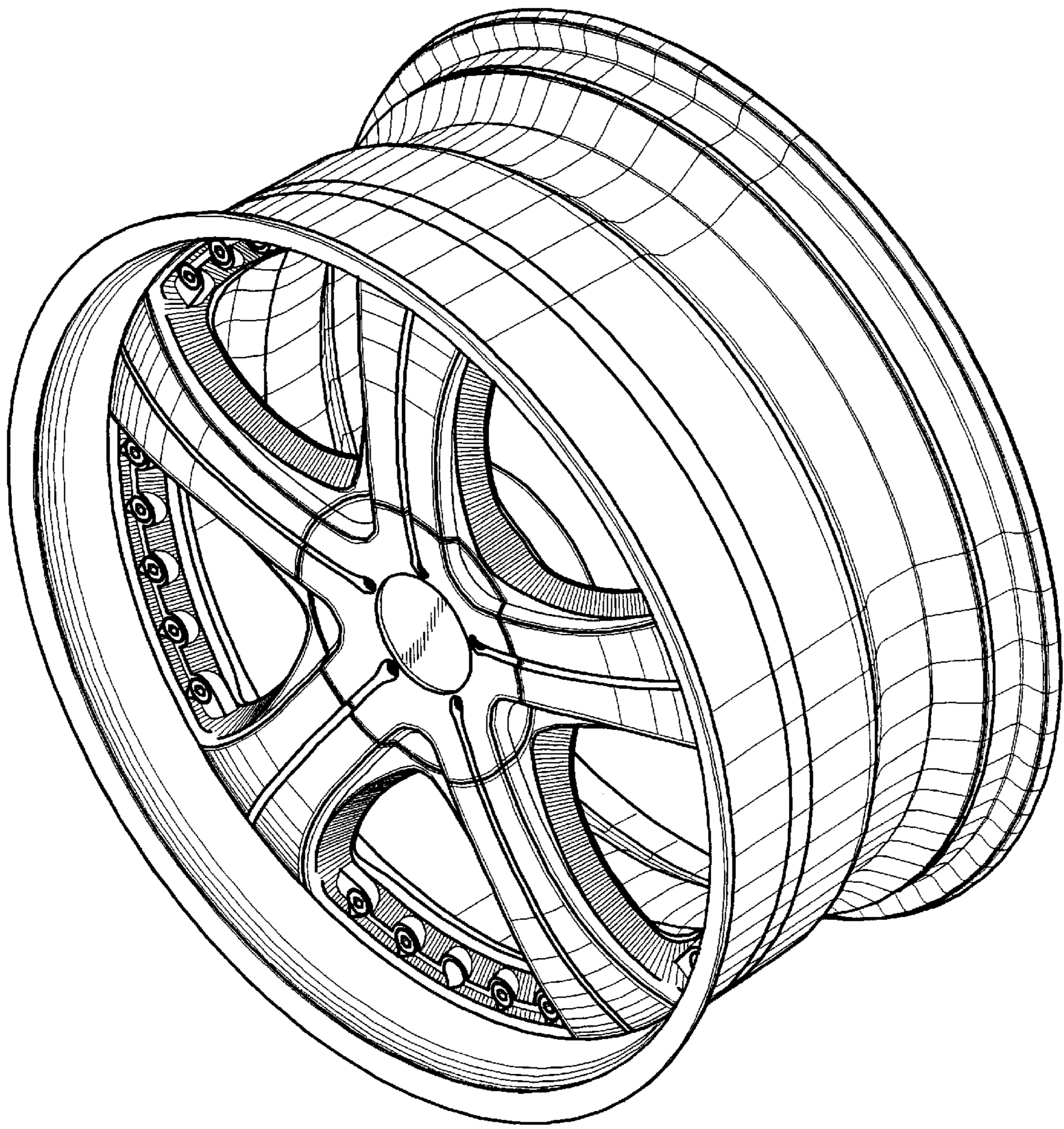

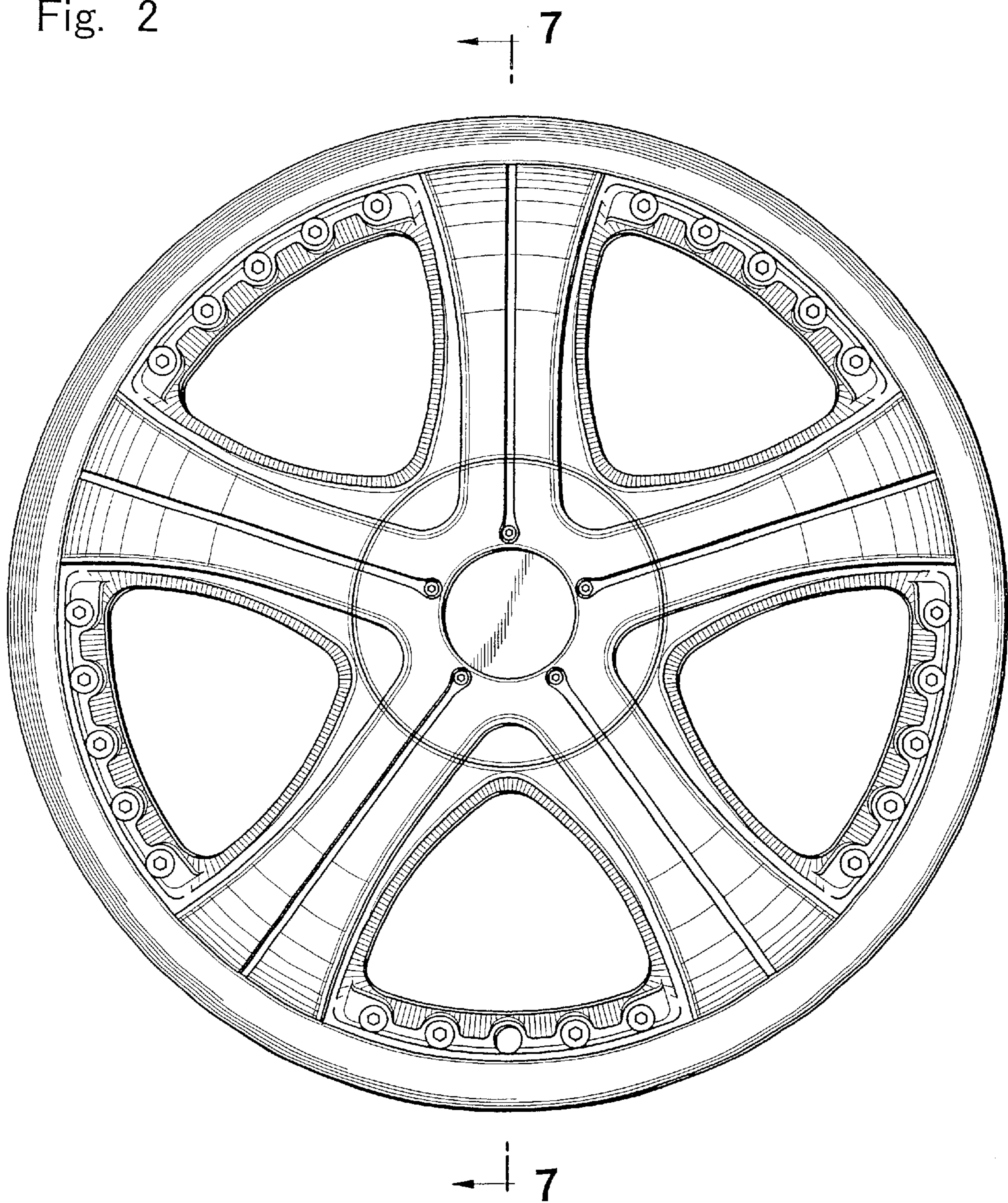

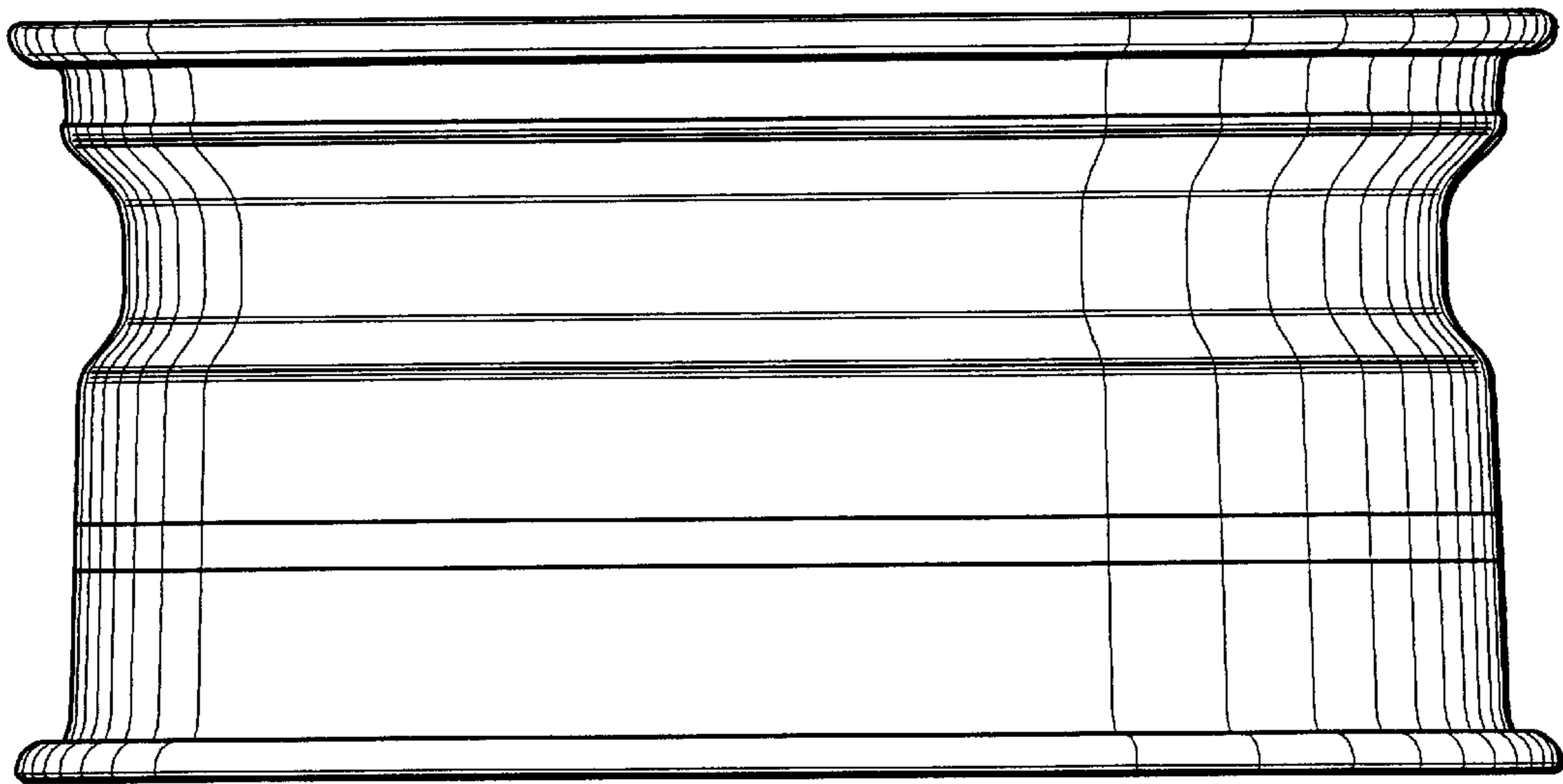

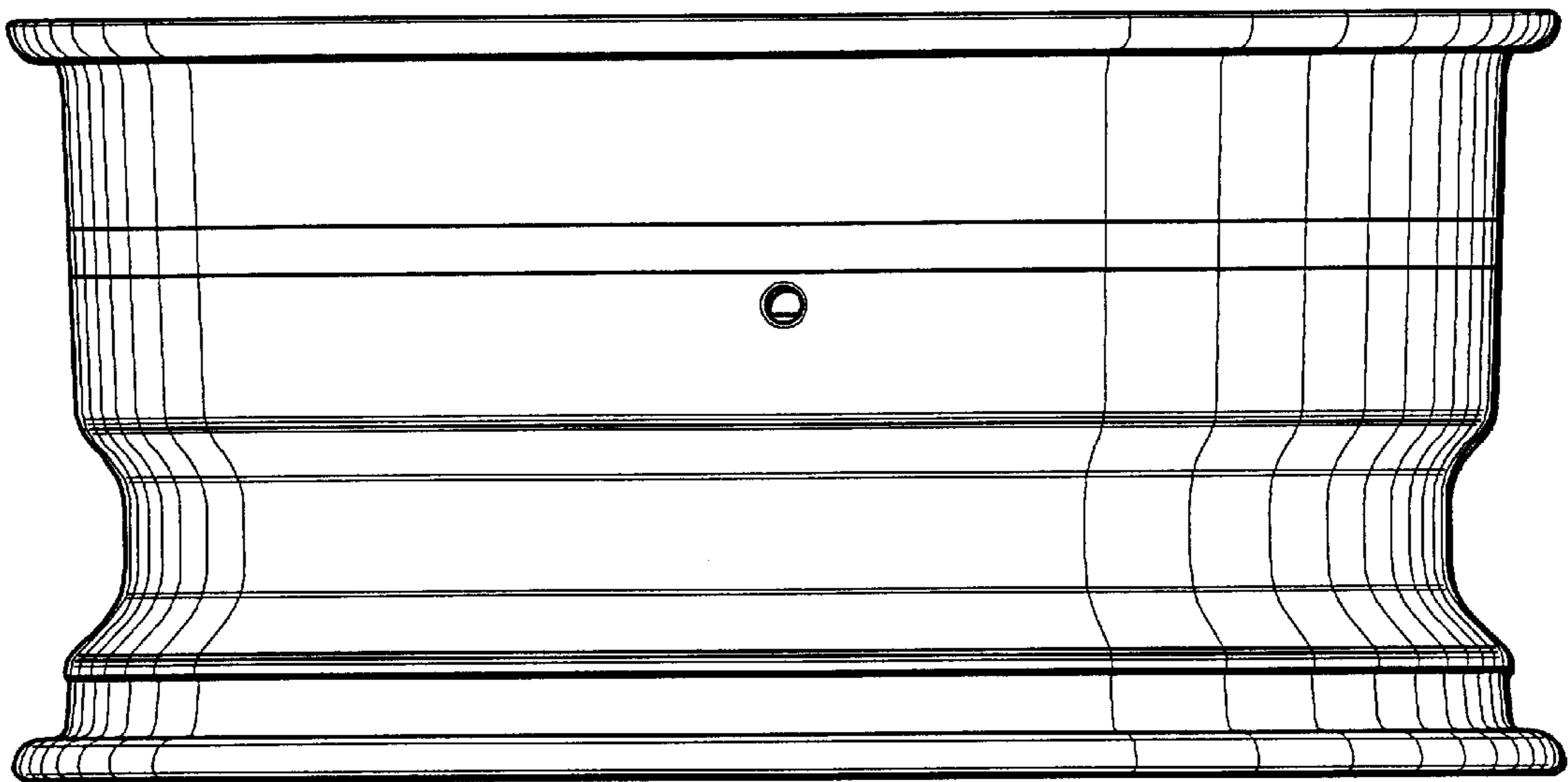
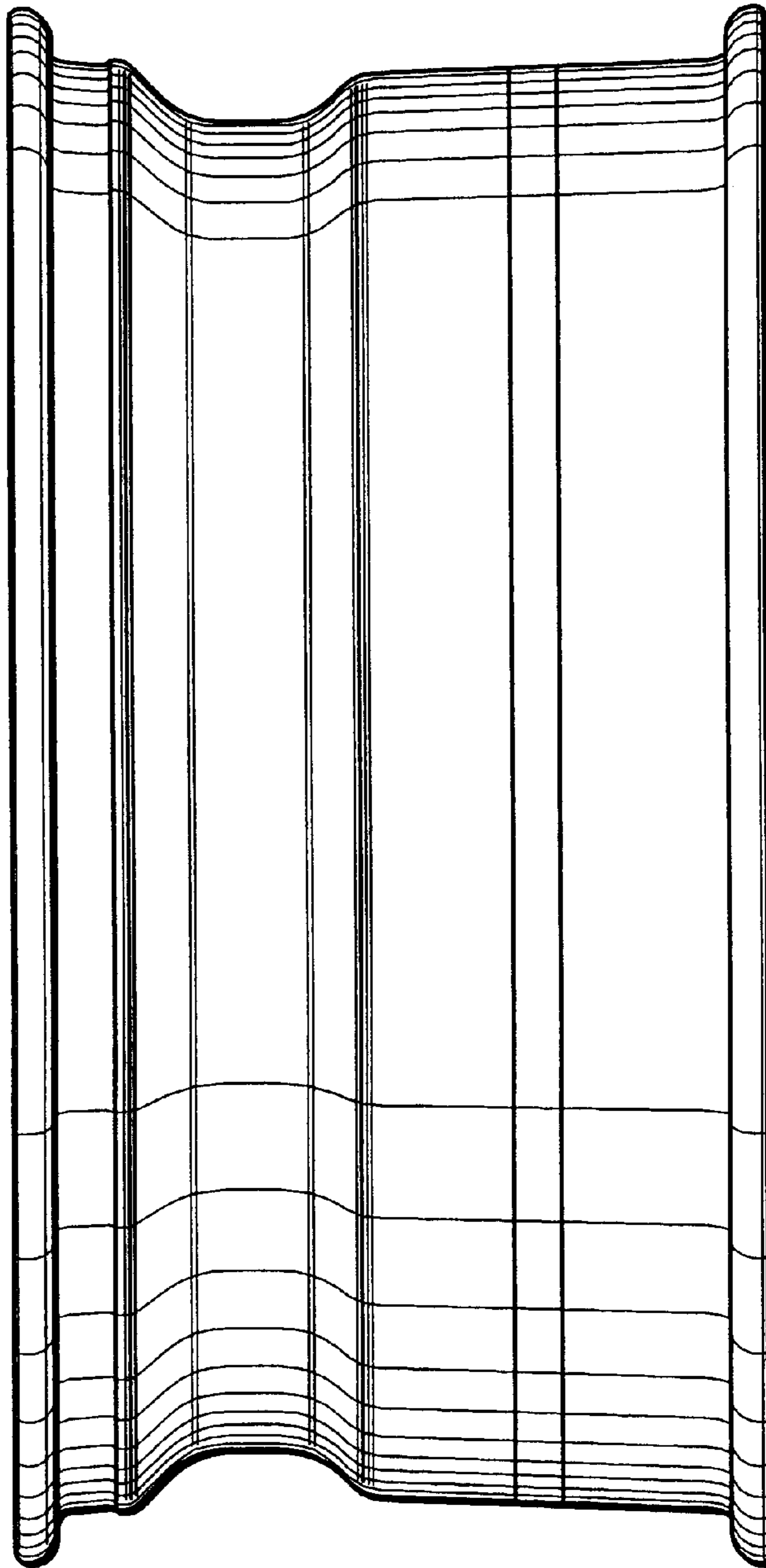
