(57) **CLAIM**

We claim the ornamental designs for a handset, as shown.

**DESCRIPTION**

FIG. 1 is a front view of the handset;  
FIG. 2 is a rear view thereof;  
FIG. 3 is top plan view thereof in an alternate position;  
FIG. 4 is a left side view thereof in an alternate position;  
FIG. 5 is a front view thereof in an alternate position;  
FIG. 6 is a right side view thereof in an alternate position;  
FIG. 7 is a bottom plan view thereof in an alternate position;  
FIG. 8 is a rear view thereof in an alternate position;  
FIG. 9 is a perspective rear view thereof in an alternate position; and,  
FIG. 10 is a perspective front view thereof in an alternate position.

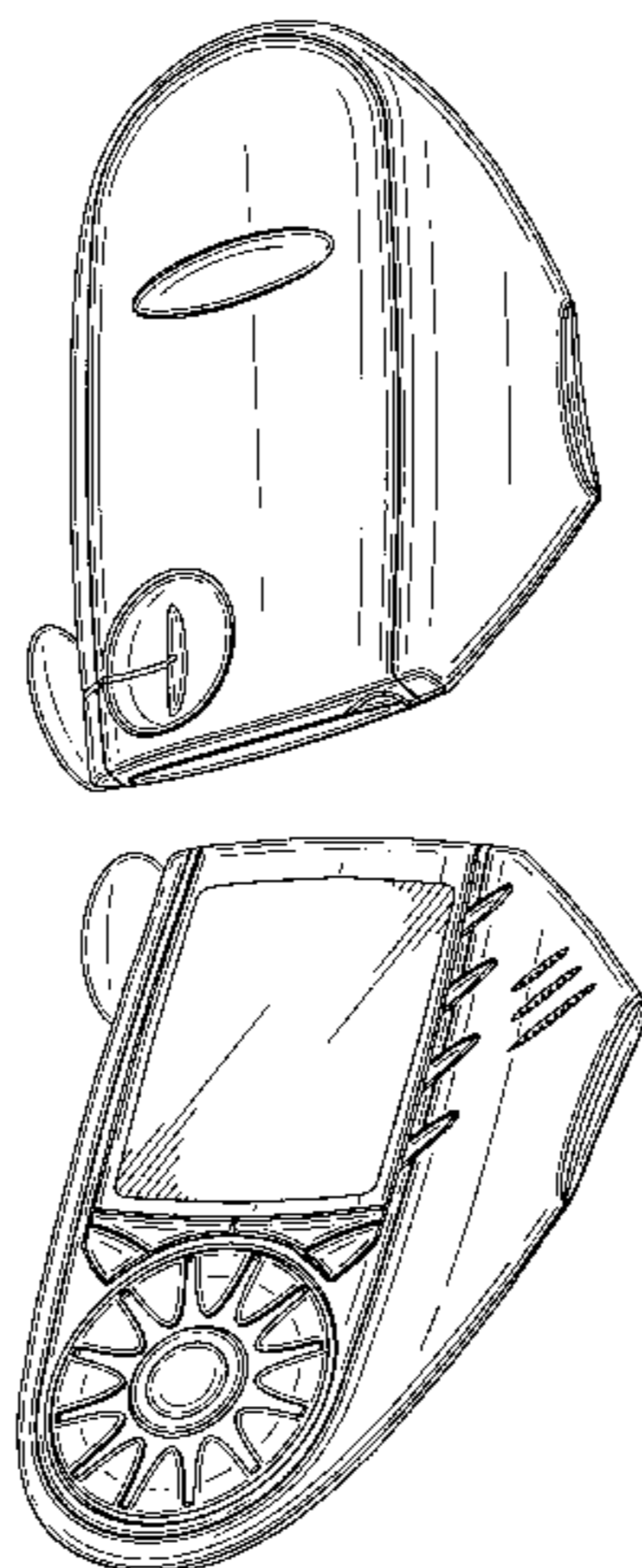

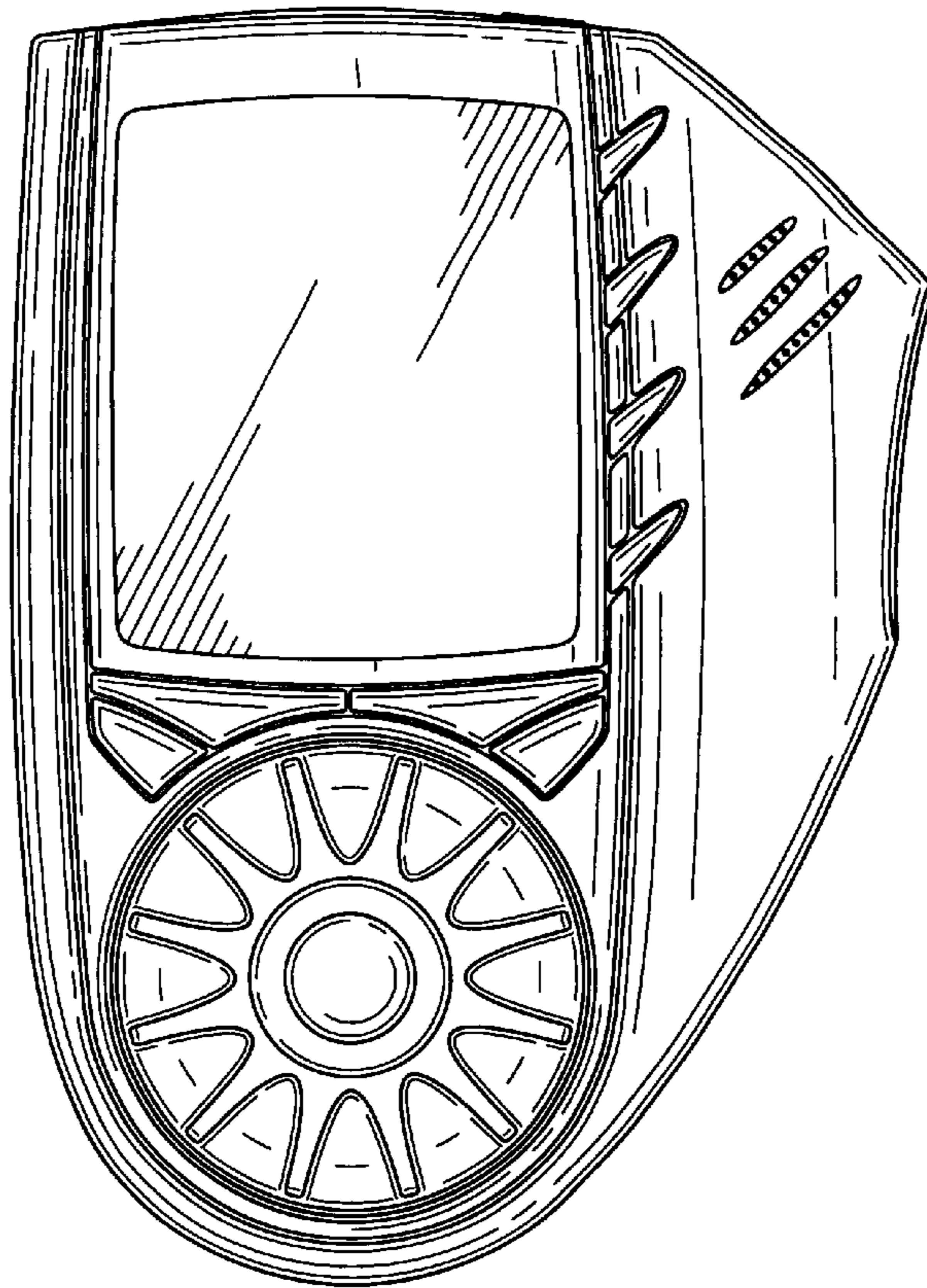

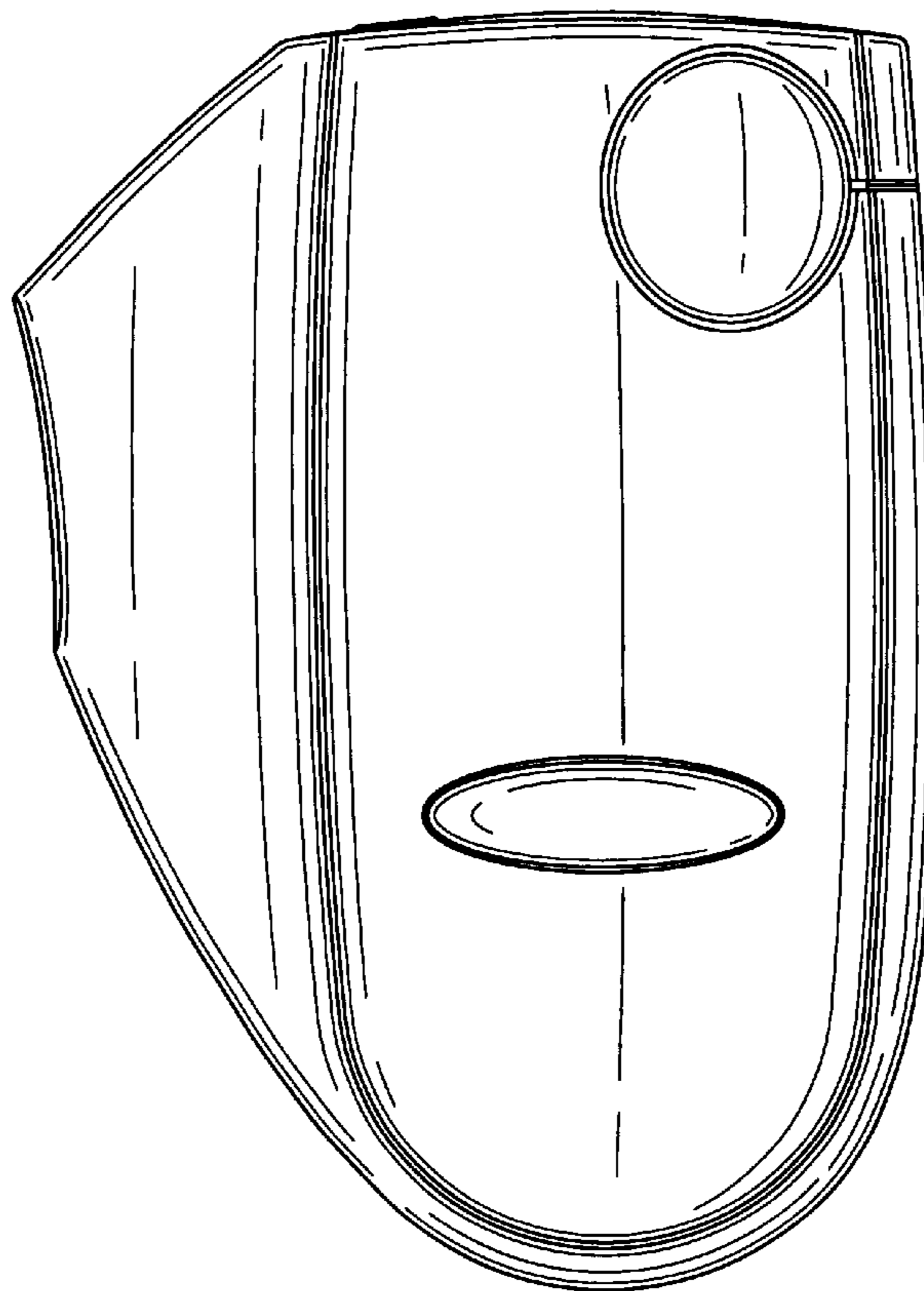

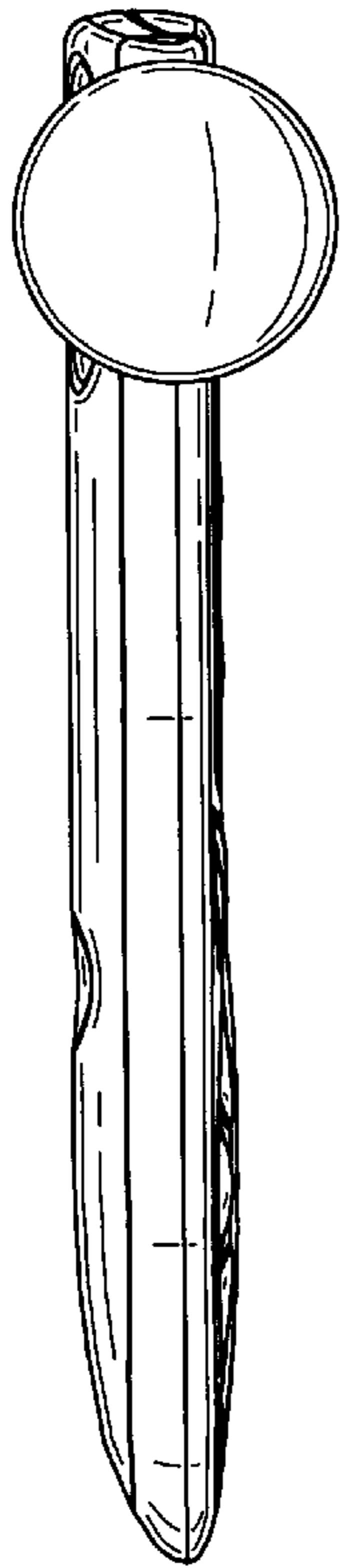
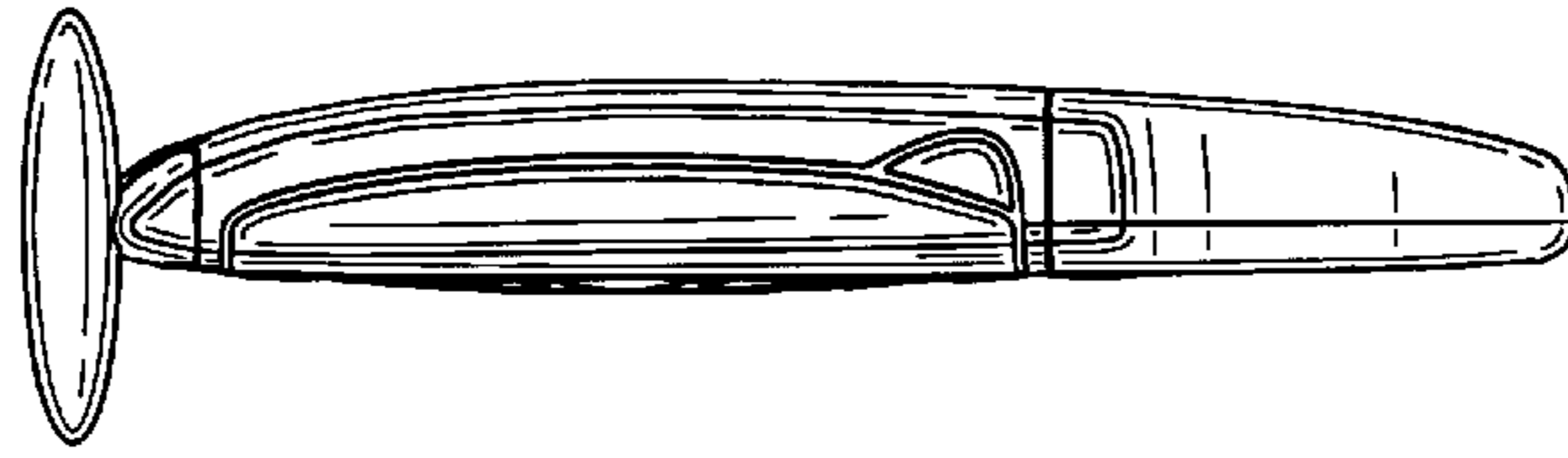

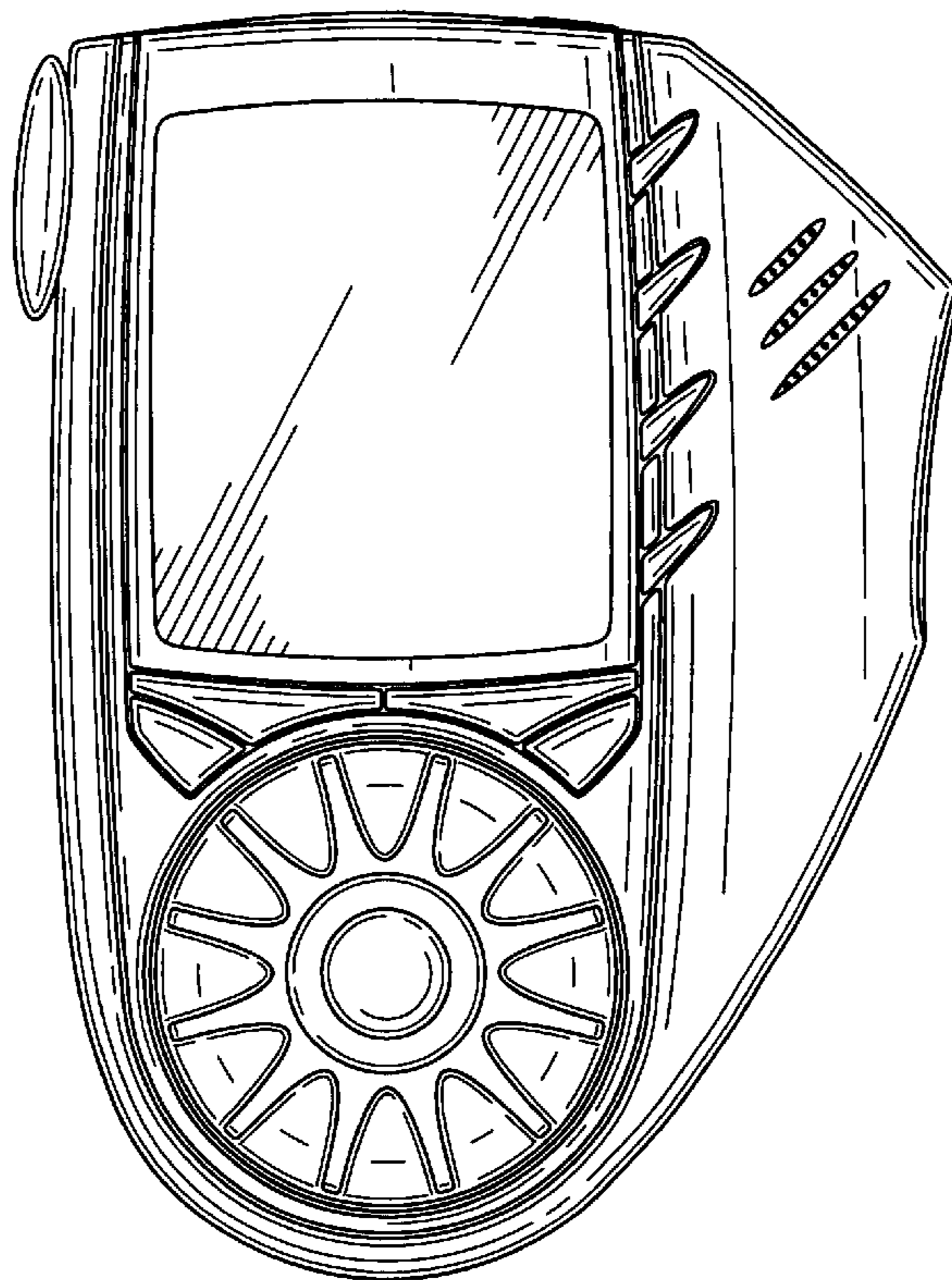

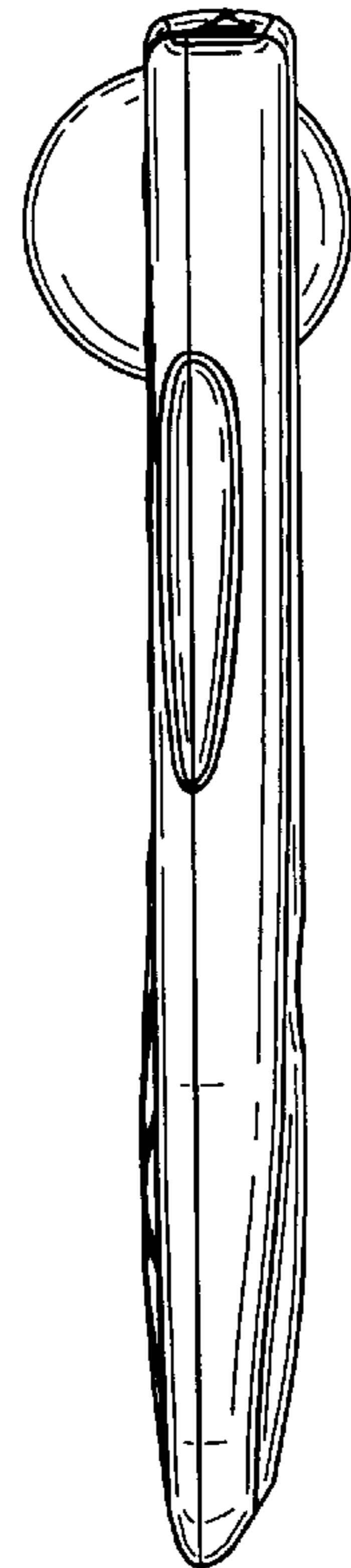
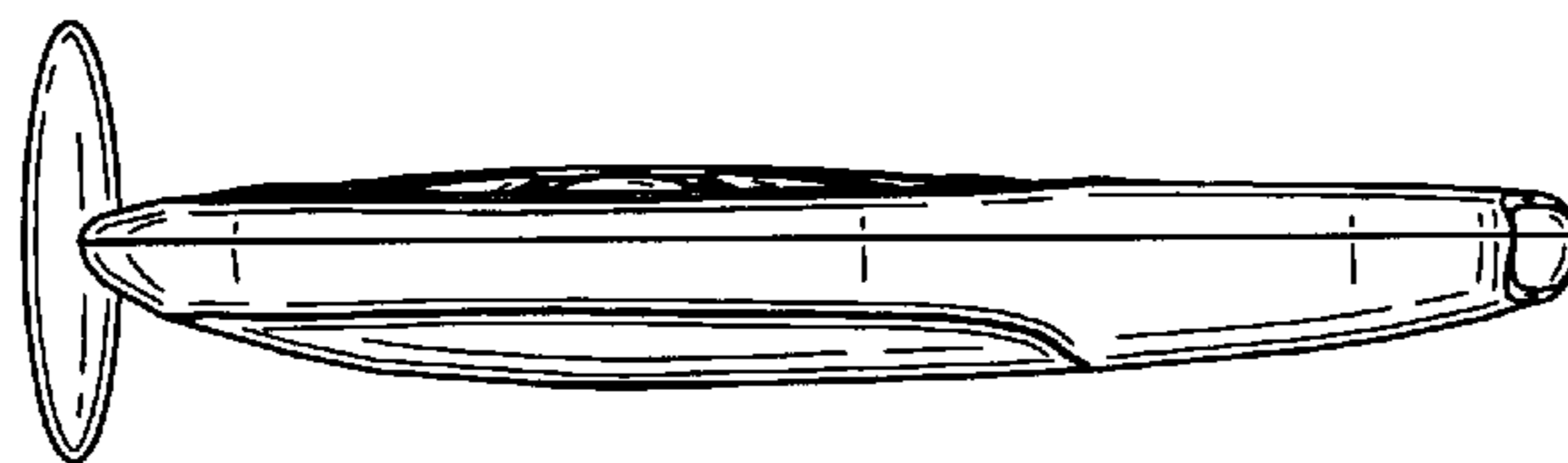

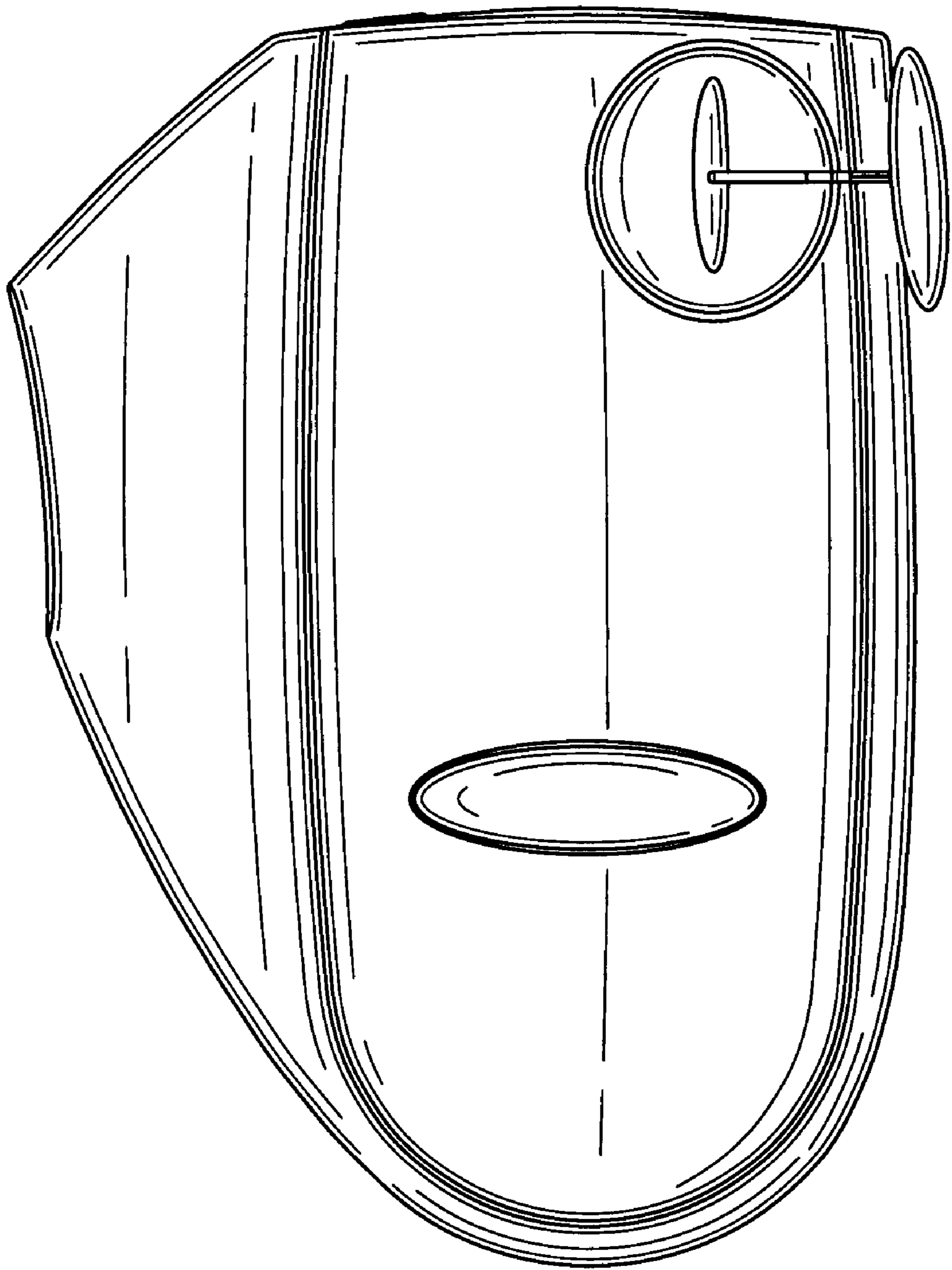

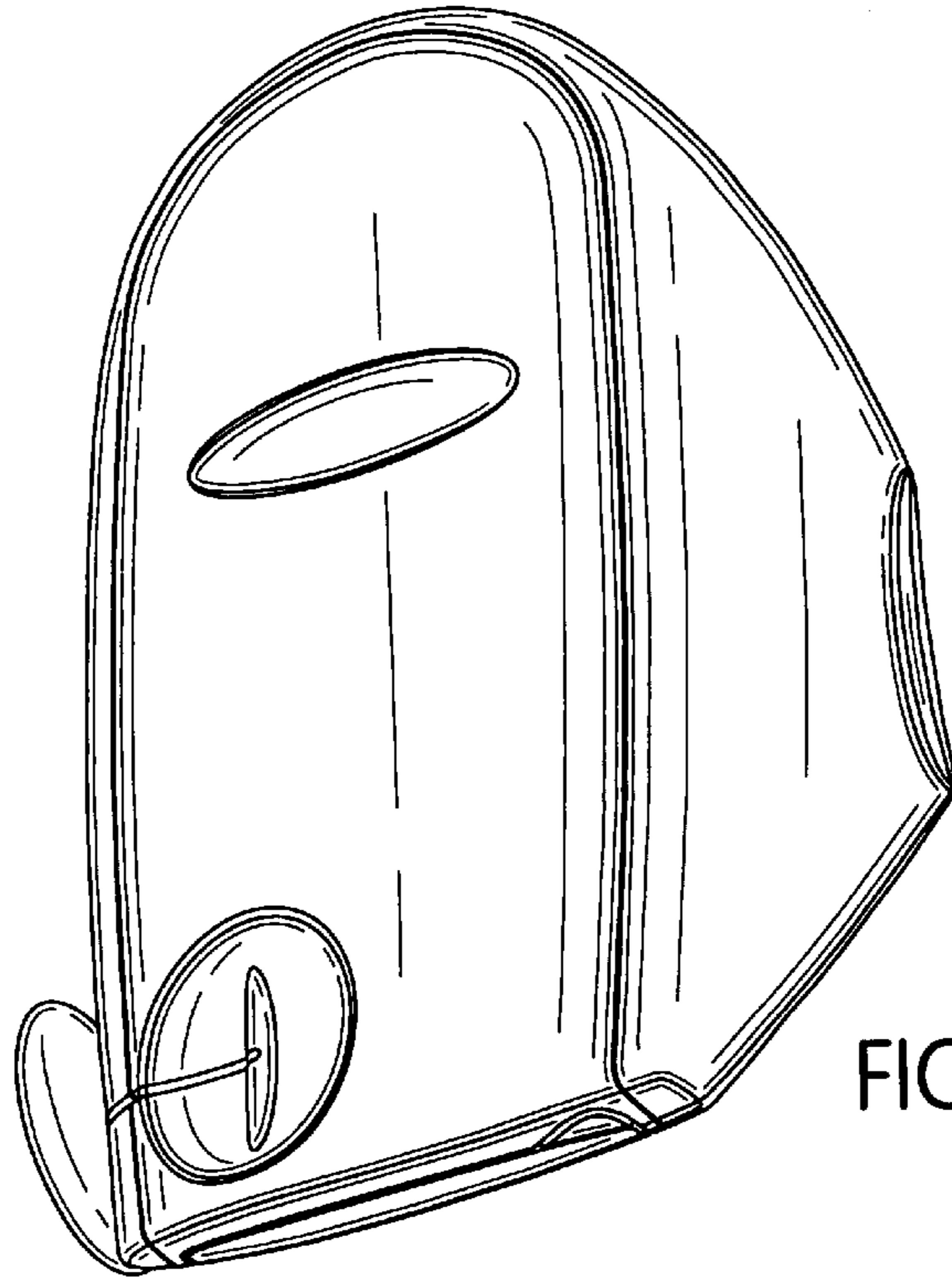

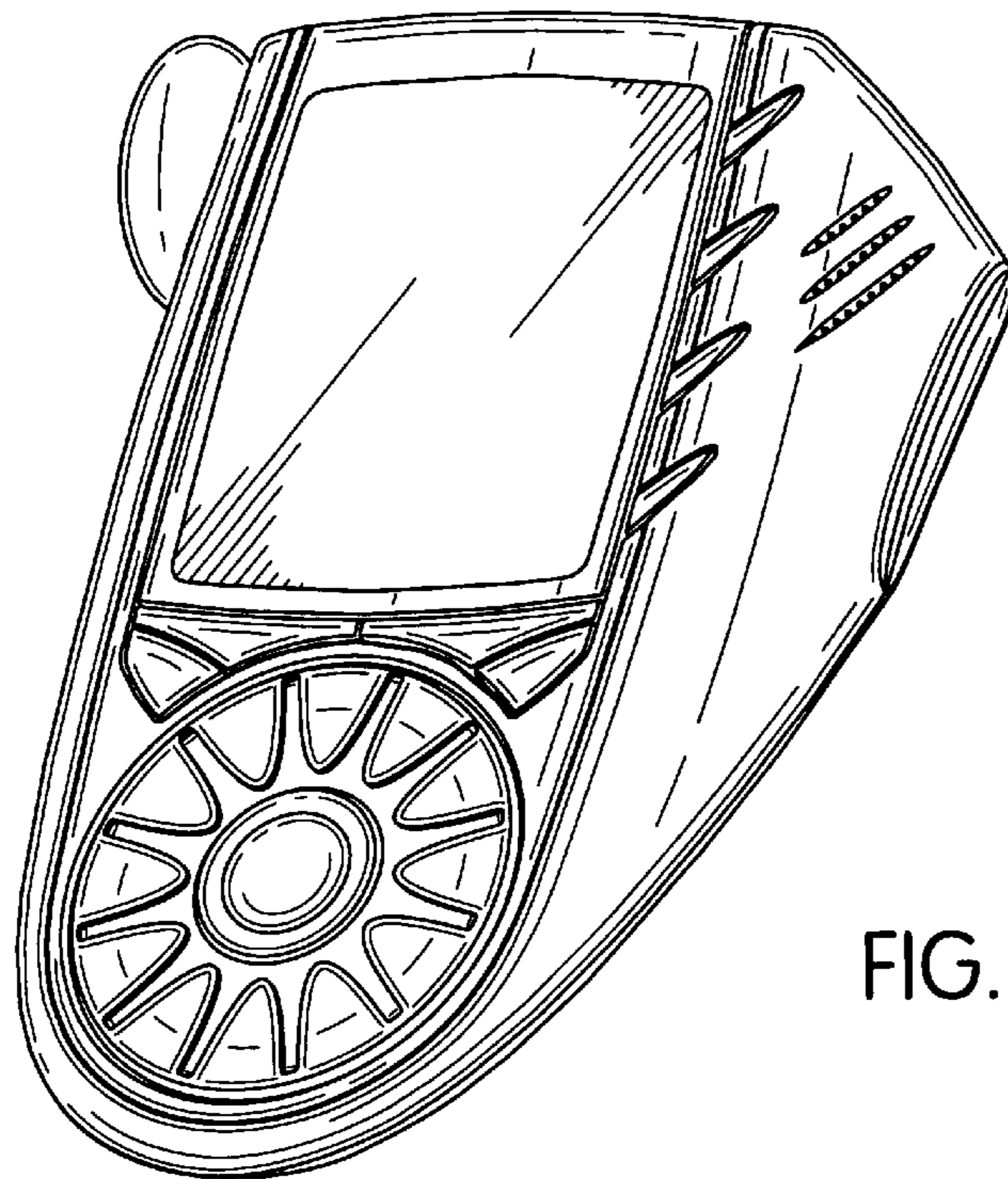
