The ornamental design for an ink cartridge for printer, as shown and described.

DESCRIPTION

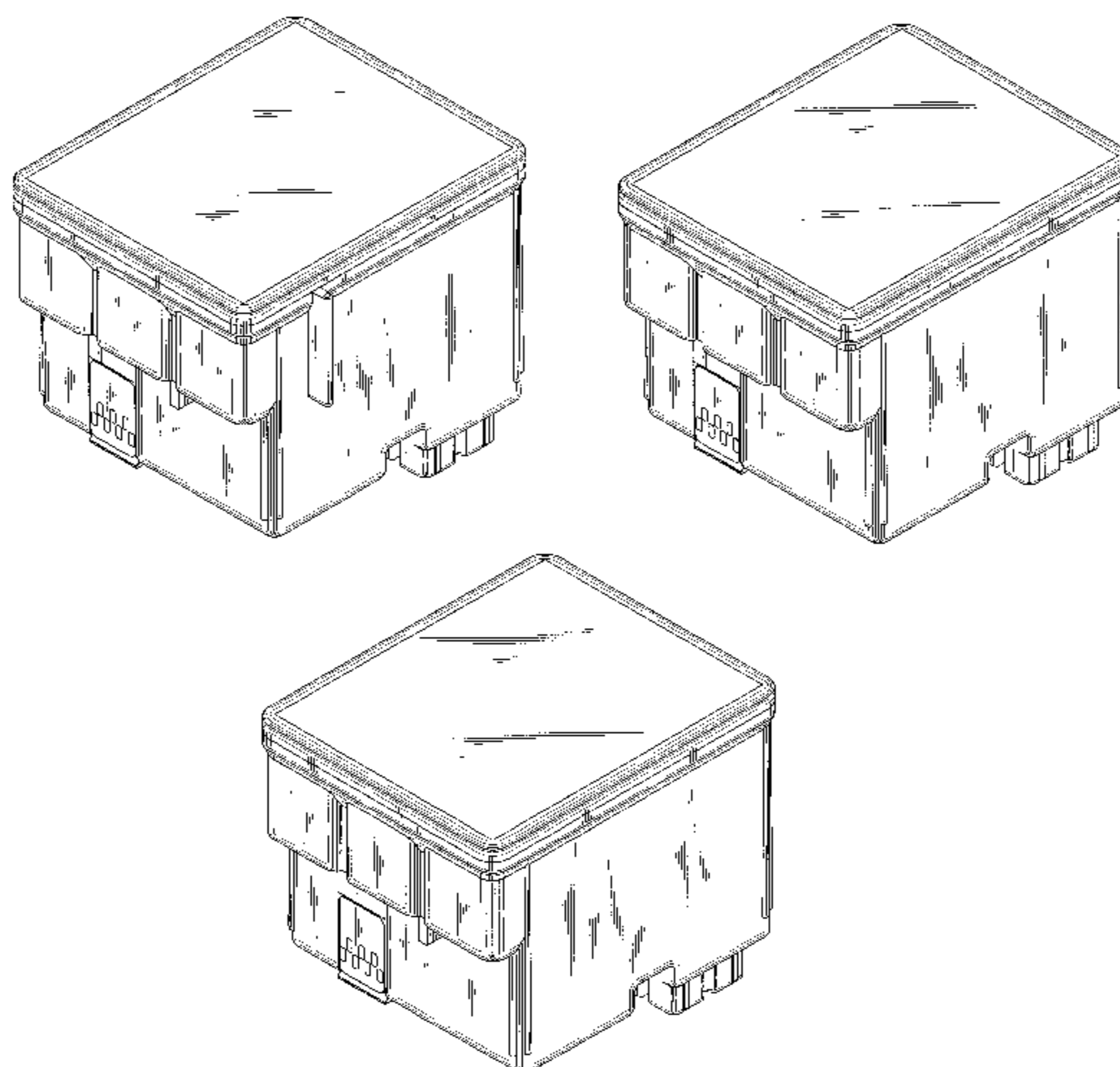

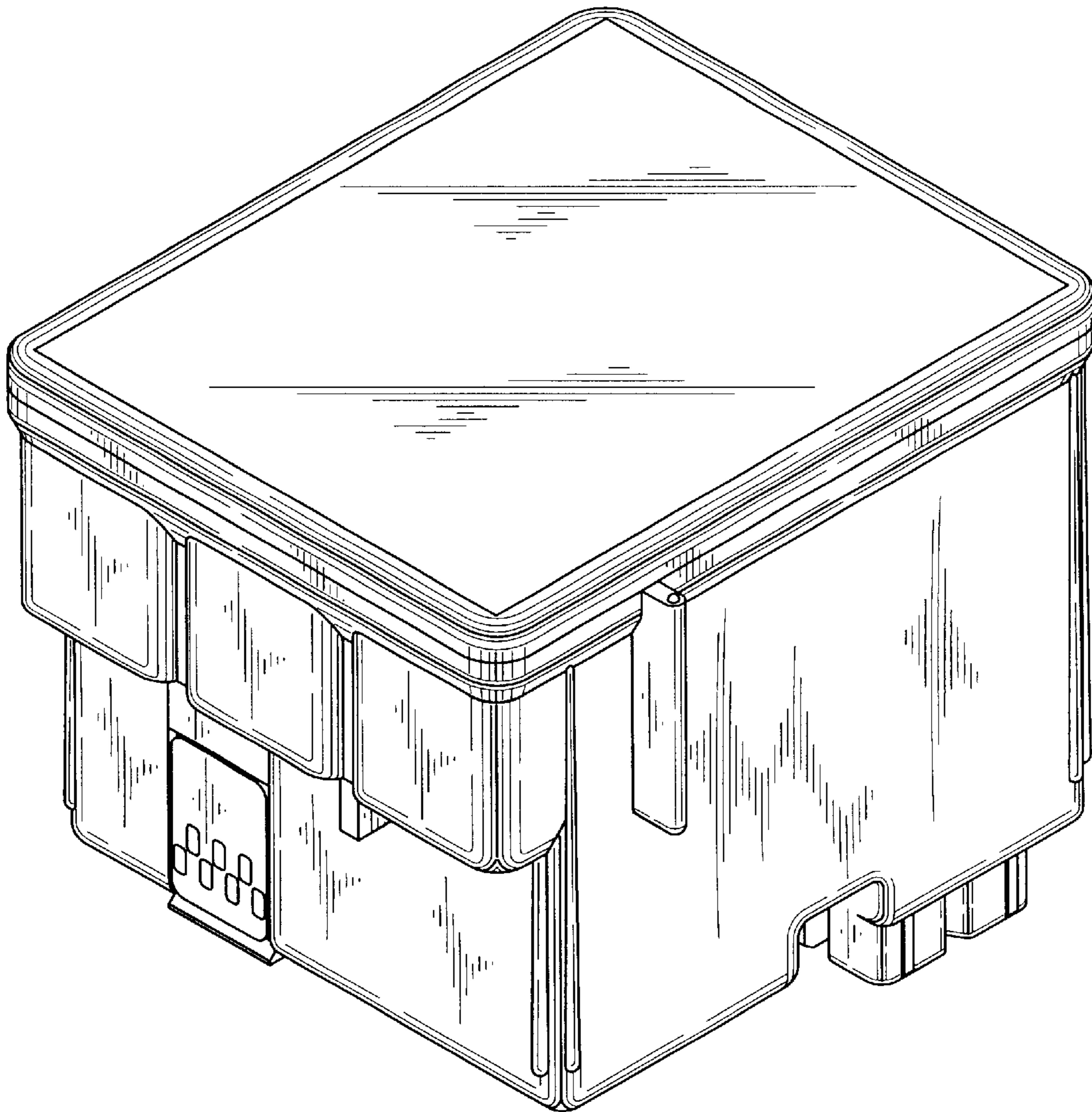

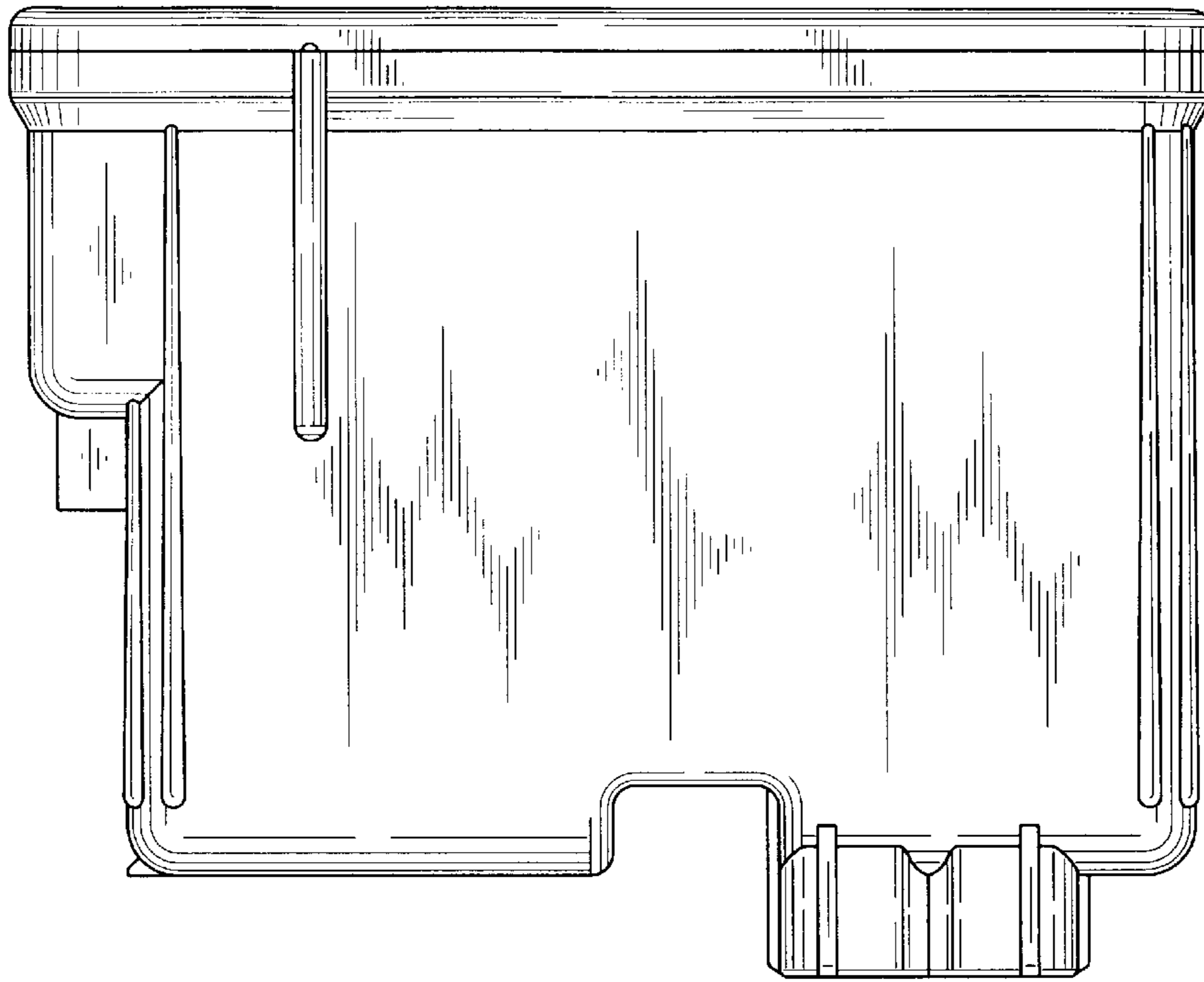

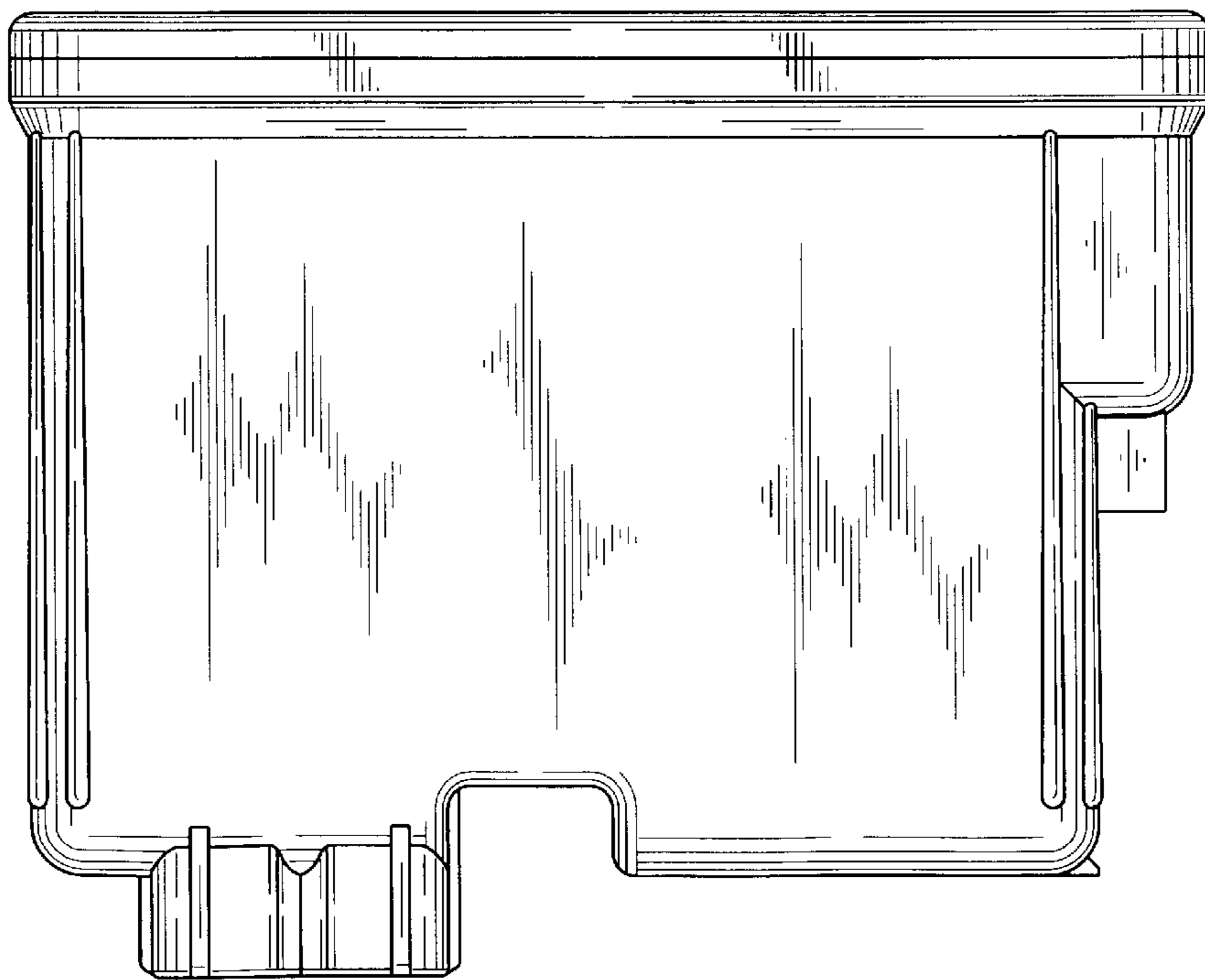

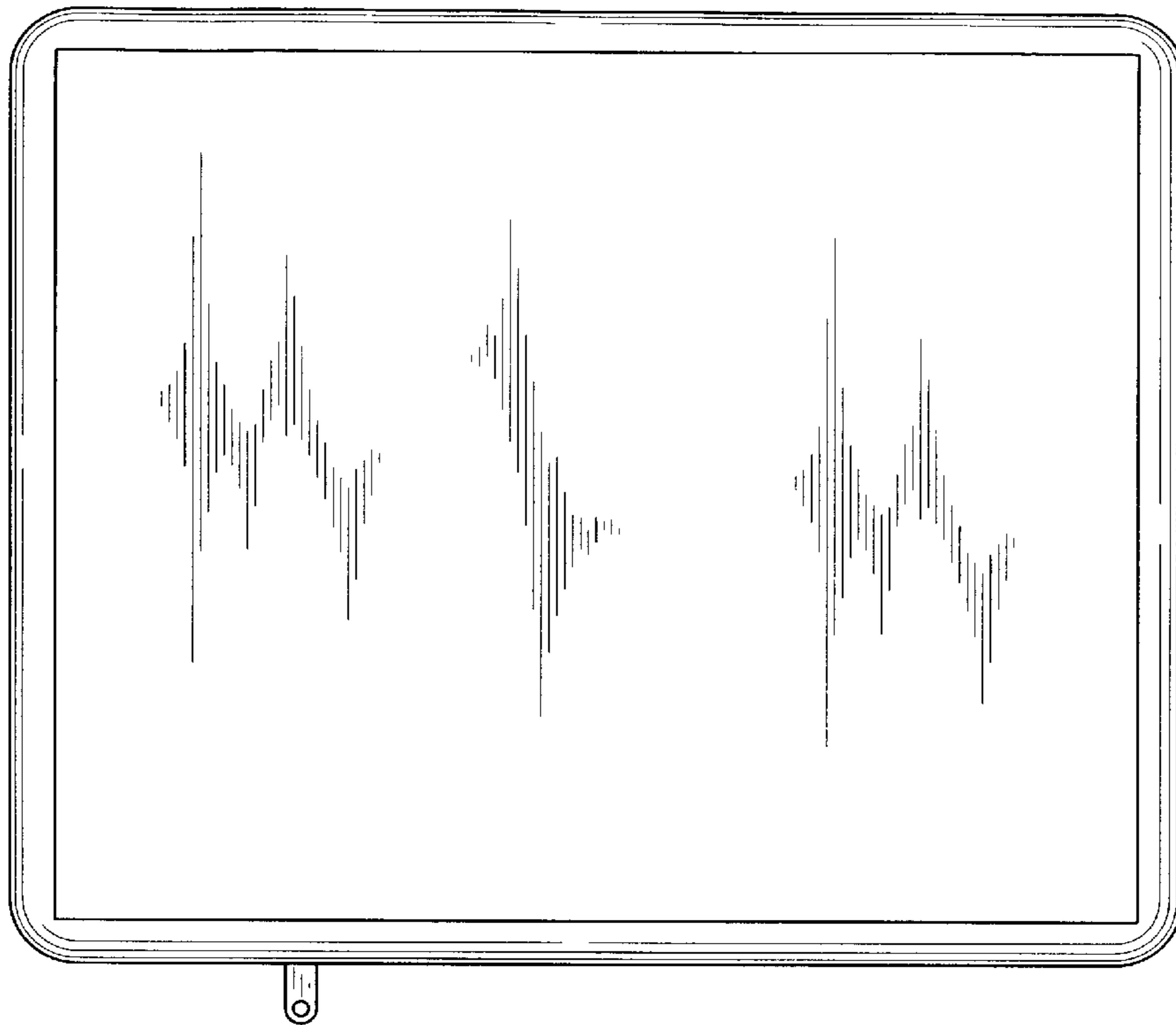

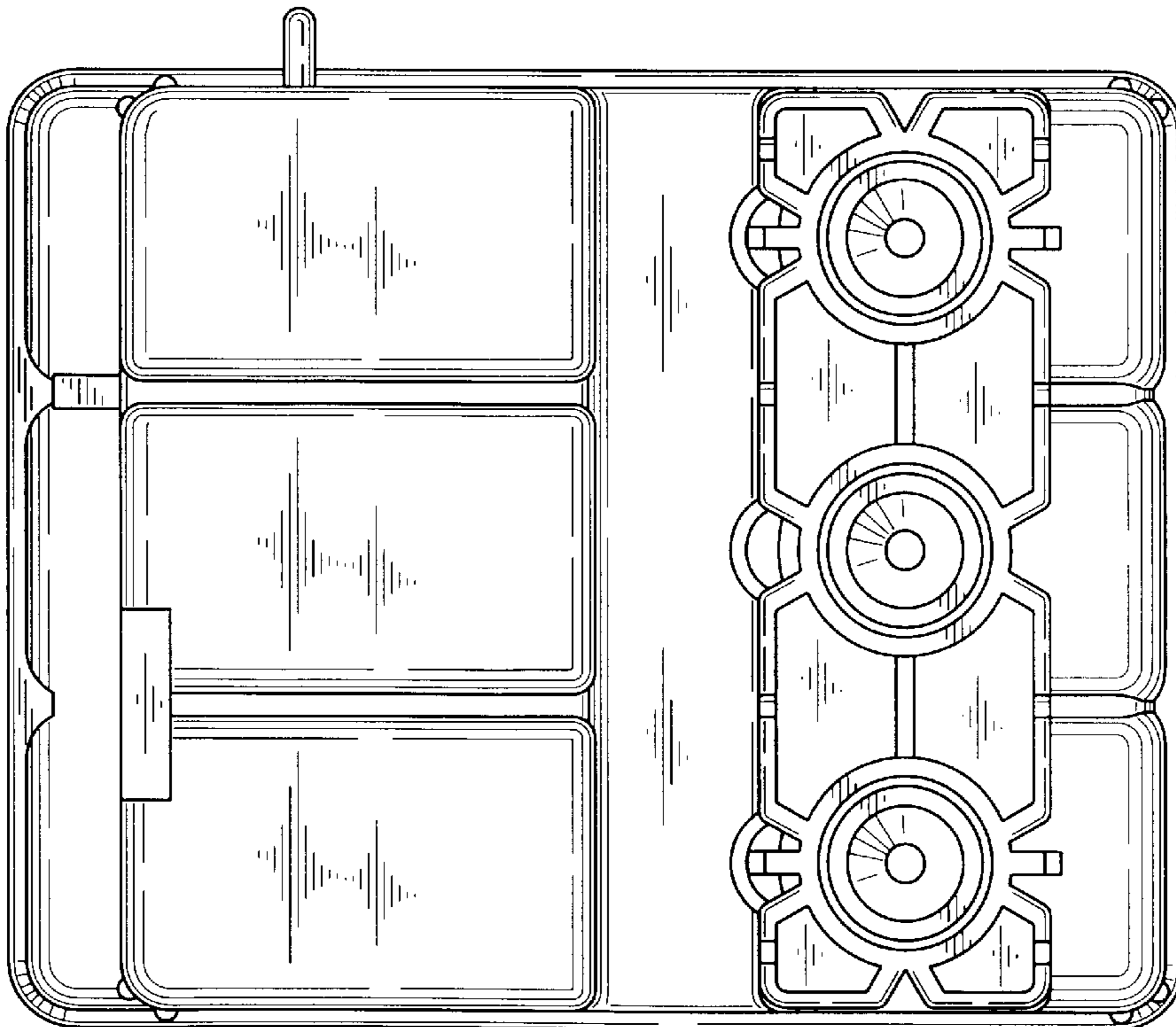

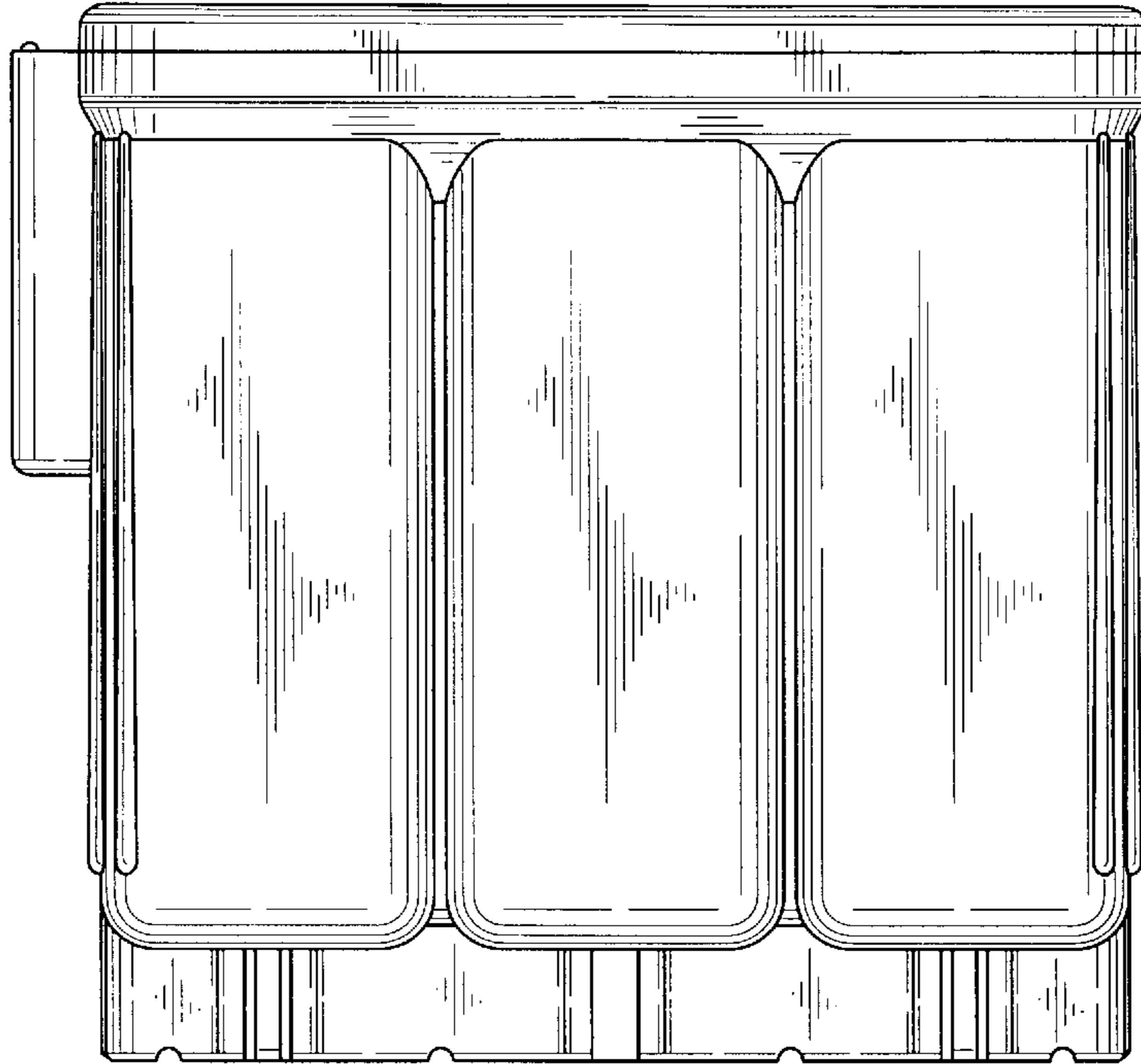

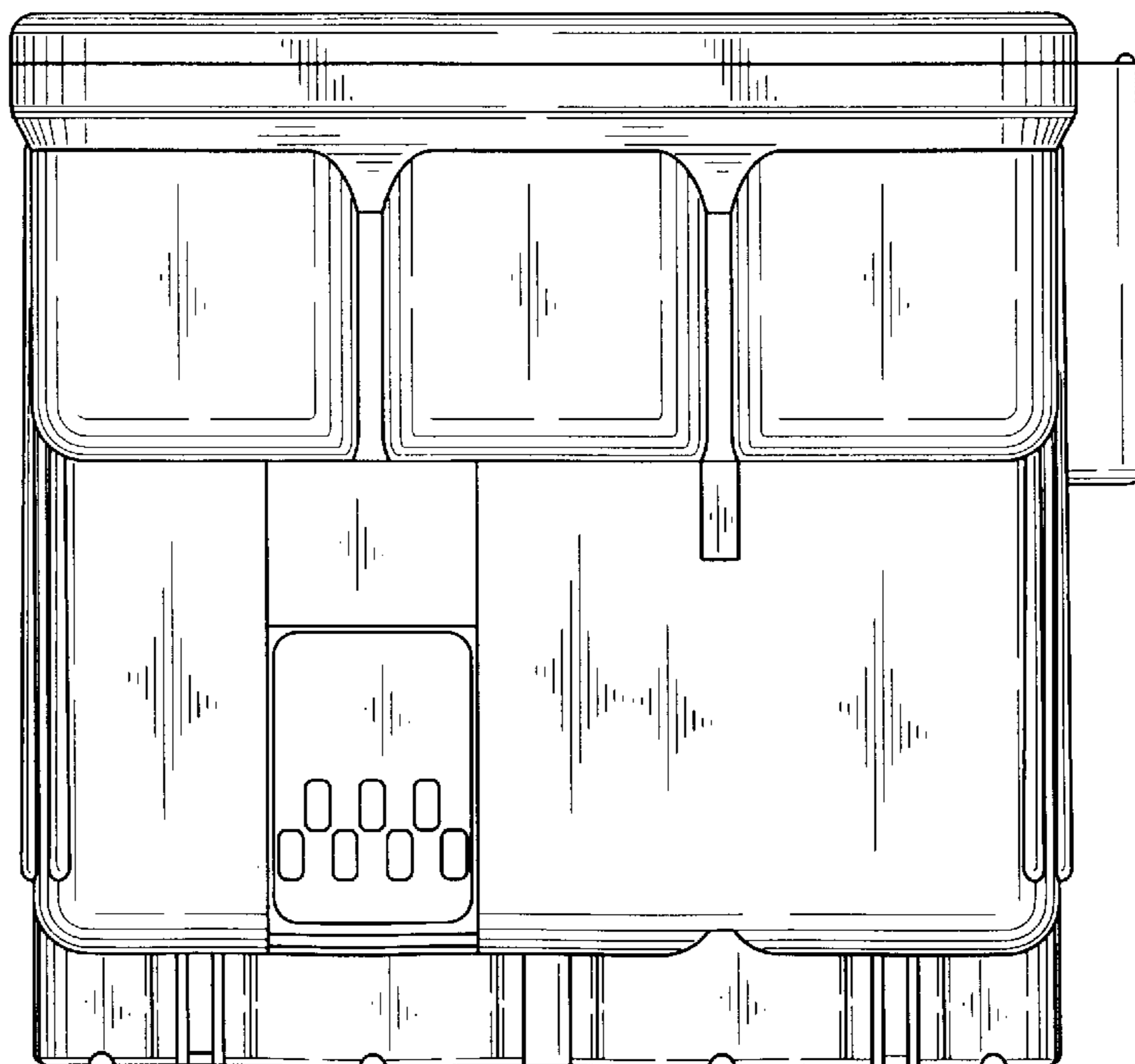

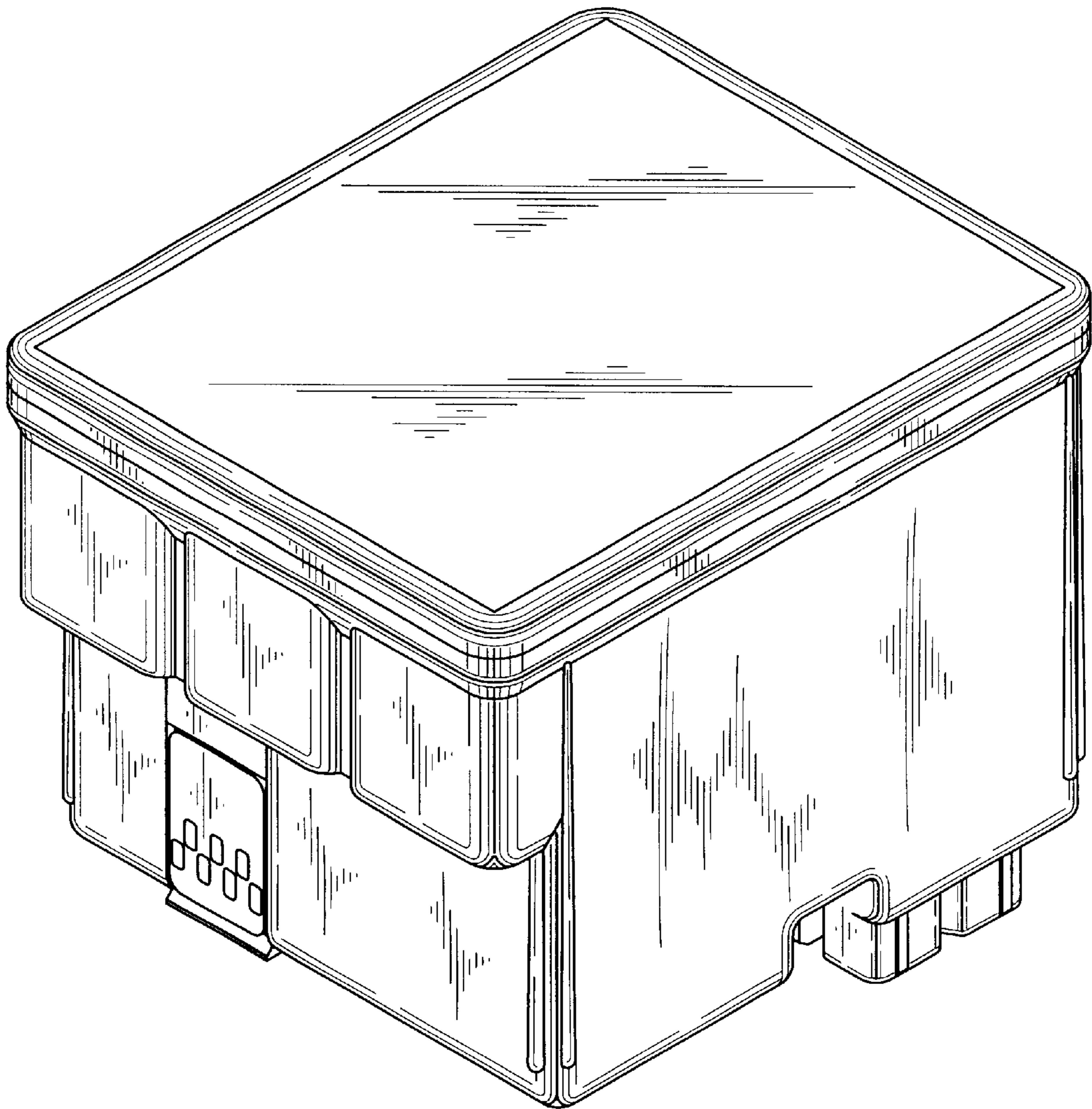

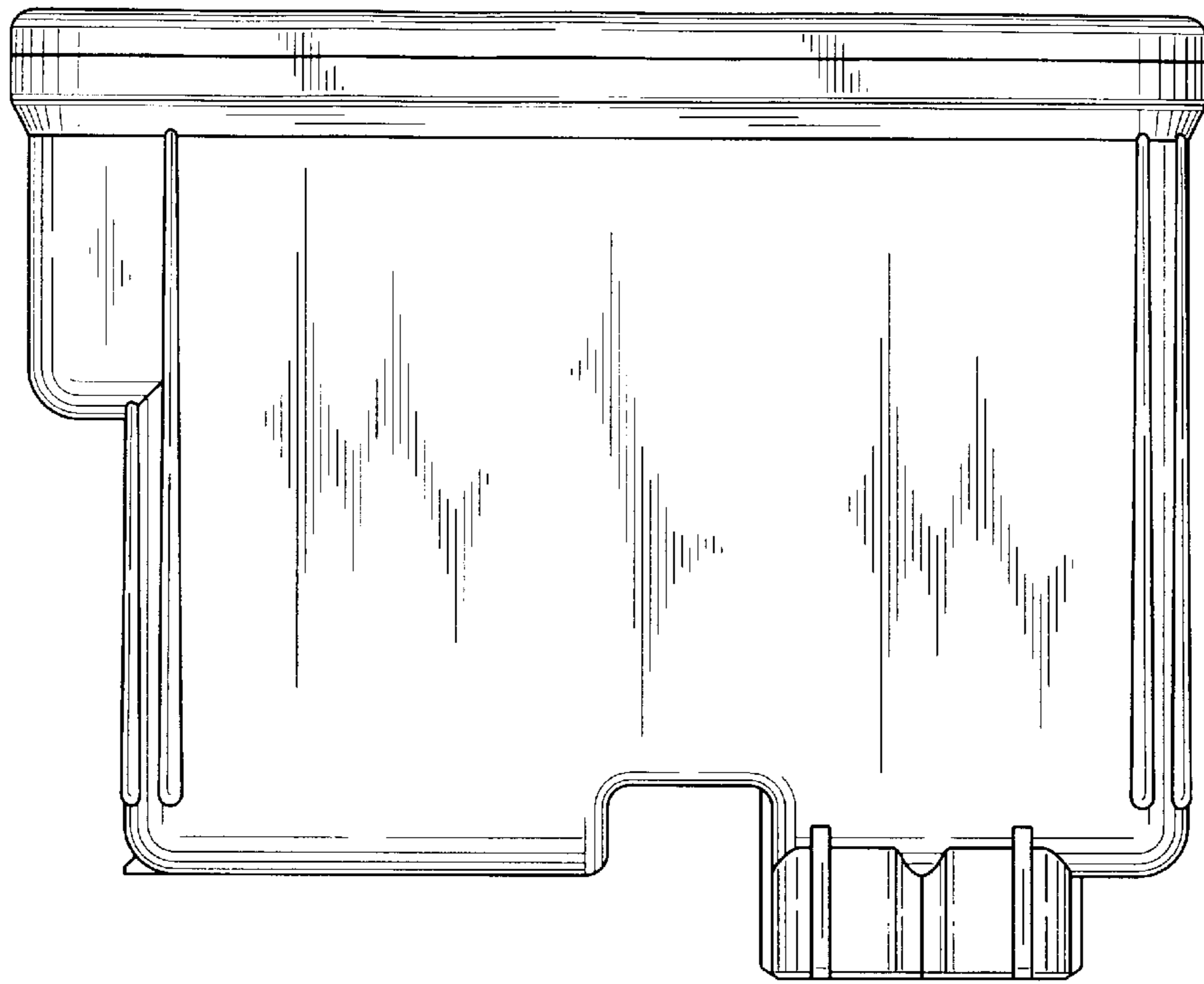

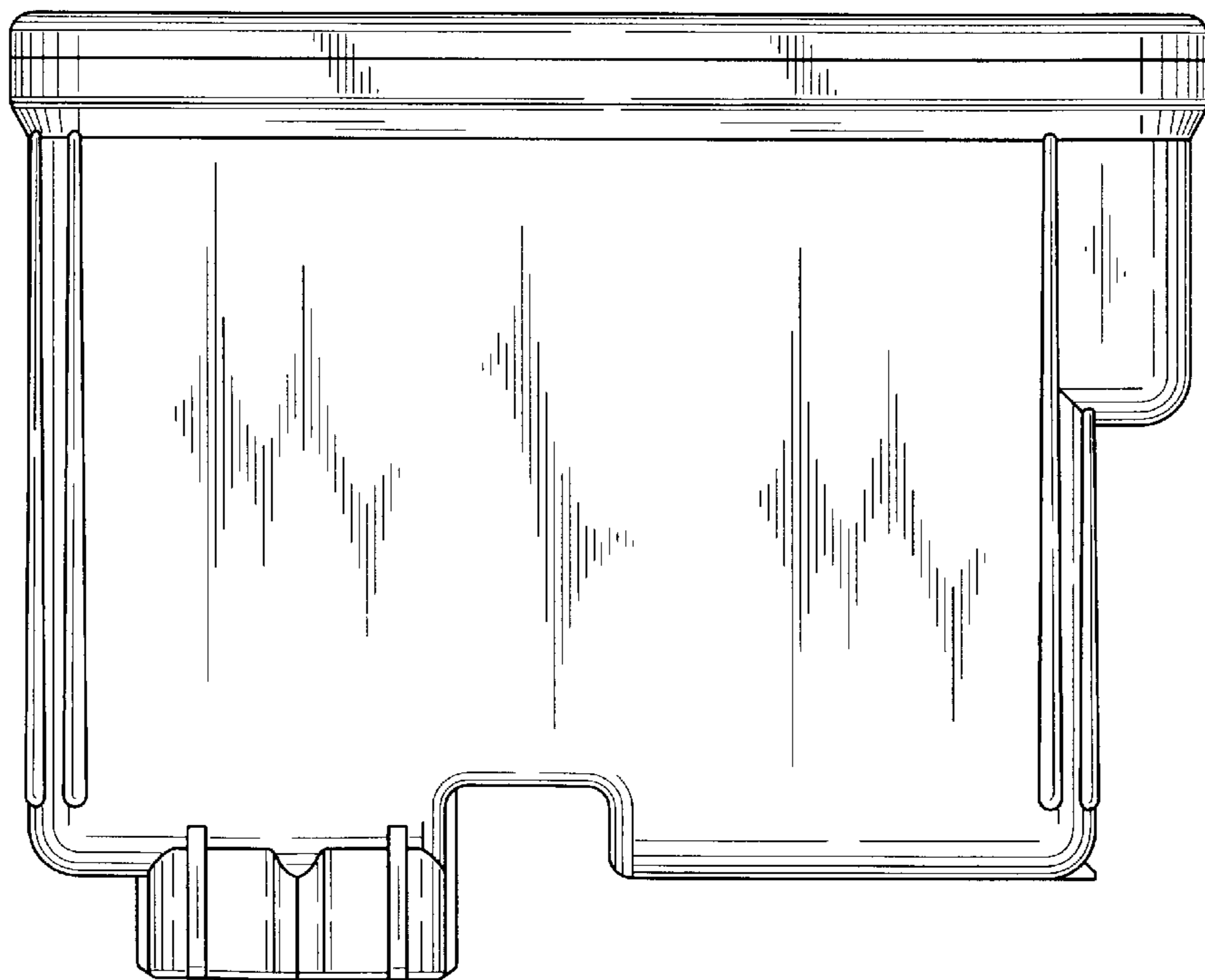

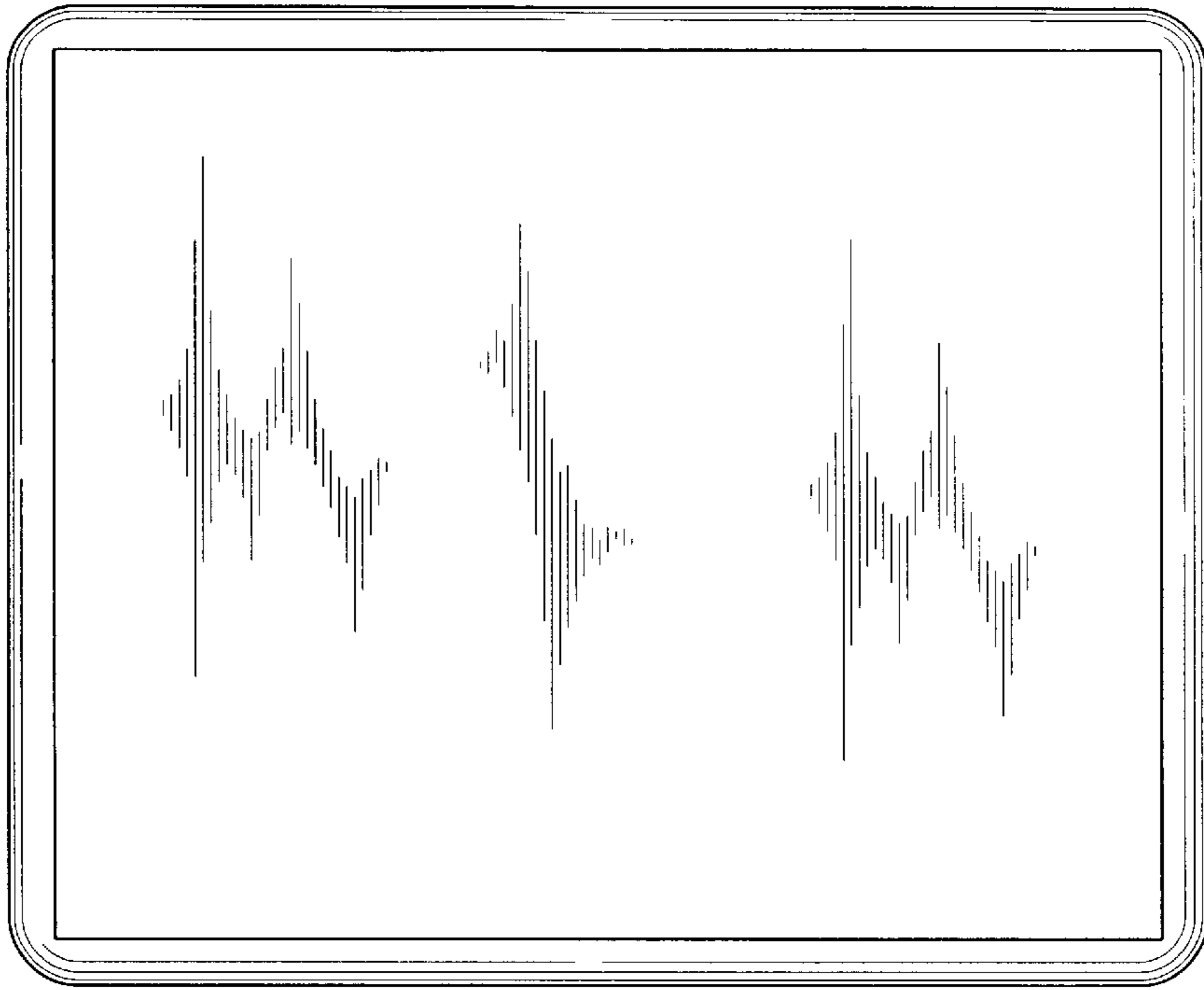

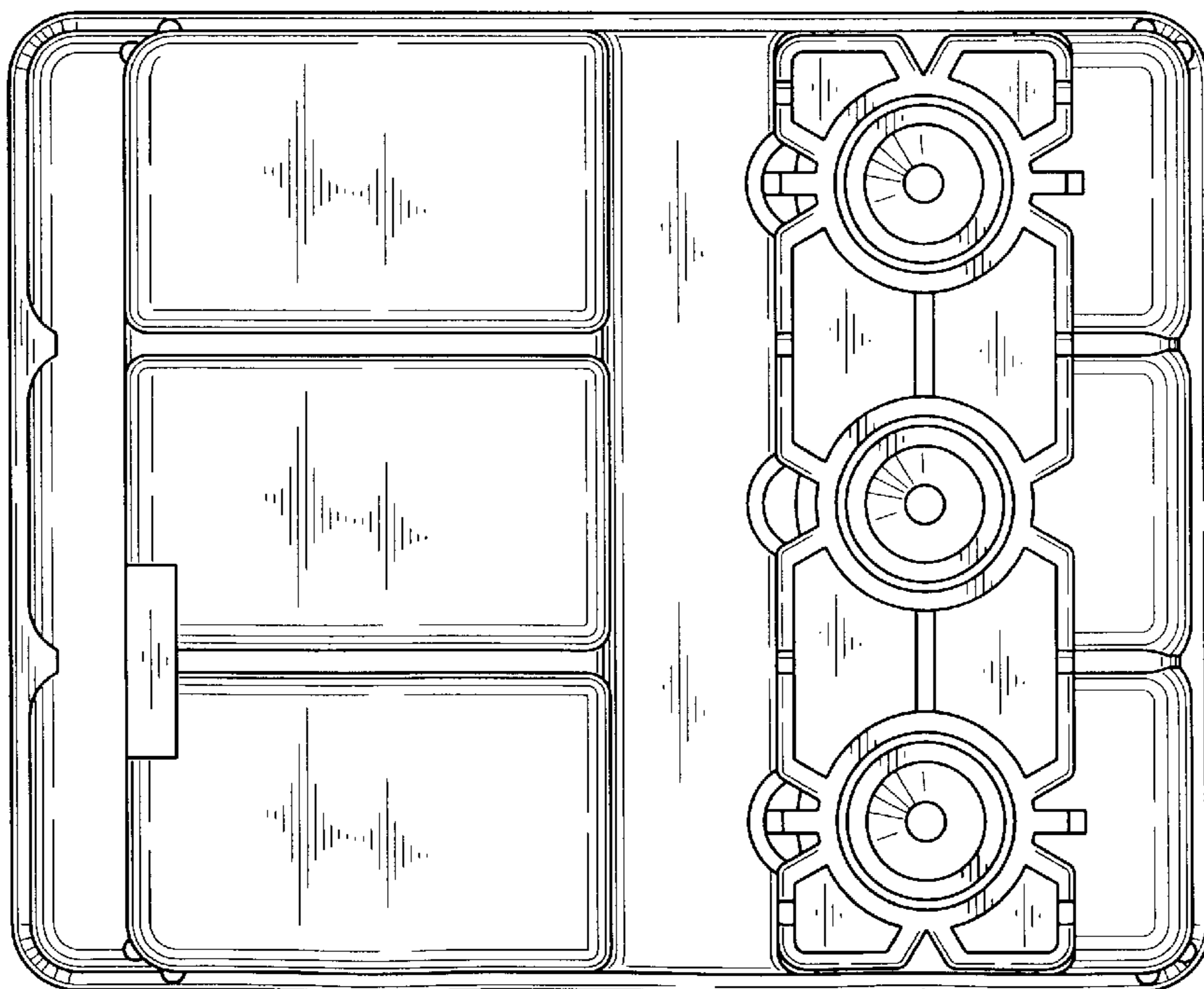

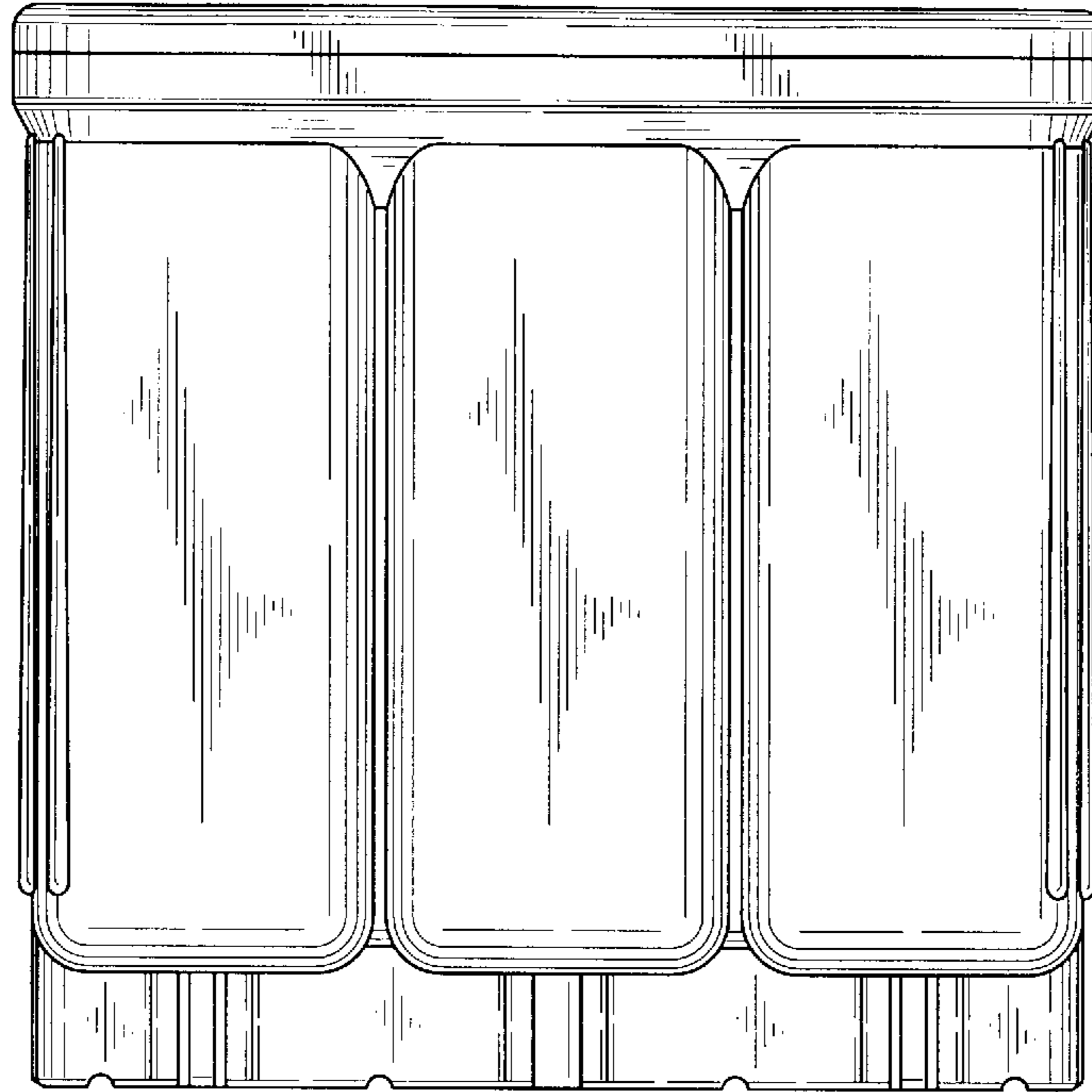

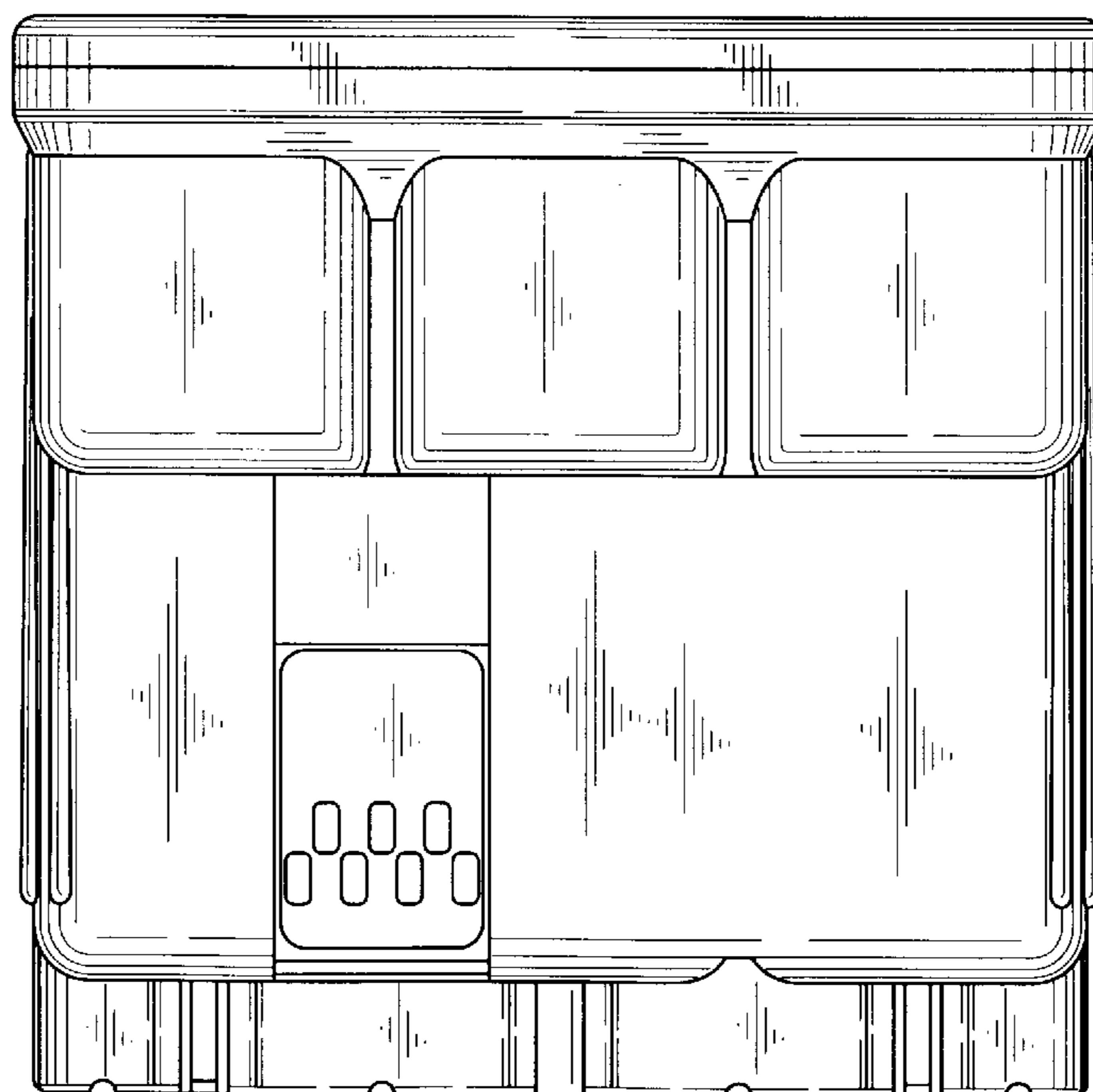

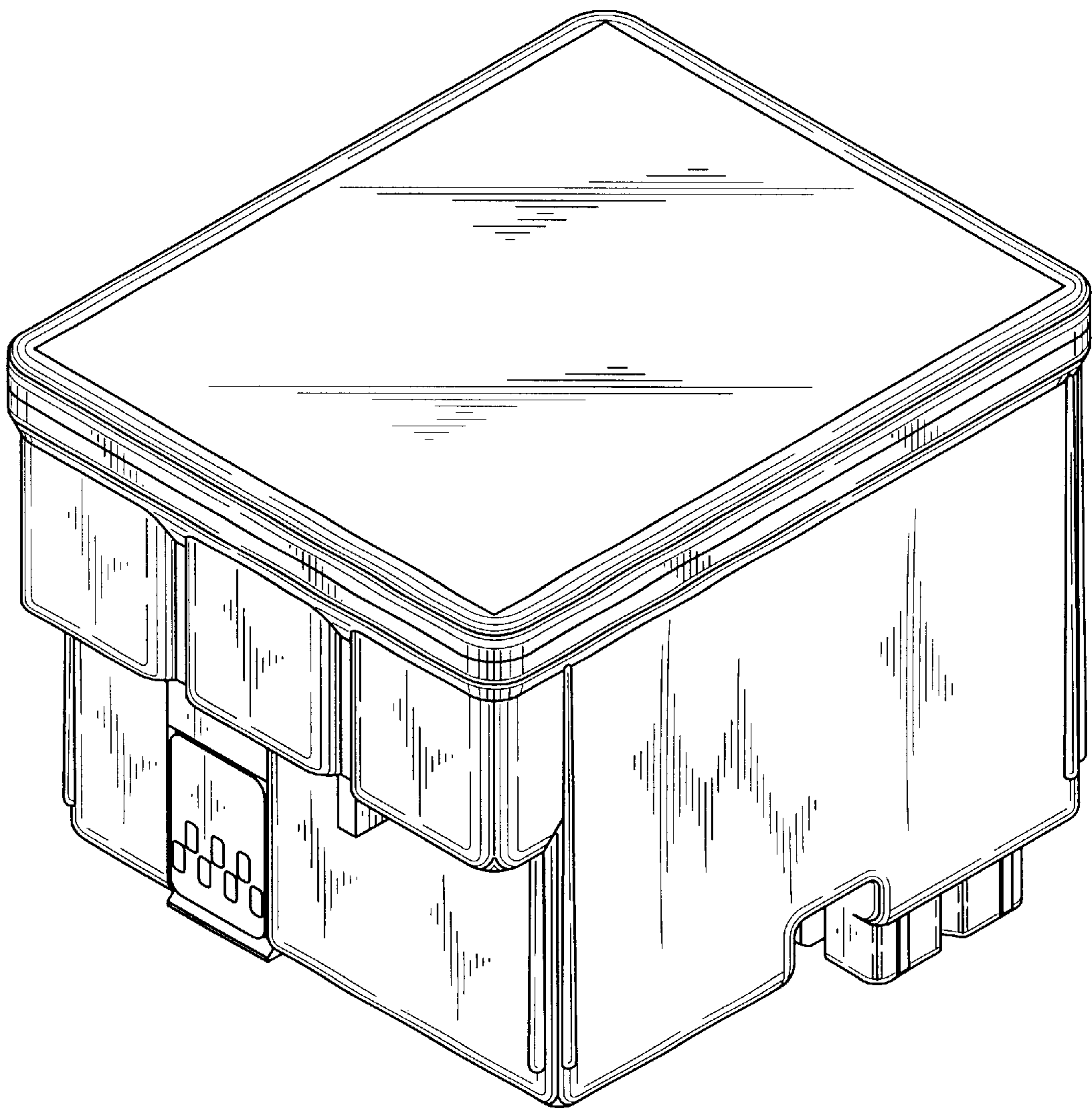

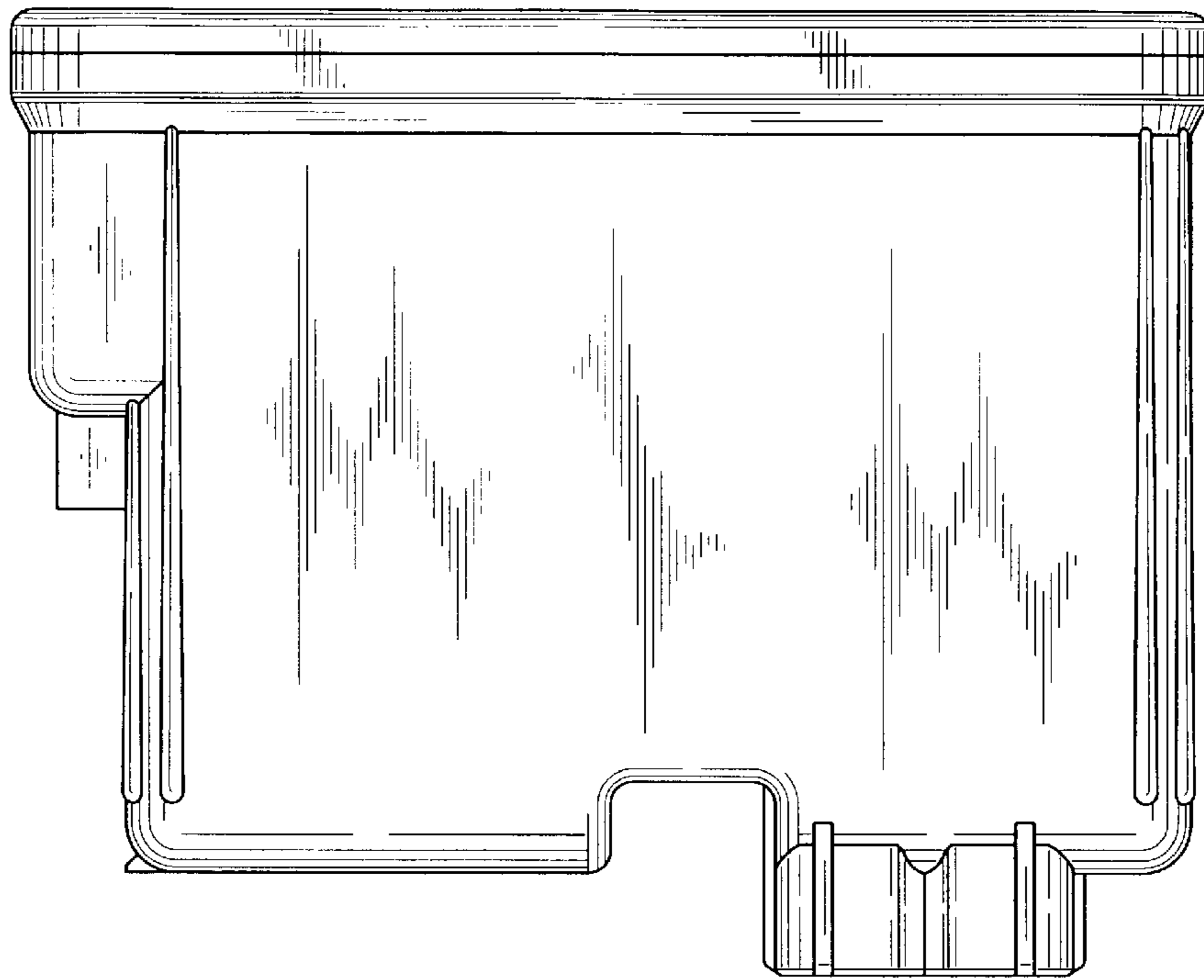

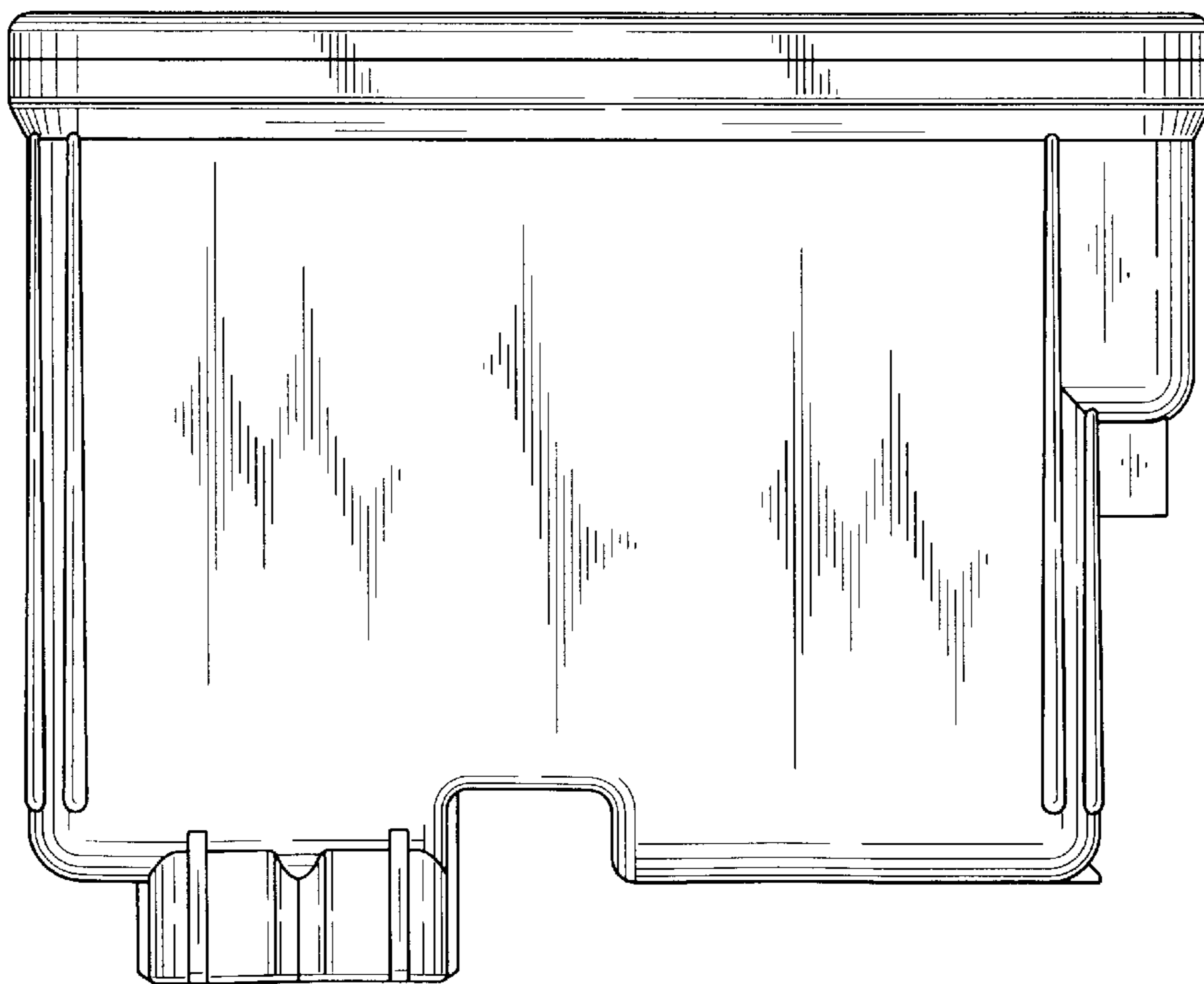

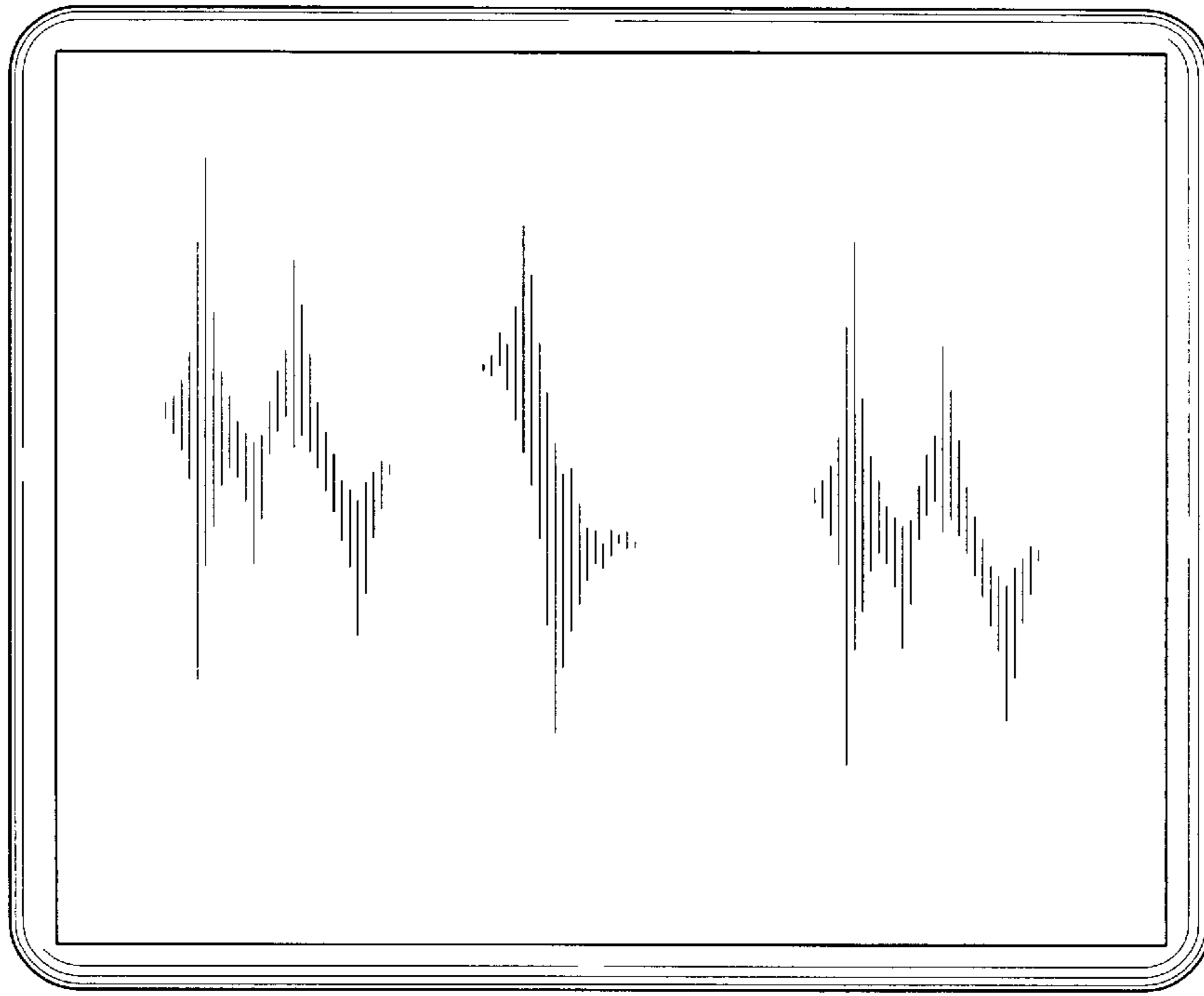

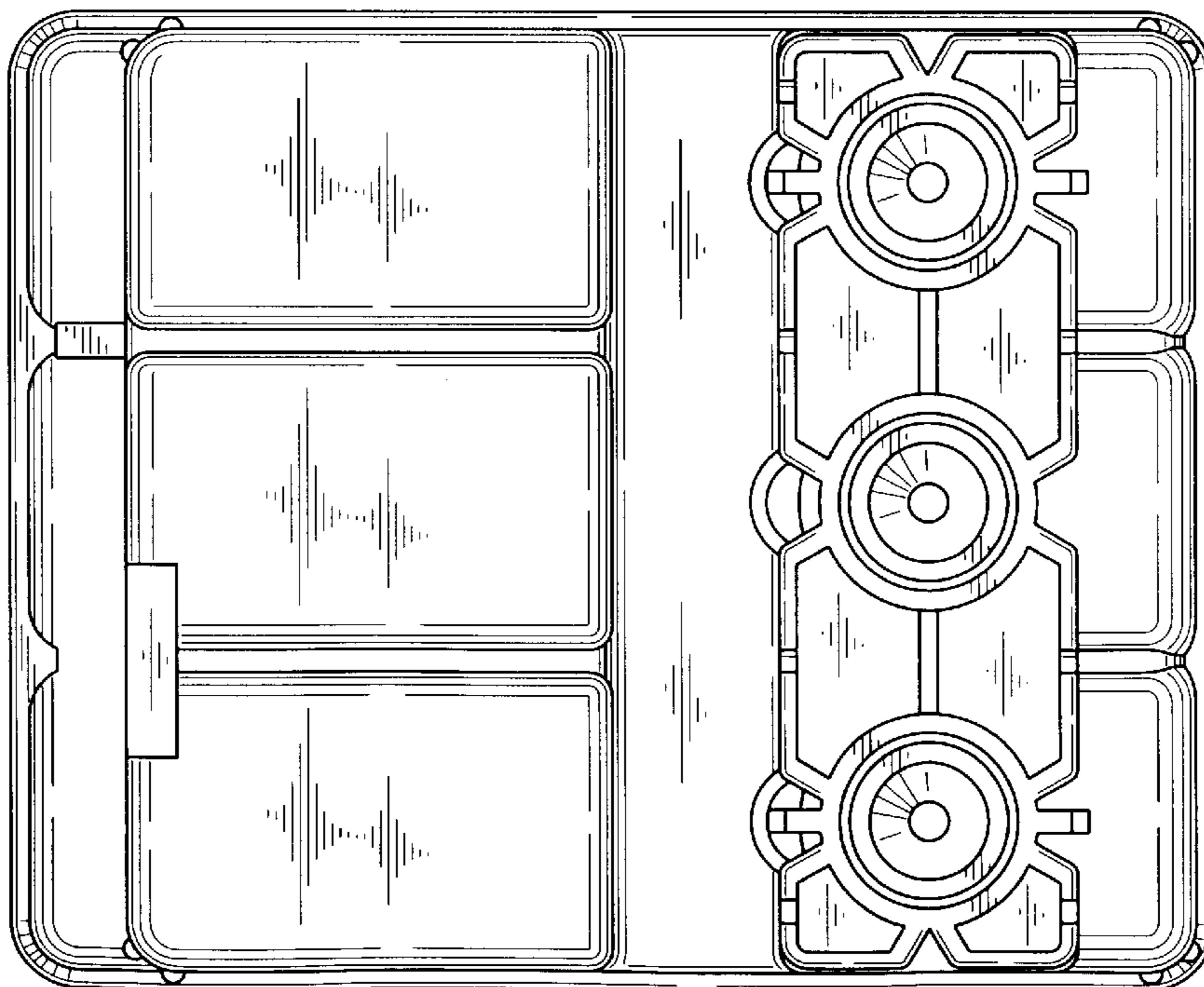

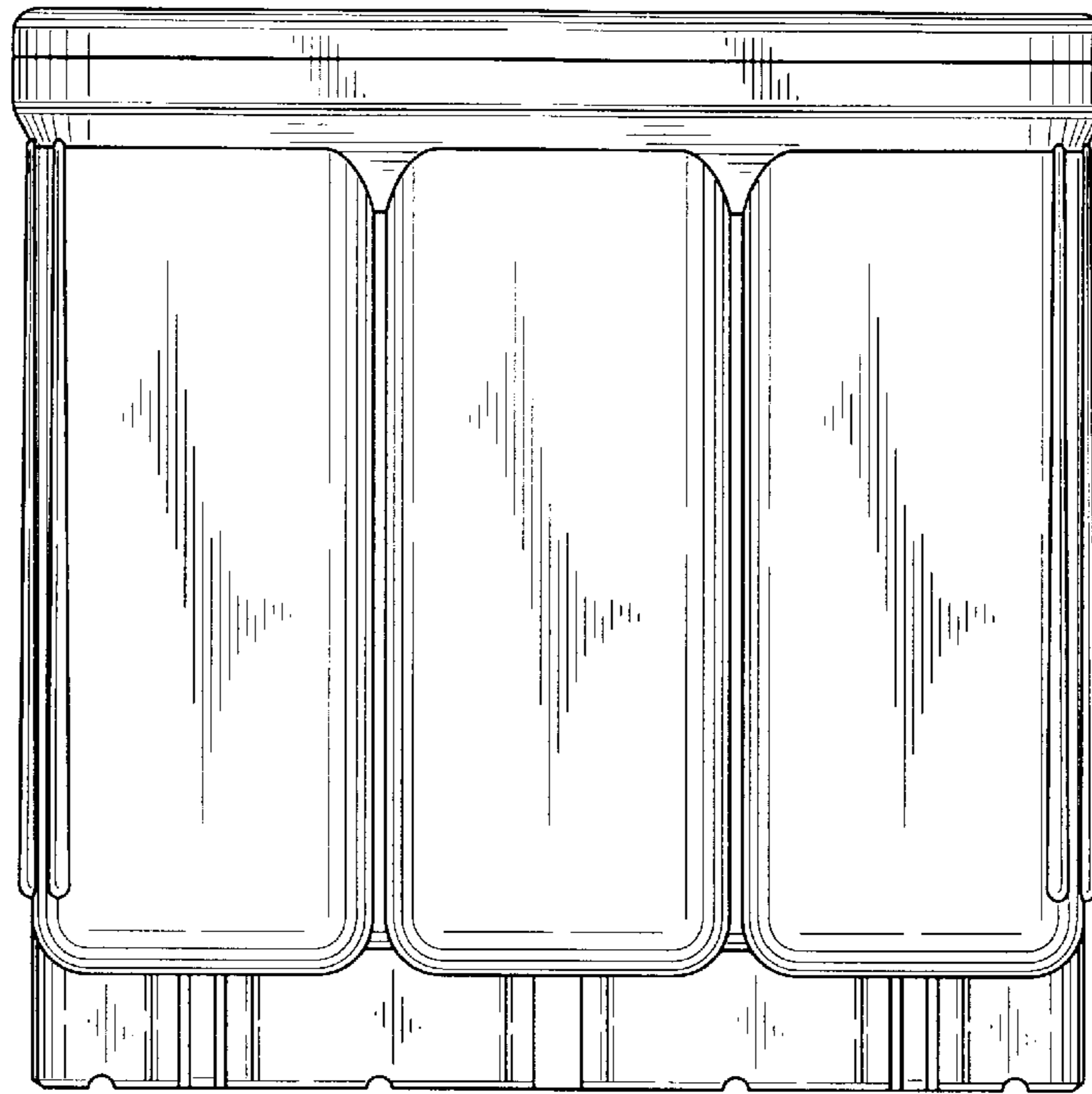
