FIG. 3 is a rear view of the patrol car decoy of the present invention showing my new design.

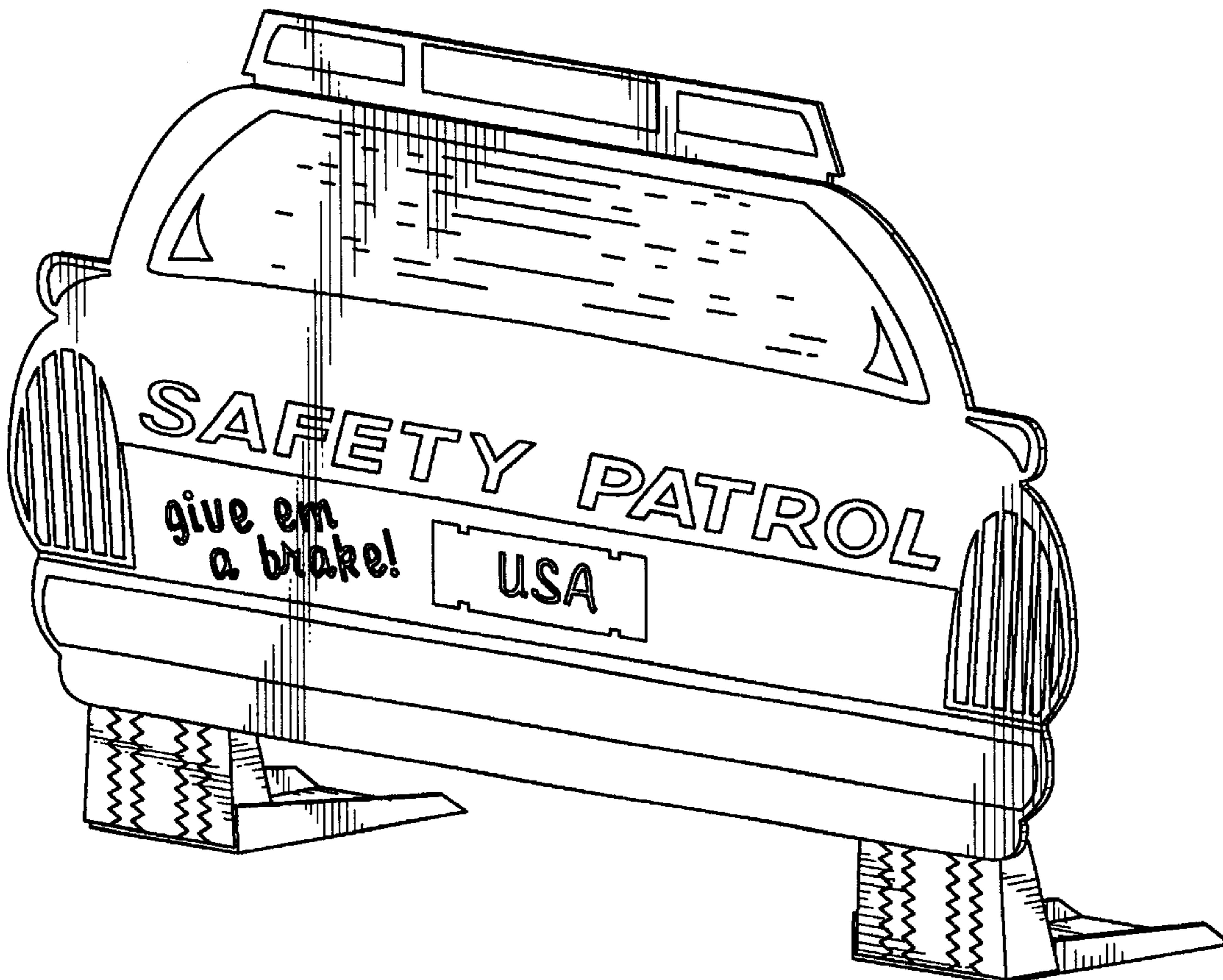
FIG. 4 is a right side view of the patrol car decoy of the present invention showing my new design.

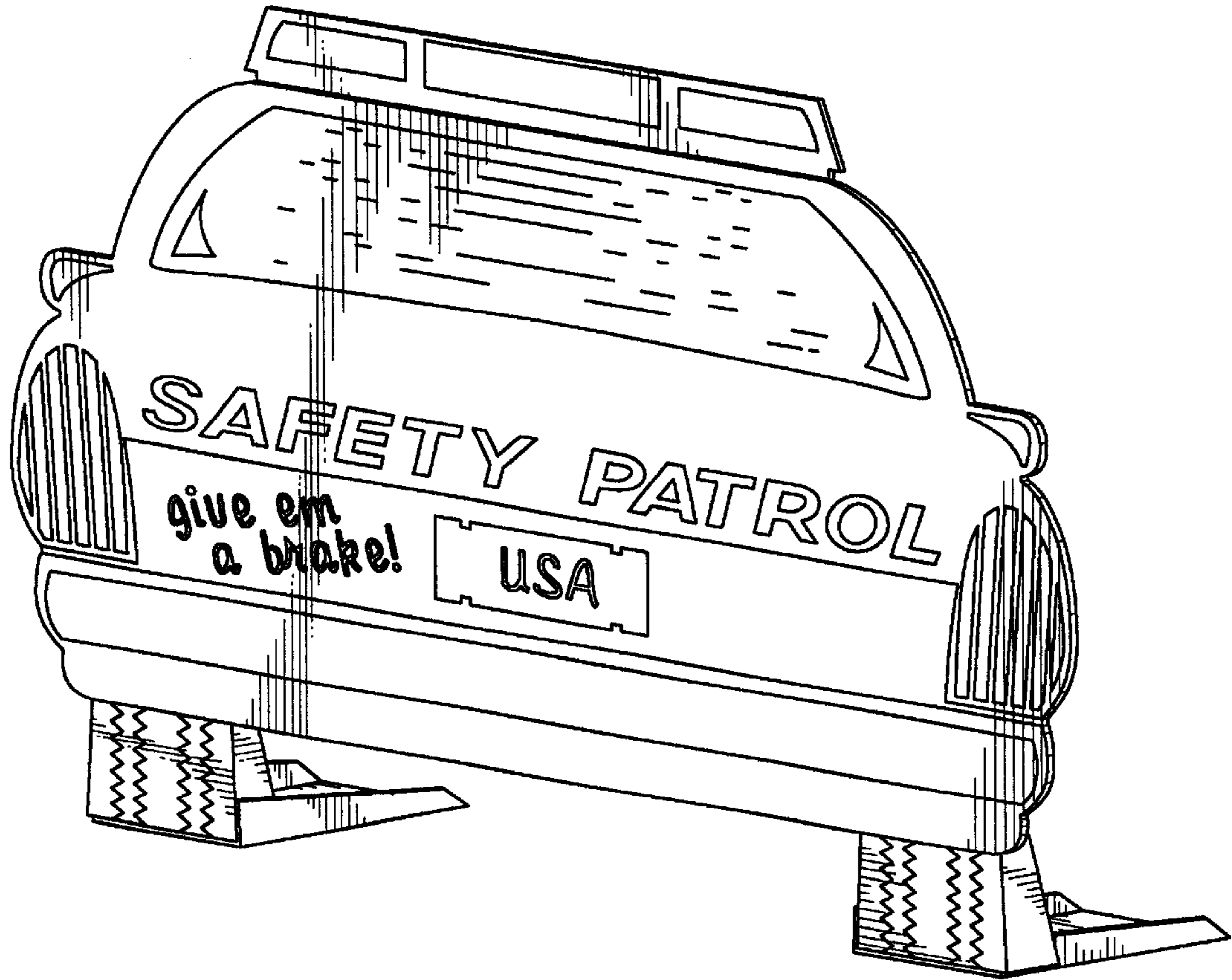

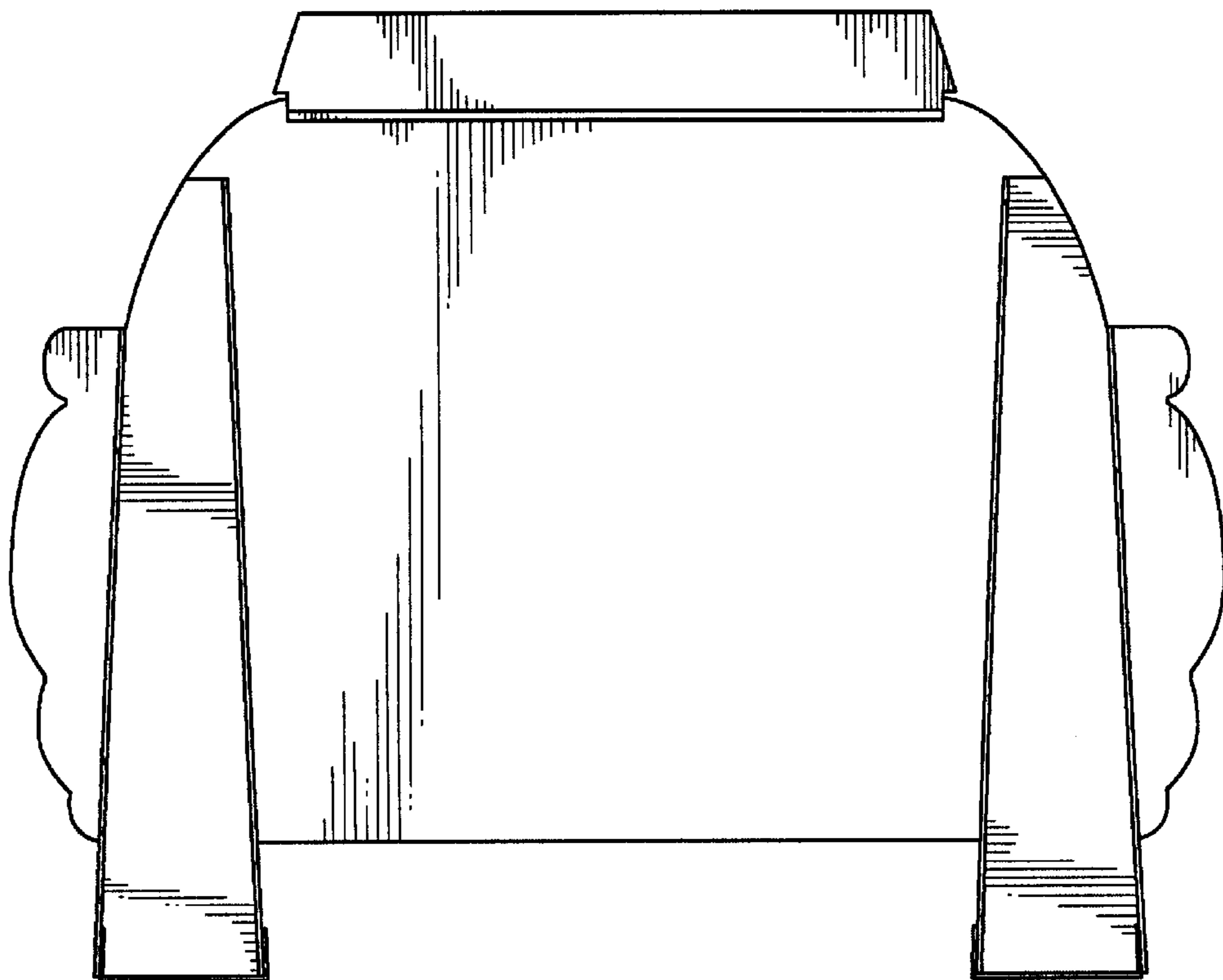

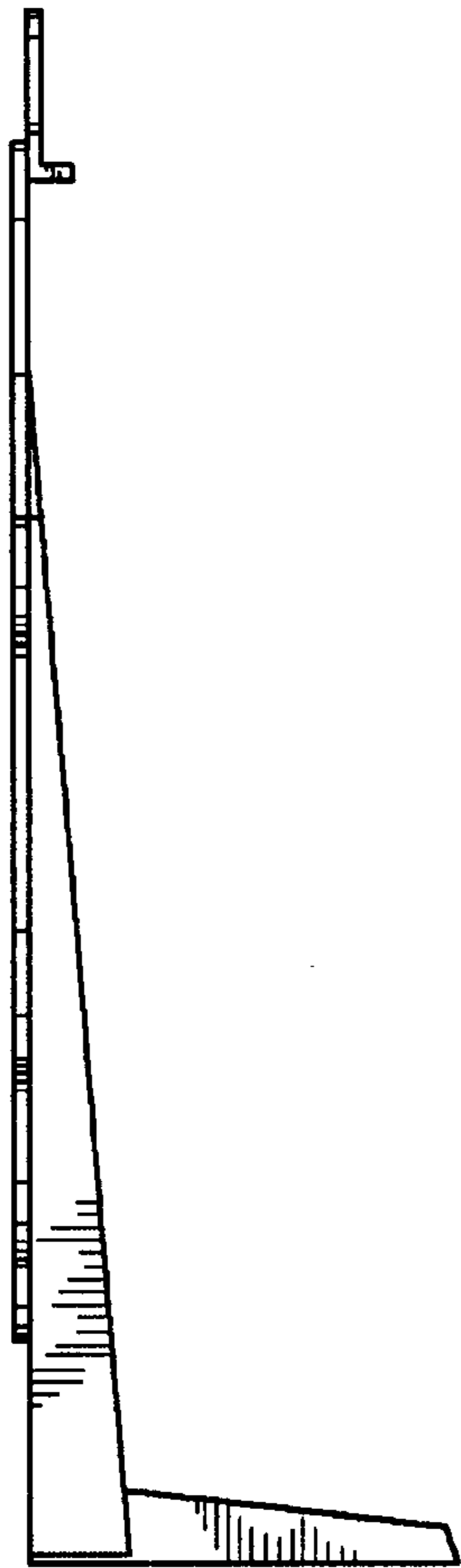

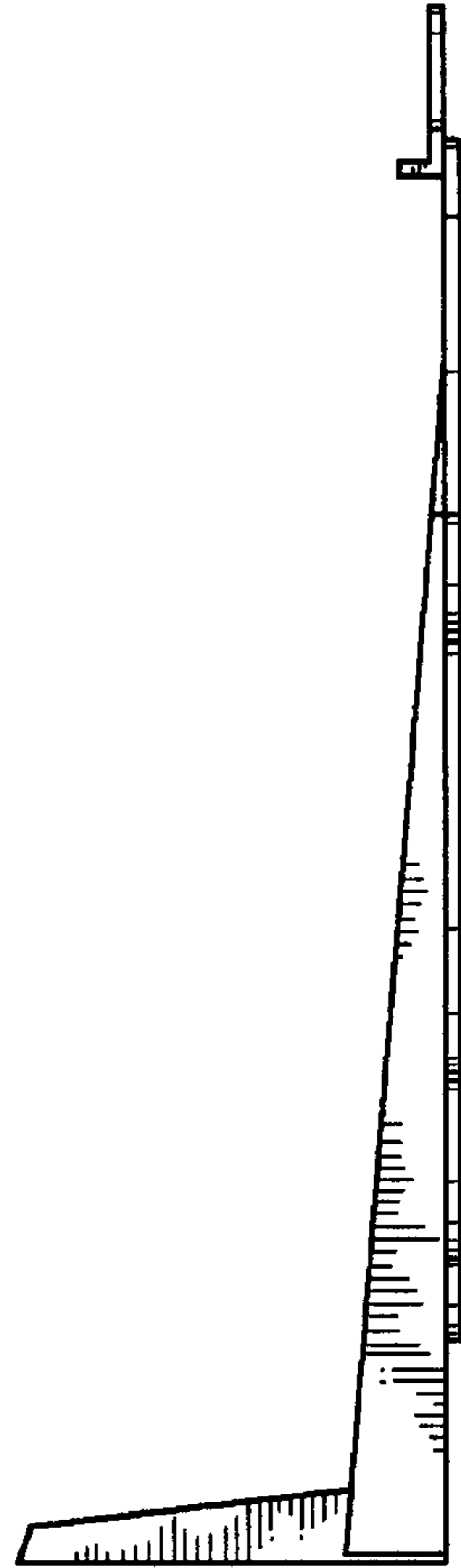

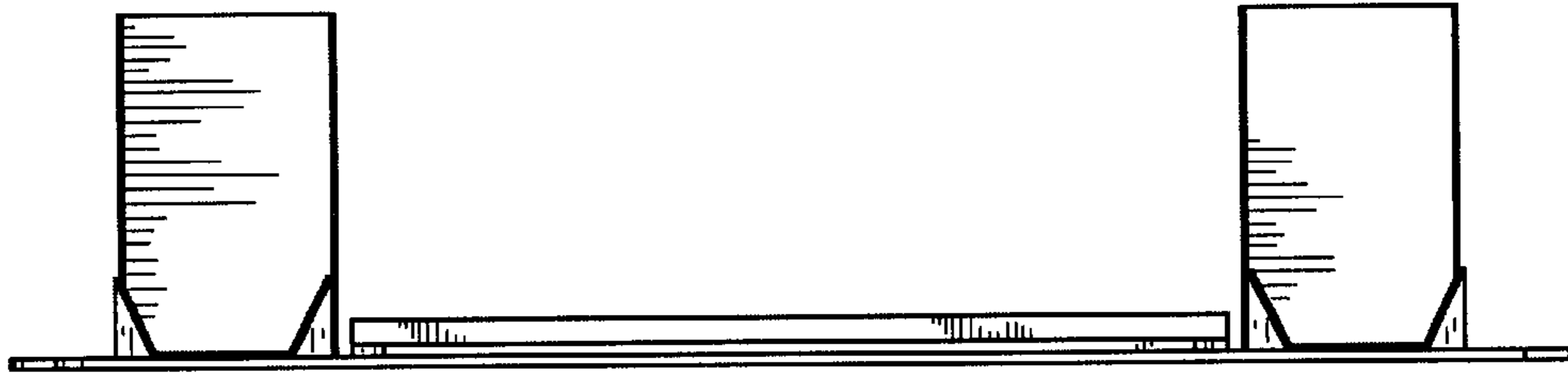

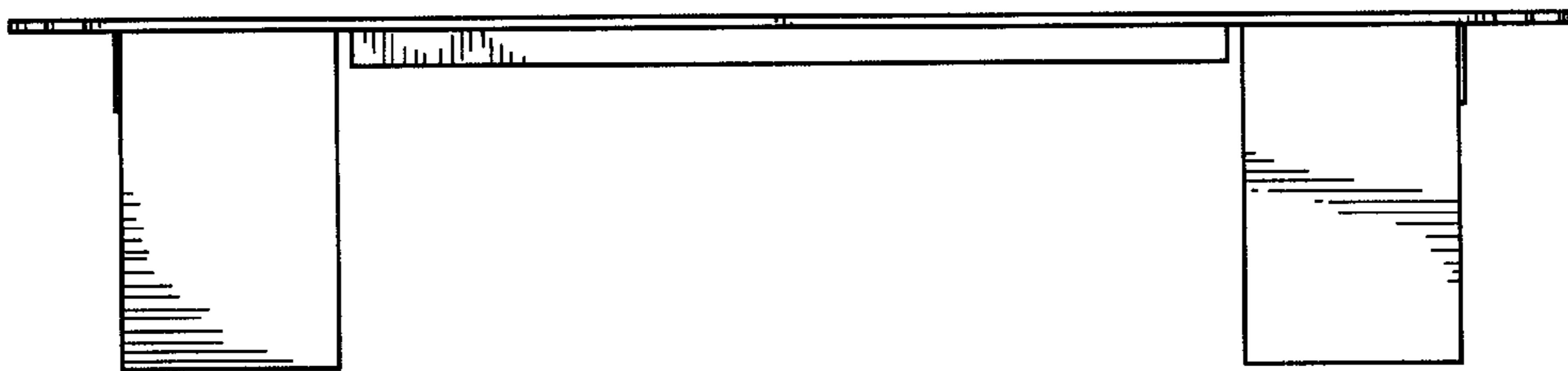
