(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a golf club head according to the present design;
 FIG. 2 is a front perspective view of the golf club head;
 FIG. 3 is a rear perspective view of the golf club head;
 FIG. 4 is a side elevation view of the golf club head;
 FIG. 5 is a side elevation view of the golf club head;
 FIG. 6 is a top plan view of the golf club head;
 FIG. 7 is a bottom plan view of the golf club head;
 FIG. 8 is a cross sectional view taken on line 8—8 of FIG. 2; and,
 FIG. 9 is a cross sectional view taken on line 9—9 of FIG. 4.

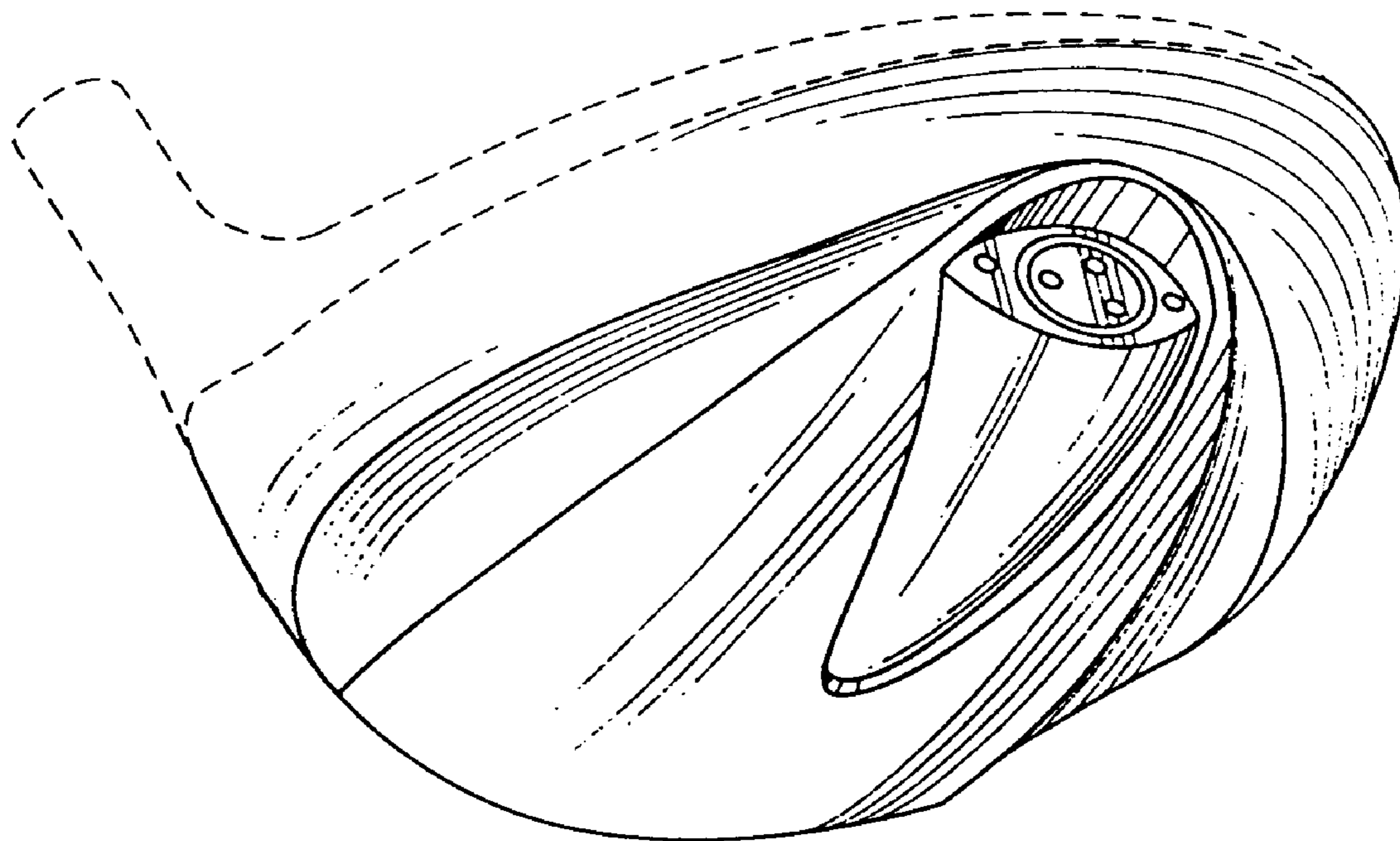

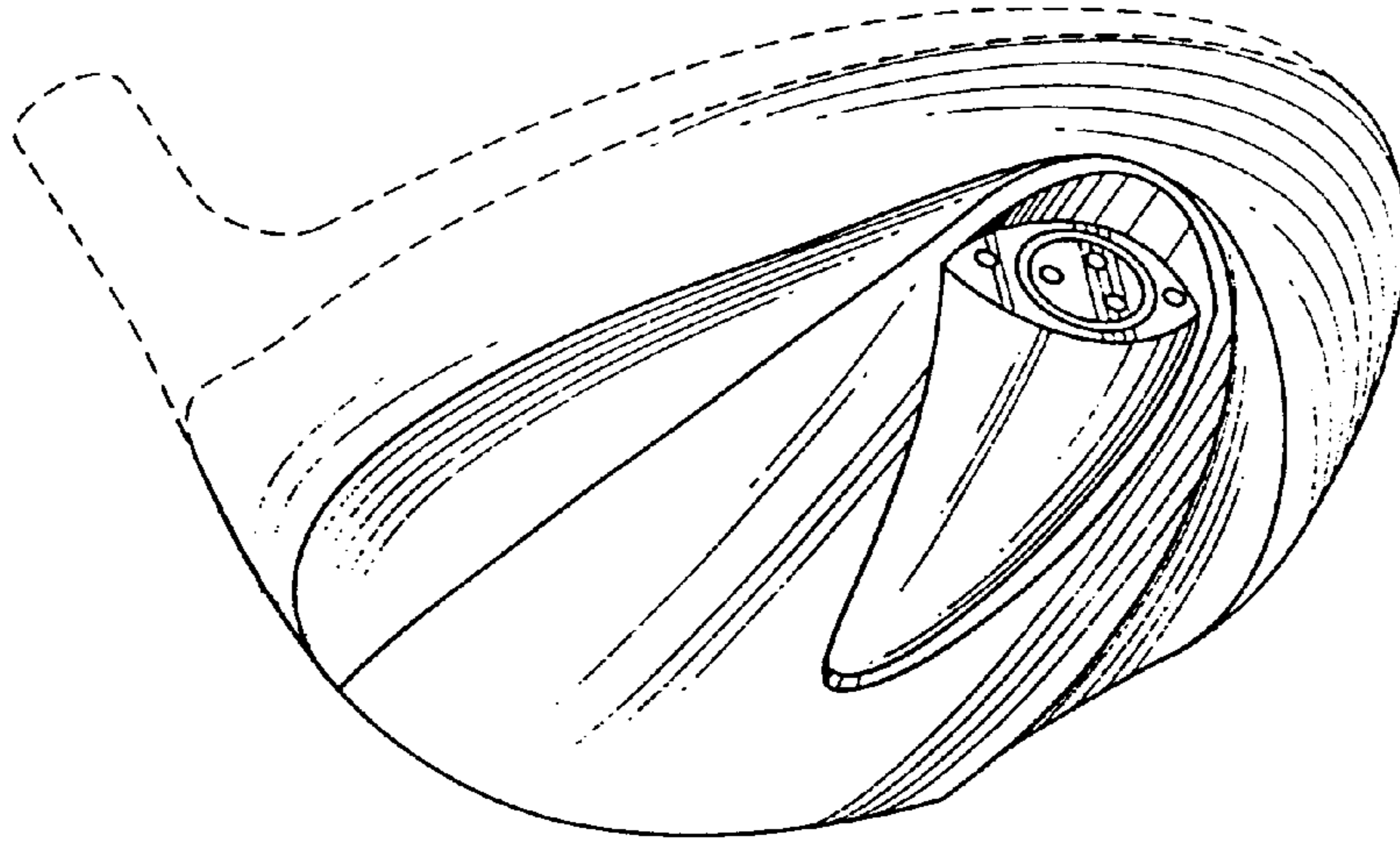

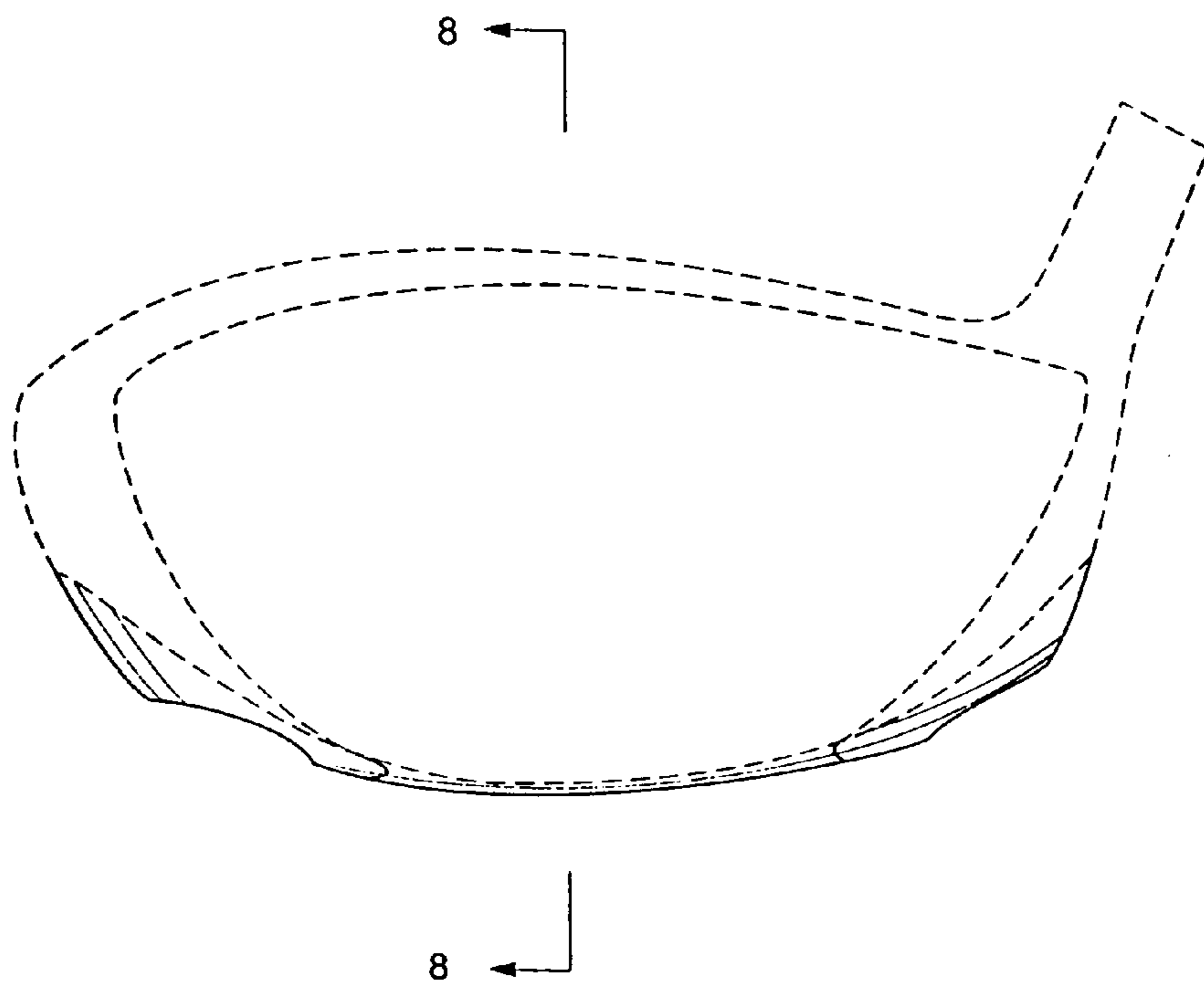

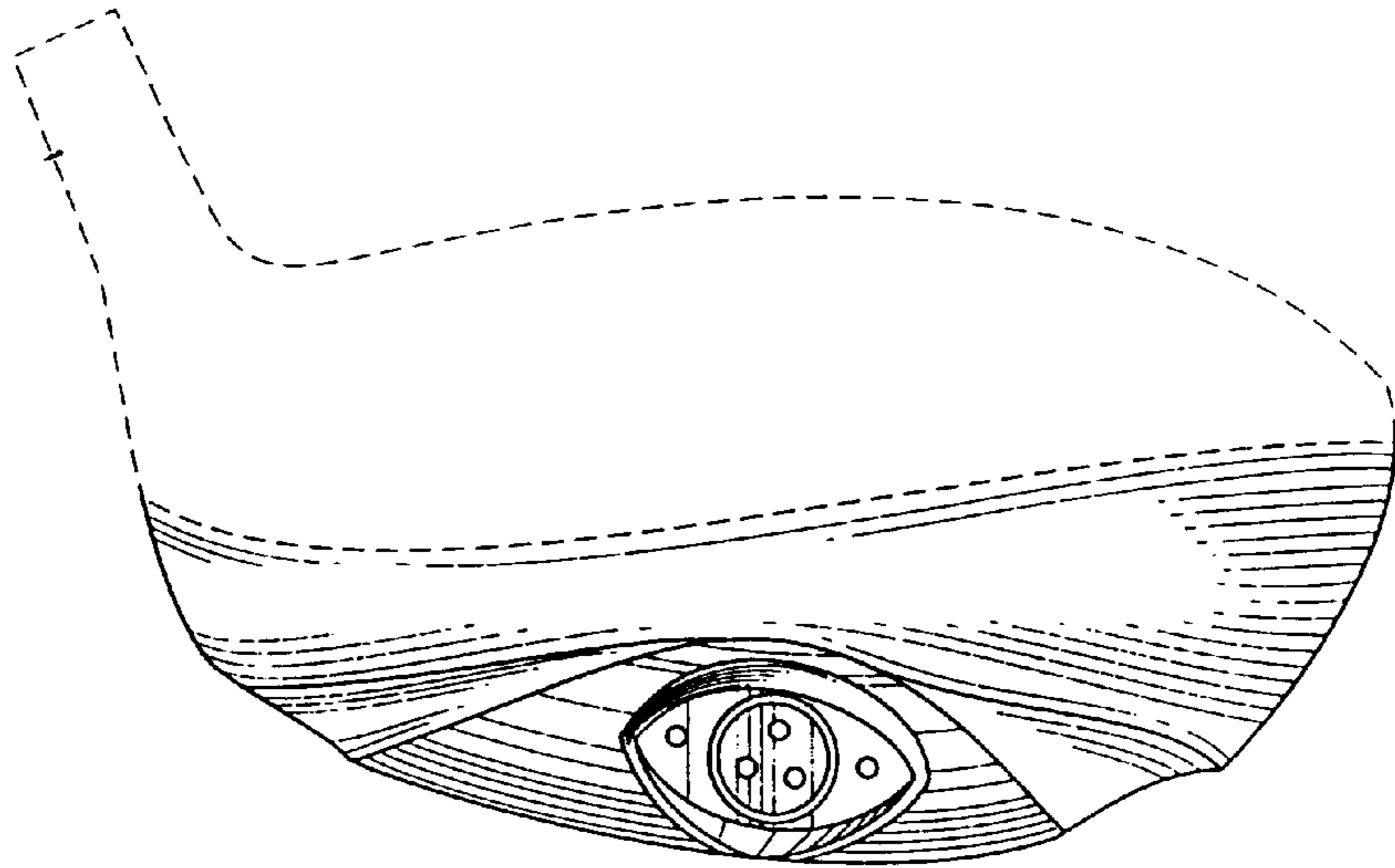

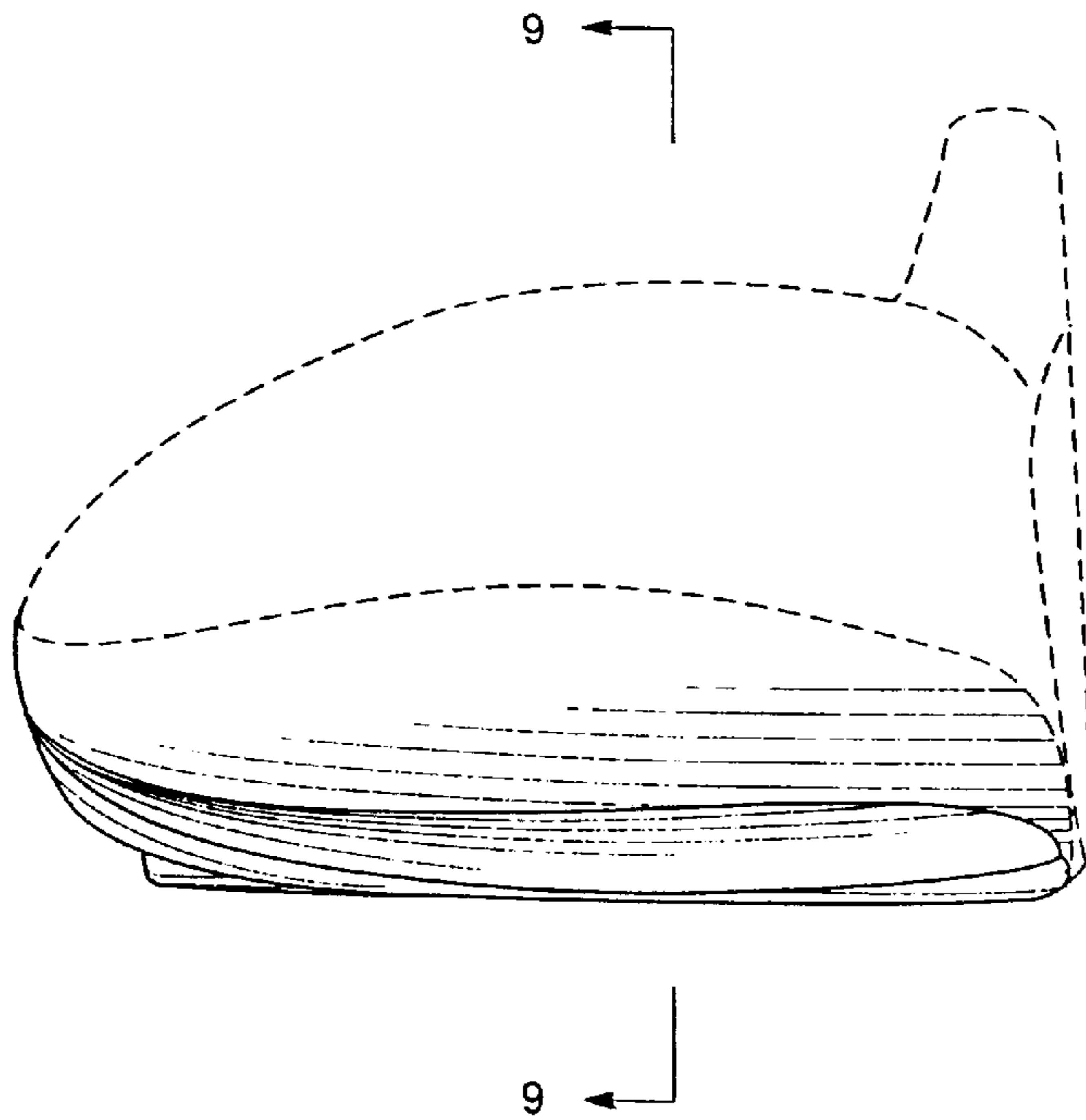

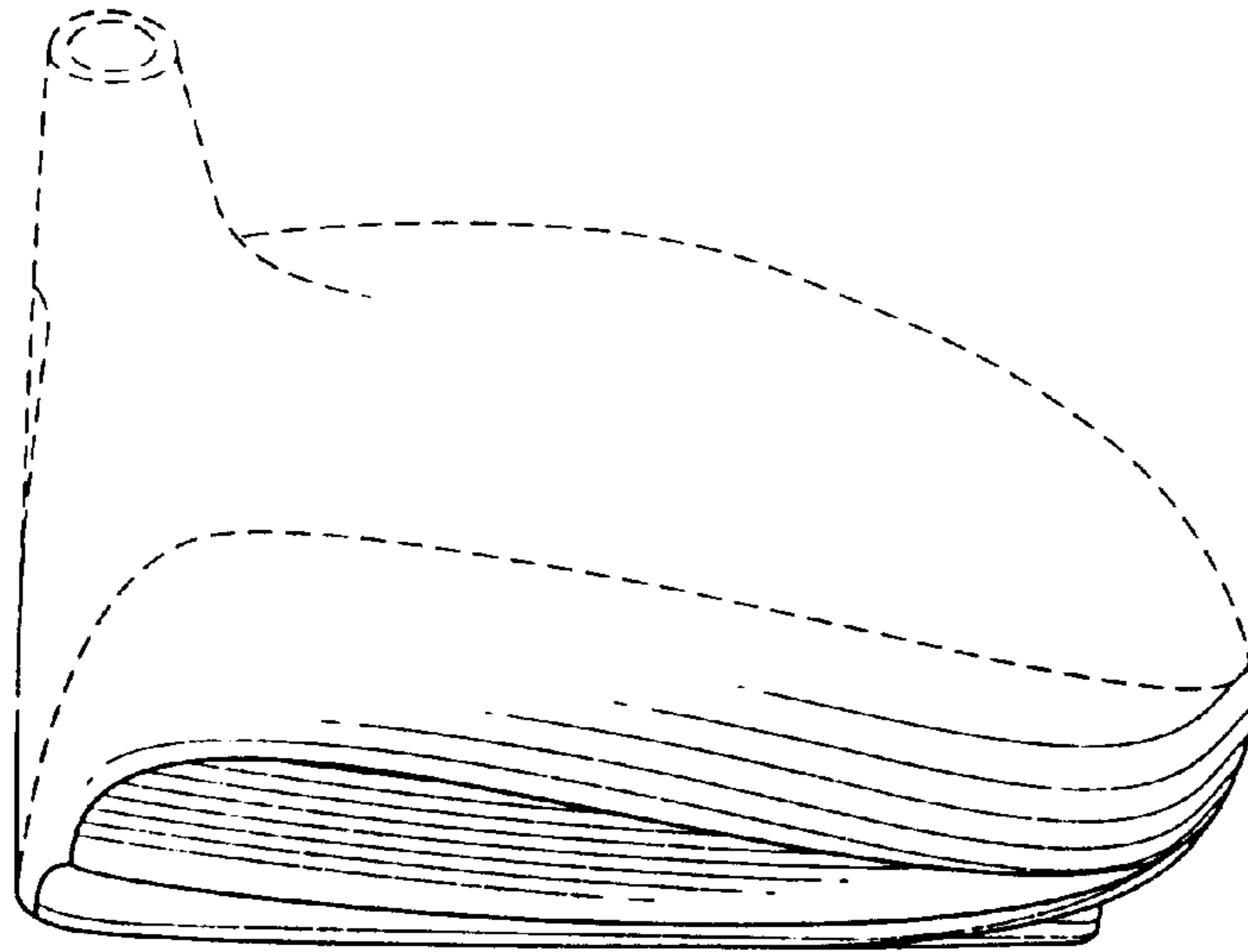

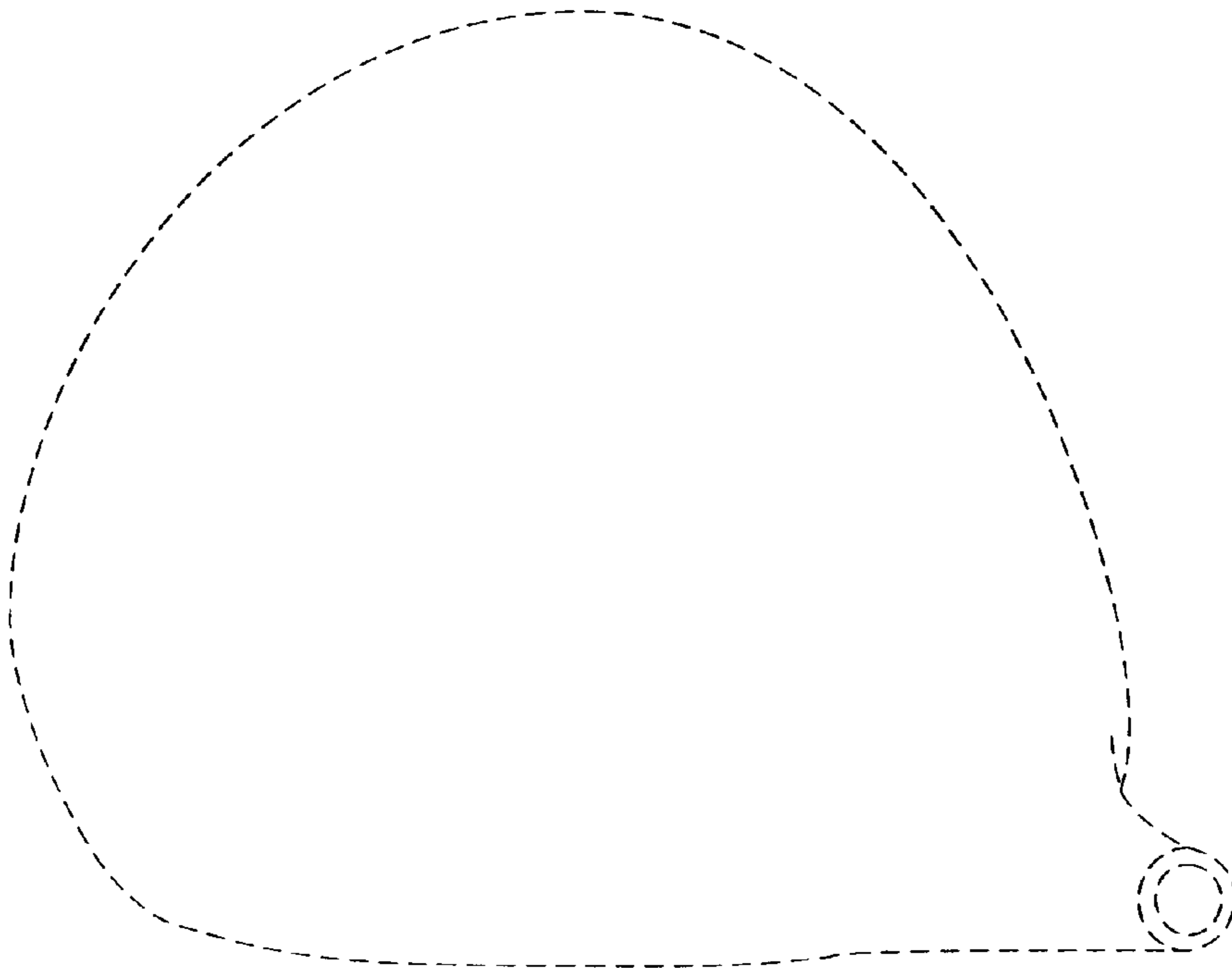

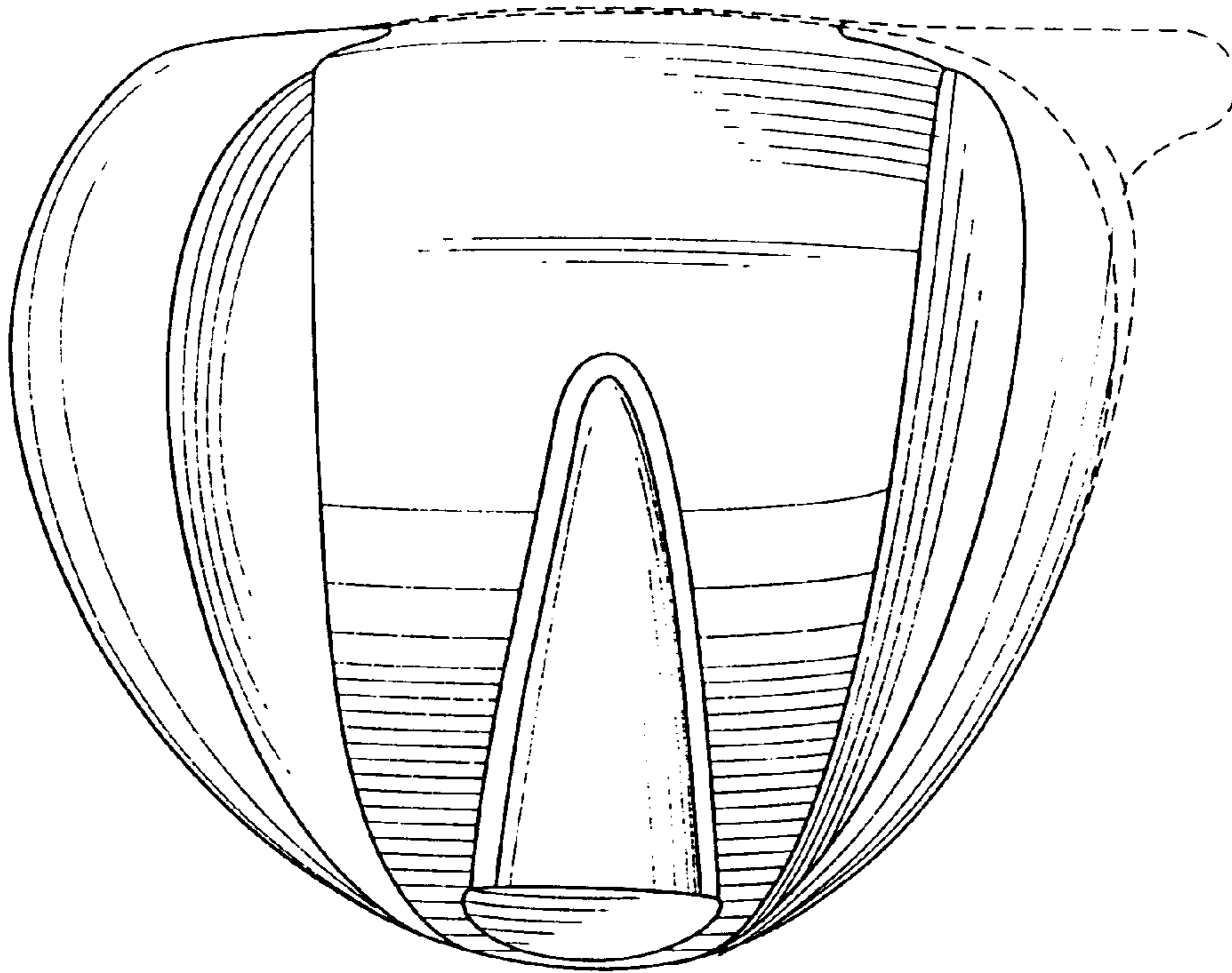

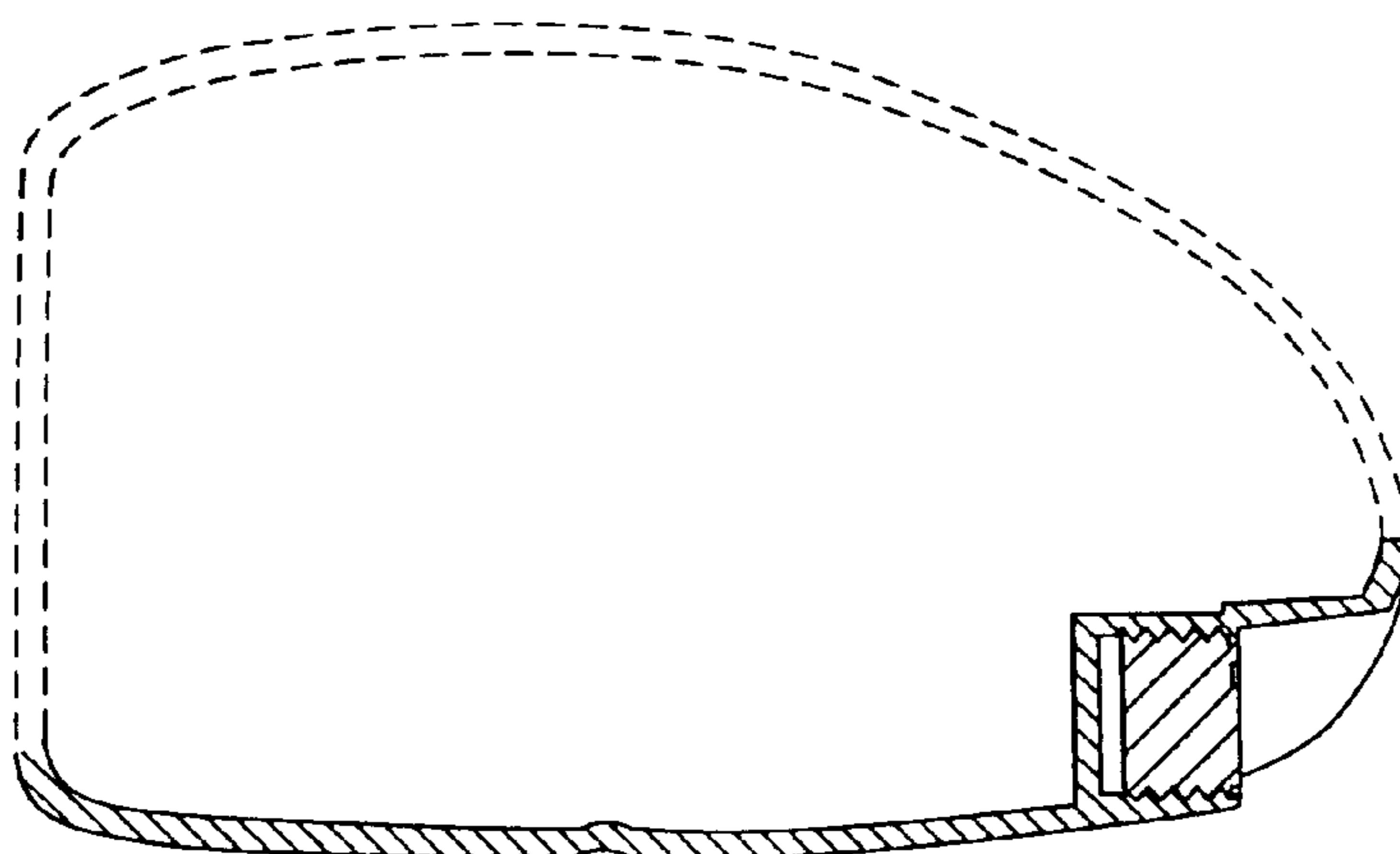
