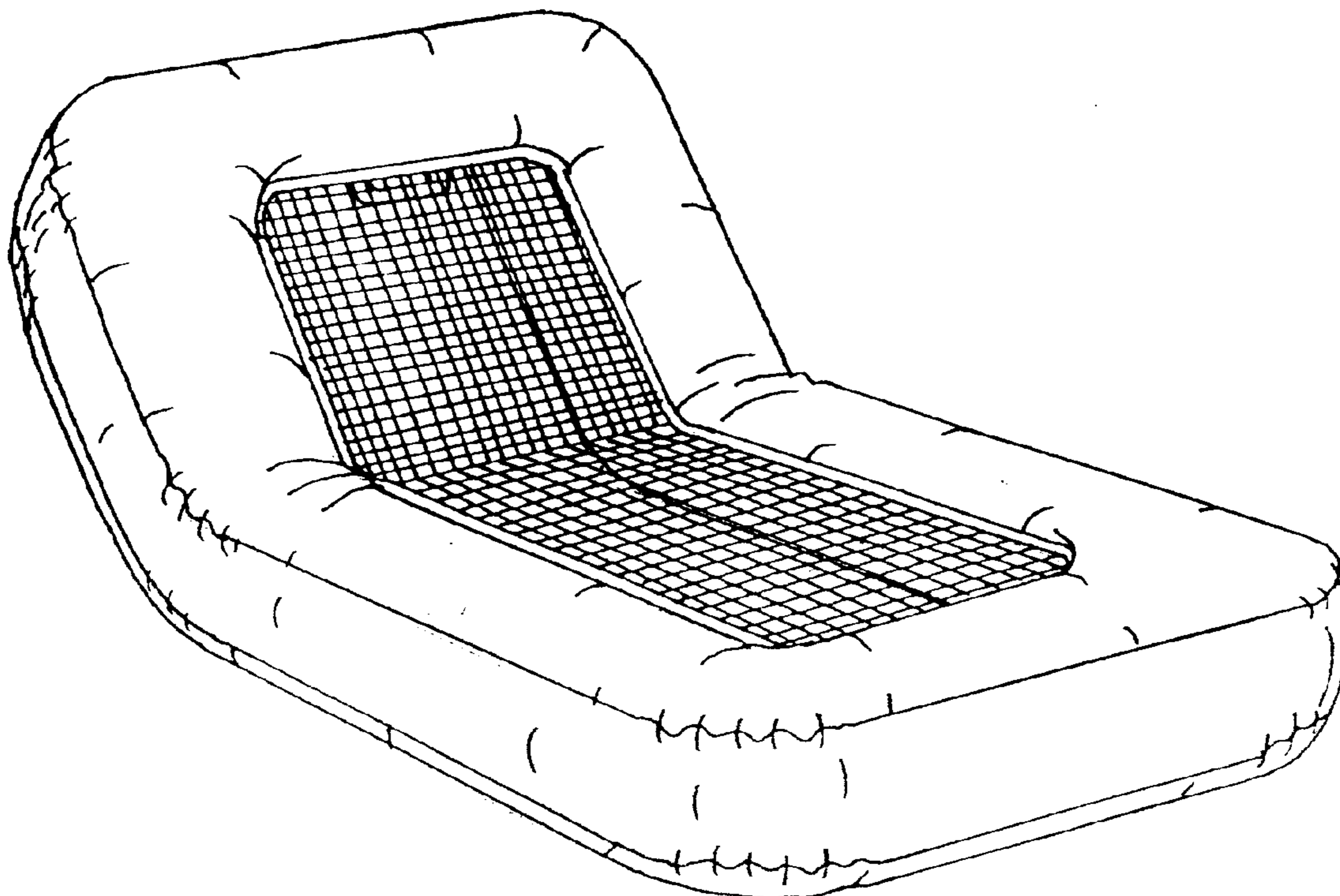

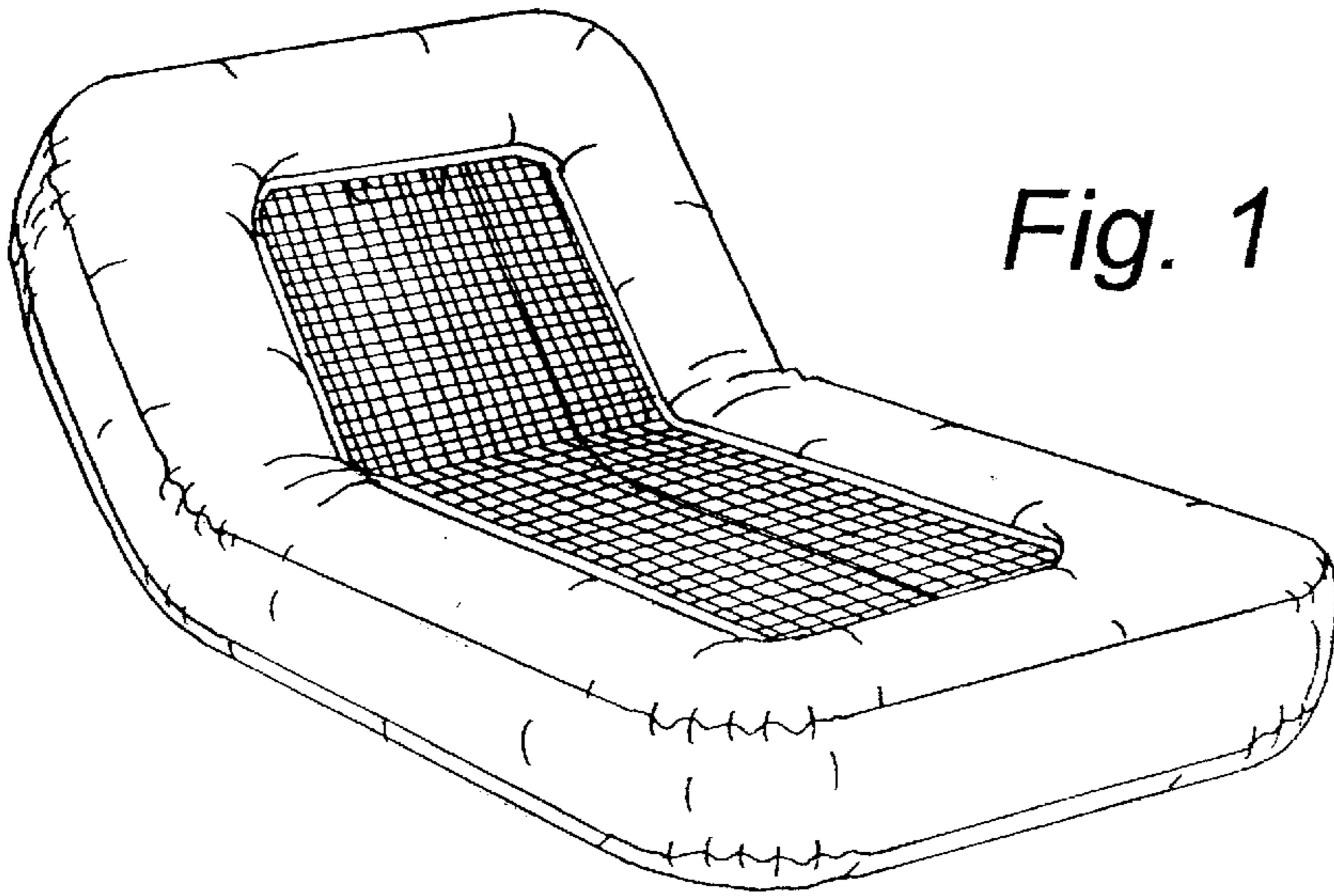
The ornamental design for an inflatable float, as shown and described.

**DESCRIPTION**

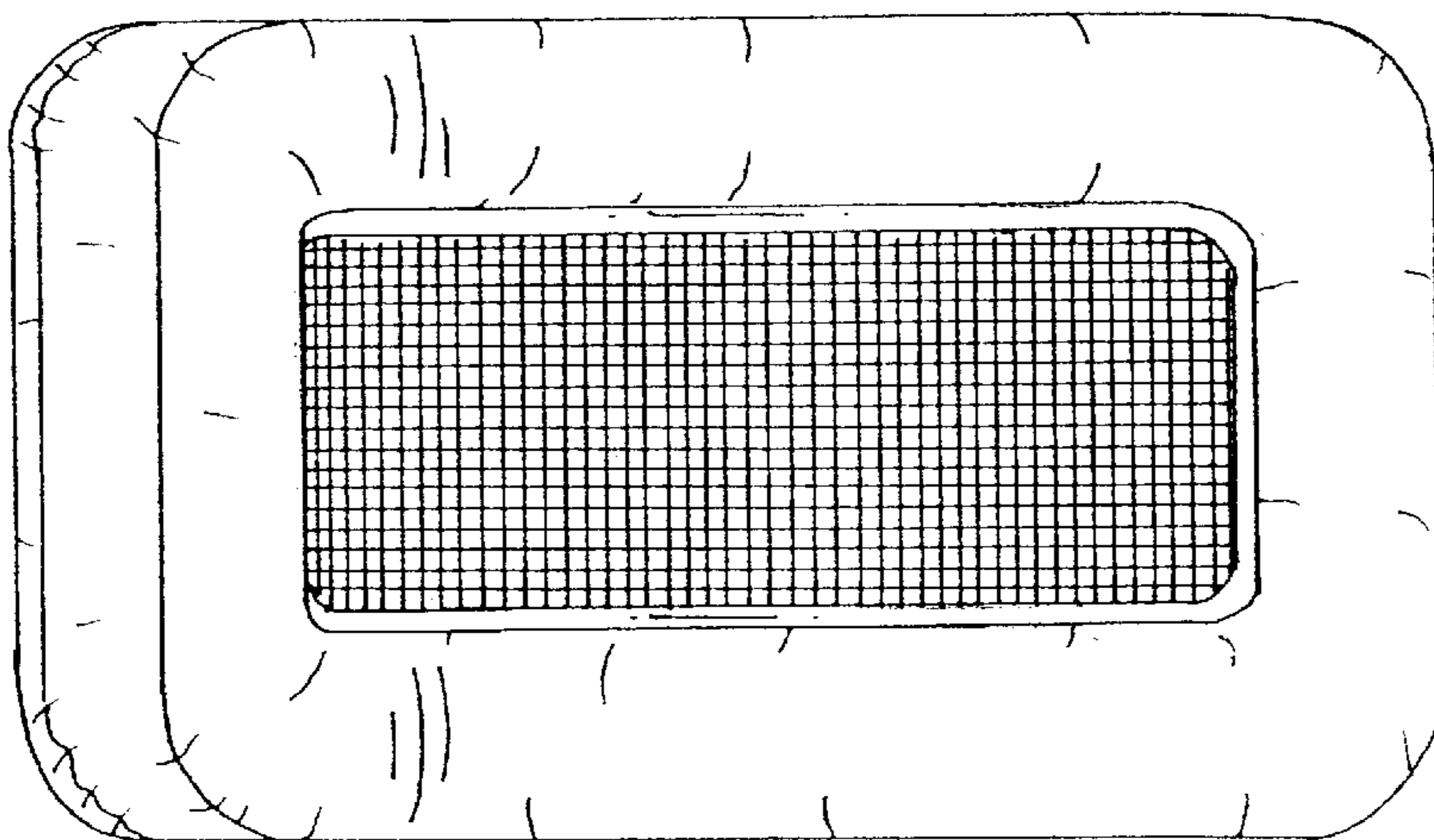
FIG. 1 is a perspective view of an inflatable float showing my new design;

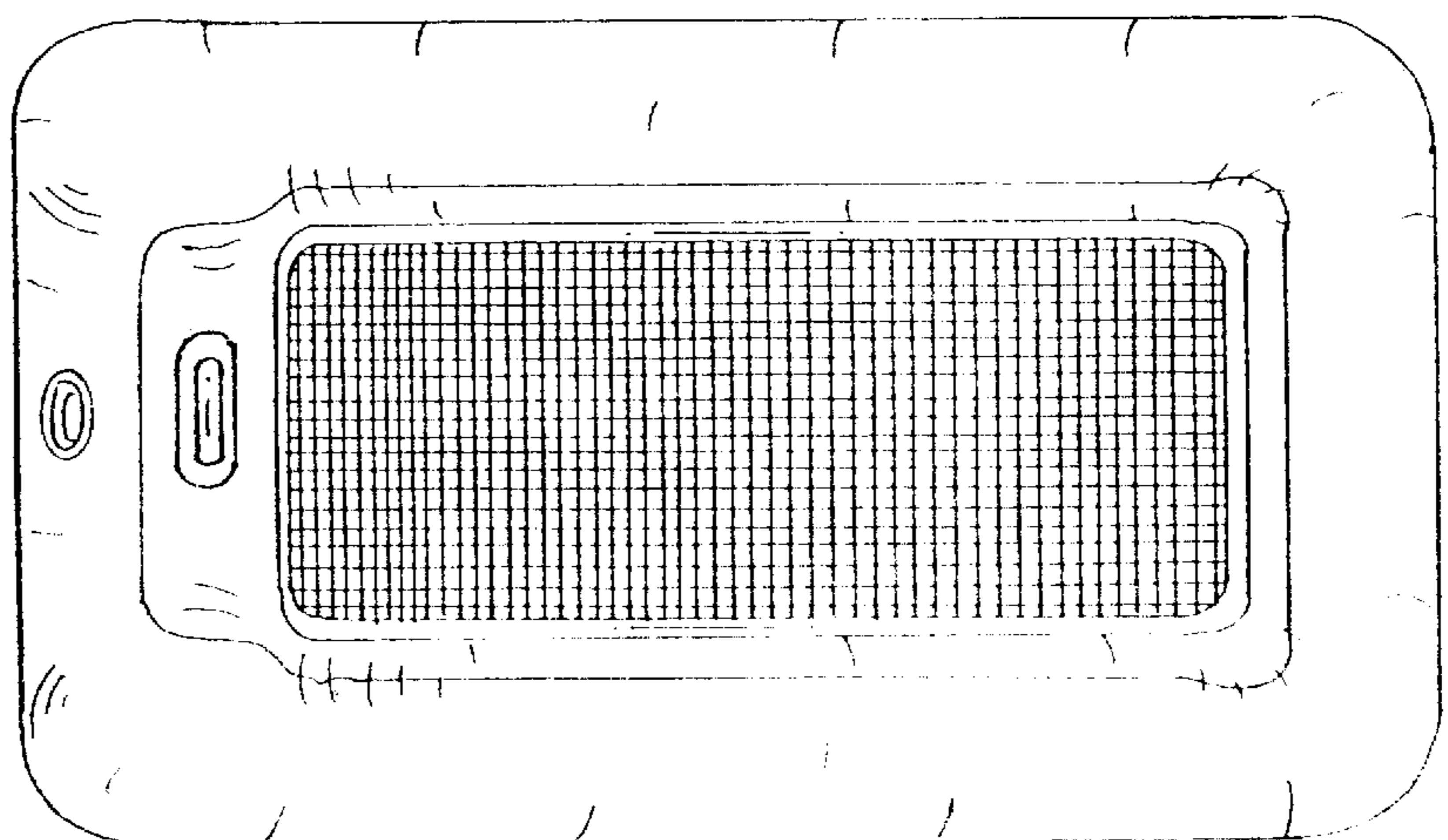




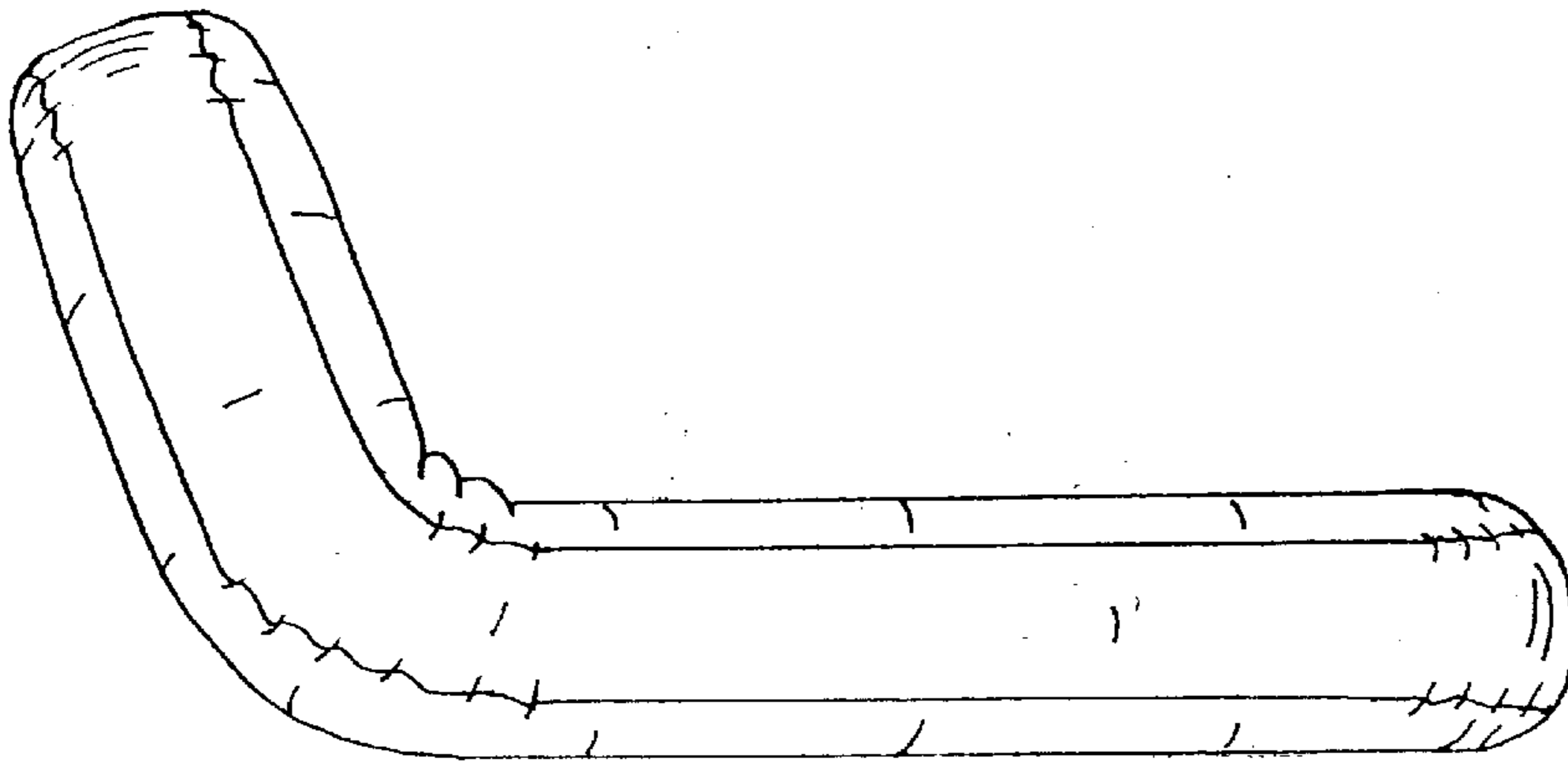

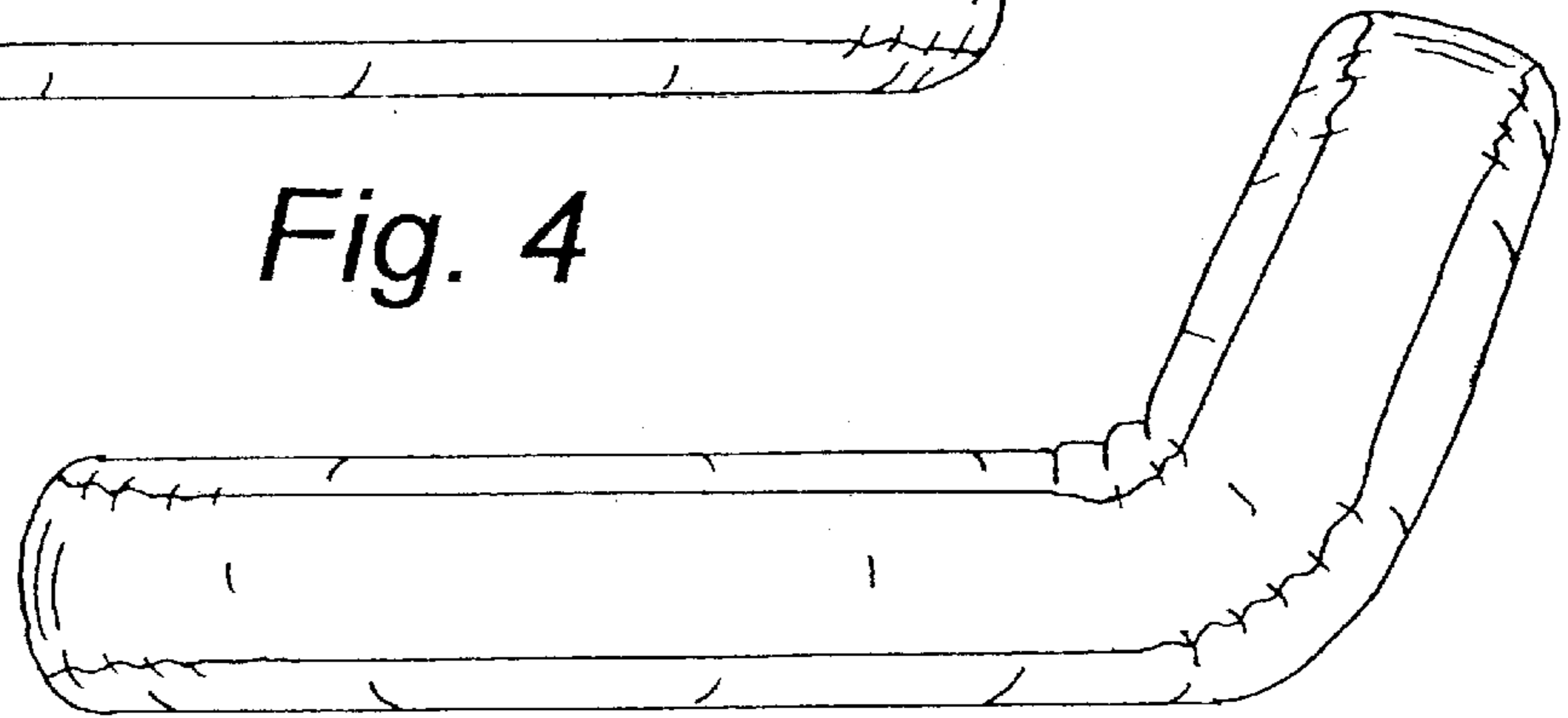

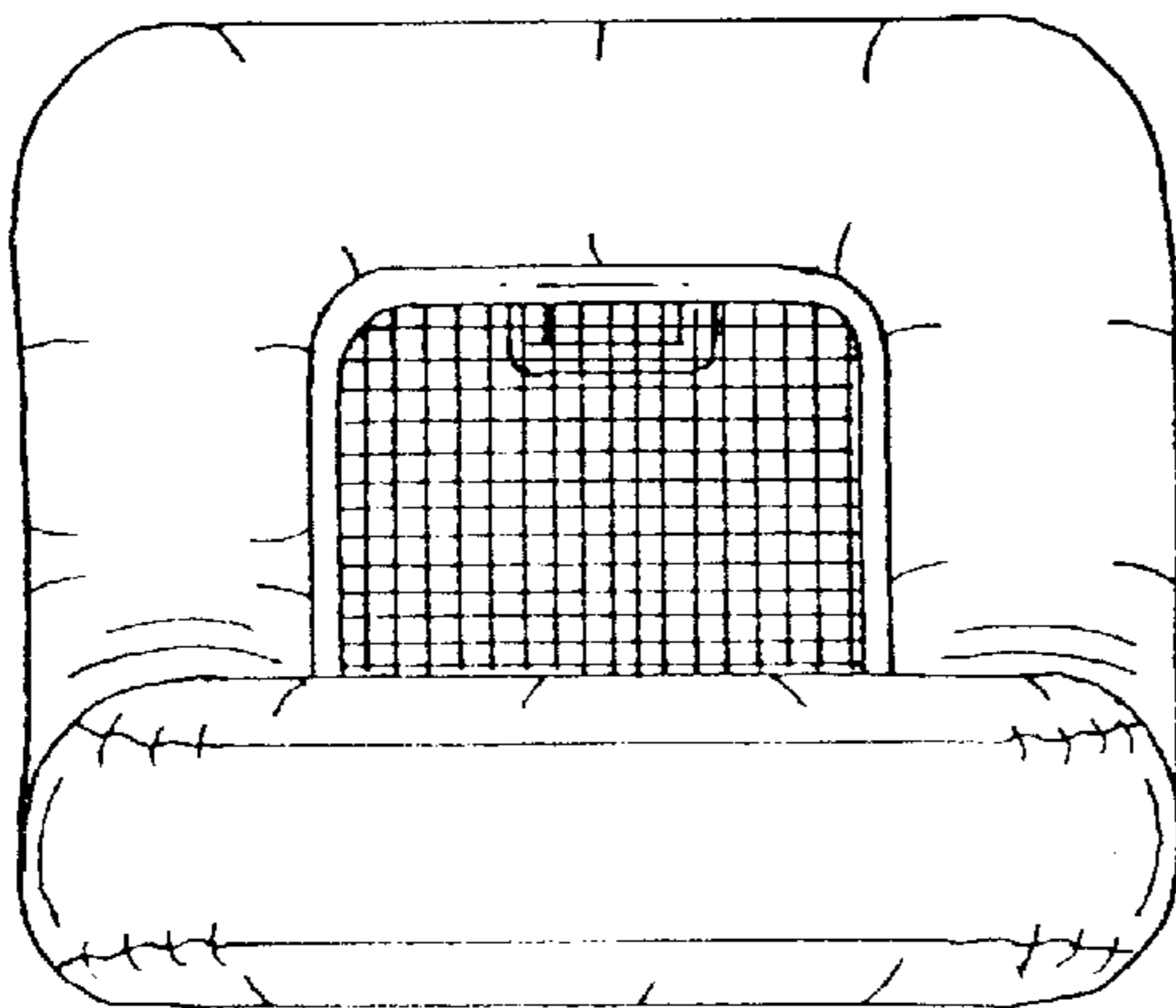

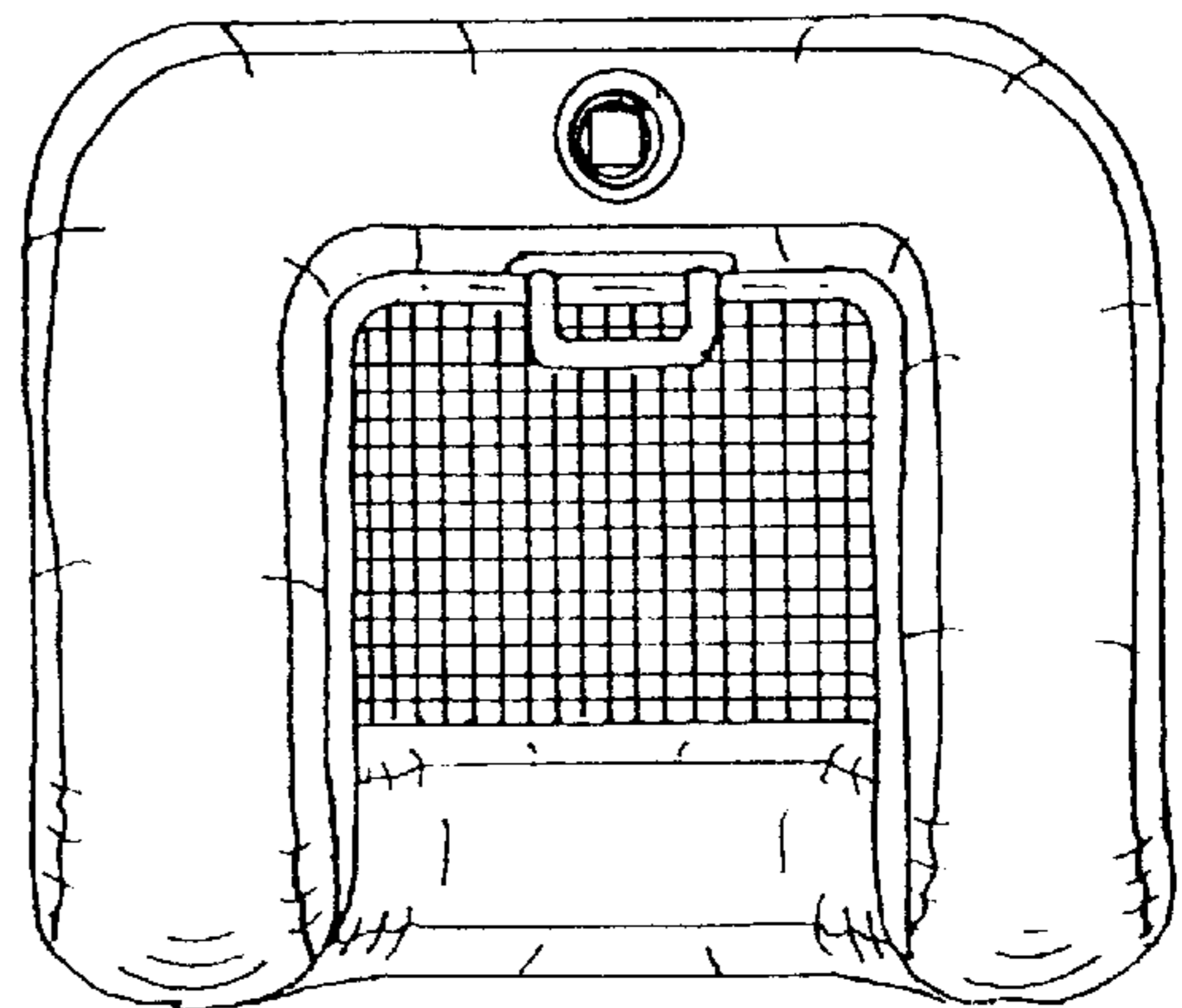
