The ornamental design for a spa body support, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a spa body support, showing my new design;

FIG. 2 is a front view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a side view thereof;

FIG. 6 is an isometric view of the left side element of the spa body support;

FIG. 7 is an isometric view of the center element thereof;

FIG. 8 is an isometric view the right side element thereof;

FIG. 9 is a top plan view of the left element of the spa body support shown in FIGS. 6 and 11;

FIG. 10 is a left side view of FIGS. 6 and 11;

FIG. 11 is a front elevational view of FIG. 6;

FIG. 12 is a right side view of FIGS. 6 and 11;

FIG. 13 is a bottom plan view of FIGS. 6 and 11;

FIG. 14 is a top plan view of the center element of the spa body support shown in FIGS. 7 and 16;

FIG. 15 is a left side view of FIGS. 7 and 16;

FIG. 16 is a front elevational view of FIG. 7;

FIG. 17 is a right side view of FIGS. 7 and 16;

FIG. 18 is a bottom plan view of FIGS. 7 and 16;

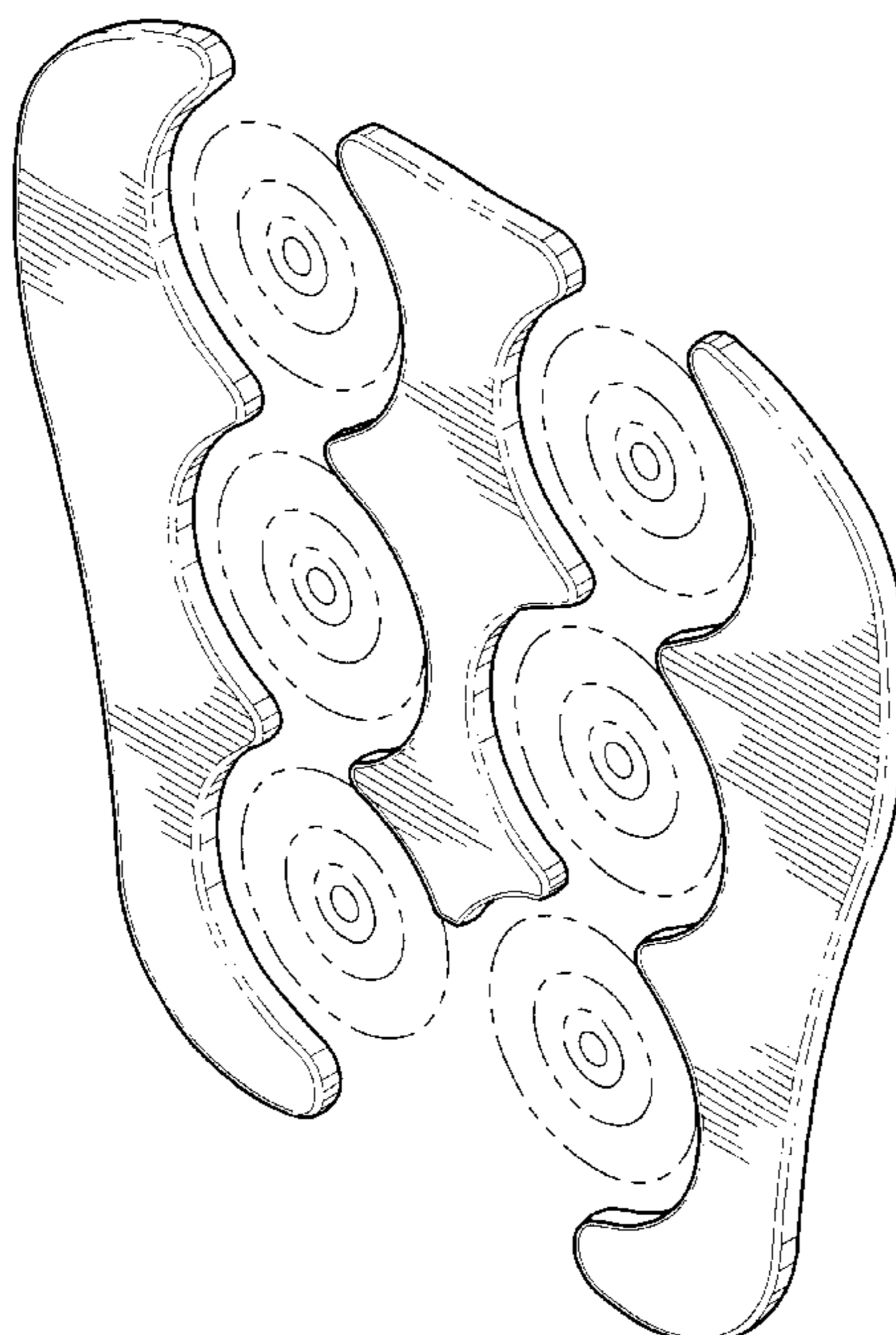
FIG. 21 a front elevational view of FIG. 8;

FIG. 19 is a top plan view of the right element of the spa body support shown in FIGS. 8 and 21;

FIG. 20 is a left side view of FIGS. 8 and 21;

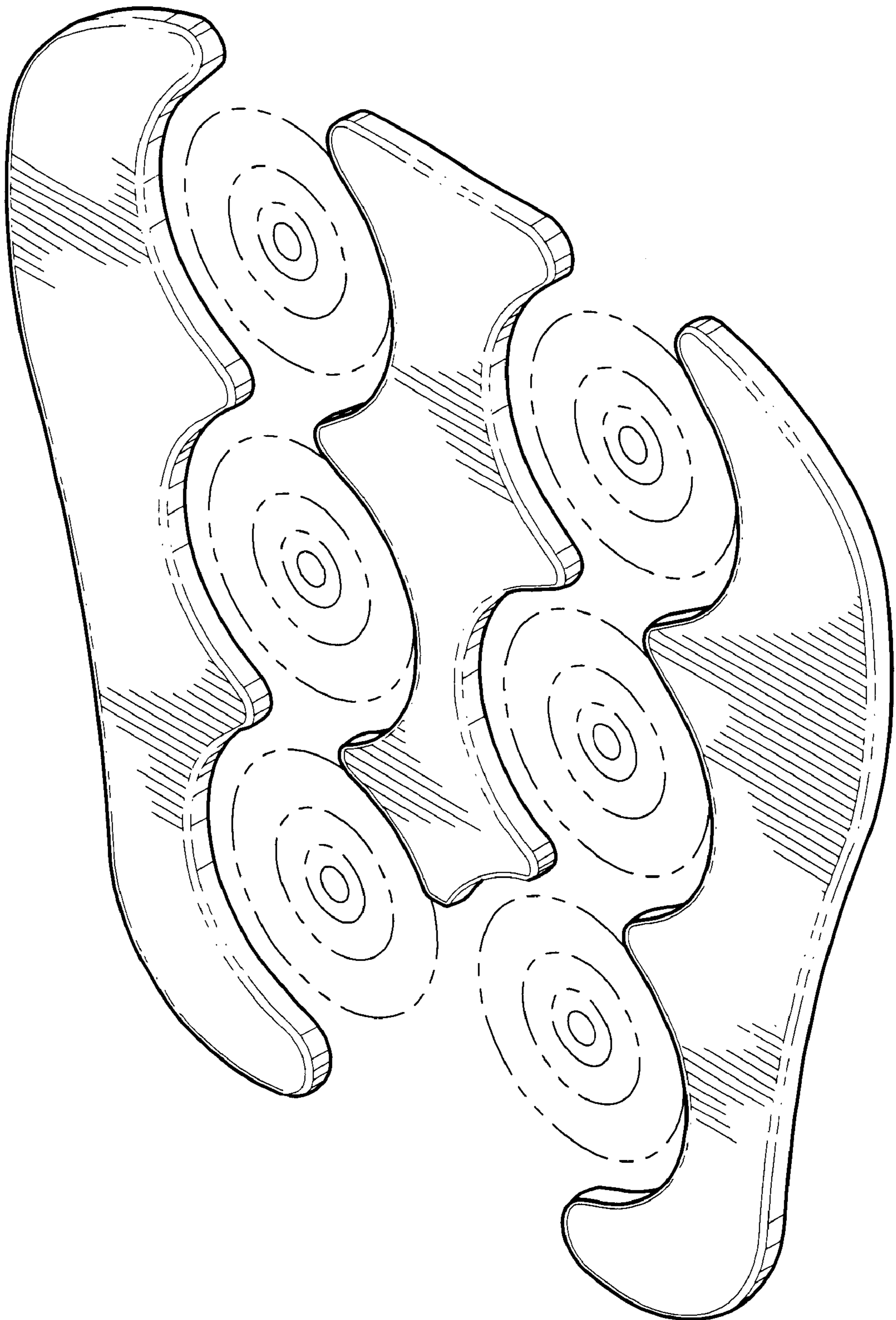

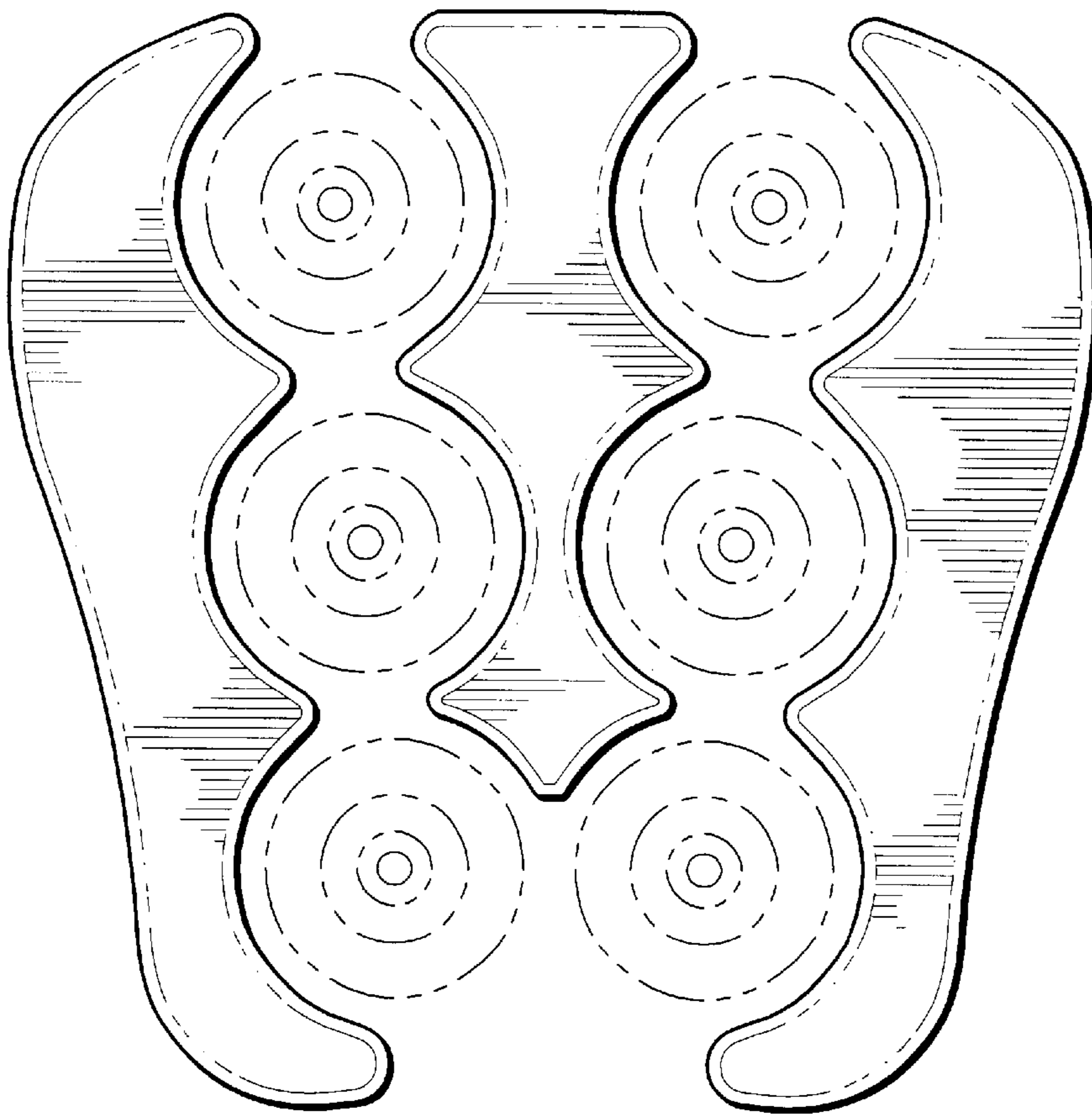

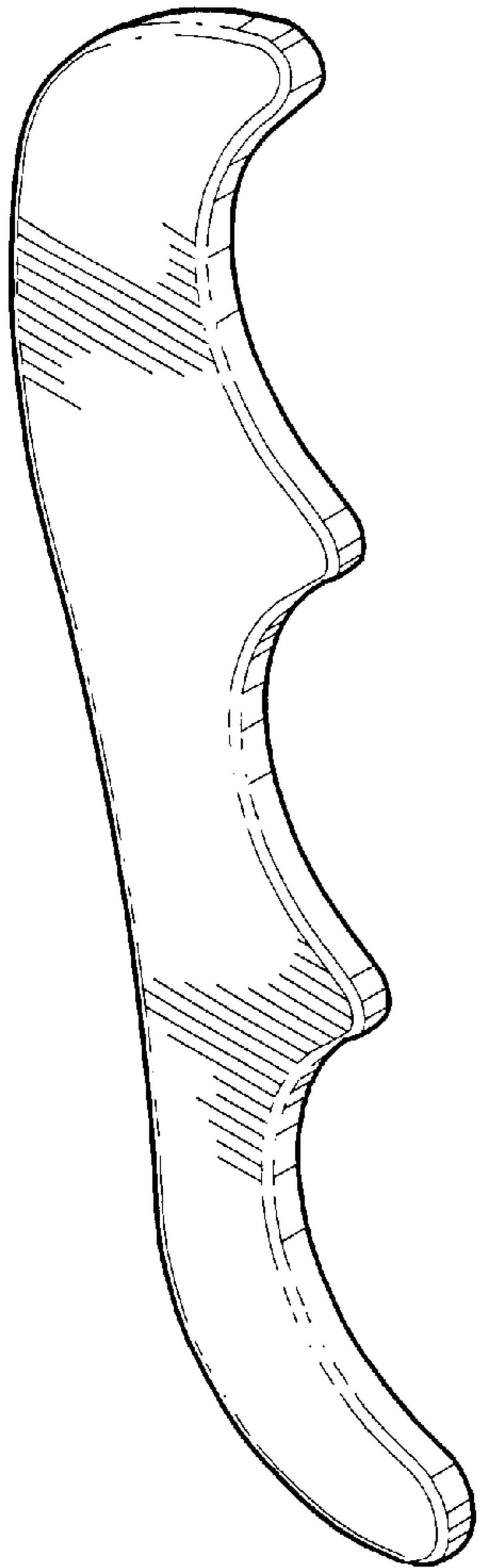

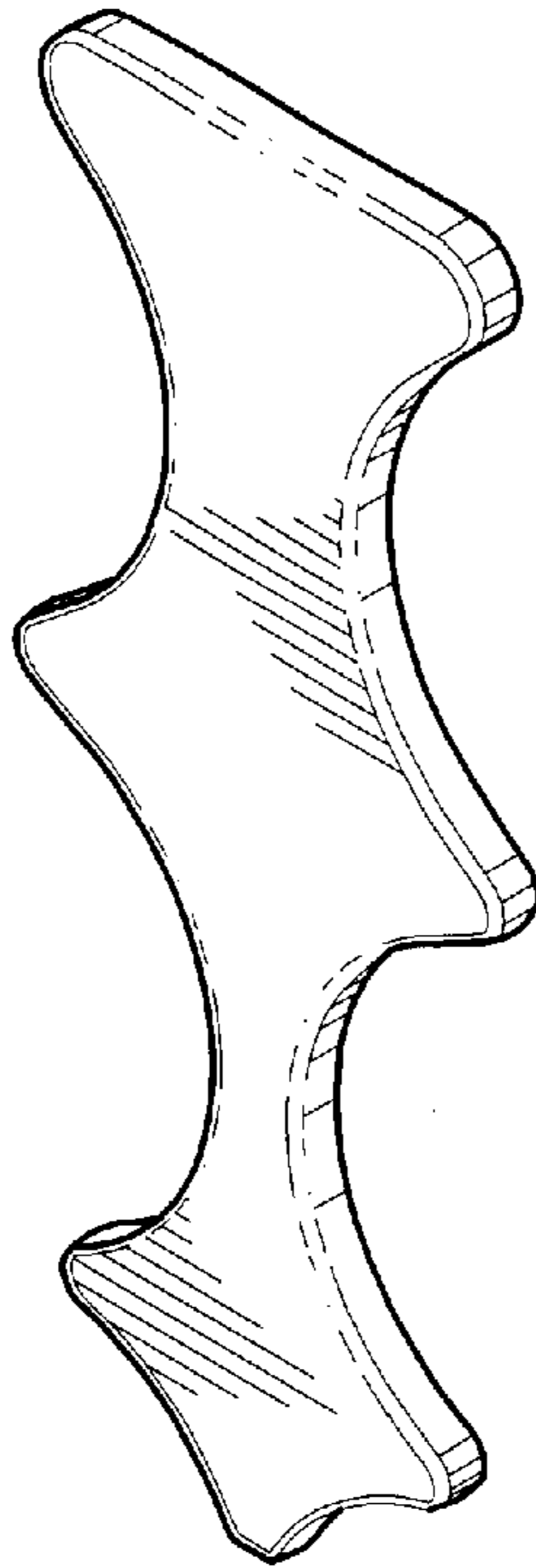

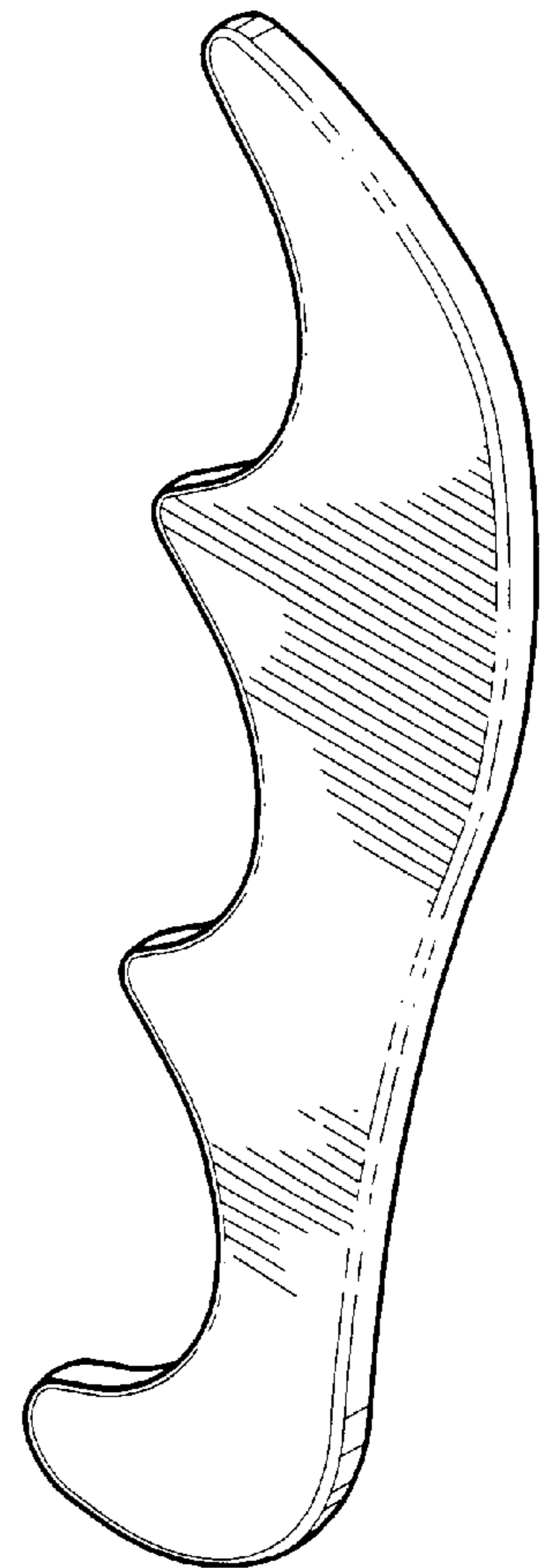

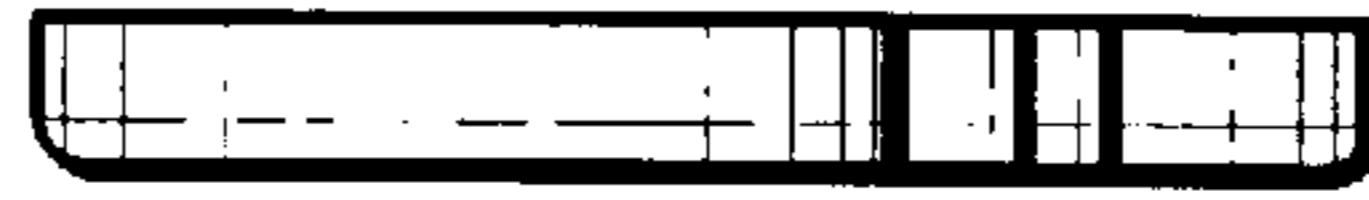

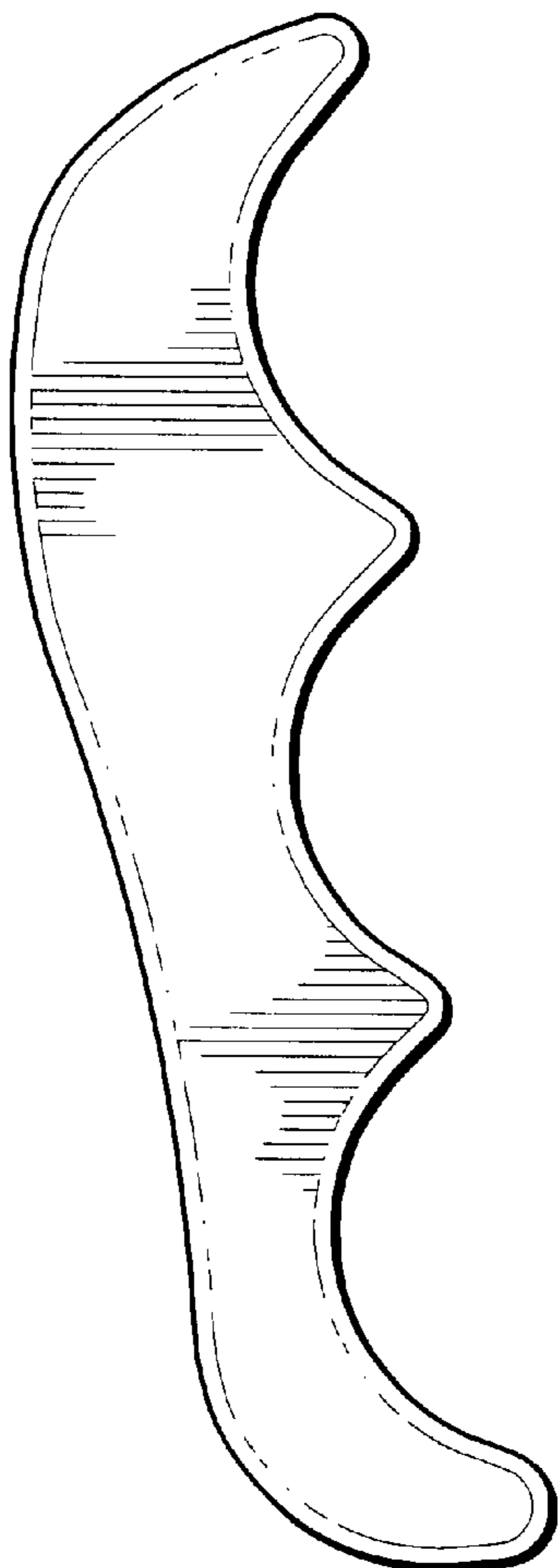

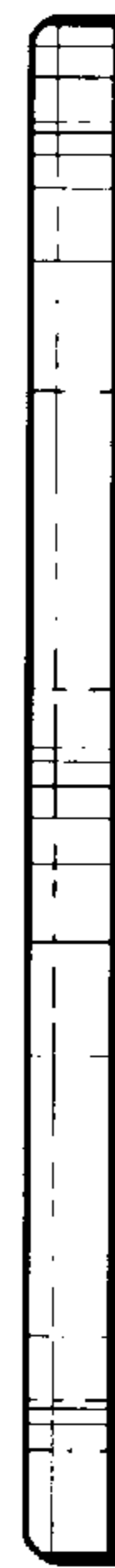
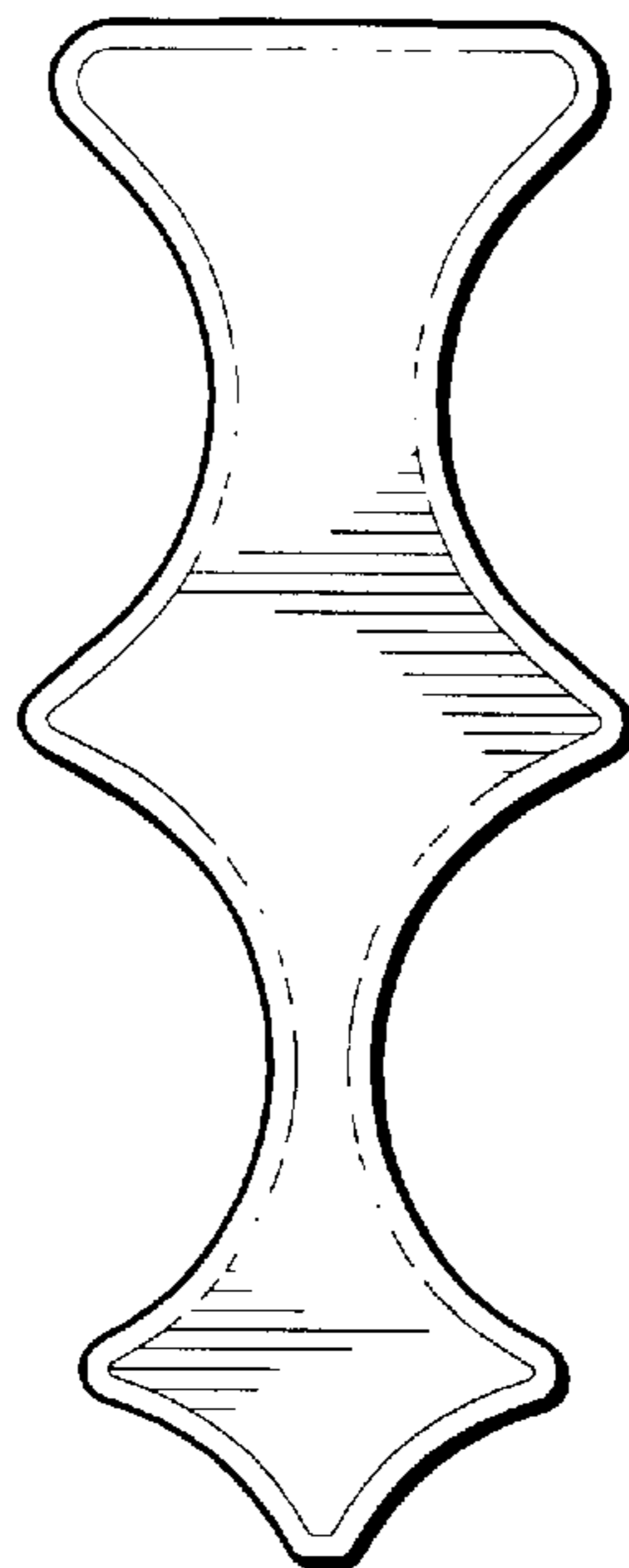
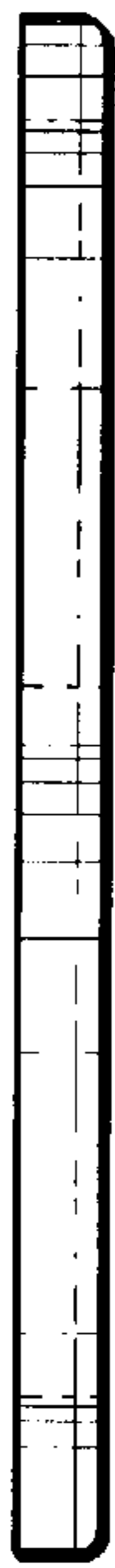

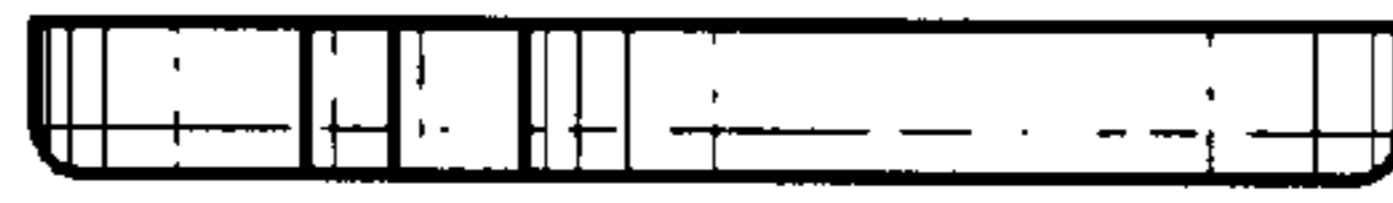

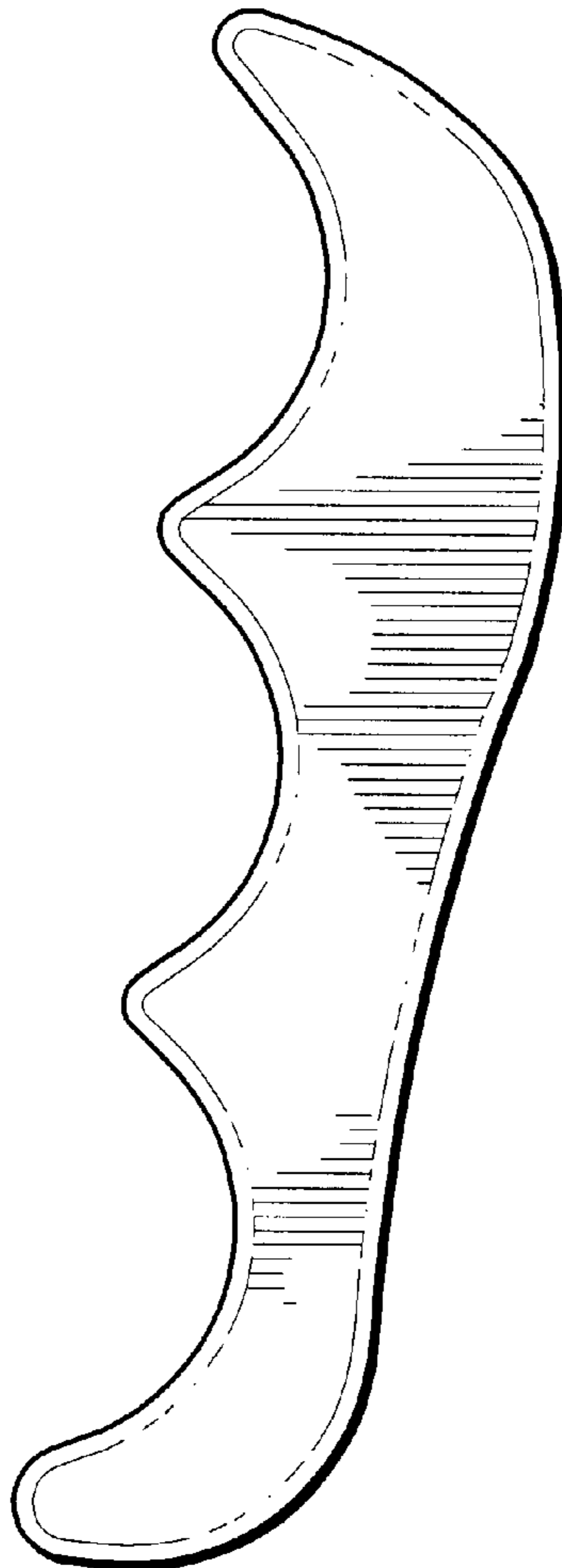
