FIG. 2 is a front elevational view thereof;

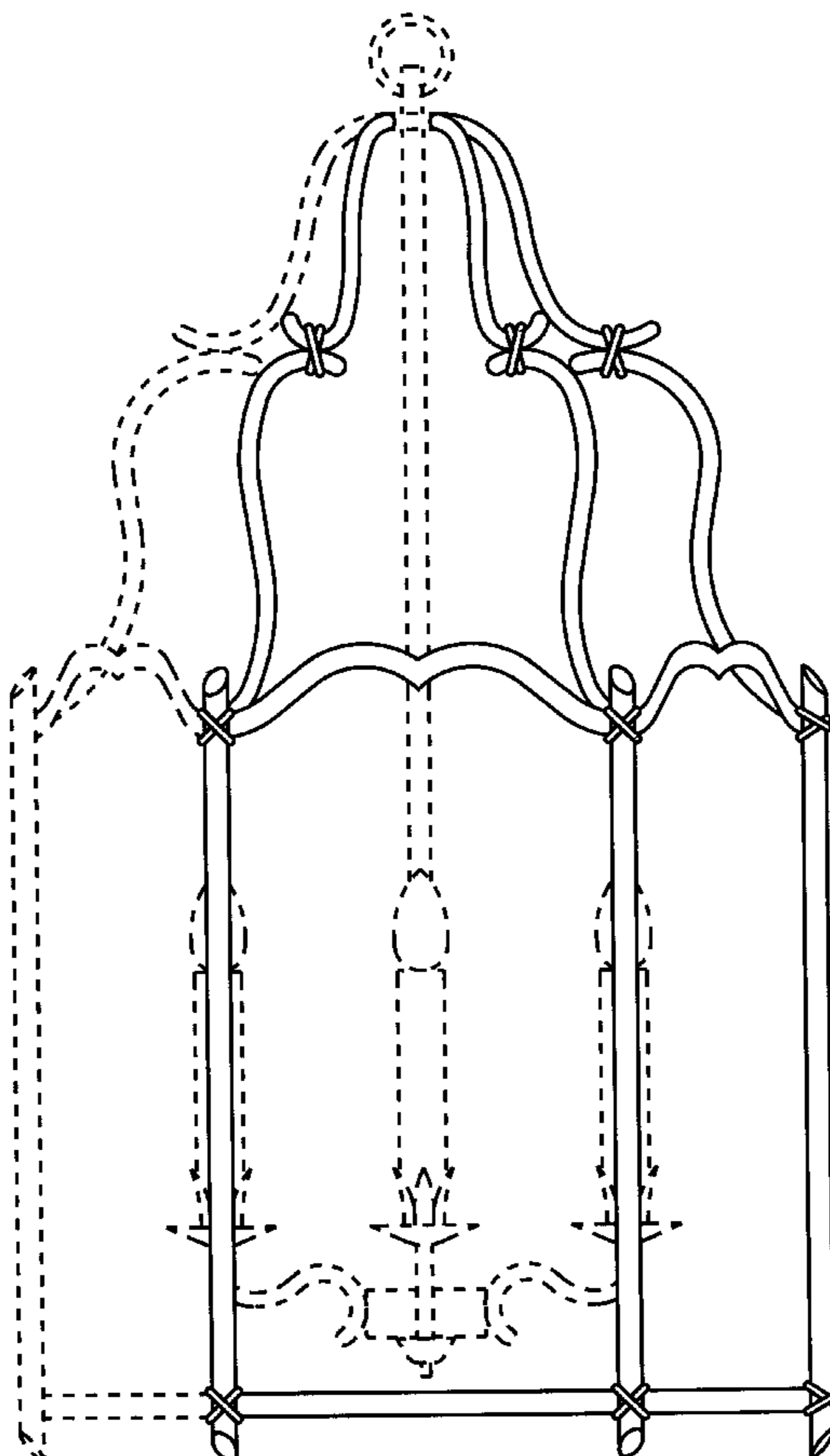
FIG. 3 is a left side elevational view thereof;

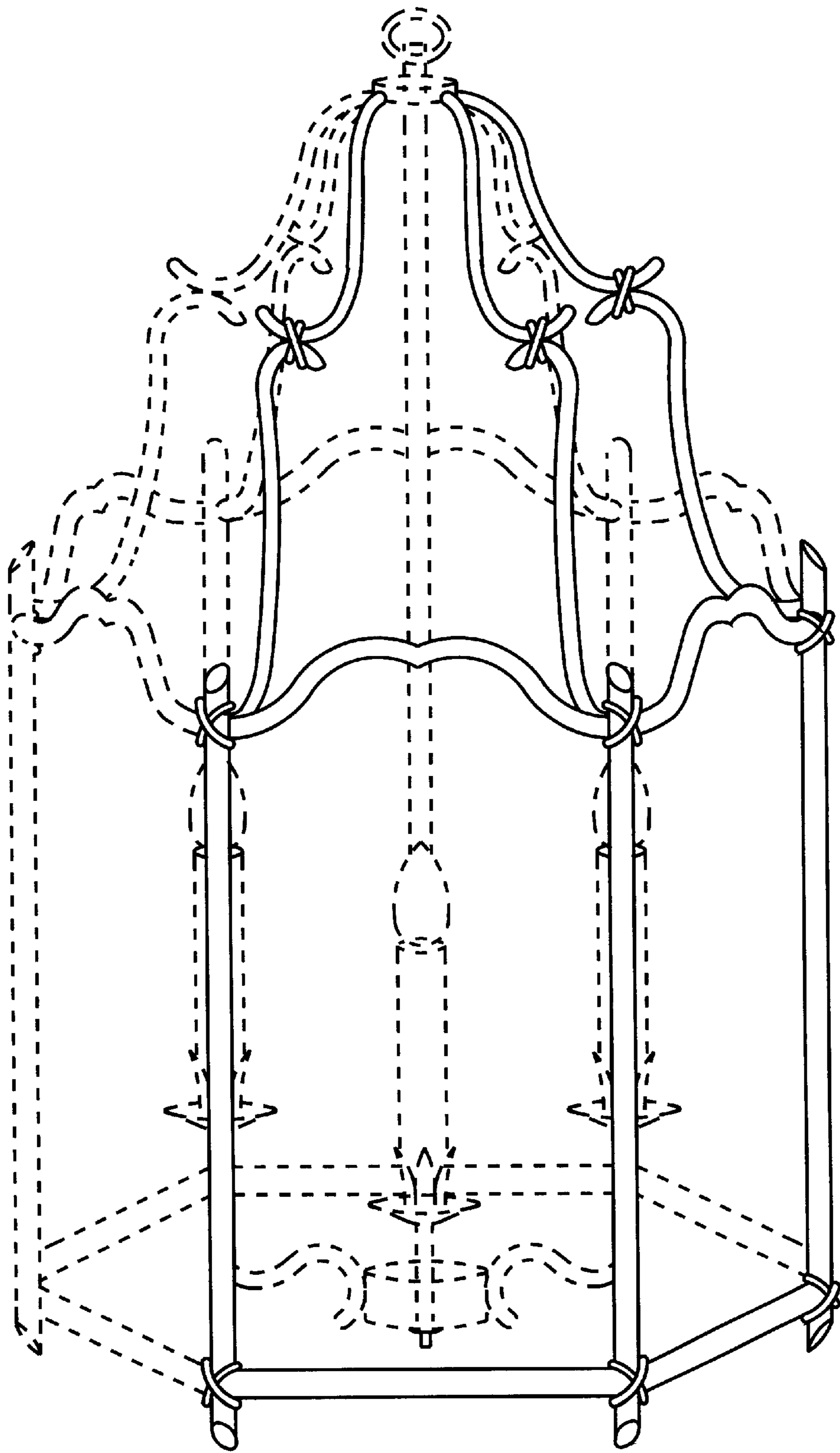
FIG. 4 is a top view thereof; and,

FIG. 5 is a bottom view thereof.

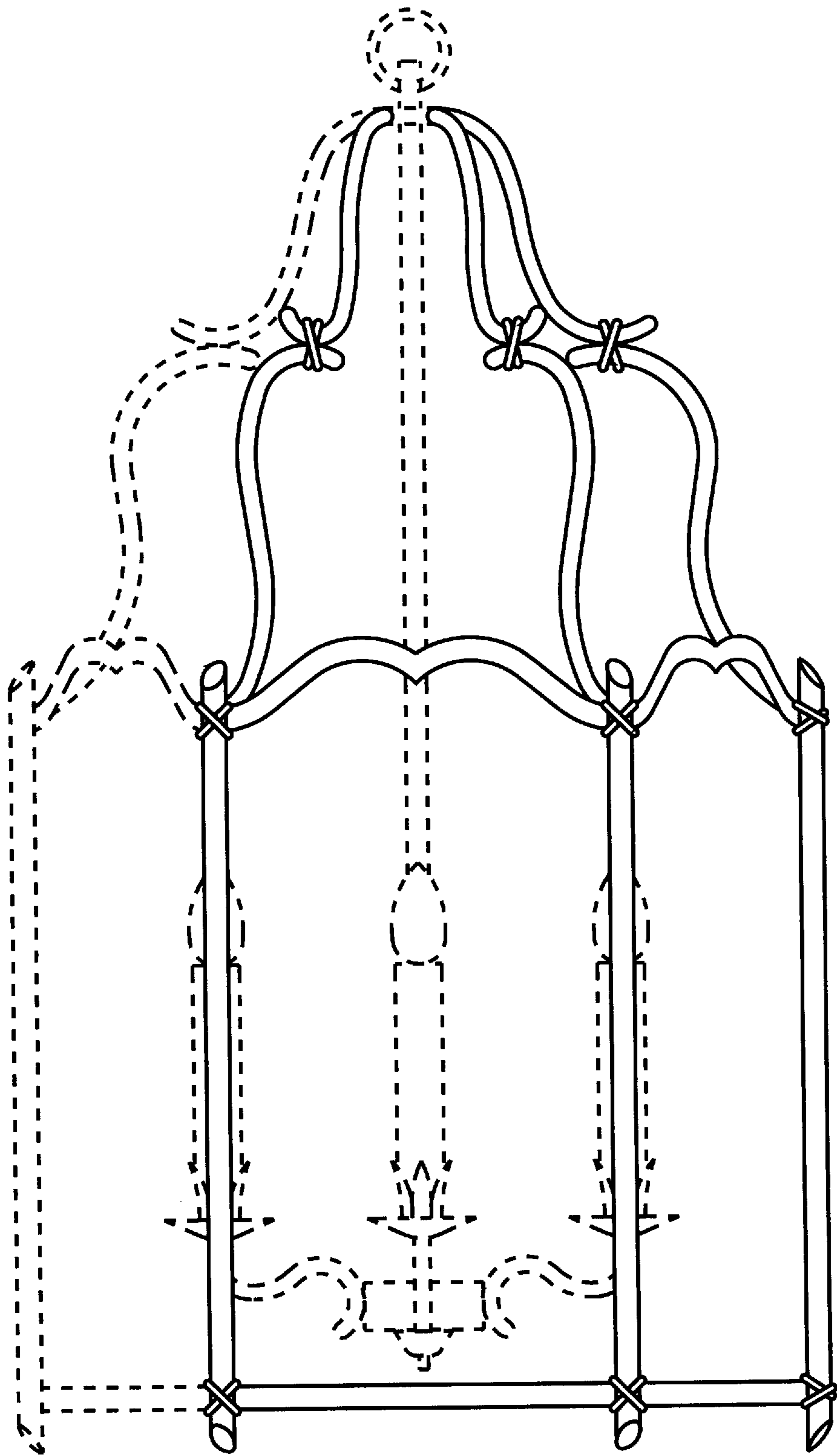

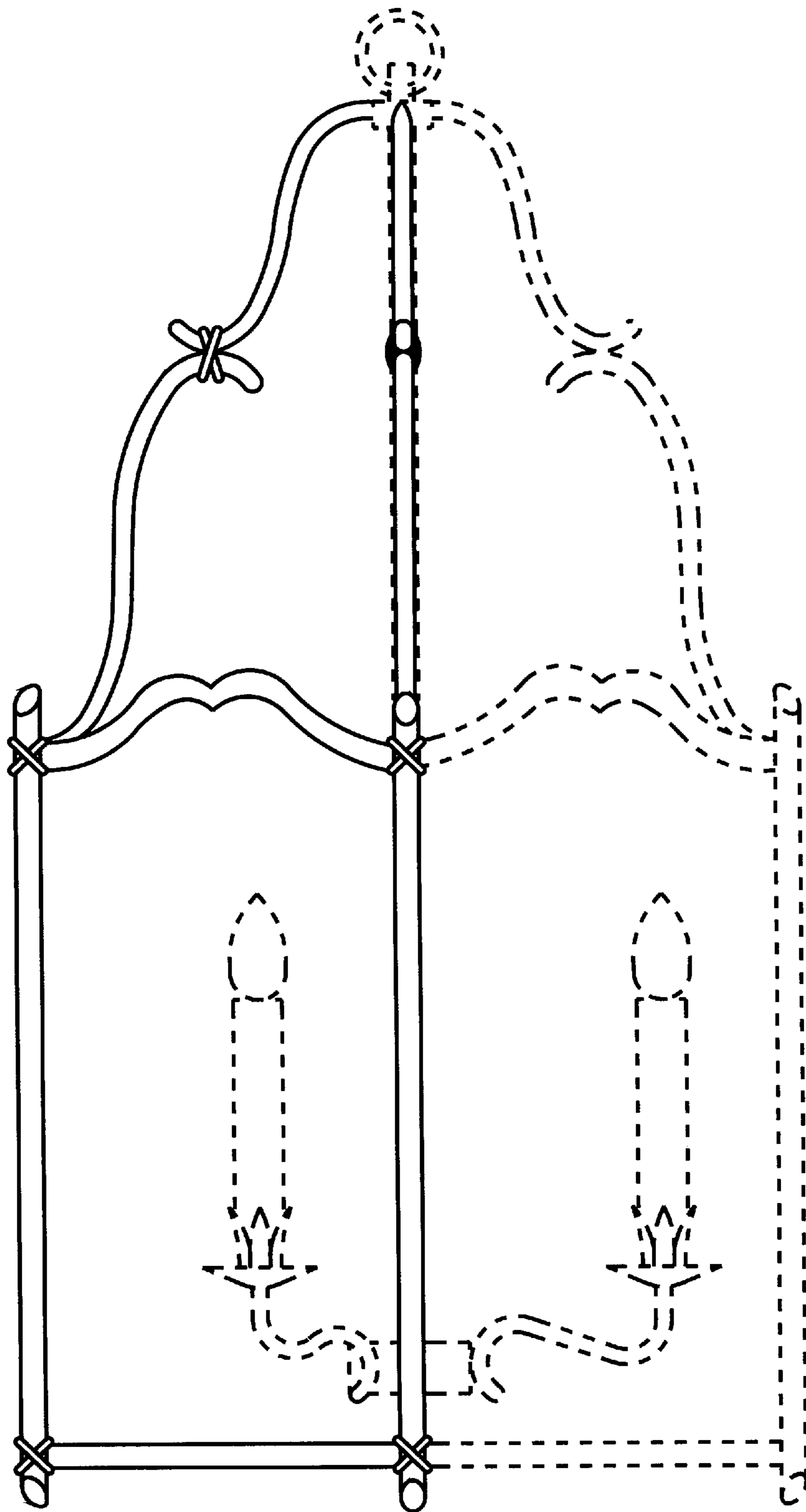




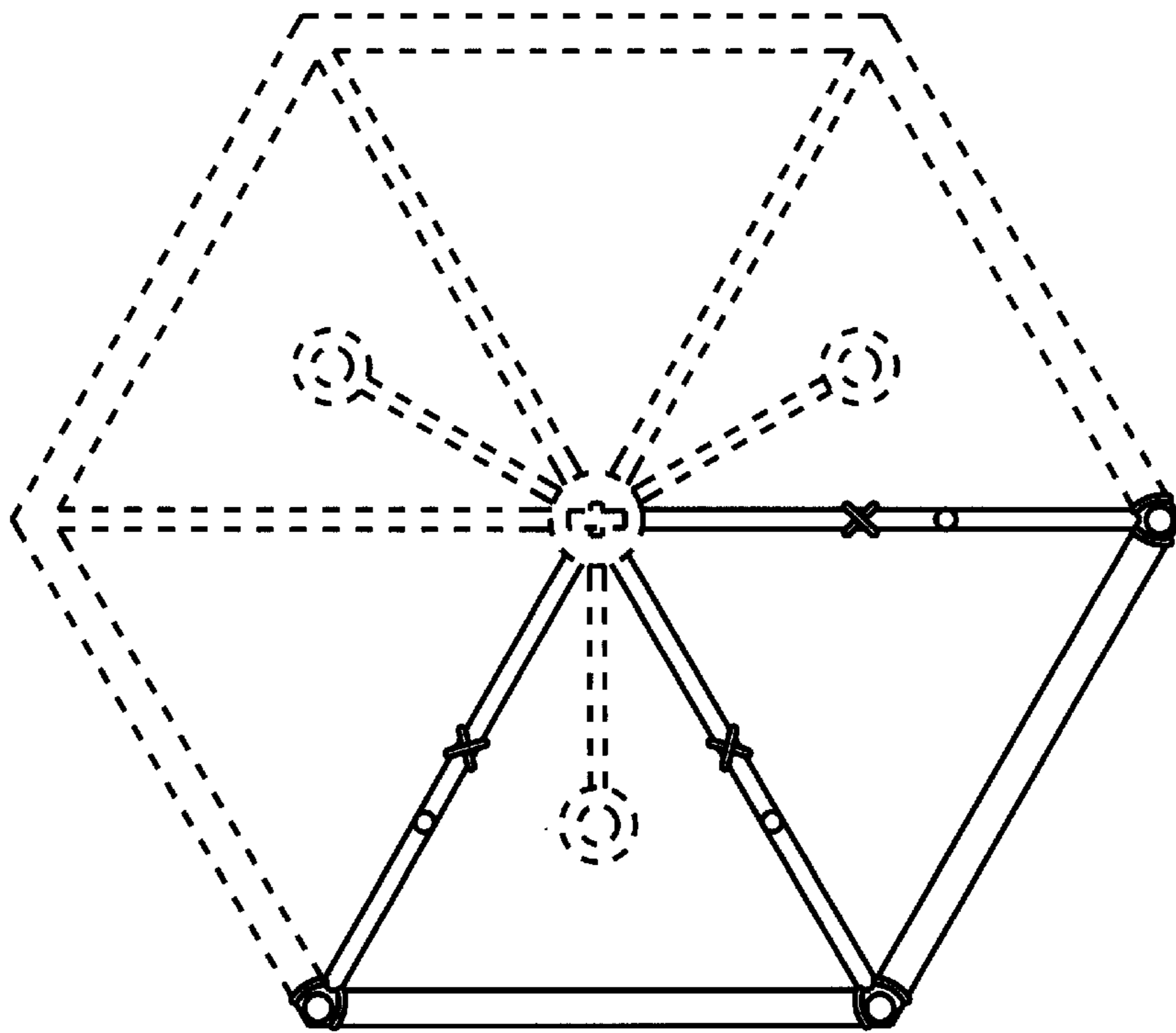

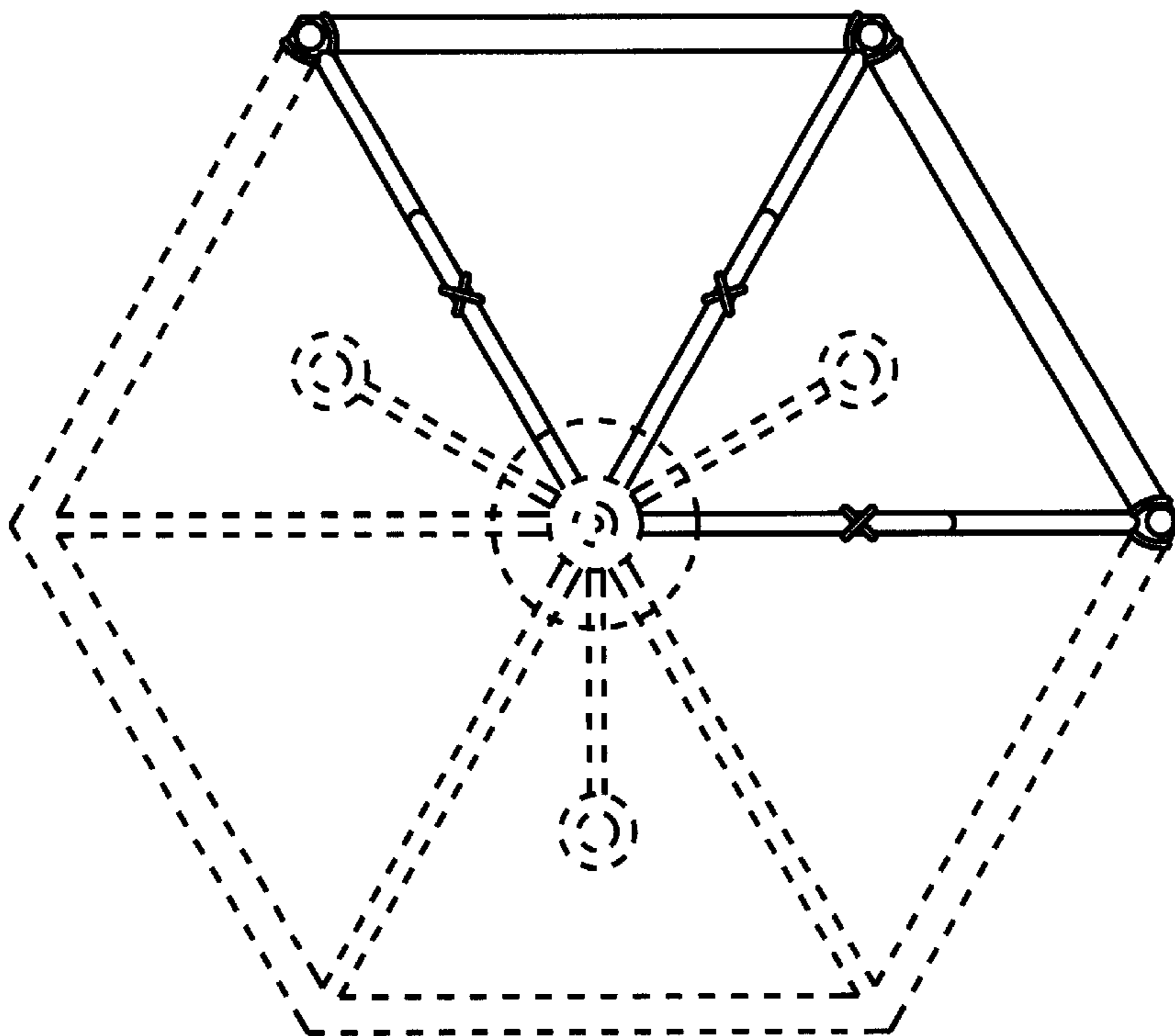
