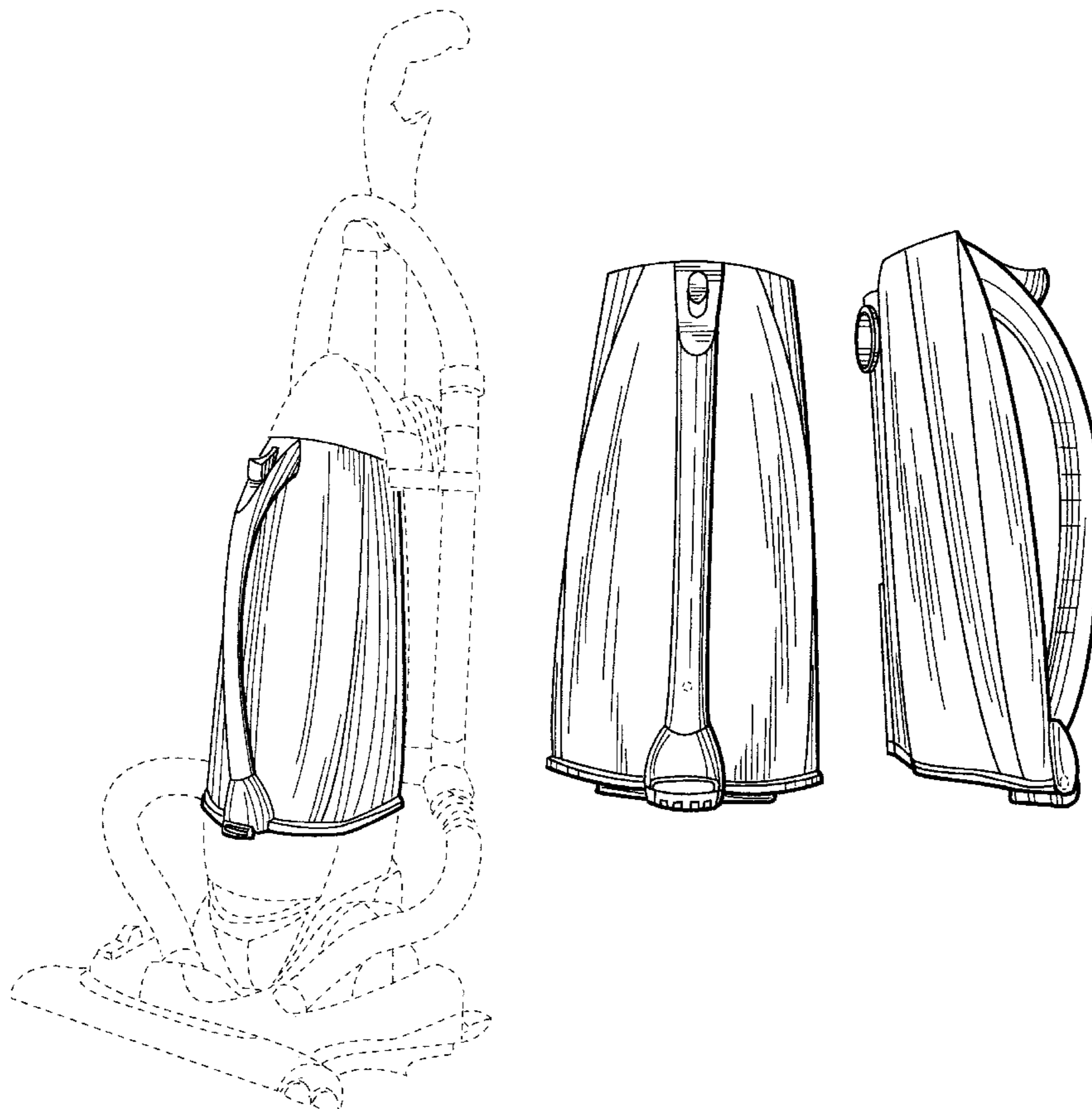
(57) **CLAIM**

The ornamental design of a dirt cup for upright vacuum cleaner, as shown and described.

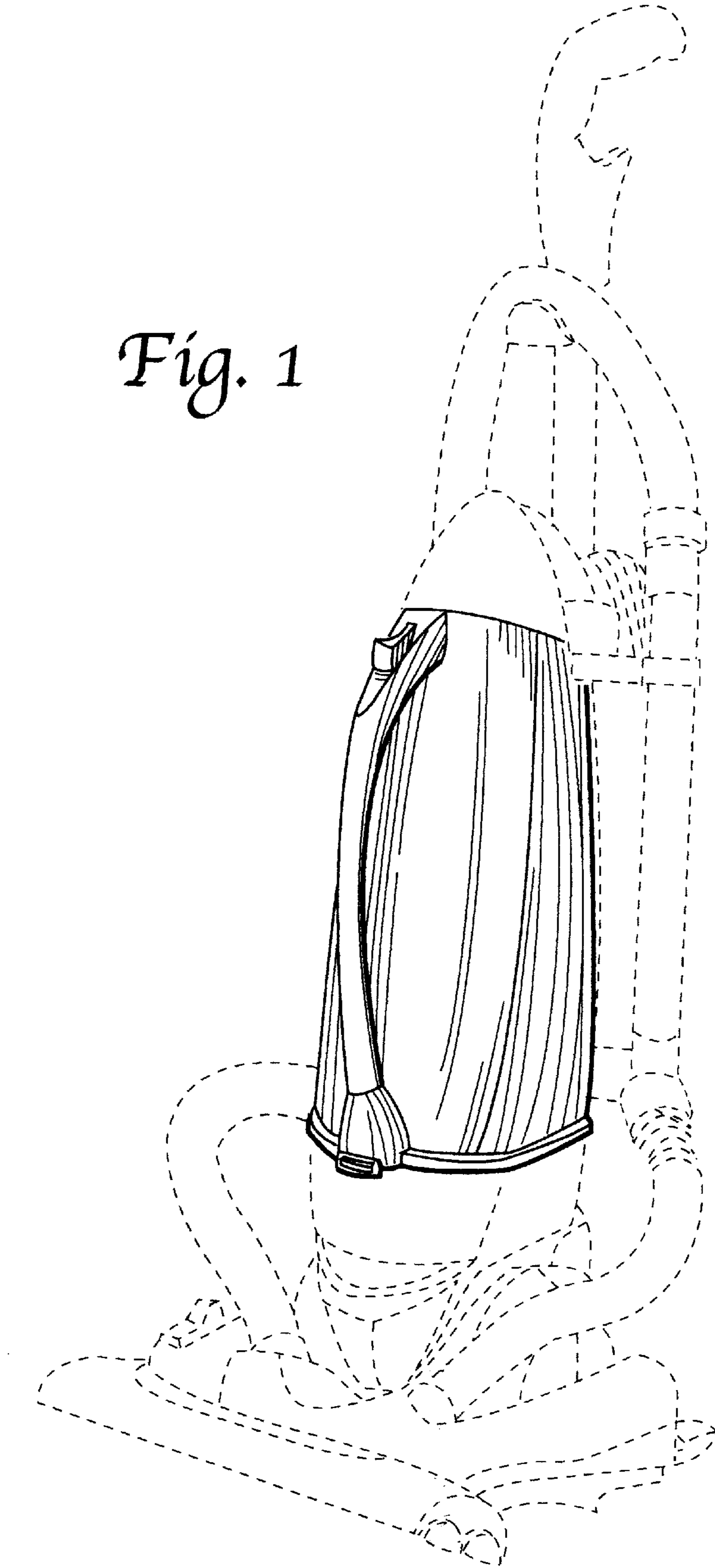
**DESCRIPTION**

FIG. 1 is a perspective view of a dirt cup for upright vacuum cleaner showing my new design;

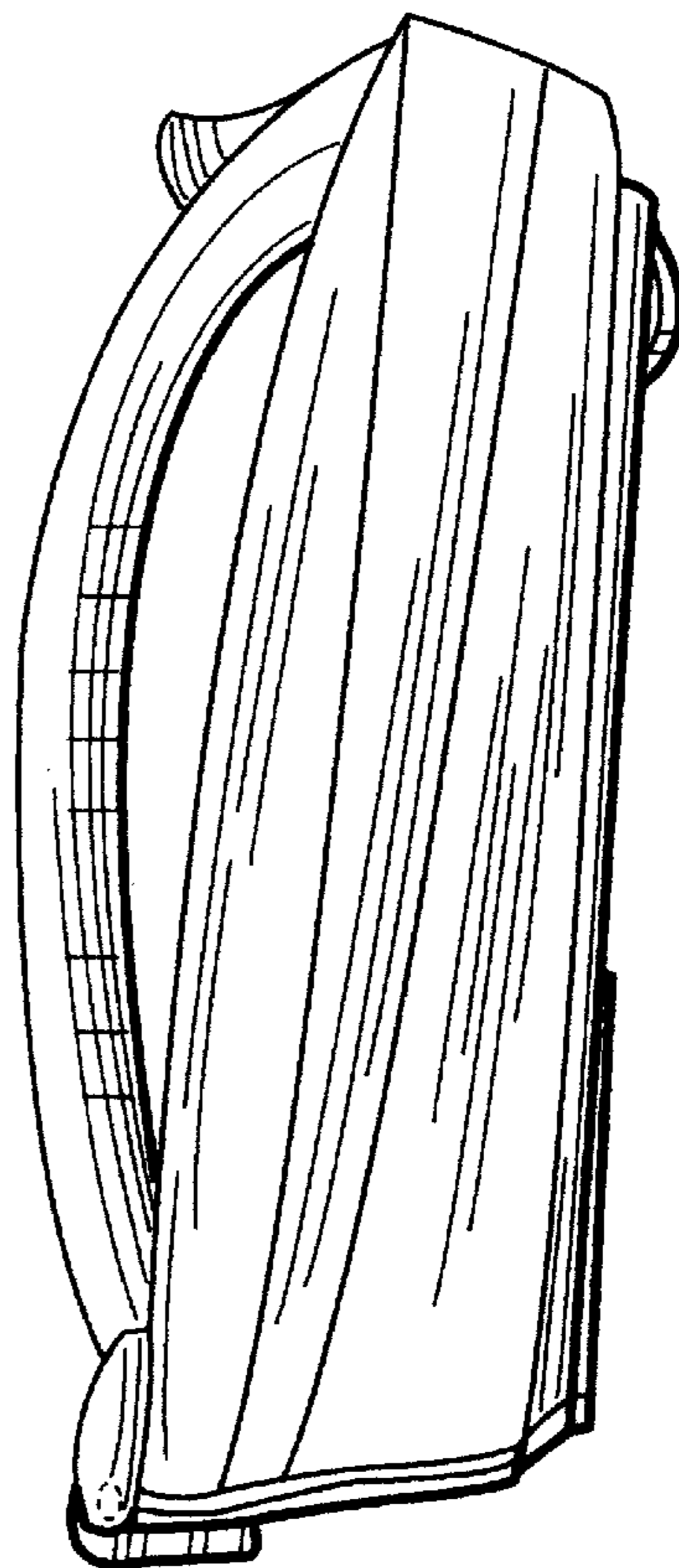

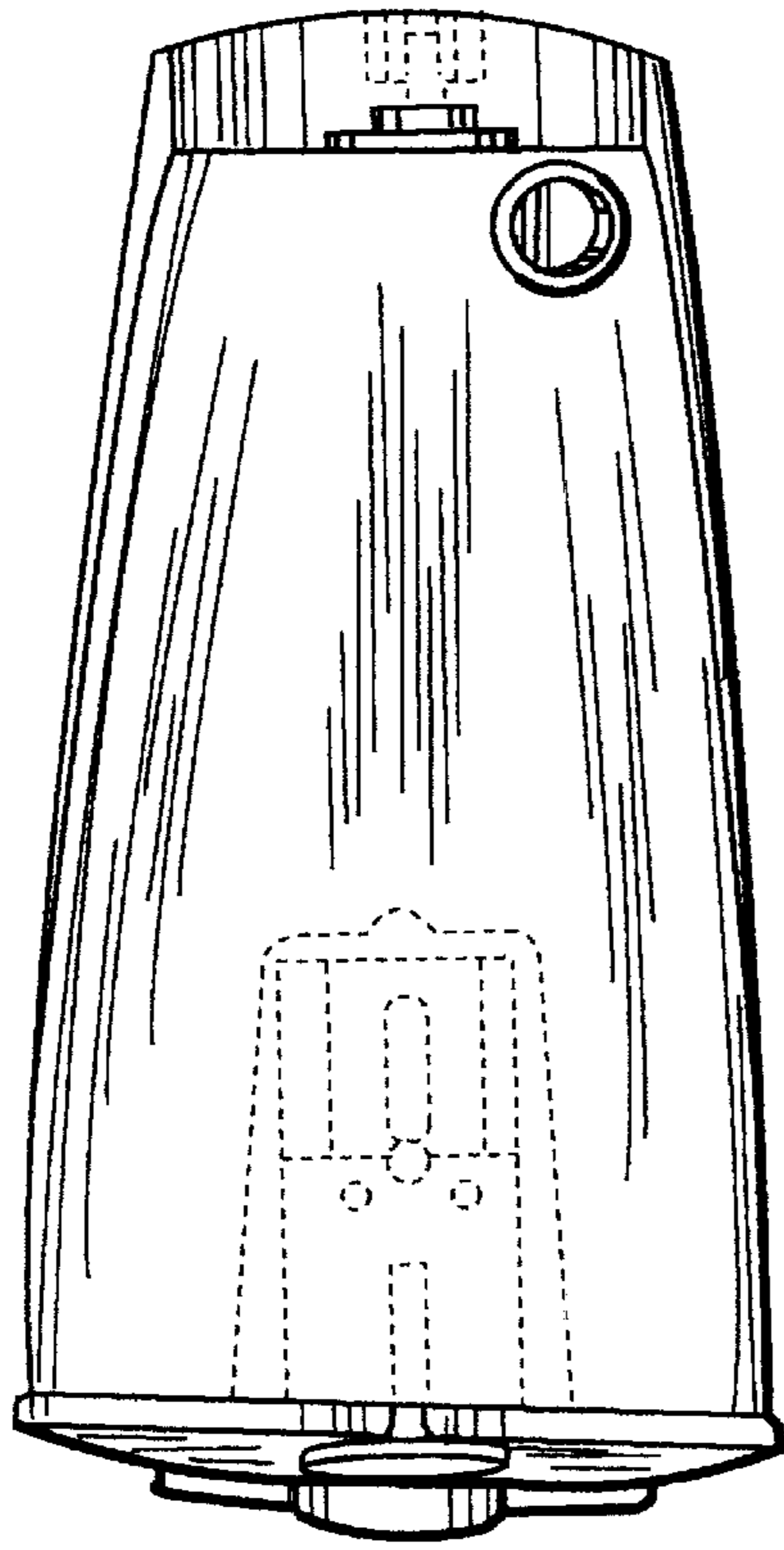




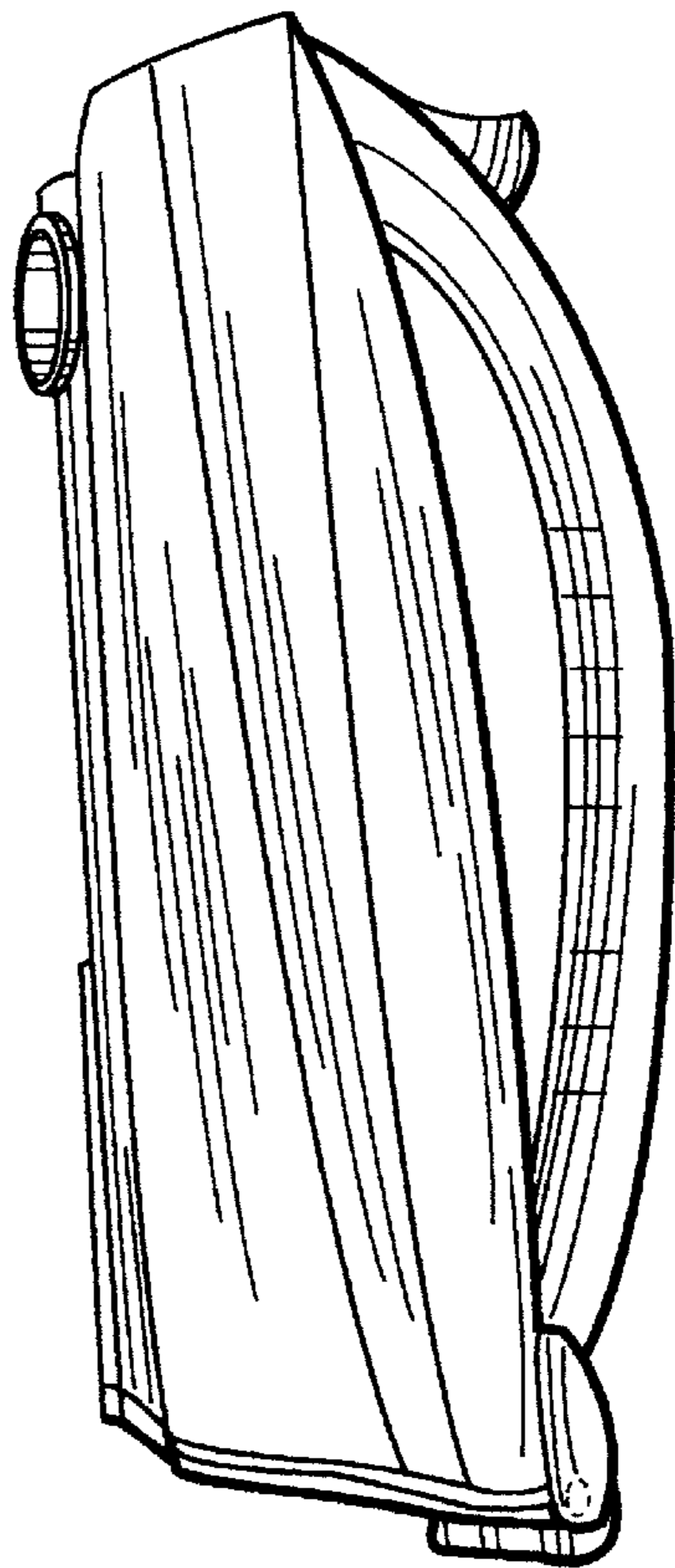

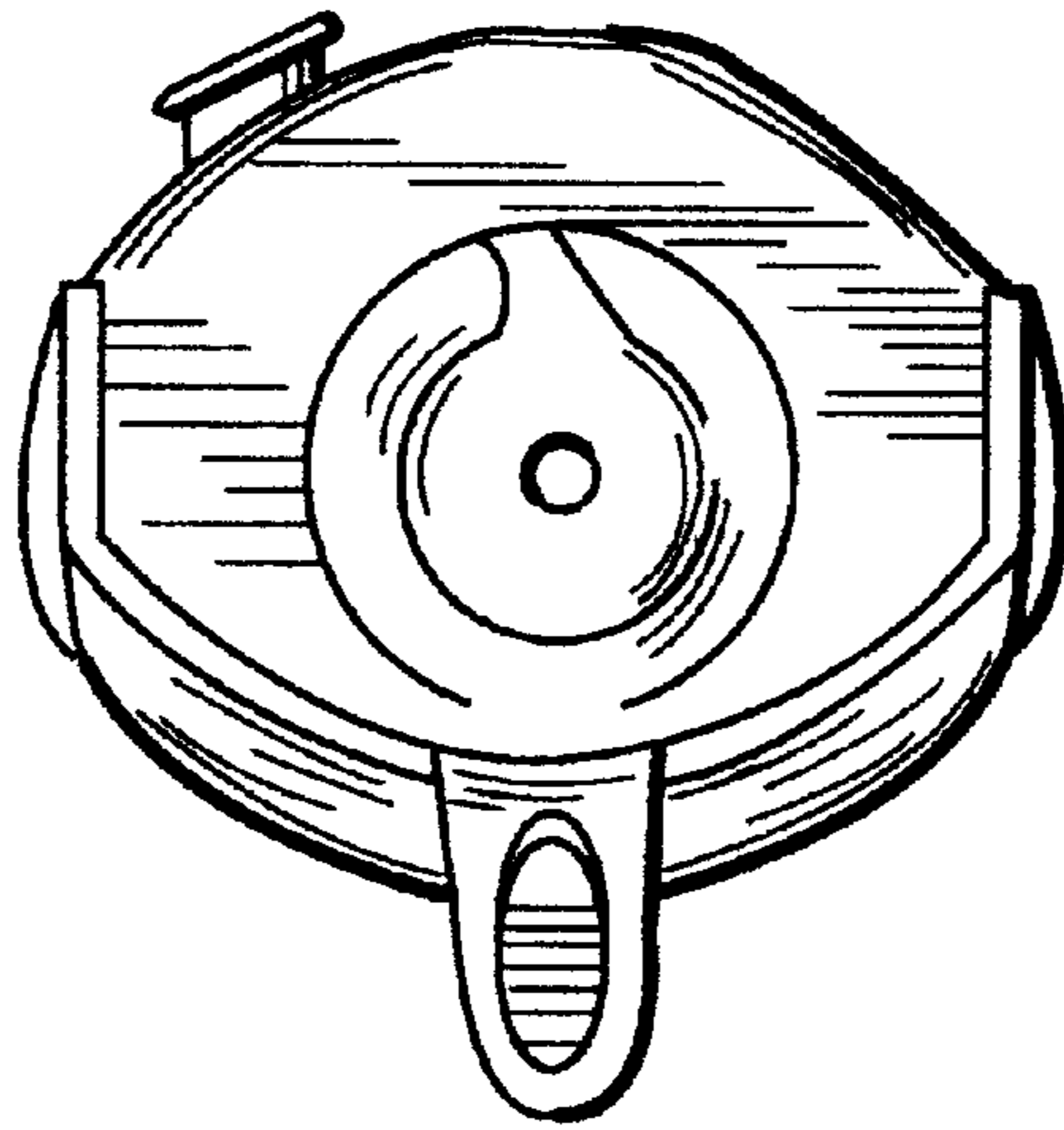

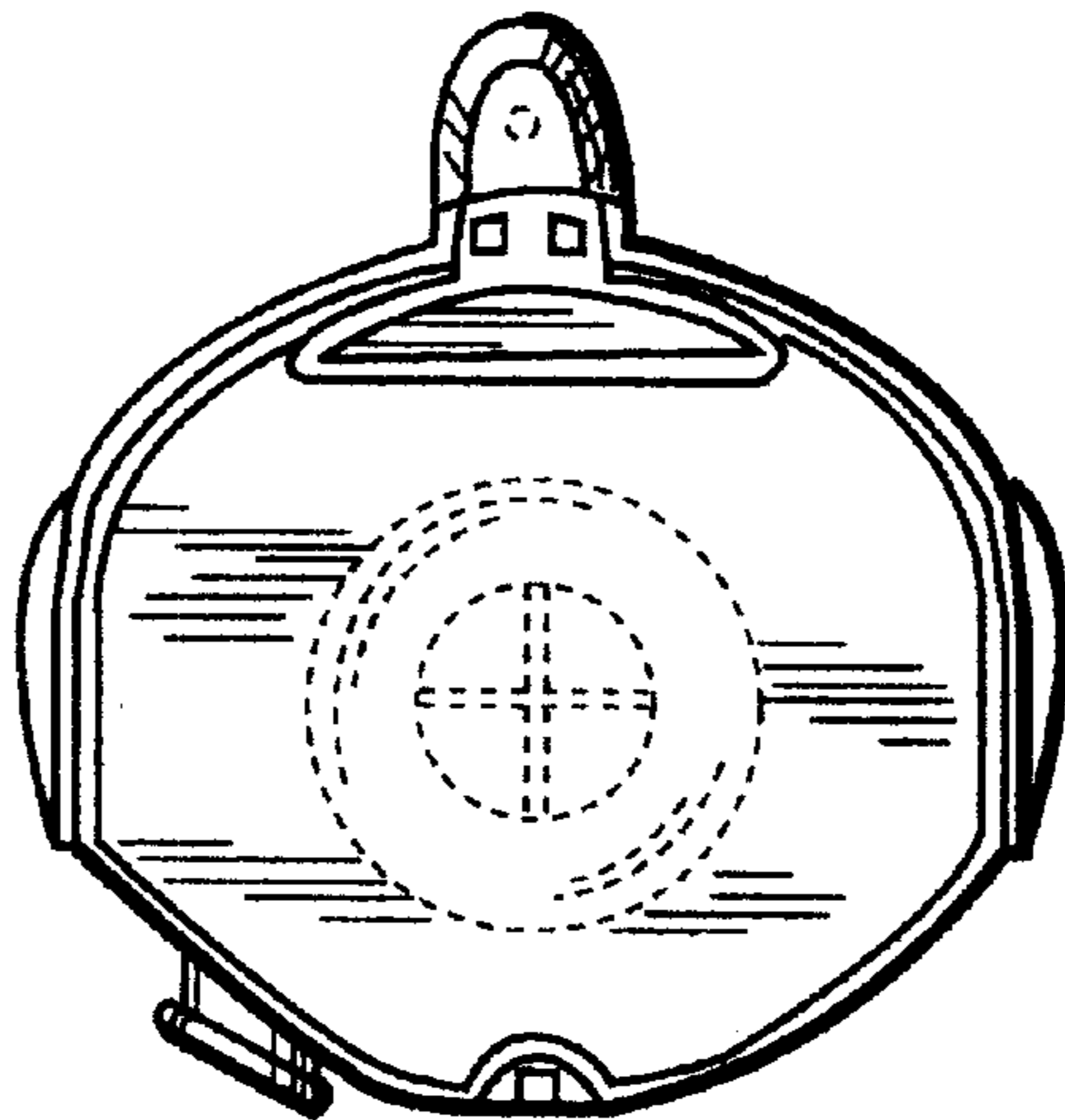
