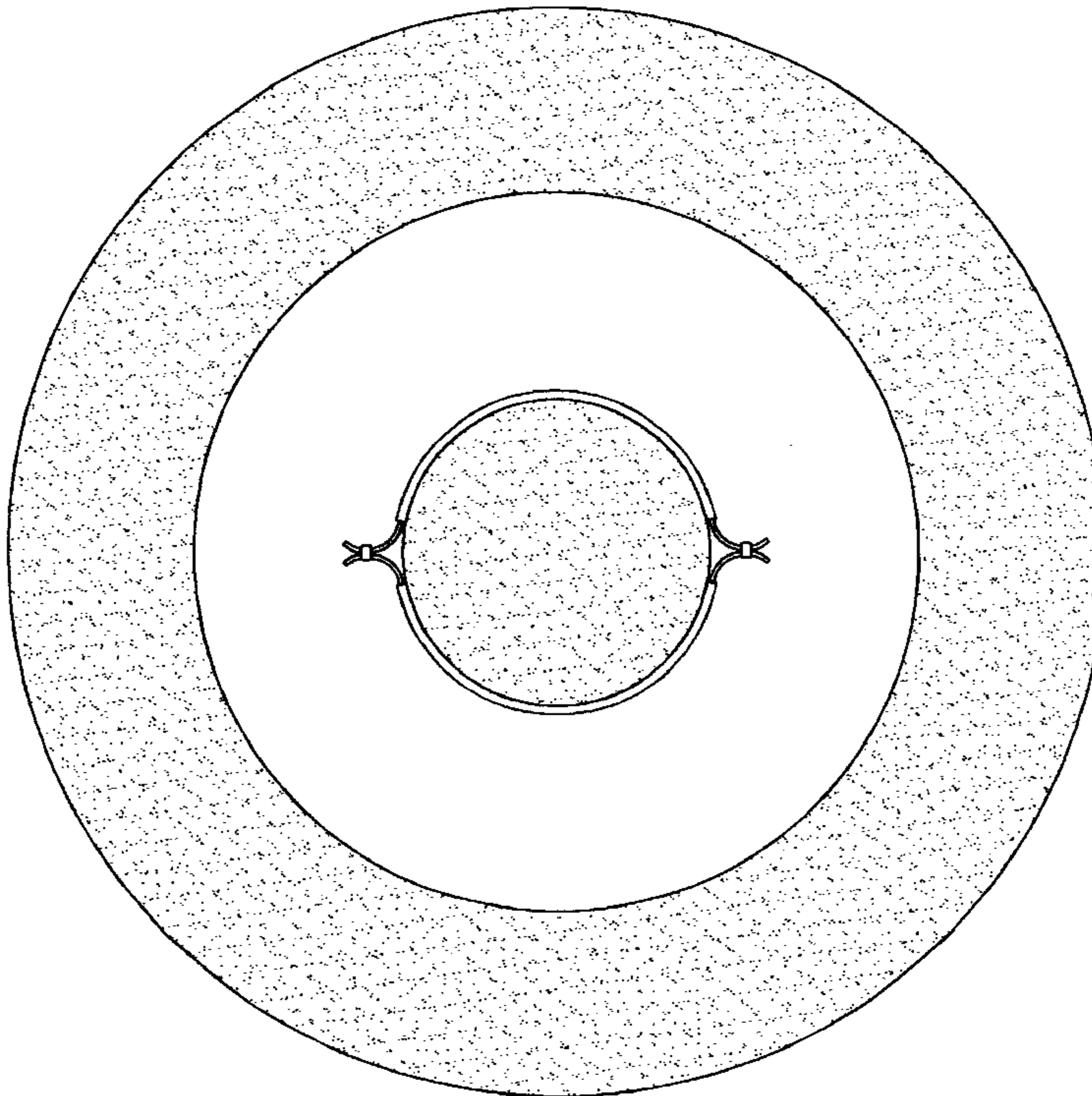
(57) **CLAIM**

DESCRIPTION

FIG. 1 depicts a top plan view of the invention; FIG. 2 depicts a side elevational view of the invention from the uppermost side of the drawing of FIG. 1. FIG. 3 depicts a side elevational view of the invention from the left side of the drawing of FIG. 1; and, FIG. 4 depicts a bottom plan view of the invention. All stippling is intended to depict color contrast.

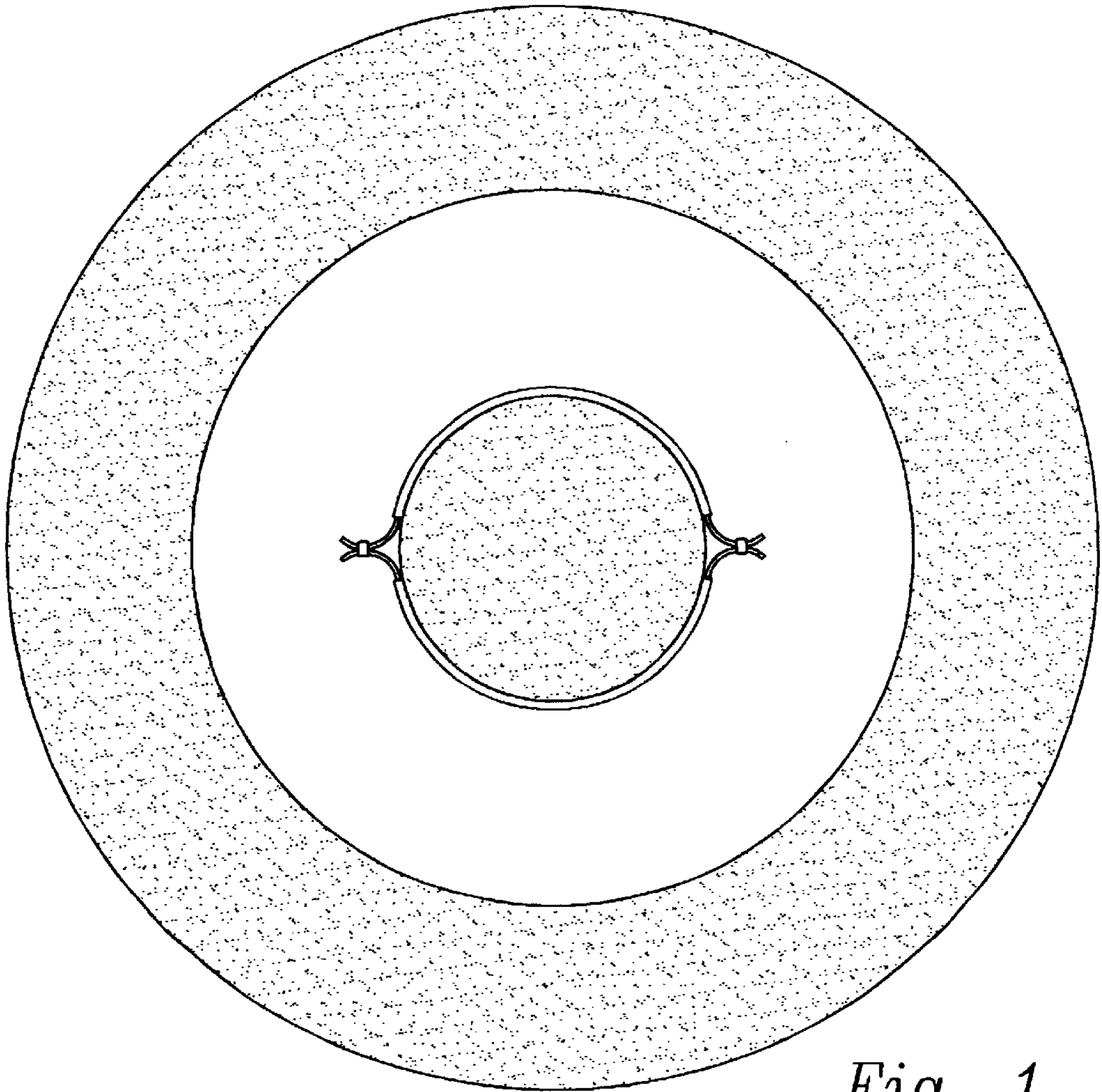

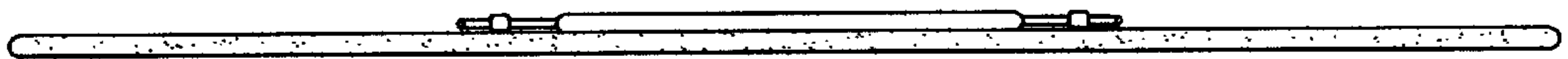

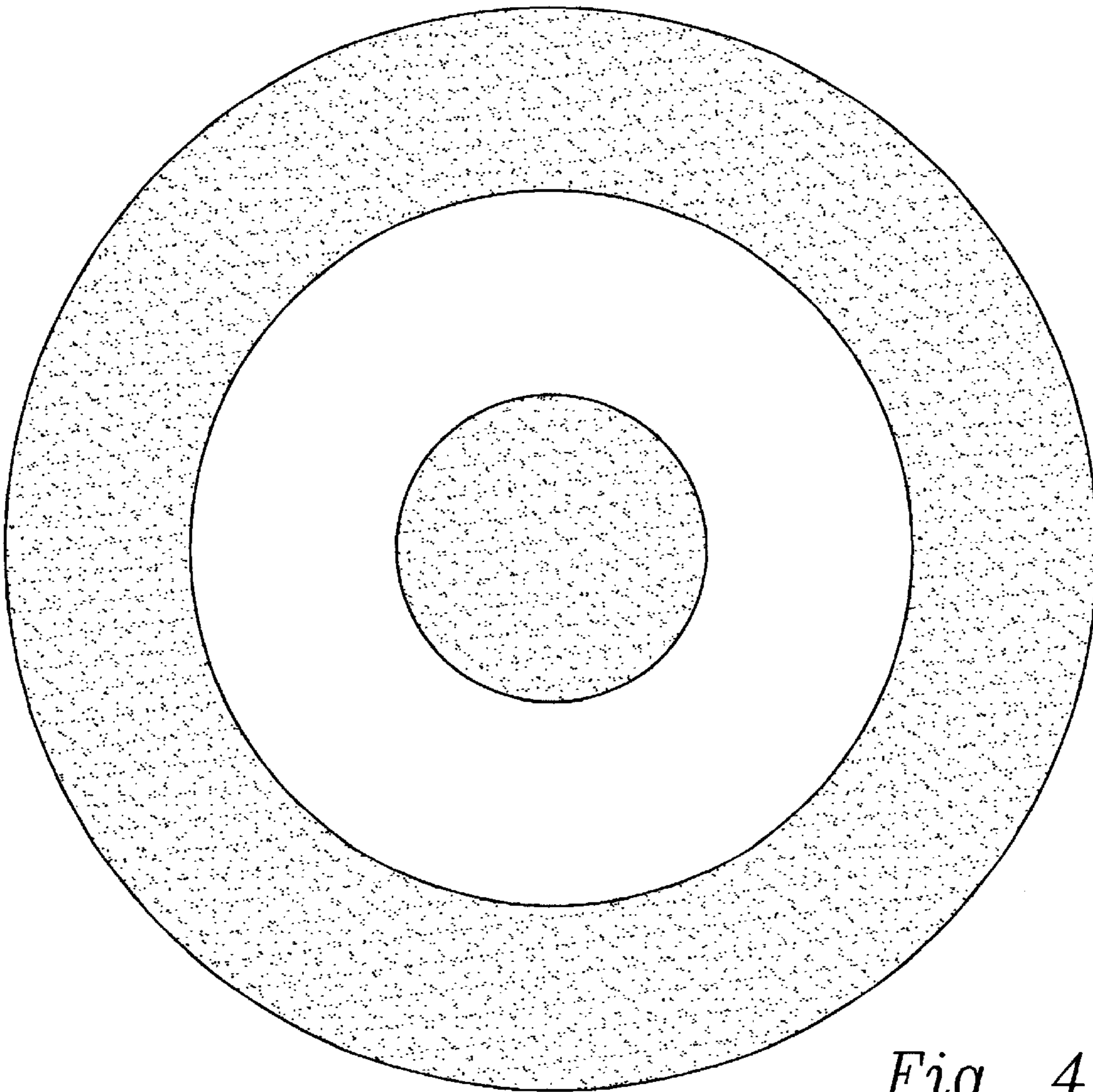
