(57) **CLAIM**

We claim the ornamental design for a beverage reservoir, as shown and described.

DESCRIPTION

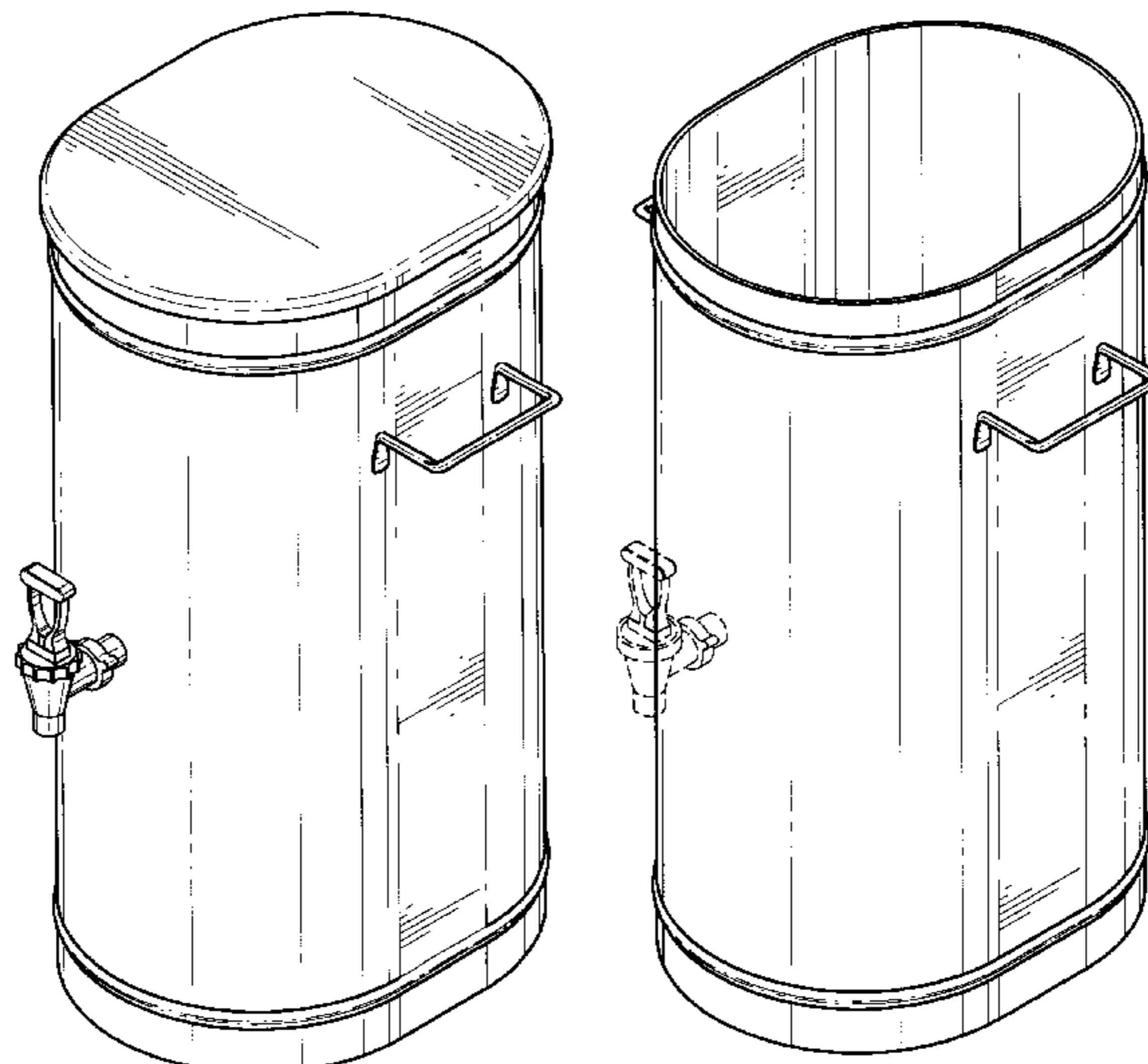

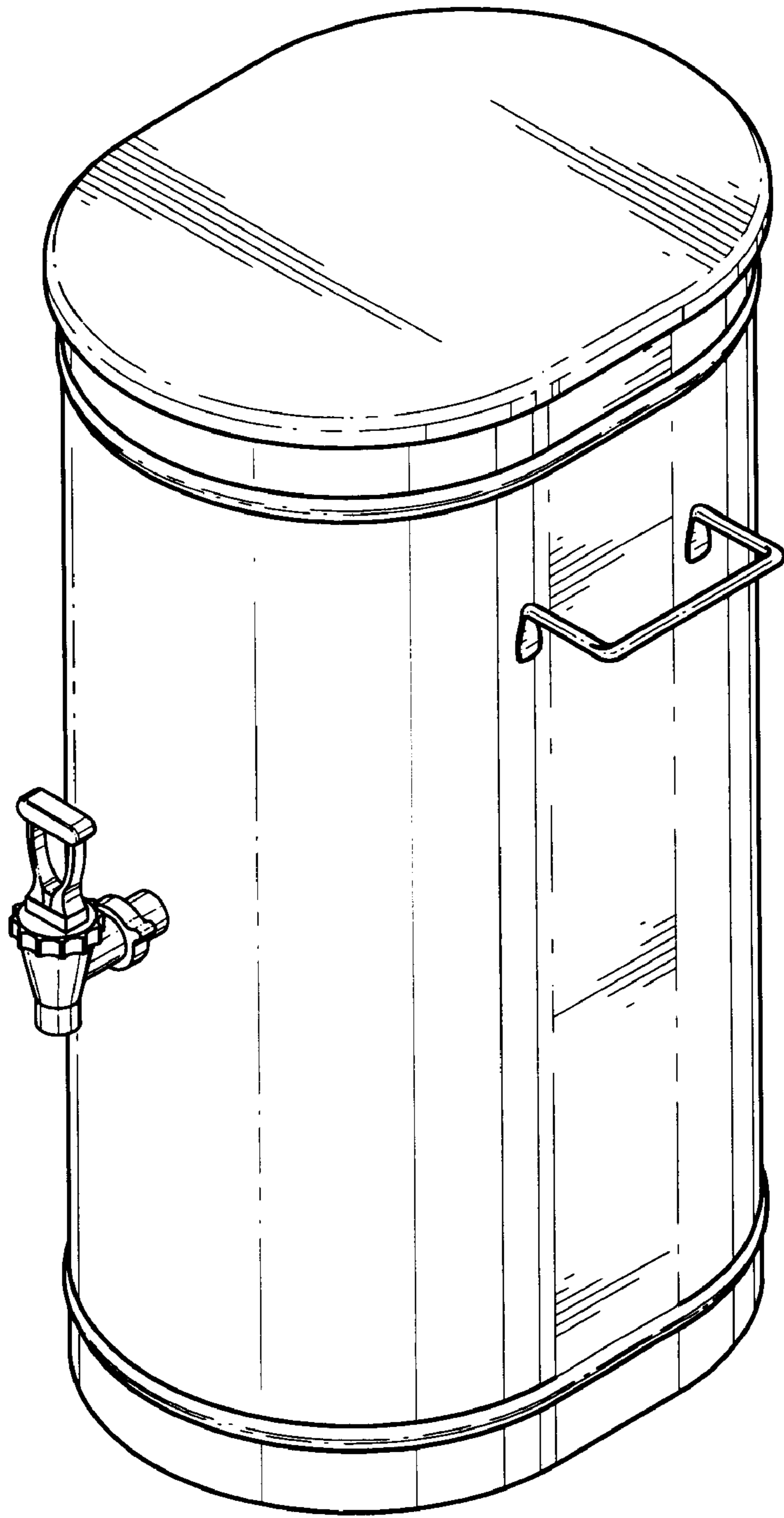

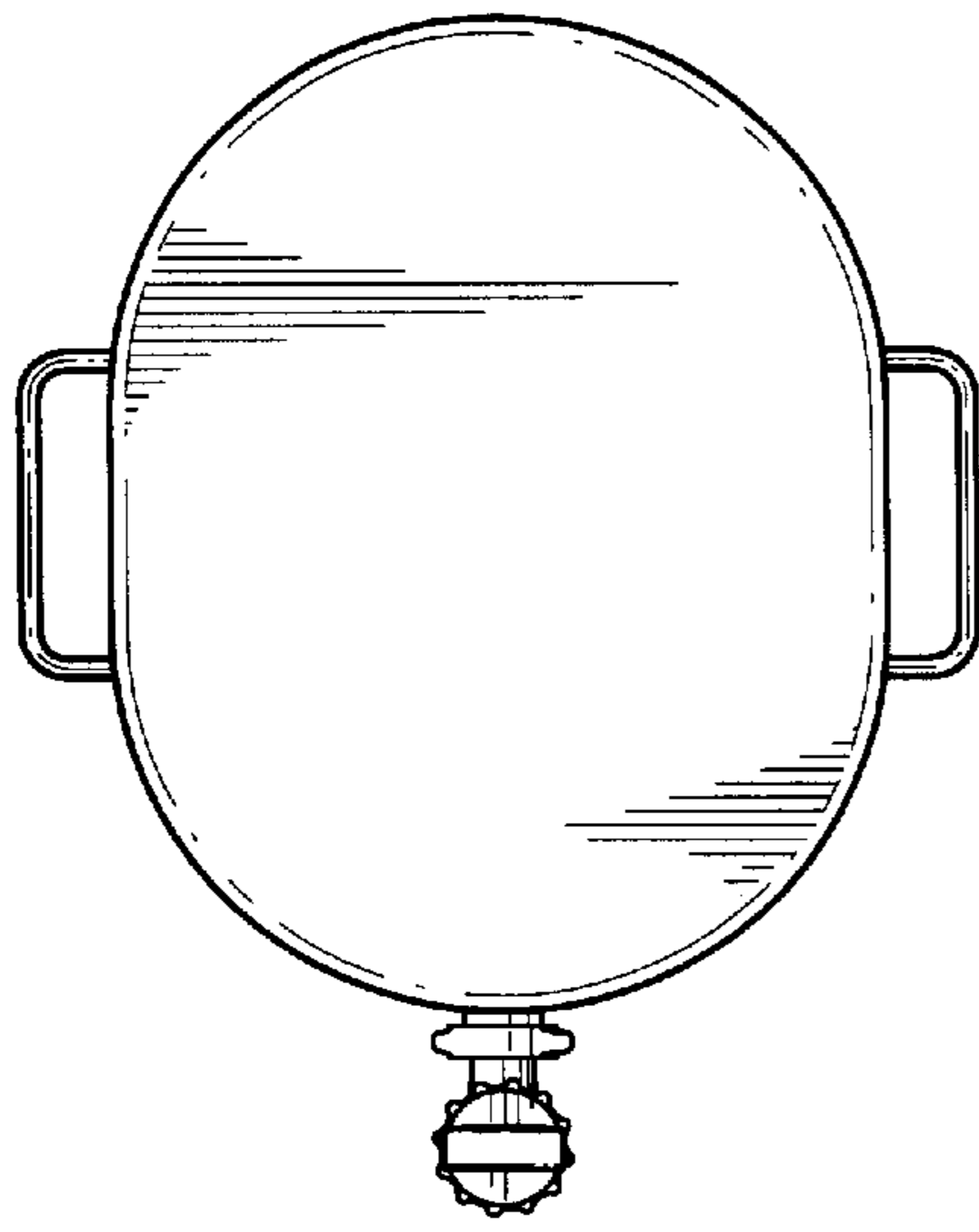

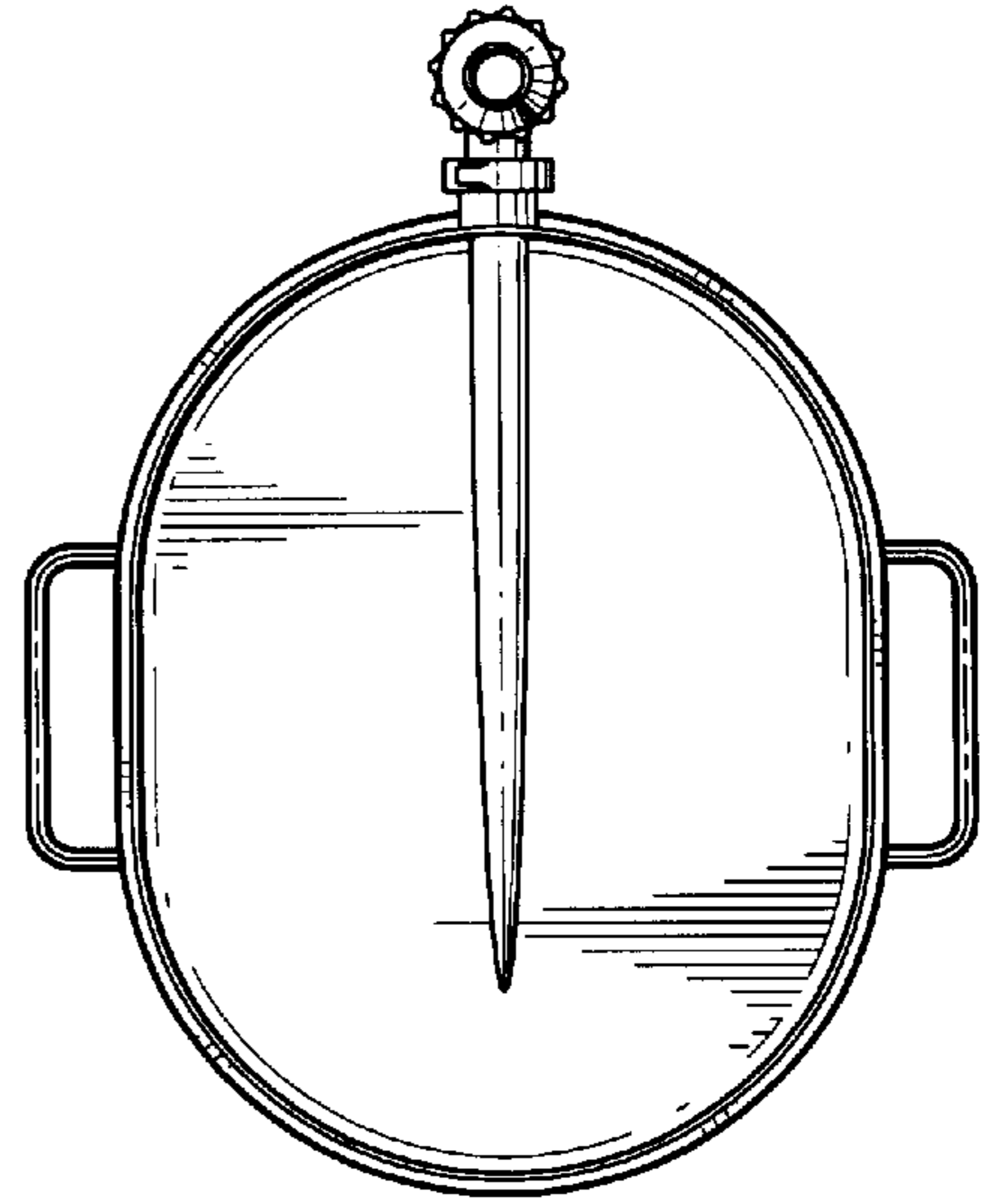

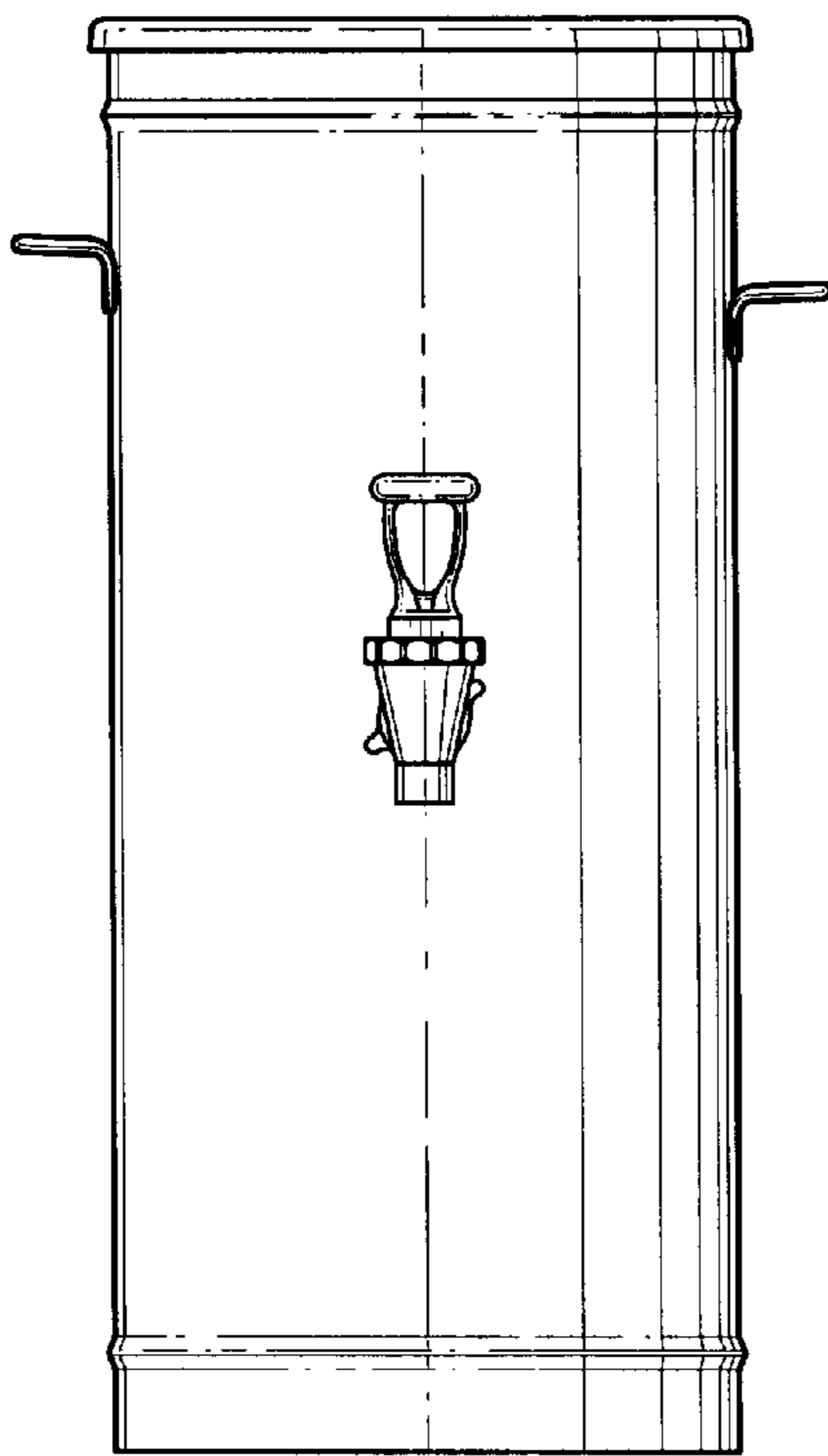

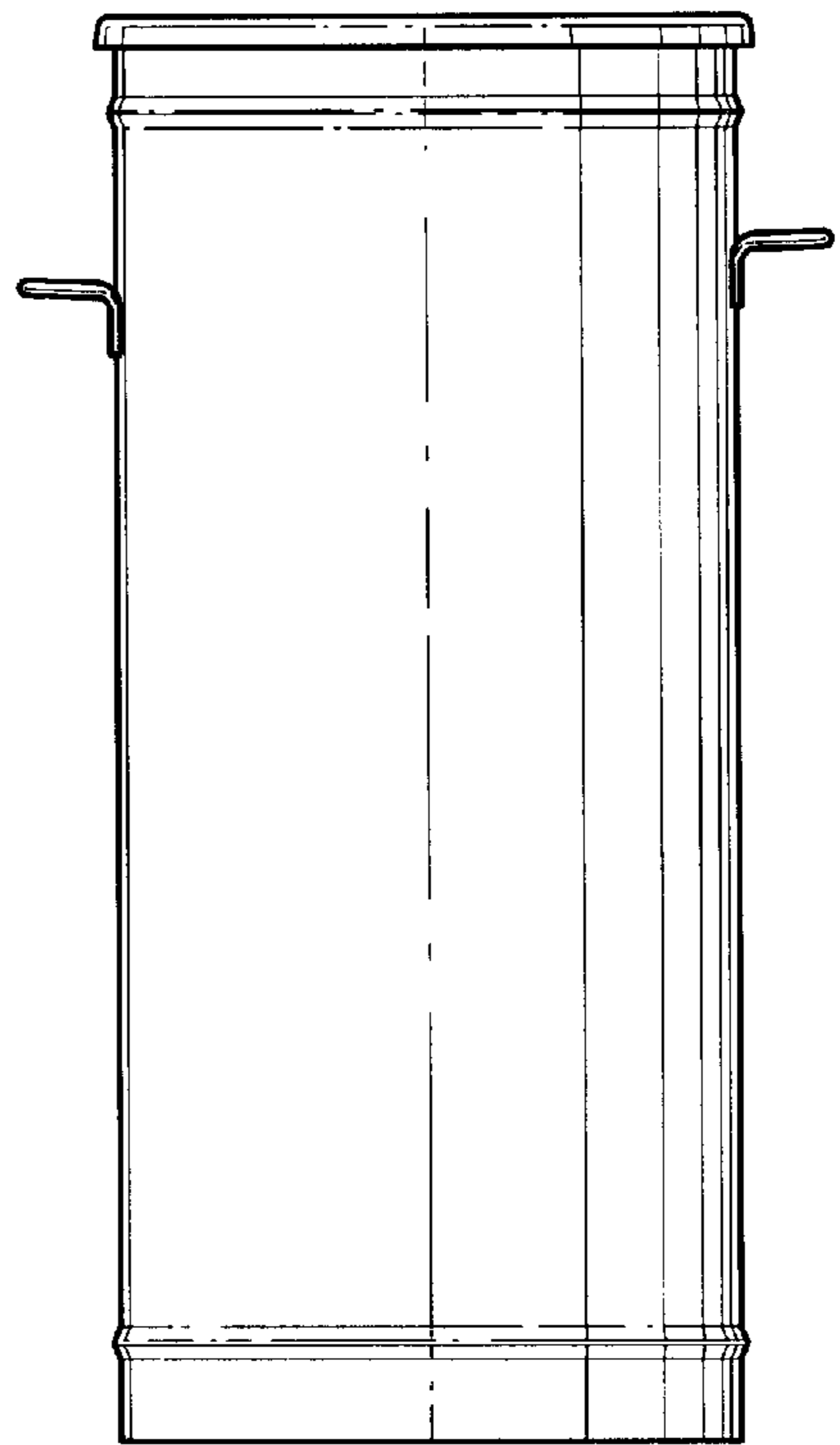

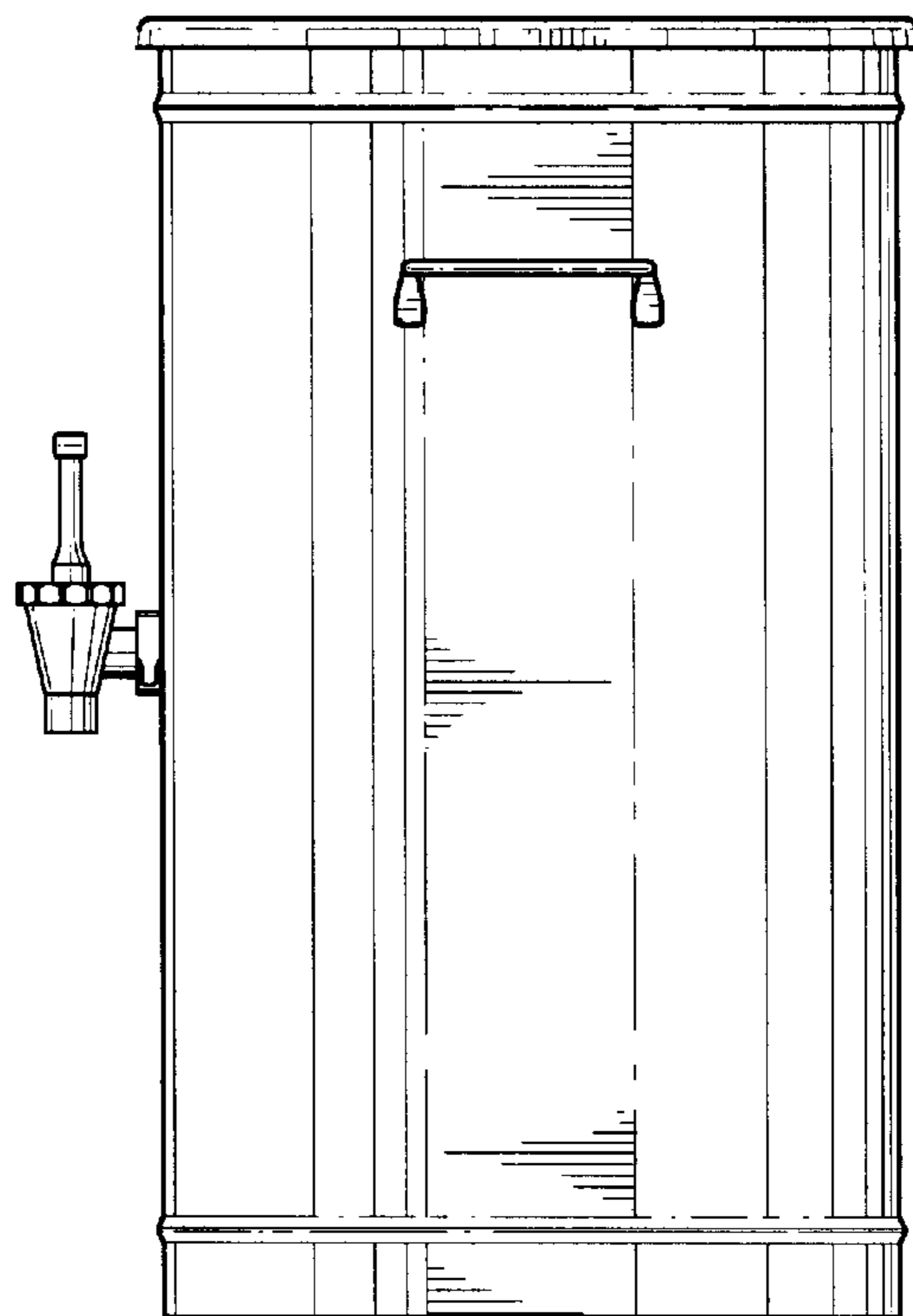
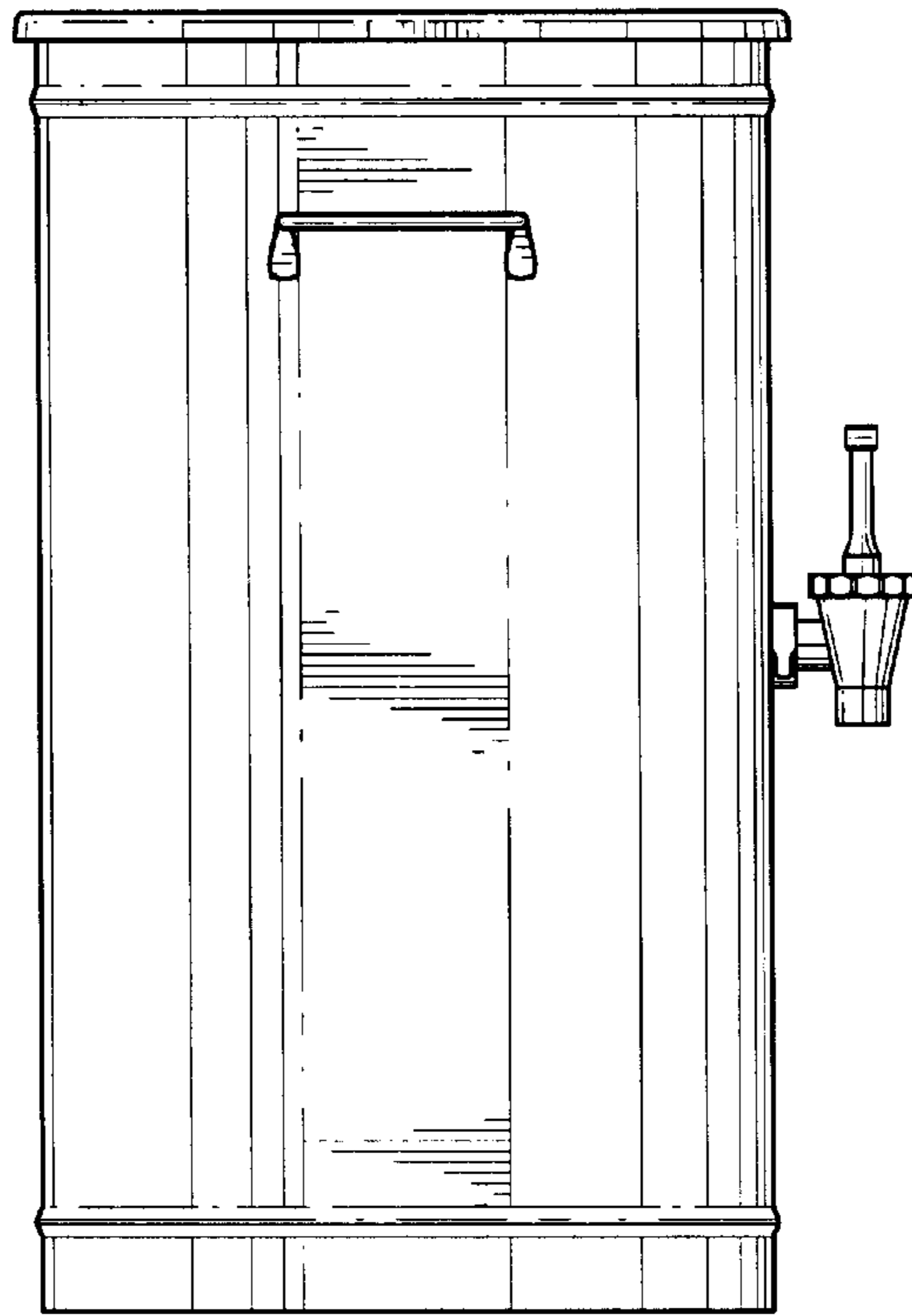

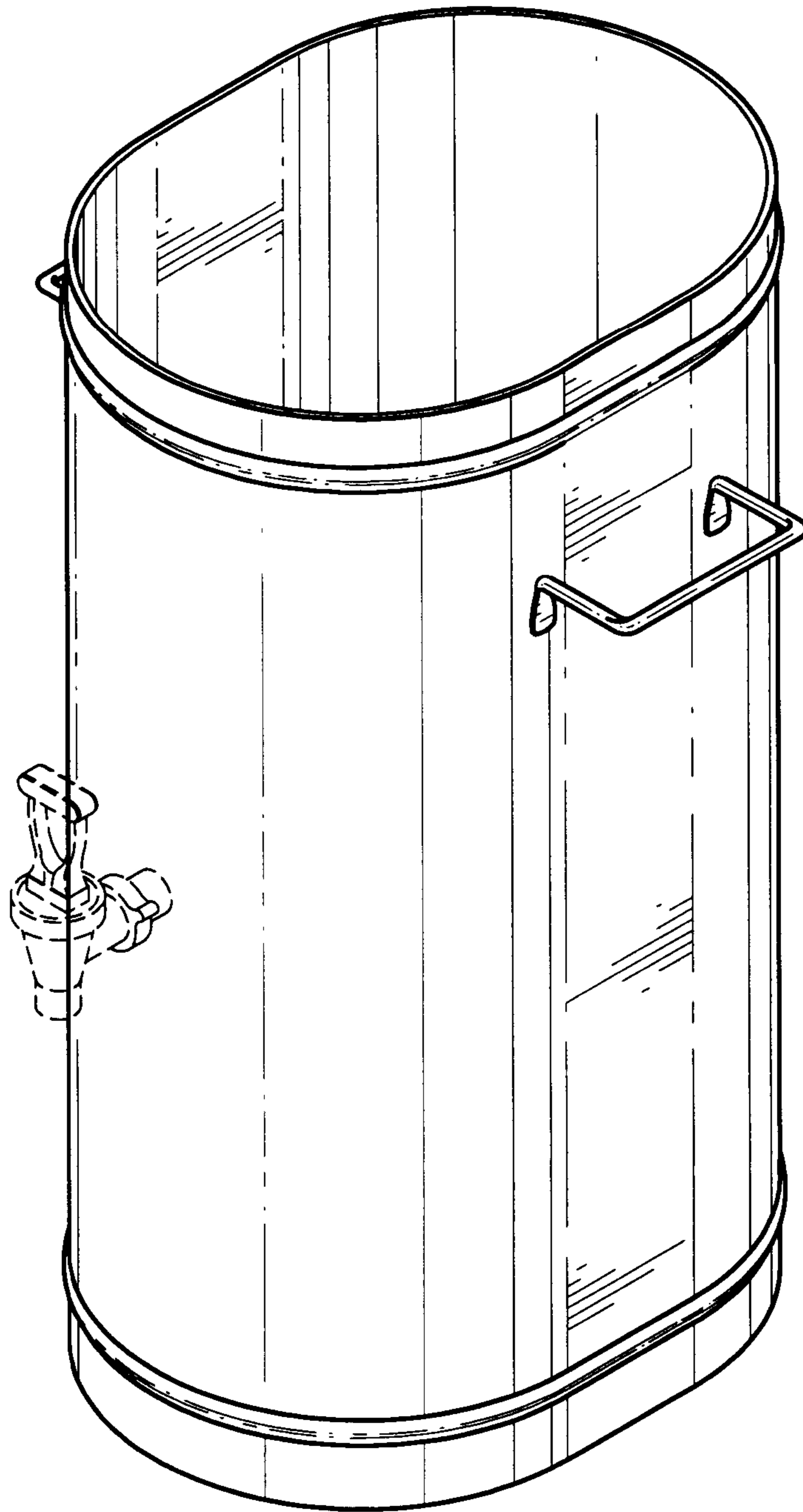

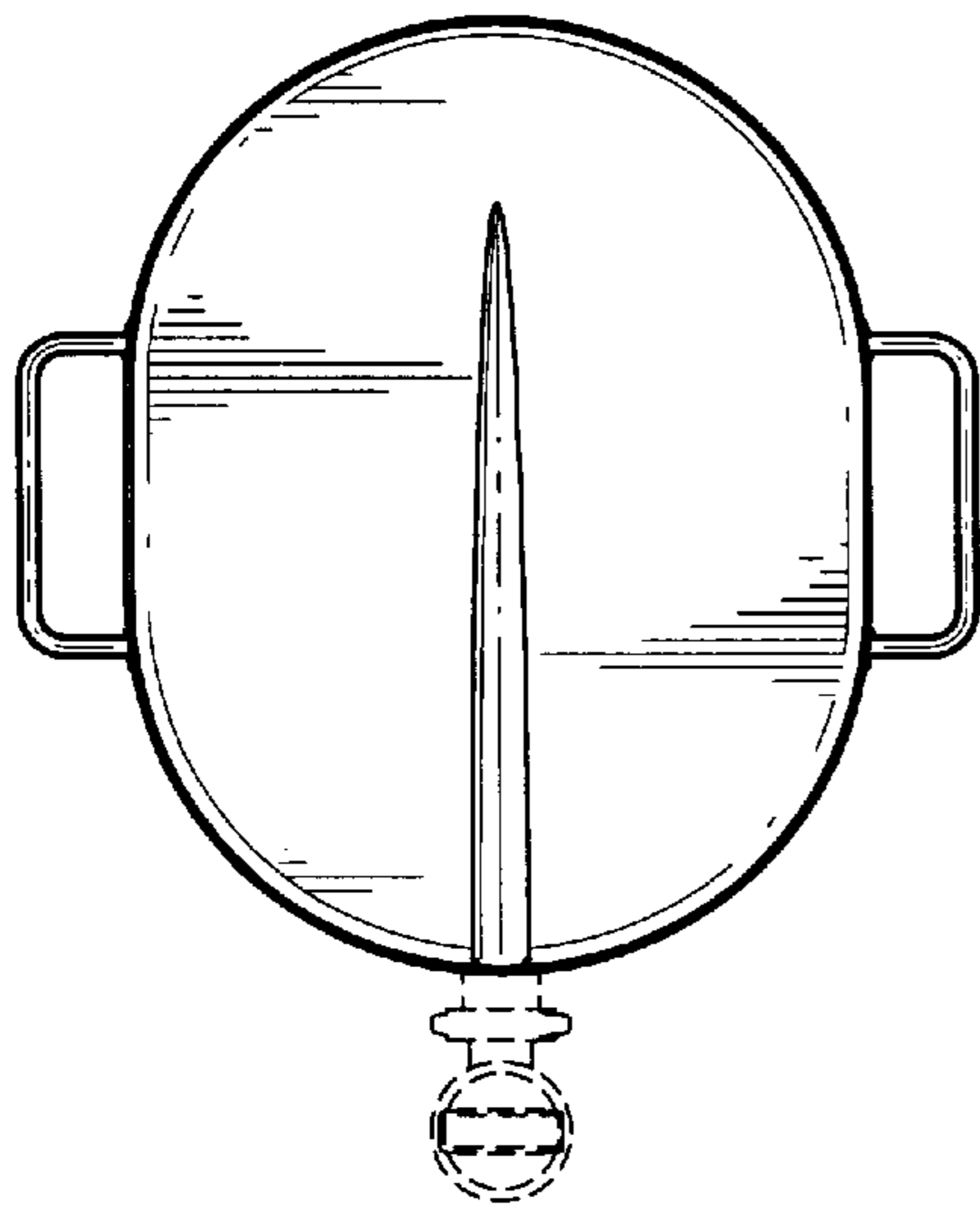

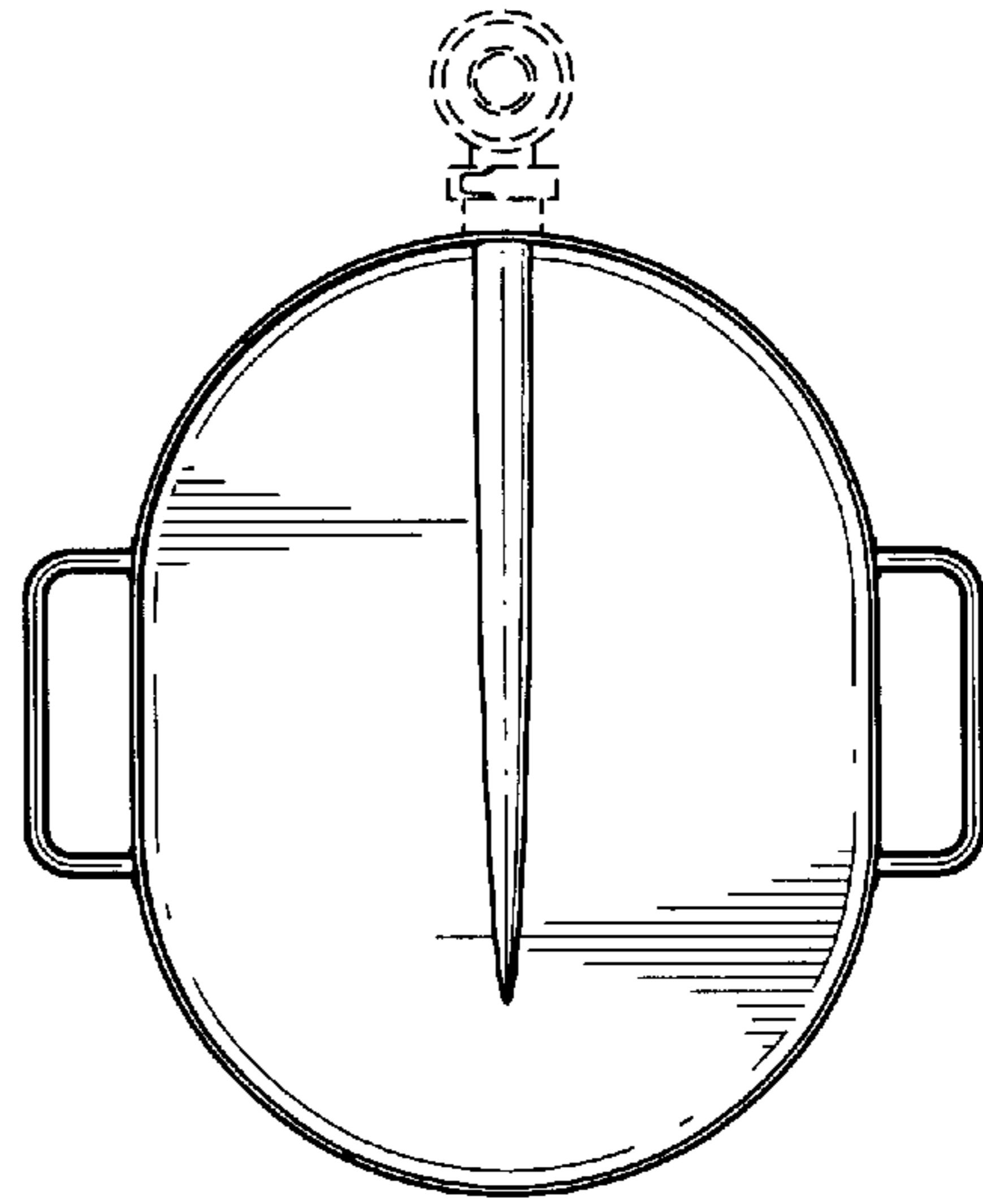

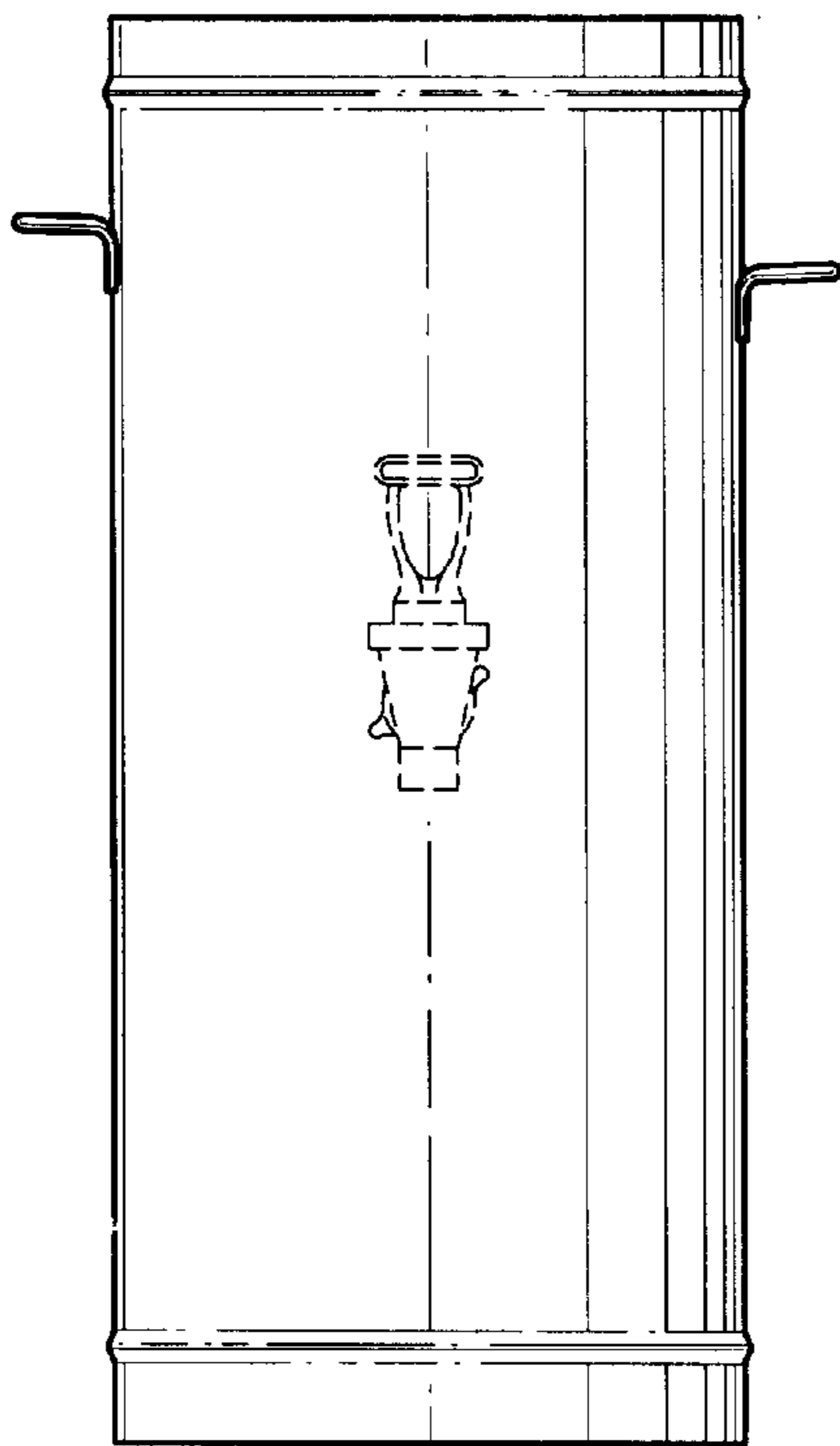

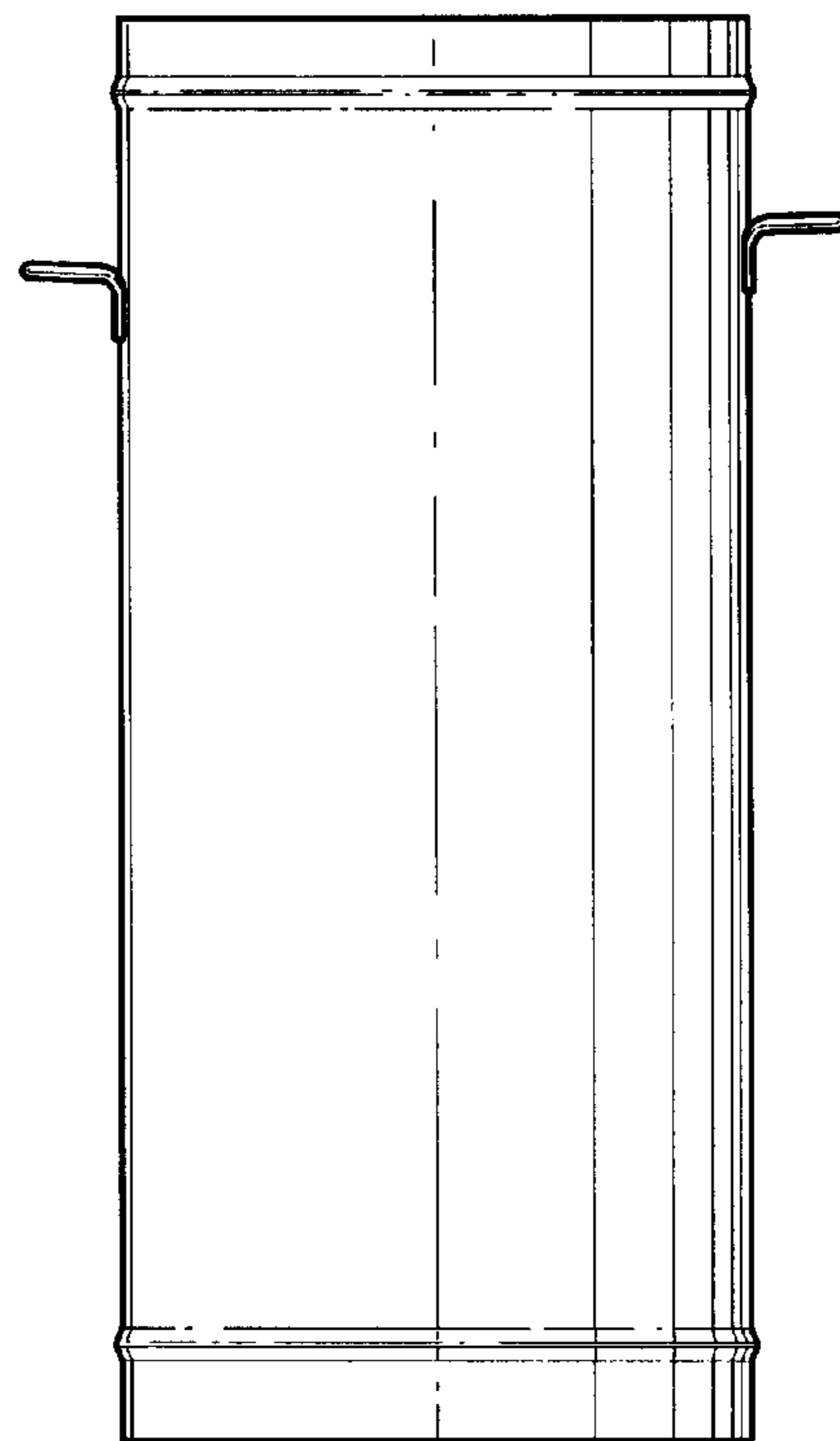

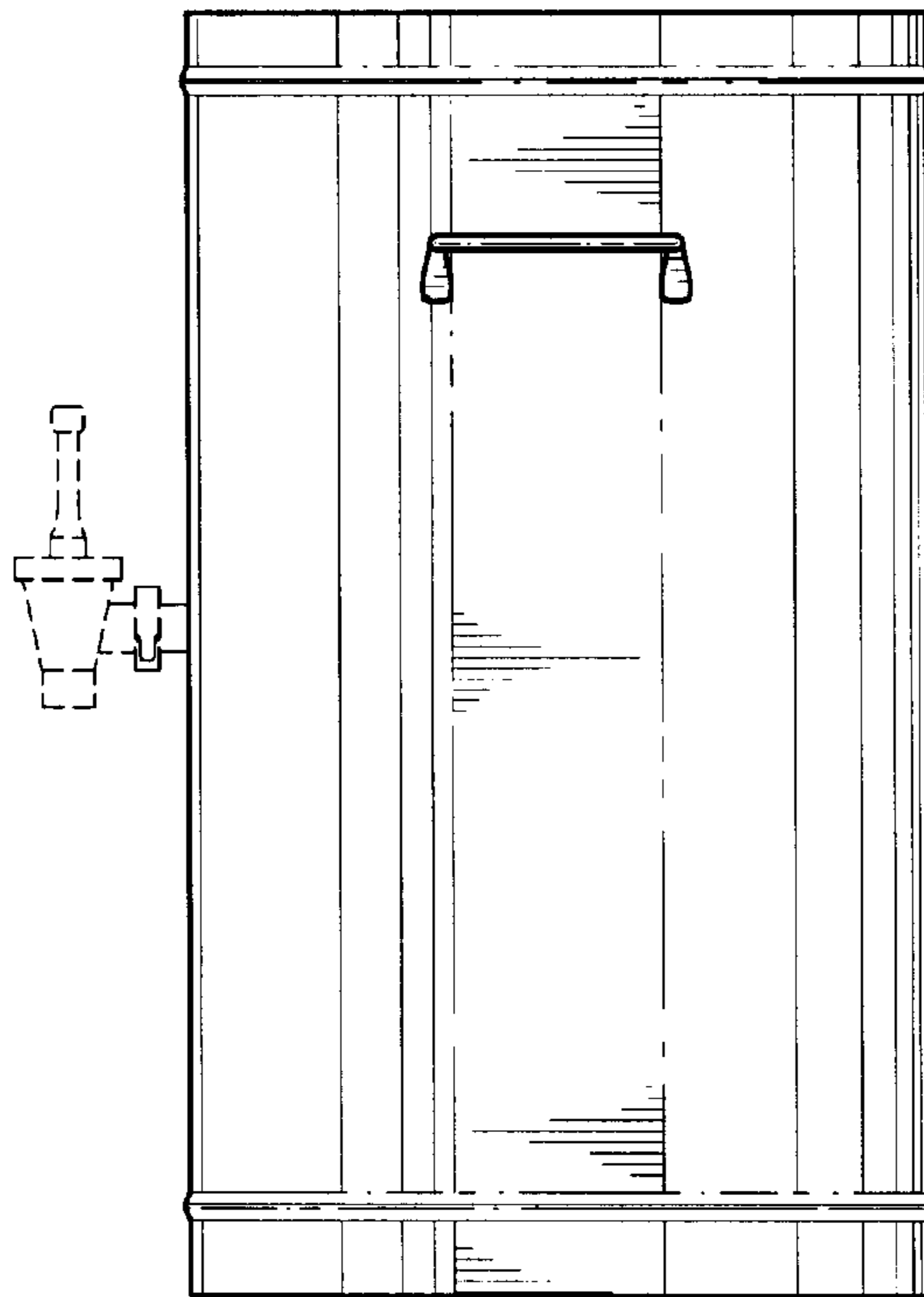
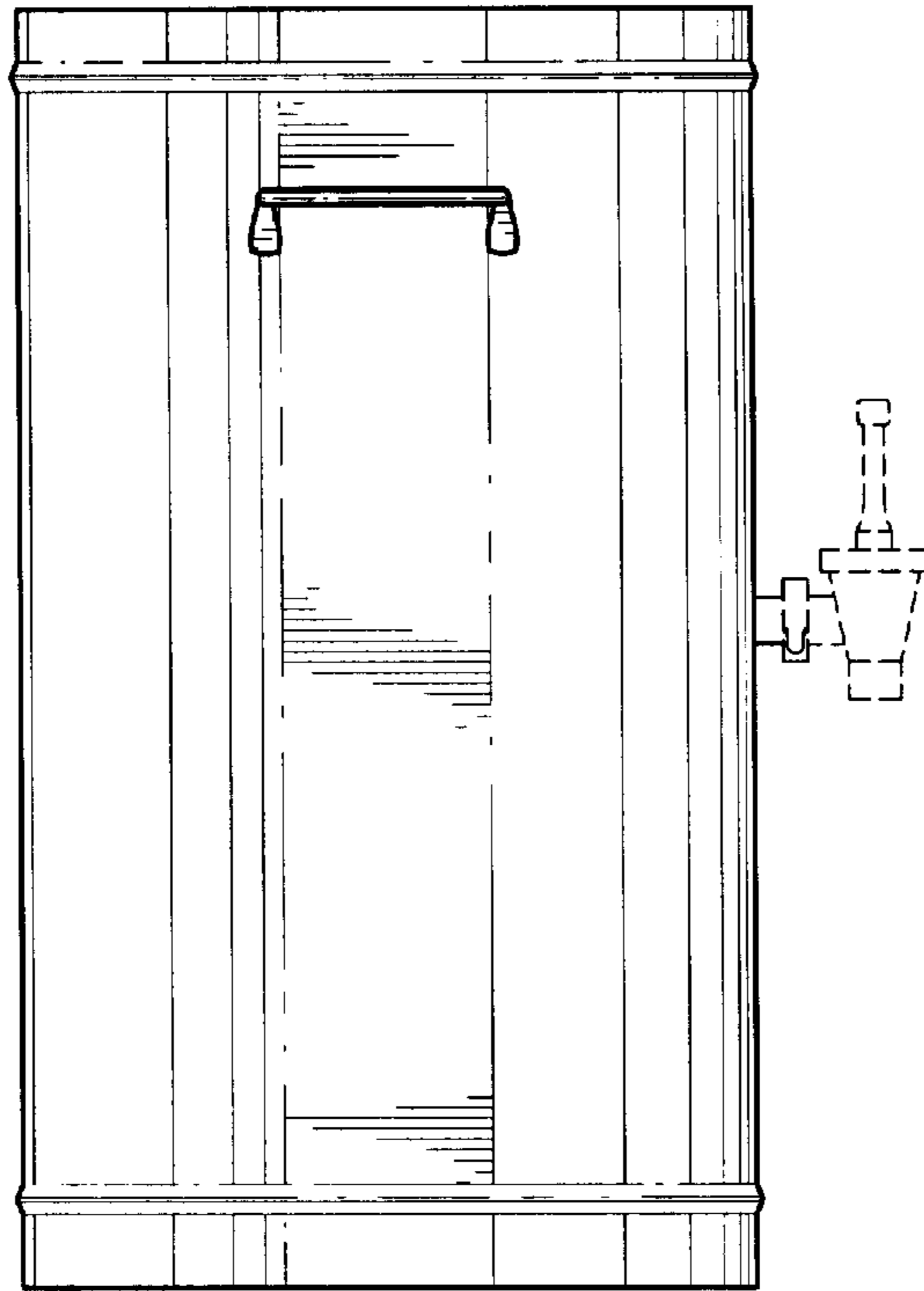
