The ornamental design of a cover for food container, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view illustrating the cover for food container, constructed in accordance with the teachings of the present invention.

FIG. 2 is a front elevational view of the cover for food container of FIG. 1.

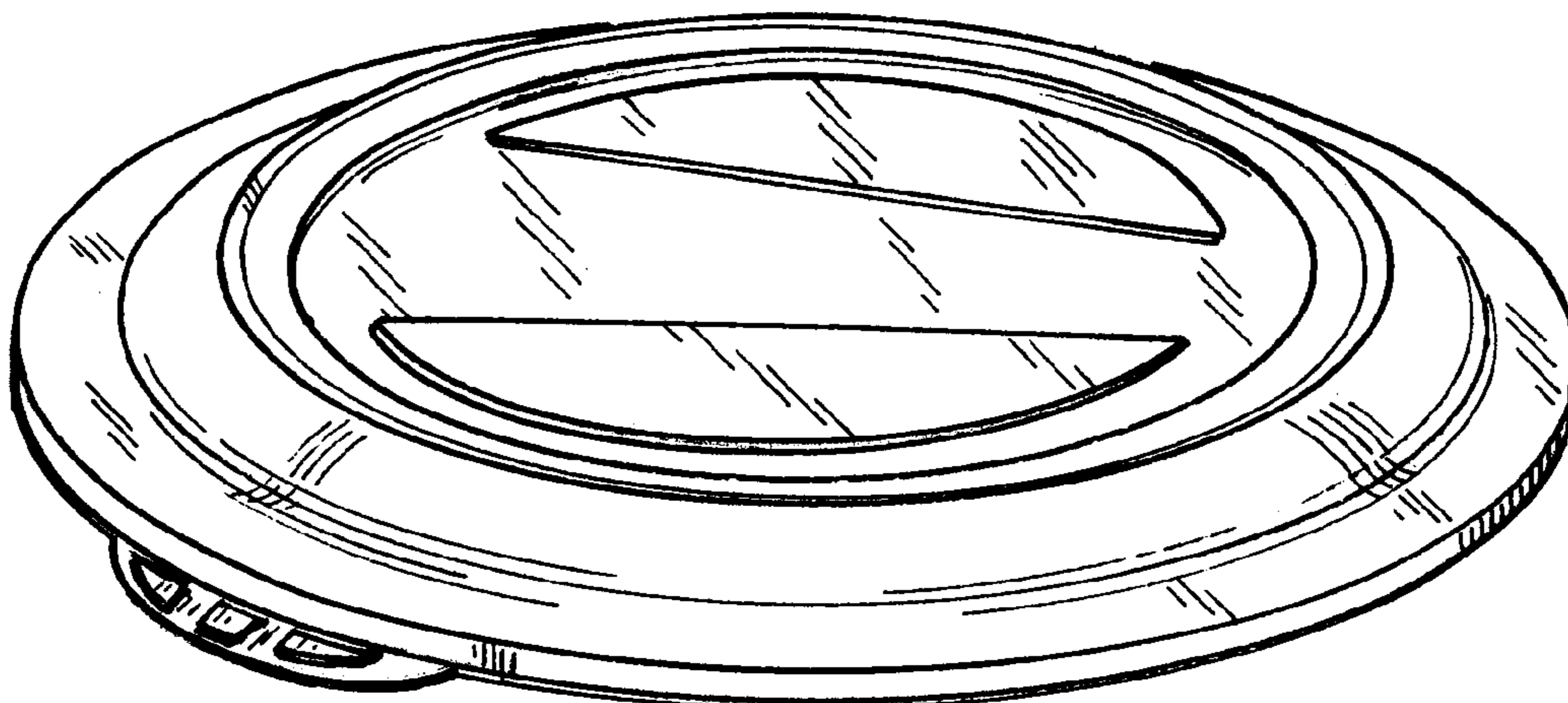
FIG. 3 is a rear elevational view of the cover for food container of FIG. 1.

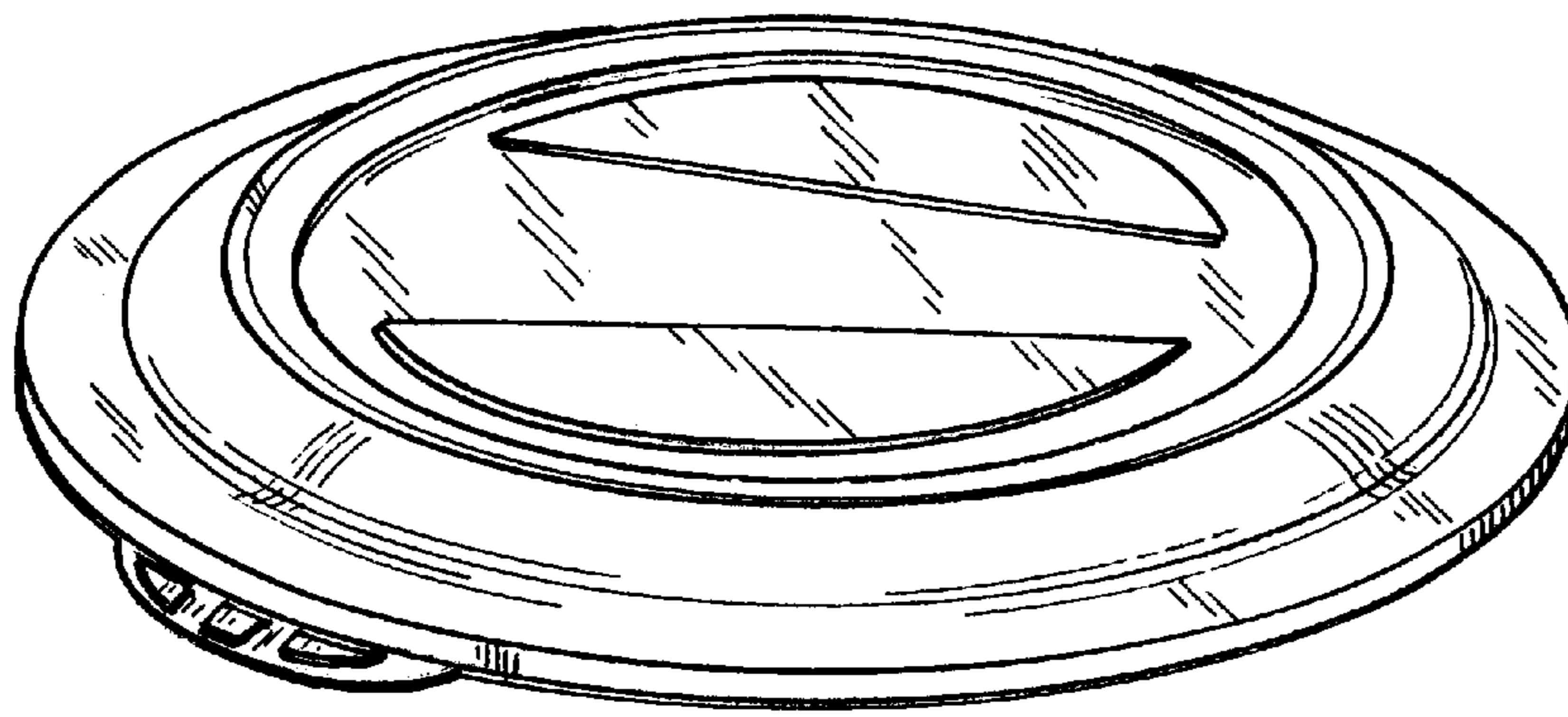

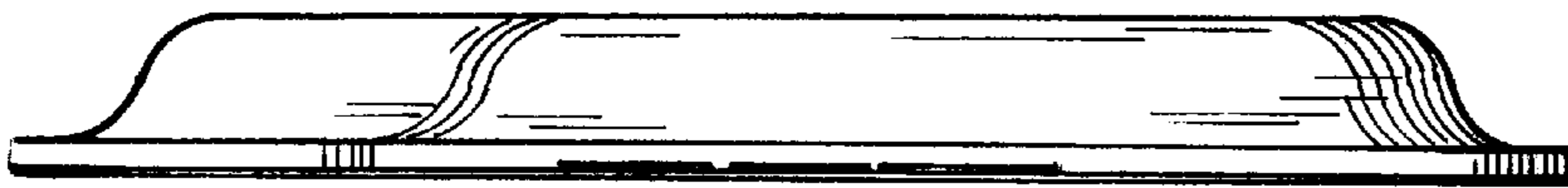

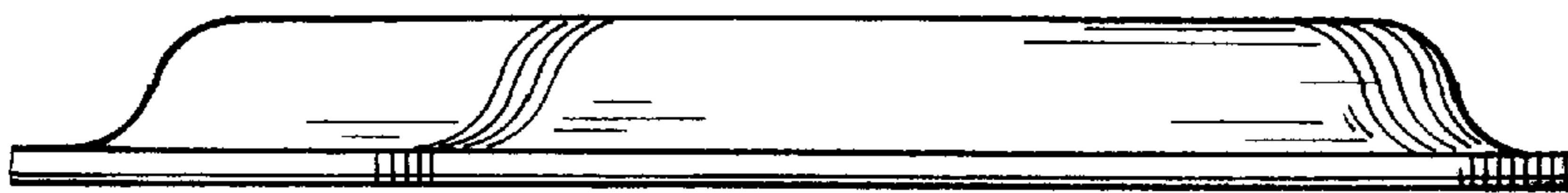

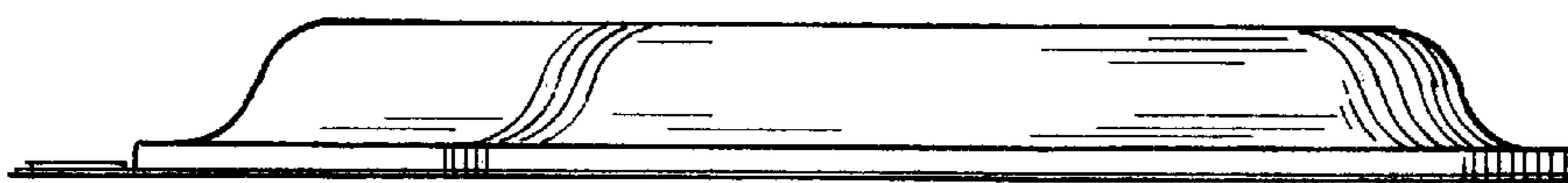
