The ornamental design for a cup, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment cup according to the present design; the back elevational view being a mirror image thereof;

FIG. 2 is a first side elevational view thereof;

FIG. 3 is a second side elevational view thereof;

FIG. 4 is a top view thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a front elevational view of a second embodiment cup according to the present design; the back elevational view being the same;

FIG. 7 is a first side elevational view thereof; the second side elevational view being the same;

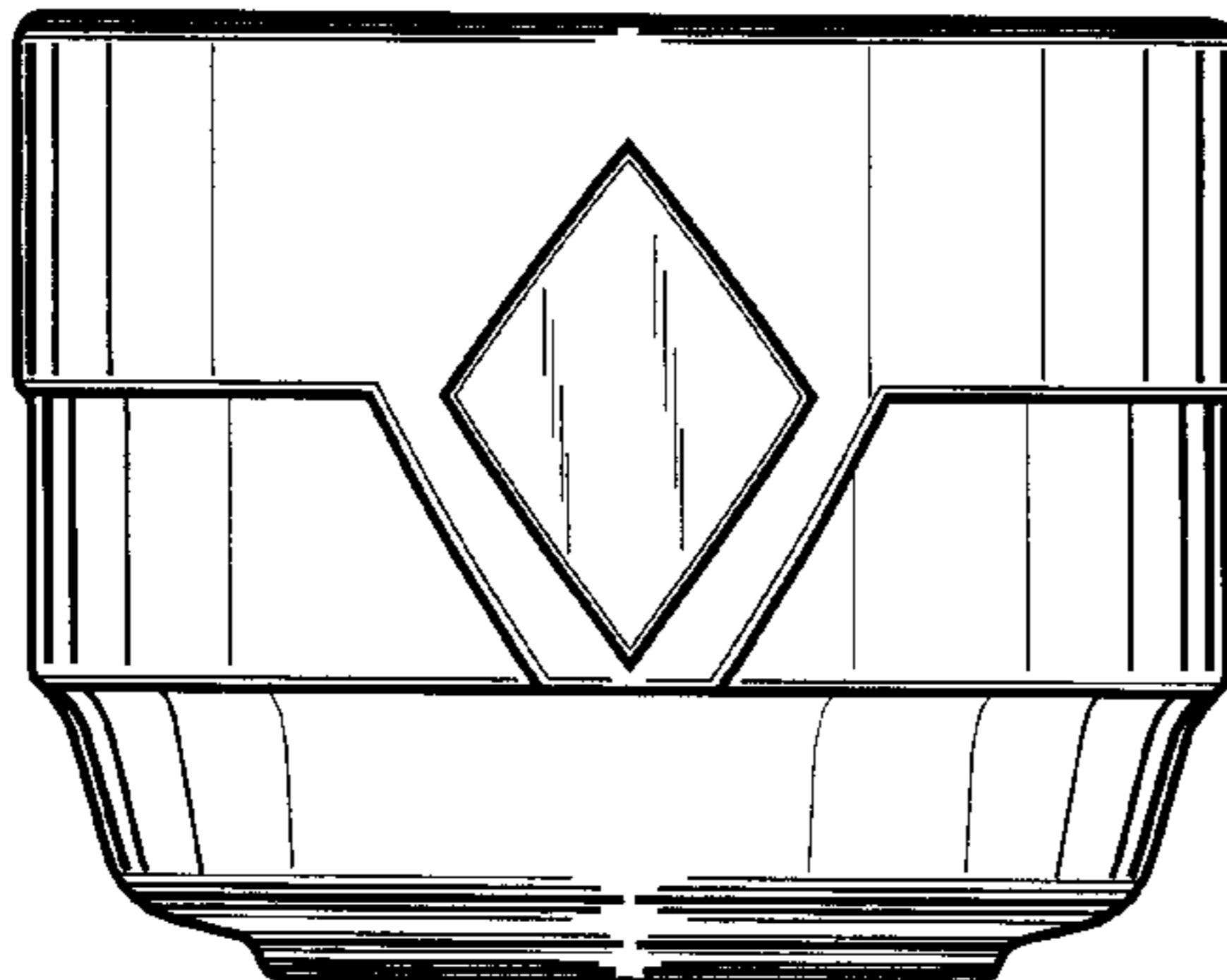
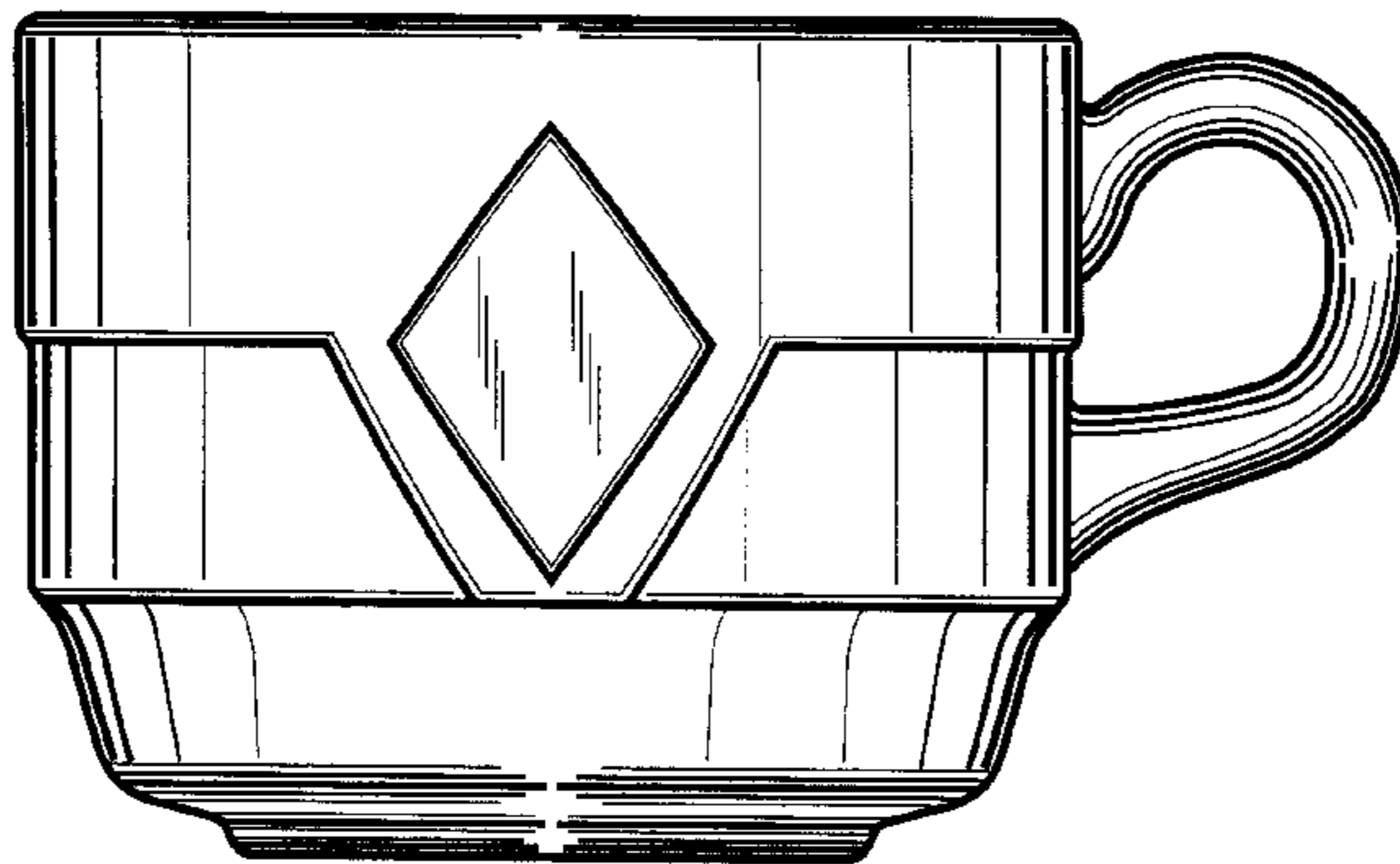
FIG. 8 is a top view thereof; and,

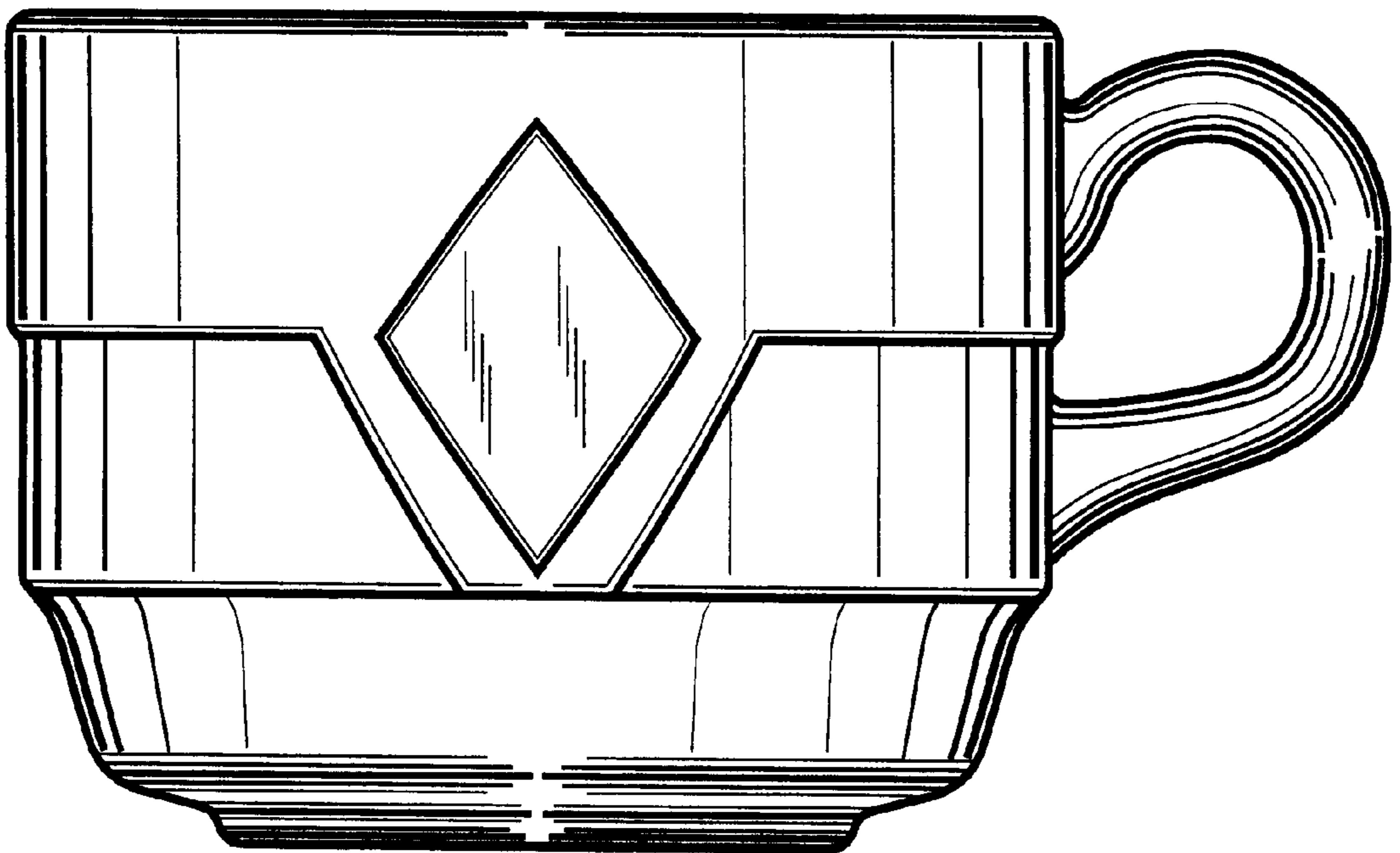
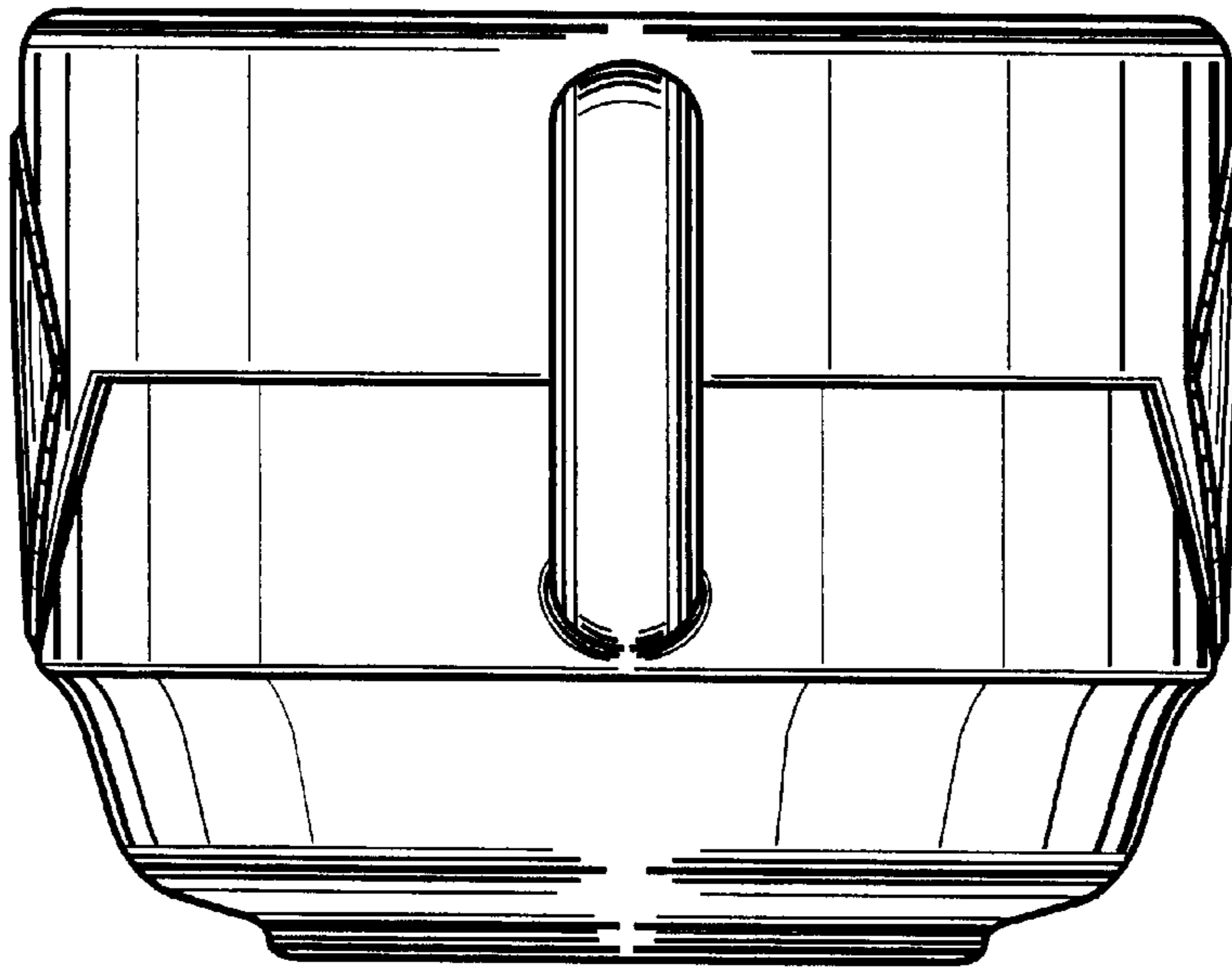
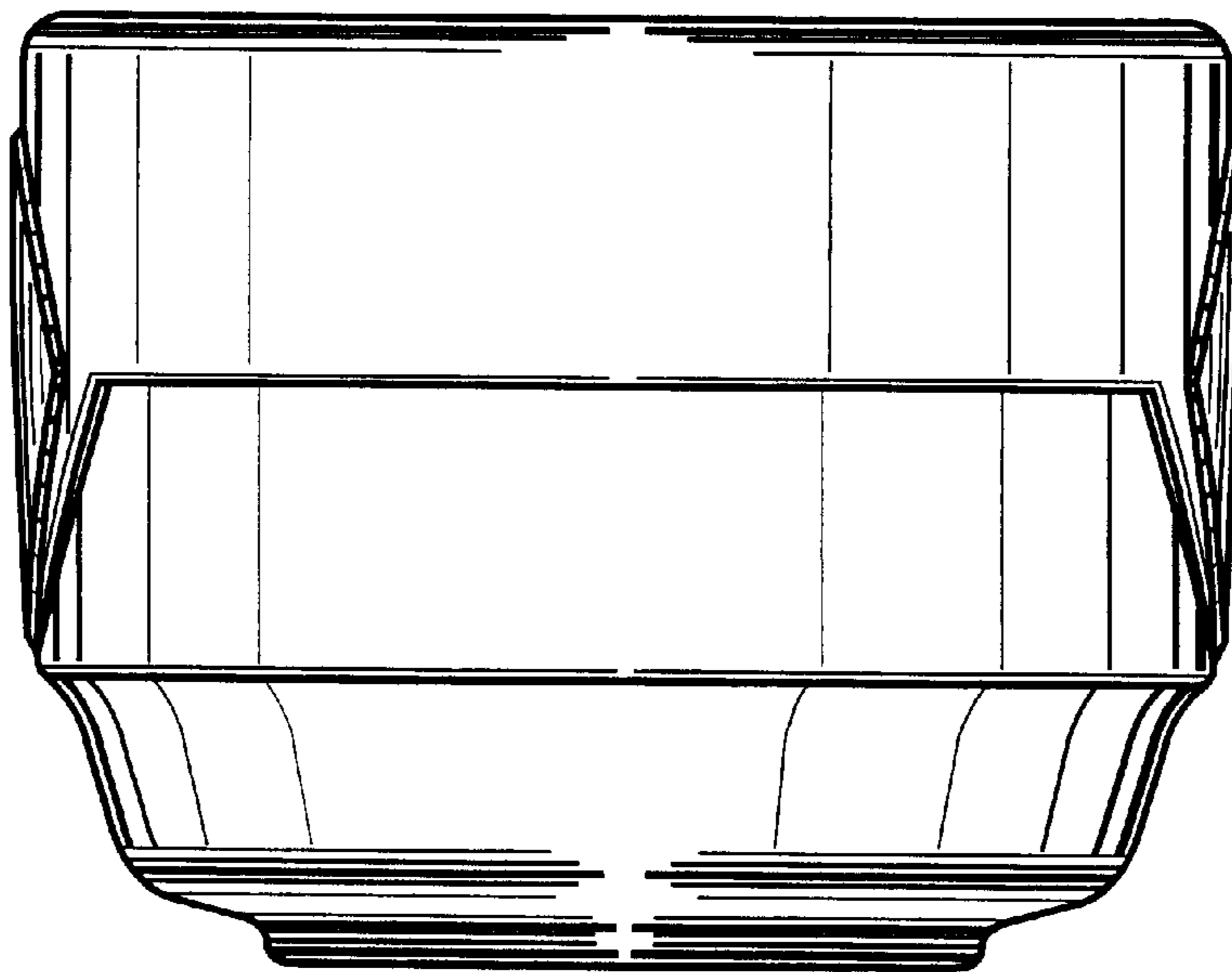

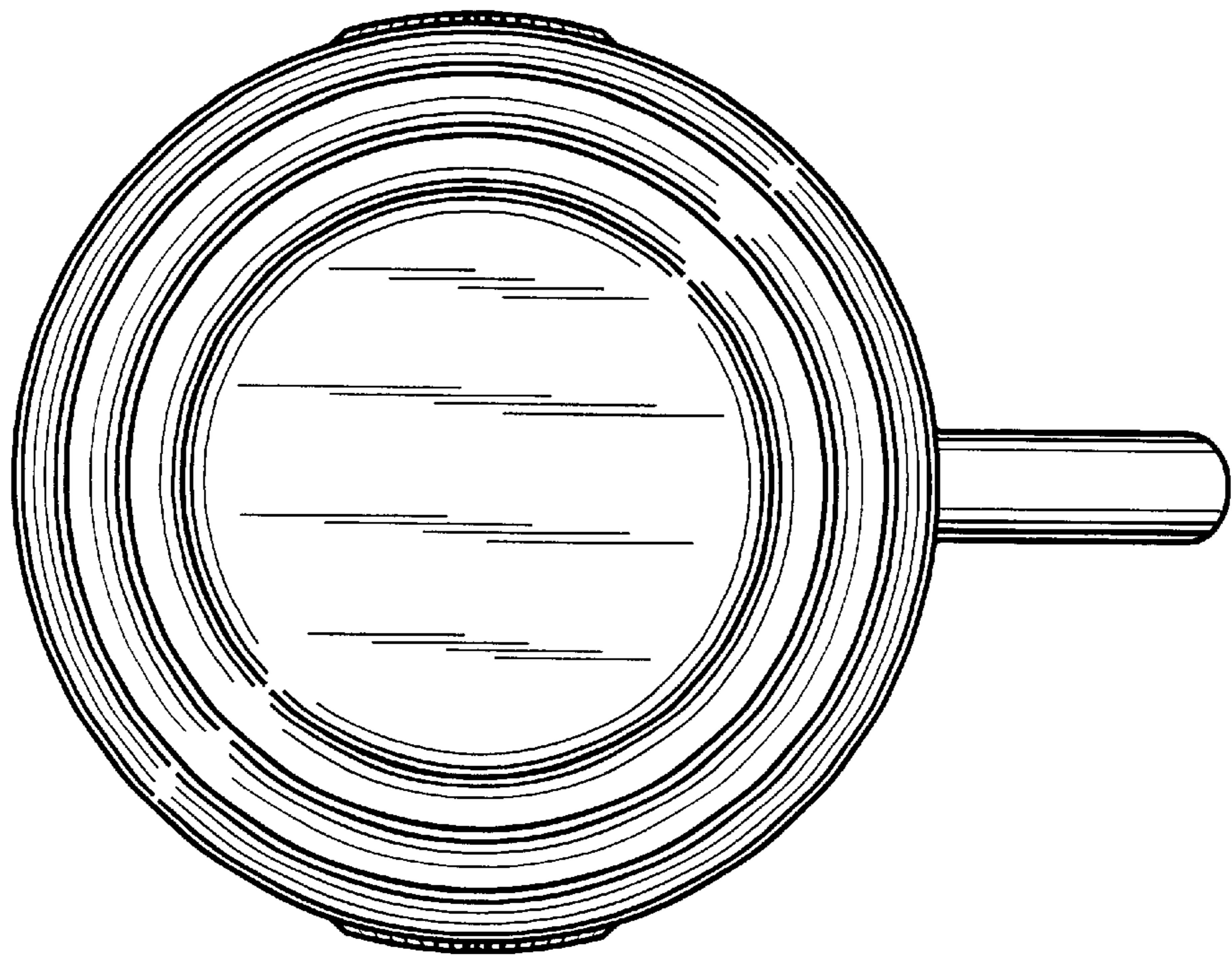

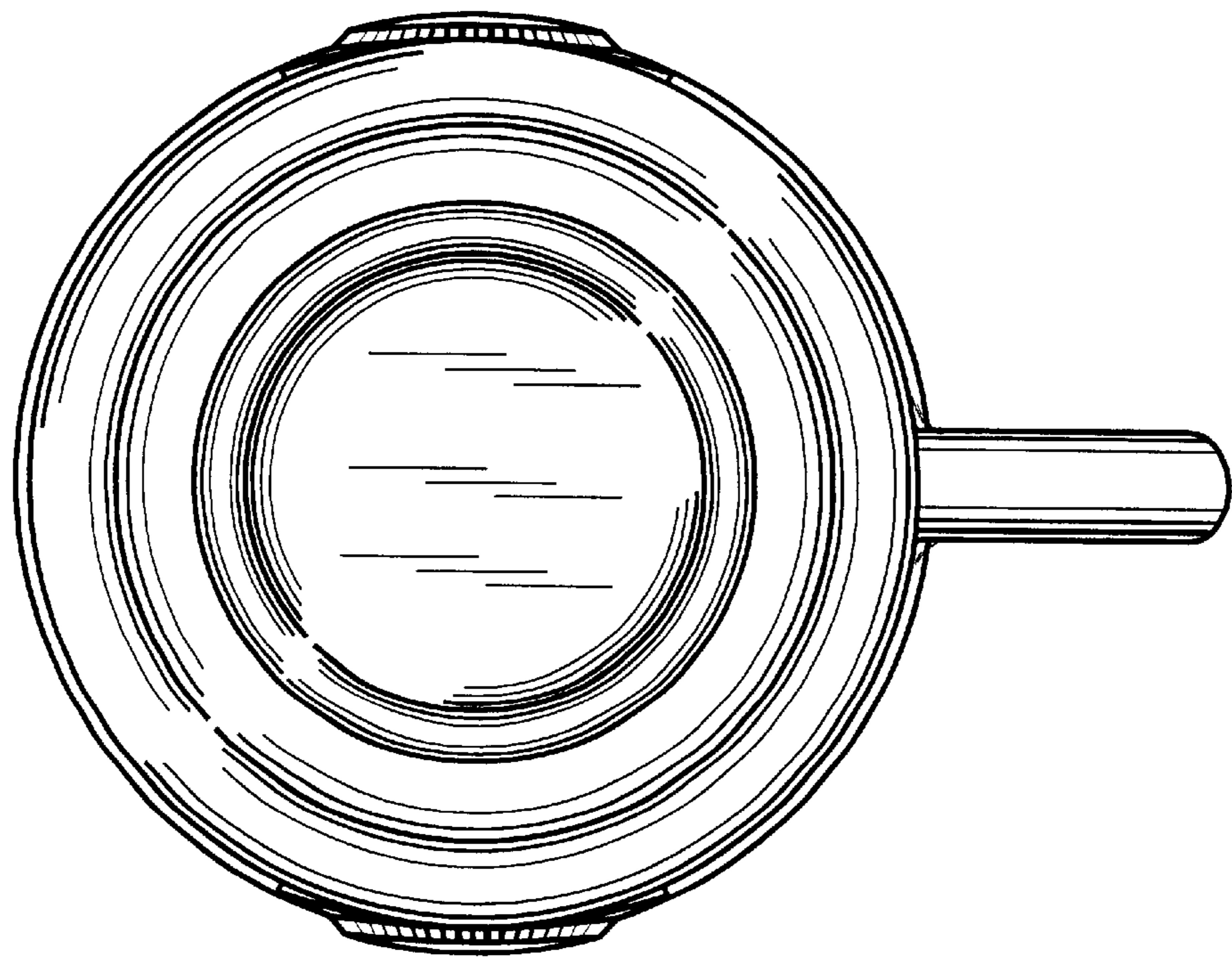
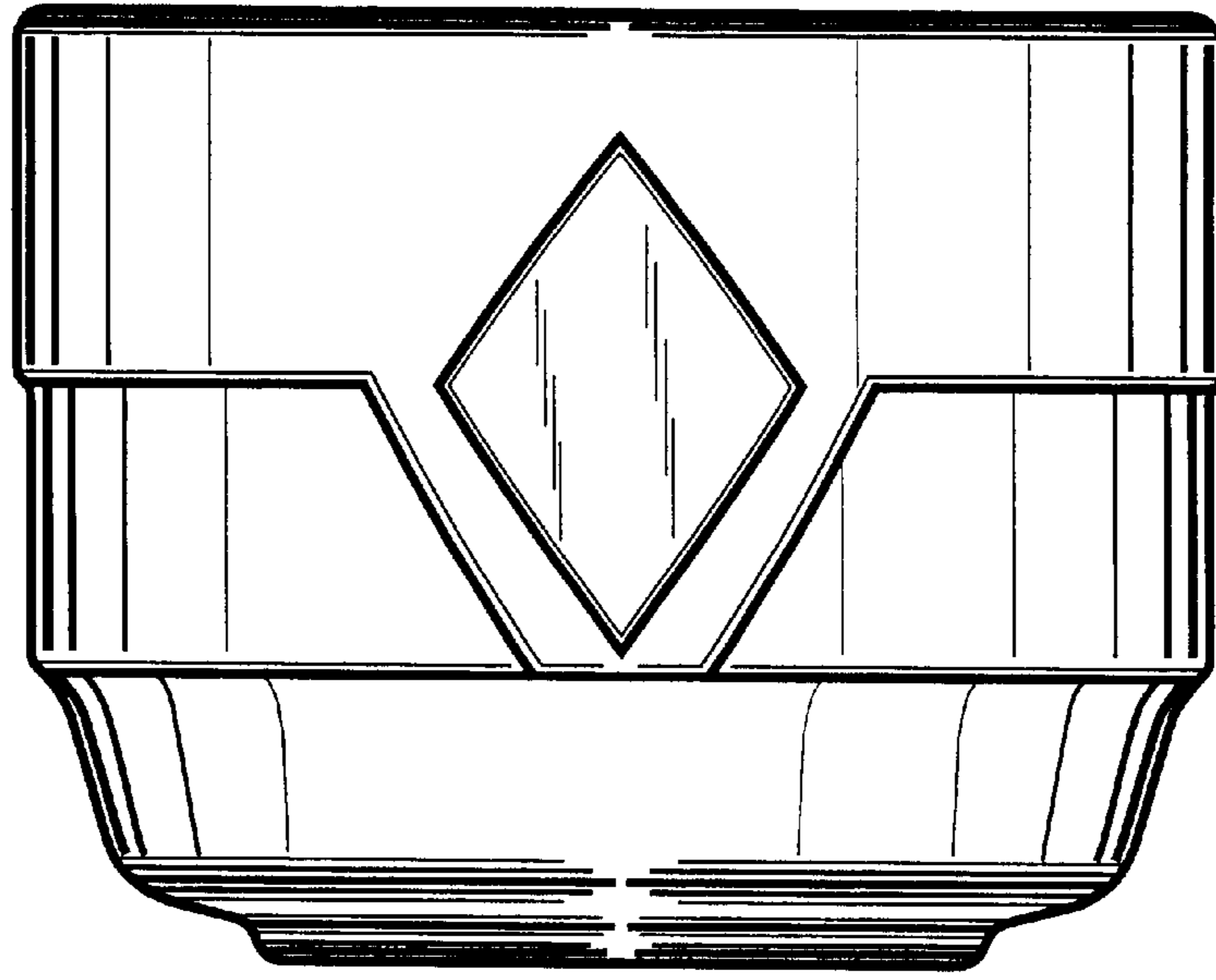
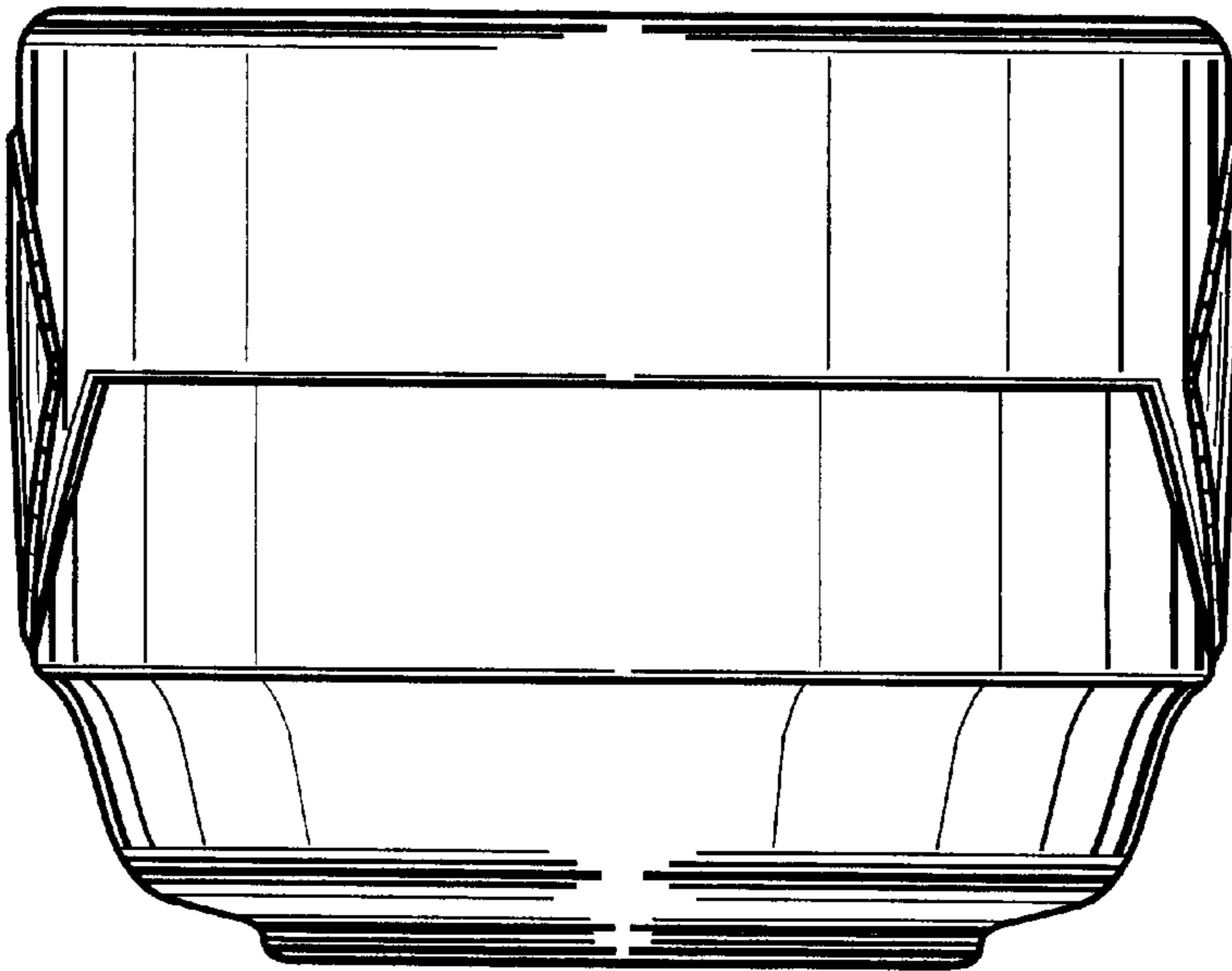

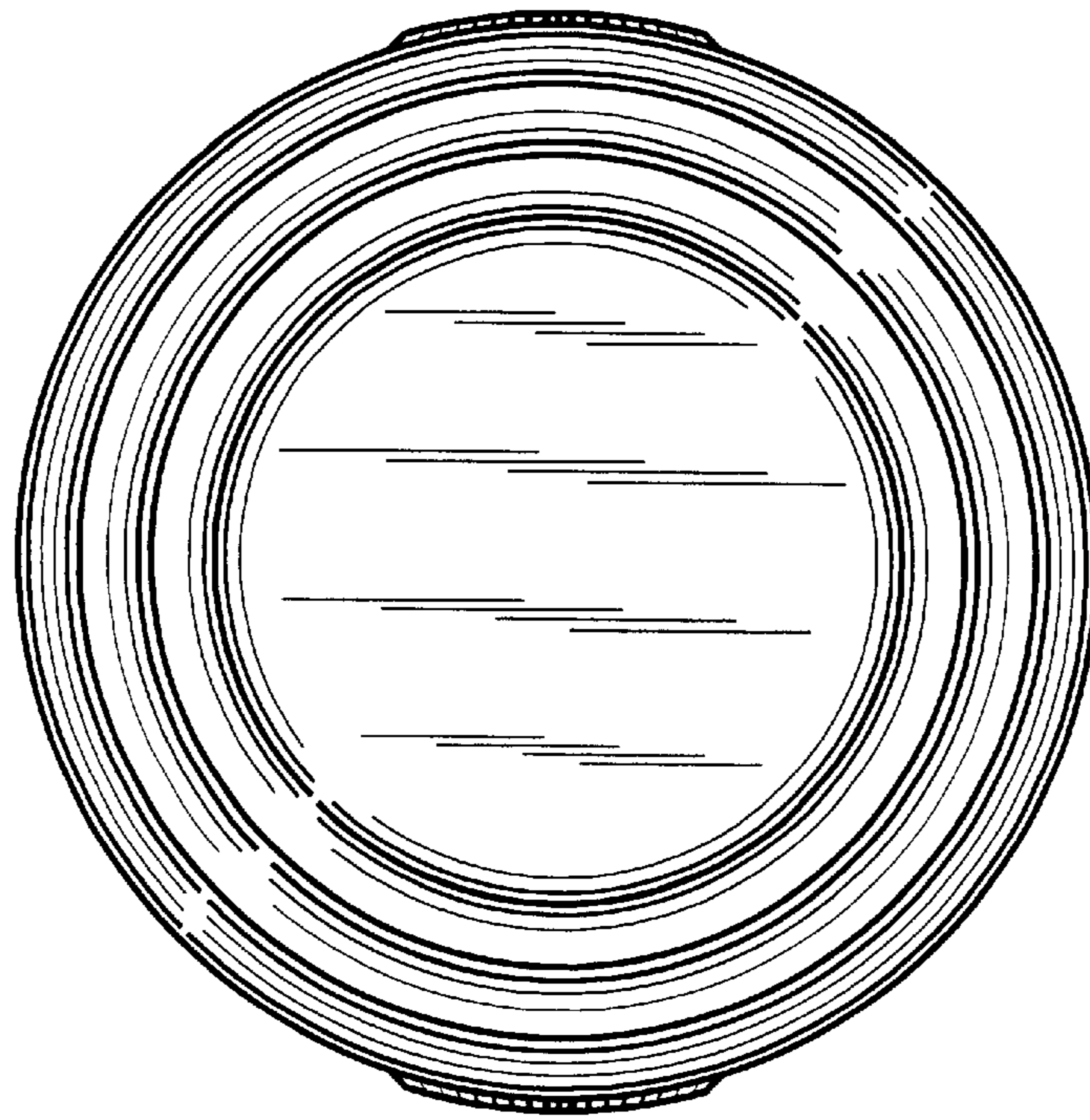

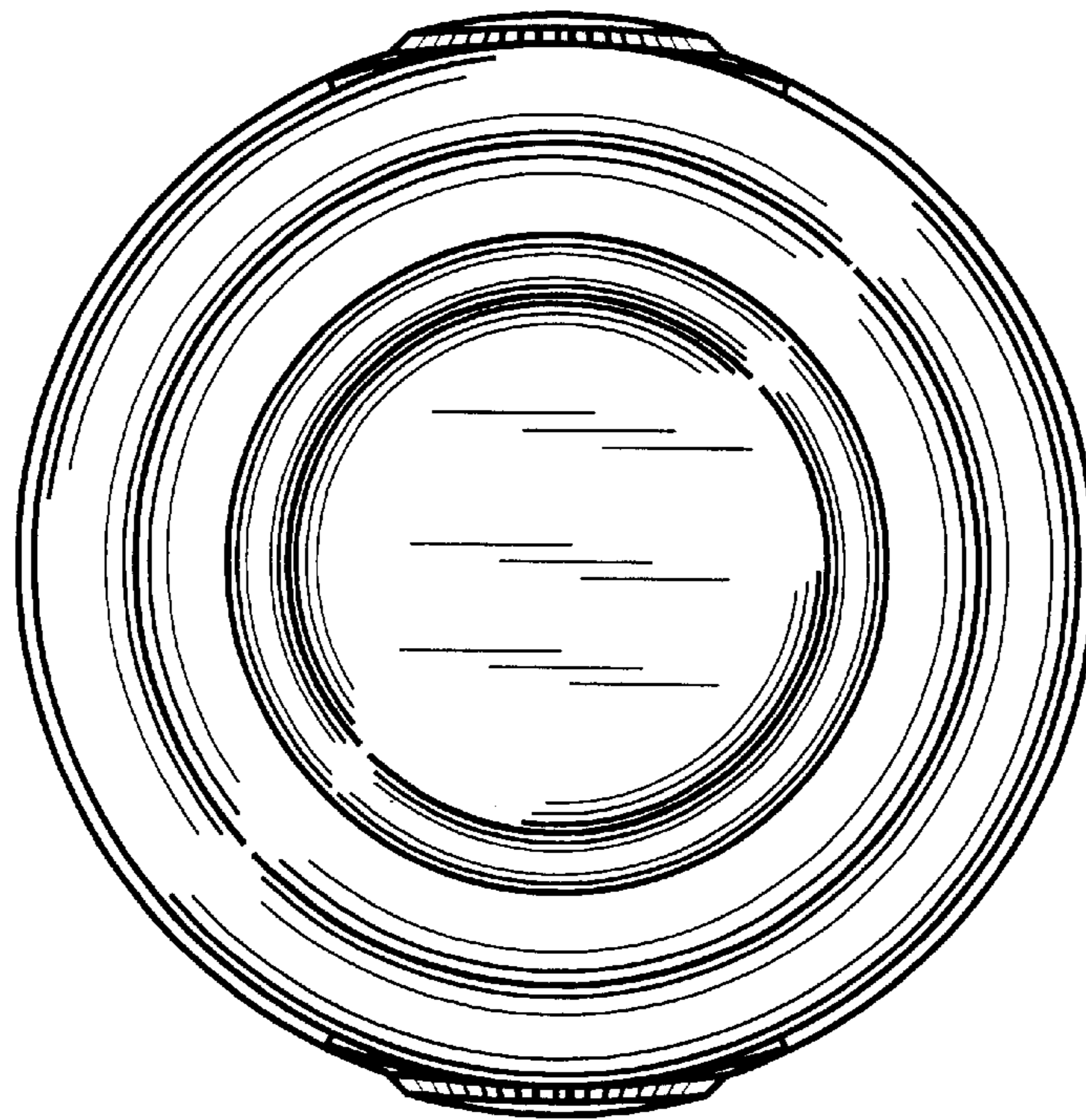
