FIG. 8 is a bottom plan view of the second embodiment.

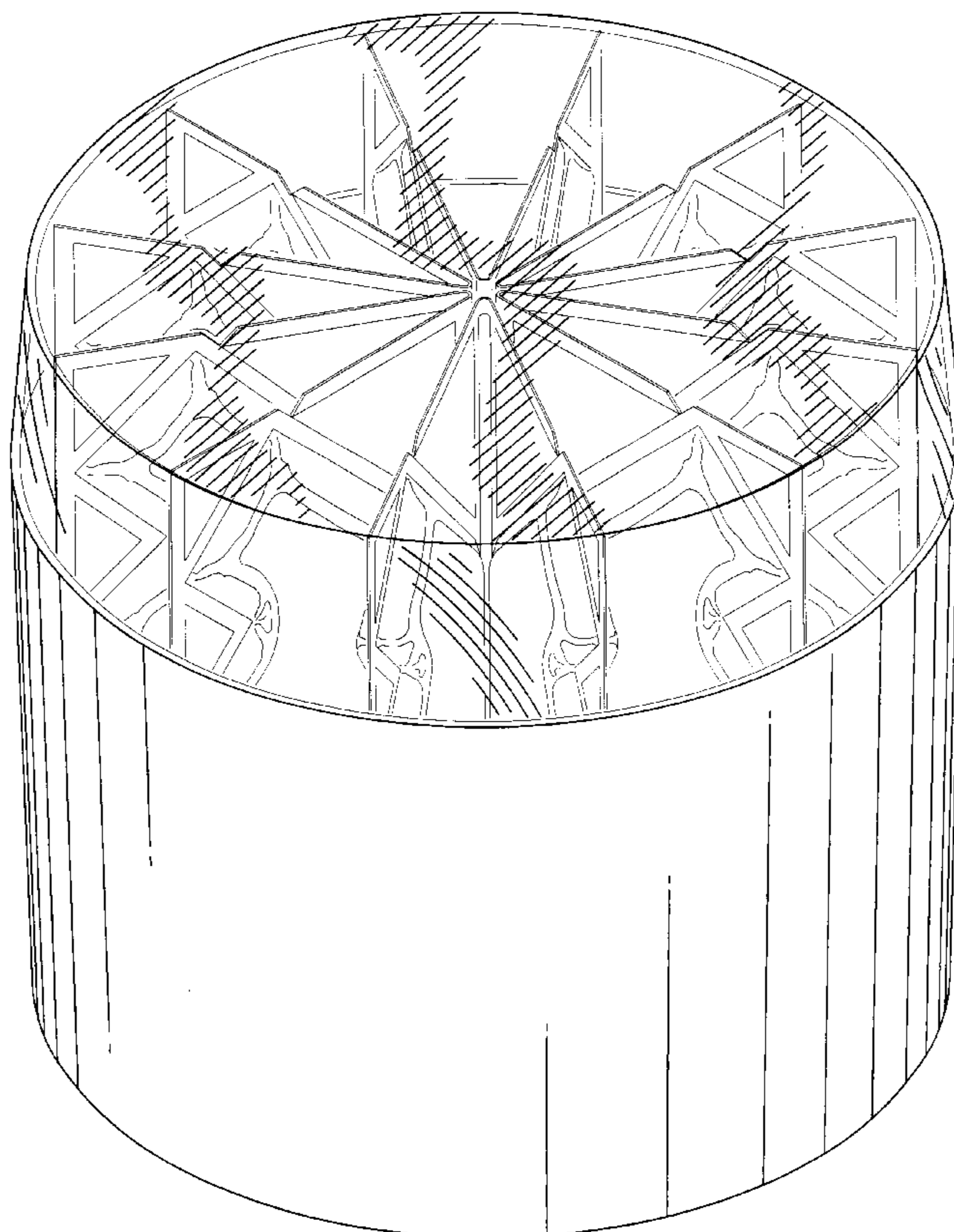
Whereas in all embodiments the back has the same appear-

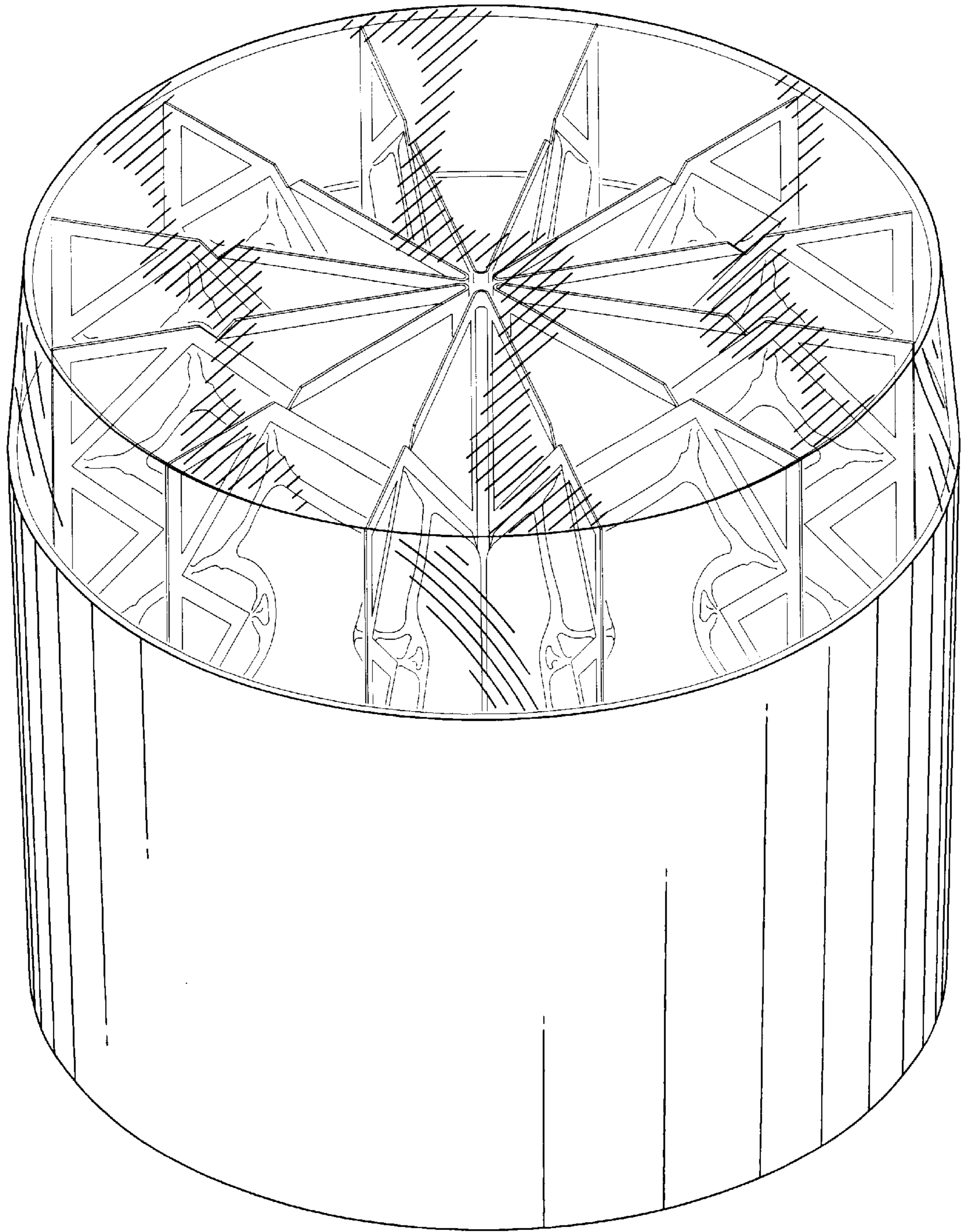

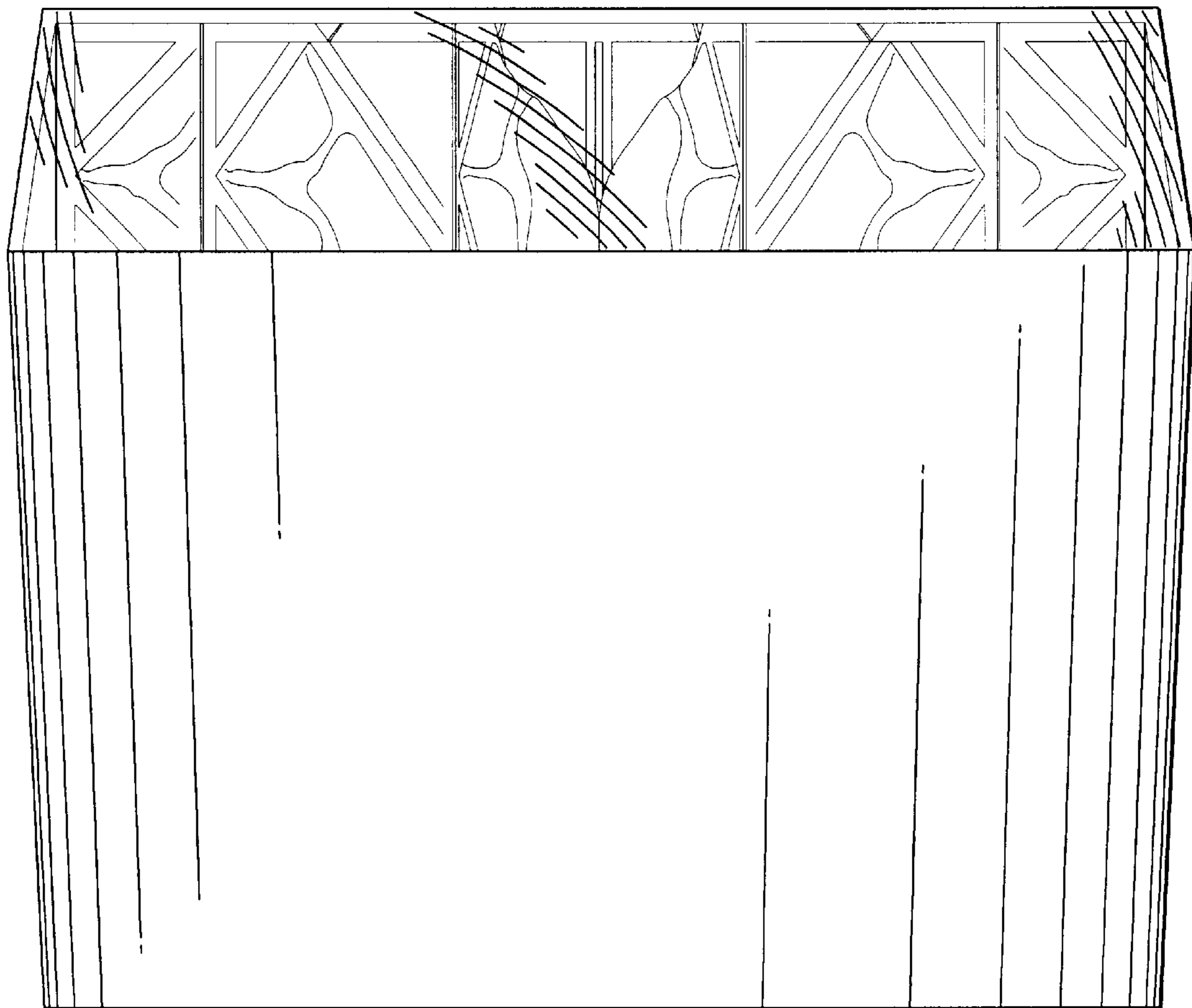

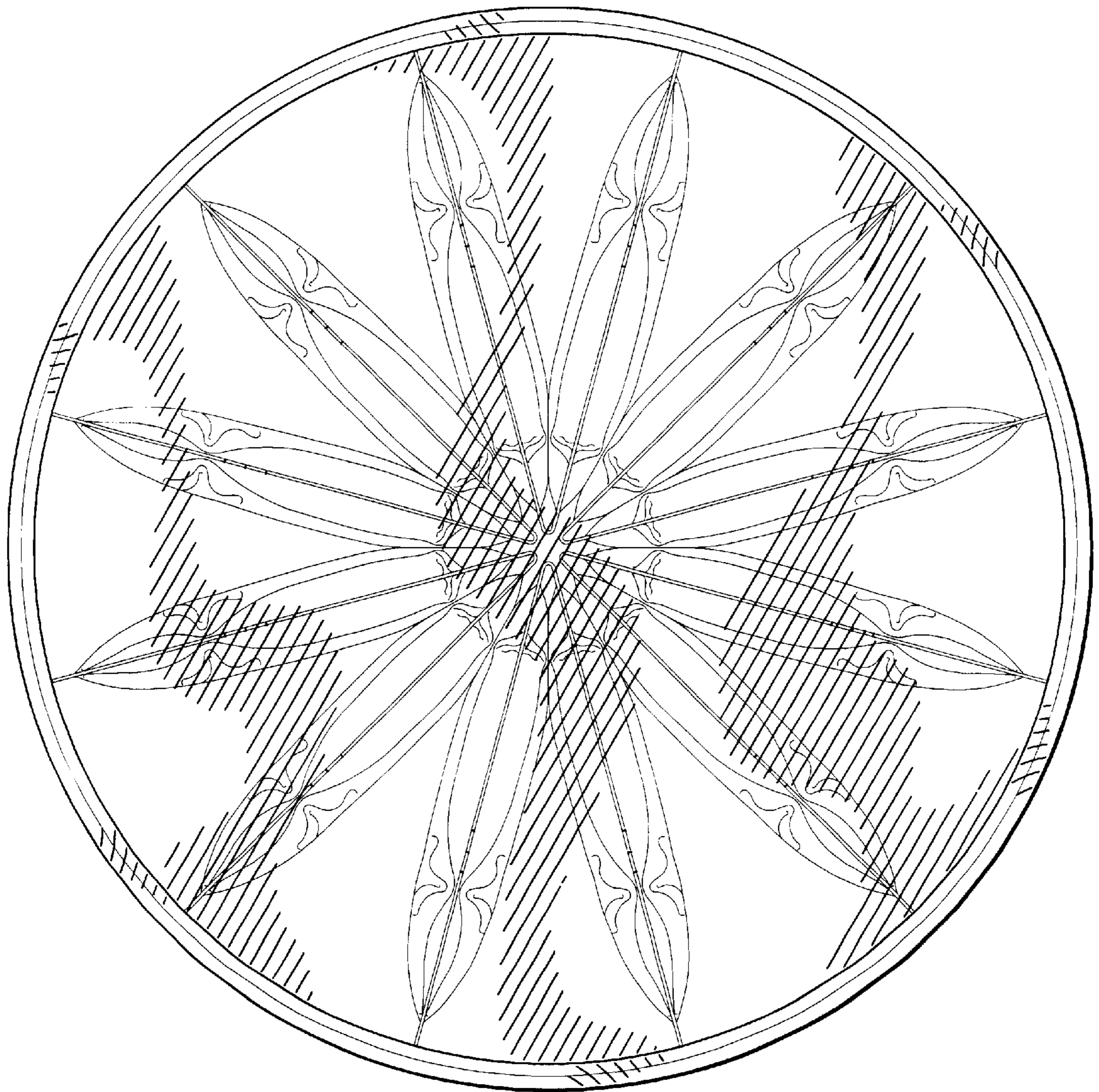

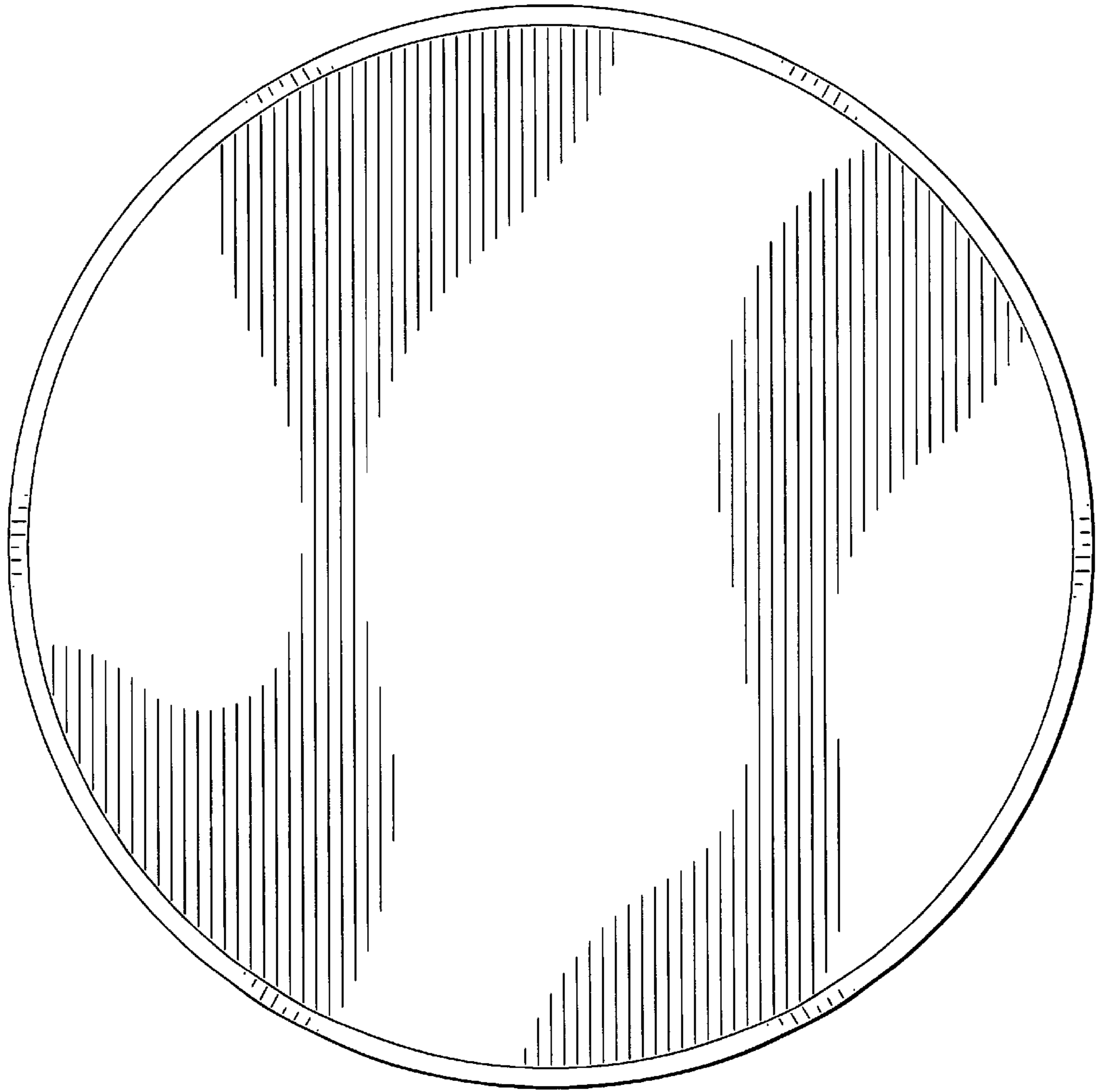

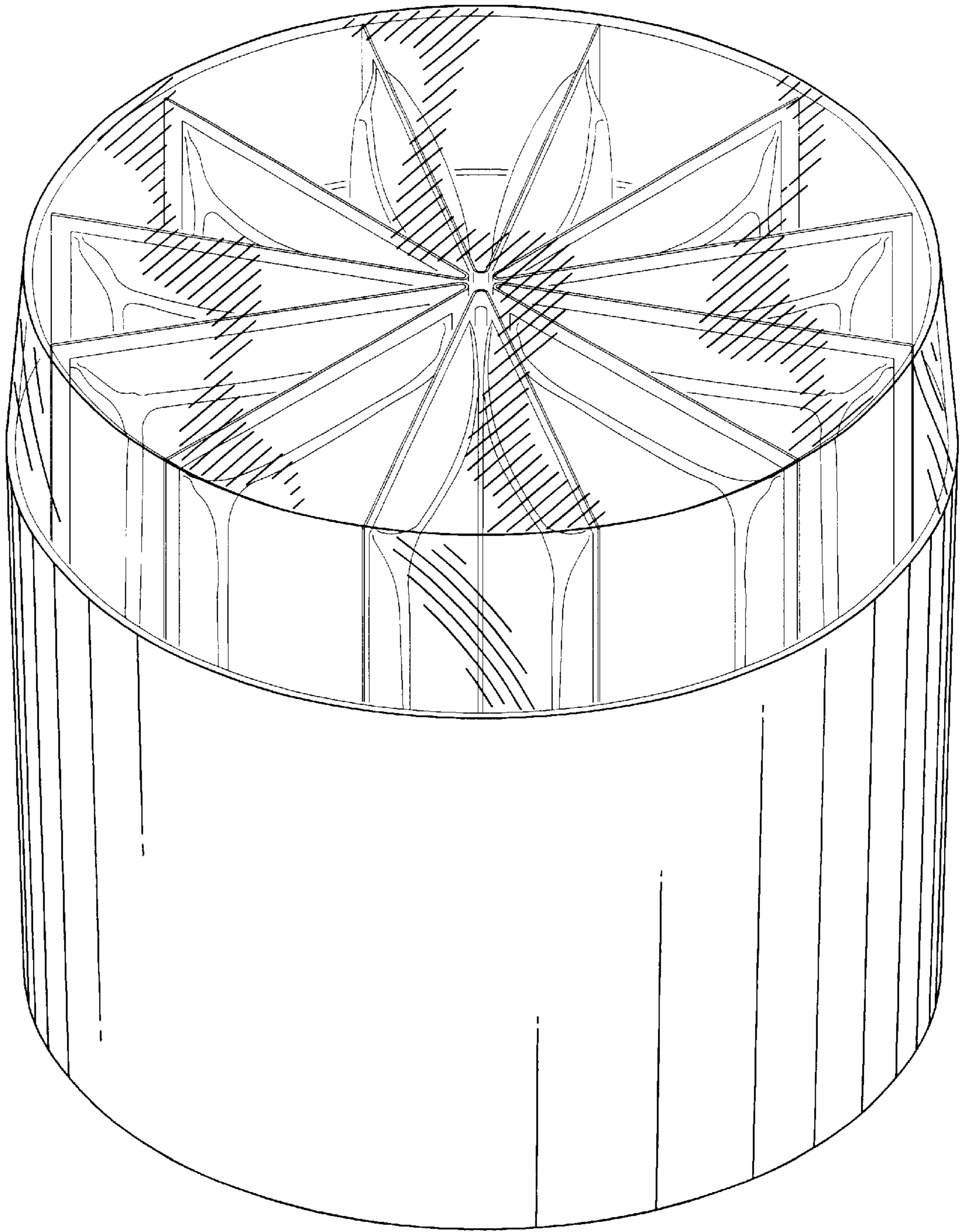

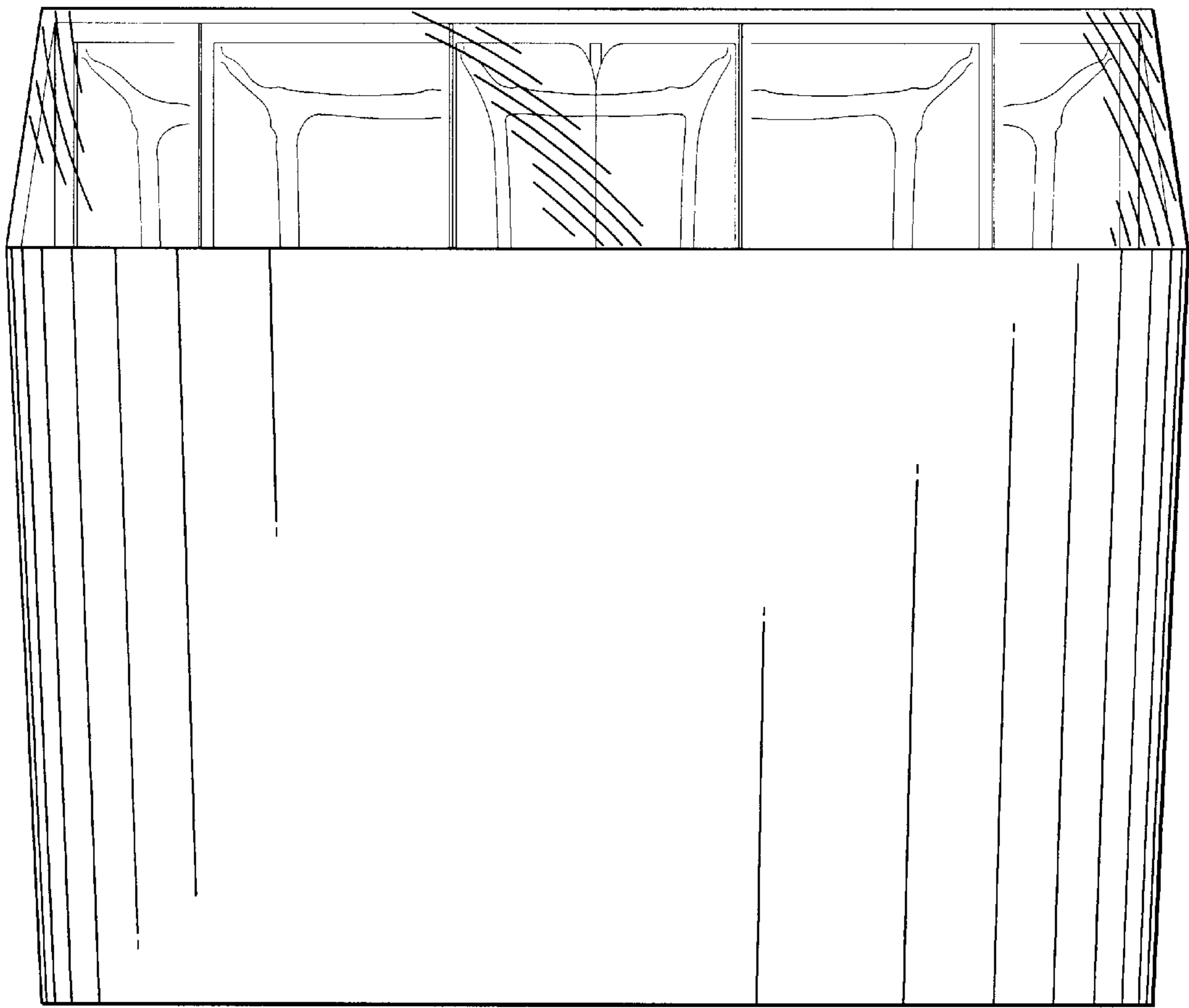

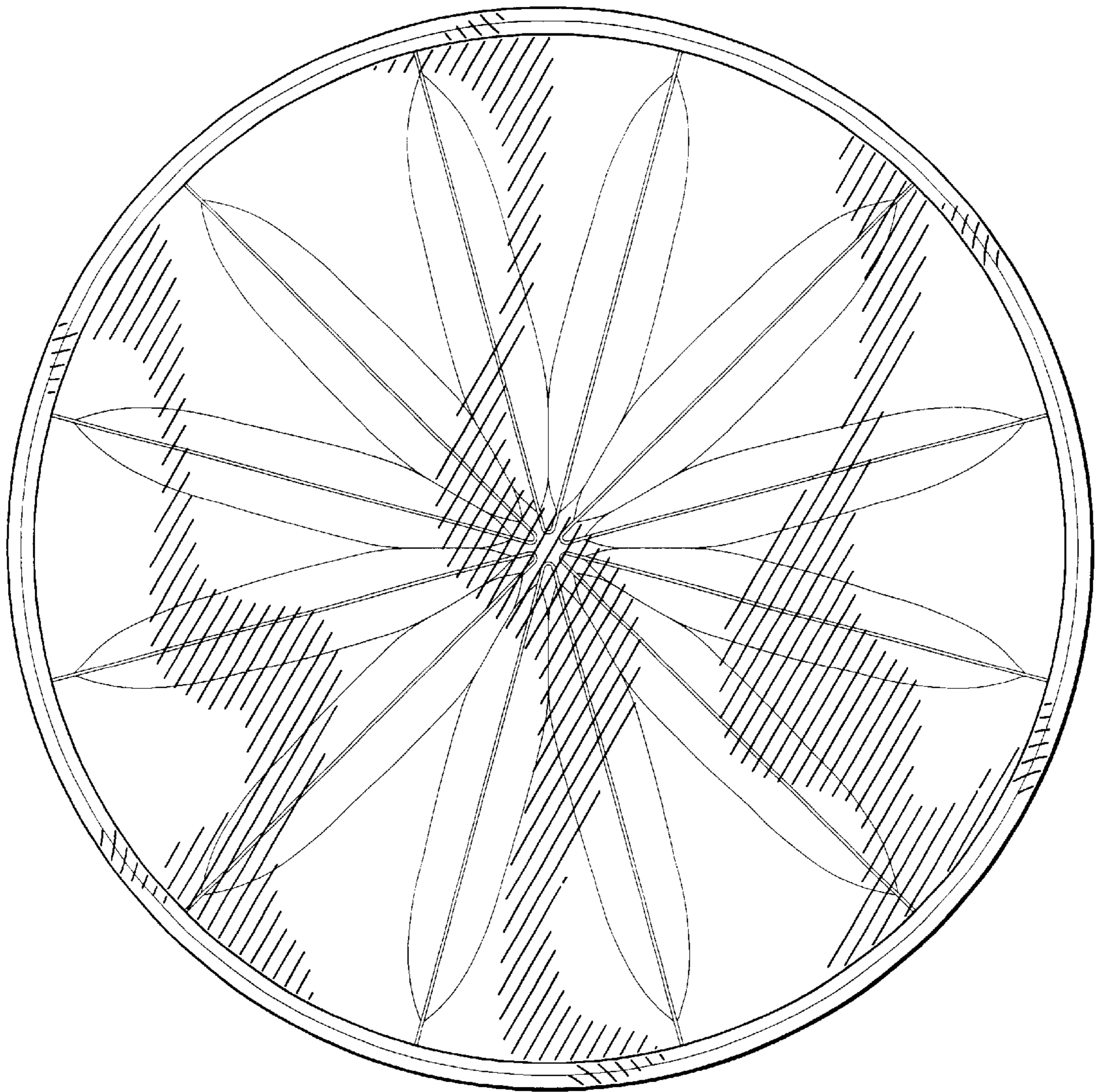

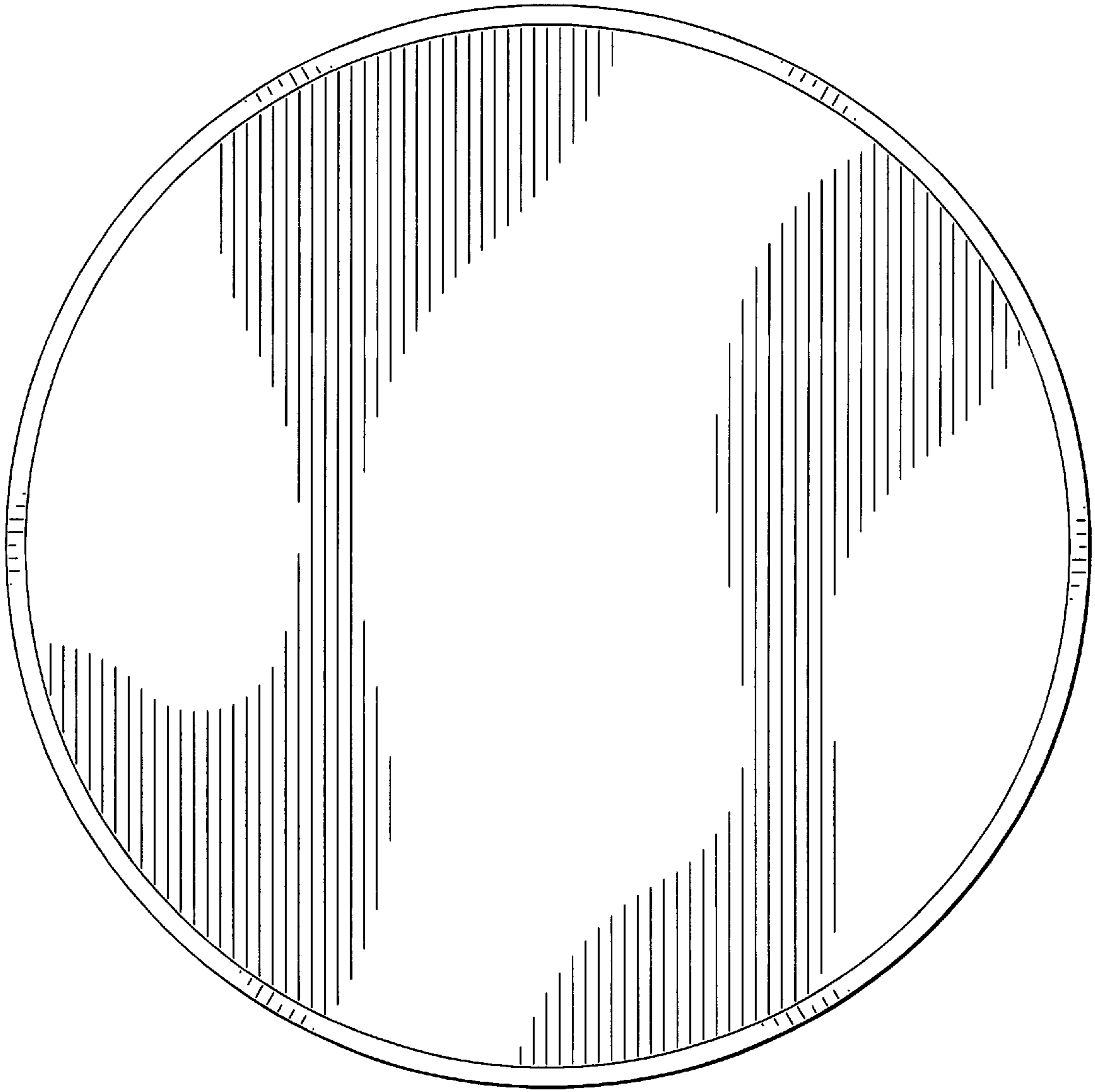
