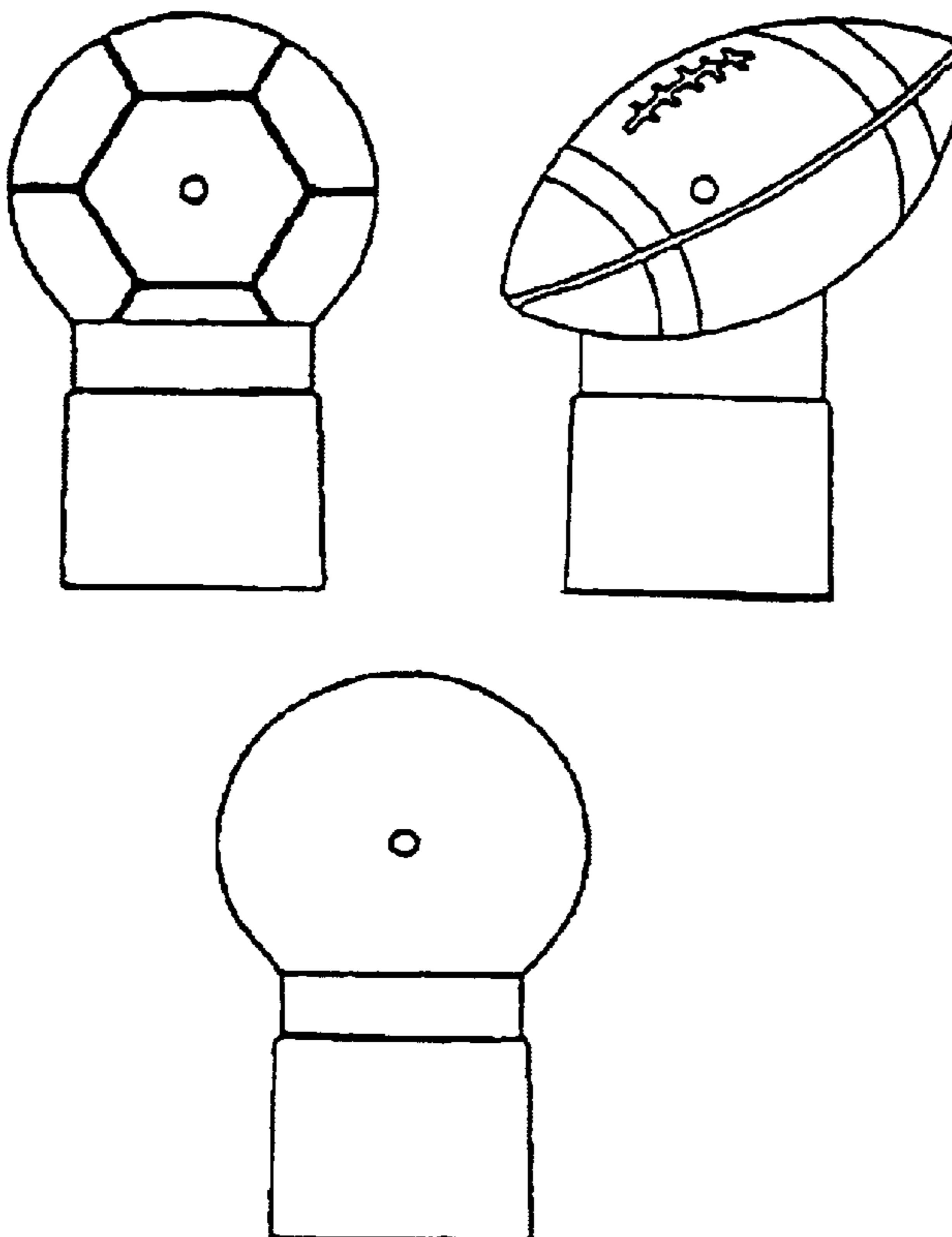
(57) **CLAIM**

The ornamental design for a pressure pump attachment for a liquid and lotion applicator, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a pressure pump attachment for a liquid and lotion applicator showing my new design; FIG. 2 is a side view of a second embodiment of FIG. 1; FIG. 3 is a side view of a third embodiment of FIG. 1; FIG. 4 is a side view of a fourth embodiment of FIG. 1; FIG. 5 is a side view of a fifth embodiment of FIG. 1; FIG. 6 is a side view of a sixth embodiment of FIG. 1; FIG. 7 is a side view of a seventh embodiment of FIG. 1; and, FIG. 8 is a side view of an eighth embodiment of FIG. 1. Each of the embodiments has a cylindrical attachment function.

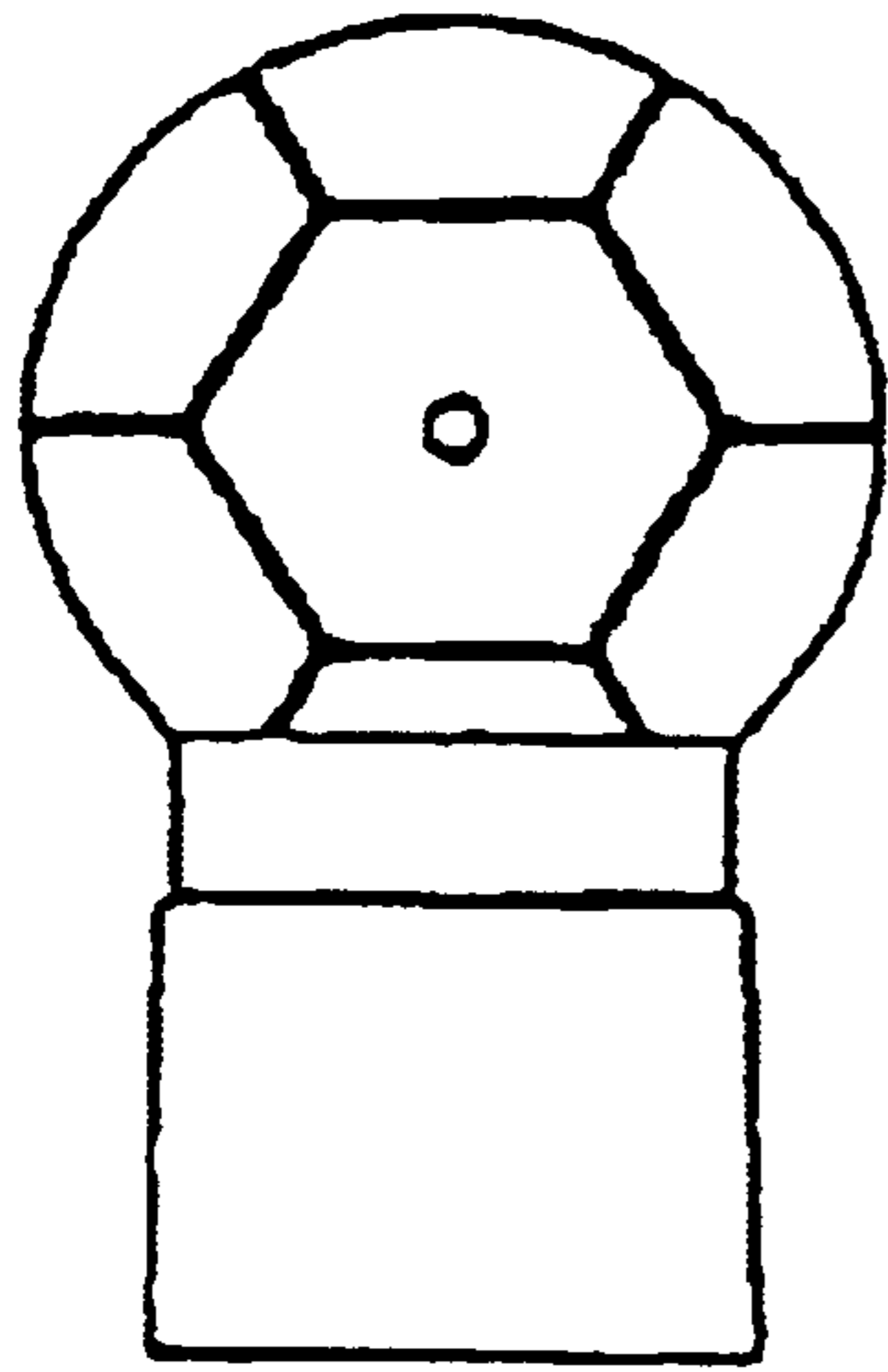

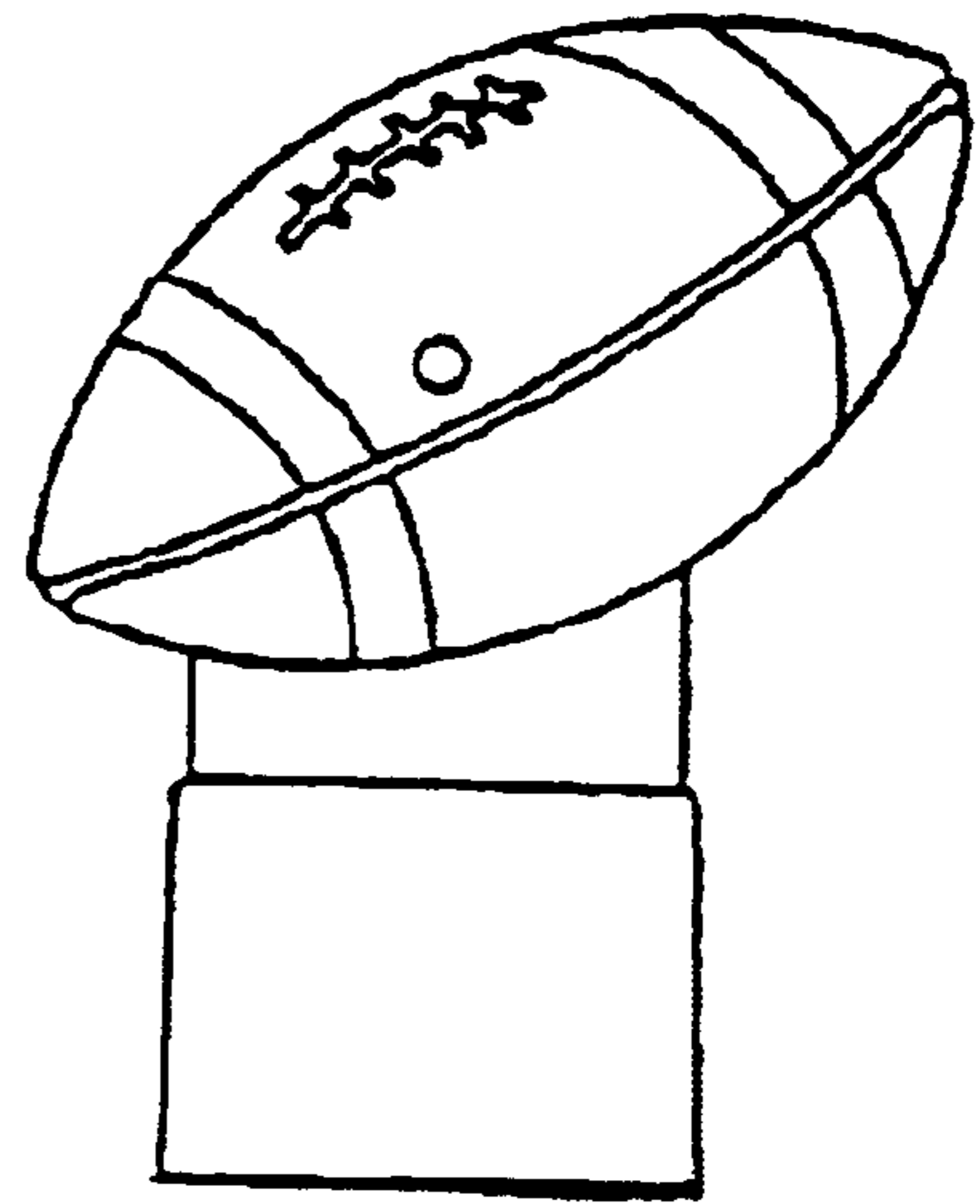

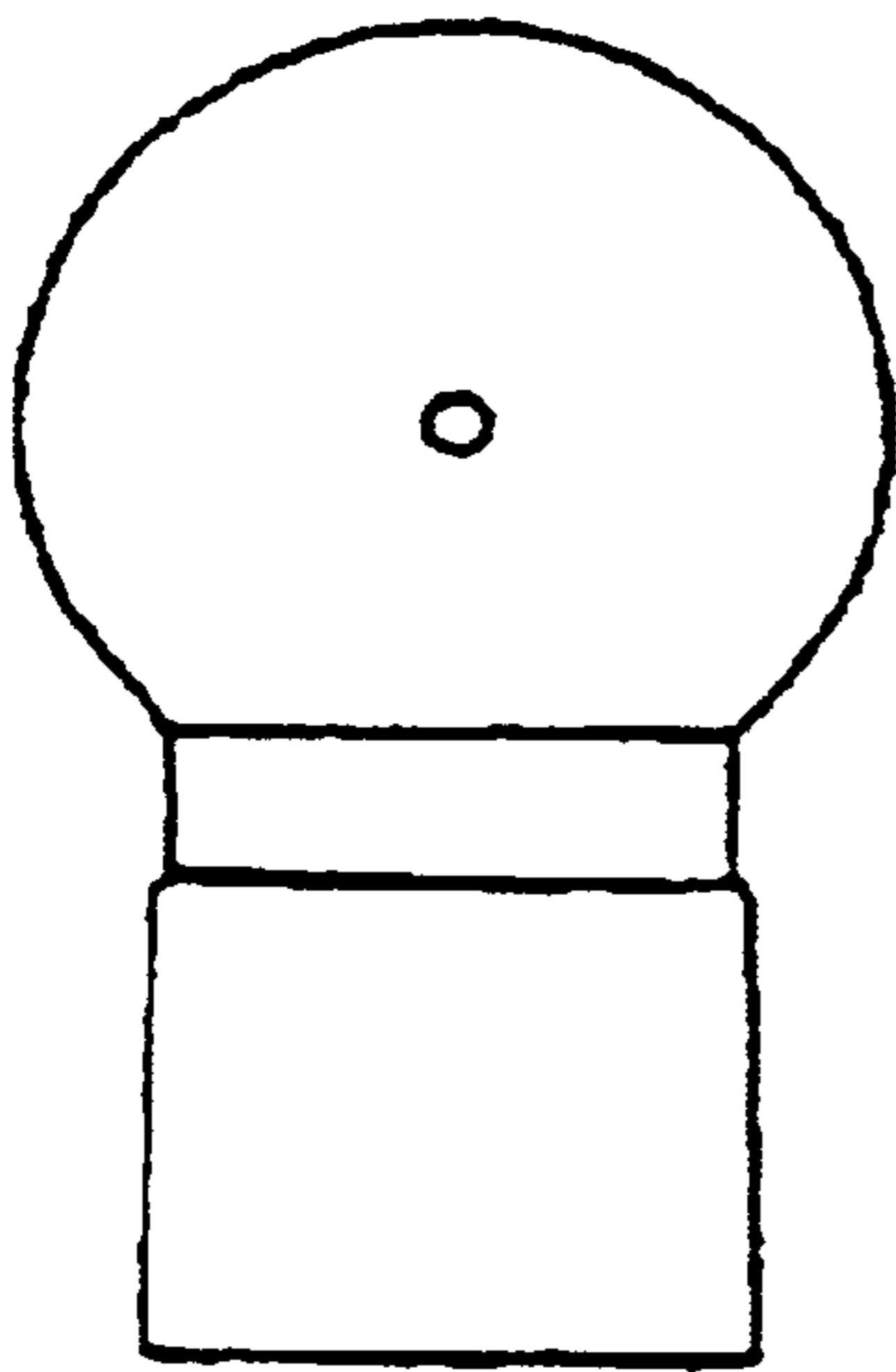

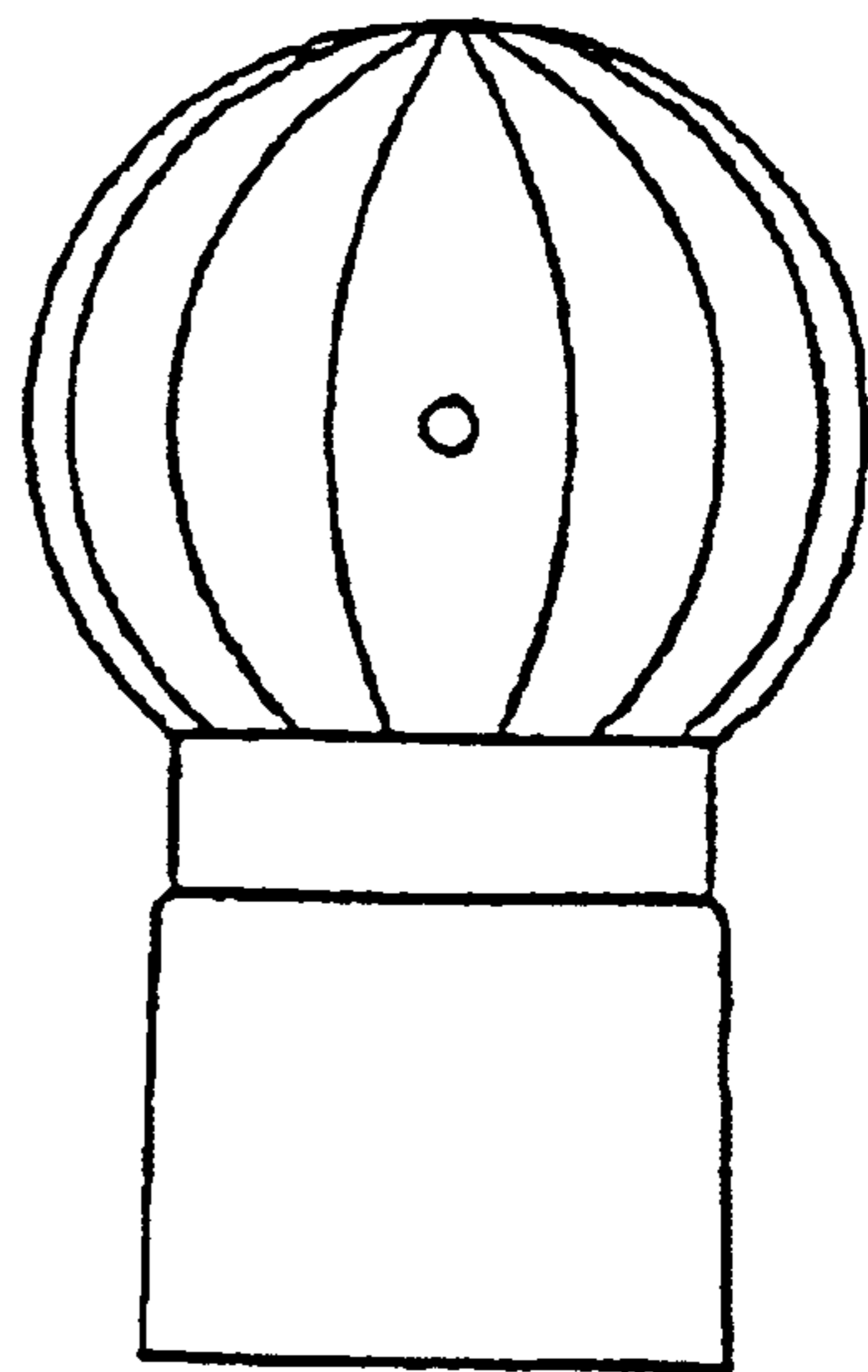

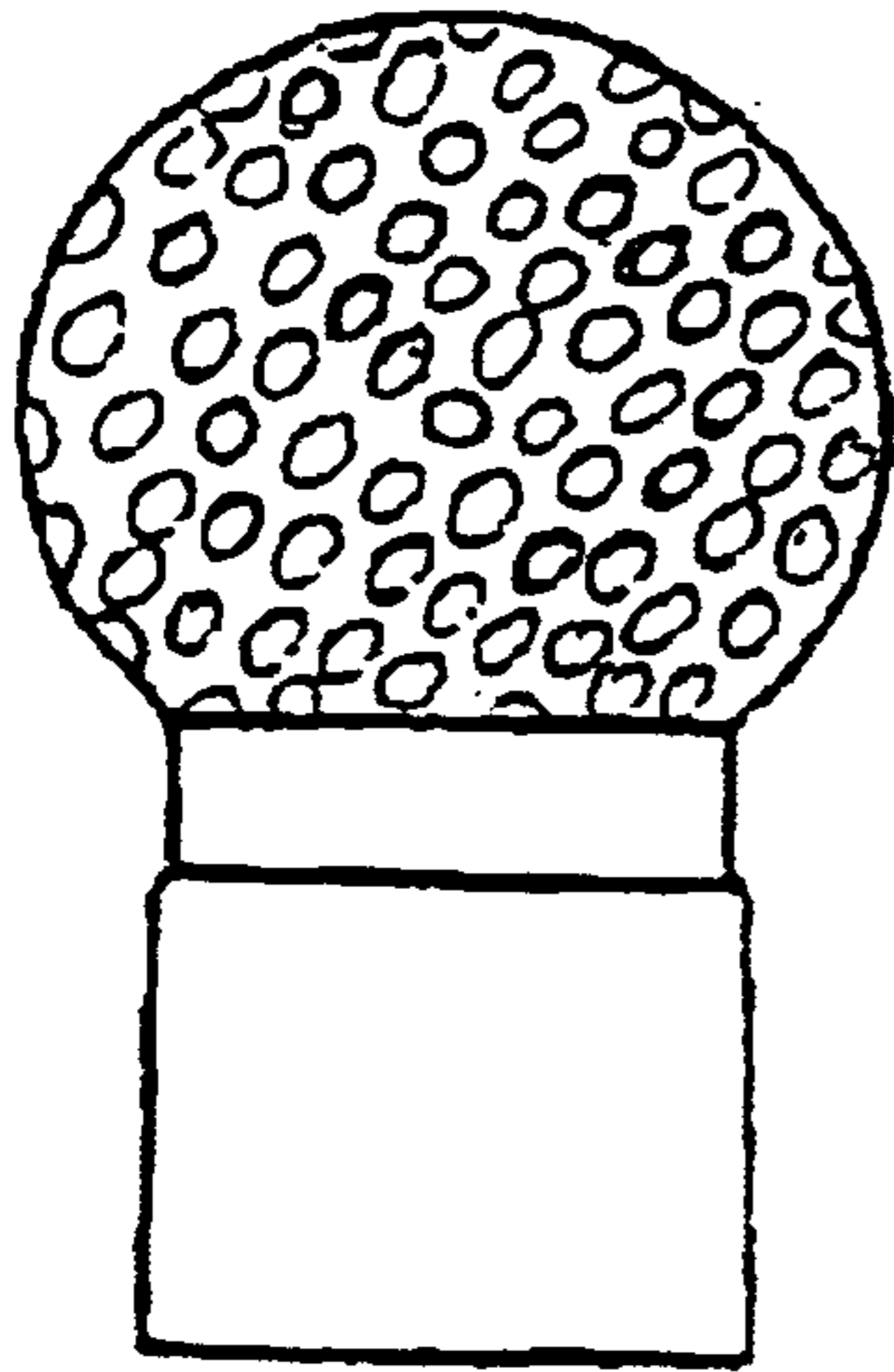

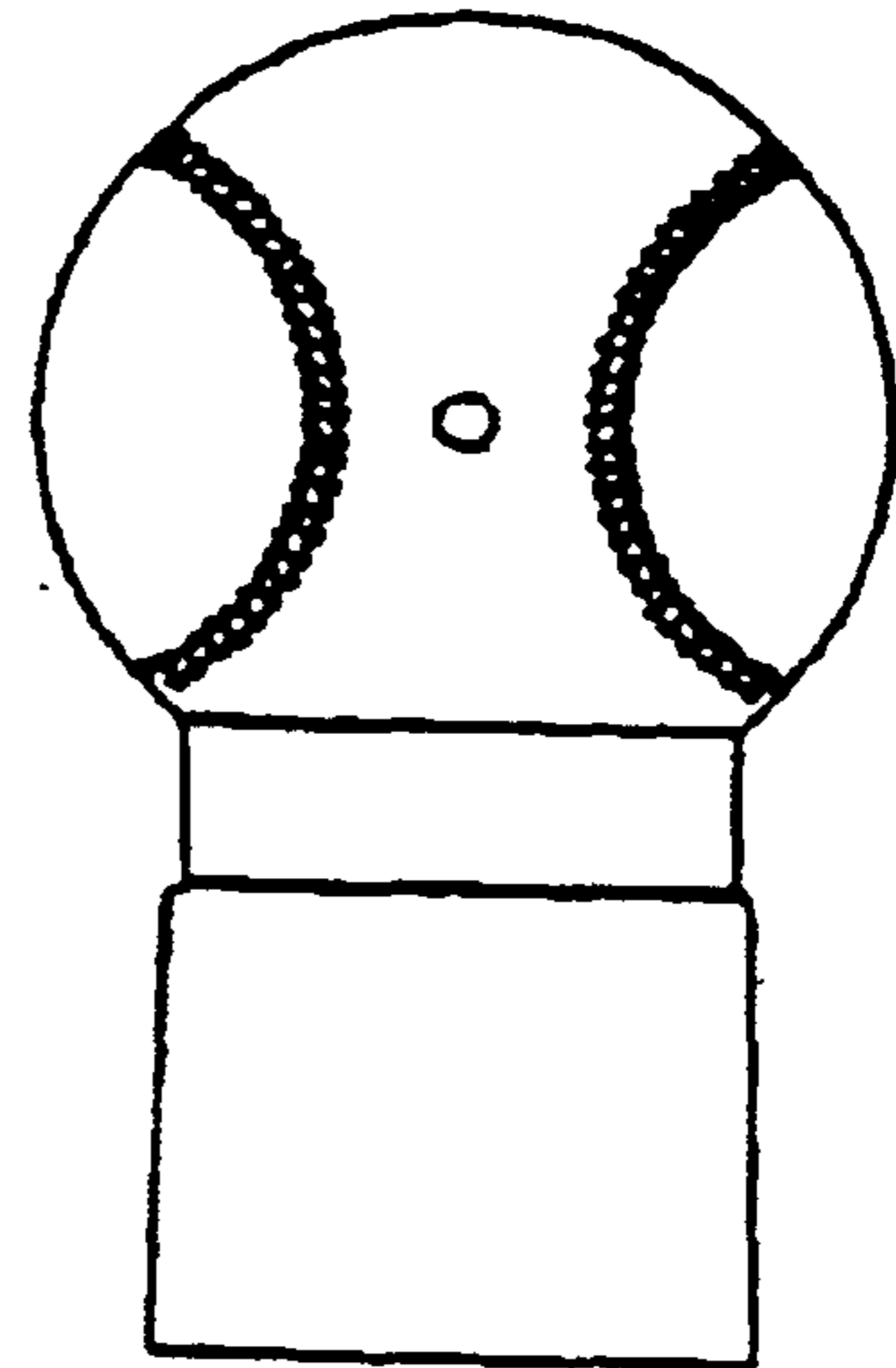

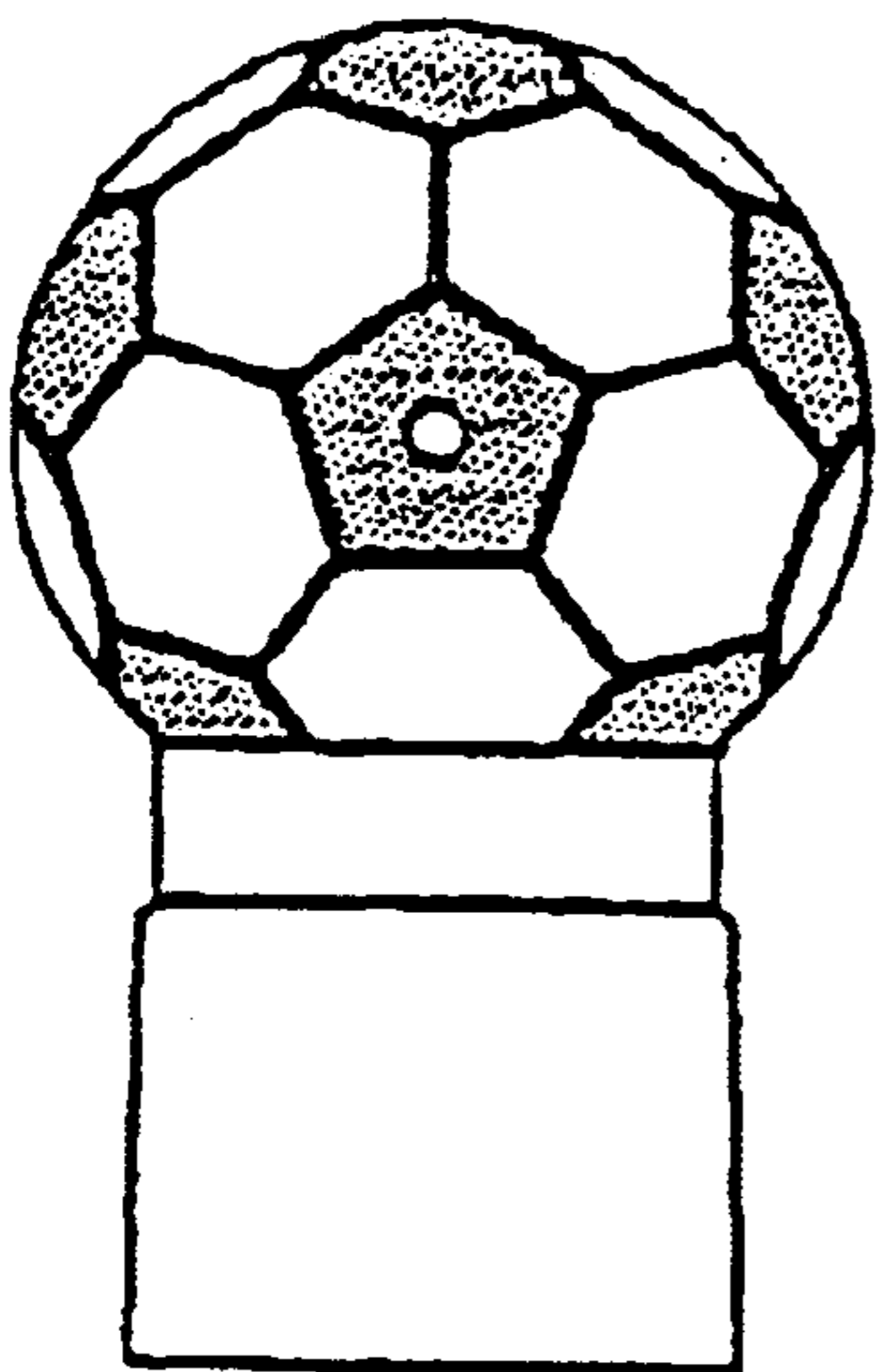

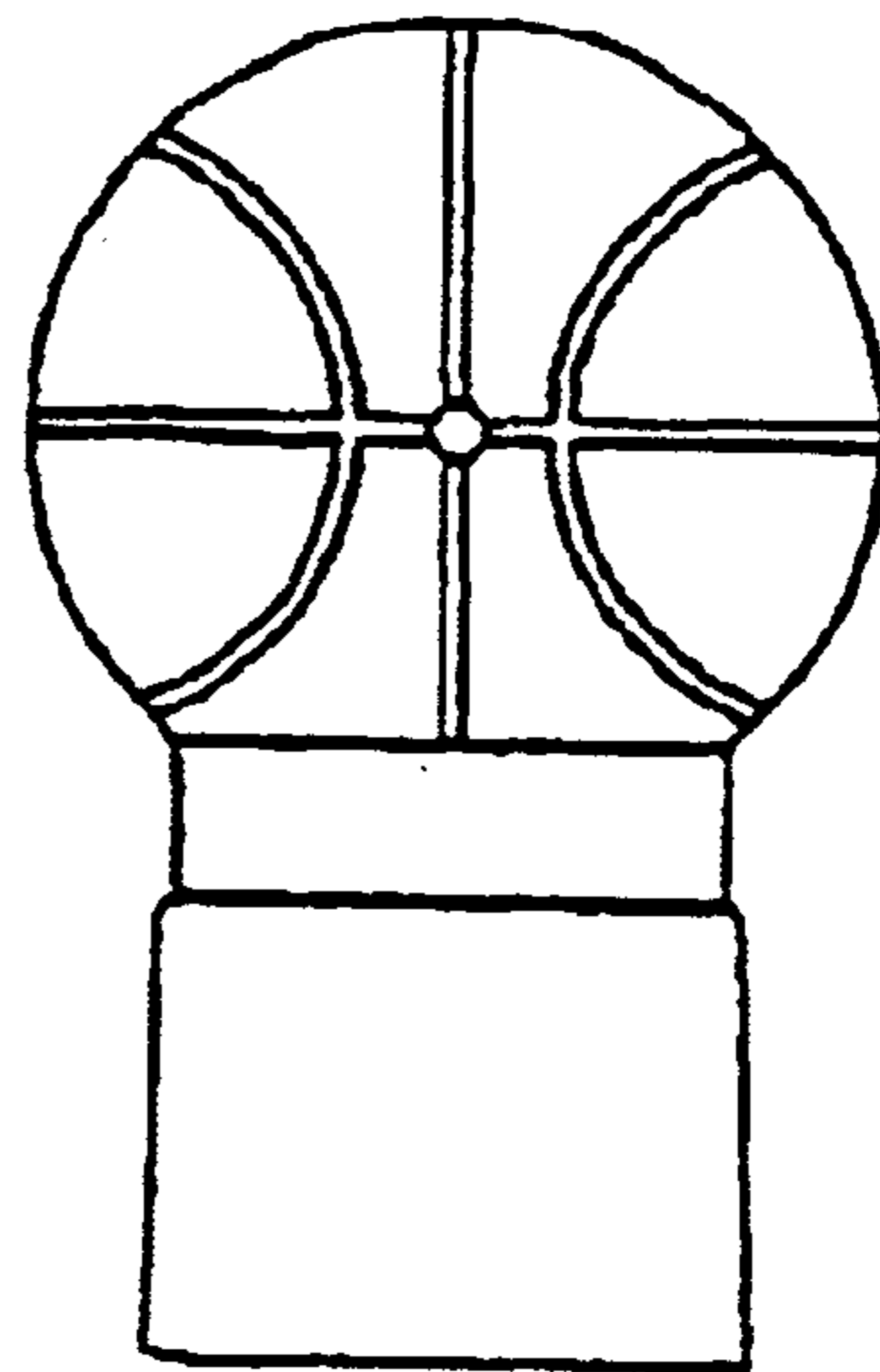
