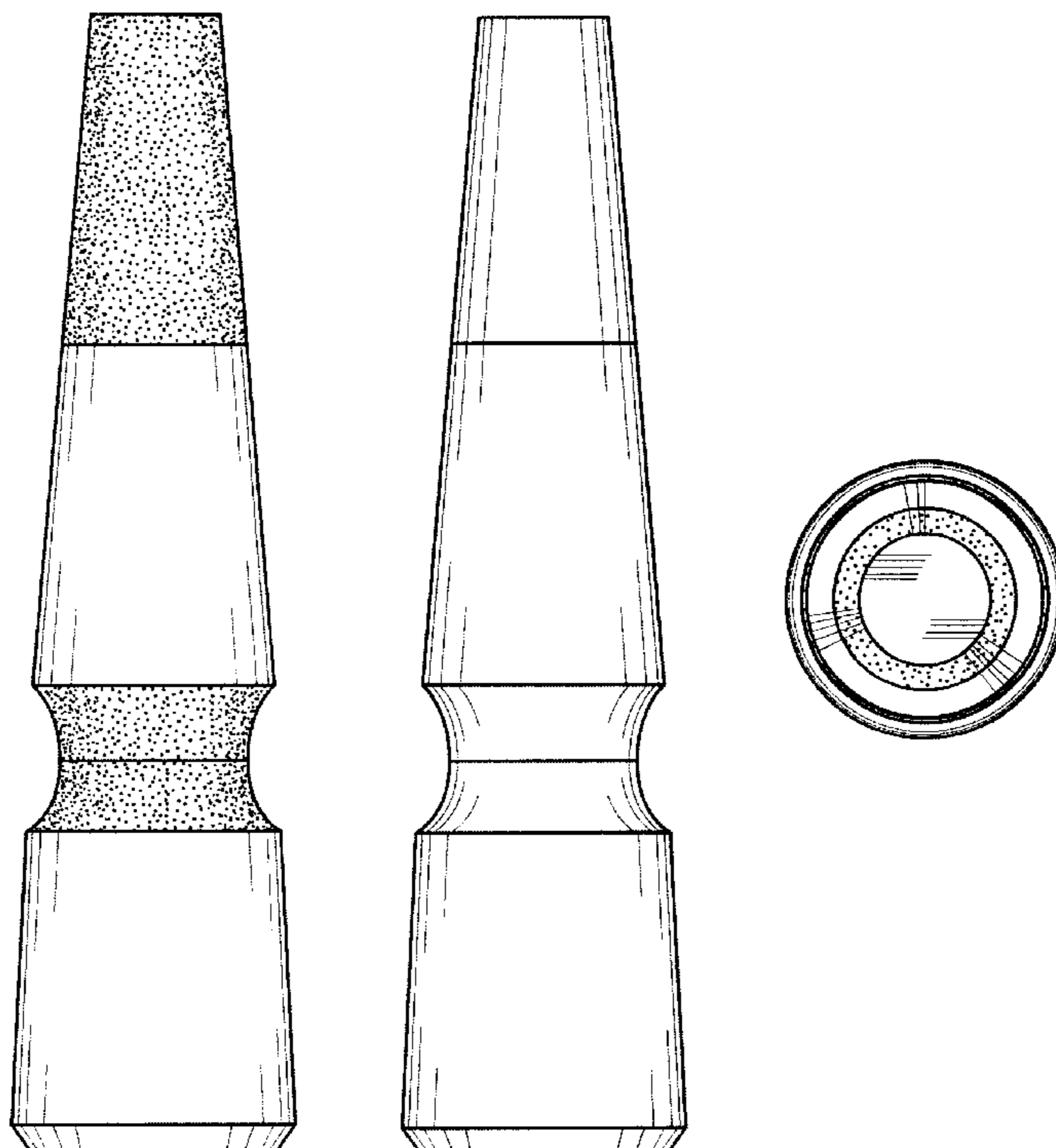
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a first embodiment of a frusto-conical container showing our new design;

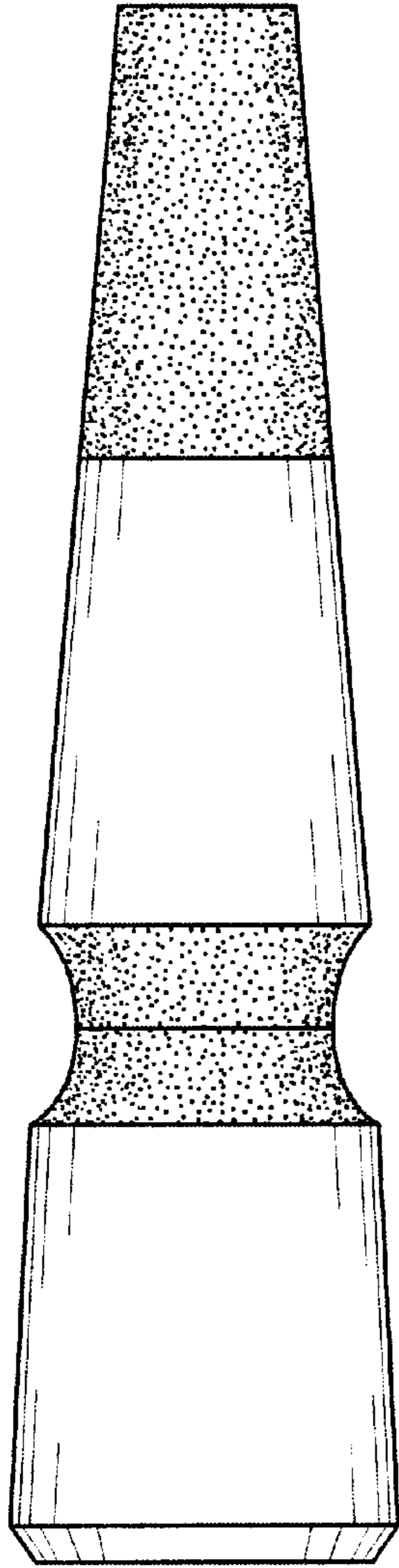

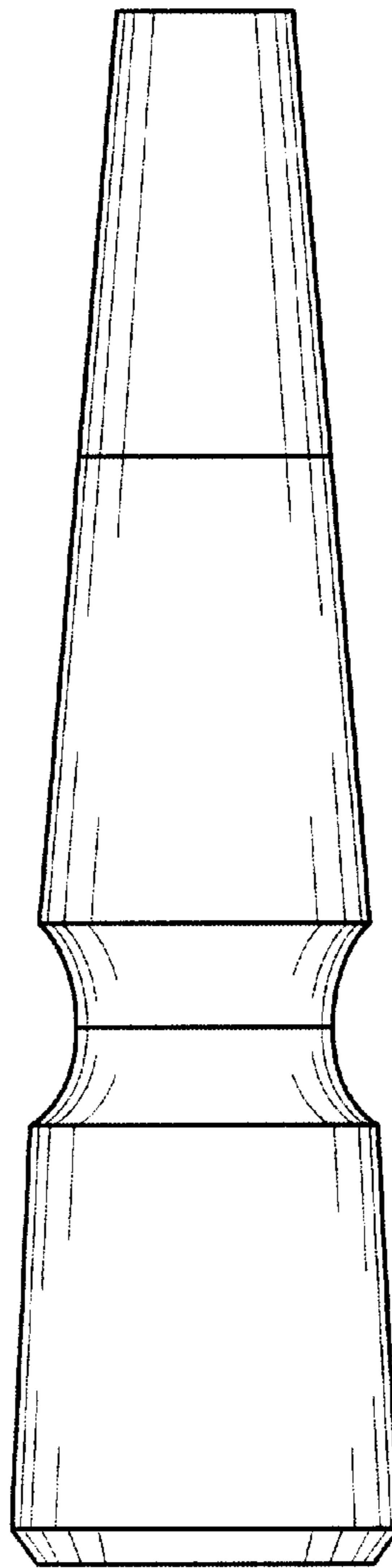

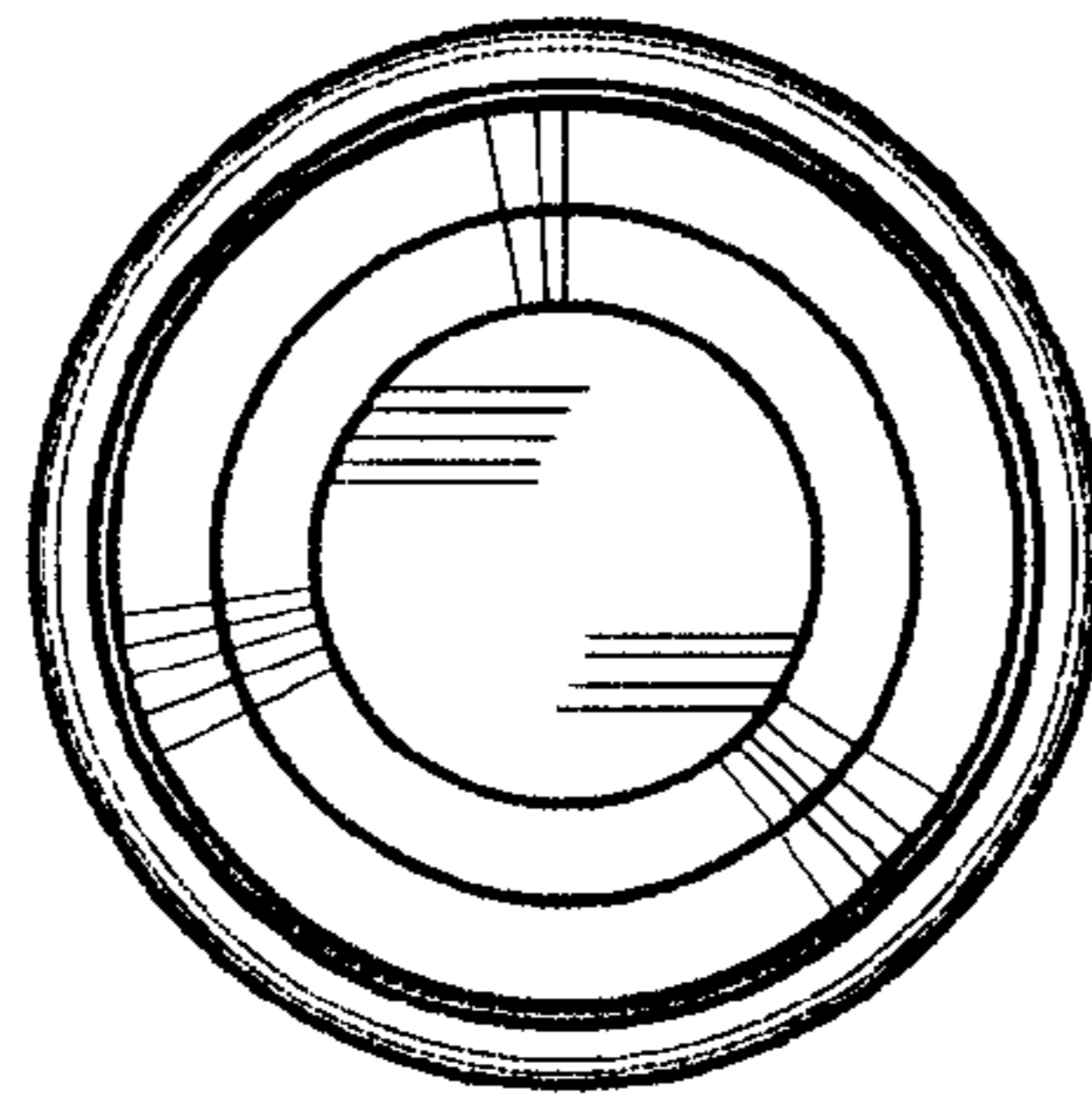

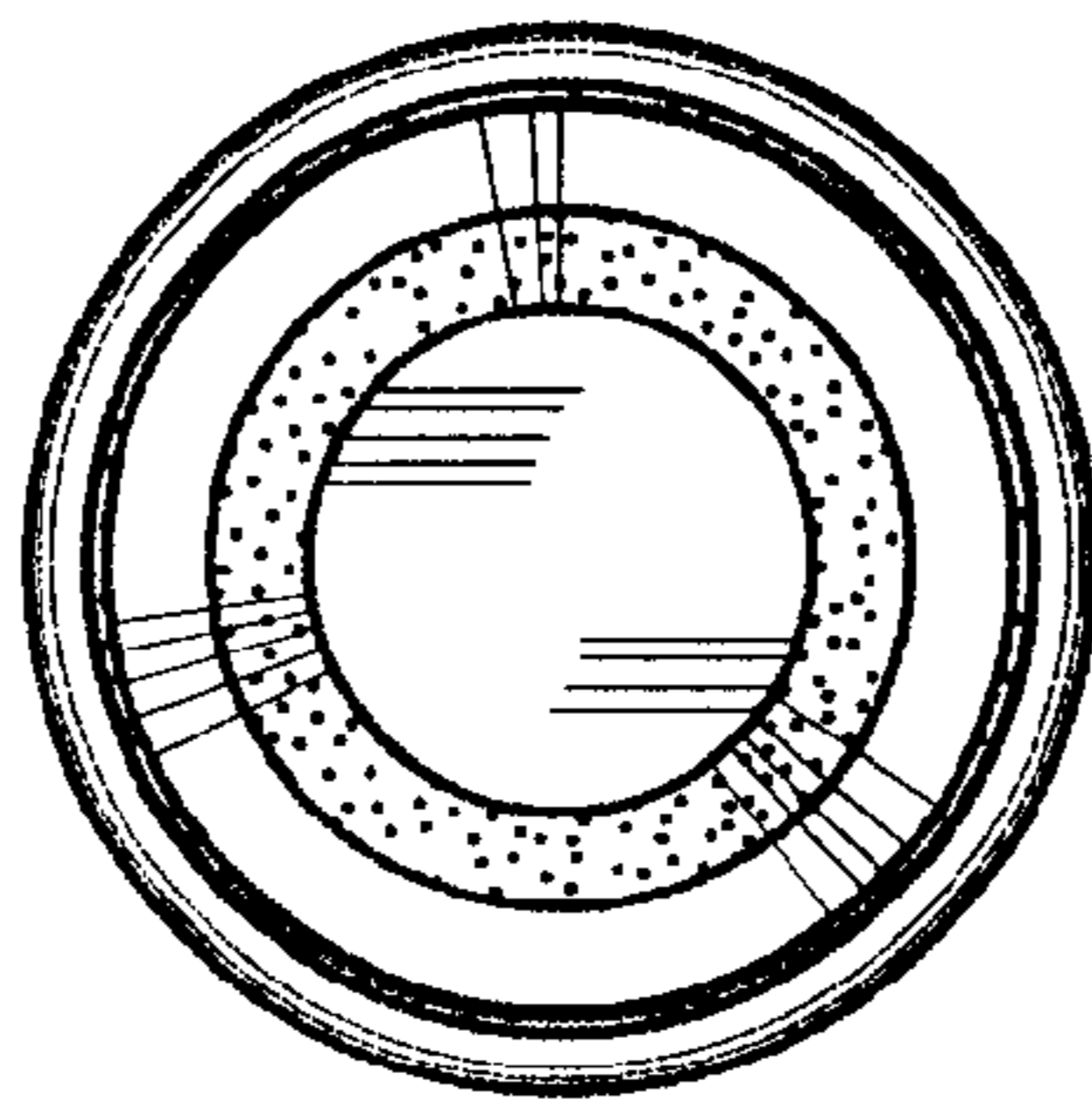

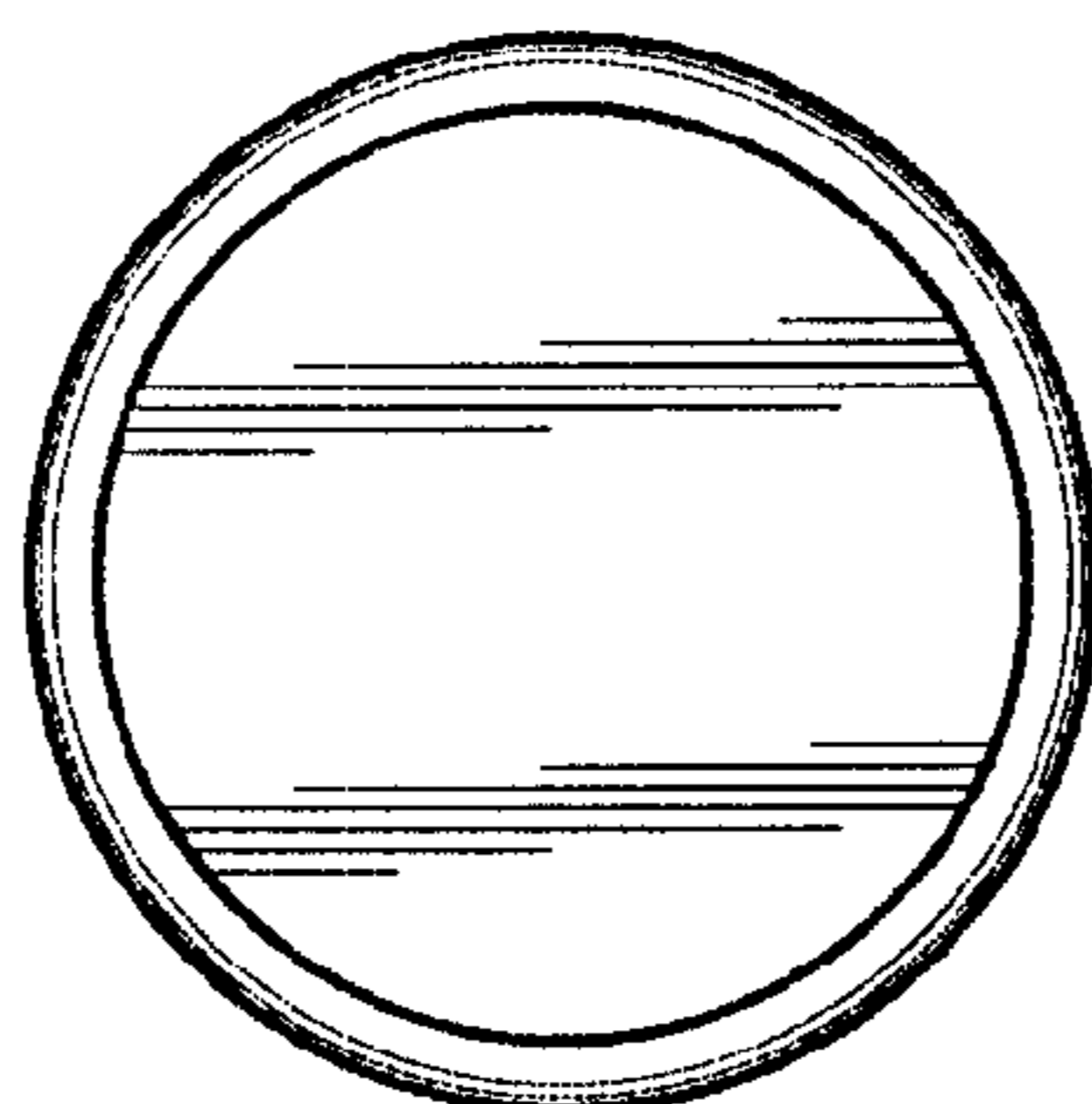
