(57) **CLAIM**

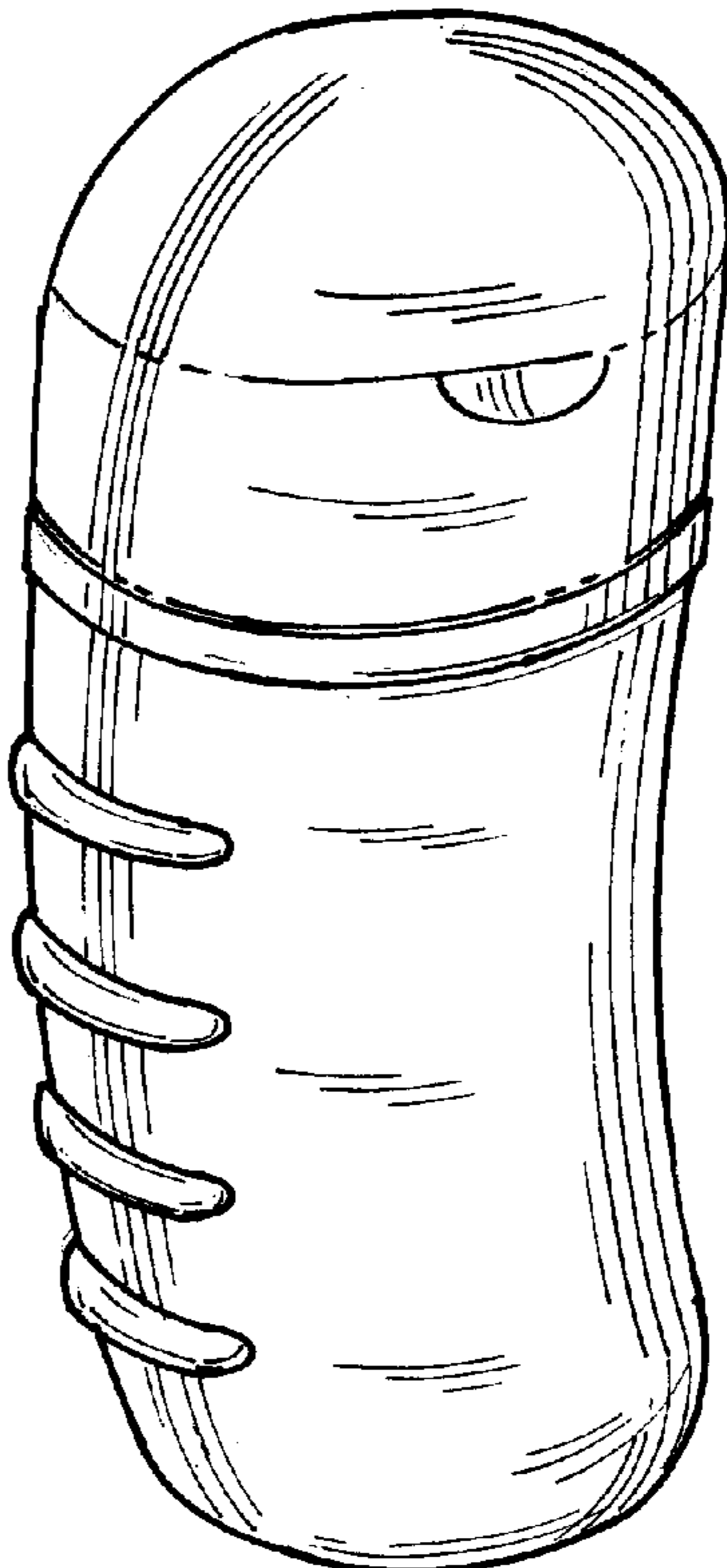
The ornamental design for the dispensing container, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view from above and to one side of the dispensing container showing the new design;
FIG. 2 is a front view of the dispensing container of FIG. 1;
FIG. 3 is a rear view of the dispensing container of FIG. 1;
FIG. 4 is a top view of the dispensing container of FIG. 1;
FIG. 5 is a bottom side view of the dispensing container of FIG. 1;
FIG. 6 is a right side view of the dispensing container of FIG. 1; and,
FIG. 7 is a left side view of the dispensing container of FIG. 1.

The detail shown in the dashed lines in FIG. 5 forms no part of the design as shown and claimed herein.

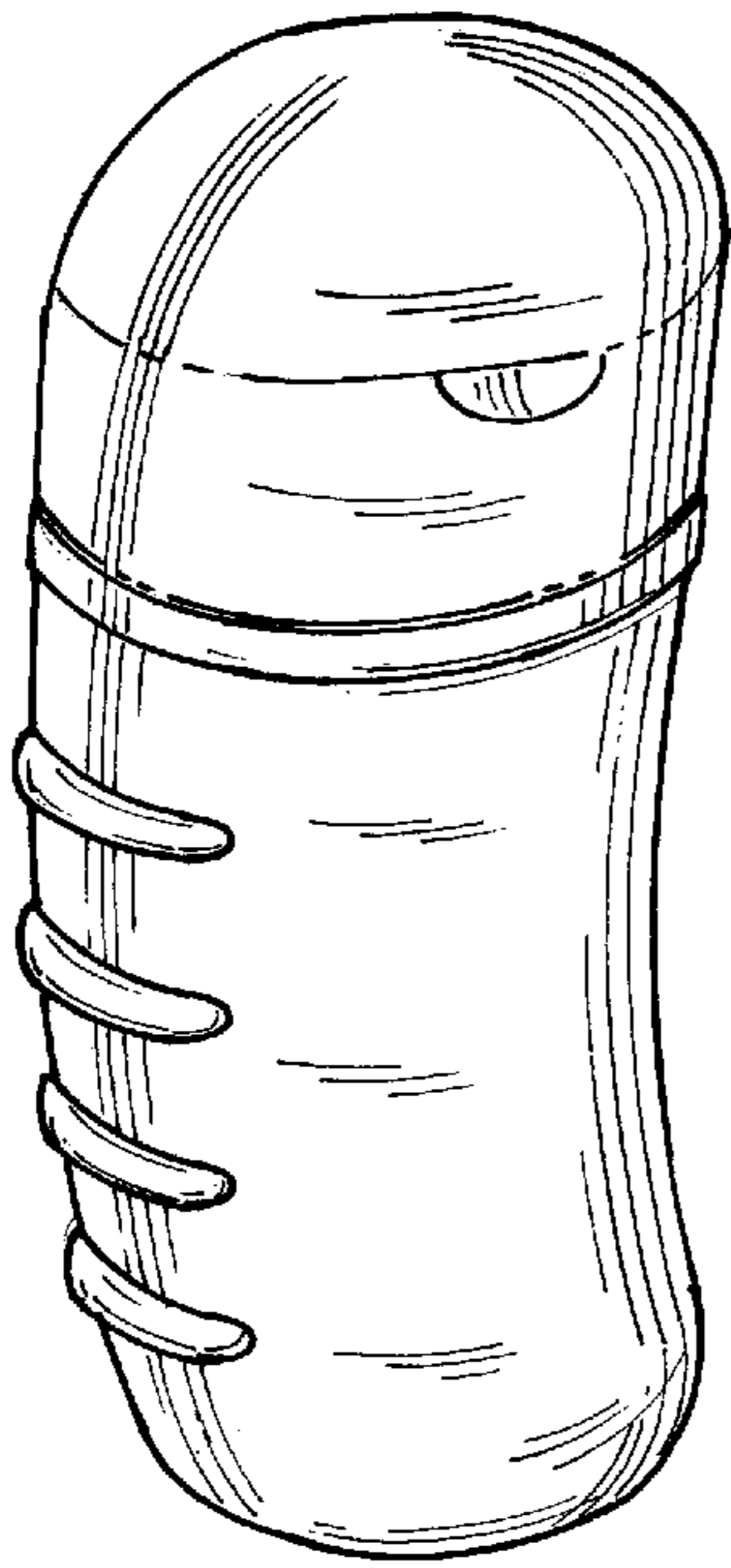

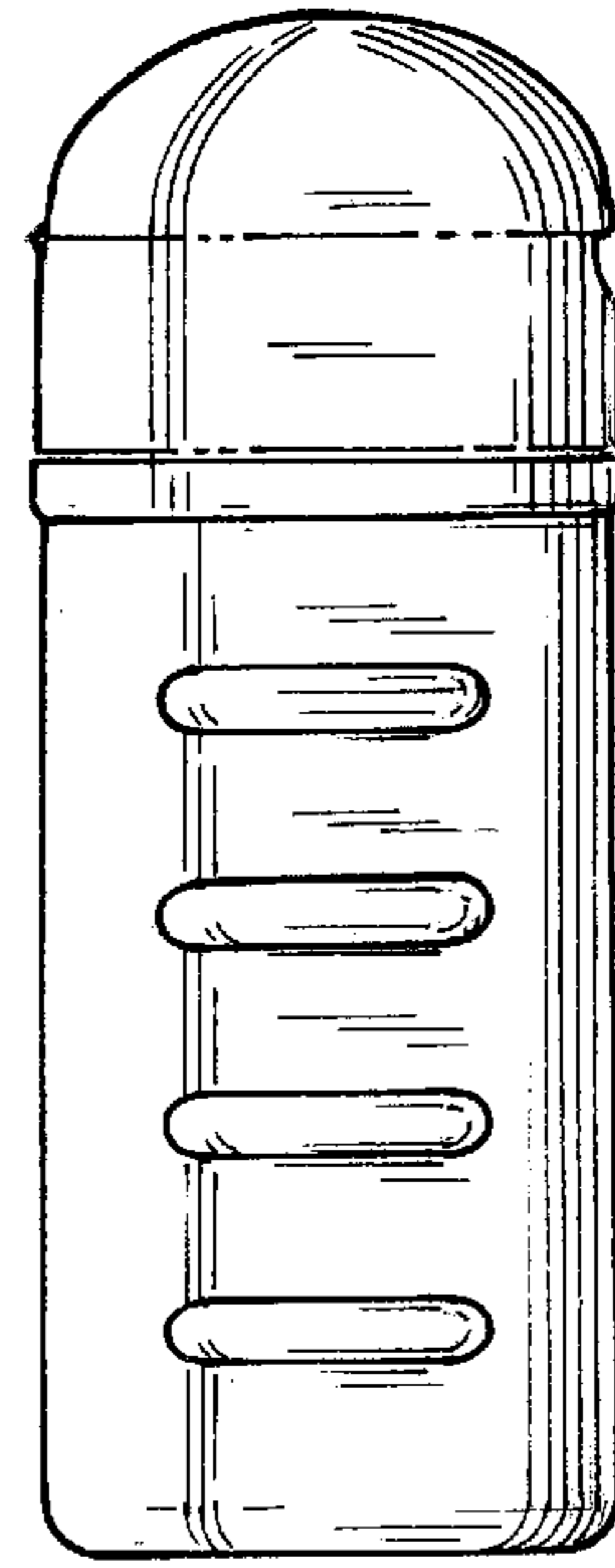

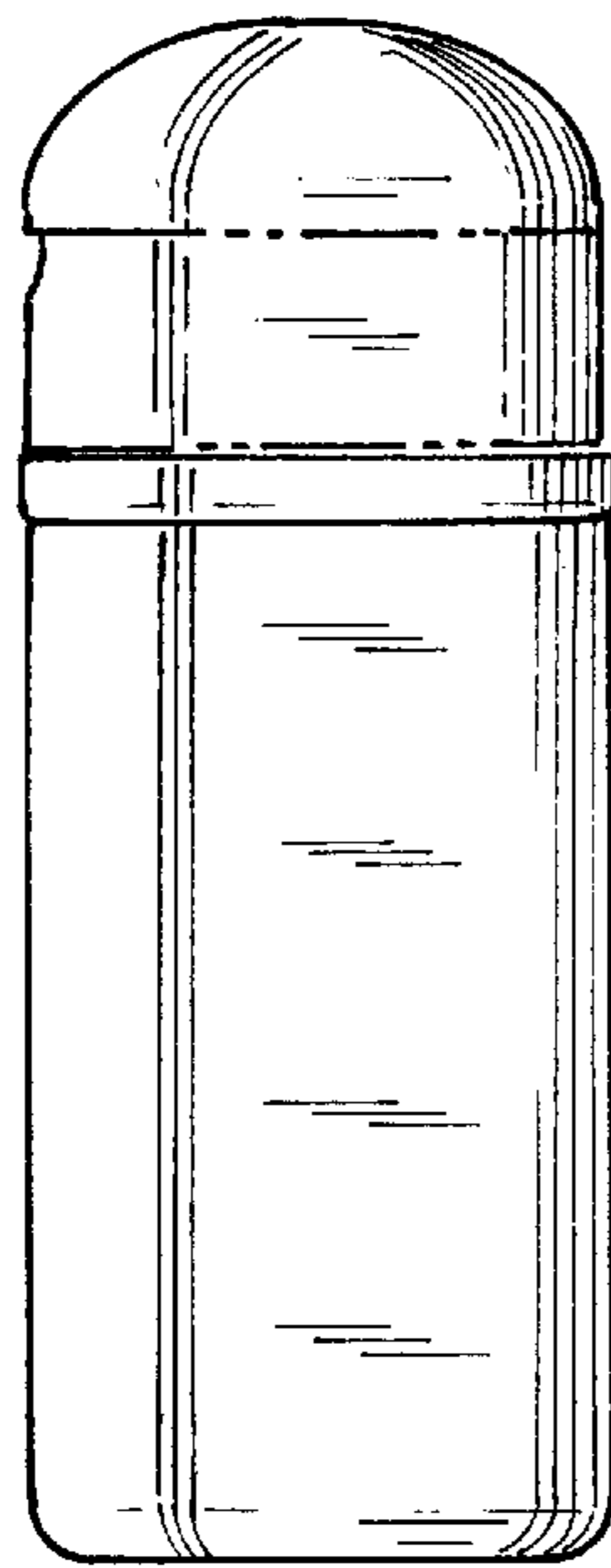

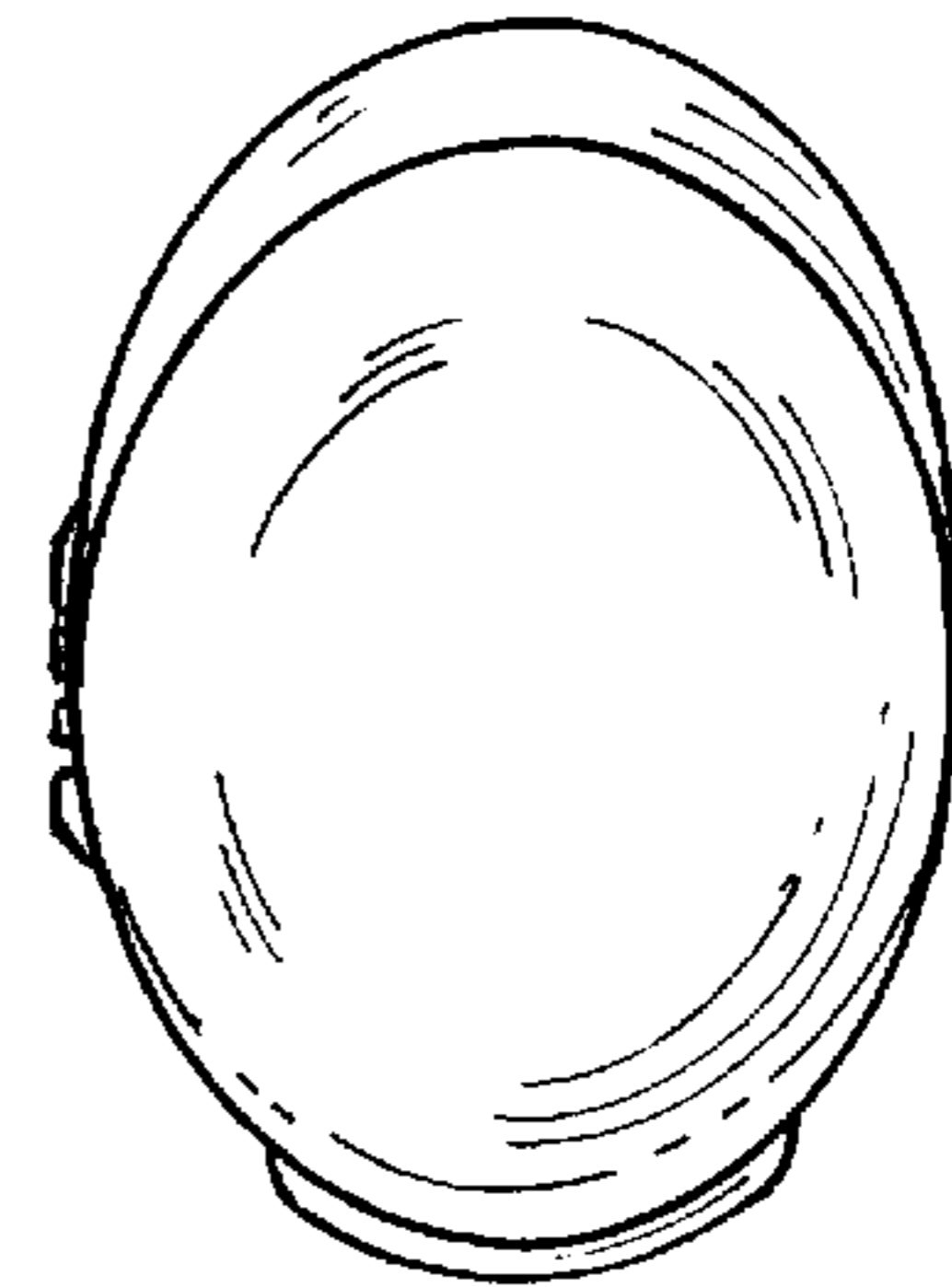

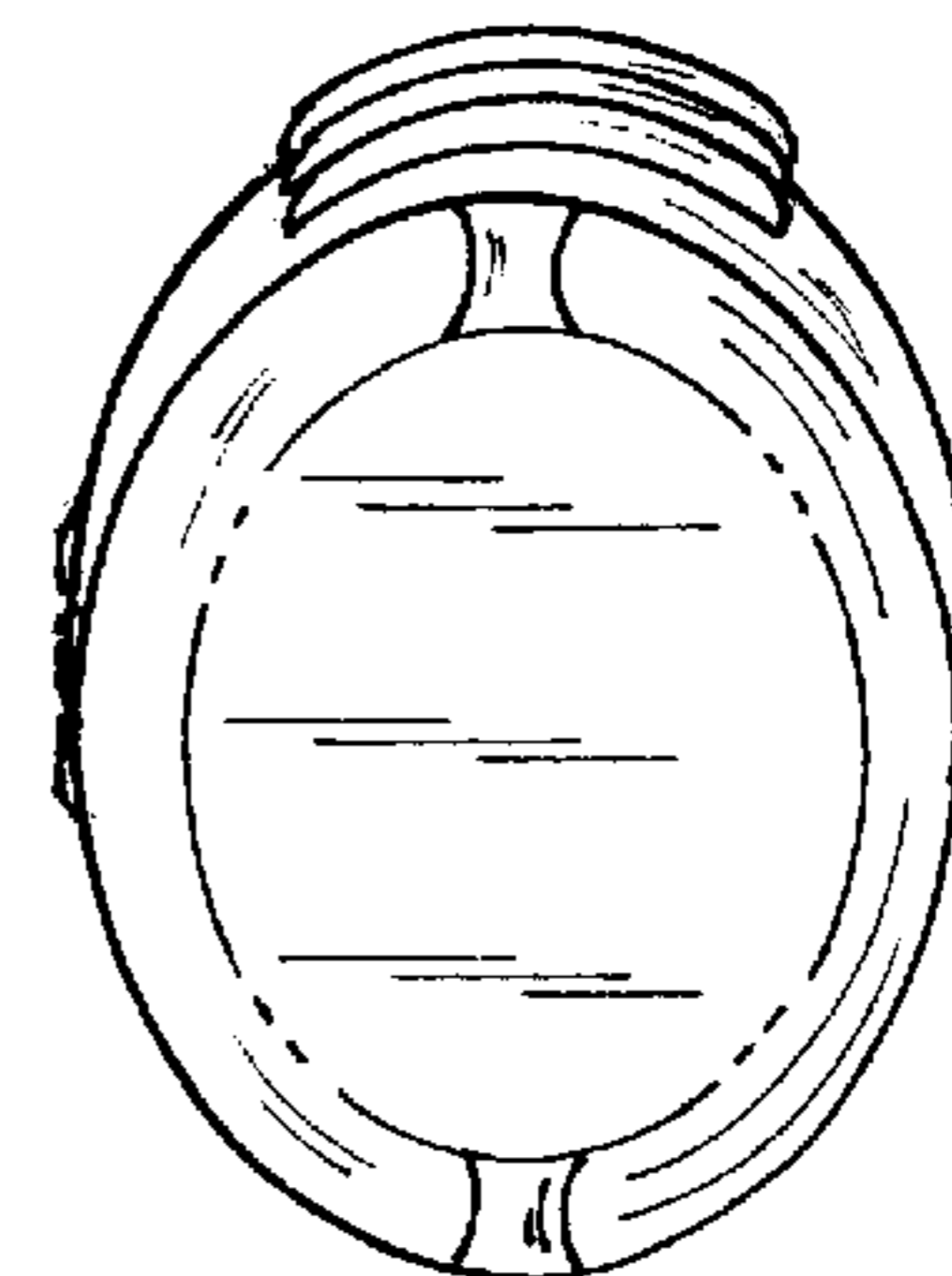

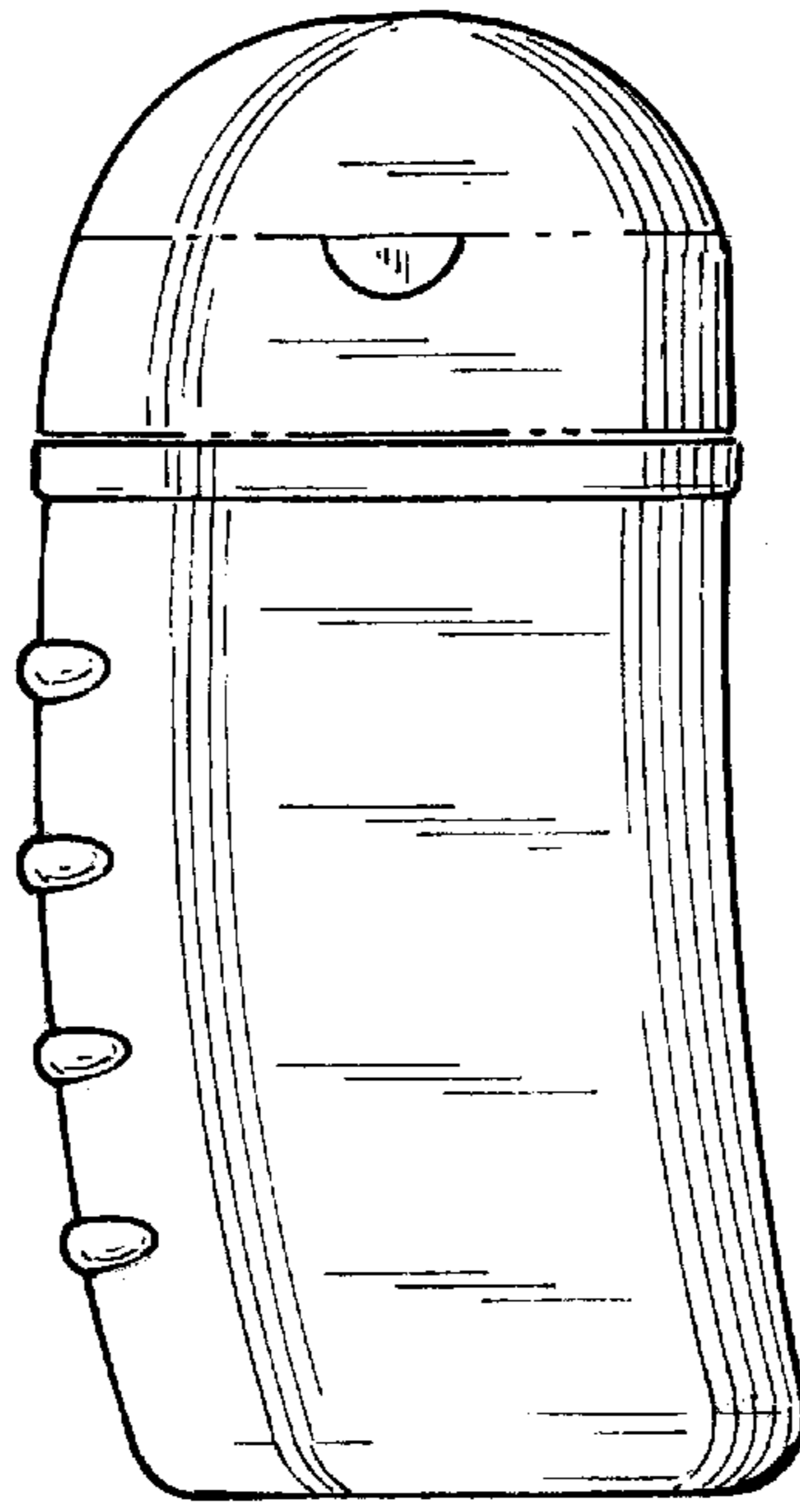

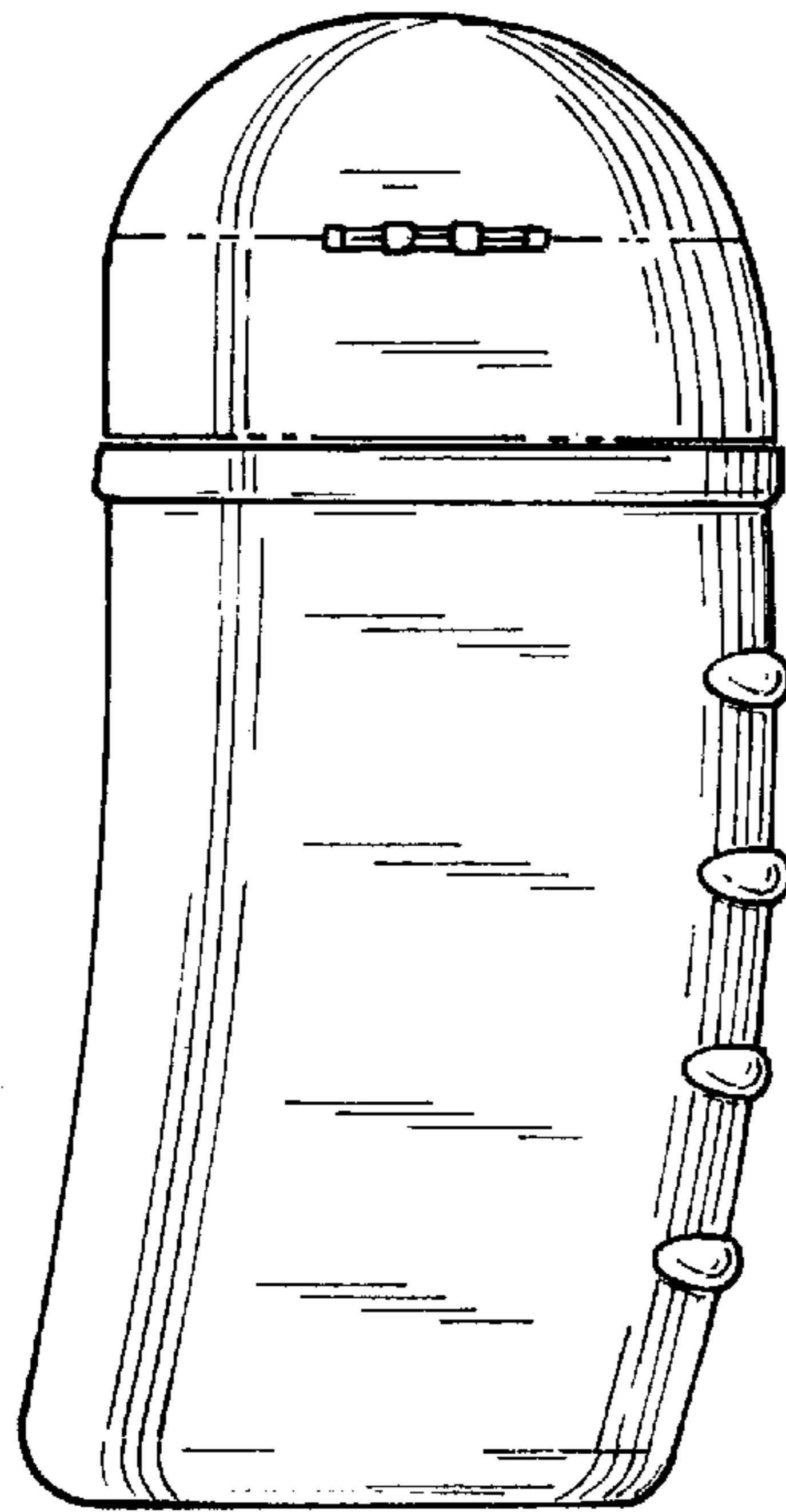
