FIG. 3 is a front view of the headset shown in FIG. 1;

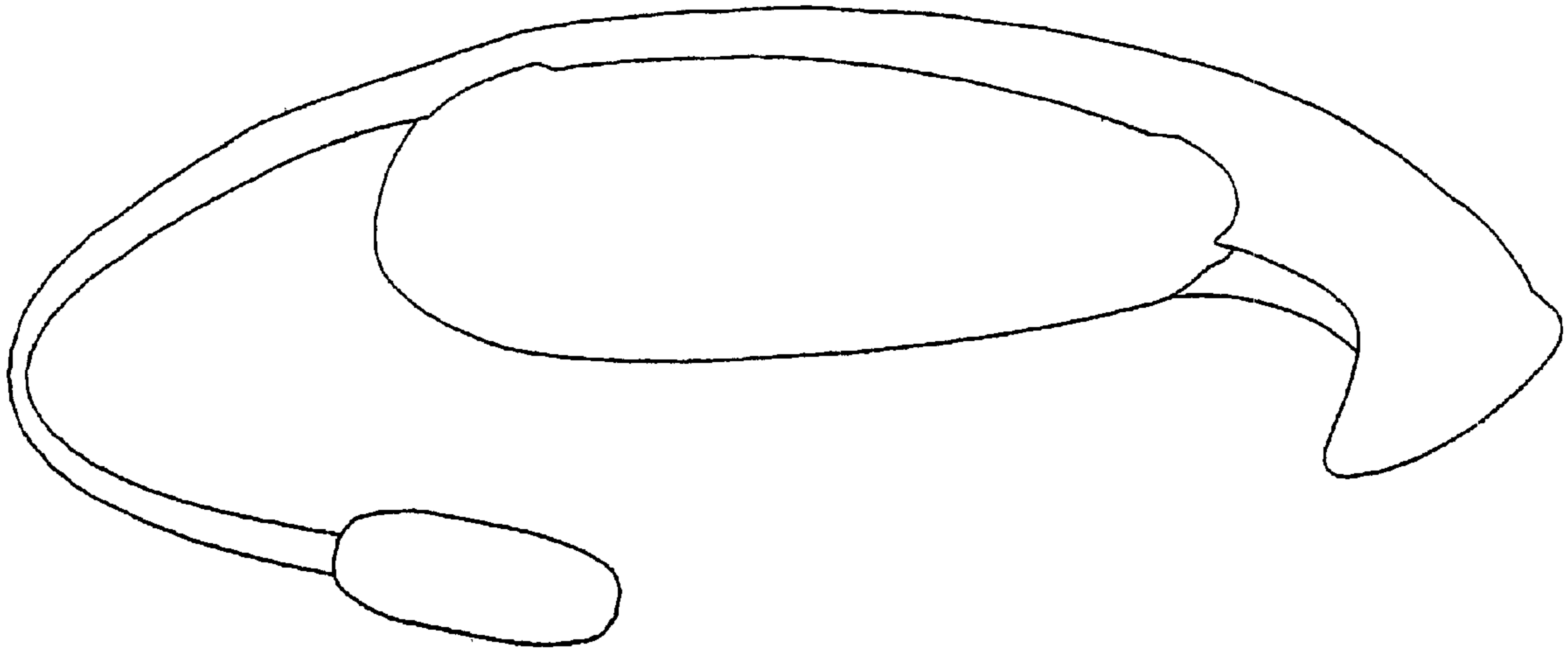
FIG. 4 is a rear view of the headset shown in FIG. 1;

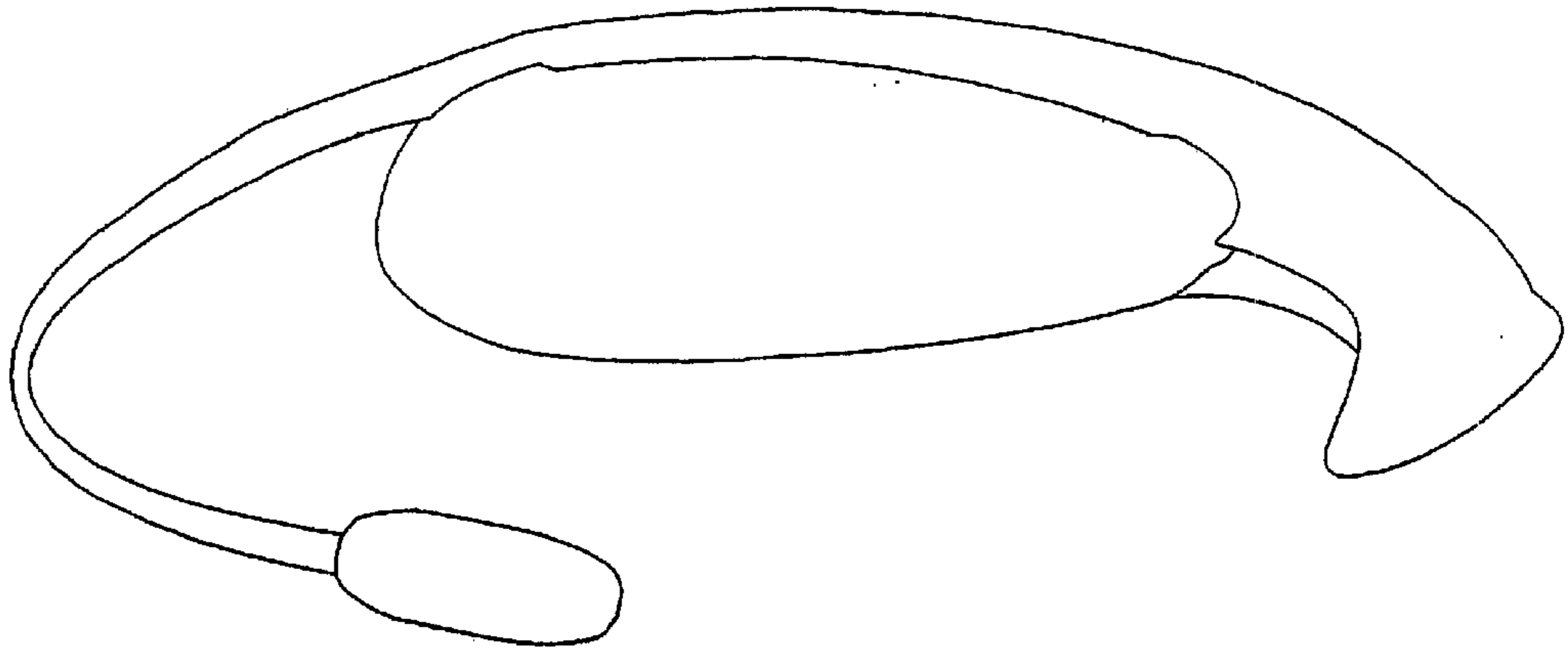

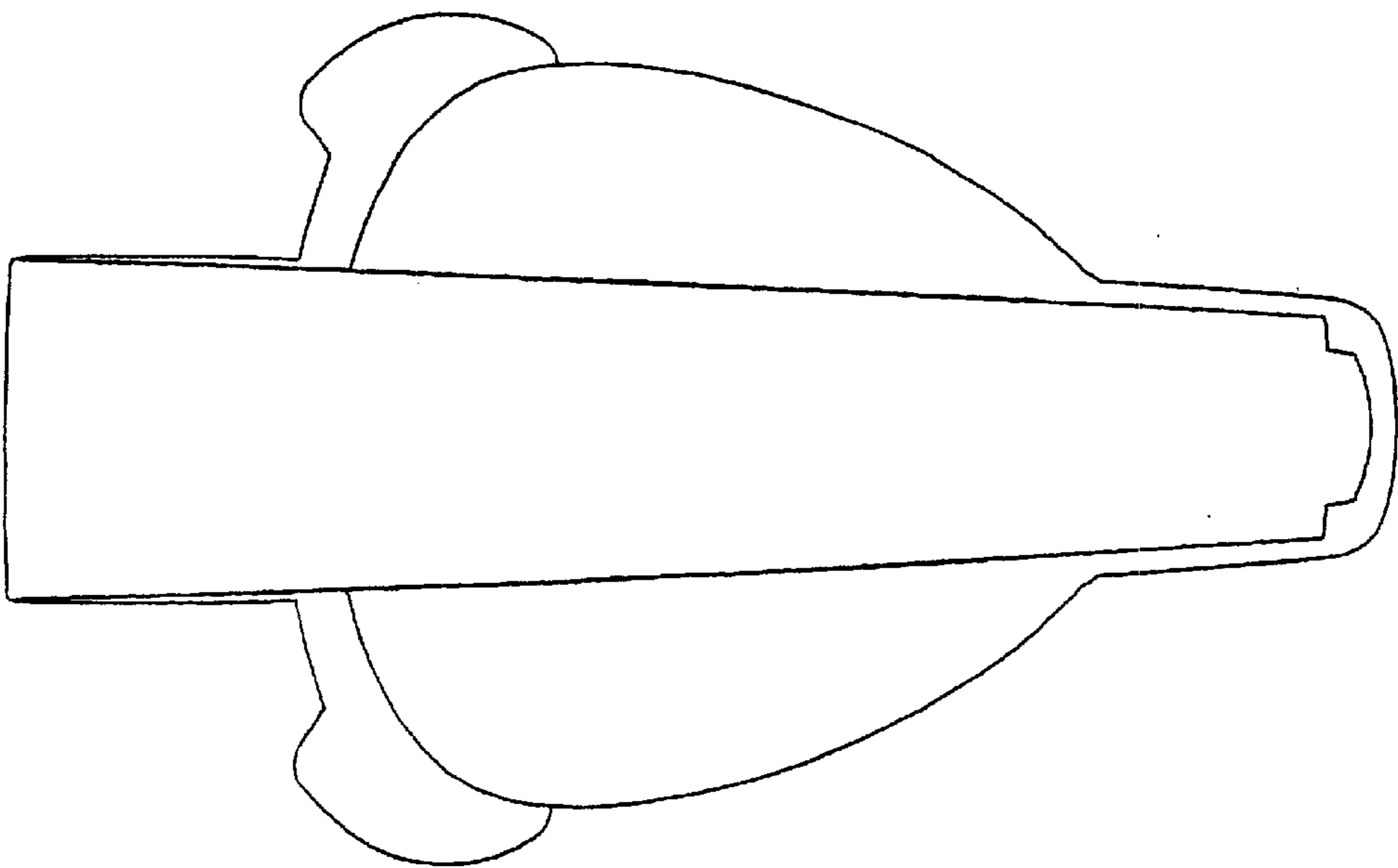

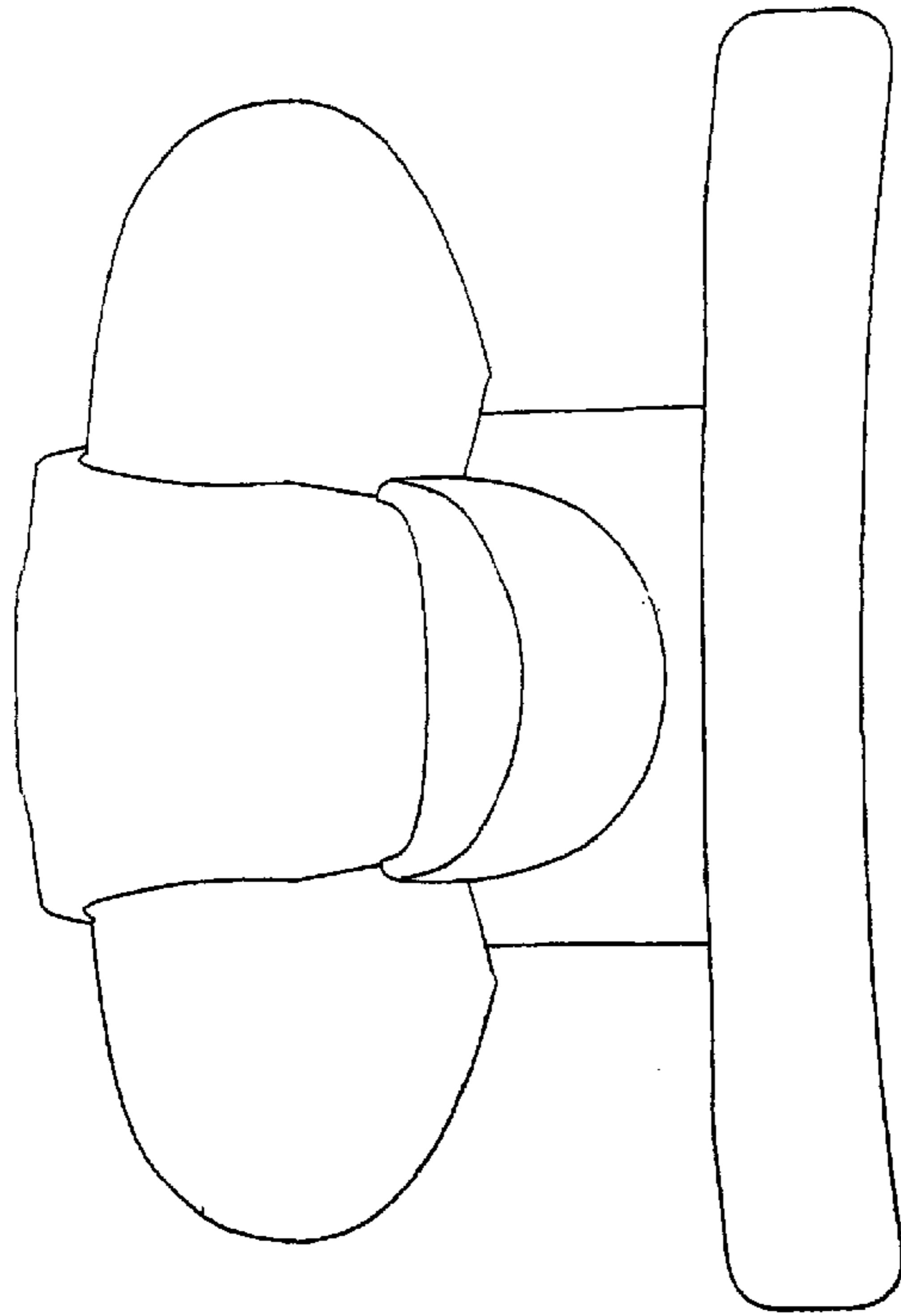

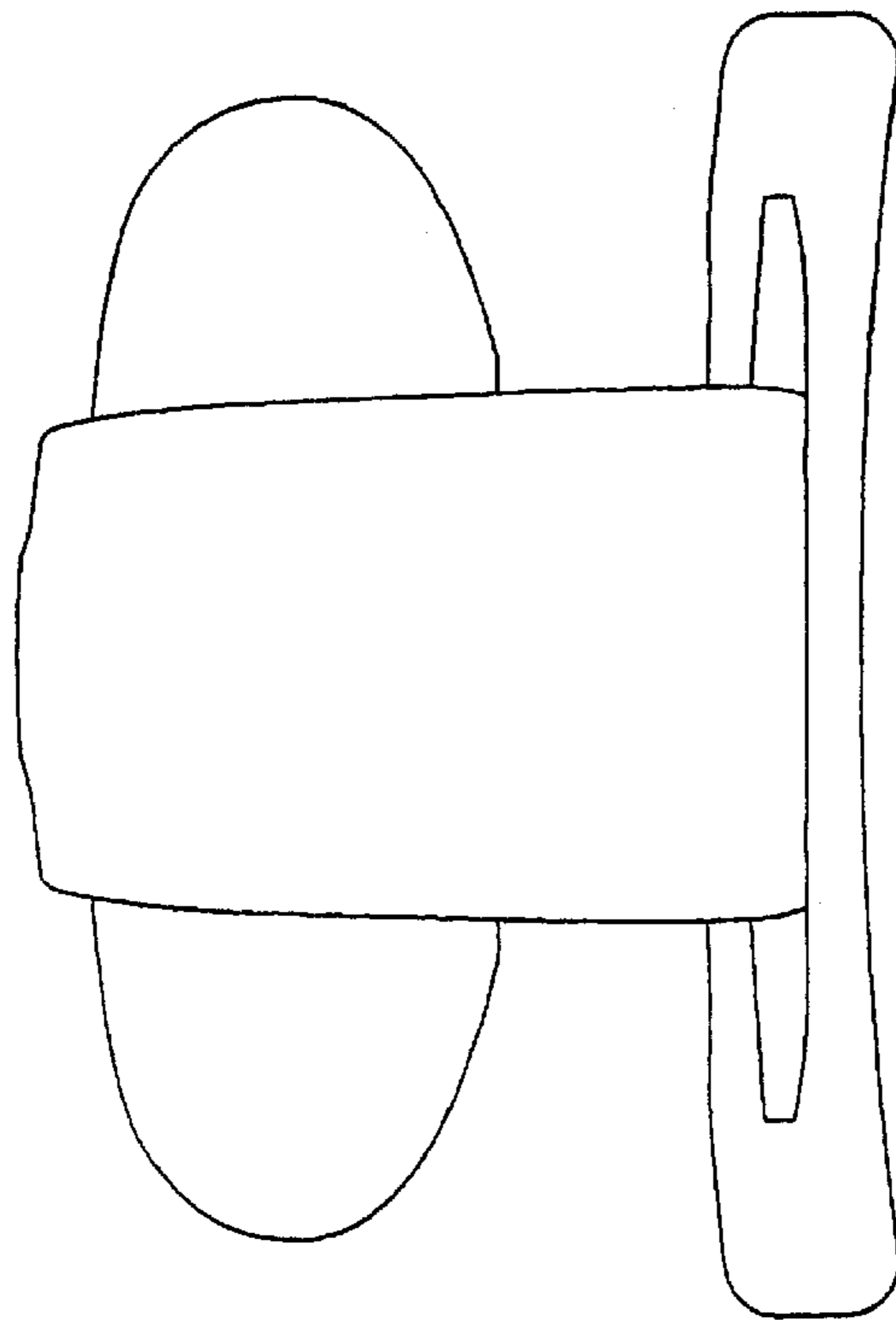

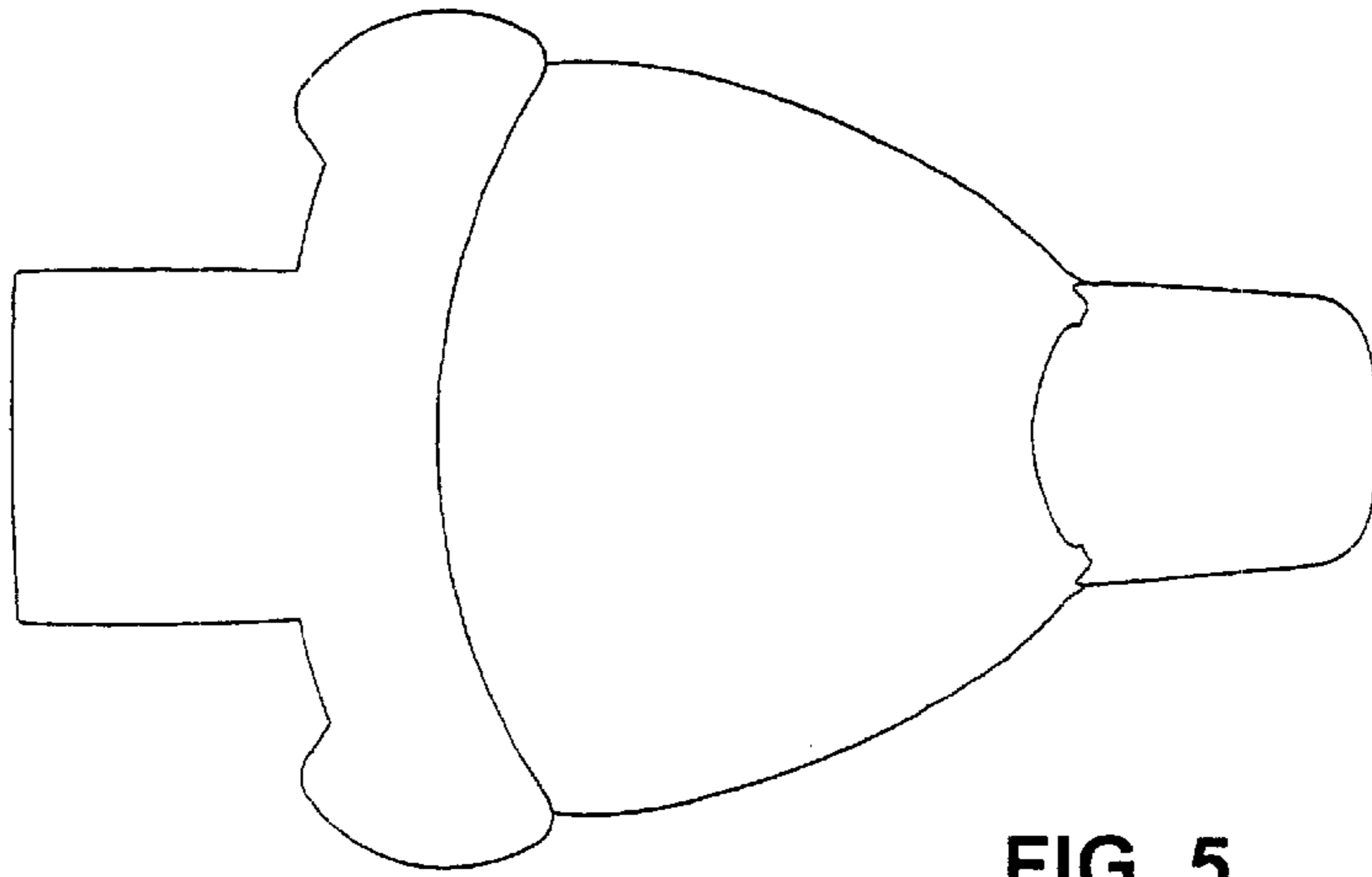

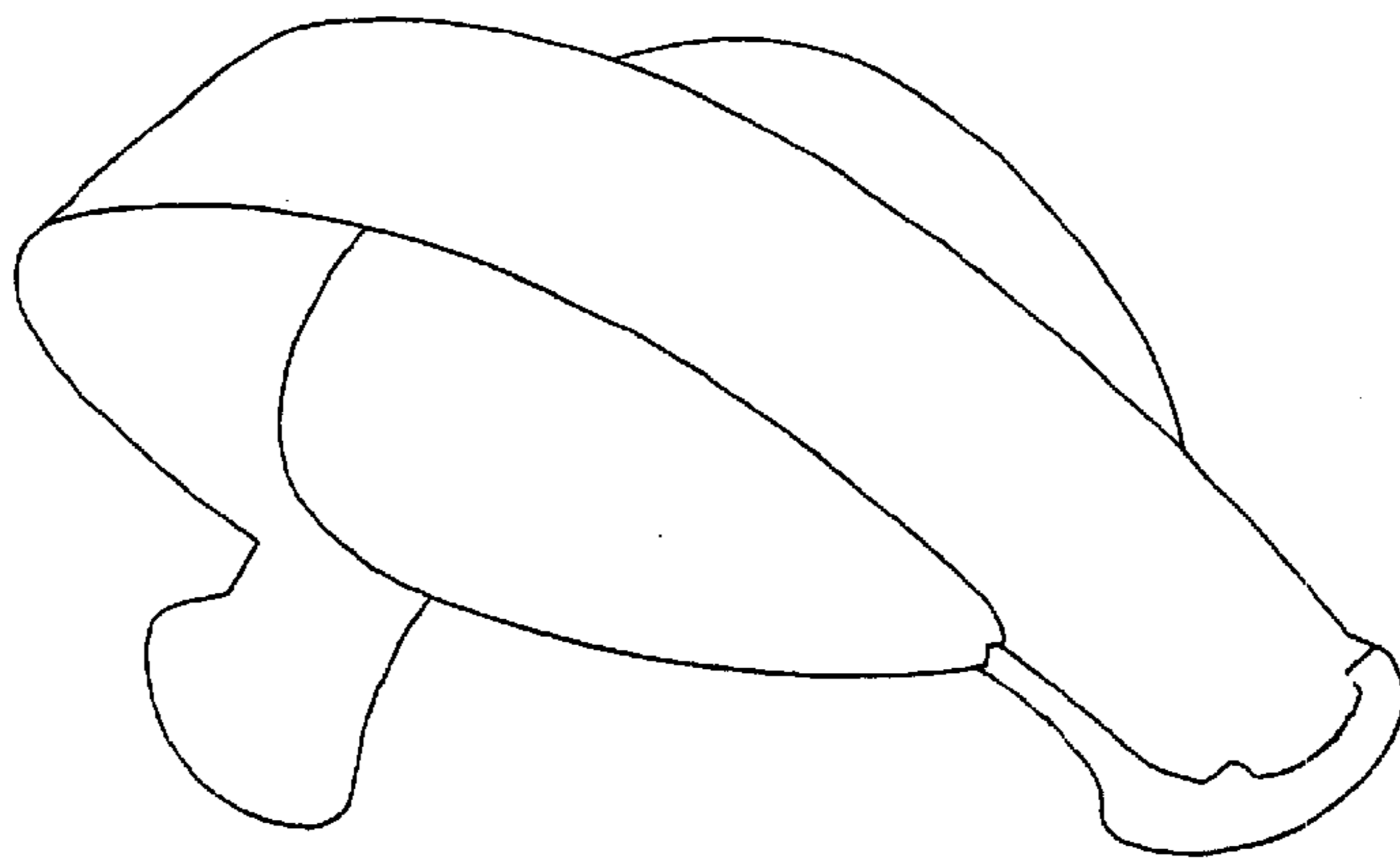

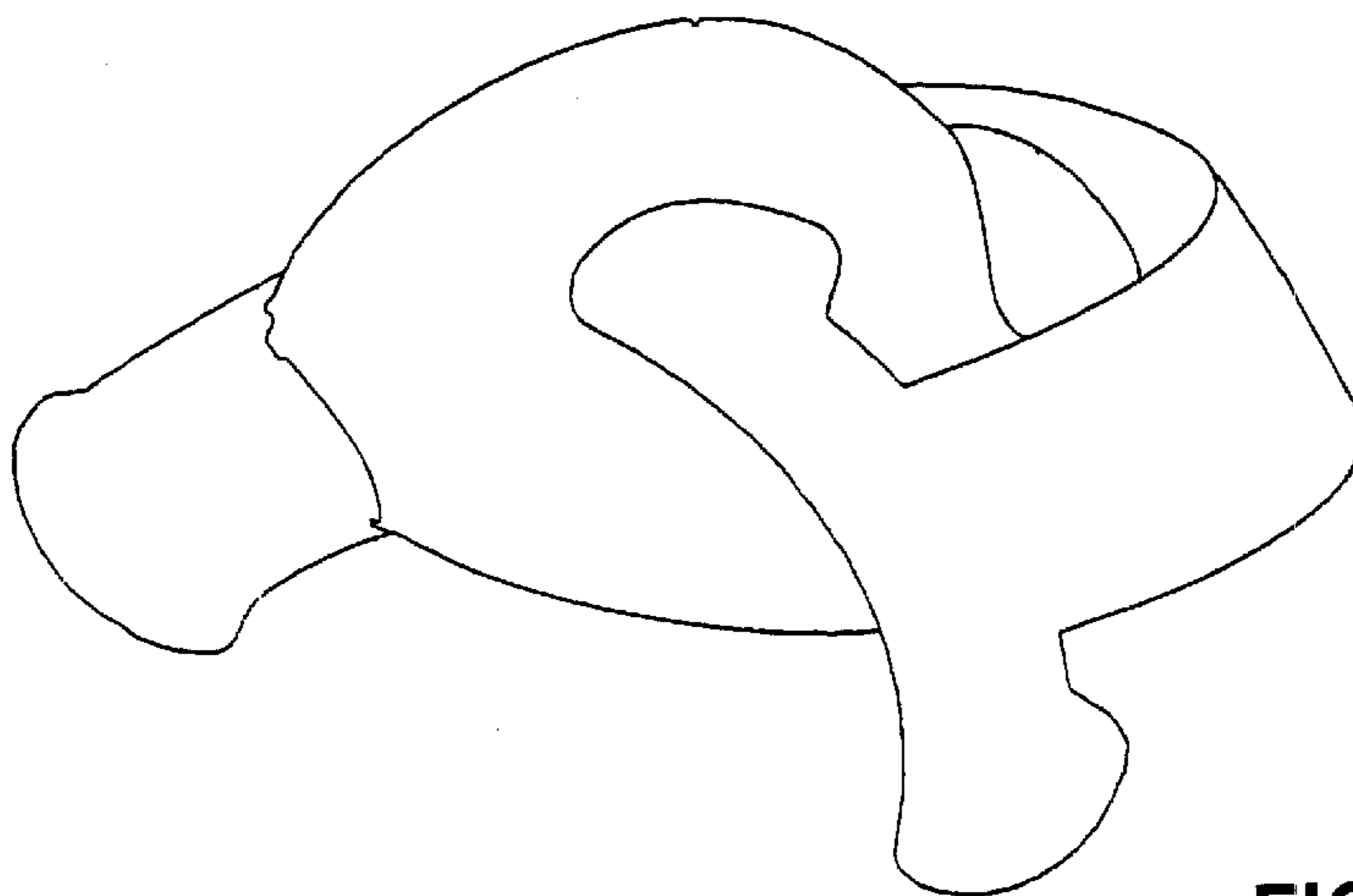
