FIG. 1 is a front elevational view of eyeglasses showing our new design;

FIG. 2 is a side elevational view thereof, the opposite side view being a mirror image thereof;

FIG. 3 is an enlarged limited length portion of a temple member thereof;

FIG. 4 is a partial side view of a temple member and earpiece thereof;

FIG. 5 is a perspective view of the top, one end and one side of a connector for connecting a temple member to the eyeglasses;

FIG. 6 is a top plan view thereof;

FIG. 7 is a perspective view of the top, one end and opposite side of the connector element with a proportion of the connector element eliminated;

FIG. 8 is a perspective view of the top, one end and one side of one portion of the connector element;

FIG. 9 is a perspective view of one side and one end of an earpiece thereof;

FIG. 10 is a perspective view of one side and one end of an earpiece cover thereof; and,

FIG. 11 is an enlarged perspective view of a portion of the opposite end of the earpiece shown in FIG. 9.

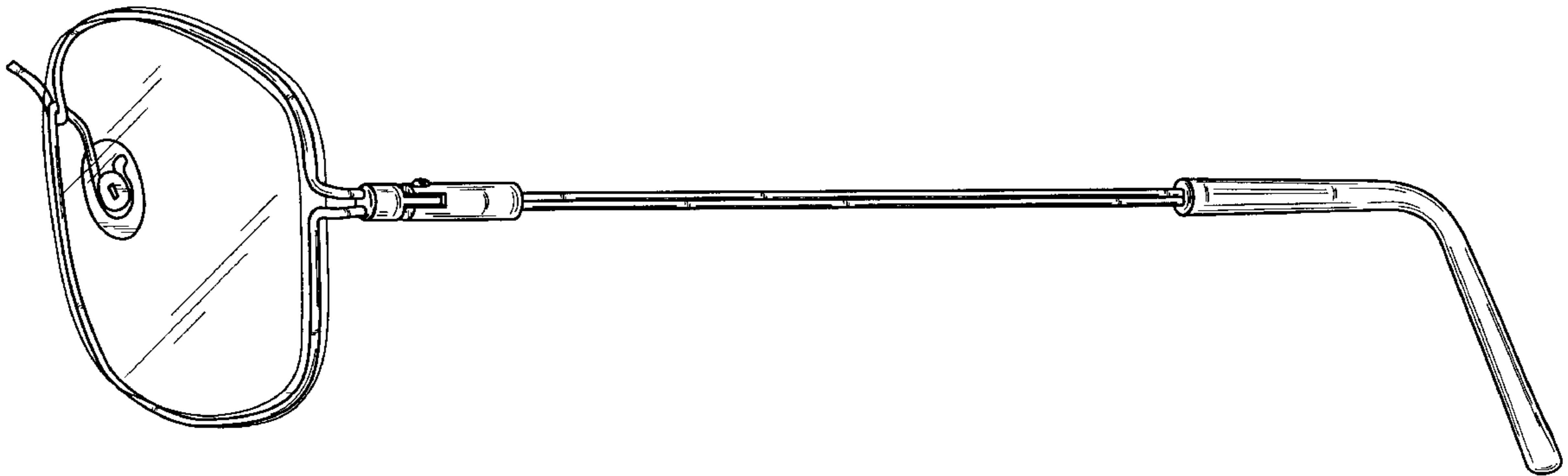

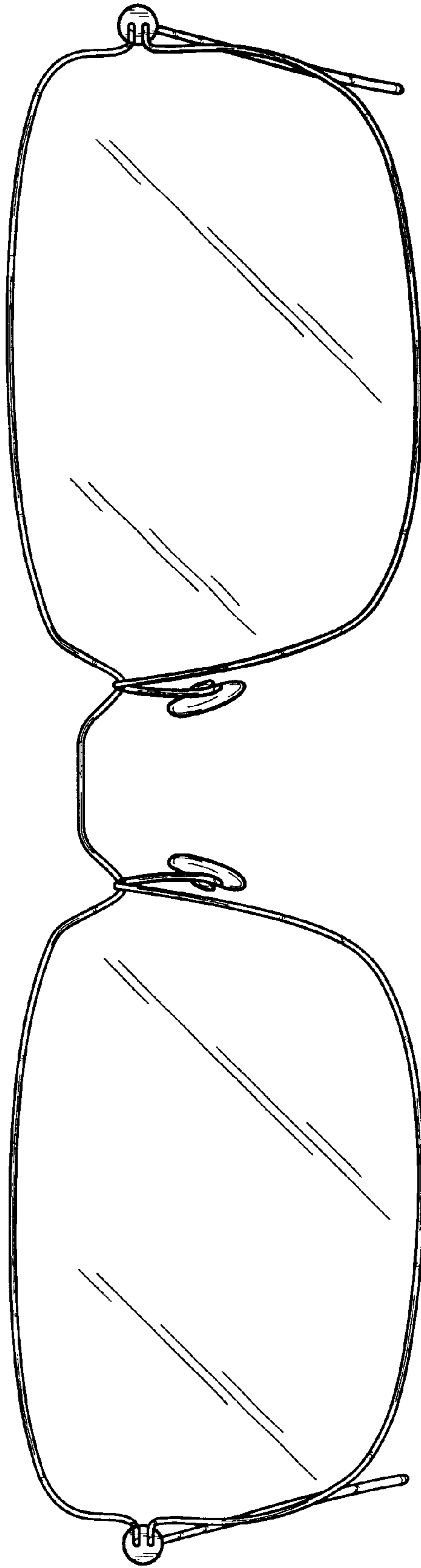

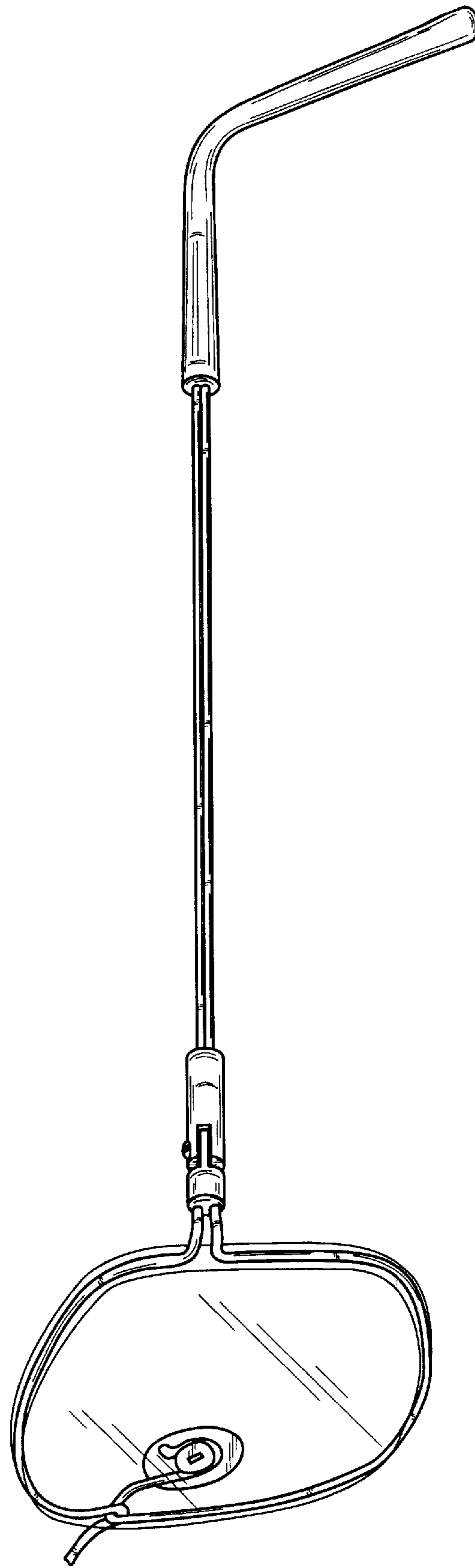

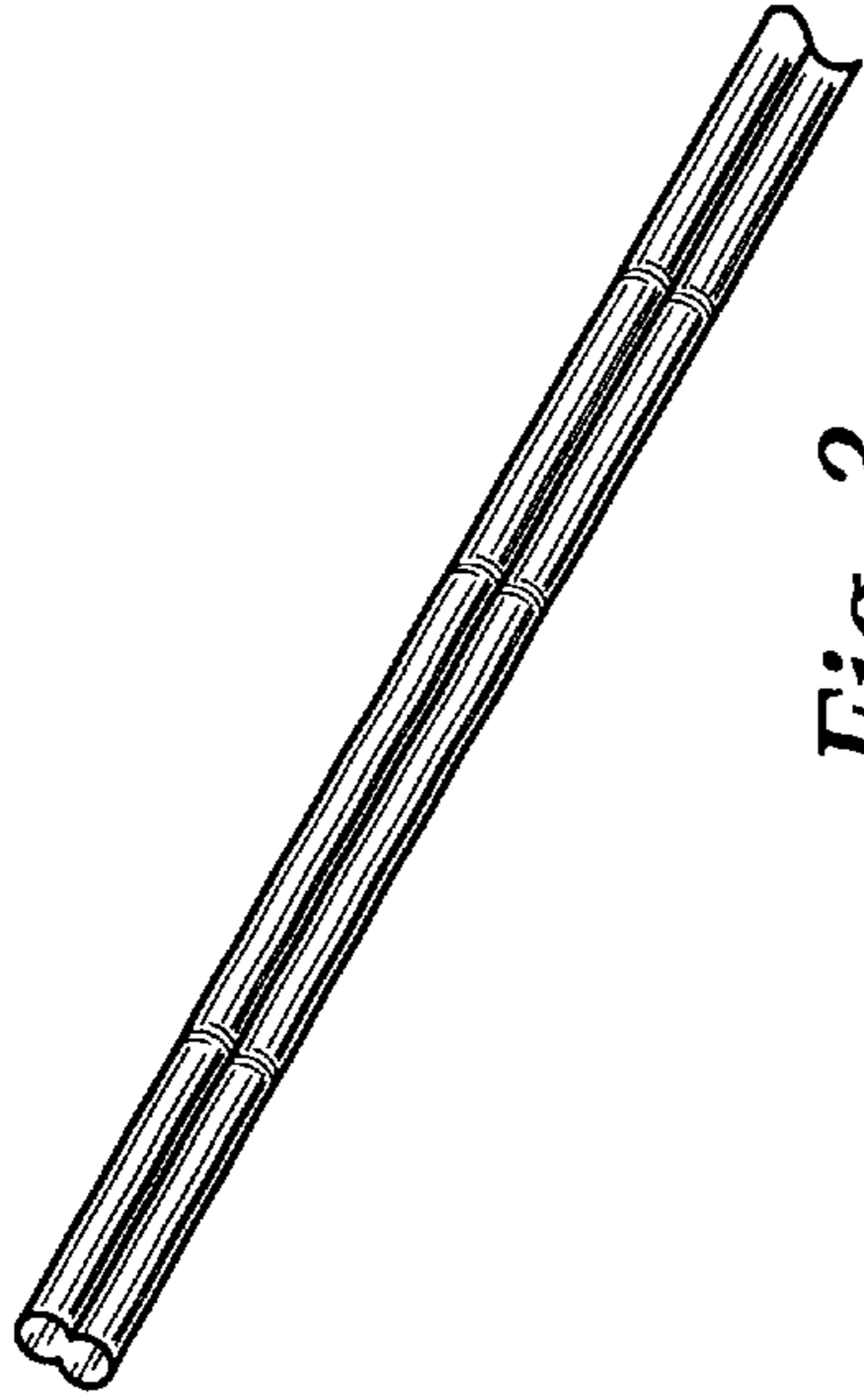

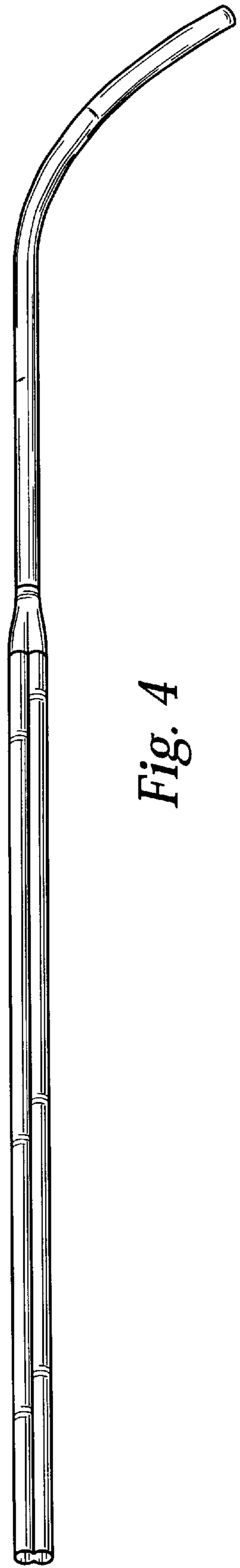

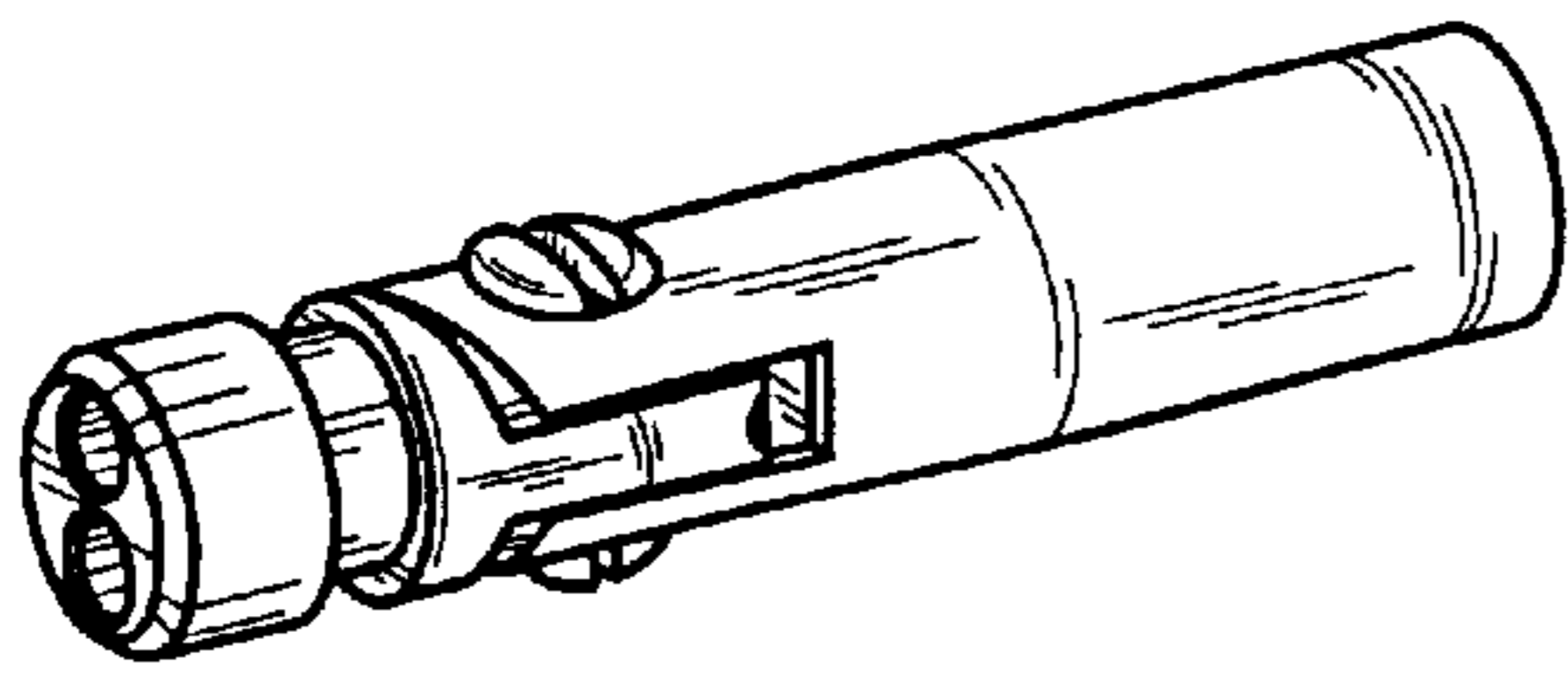

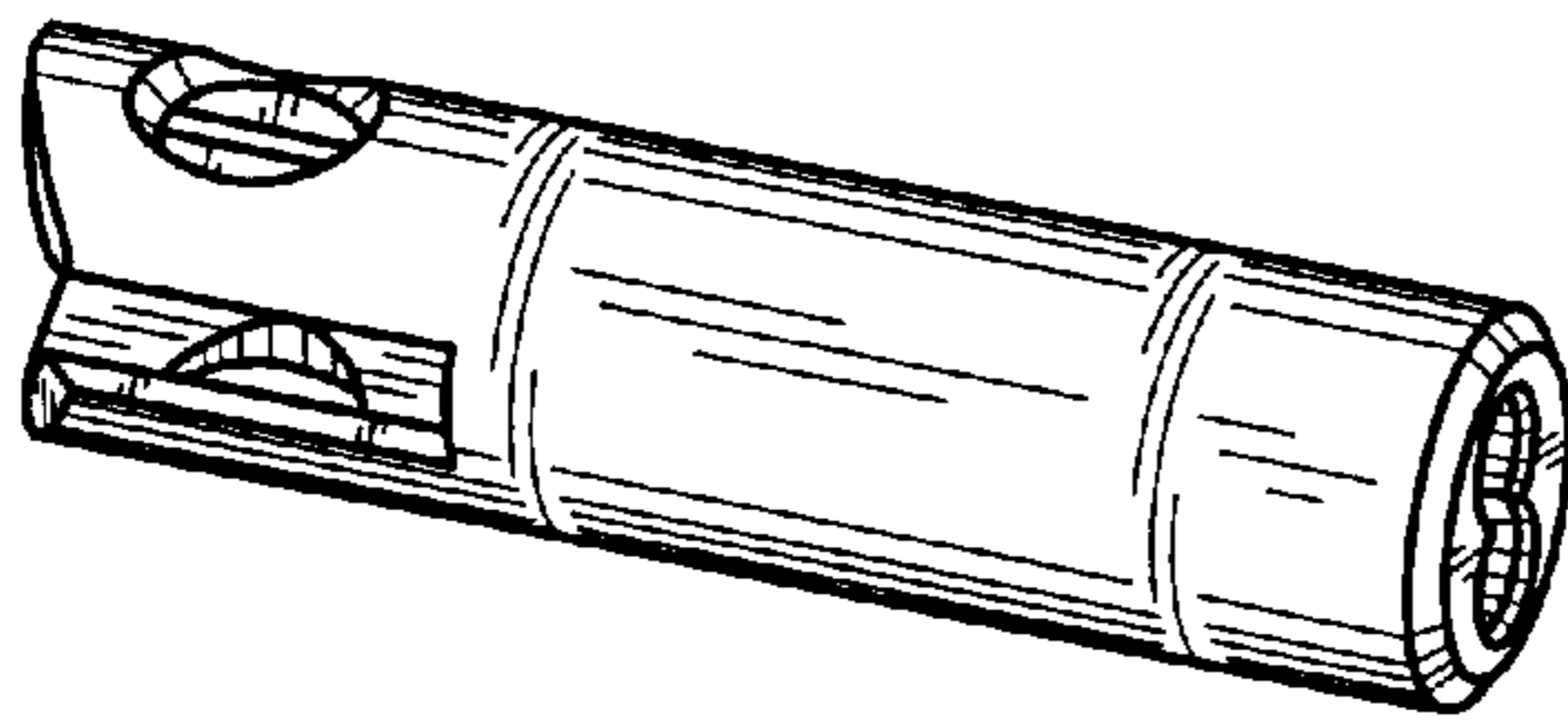

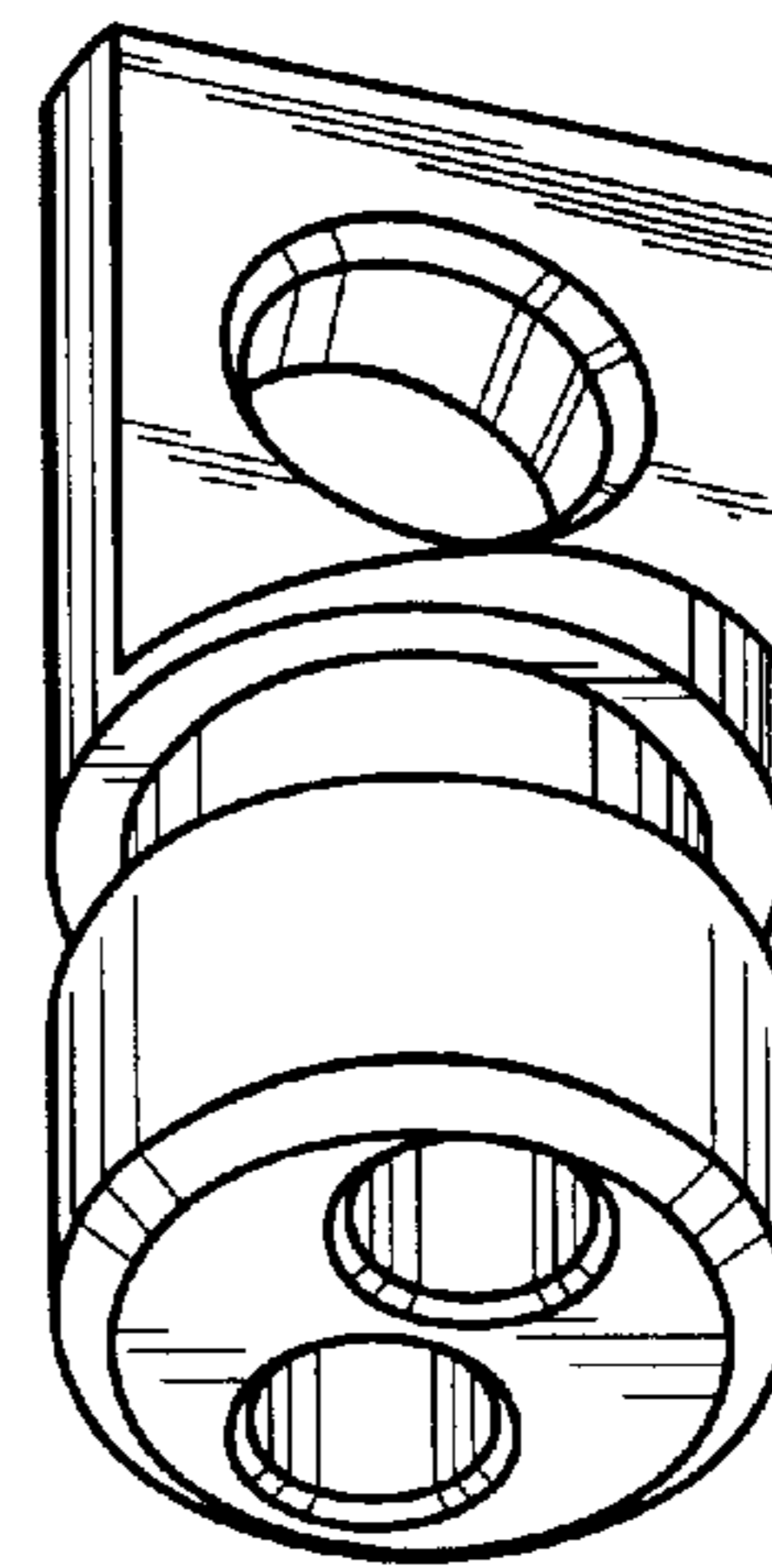

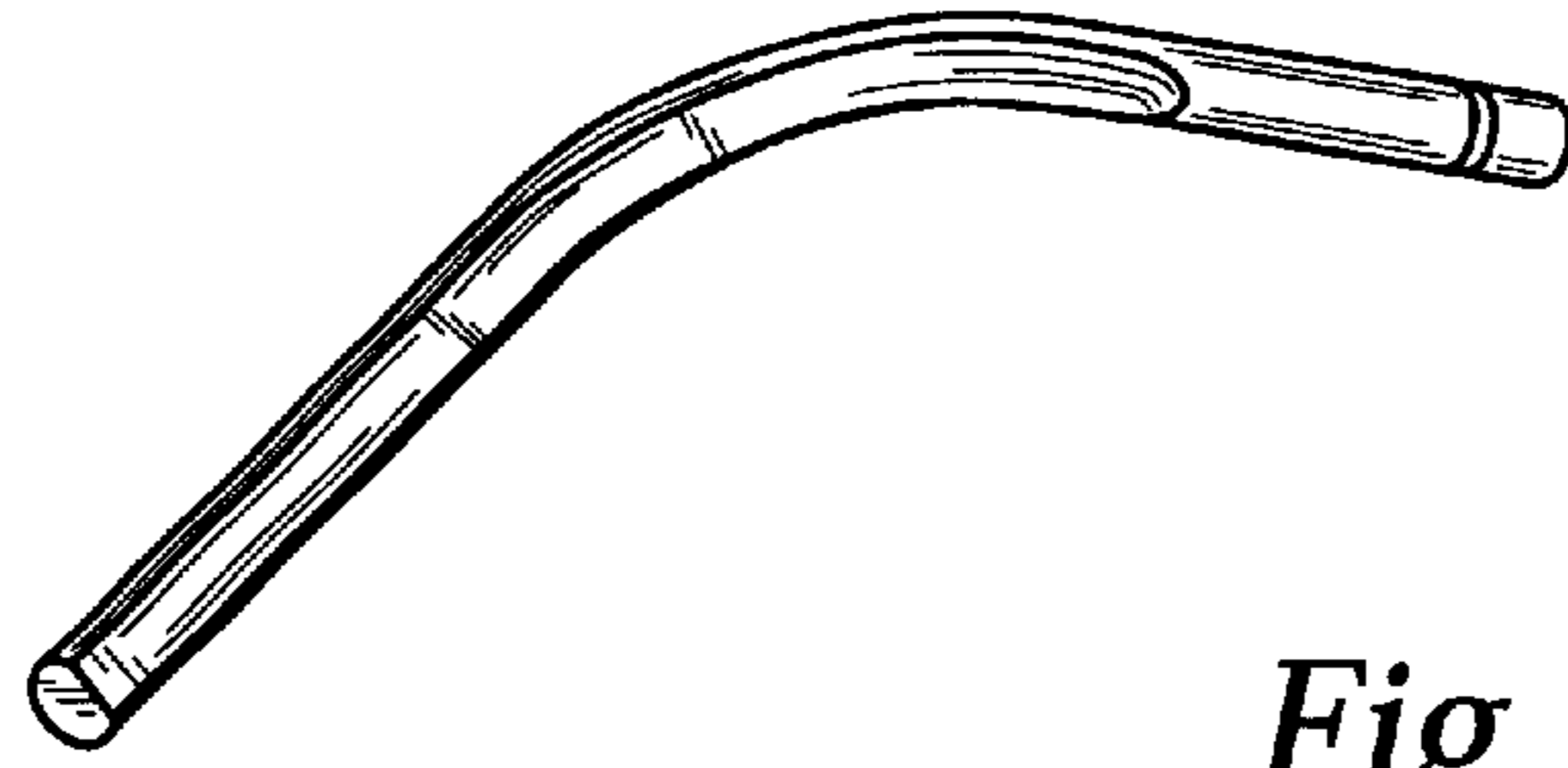

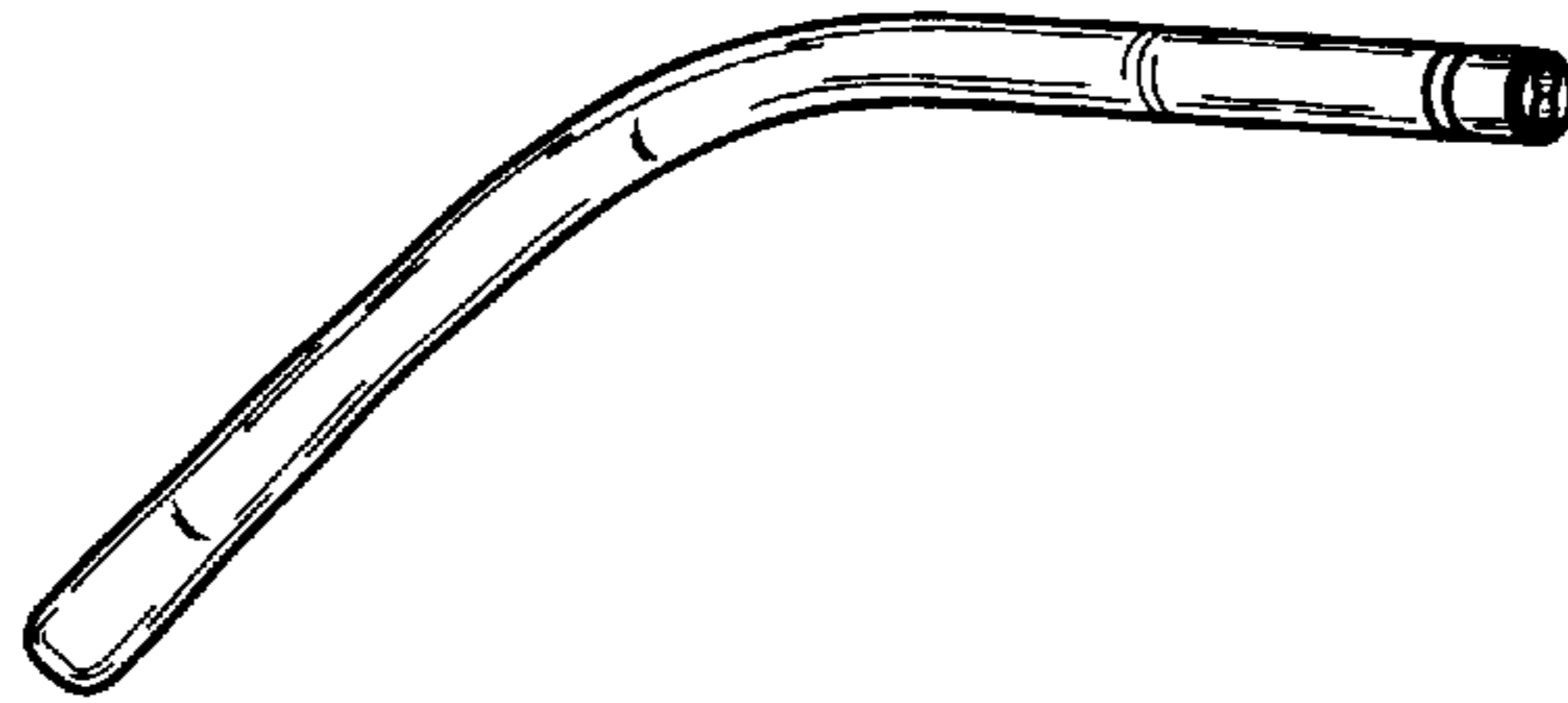

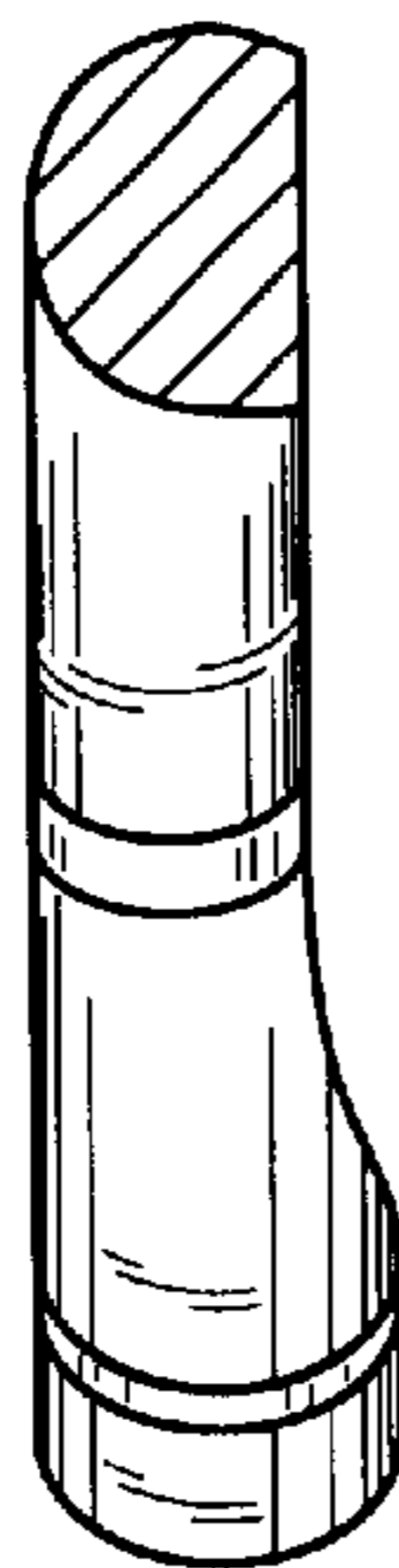
