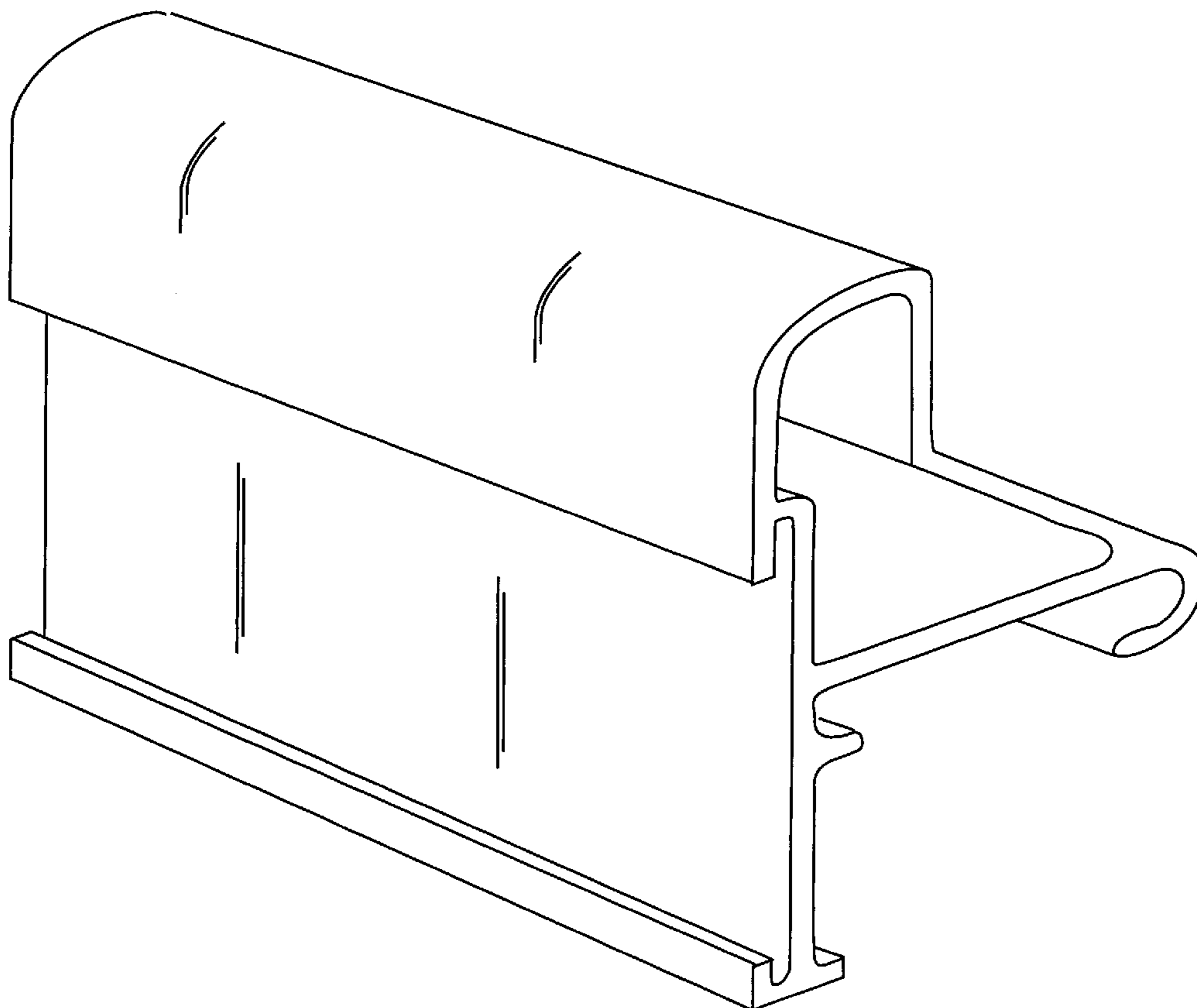
(57) **CLAIM**

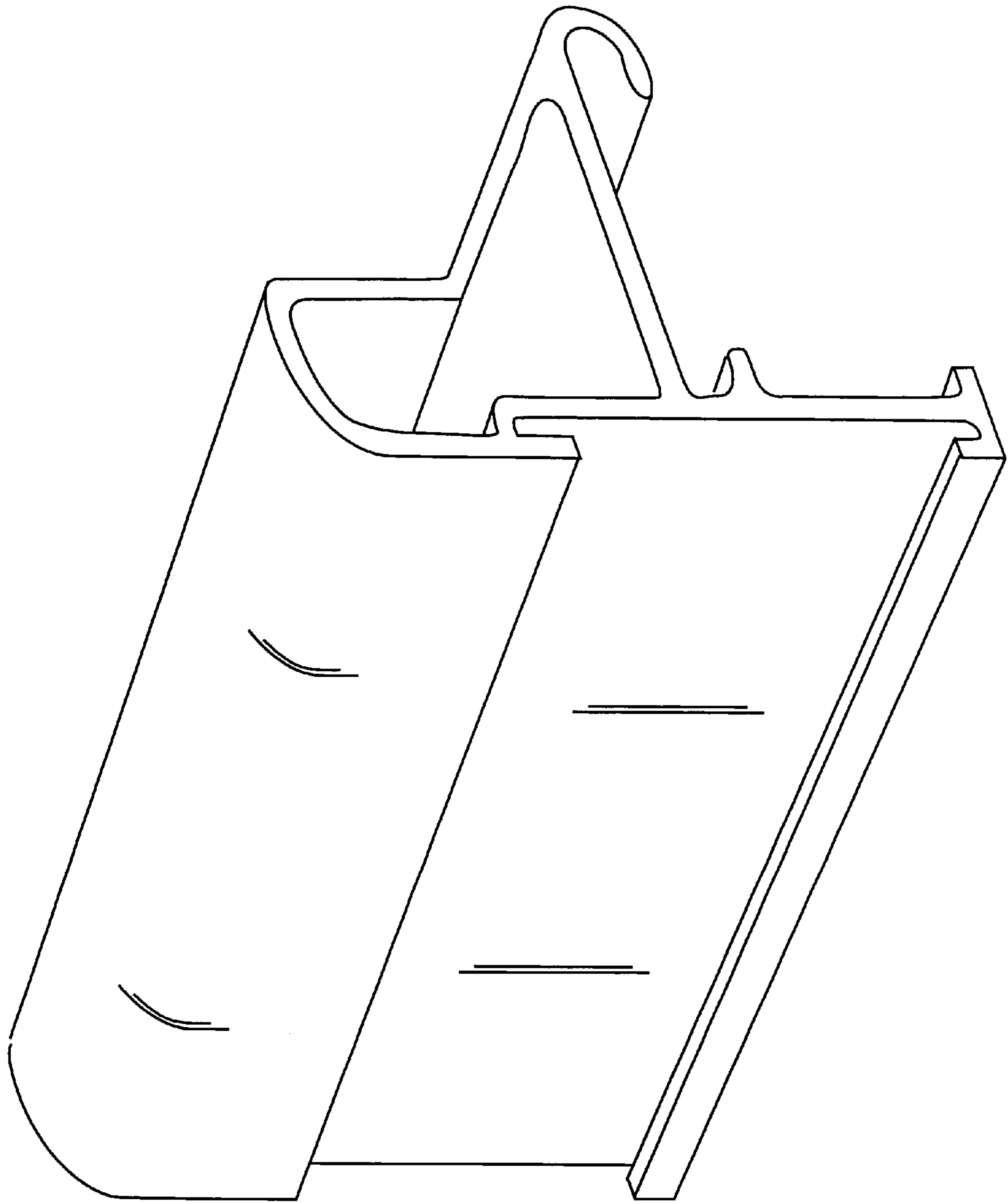

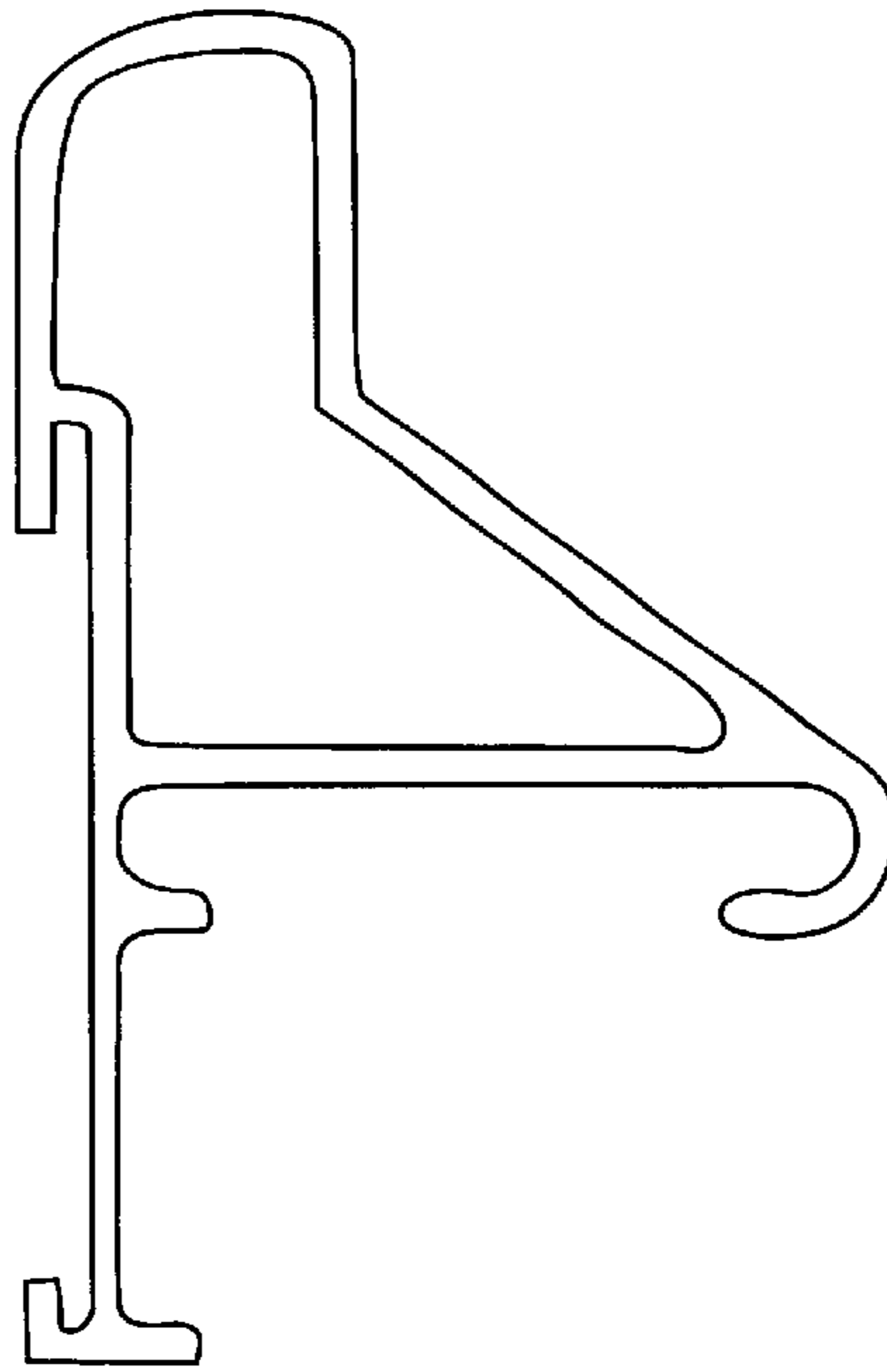


Fig 2 (Right)

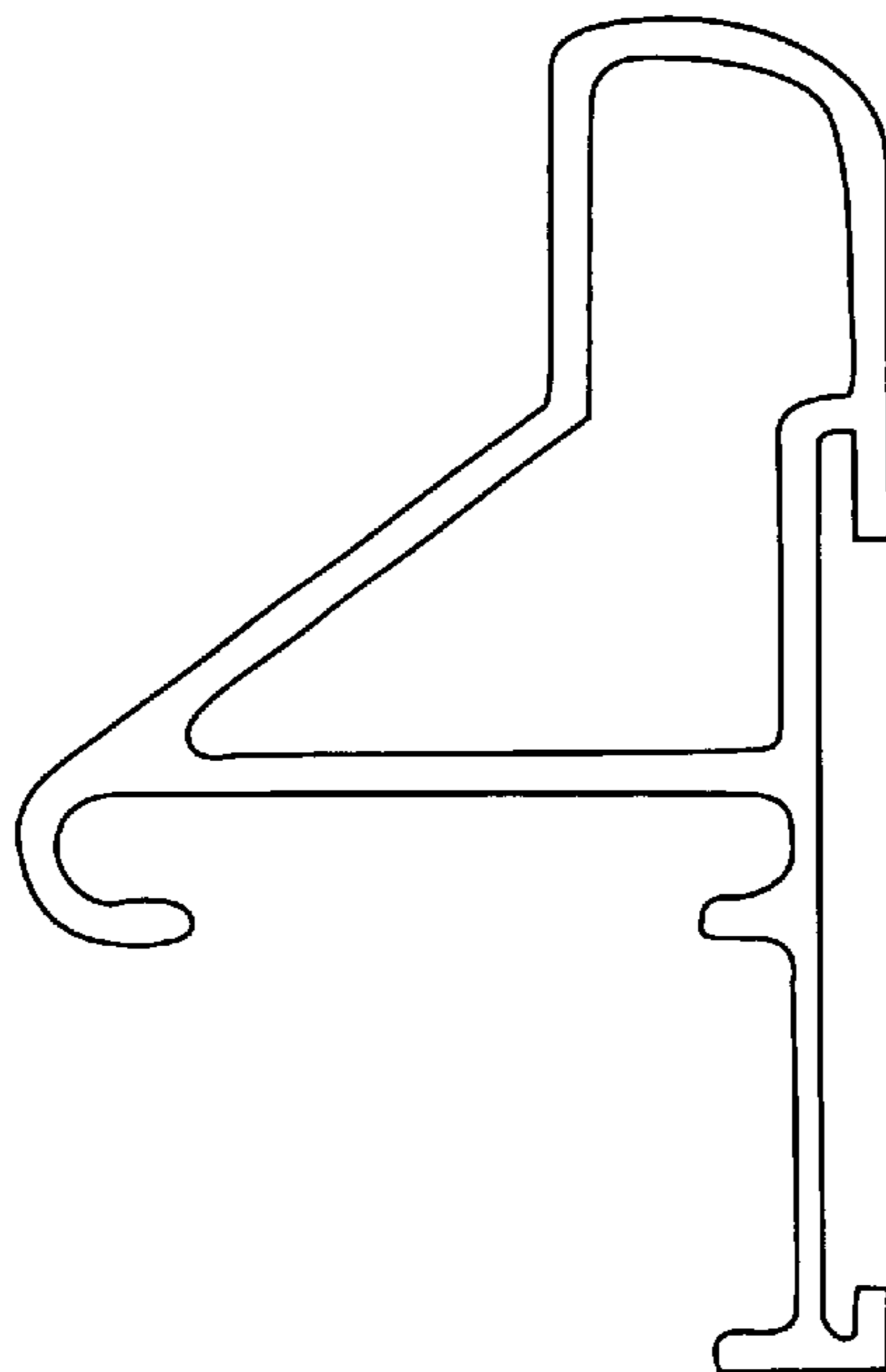

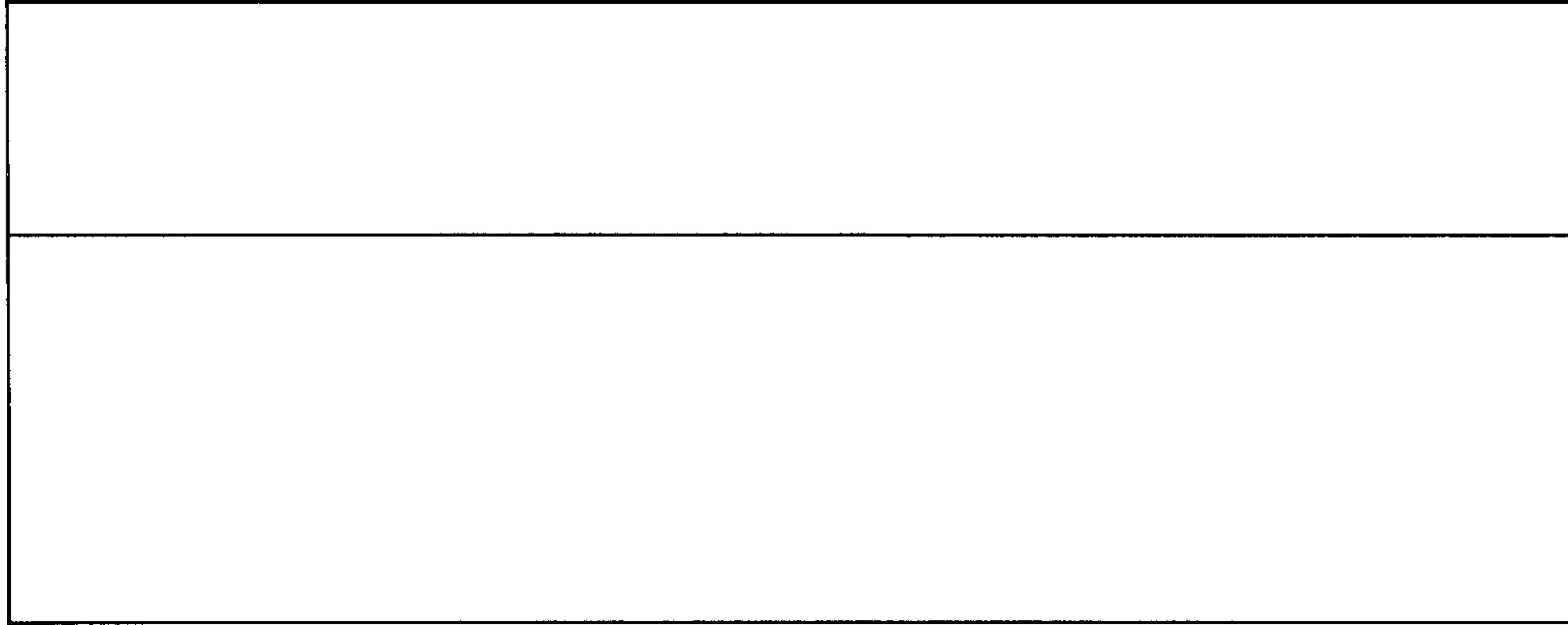

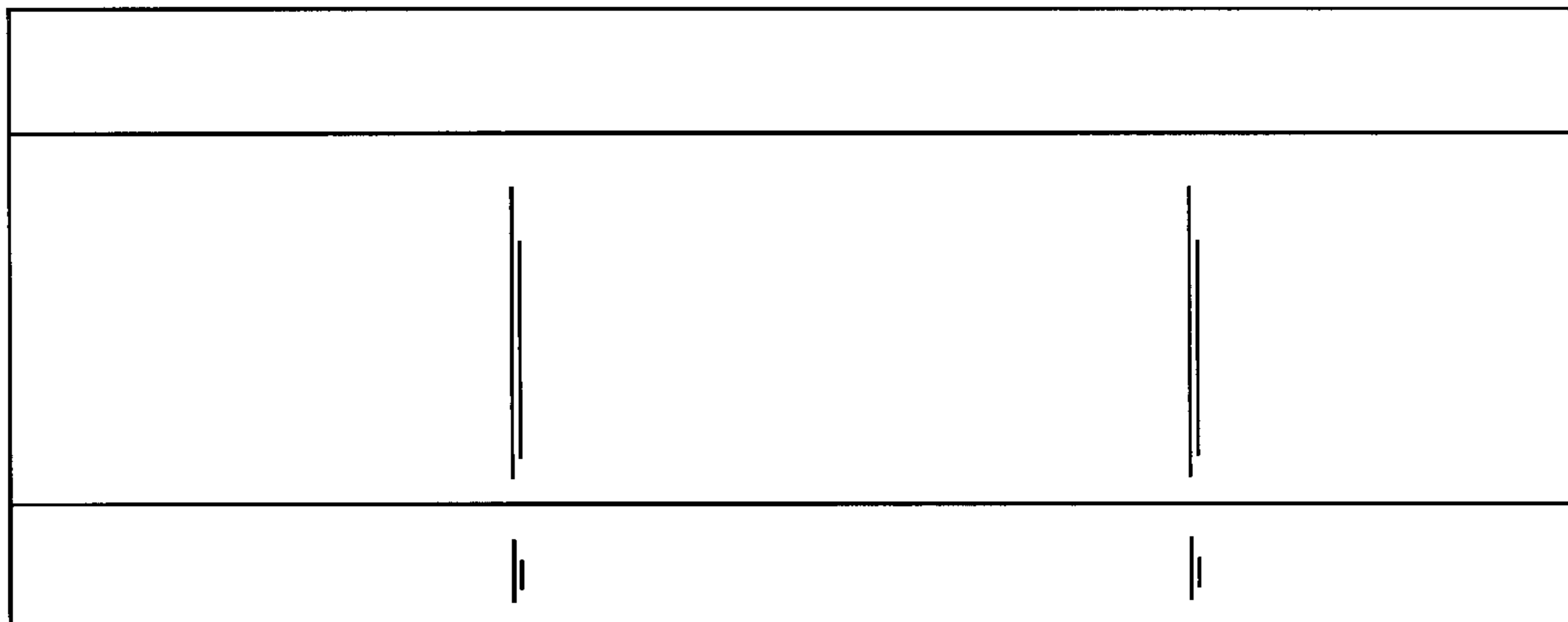


Fig 5 (Bottom)

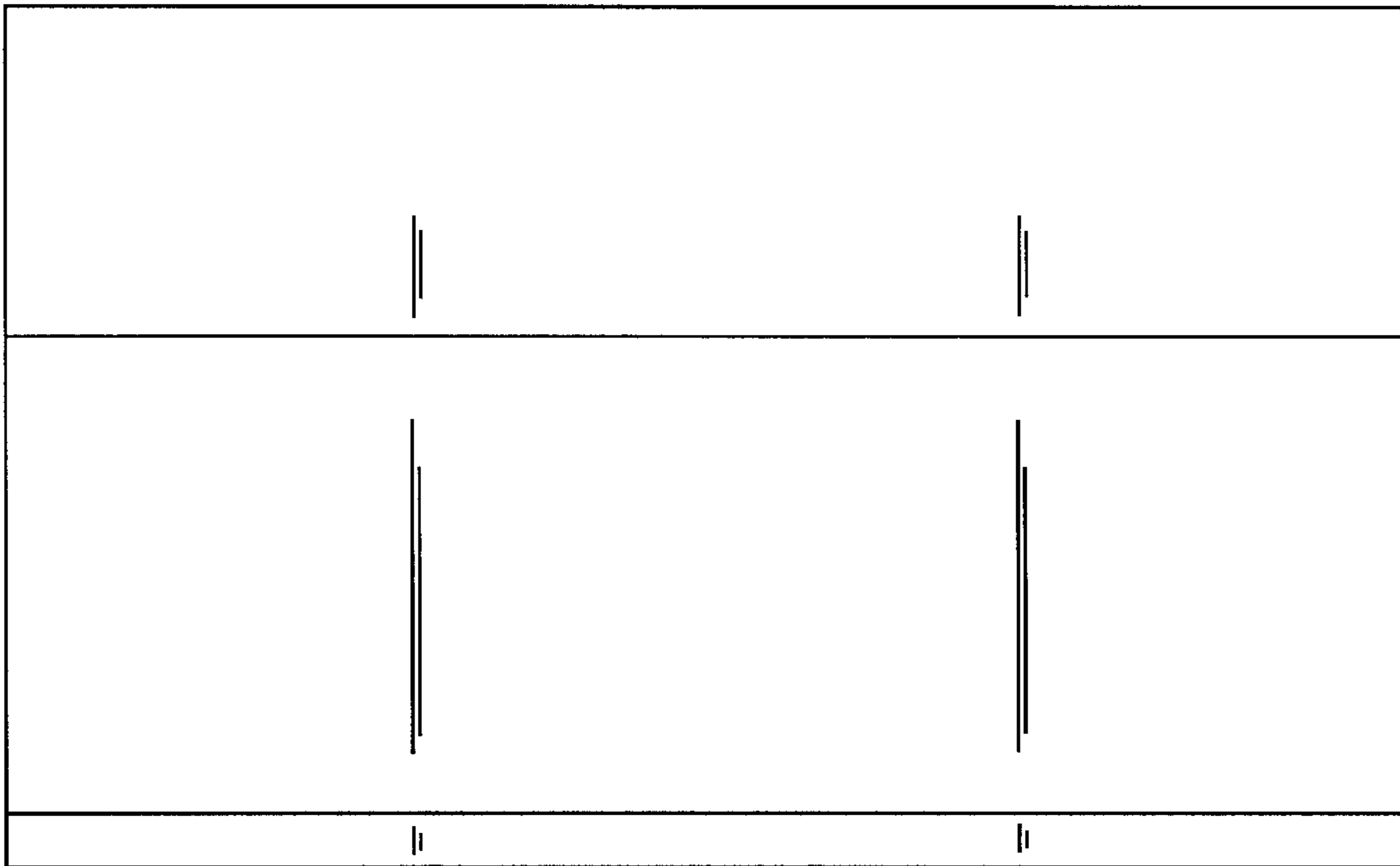


Fig 6 (Front)

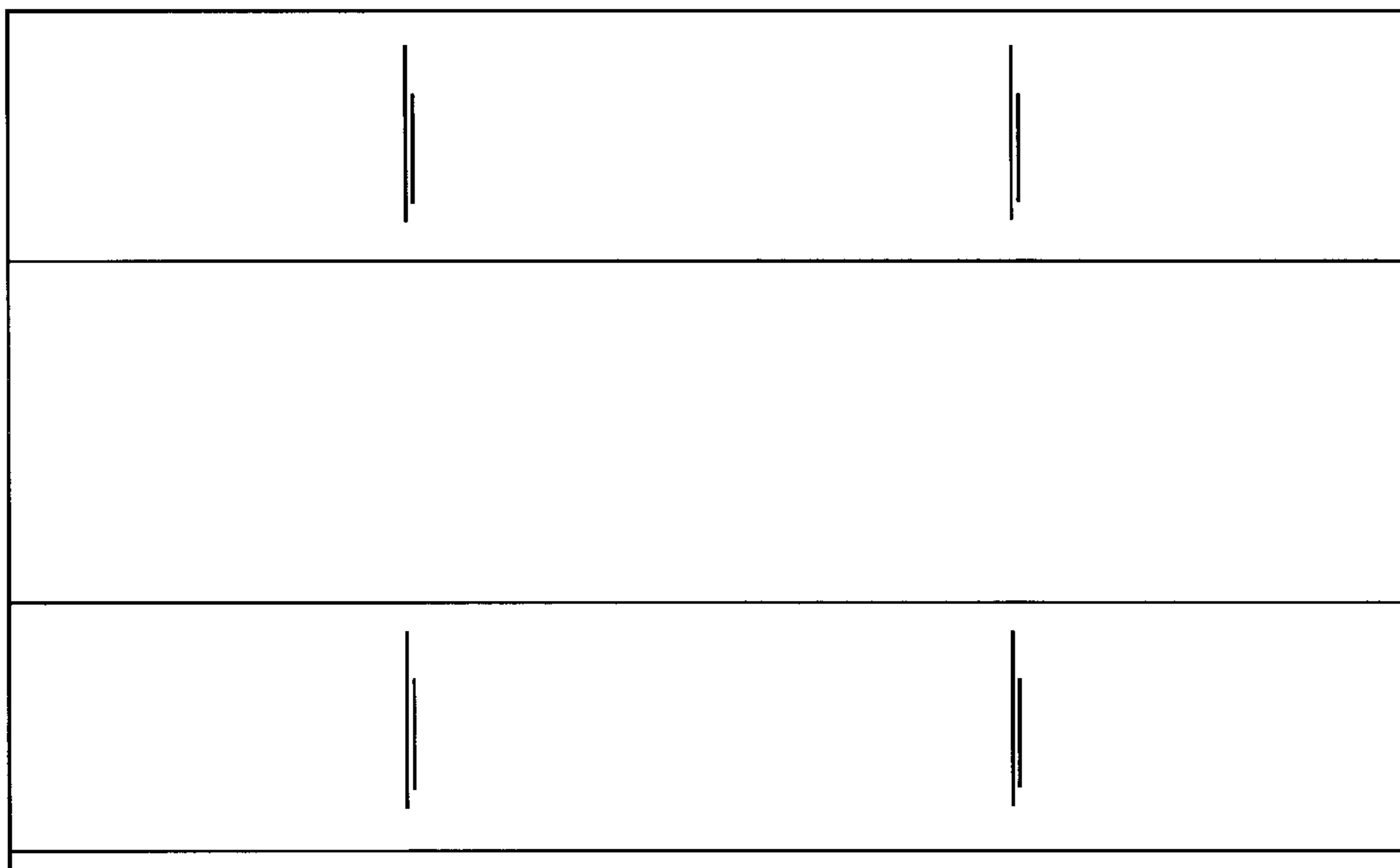
