The ornamental design for the case for a medical device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first embodiment of a case for a

medical device of our new design, where the top portion is transparent, and the article shown in dashed lines forms no part of the claimed design;

FIG. 2 is a rear view of the embodiment of FIG. 1, where the top portion is transparent, and the article shown in dashed lines forms no part of the claimed design;

FIG. 3 is an right side view of the embodiment of FIG. 1, where the top portion is transparent, and the article is shown in dashed lines forms no part of the claimed design;

FIG. 4 is a left side view of the embodiment of FIG. 1, where the top portion is transparent, and the article shown in dashed lines forms no part of the claimed design;

FIG. 5 is a top view of the embodiment of FIG. 1, where the top portion is transparent, and the article shown in dashed lines forms no part of the claimed design;

FIG. 6 is a bottom view of the embodiment of FIG. 1;

FIG. 7 is a front perspective view of the embodiment of FIG. 1 with the transparent lid open, the article shown in dashed lines forming no part of the claimed design;

FIG. 8 is a front view of a second embodiment of a case for a medical device of our new design, where the top portion is opaque;

FIG. 9 is a rear view of the embodiment of FIG. 8;

FIG. 10 is an right side view of the embodiment of FIG. 8;

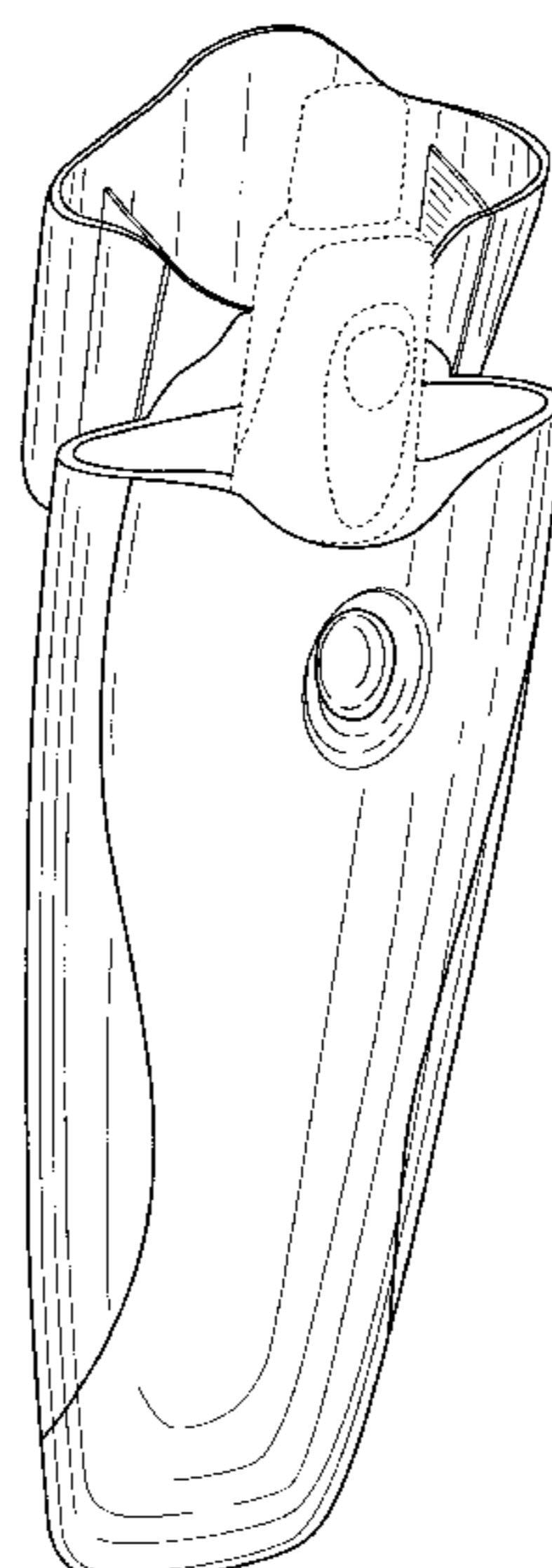
FIG. 11 is a left side view of the embodiment of FIG. 8;

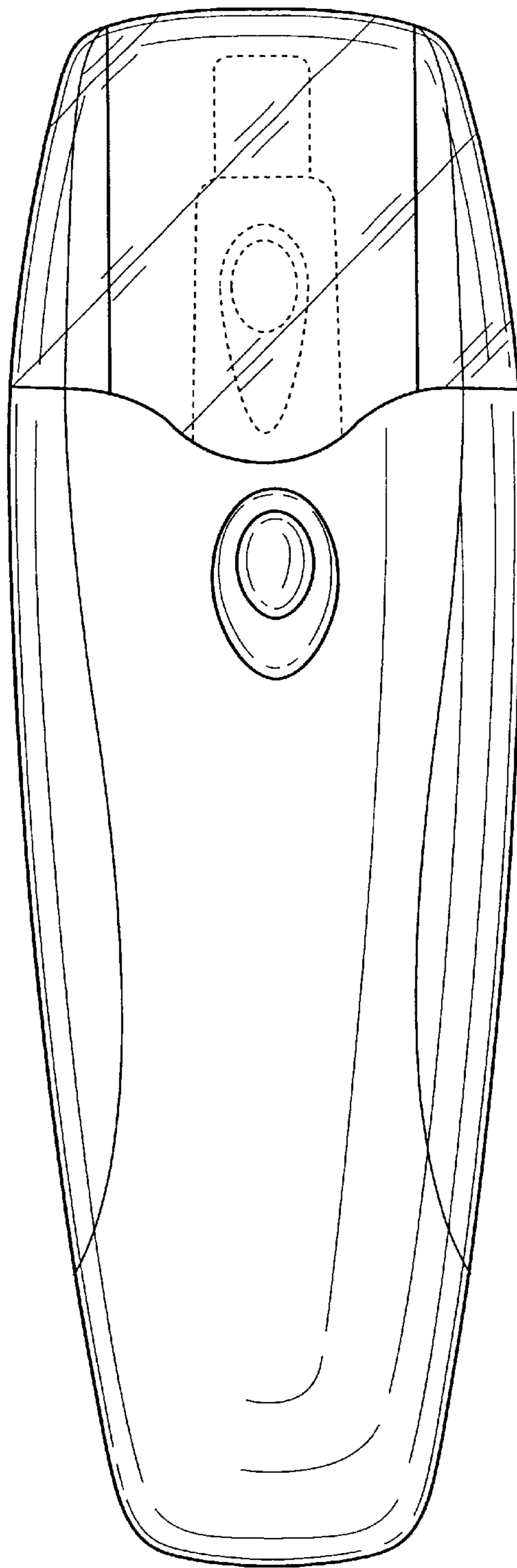
FIG. 12 is a top view of the embodiment of FIG. 8;

FIG. 13 is a bottom view of the embodiment of FIG. 8; and,

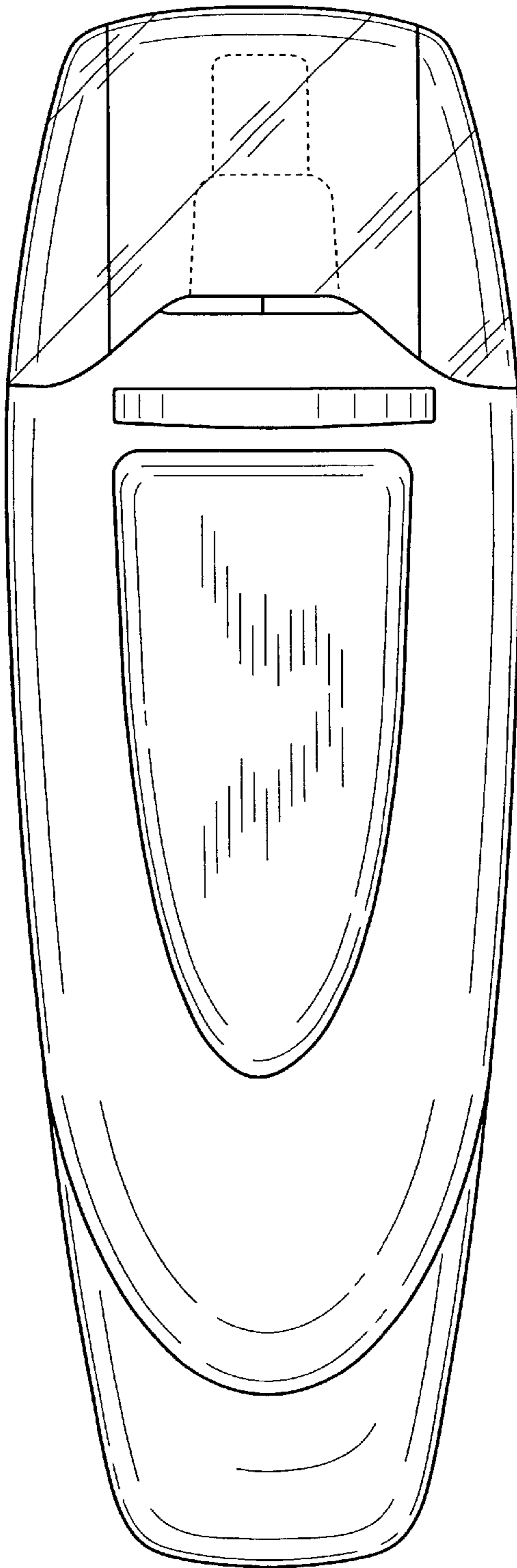
FIG. 14 is a front perspective view of the embodiment of FIG. 8 with the lid open, the article shown in dashed lines forming no part of the claimed design.

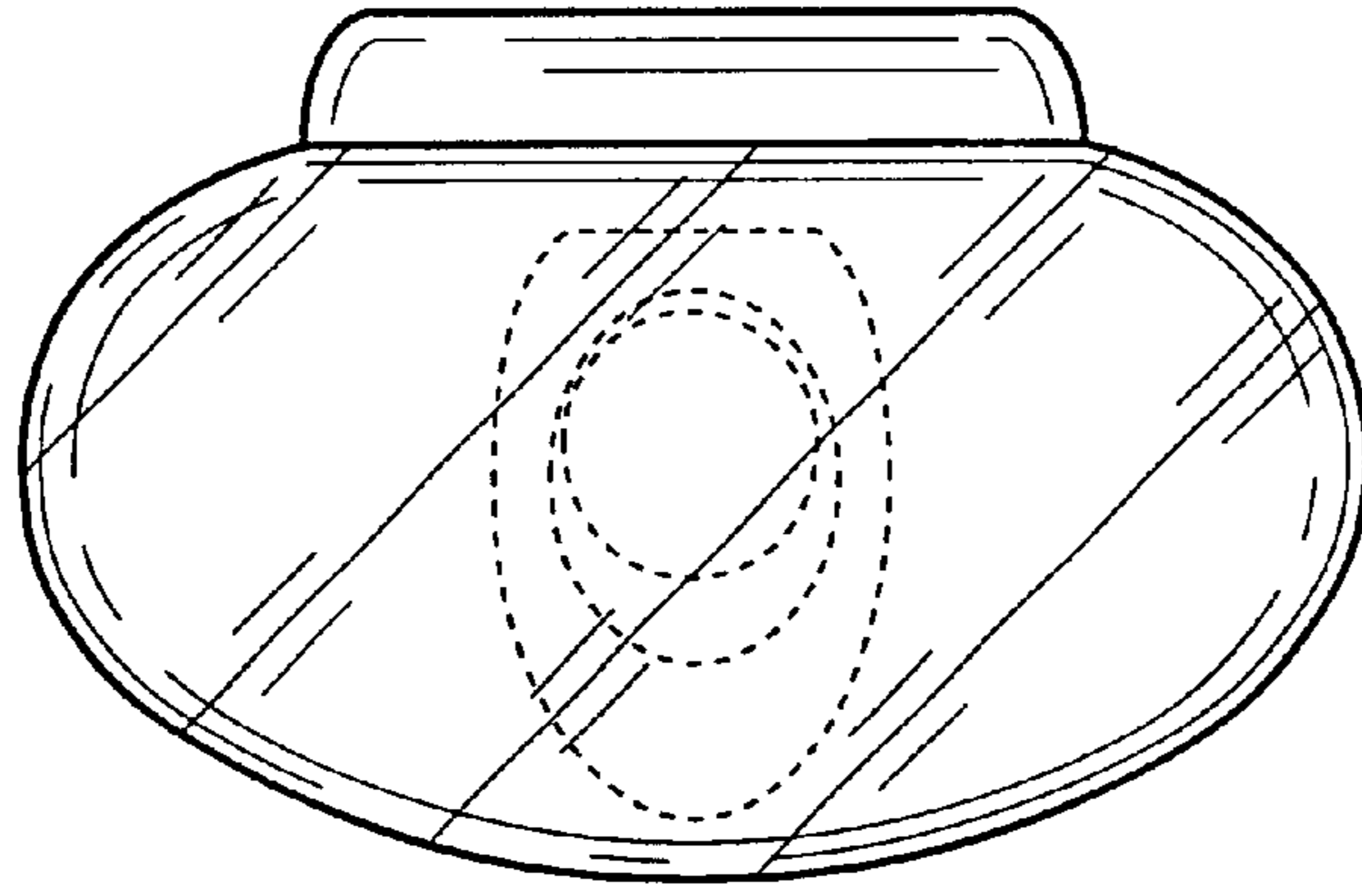

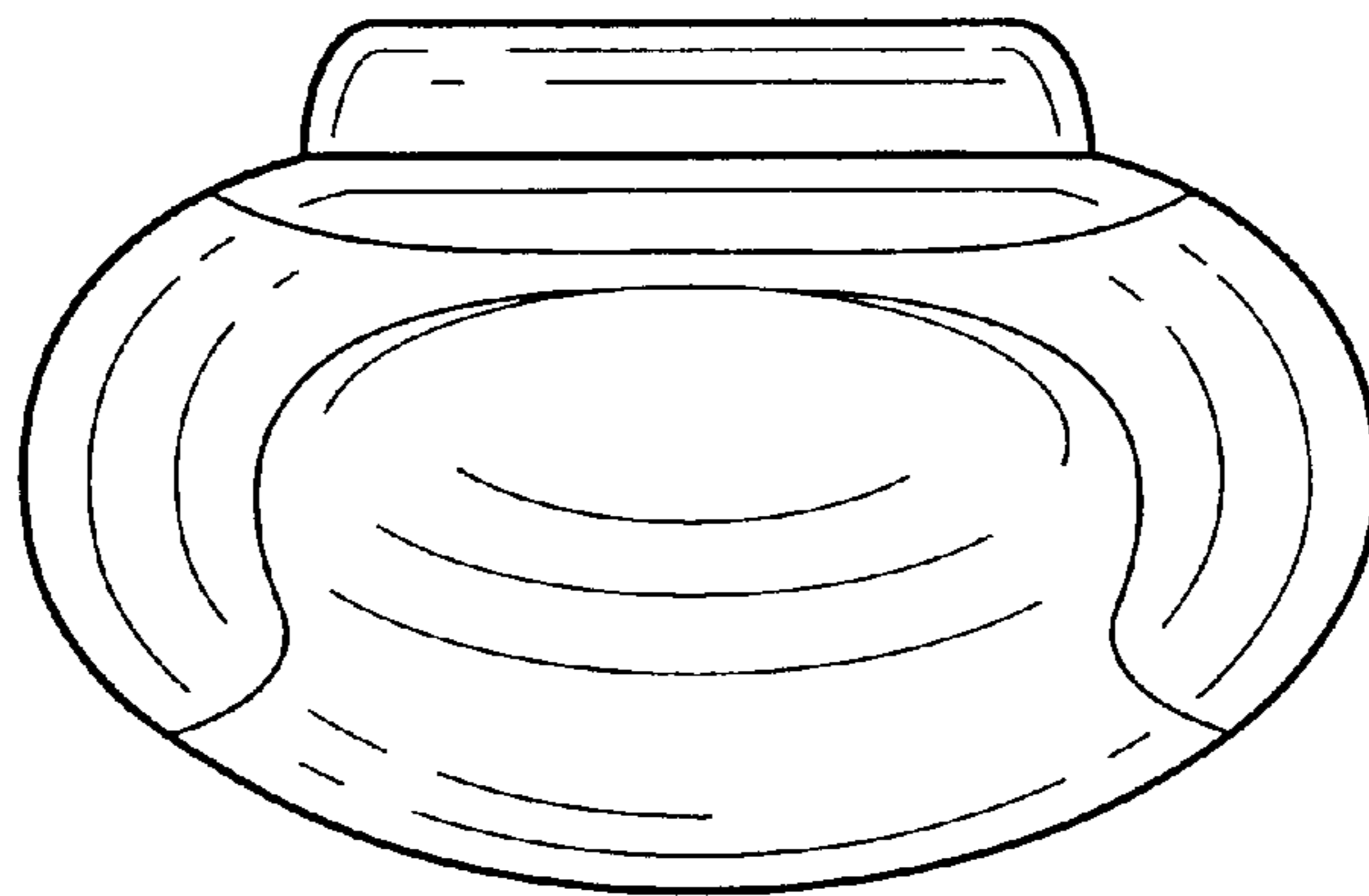

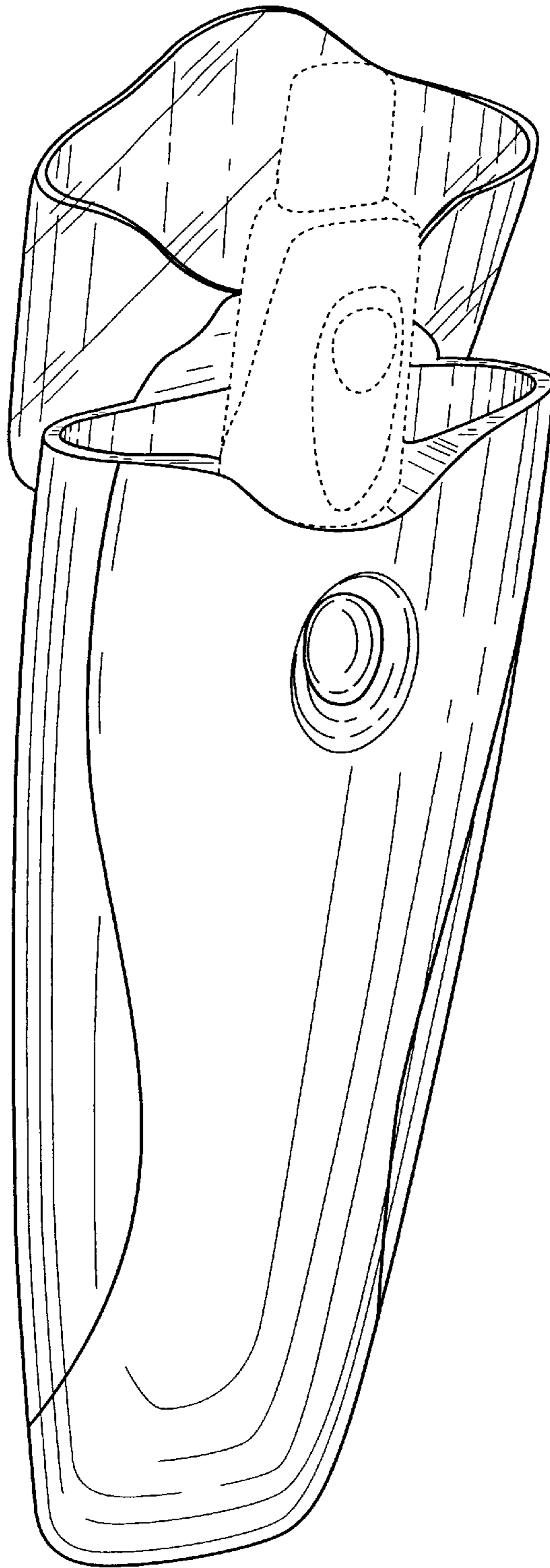

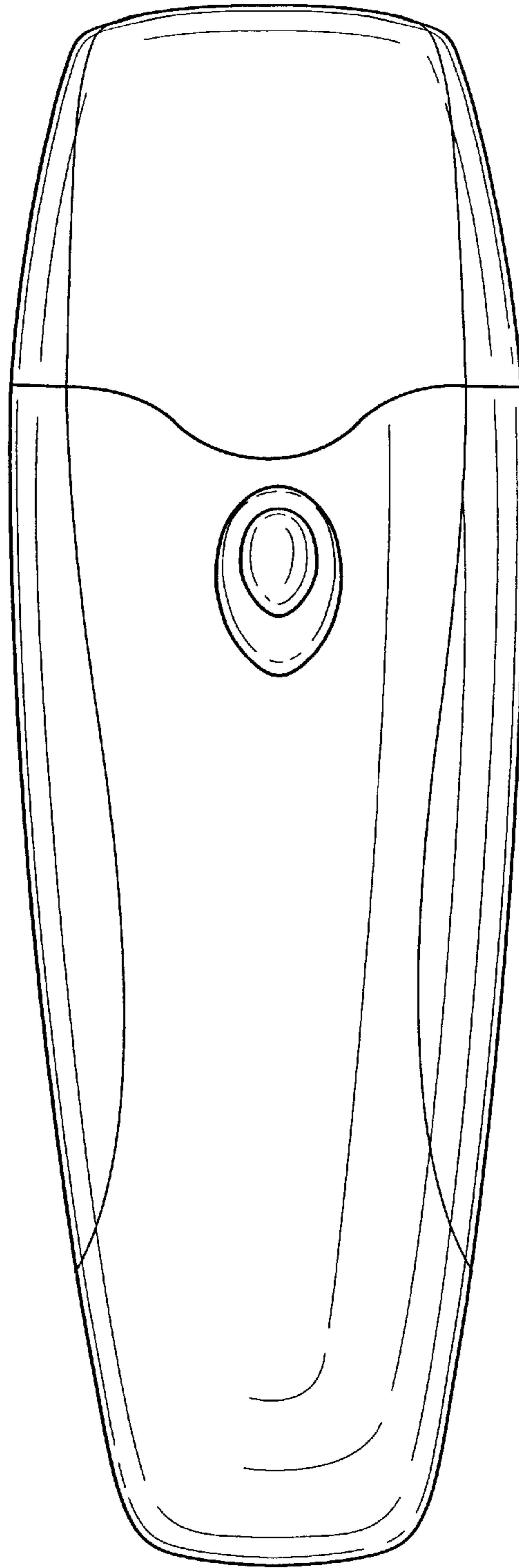

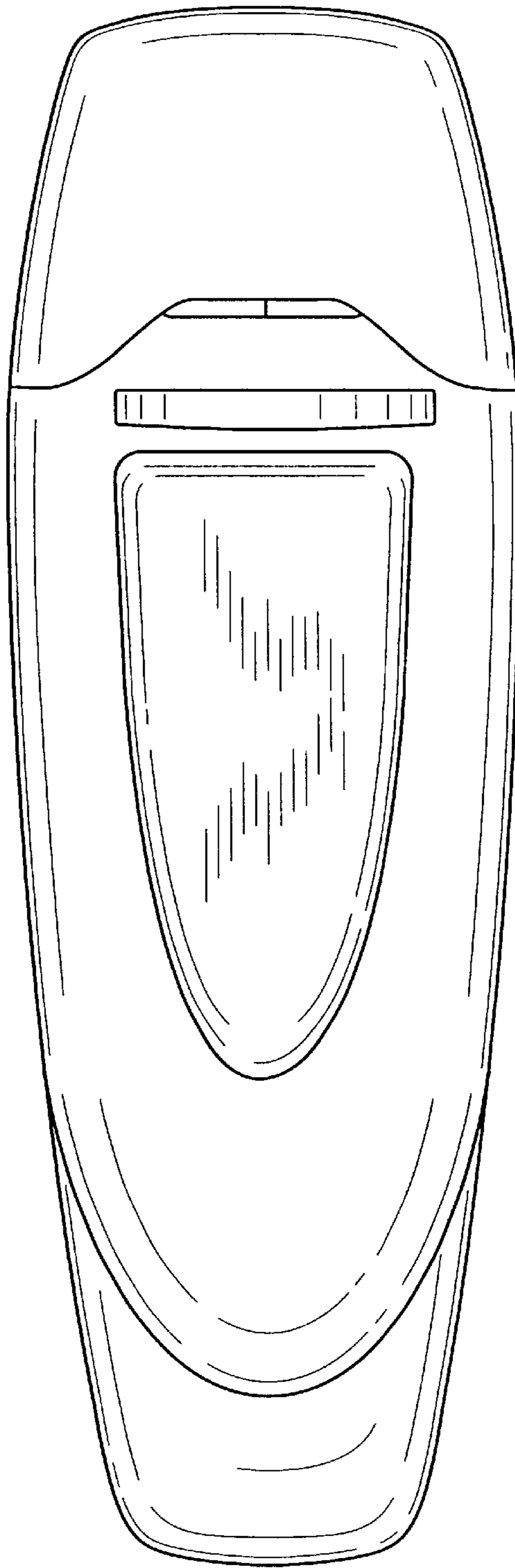

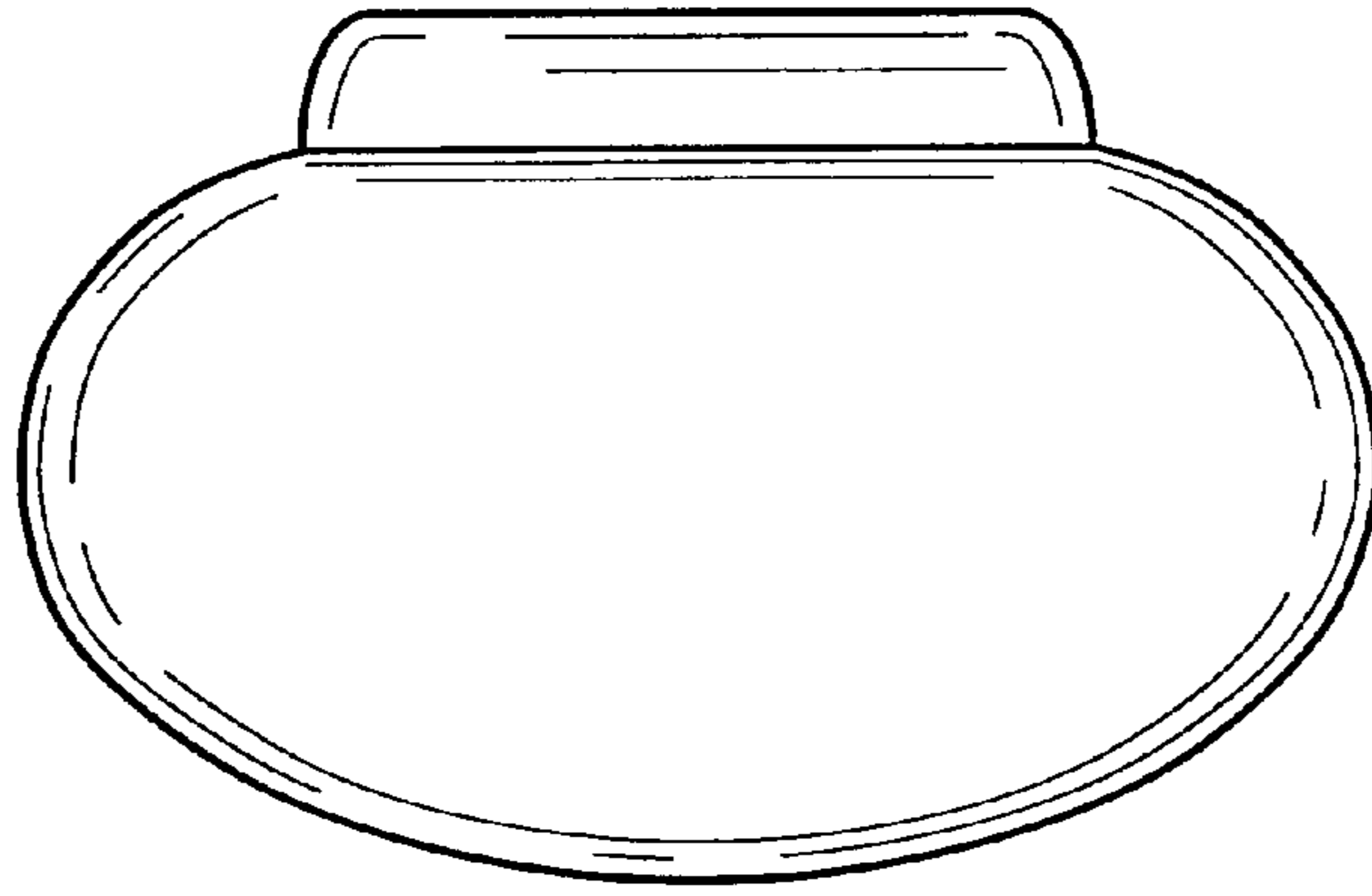




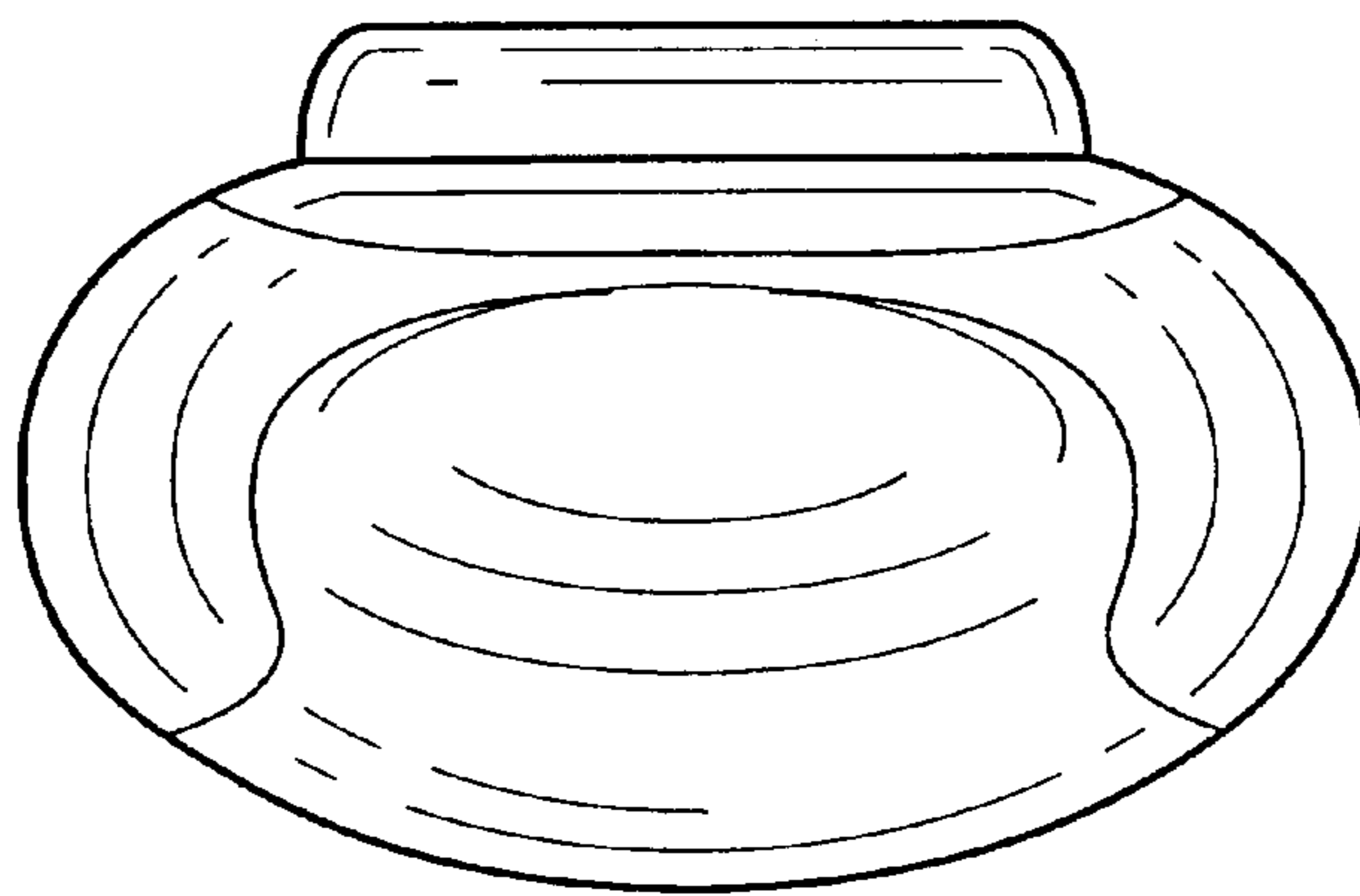

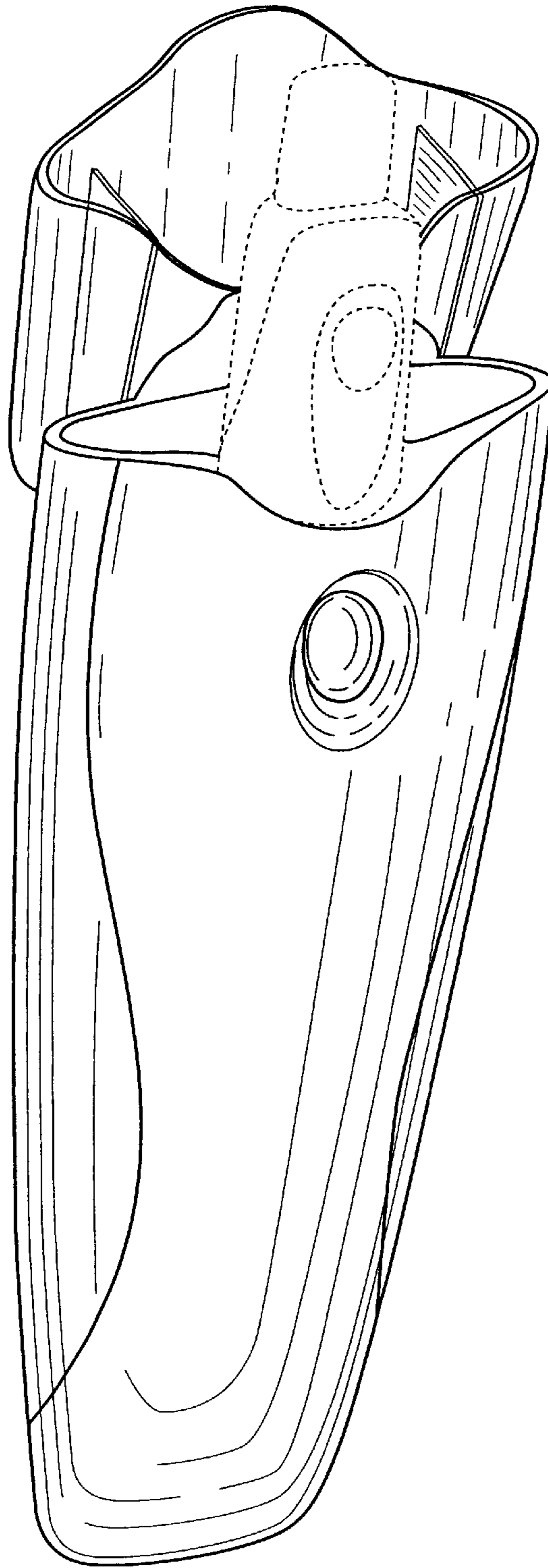
