8; and,

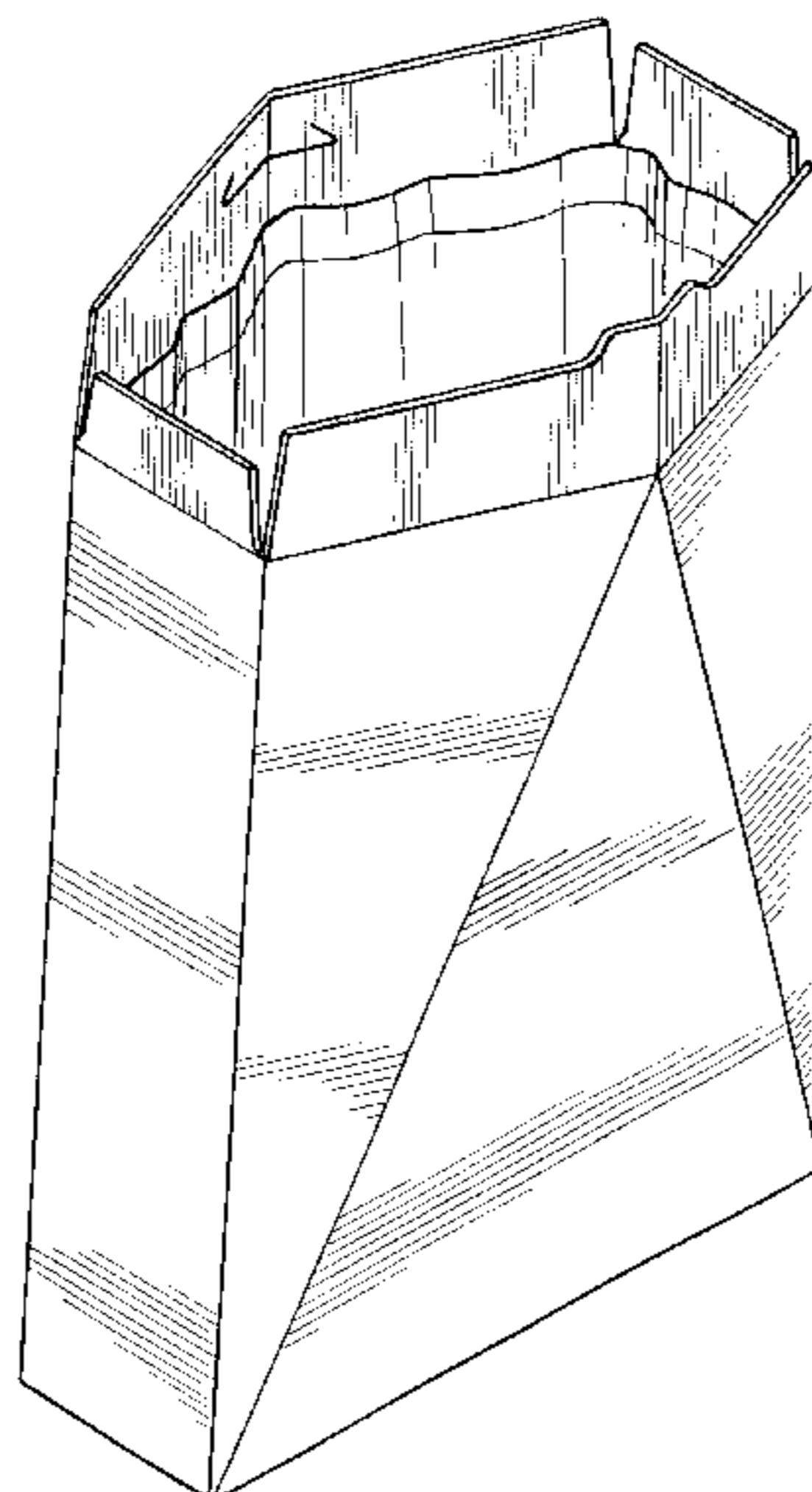
FIG. 14 is a bottom view of the alternative embodiment of

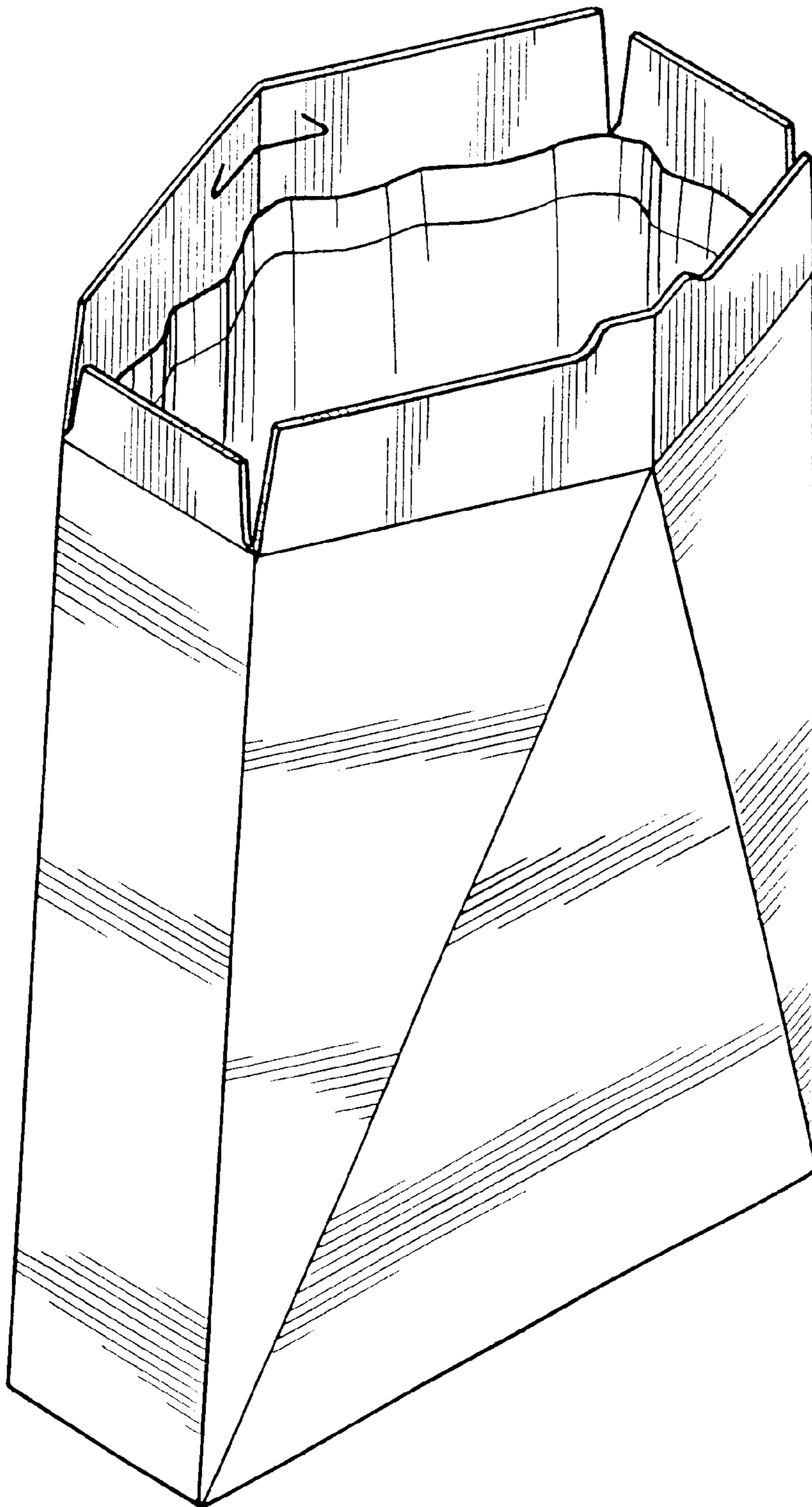

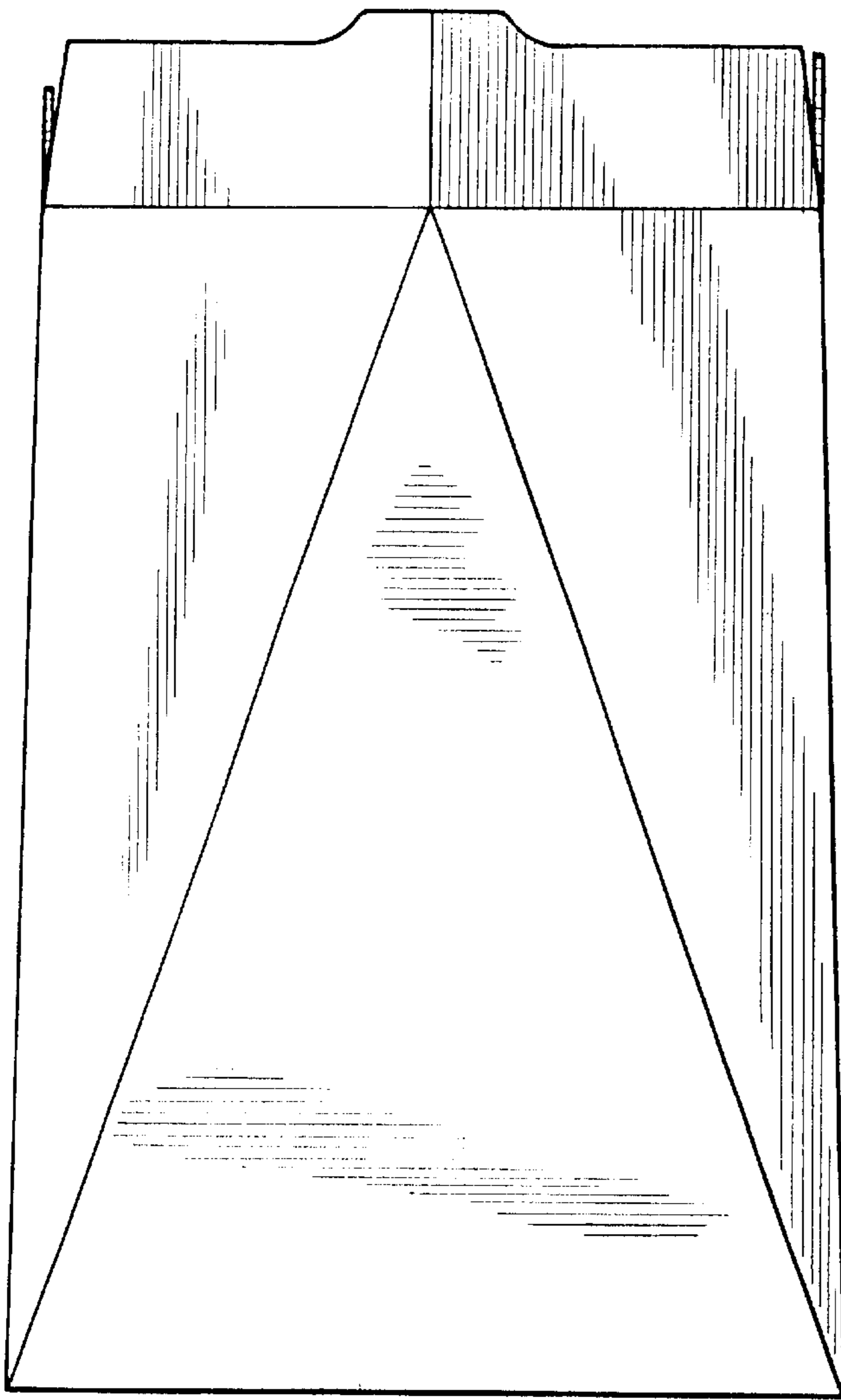

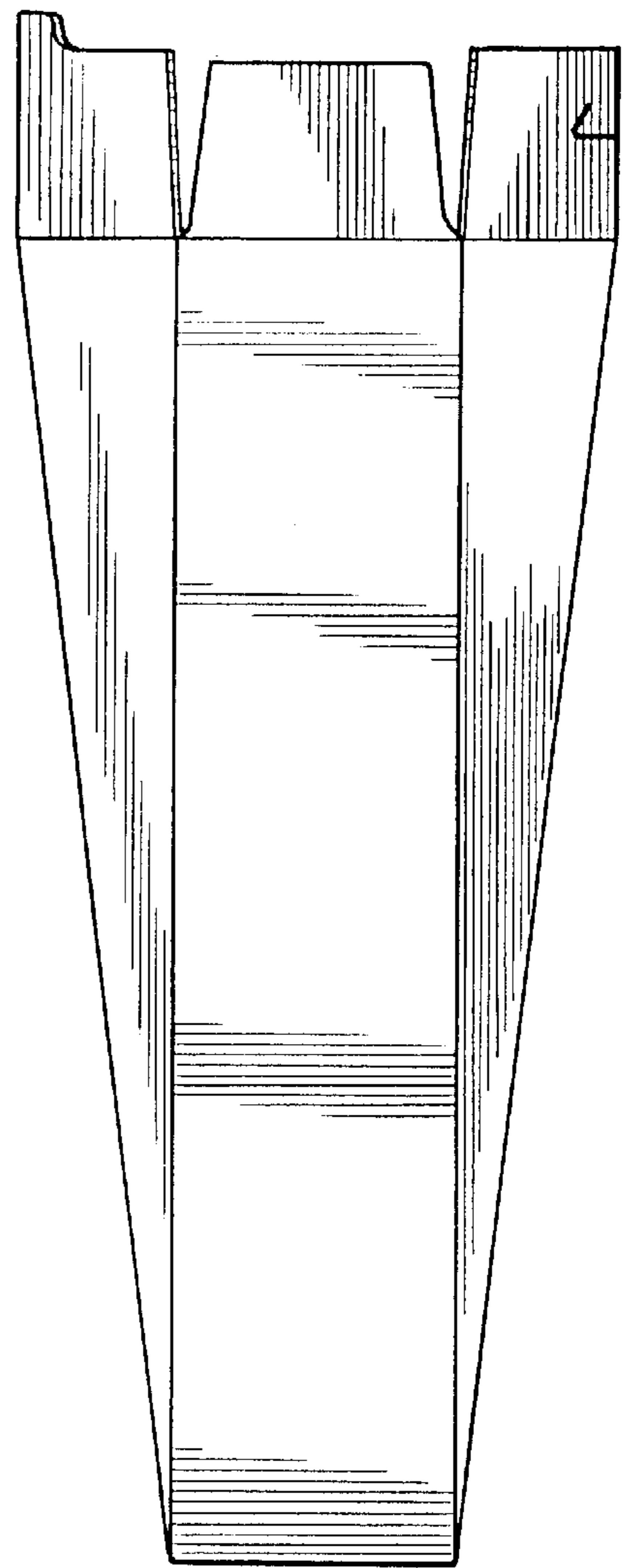

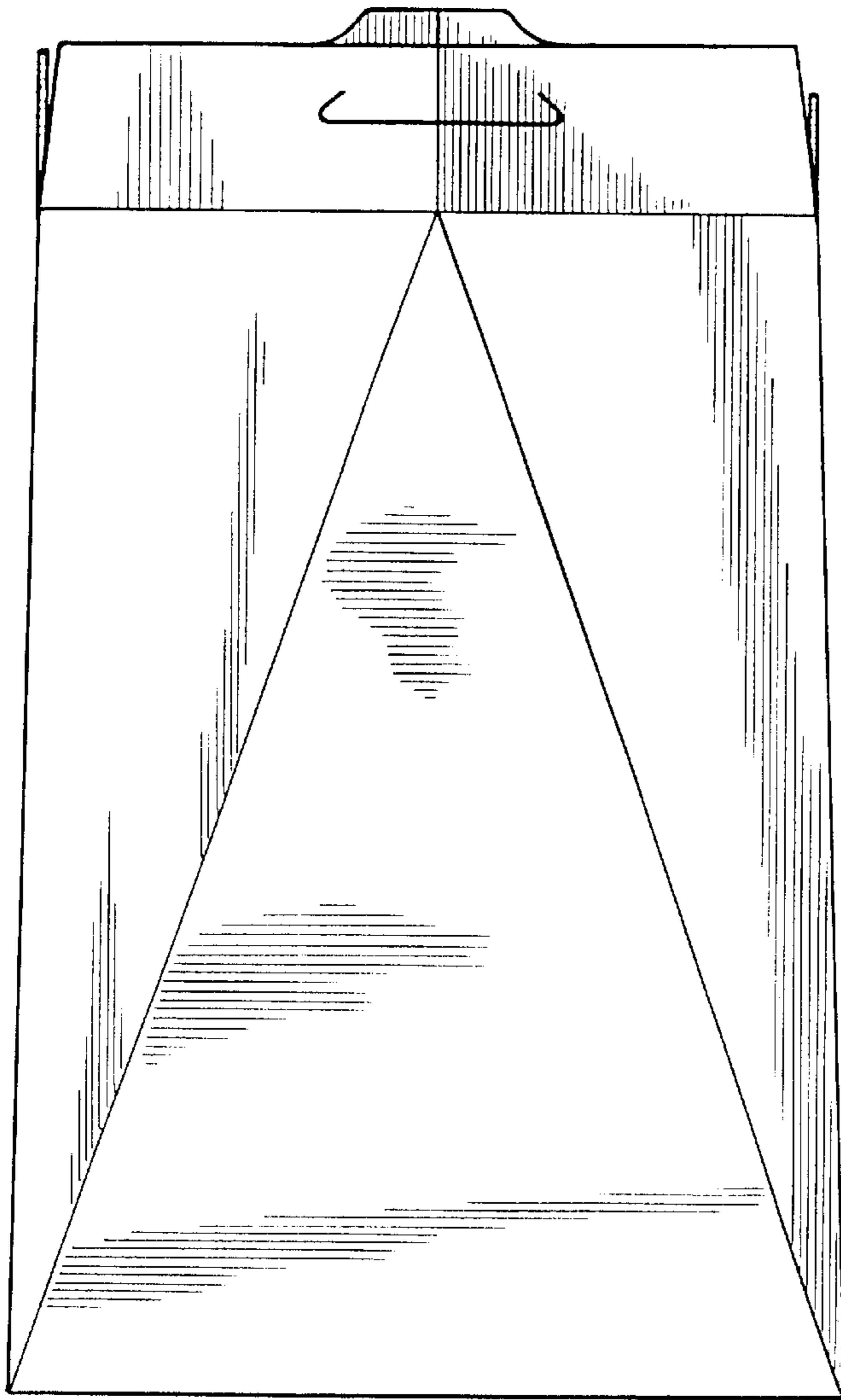

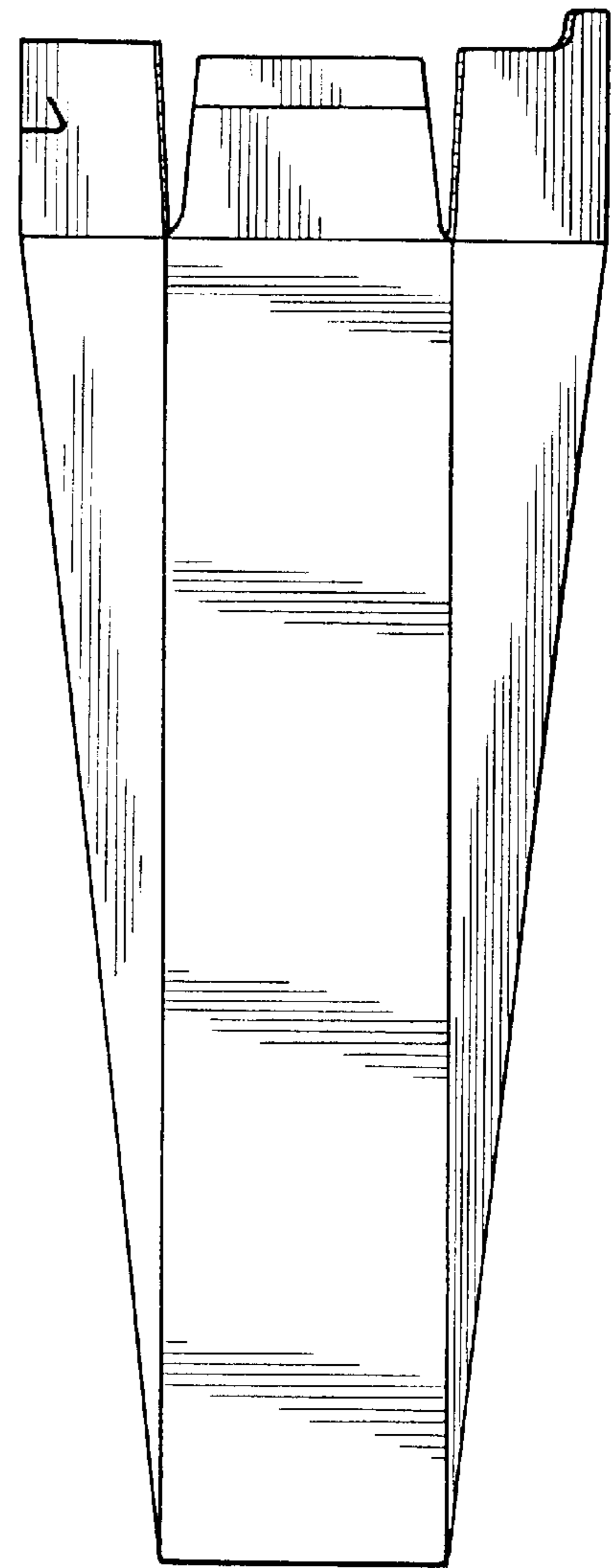

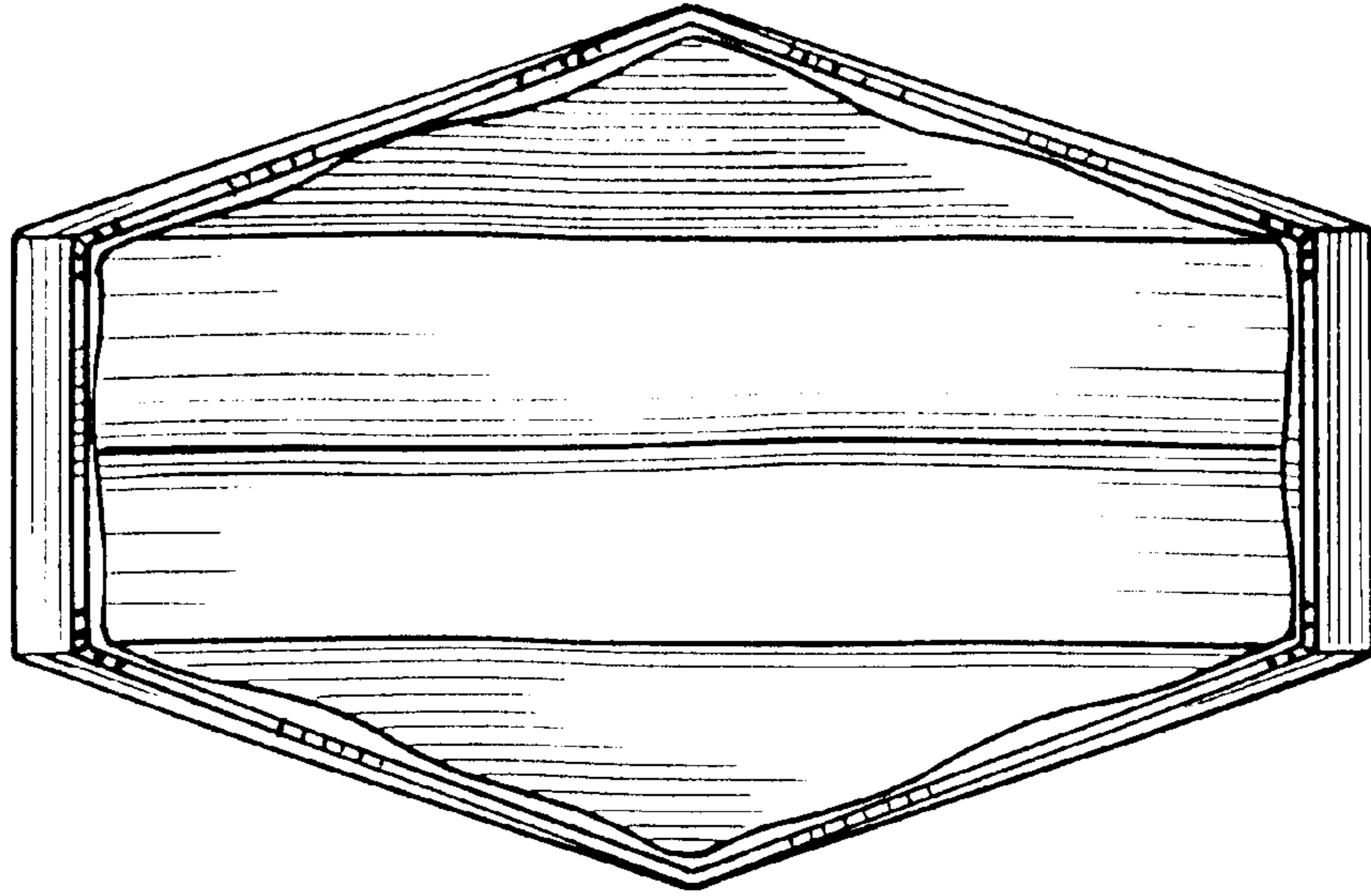

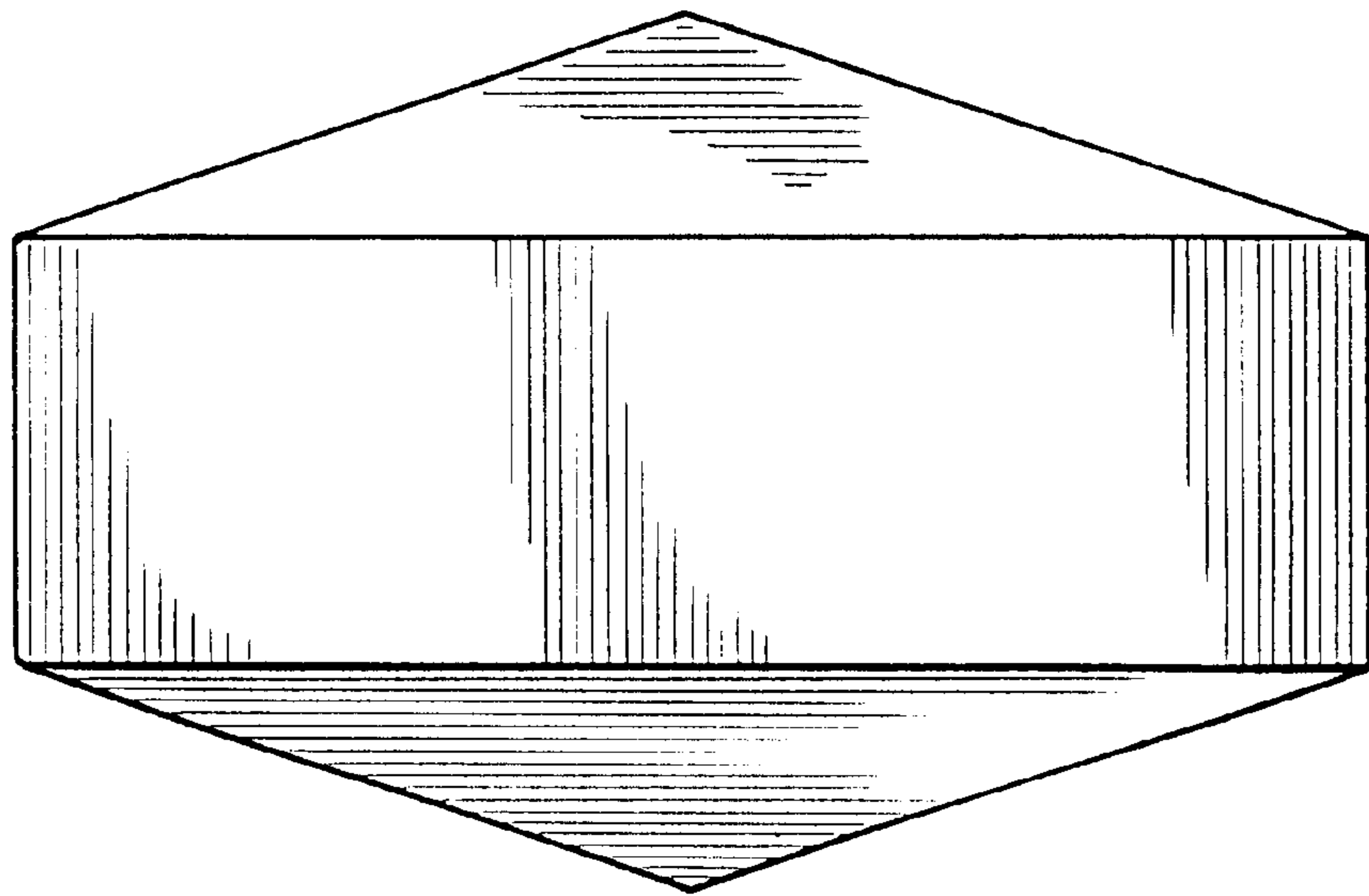

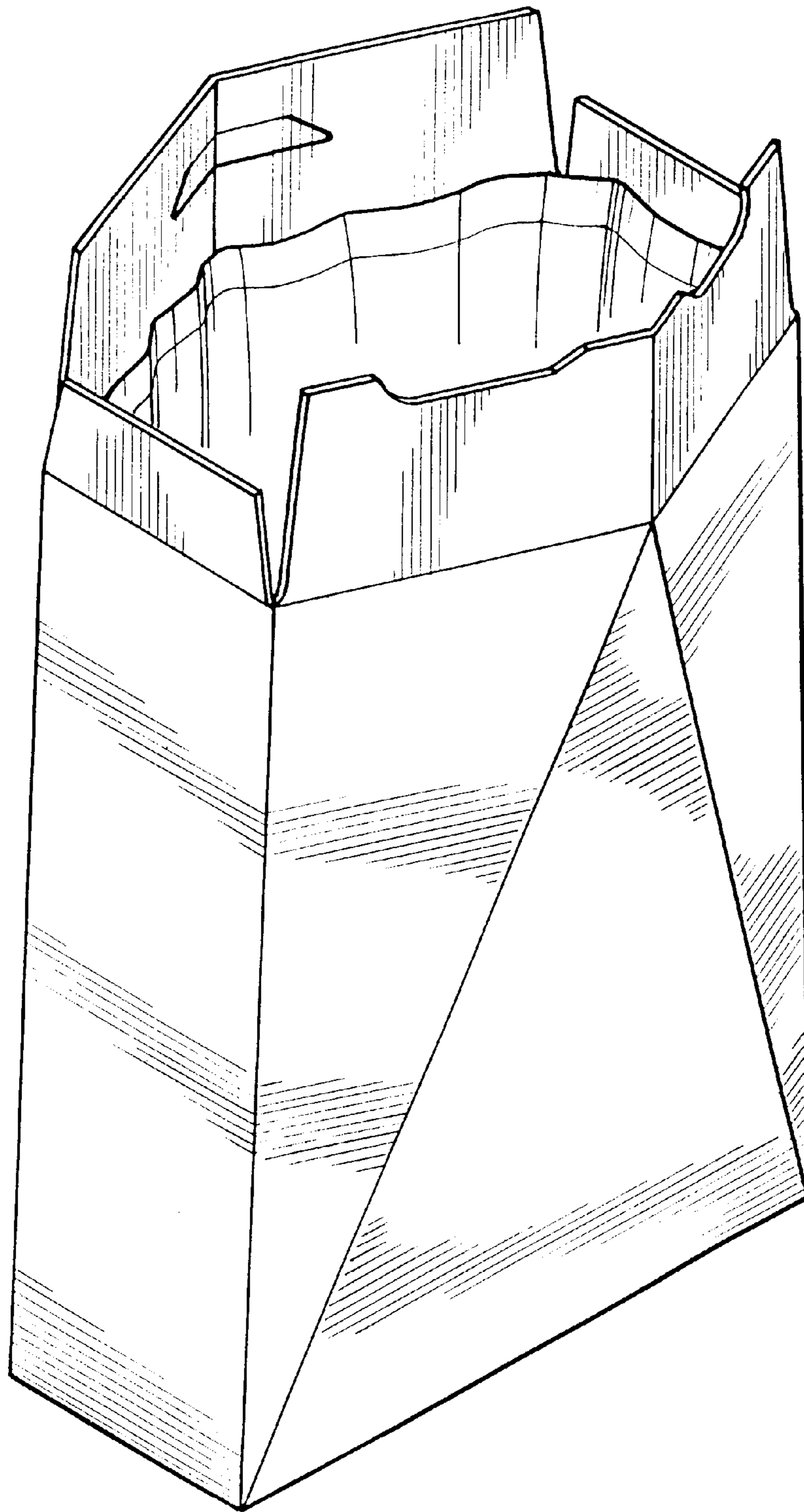

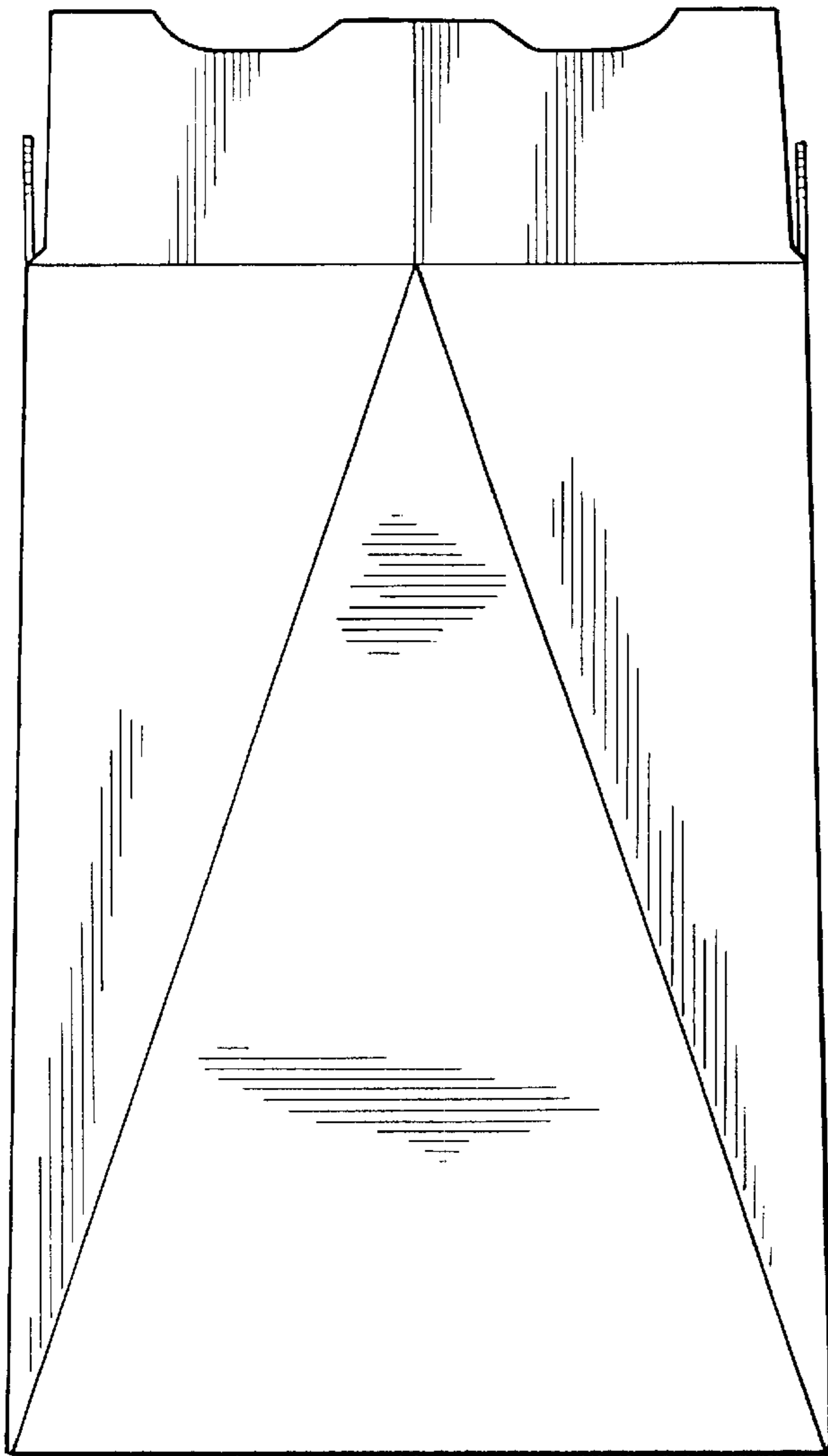

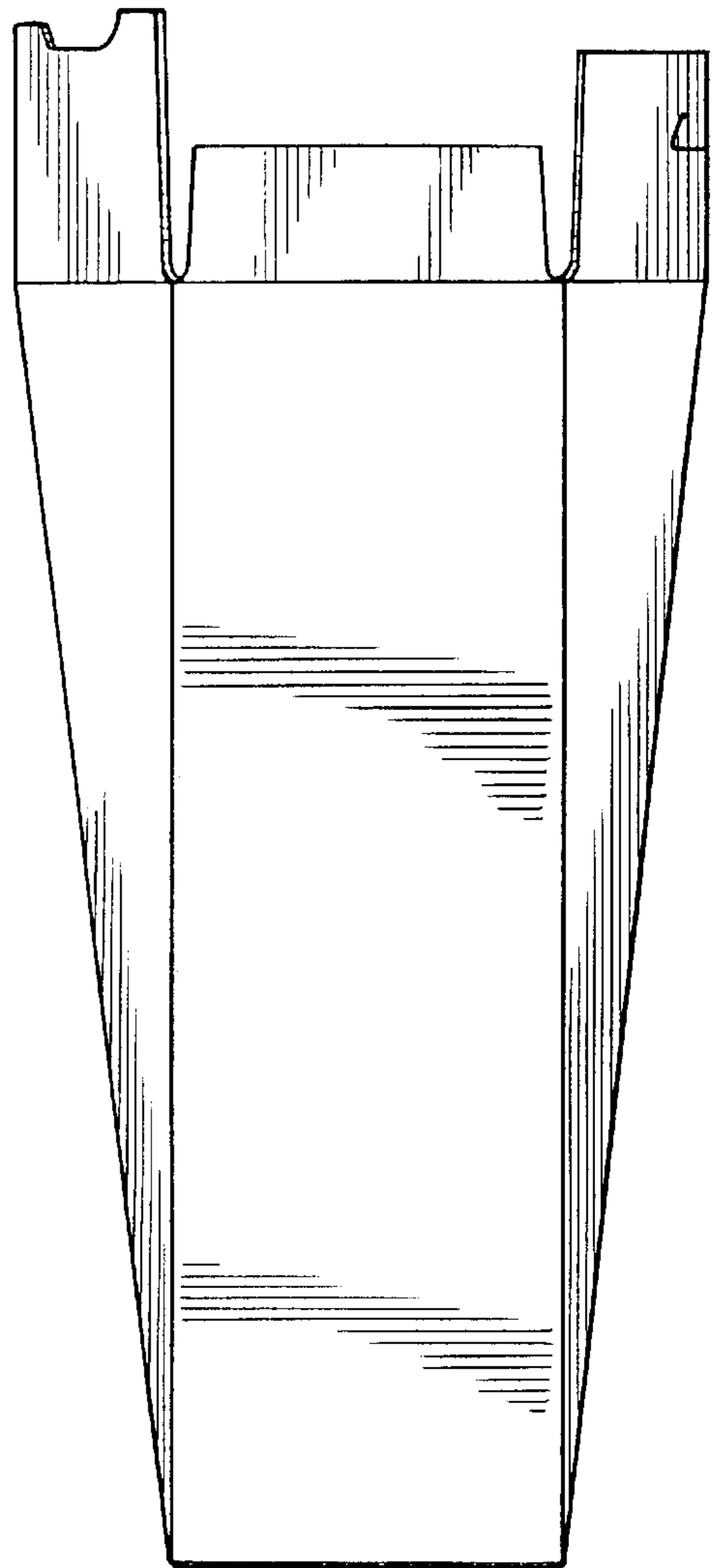

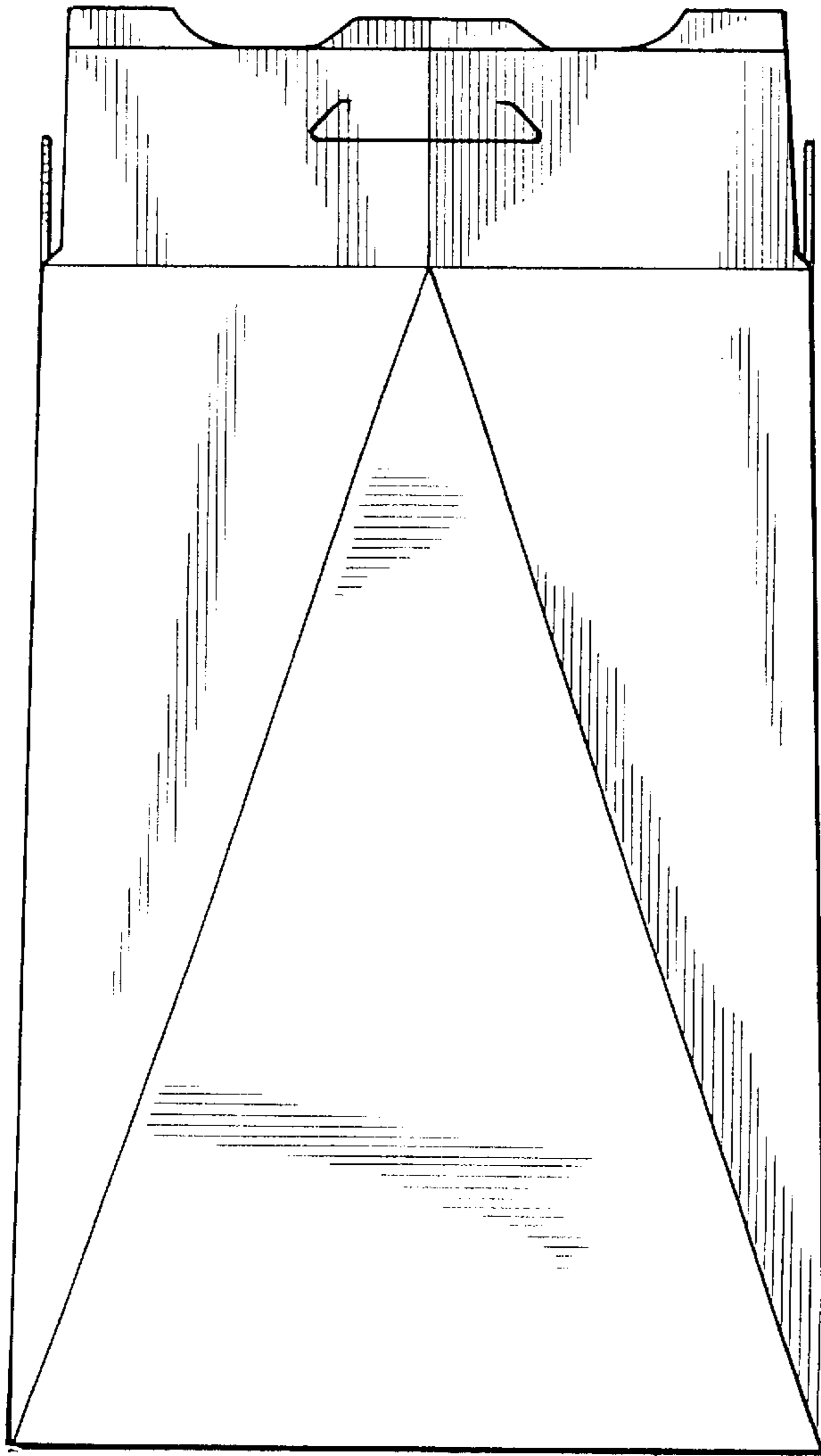

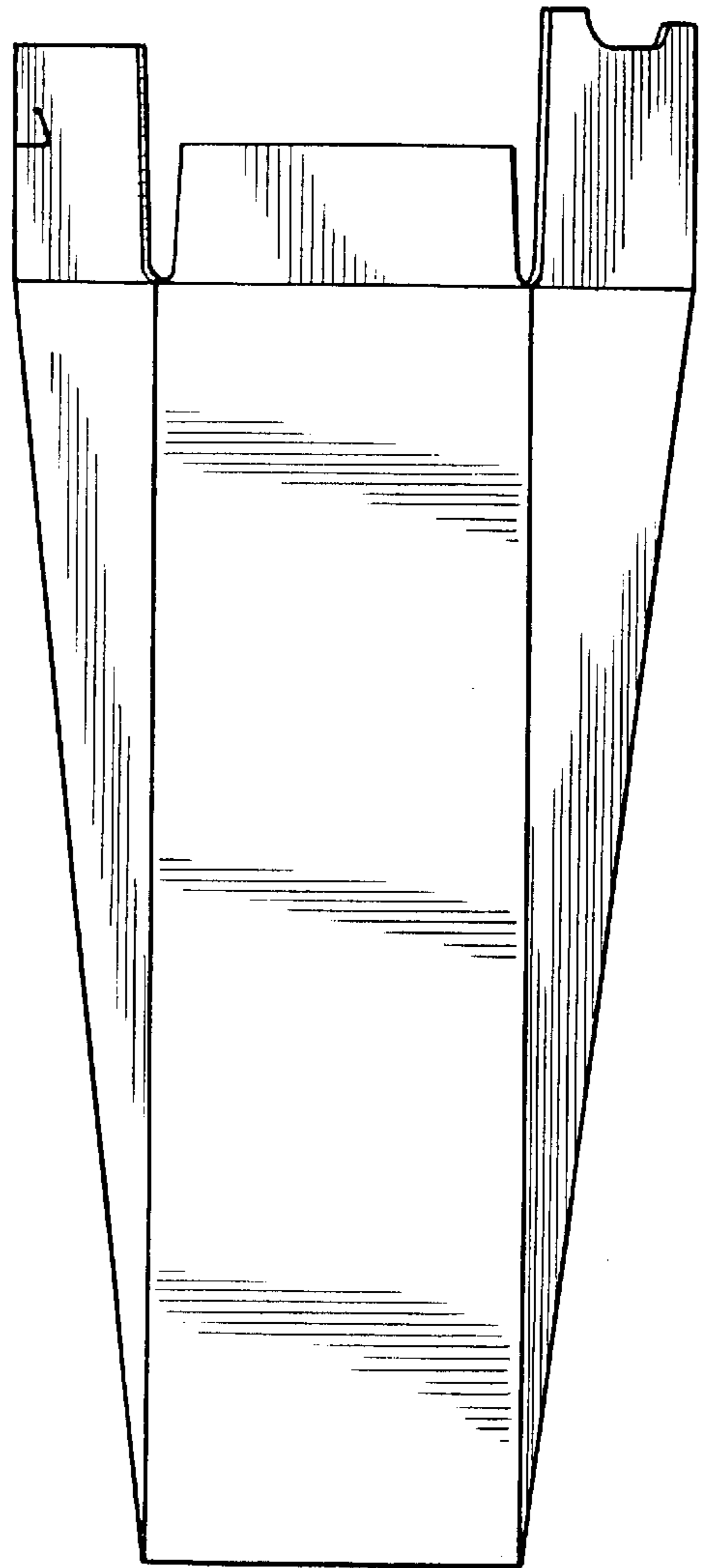

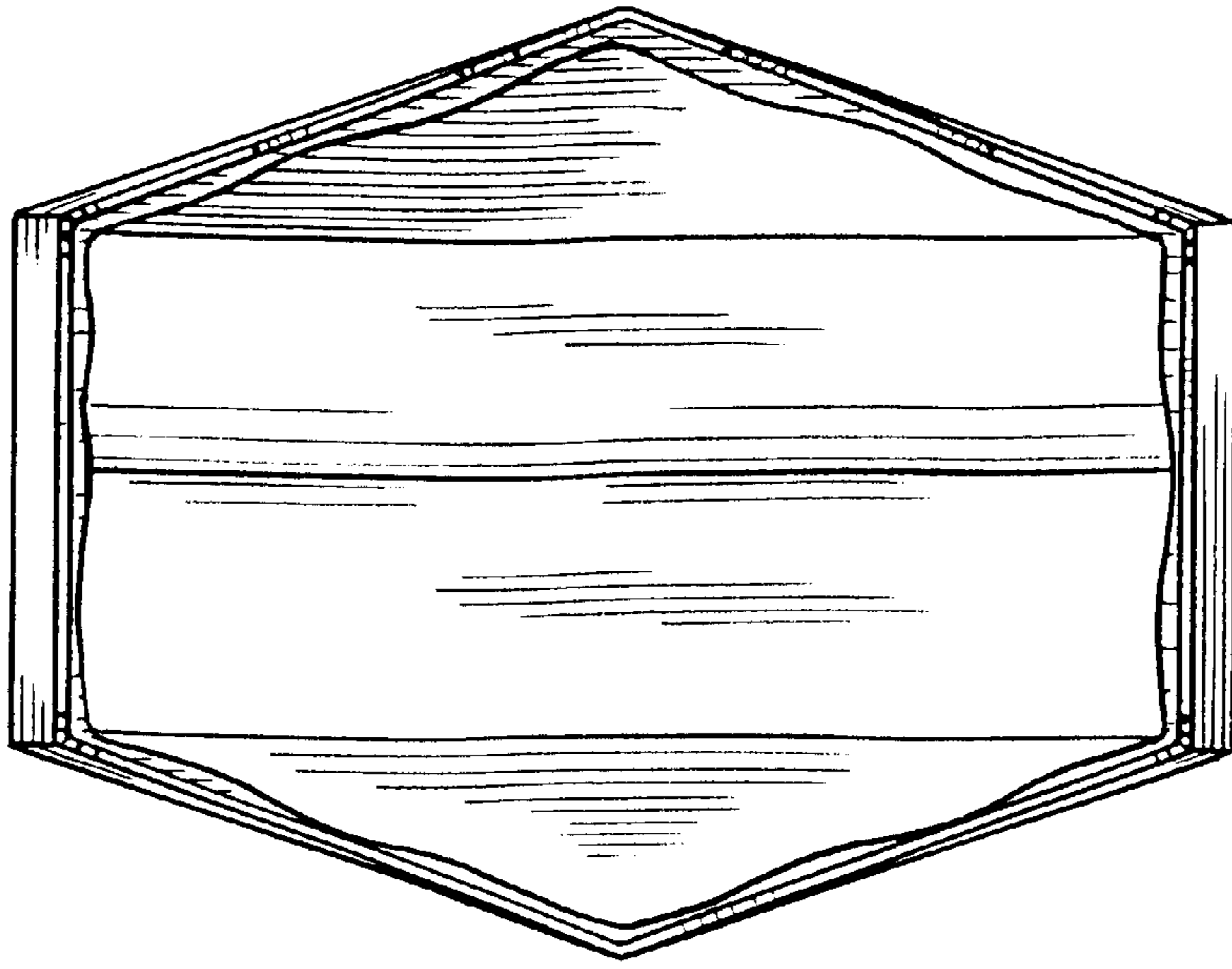

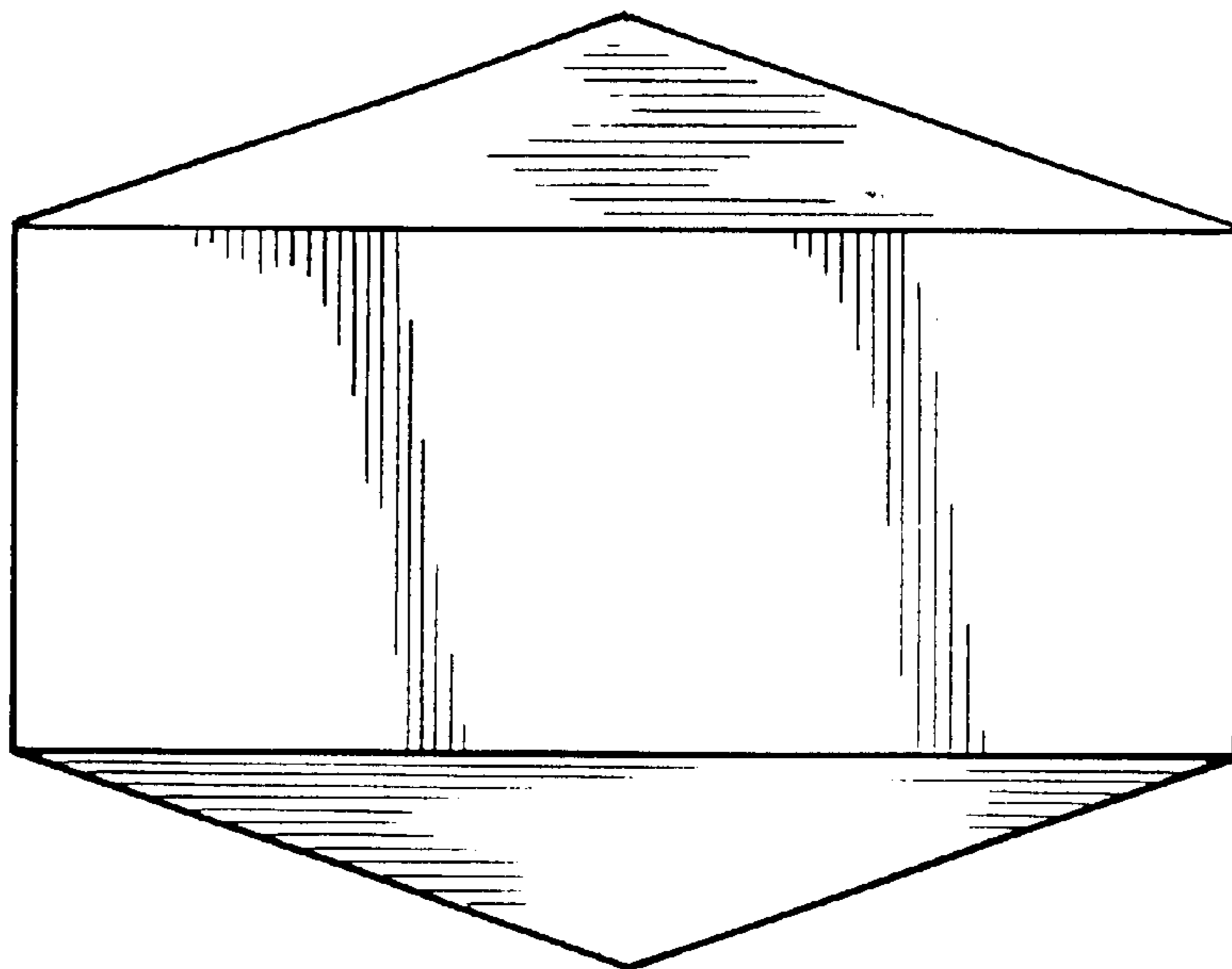
