(57) **CLAIM**

The ornamental design for a dispensing bottle, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing our new design; FIG. 2 is a front elevational view thereof, the rear elevational view being identical; FIG. 3 is a right side elevational view thereof, the left side elevational view being identical; FIG. 4 is a top plan view thereof; and, FIG. 5 is a bottom plan view thereof.

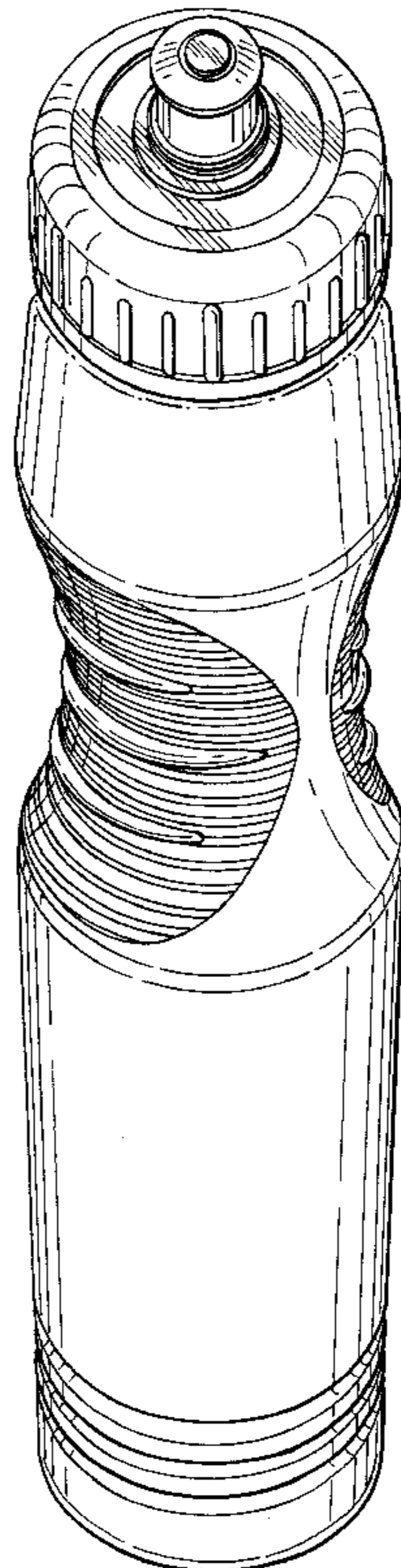

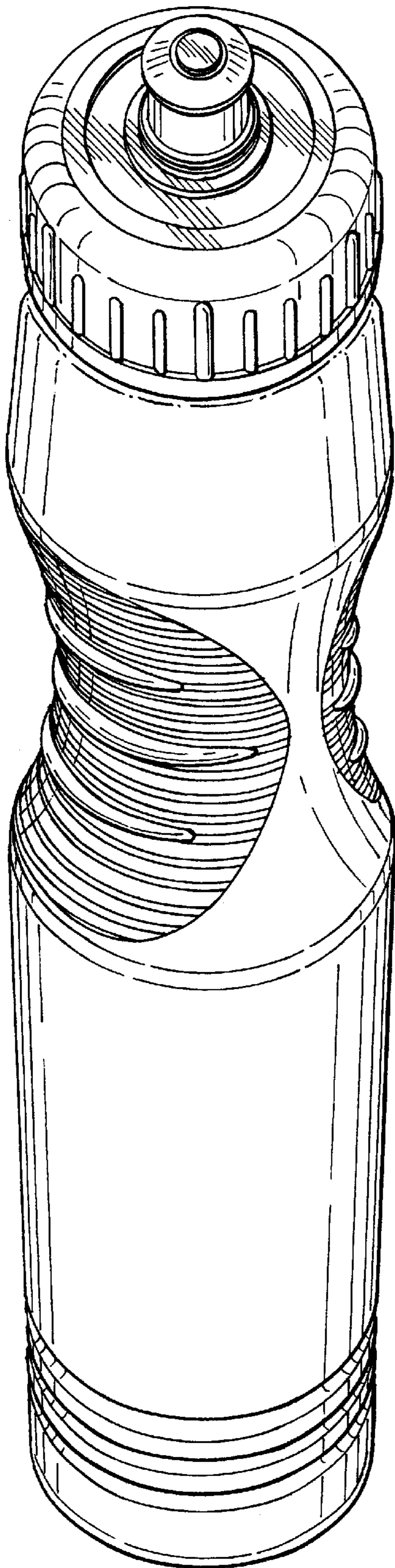

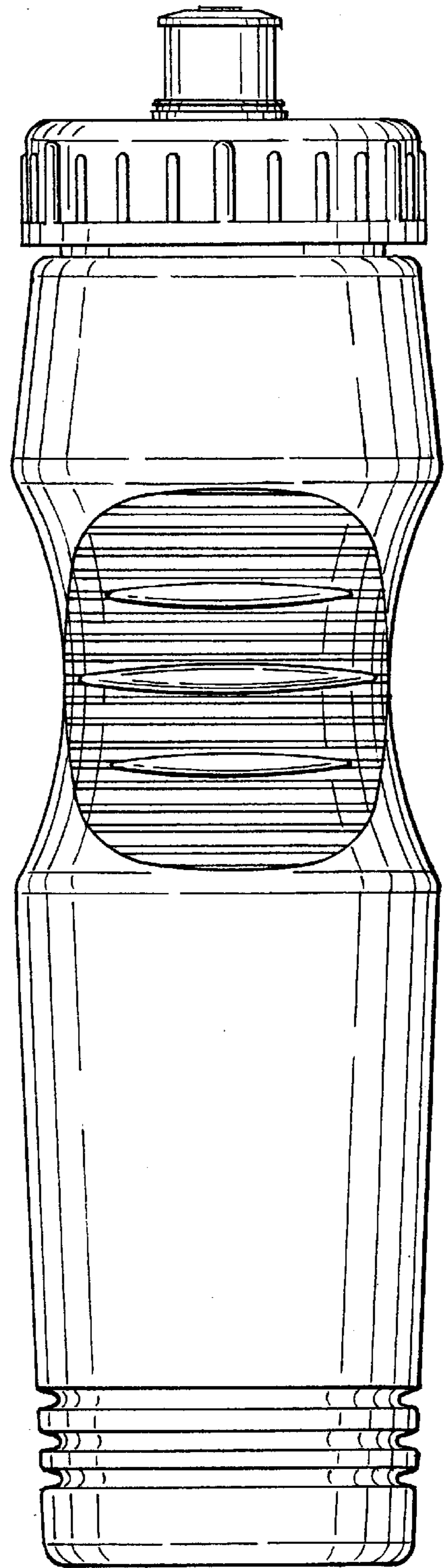

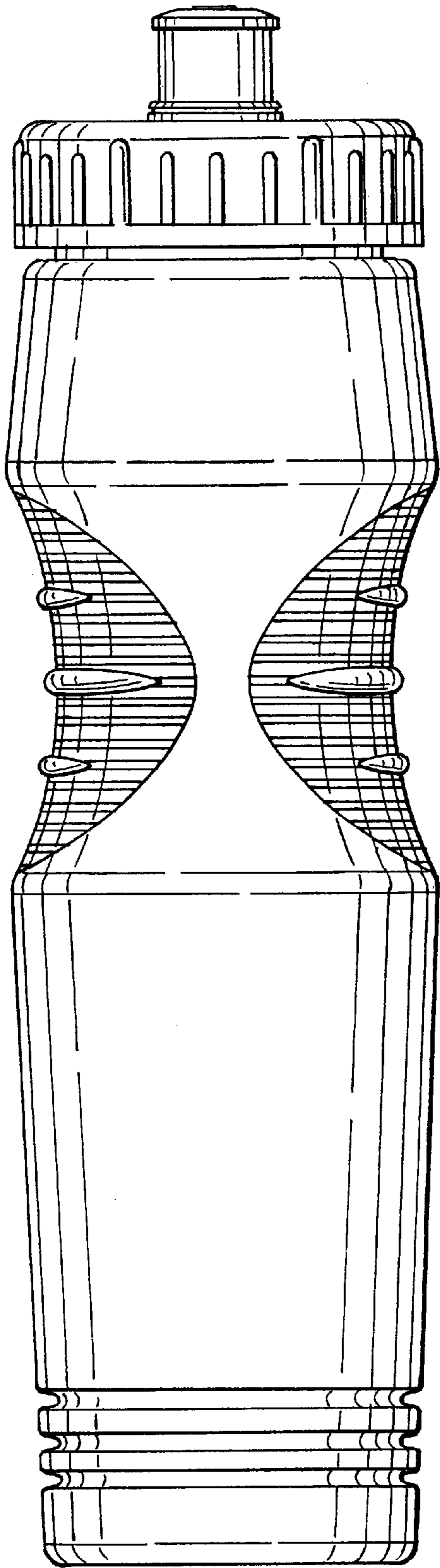

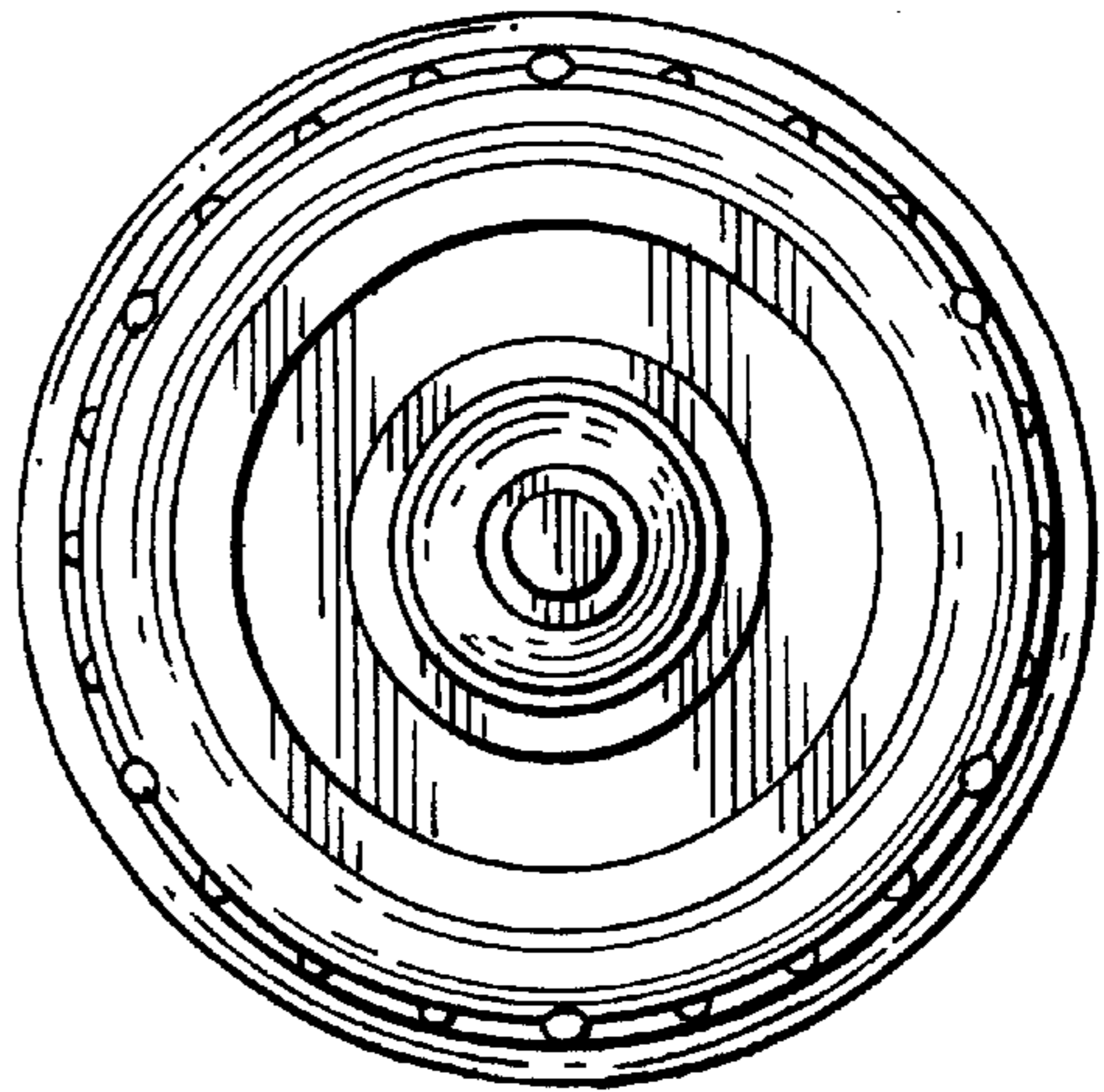
