(57) **CLAIM**

We claim the ornamental design for a back cover for a handset, as shown.

DESCRIPTION

FIG. 1 is a bottom plan view of the back cover for a handset; FIG. 2 is a right side view thereof; FIG. 3 is a front view thereof; FIG. 4 is a left side view thereof; and, FIG. 5 is a perspective front view thereof.

The broken line showing of the extending tabs is for illustrative purposes only and forms no part of the claimed design.

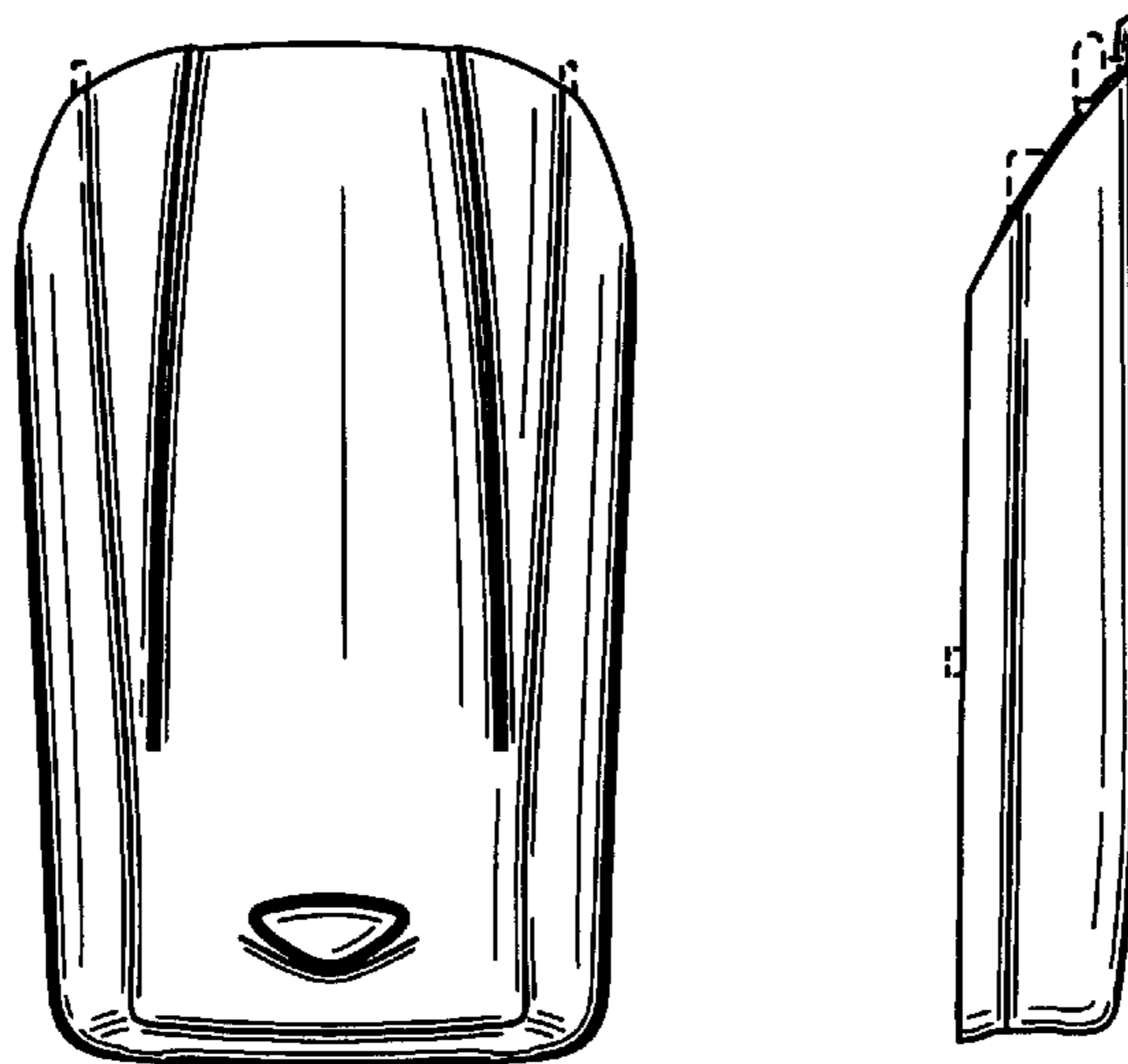

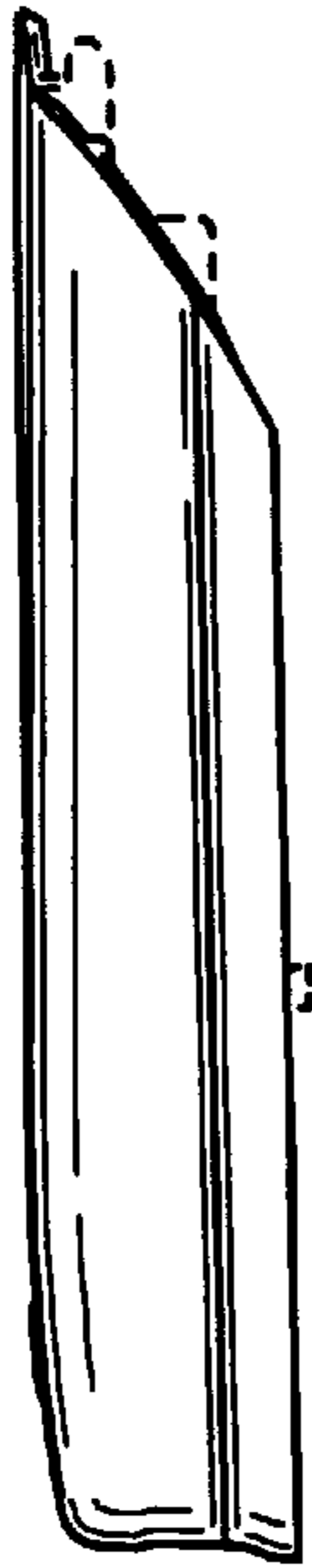
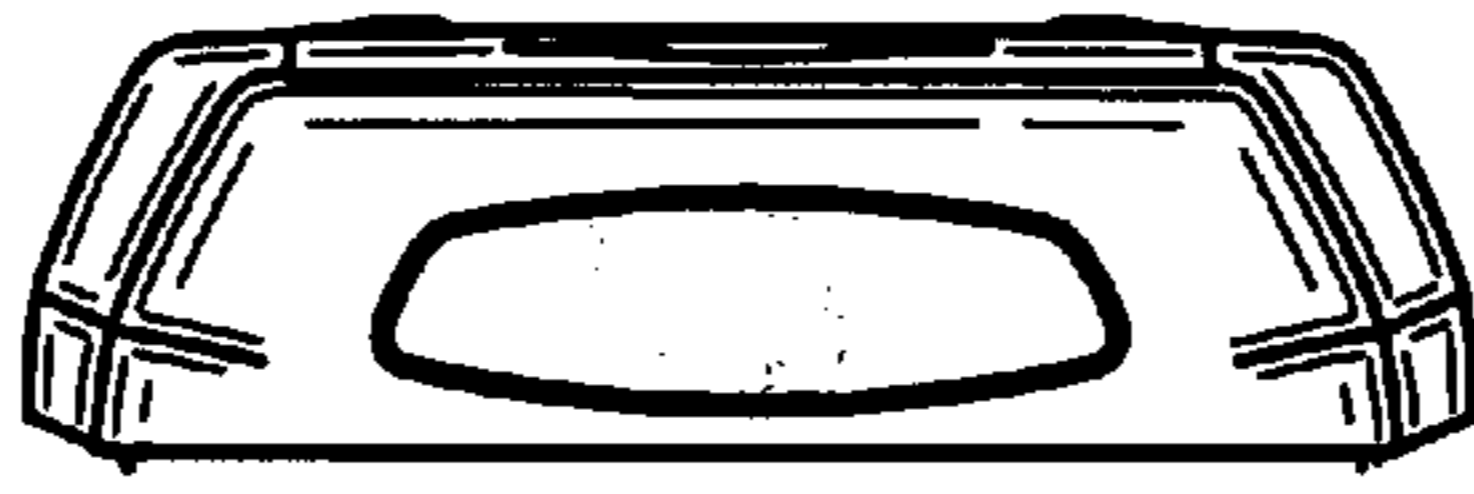

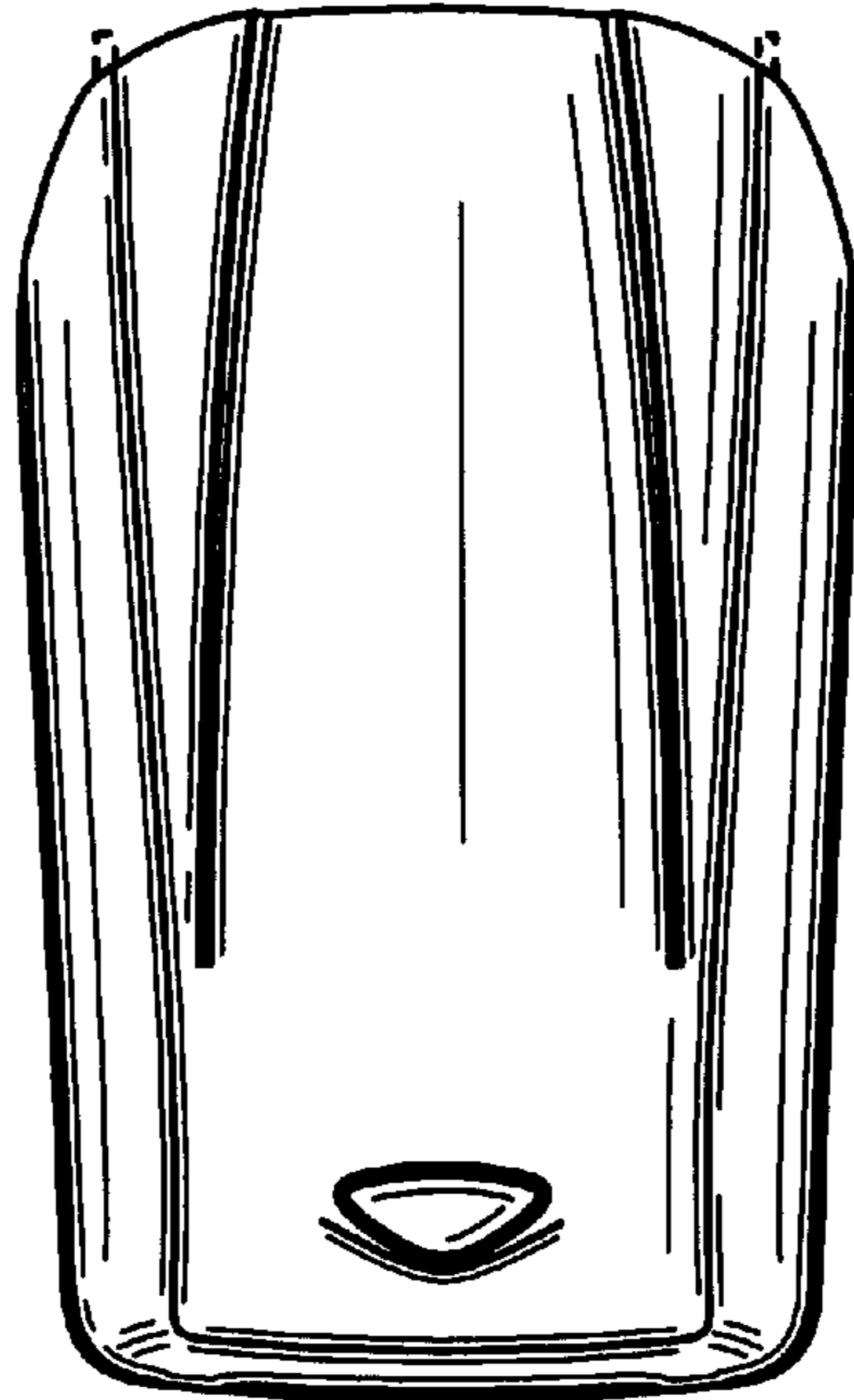

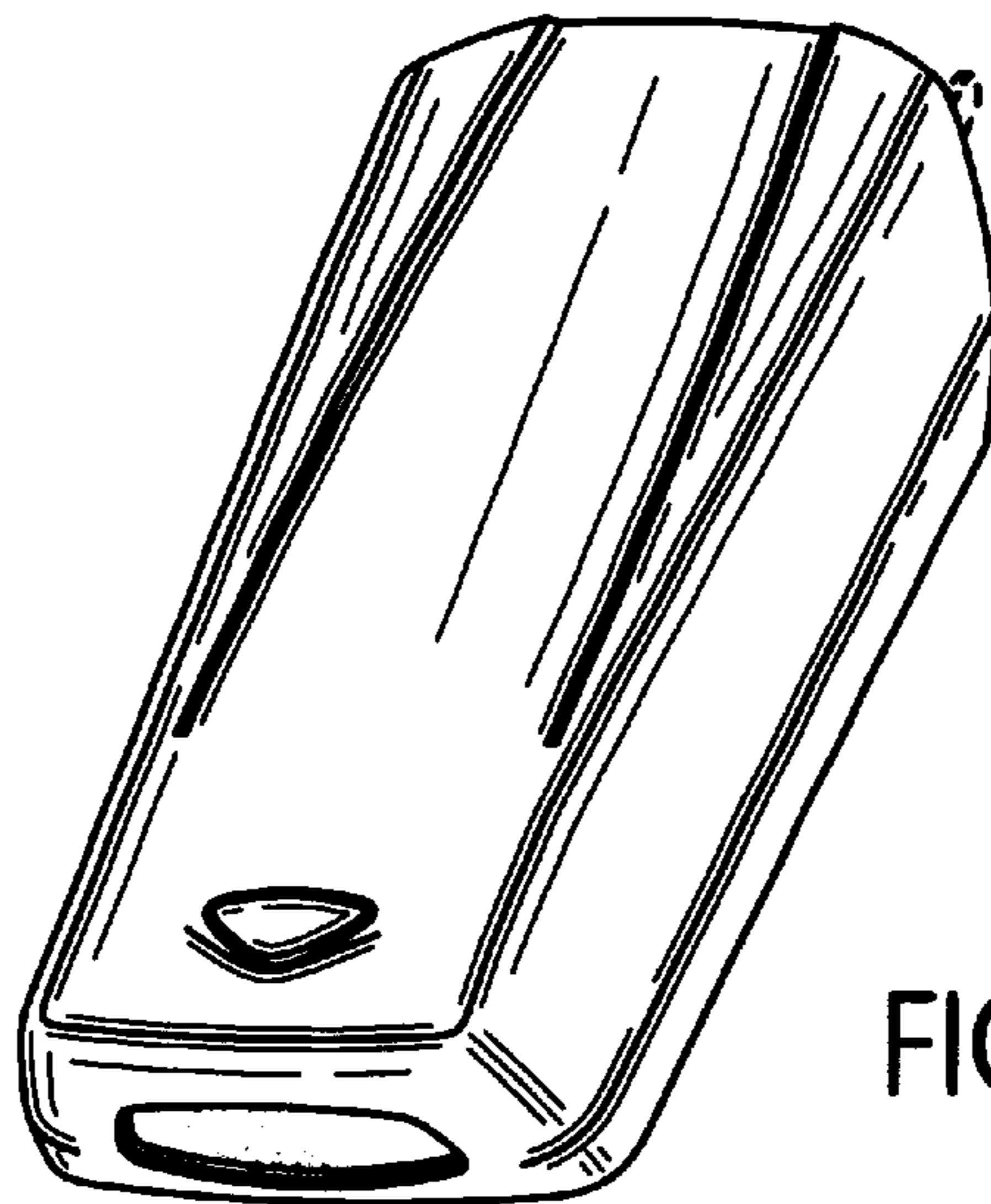
